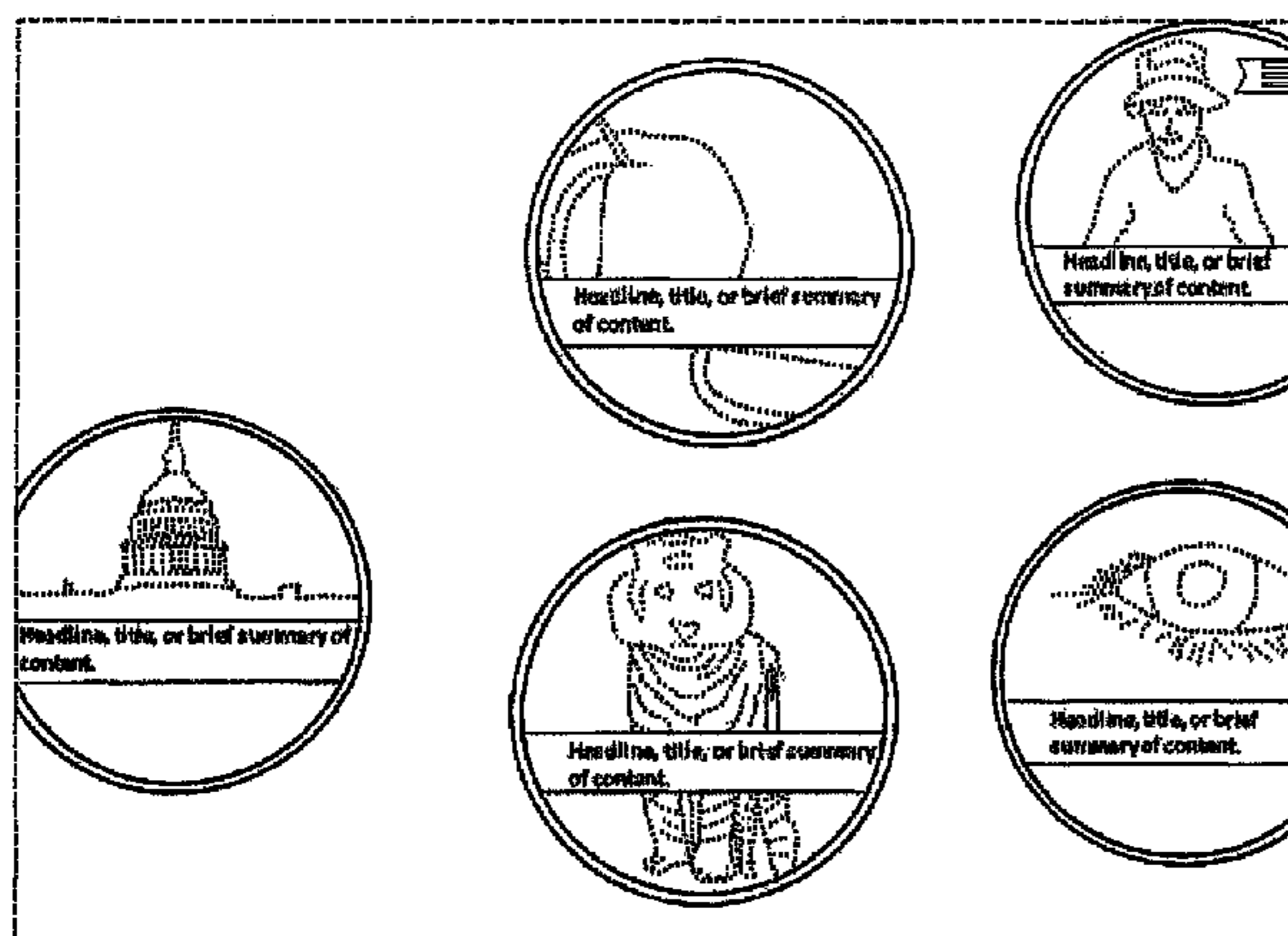
The broken line words, letters, numbers, and various graphical representations are for illustrative purposes only and form no part of the claimed design.

The computer screen shown in broken lines forms no part of the claimed design.

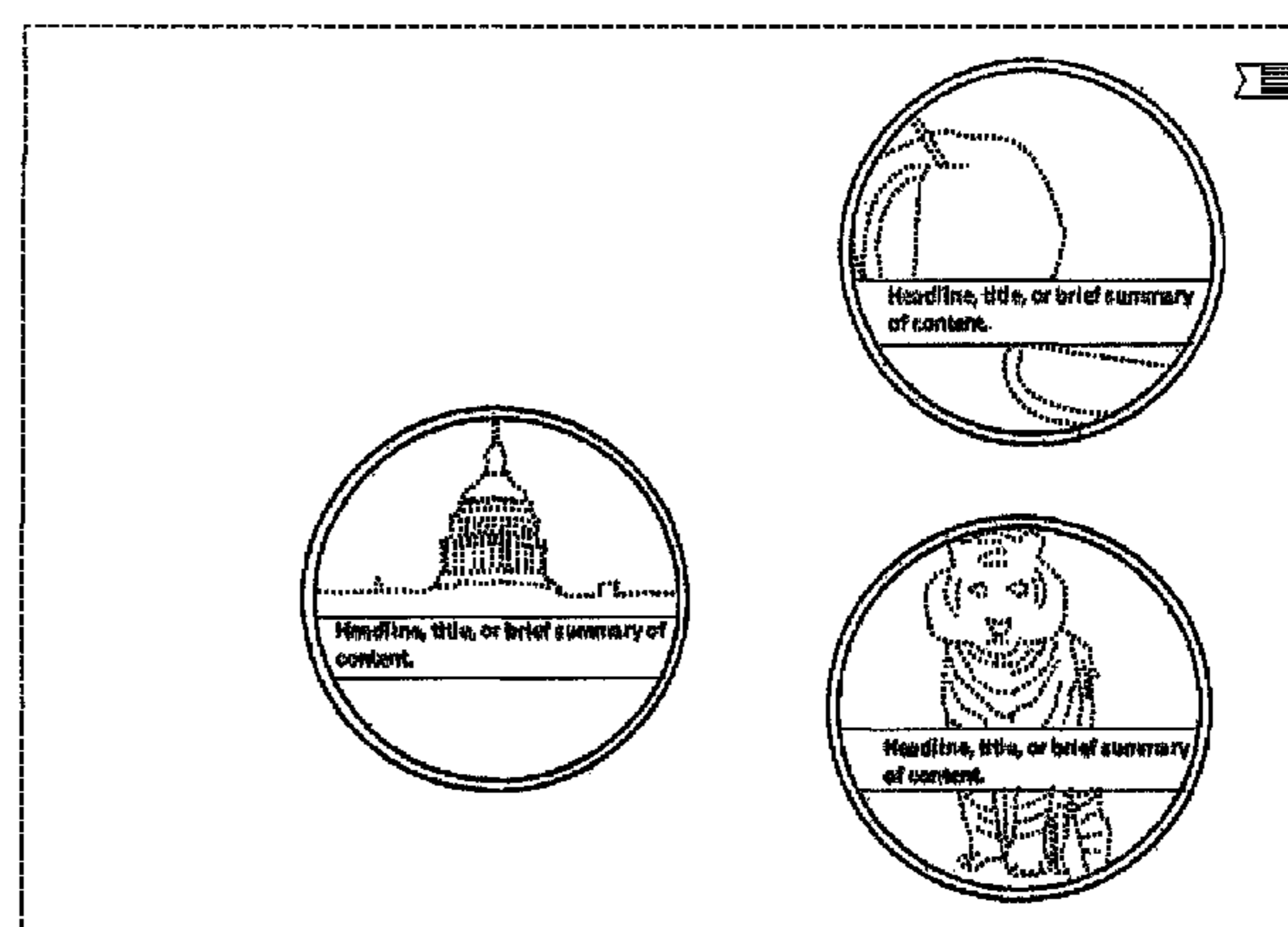
The portions of the graphical user interface shown in broken lines form no part of the claimed design.

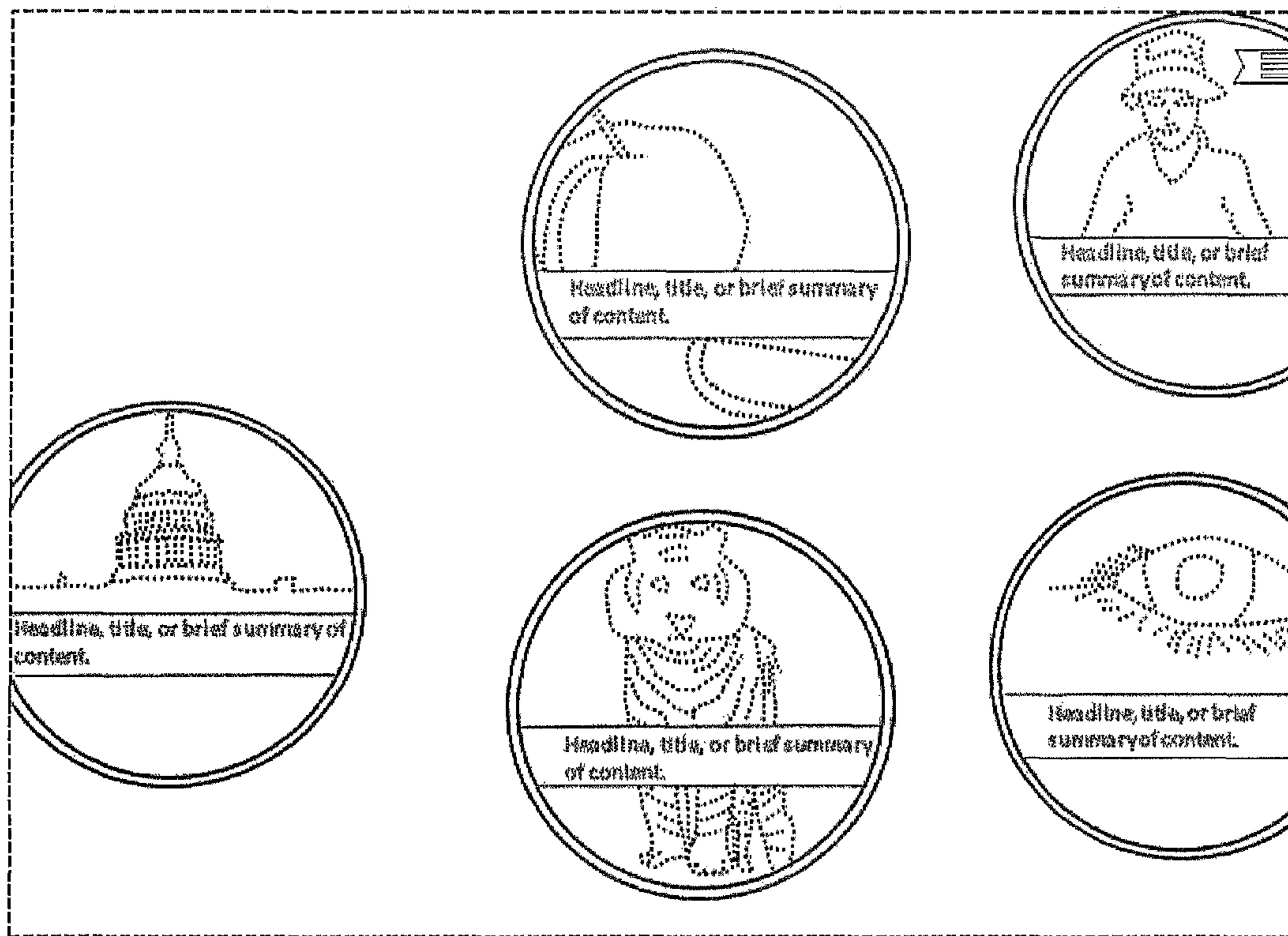

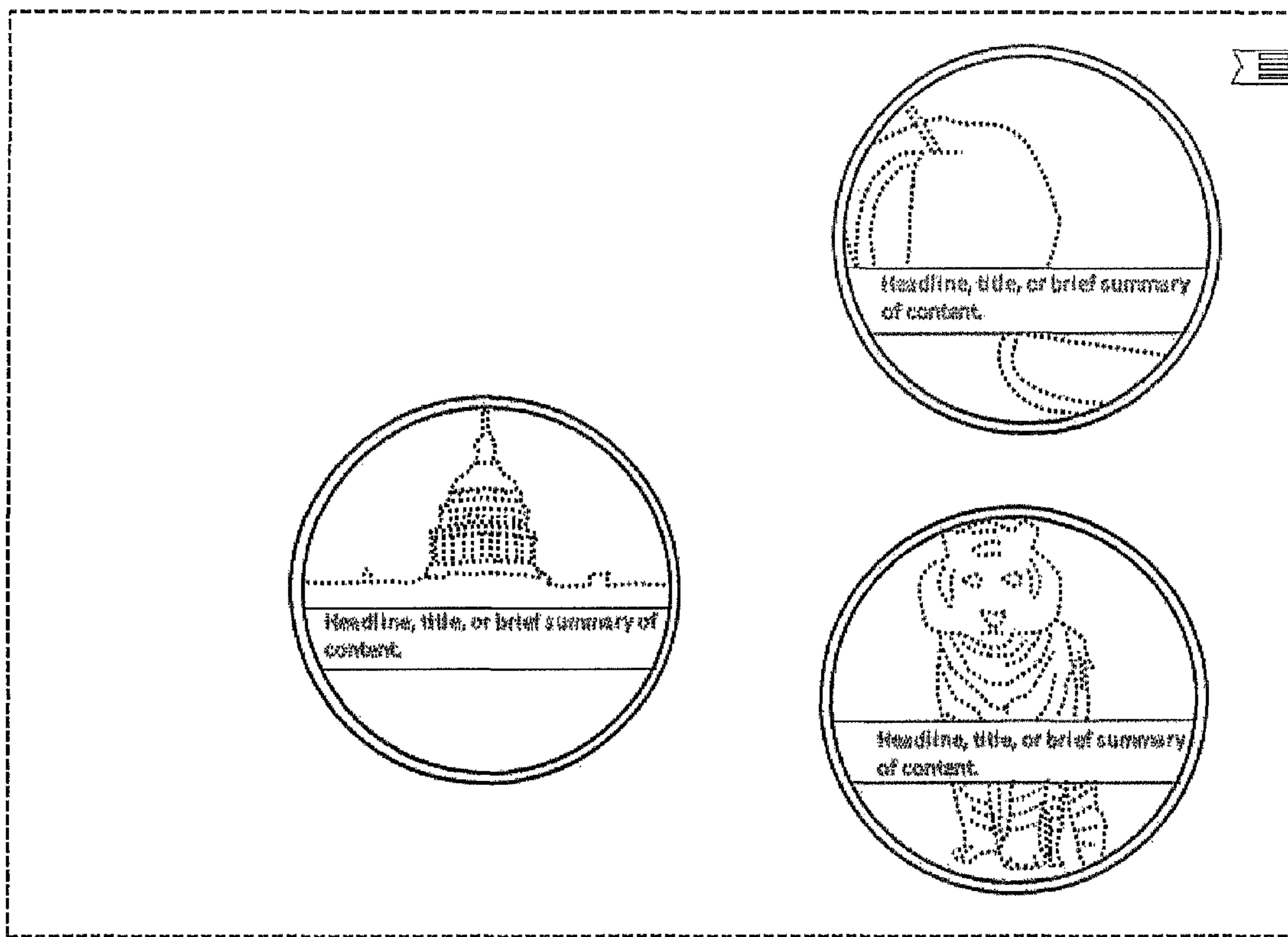
