**DESCRIPTION**

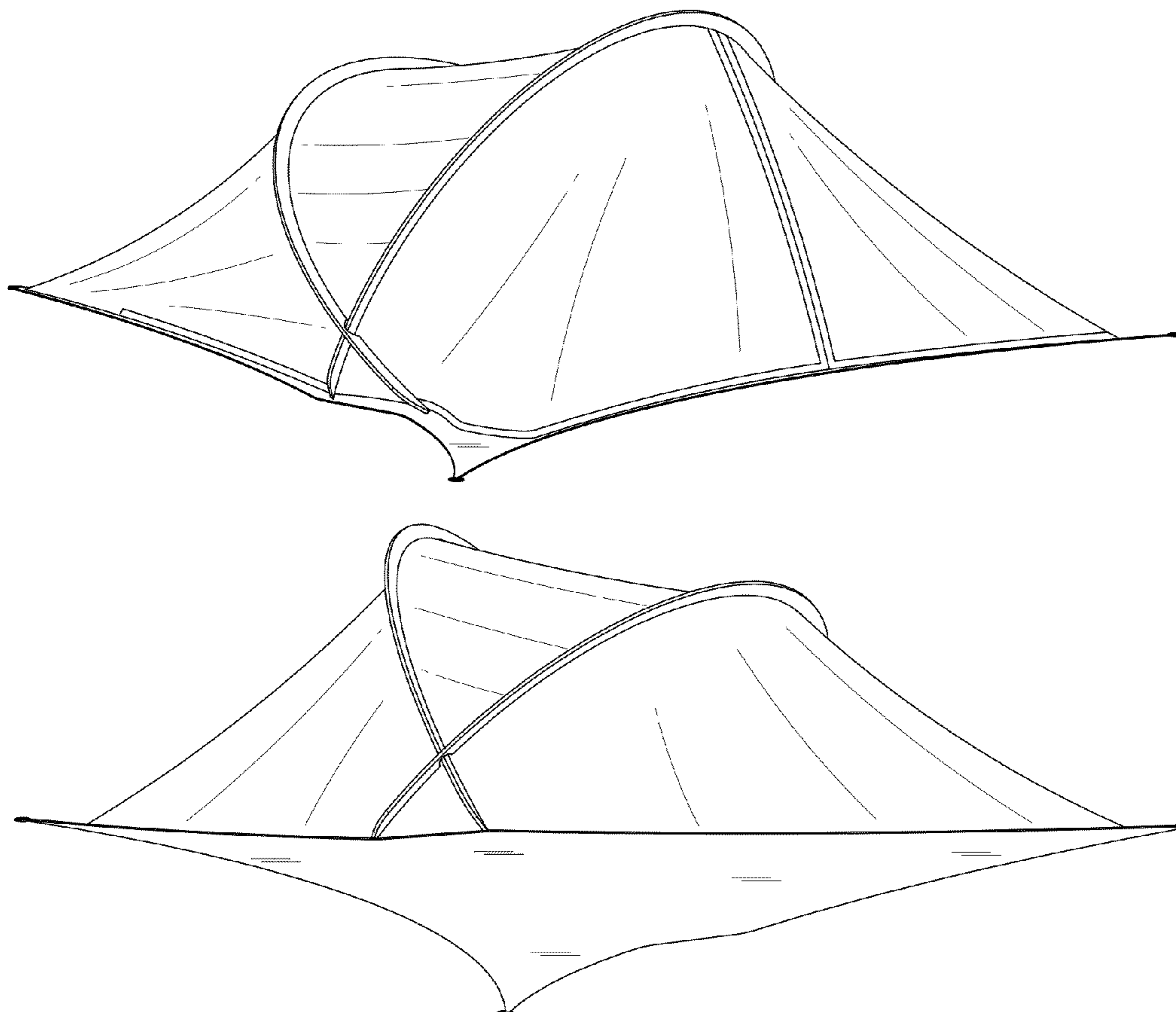
FIG. 1 shows a top perspective view of a tree tent.

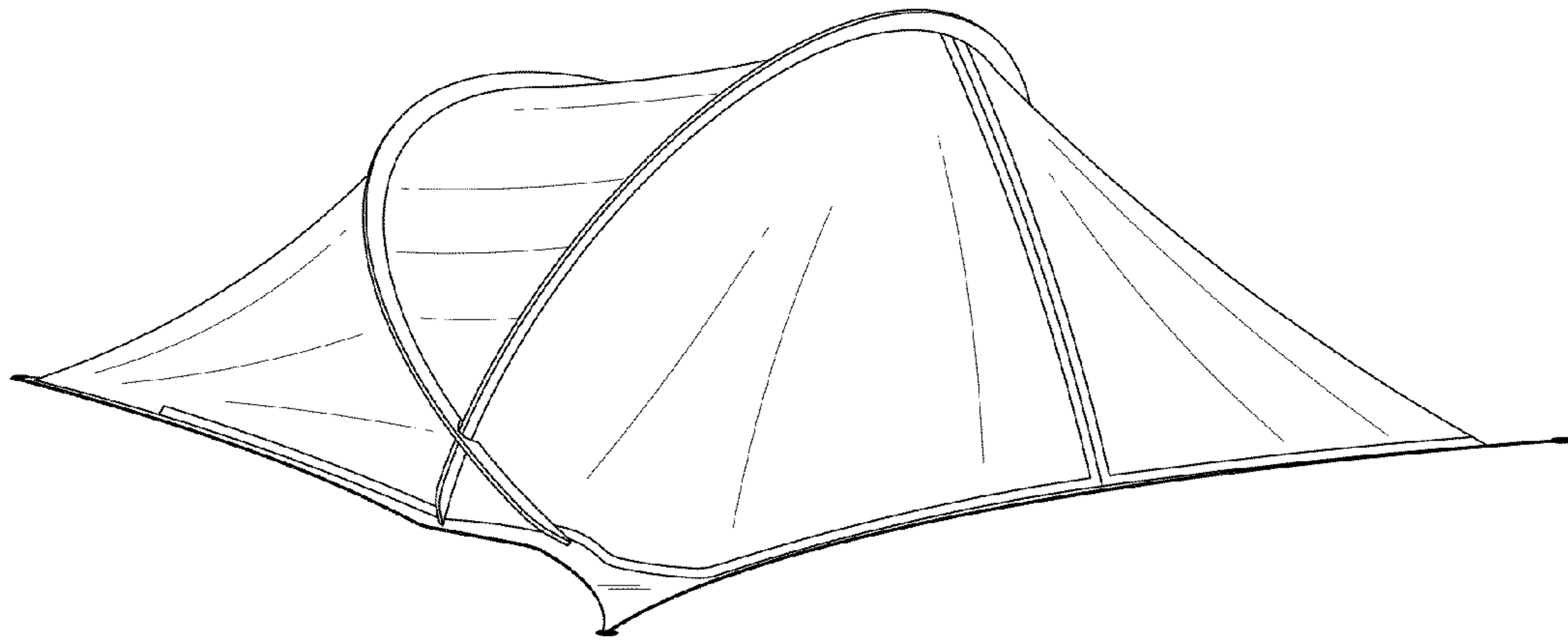

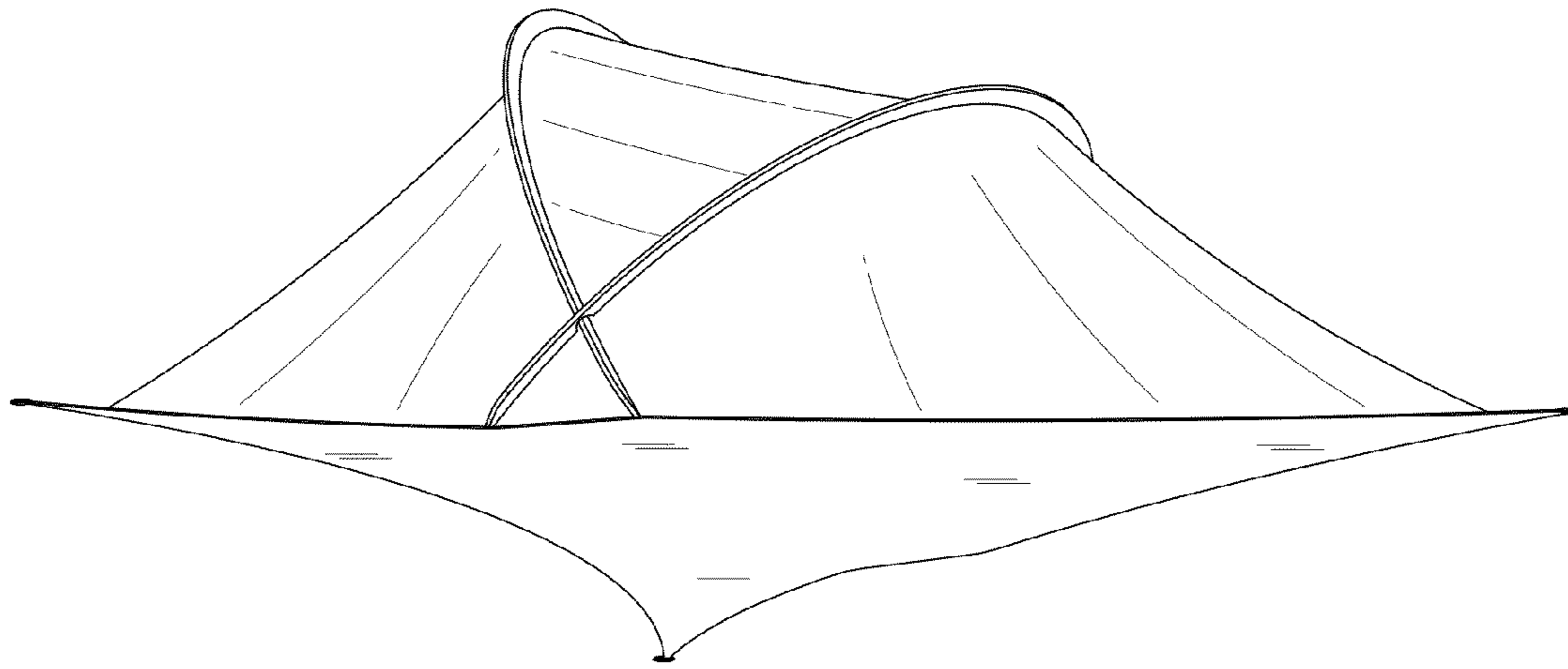

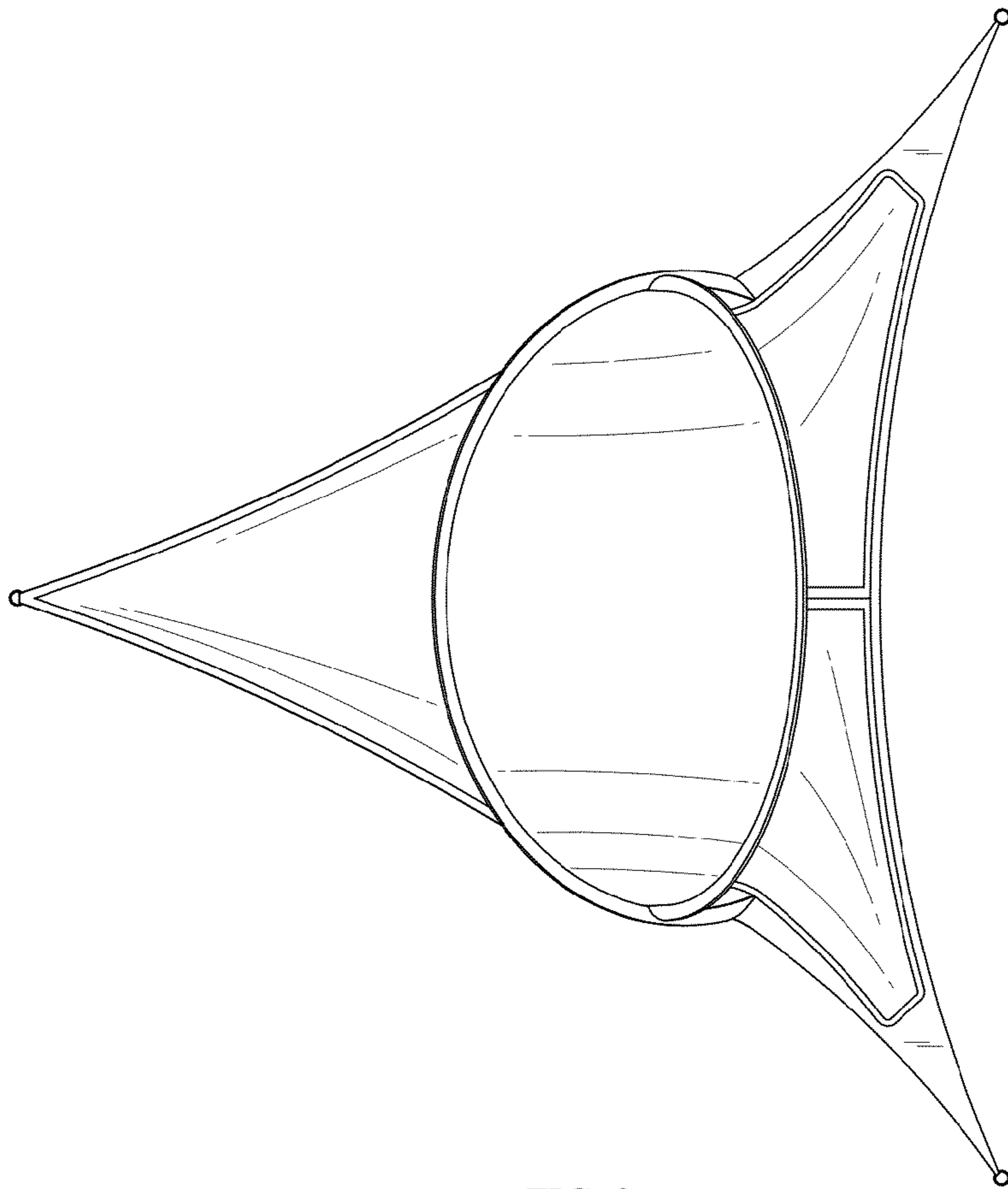

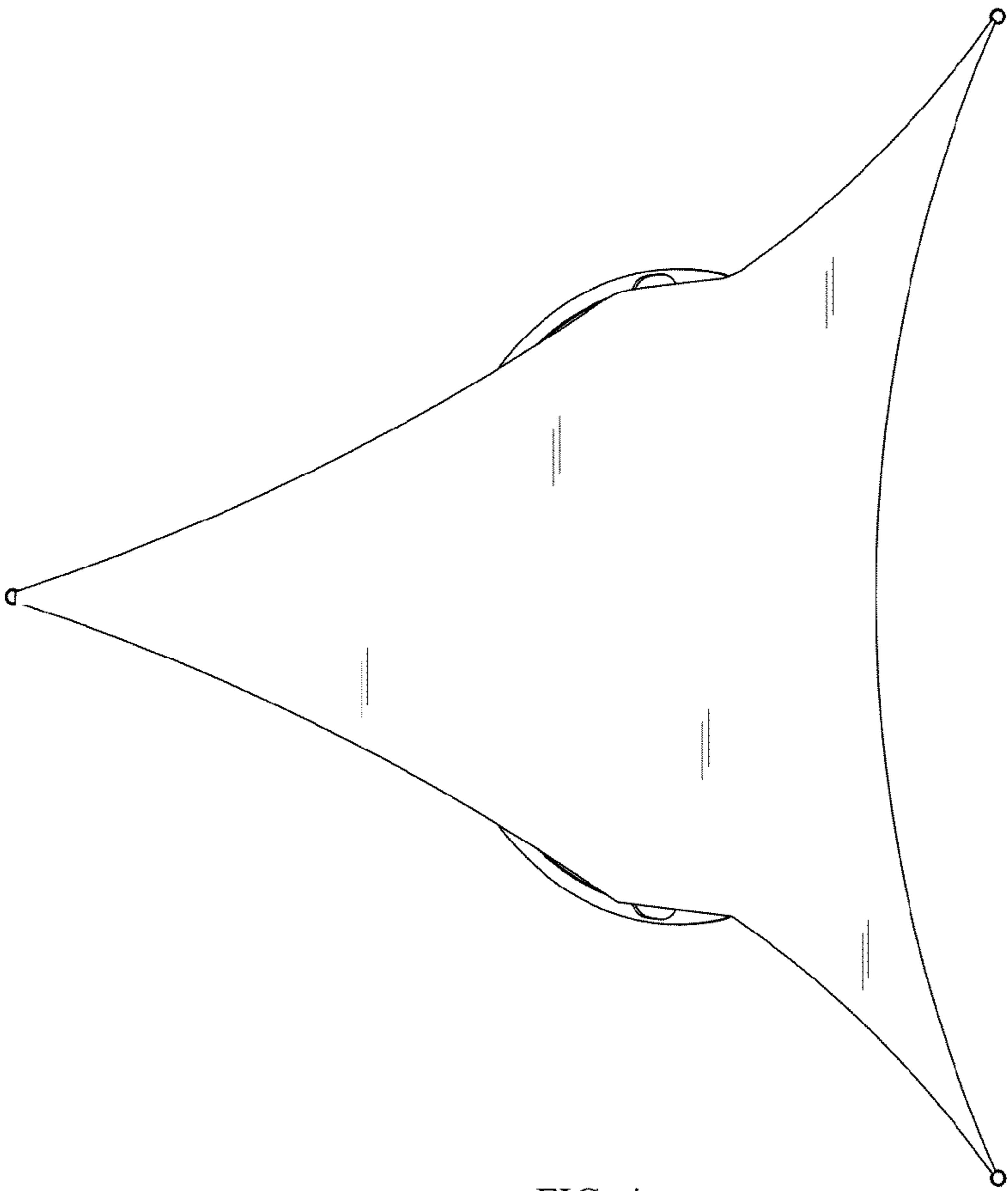

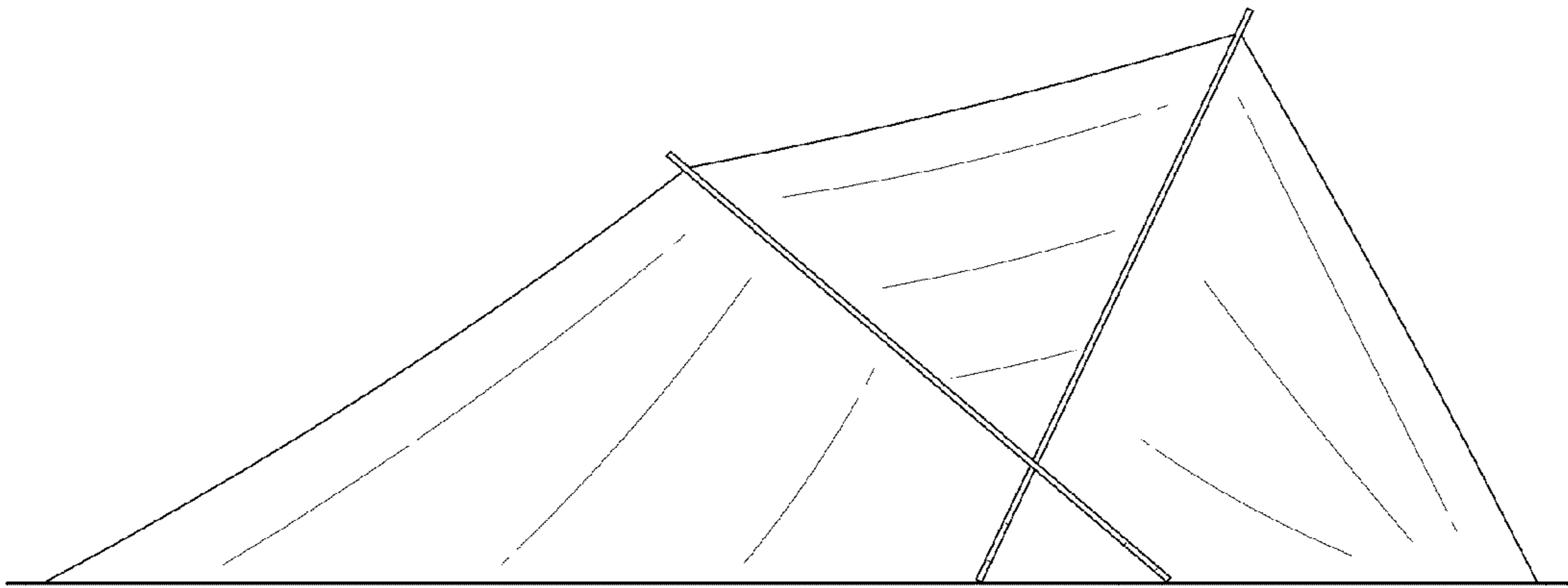

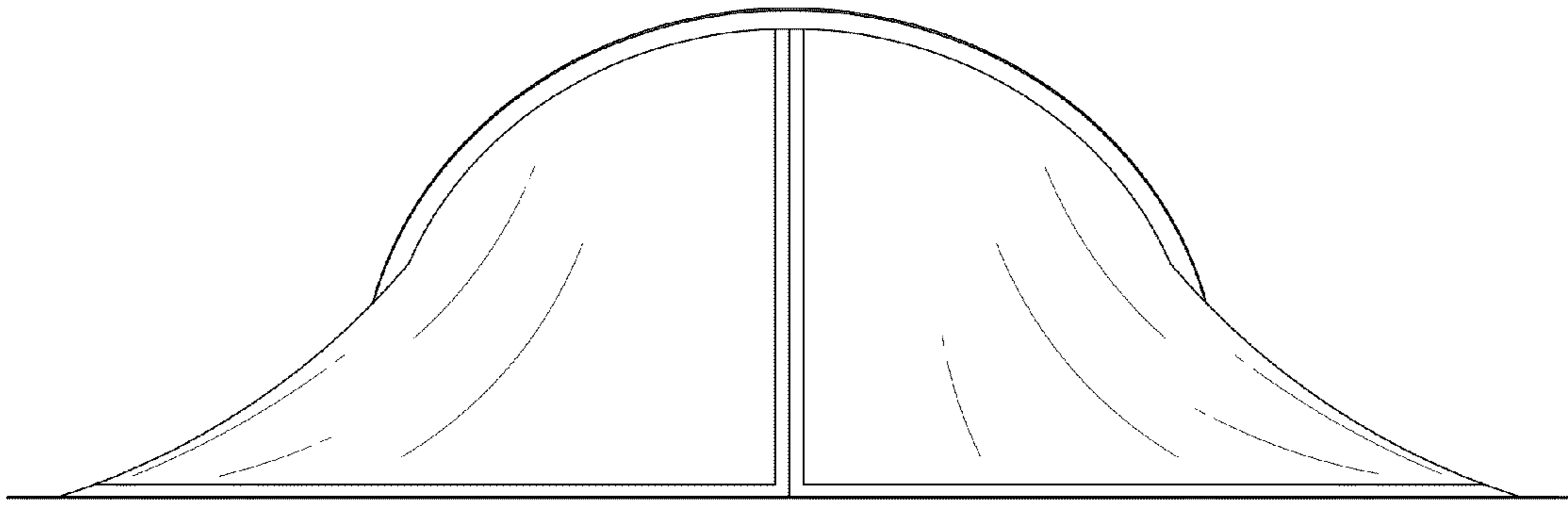

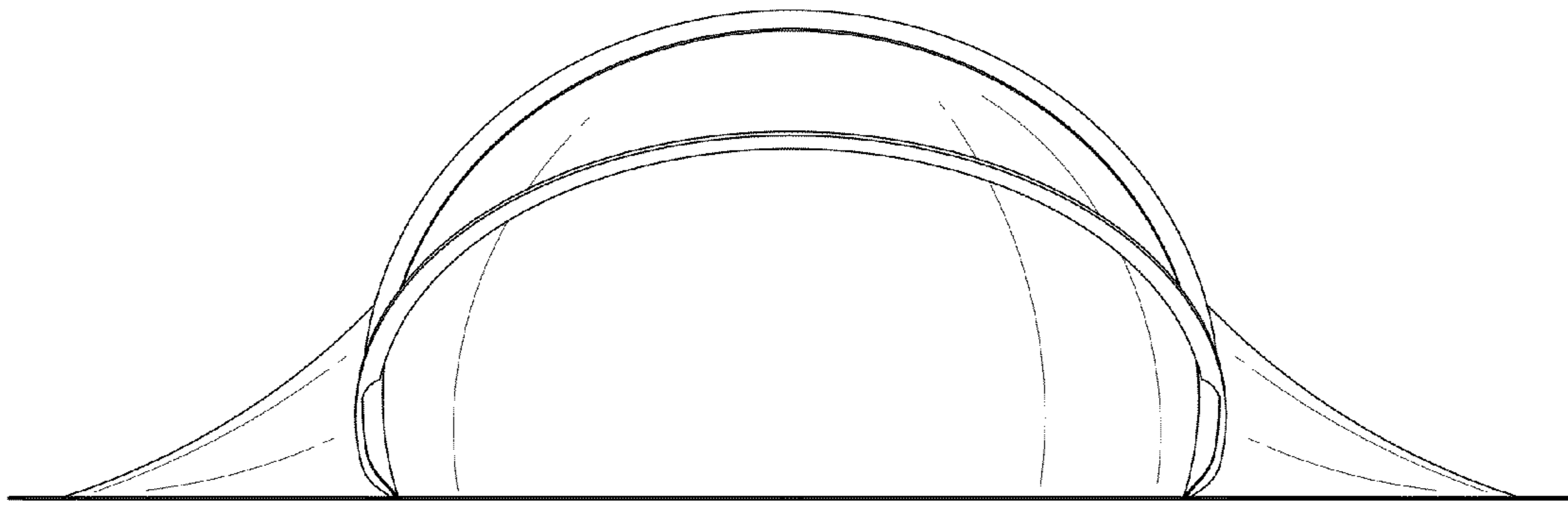
