(57) **CLAIM**

The ornamental design for a front sight for a gun, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, top perspective view of a front sight for a gun in accordance with my new design, the front sight for a gun being shown in a raised position;

FIG. 2 is a rear, left, bottom perspective view of the front sight for a gun of FIG. 1;

FIG. 3 is a front view of the front sight for a gun of FIG. 1;

FIG. 4 is a right side view of the front sight for a gun of FIG. 1;

FIG. 5 is a rear view of the front sight for a gun of FIG. 1;

FIG. 6 is a left side view of the front sight for a gun of FIG. 1;

FIG. 7 is a top view of the front sight for a gun of FIG. 1;

FIG. 13 is a rear view of the front sight for a gun of FIG. 9;

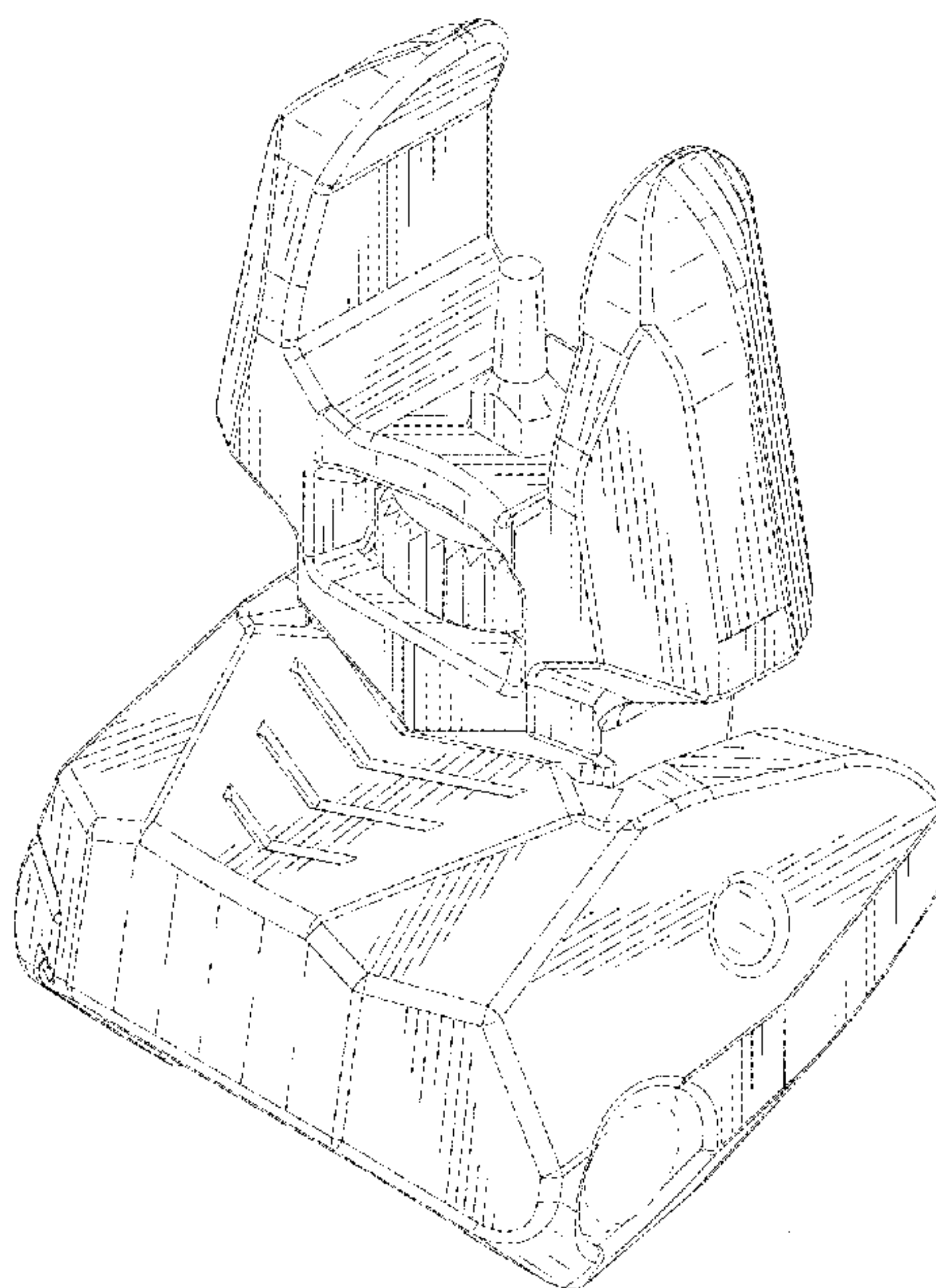
FIG. 14 is a left side view of the front sight for a gun of FIG. 9;

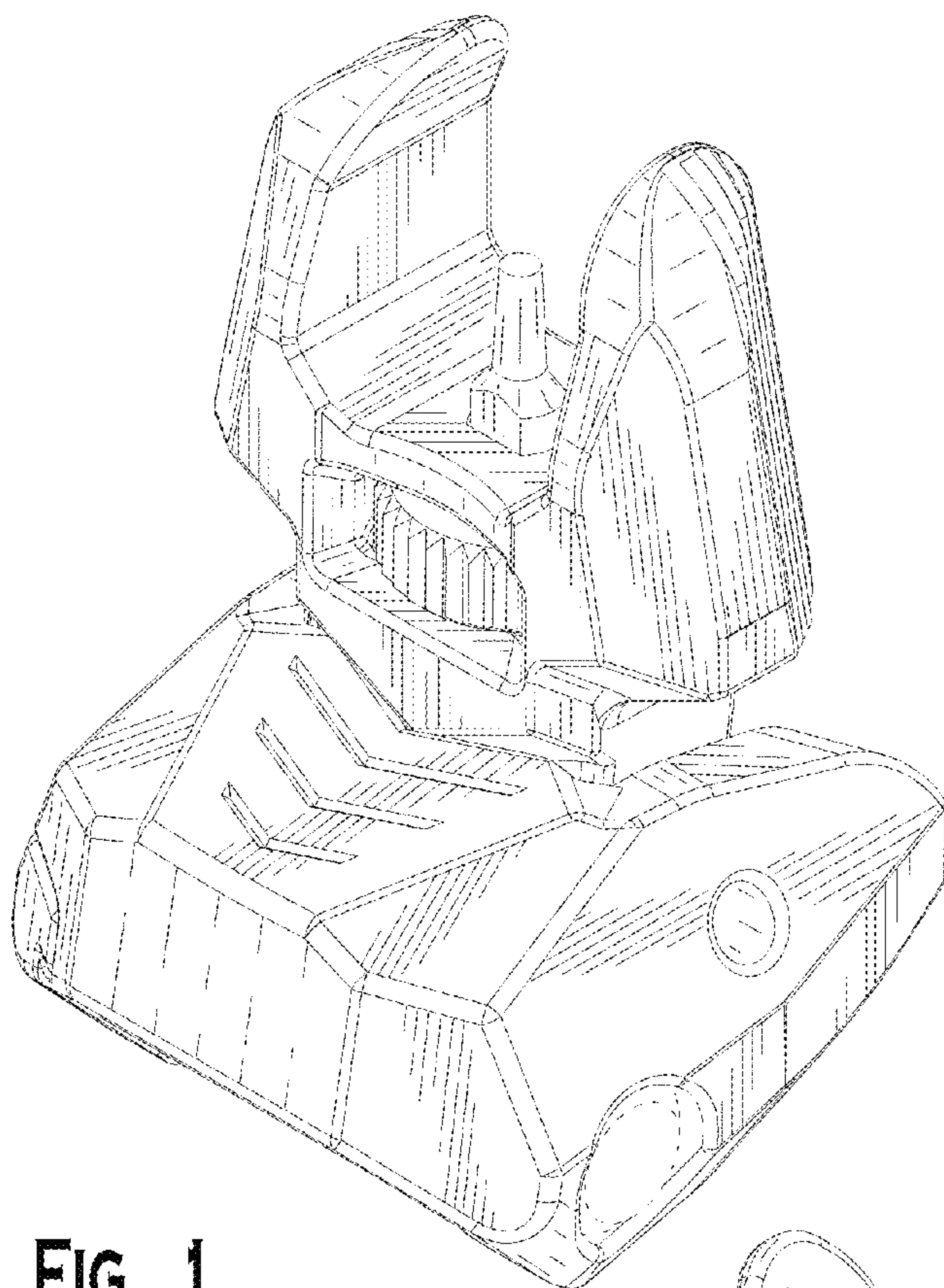

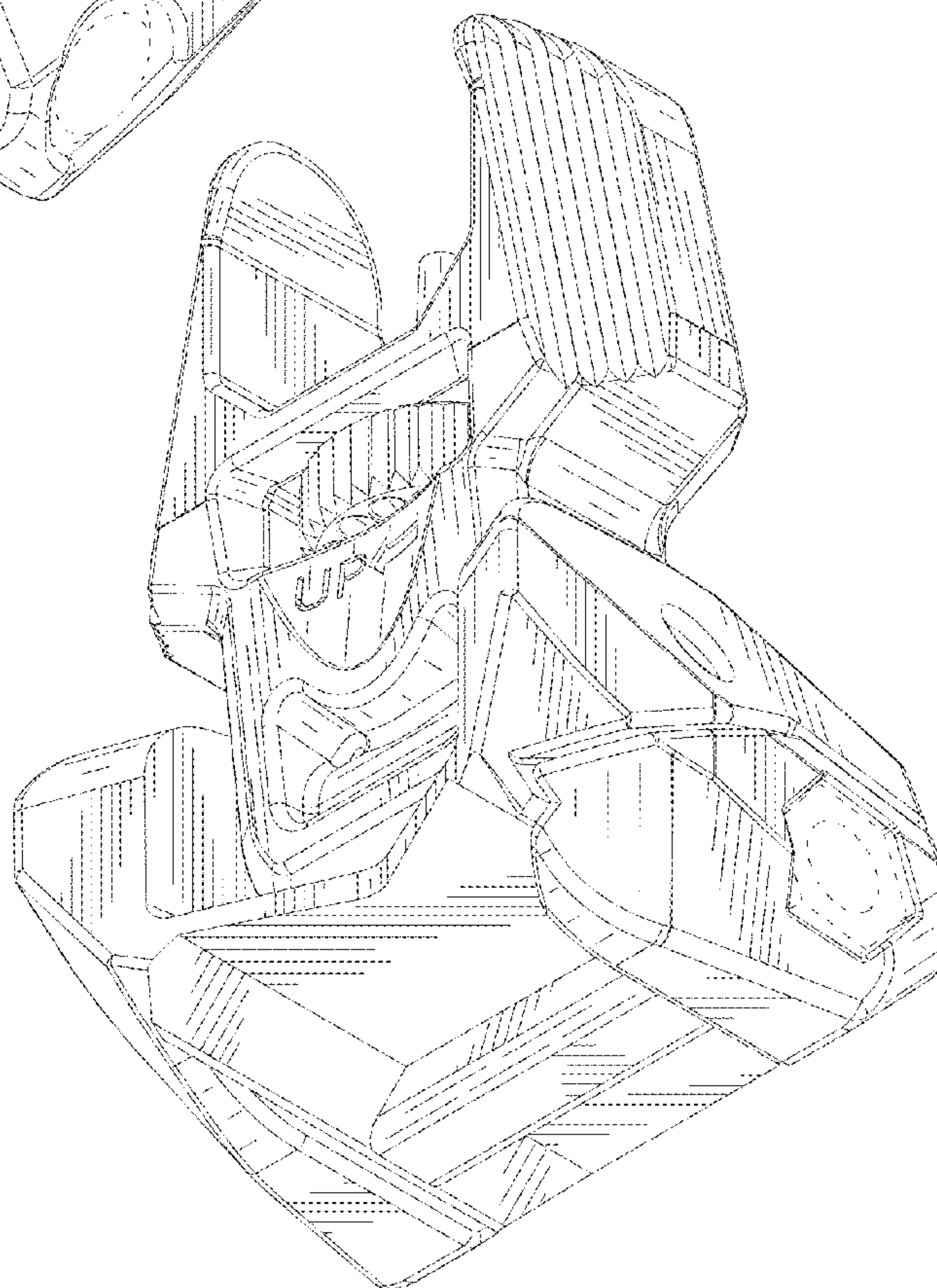

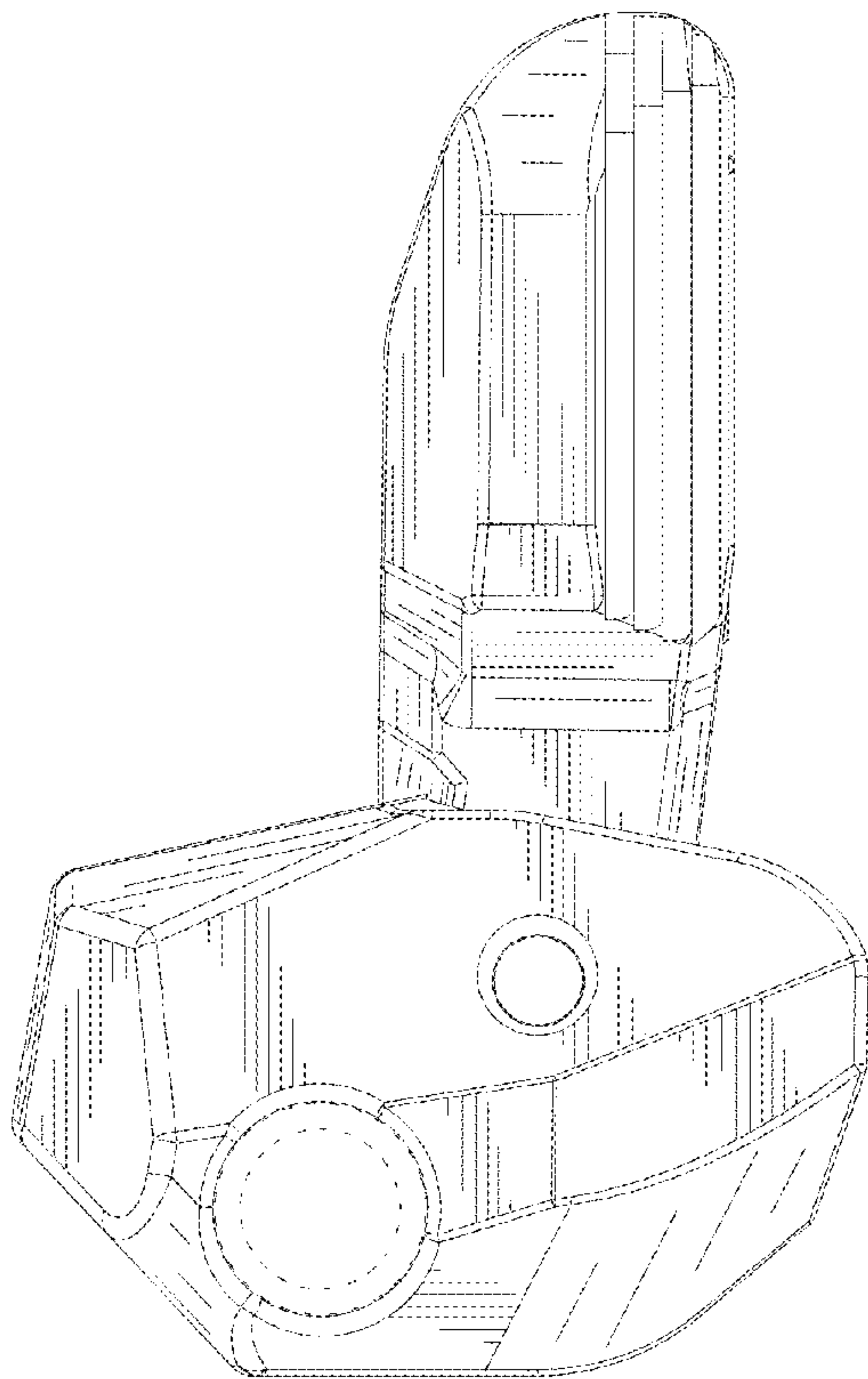
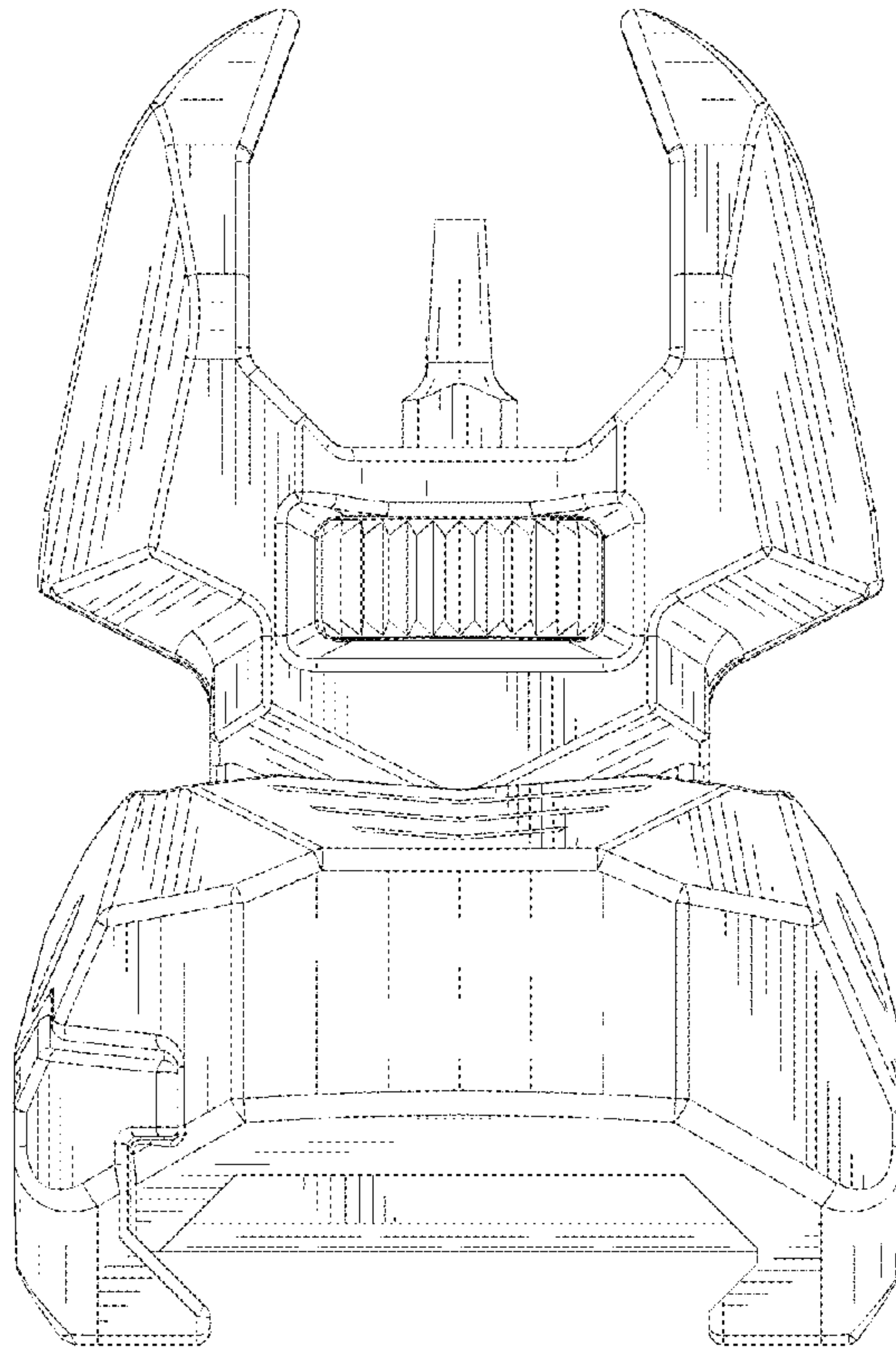

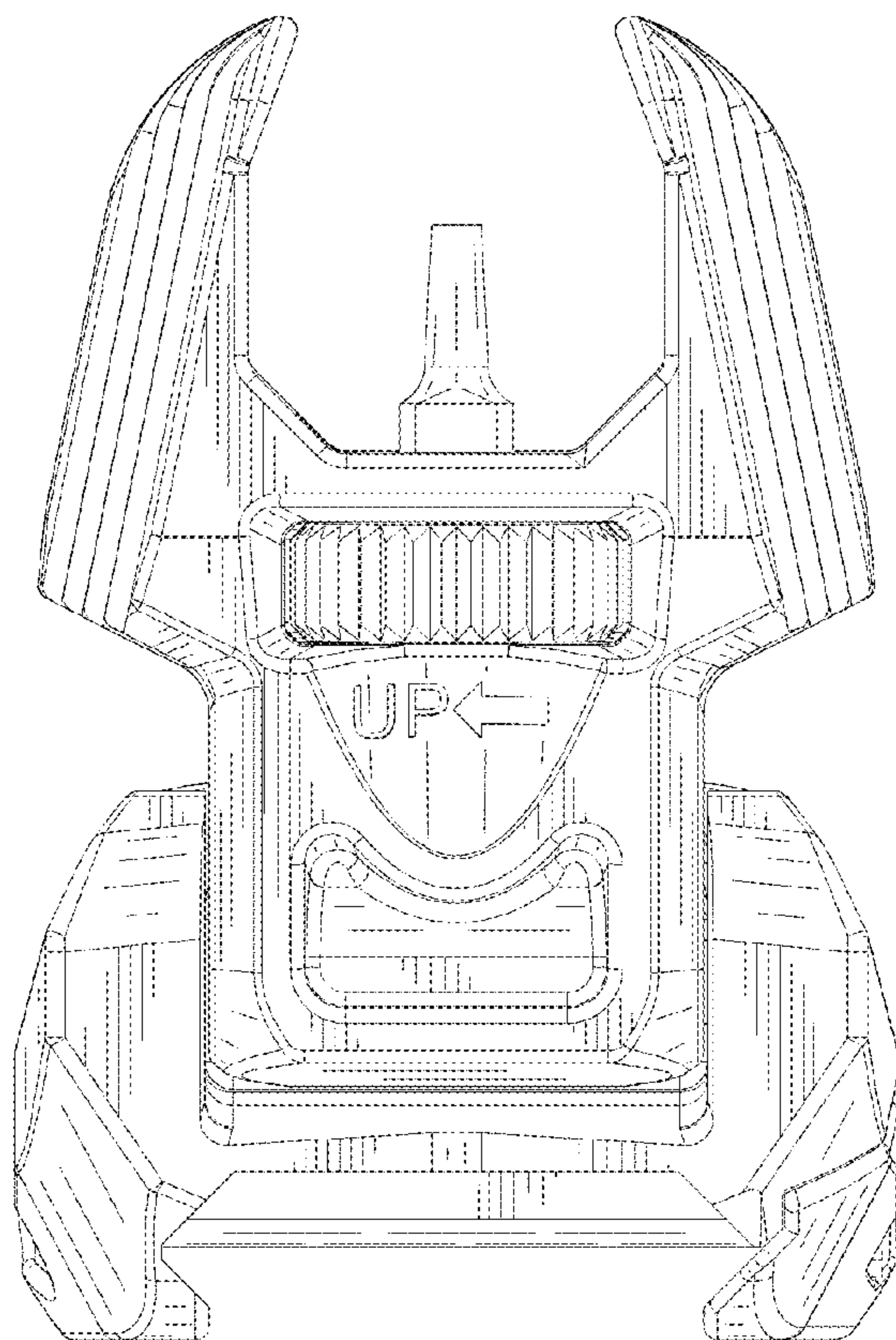

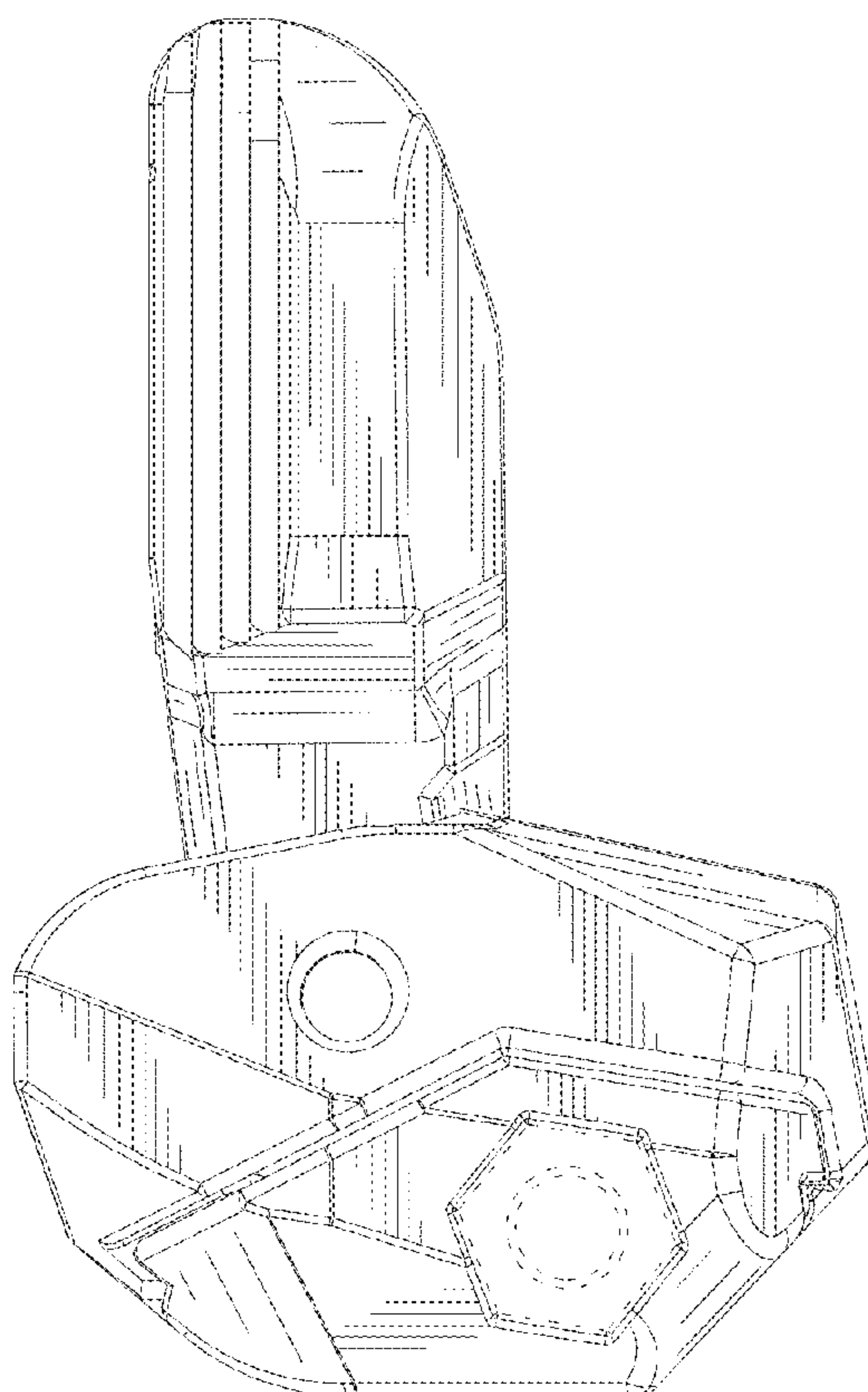

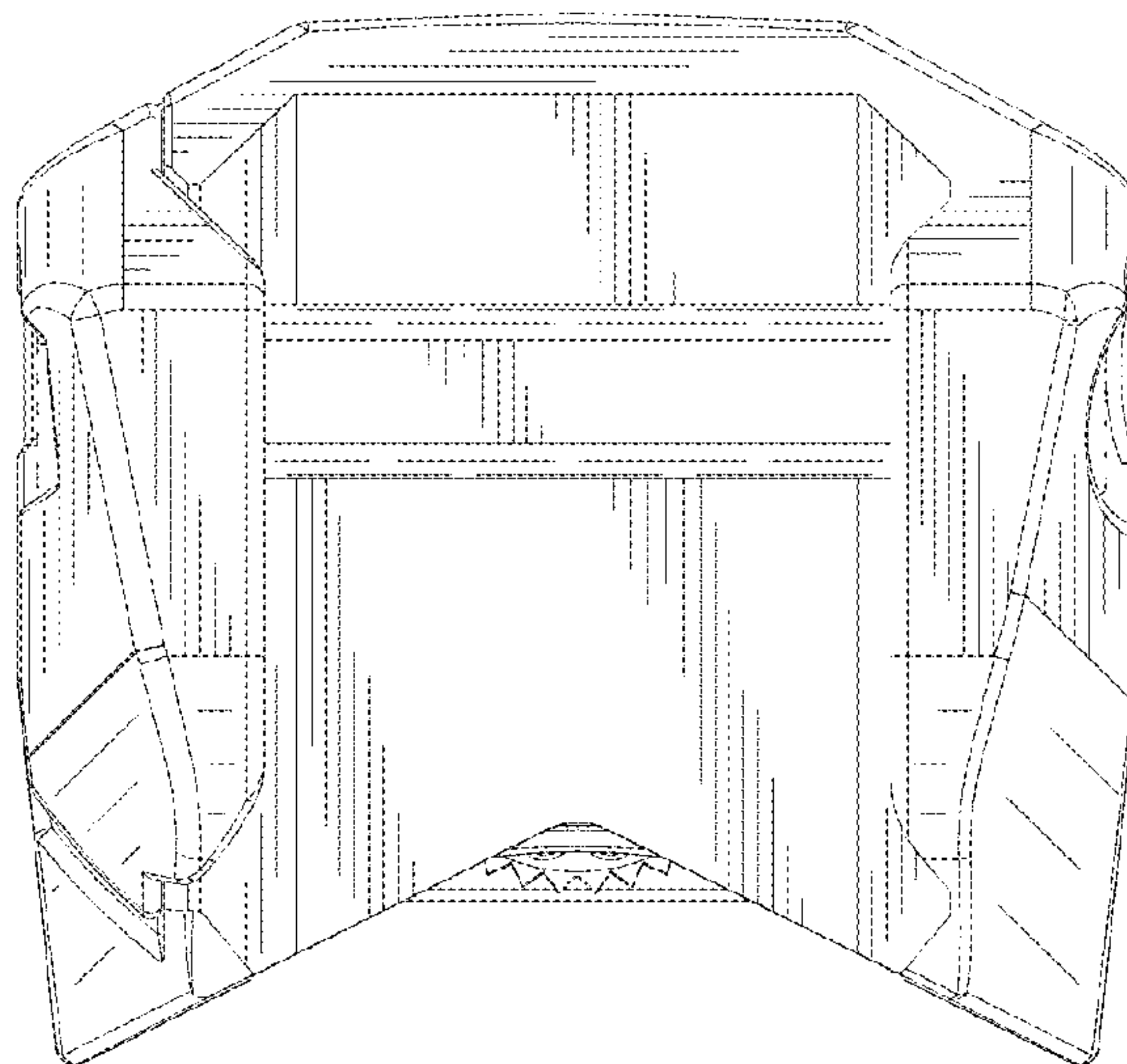
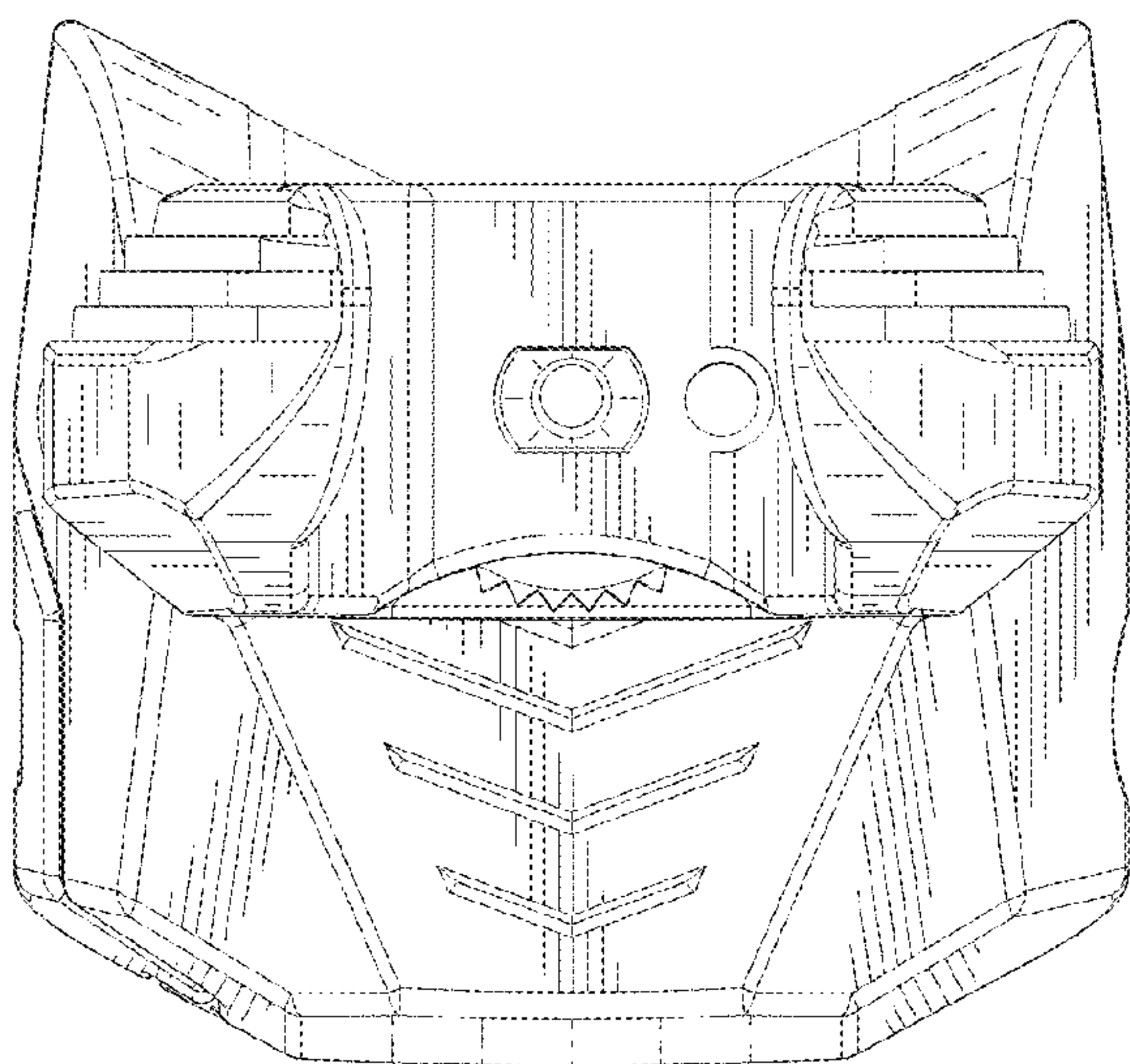

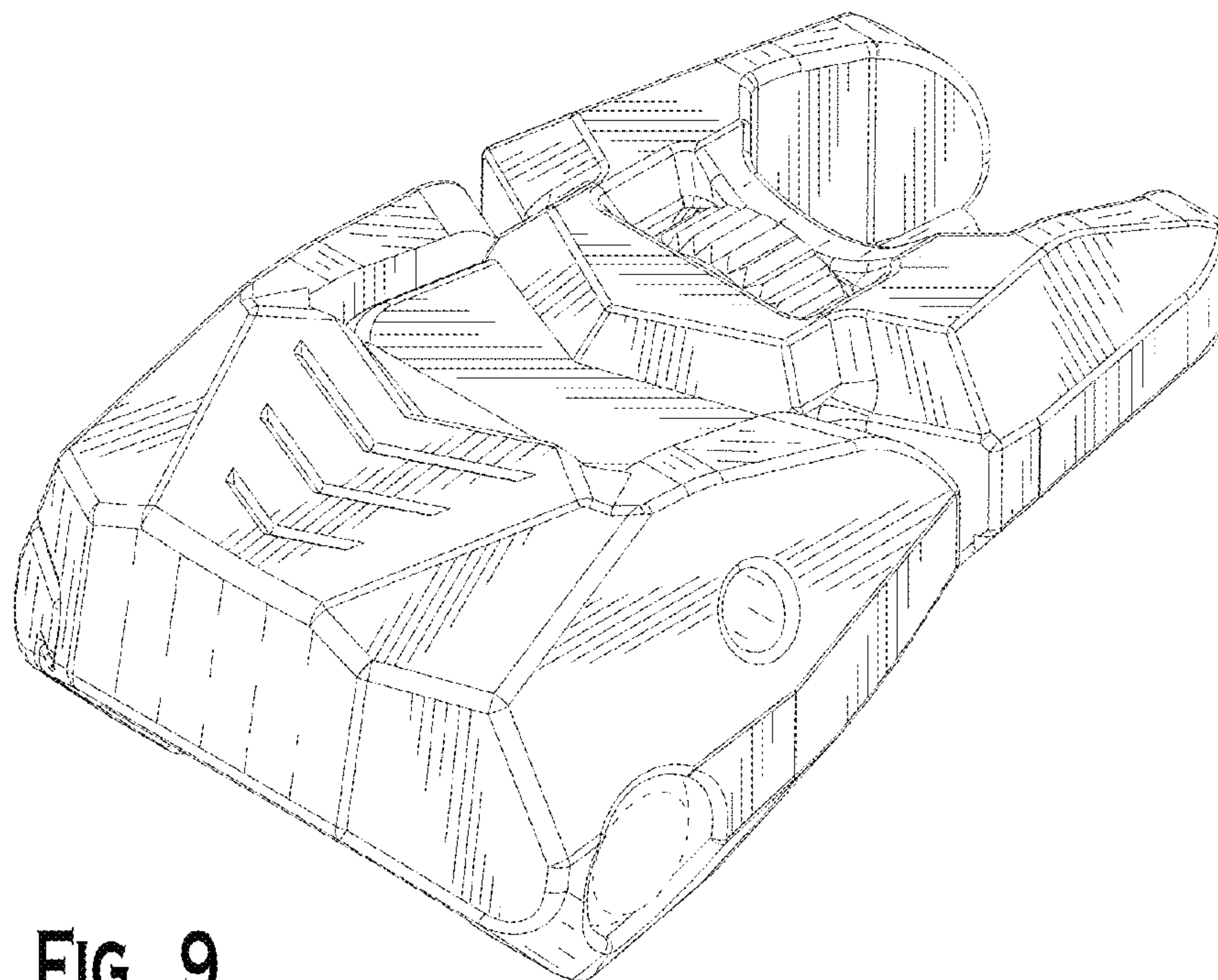

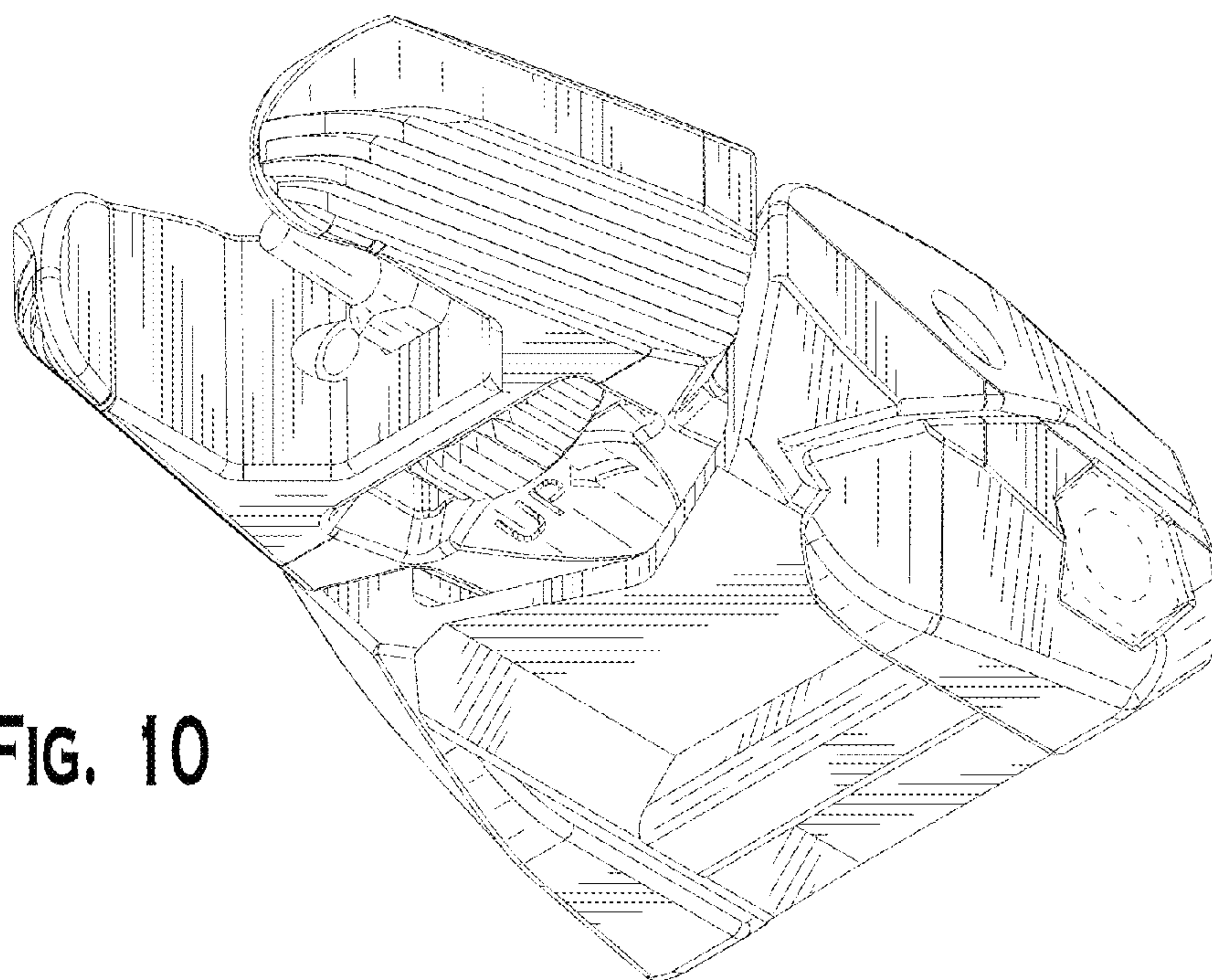

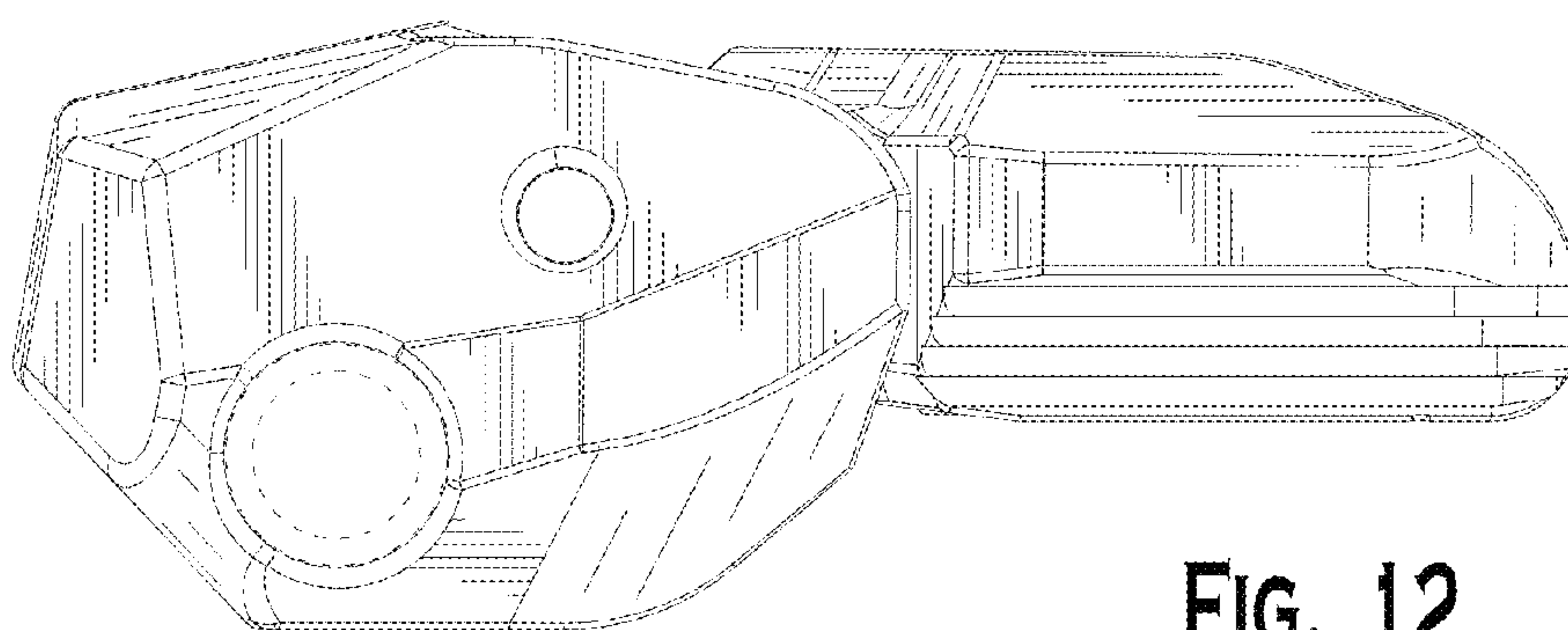
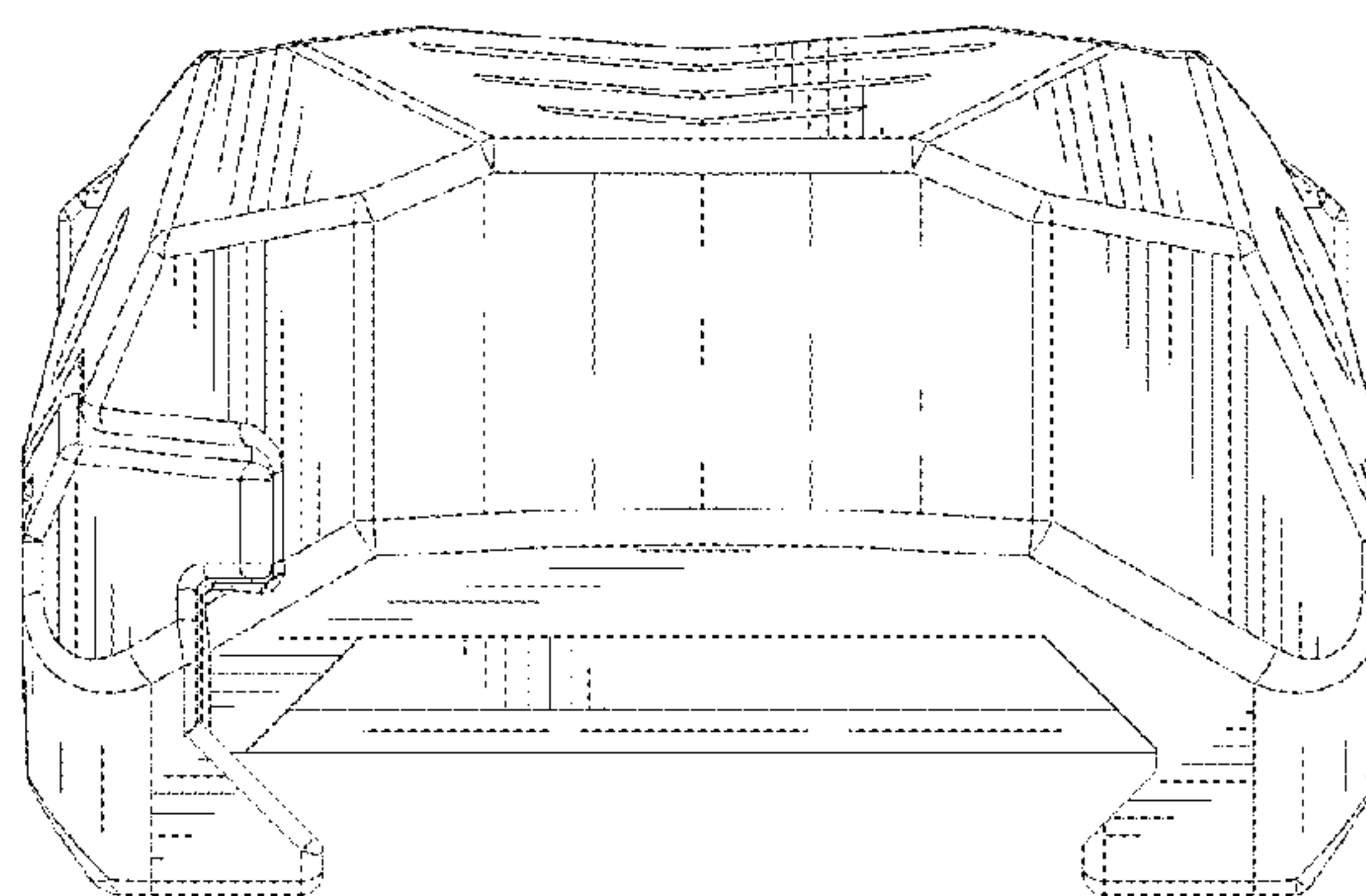

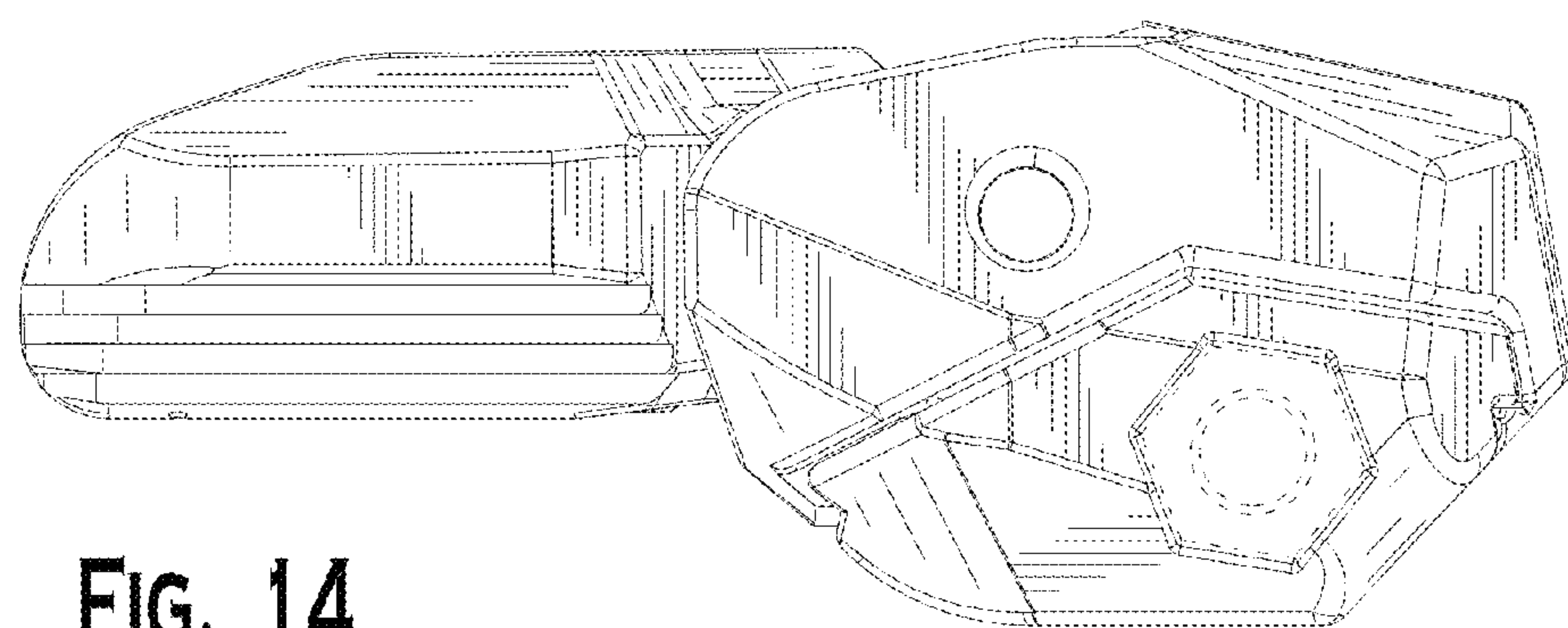
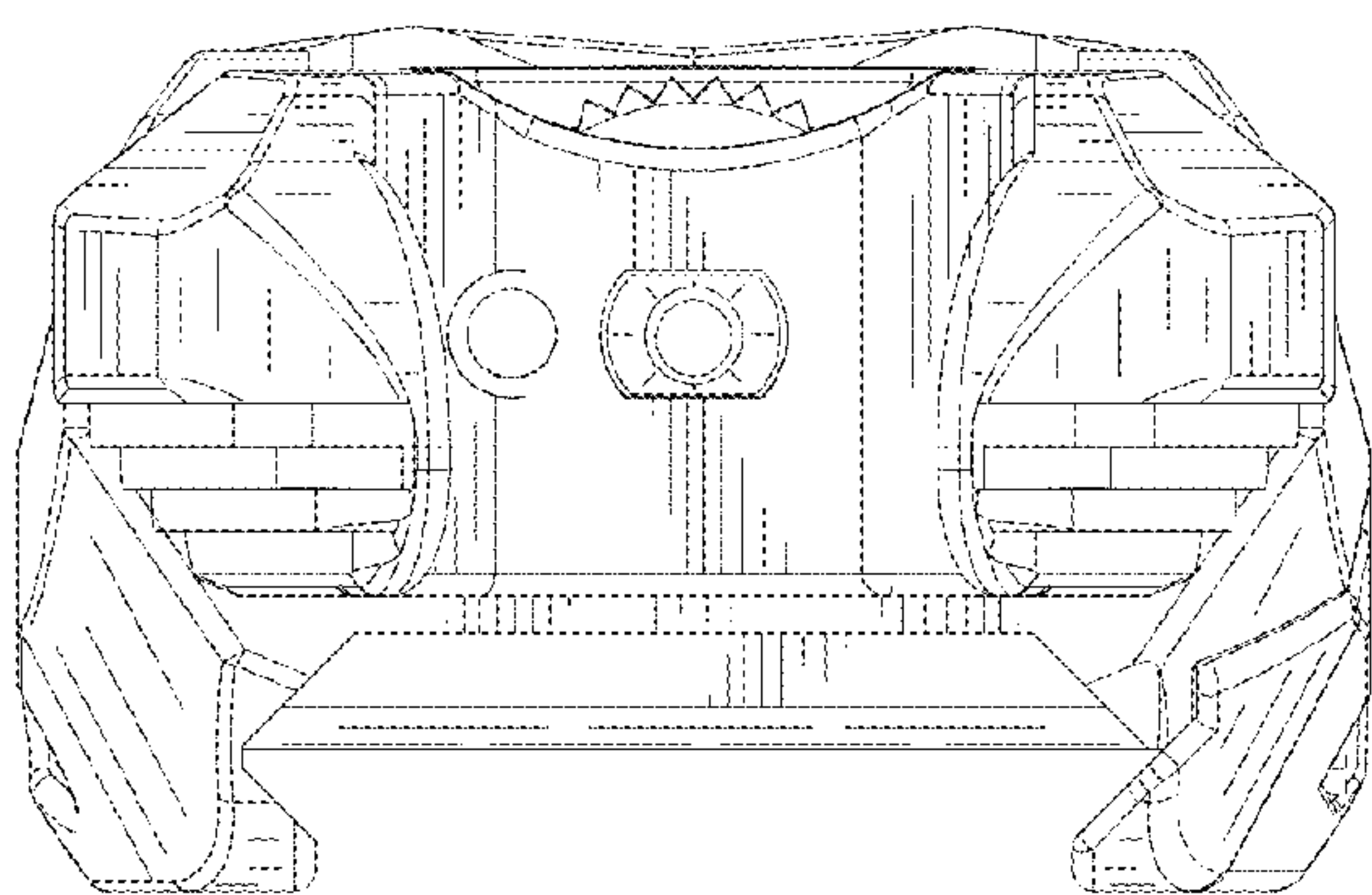

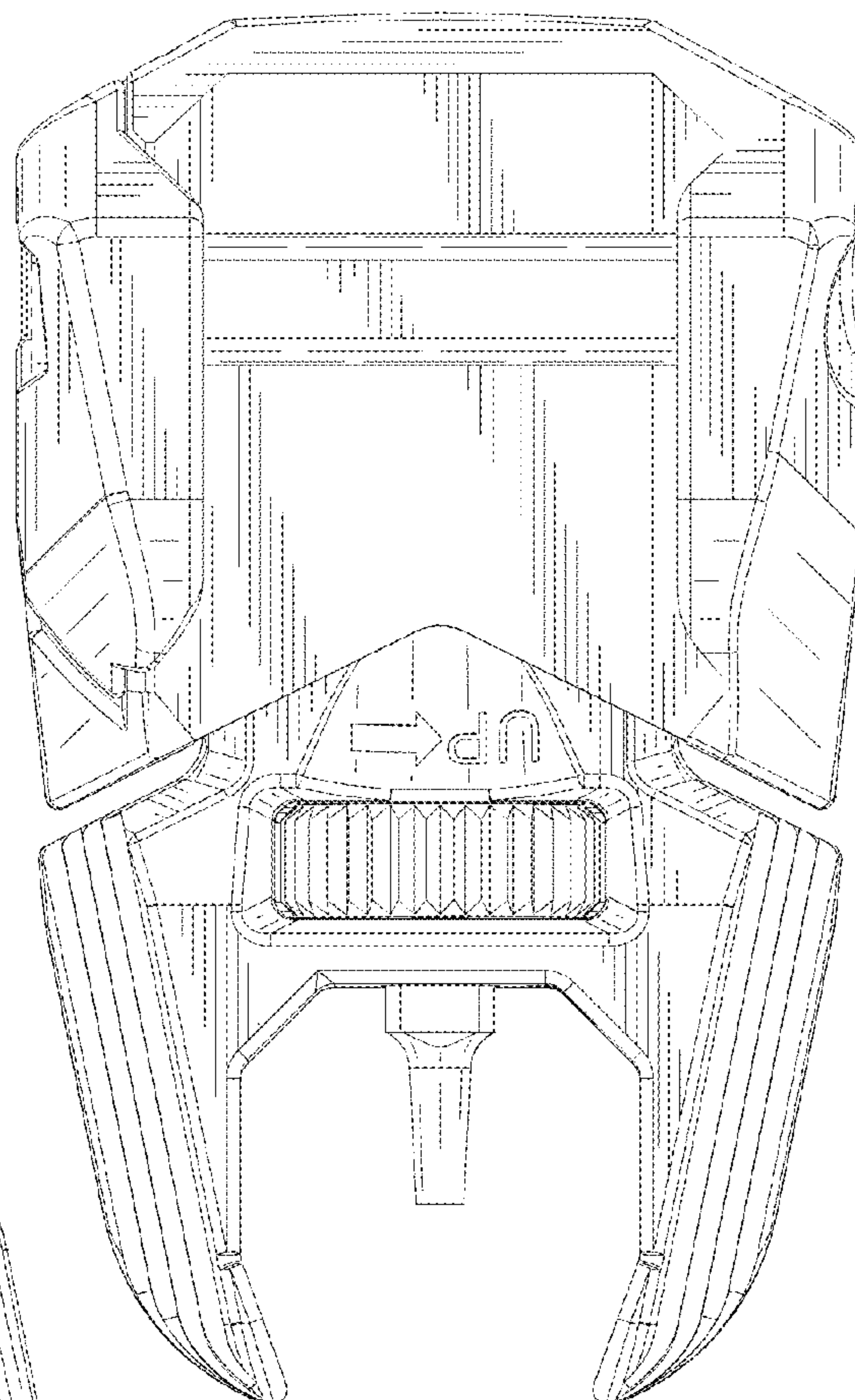
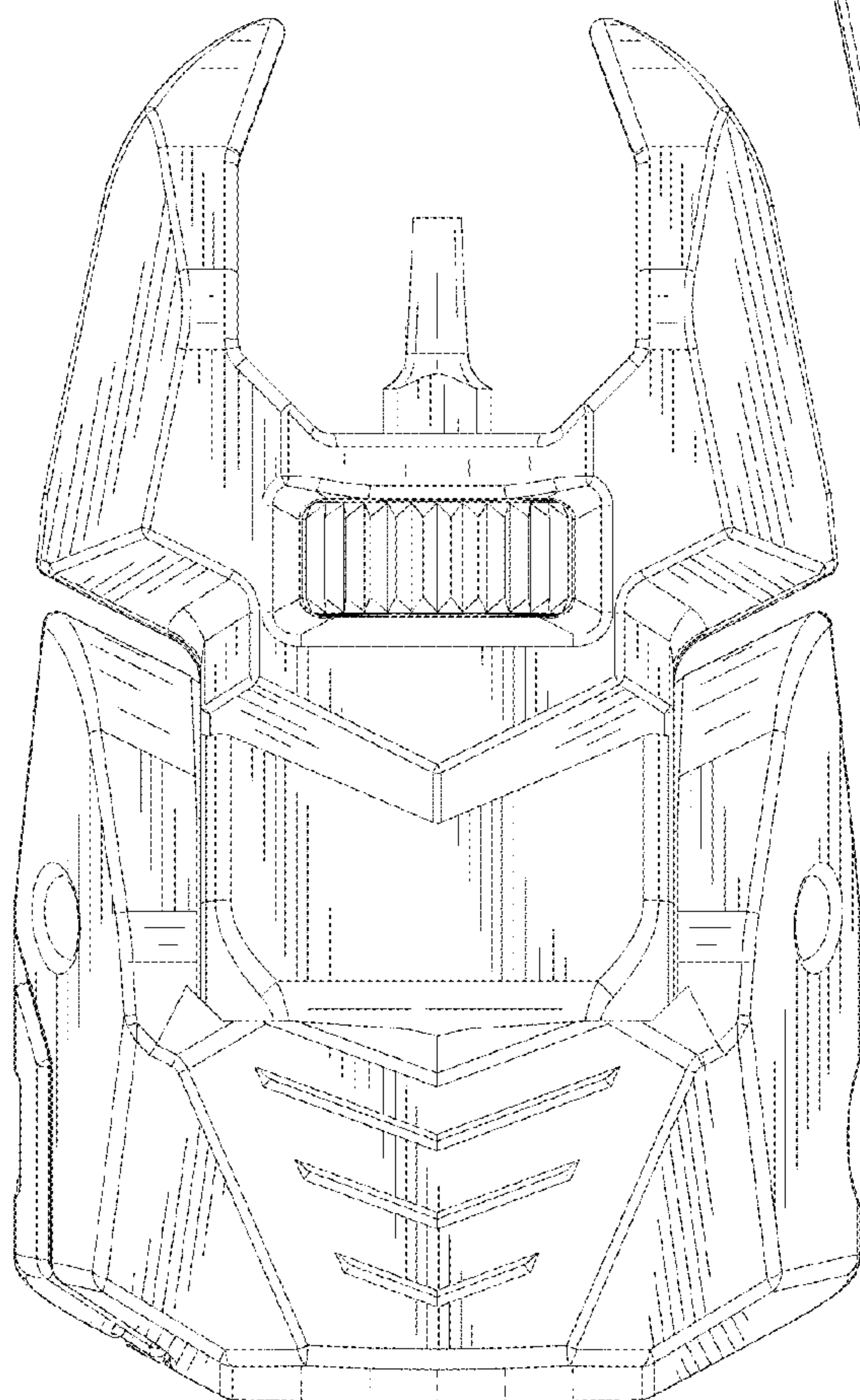
