(57) **CLAIM**  
The ornamental design for an air freshener, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the air freshener showing a plug exploded from the container and without labels;  
 FIG. 2 is a left side elevation view thereof;  
 FIG. 3 is a front elevation view thereof;  
 FIG. 4 is a right side elevation view thereof;  
 FIG. 5 is a rear elevation view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a perspective view of a second embodiment of the air freshener without labels and the plug exploded from the container;  
 FIG. 9 is a left side elevation view thereof; and,  
 FIG. 10 is a top plan view thereof.

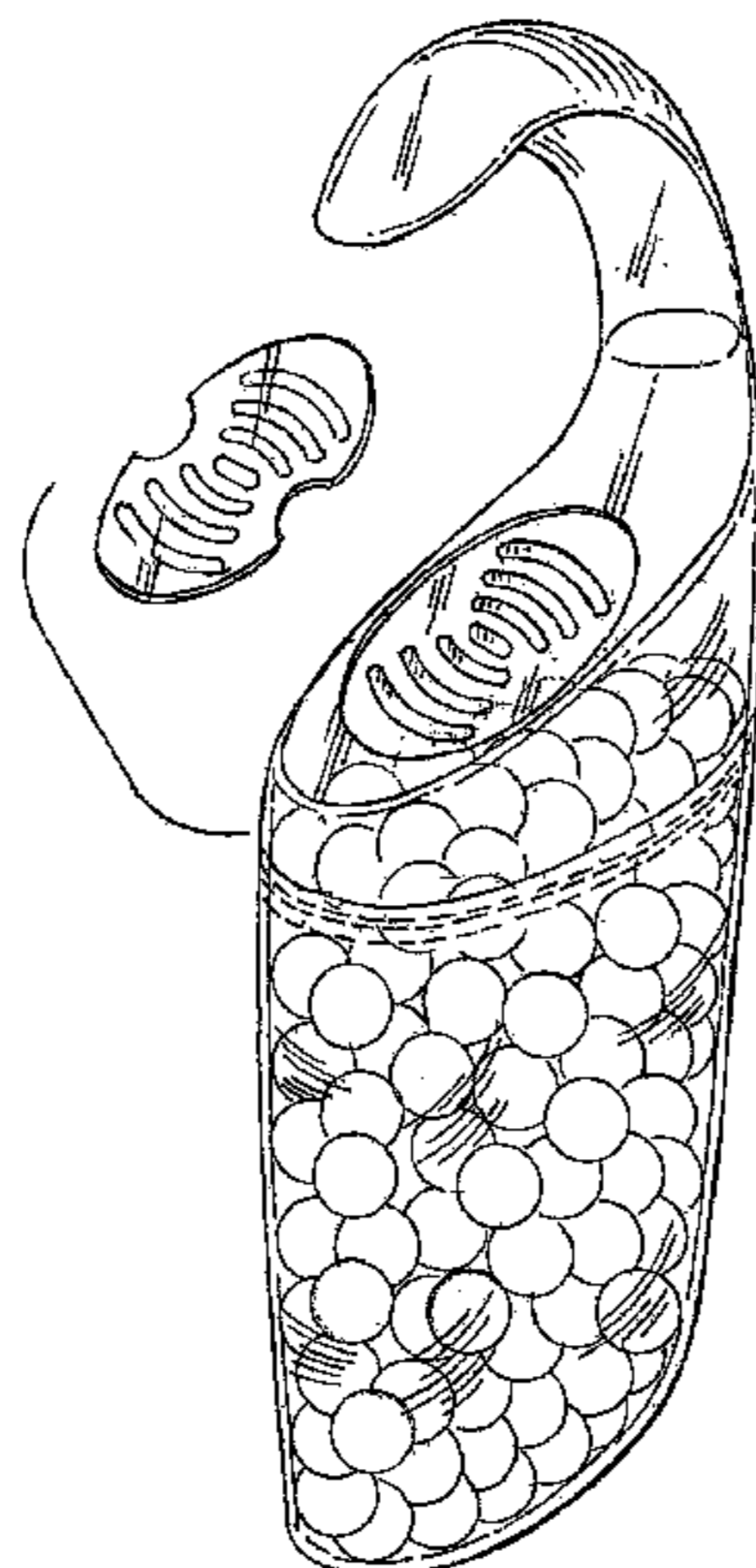

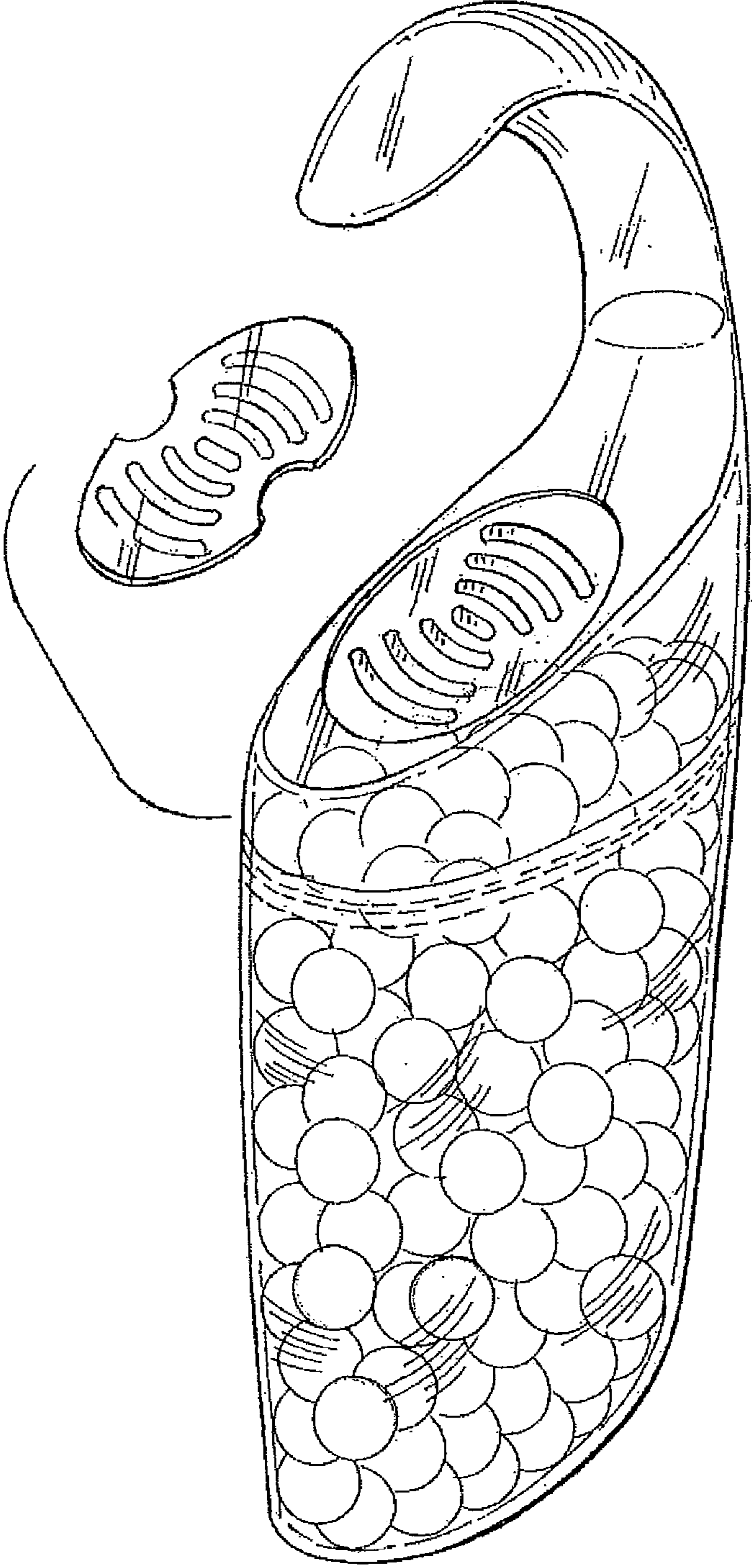

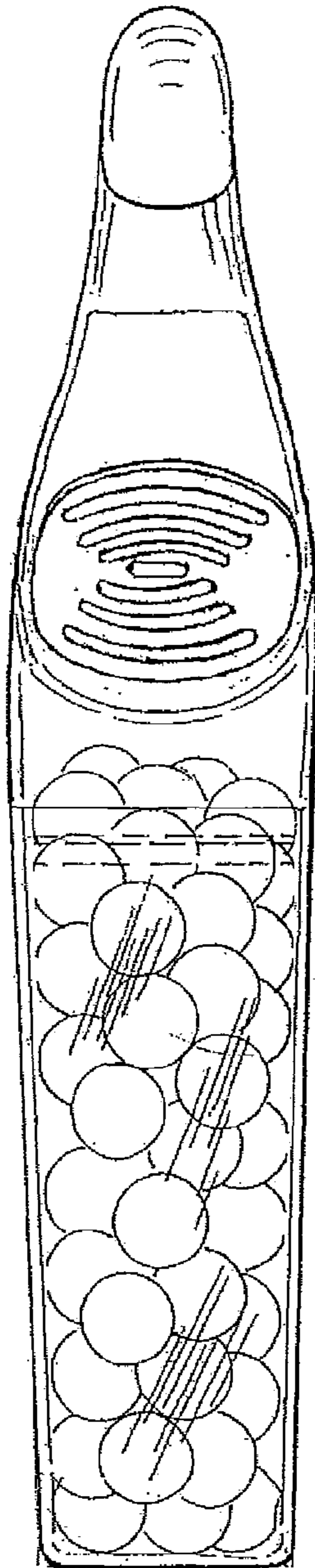

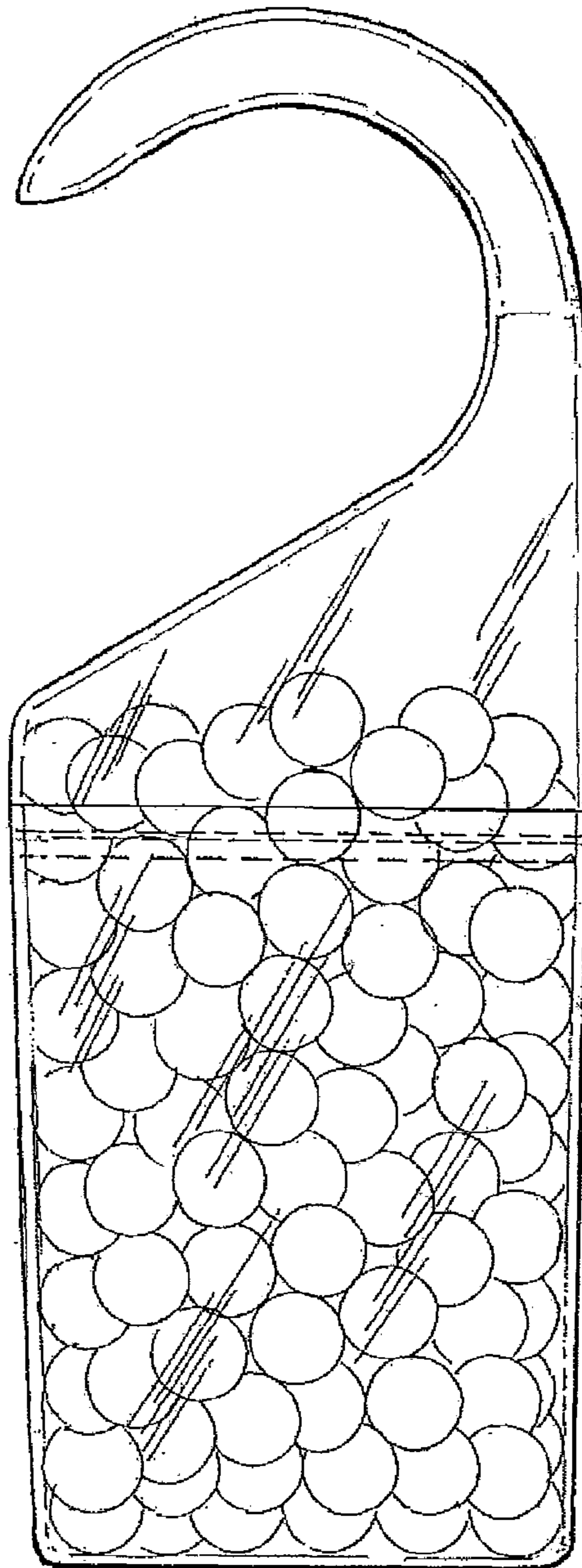

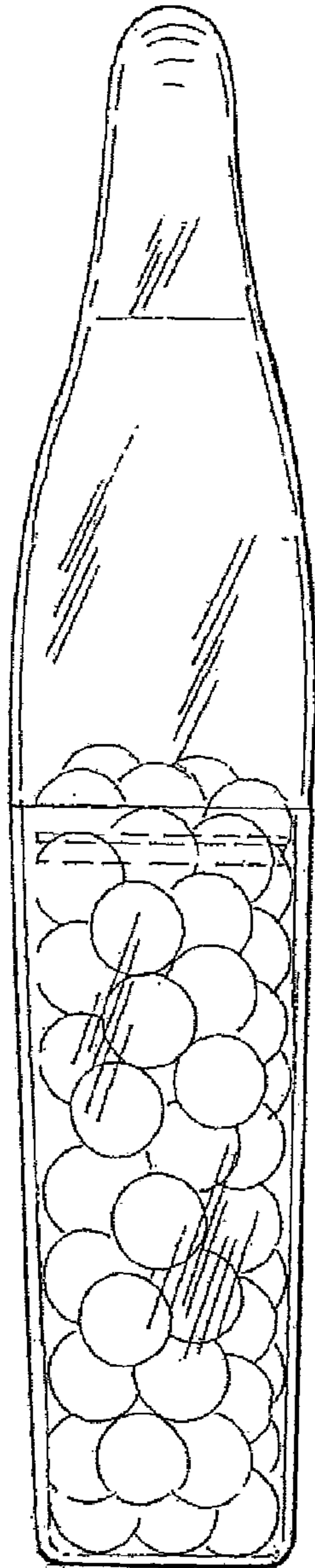

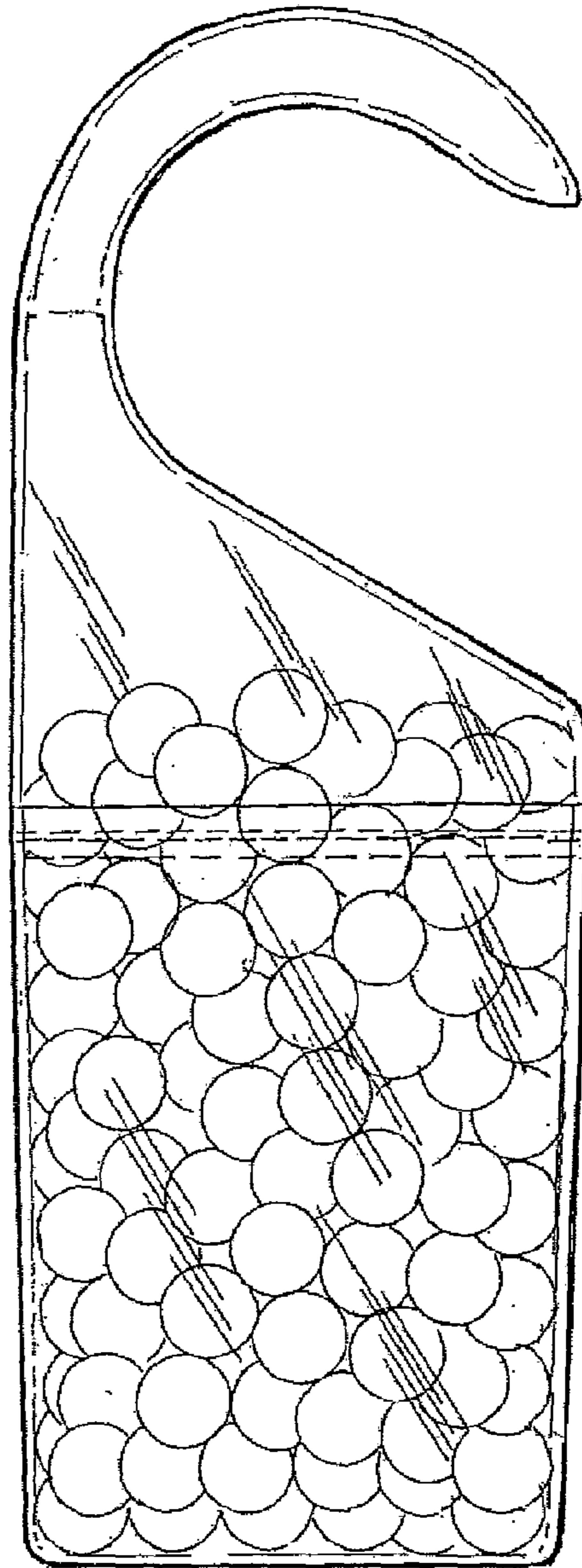

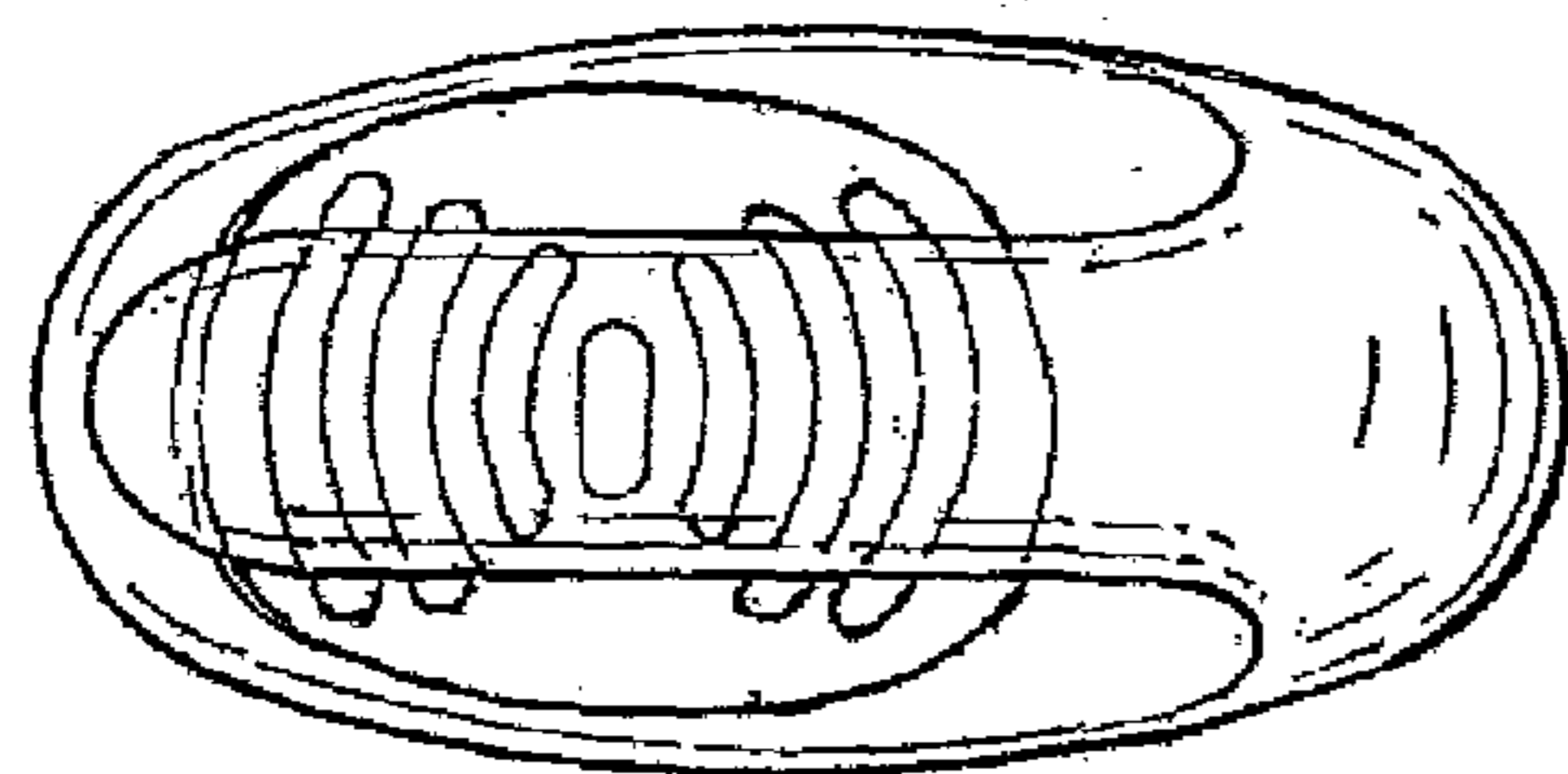

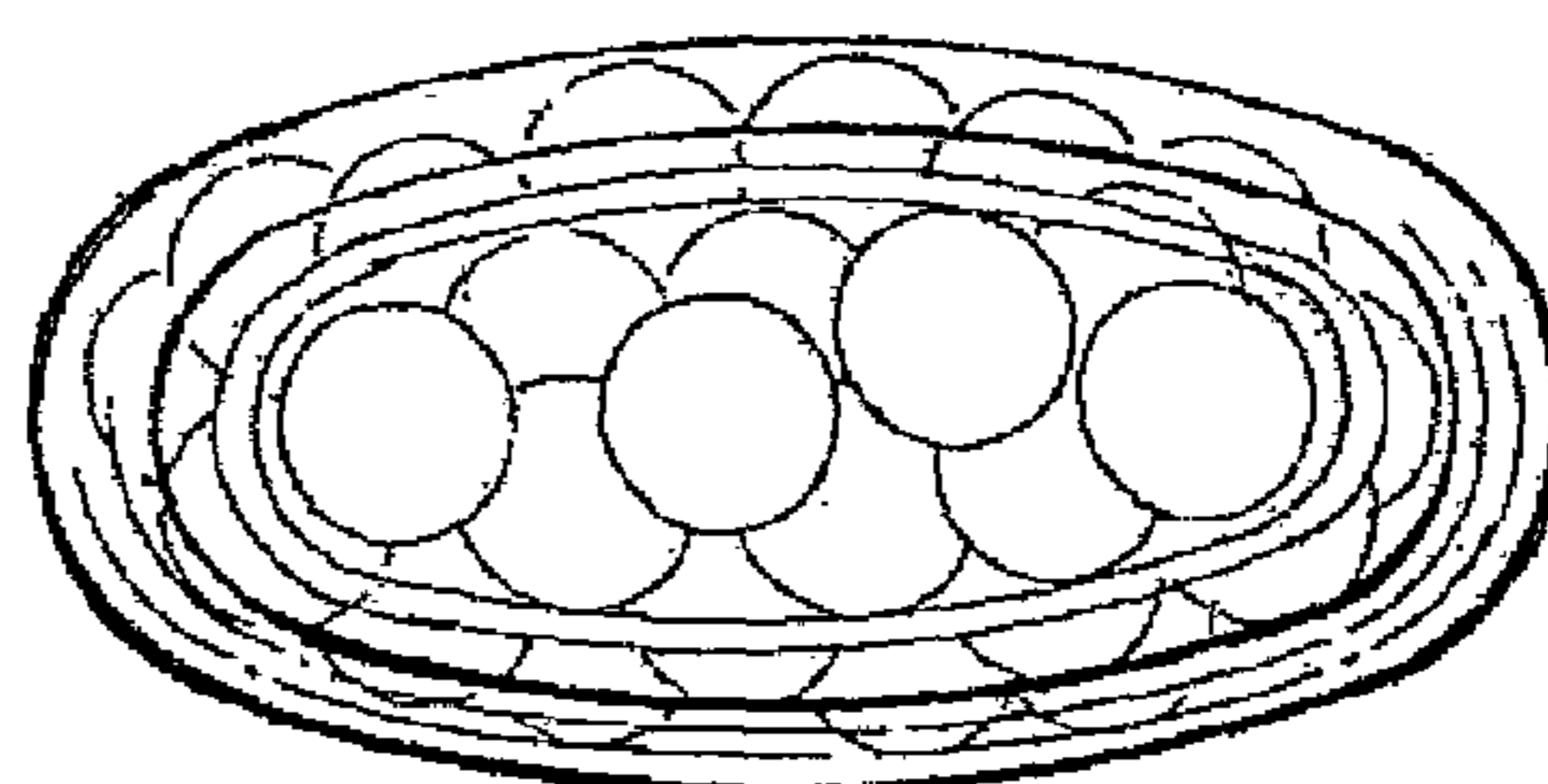

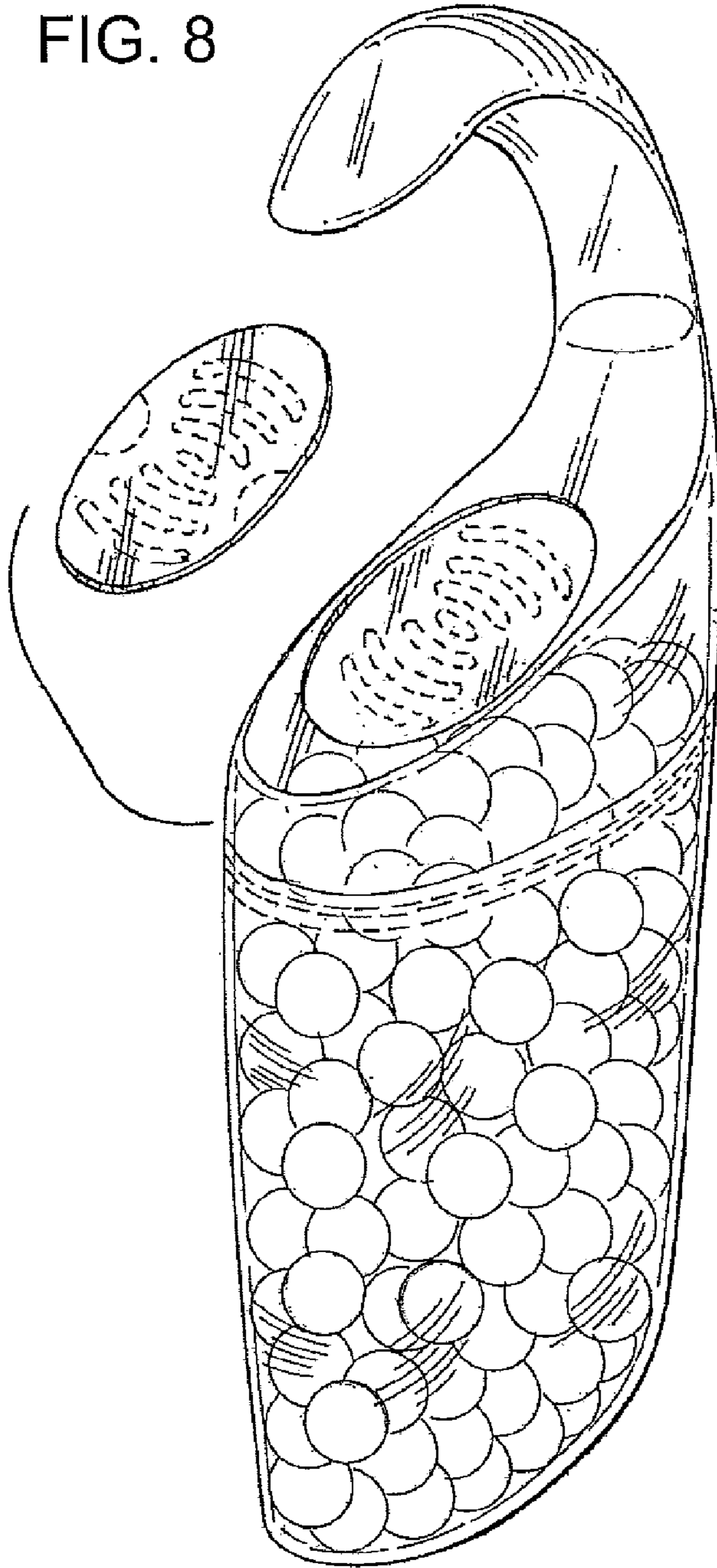

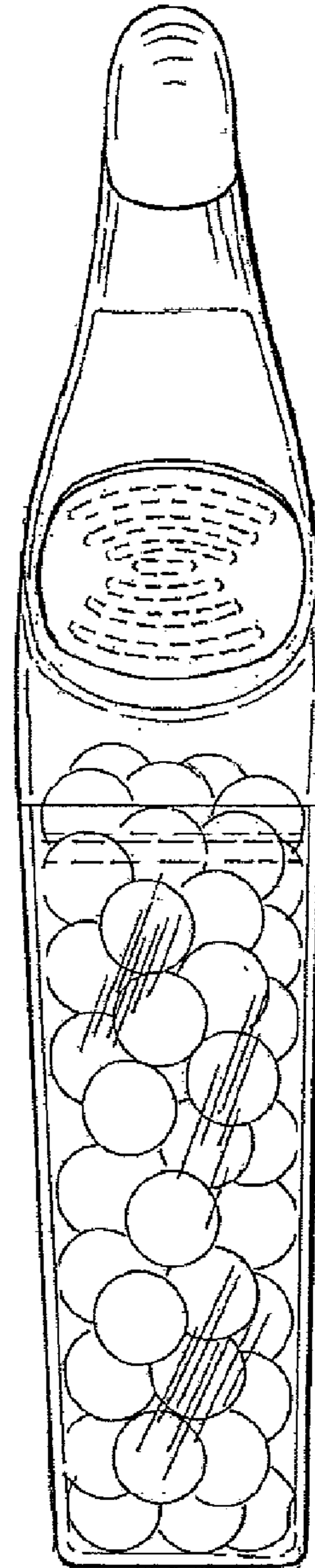
