DESCRIPTION

FIG. 1 is a perspective view of the sports bra as worn by a woman according to the present invention;

FIG. 4 is a side elevation view thereof;

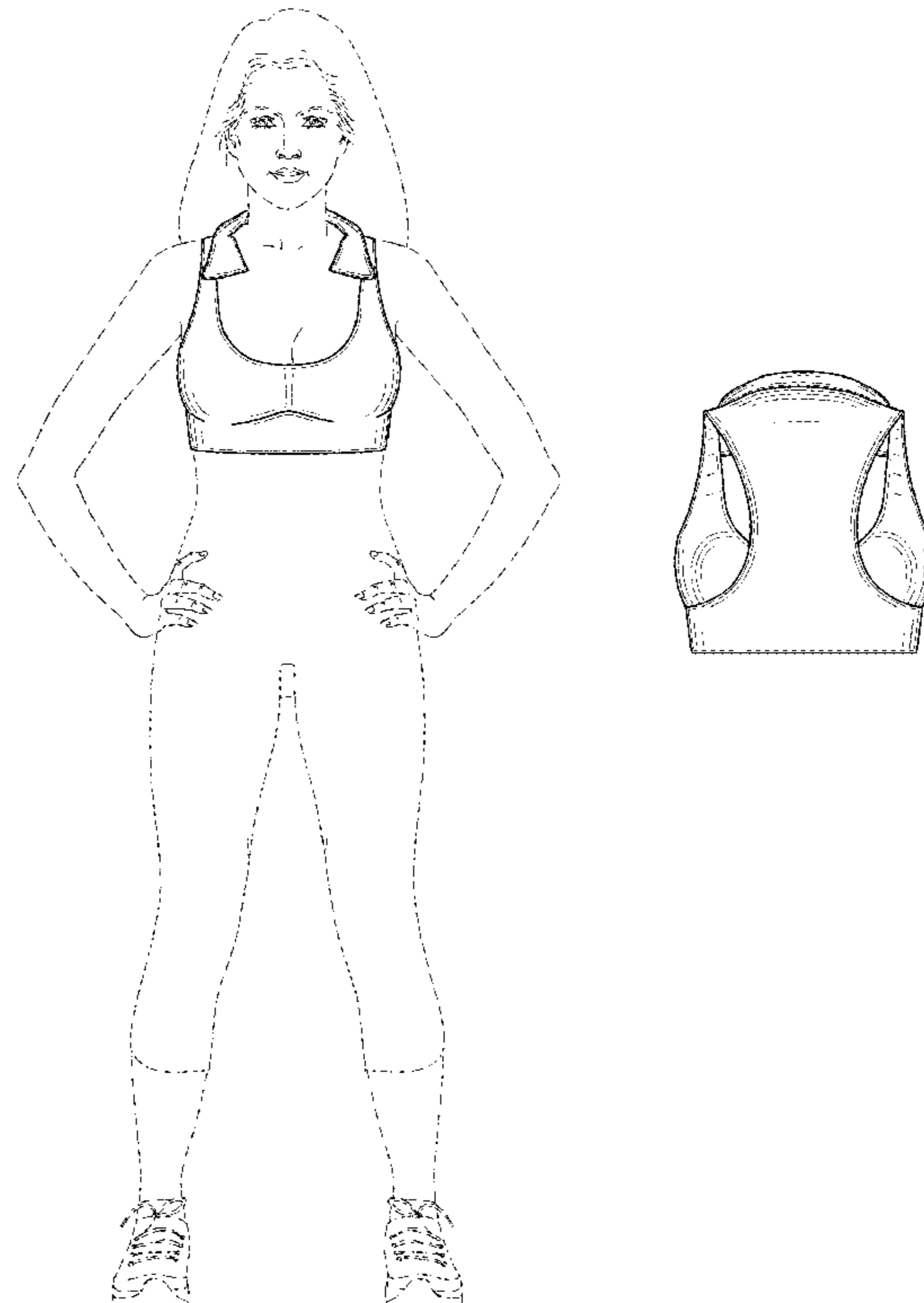
FIG. 5 is an opposite side elevation view of that shown in FIG. 4;

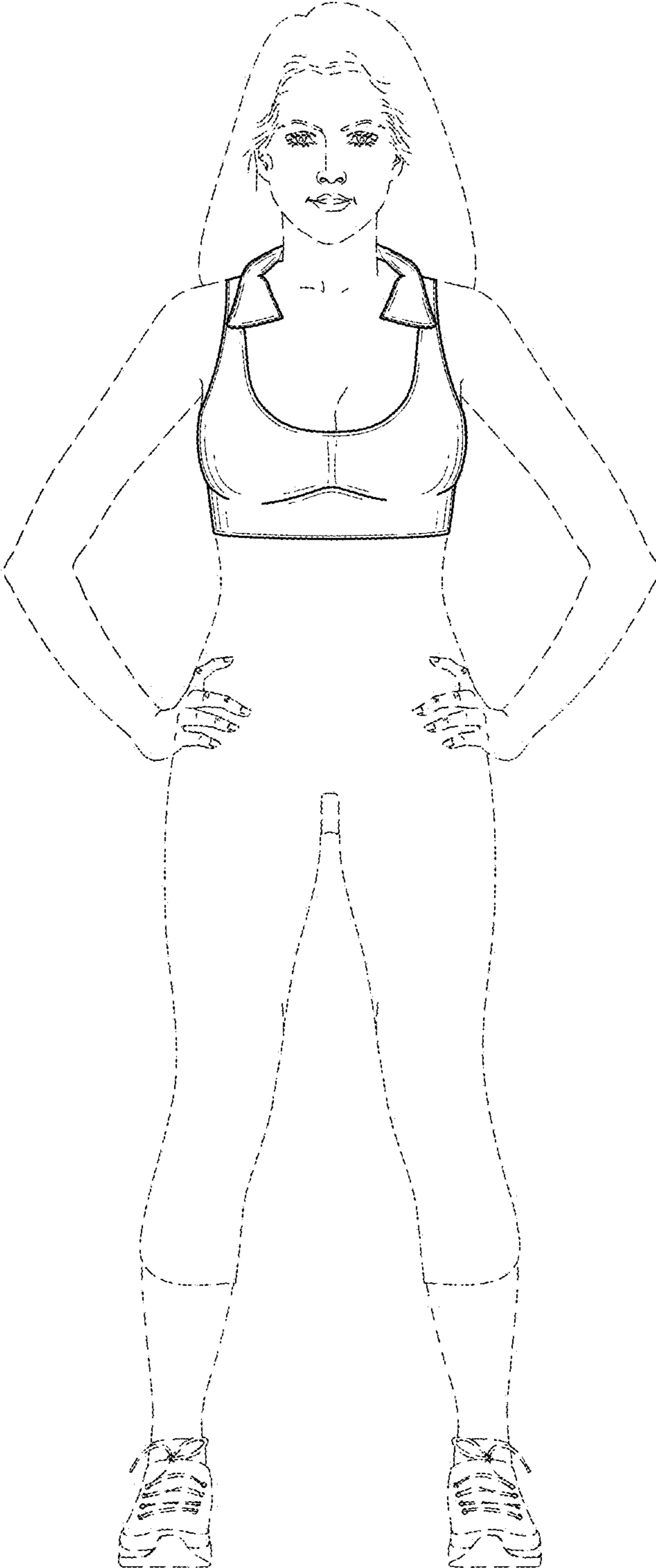

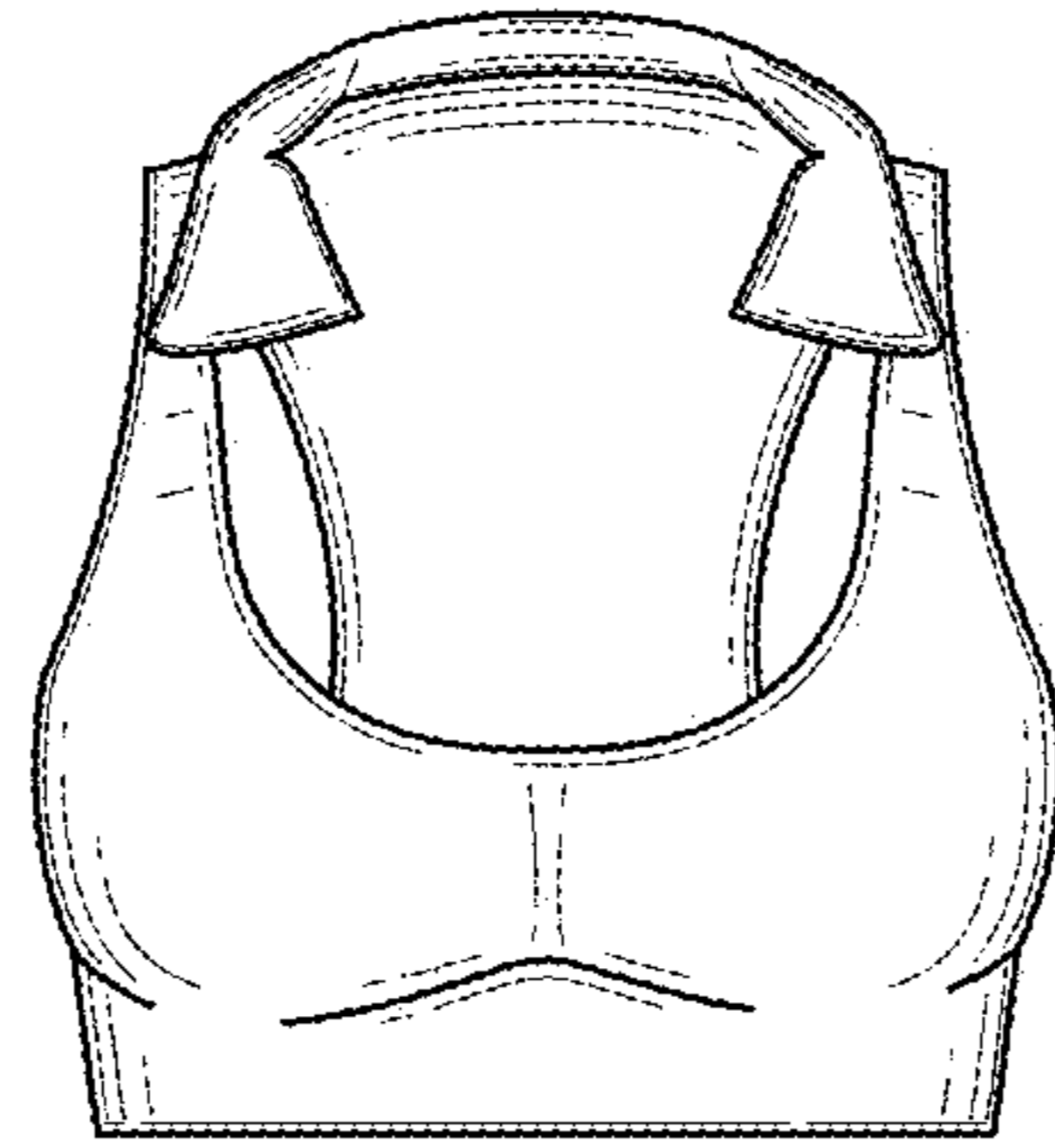

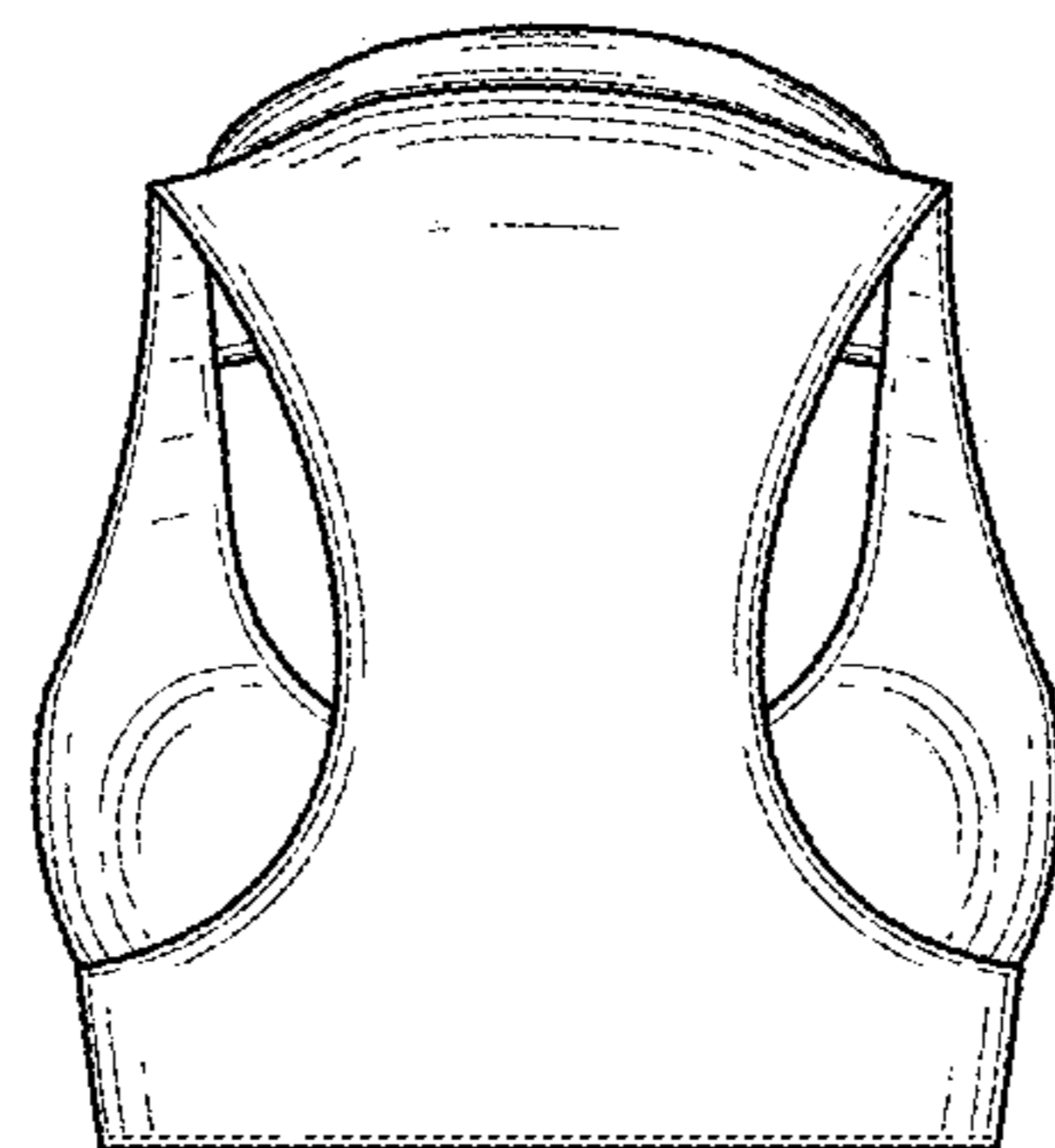

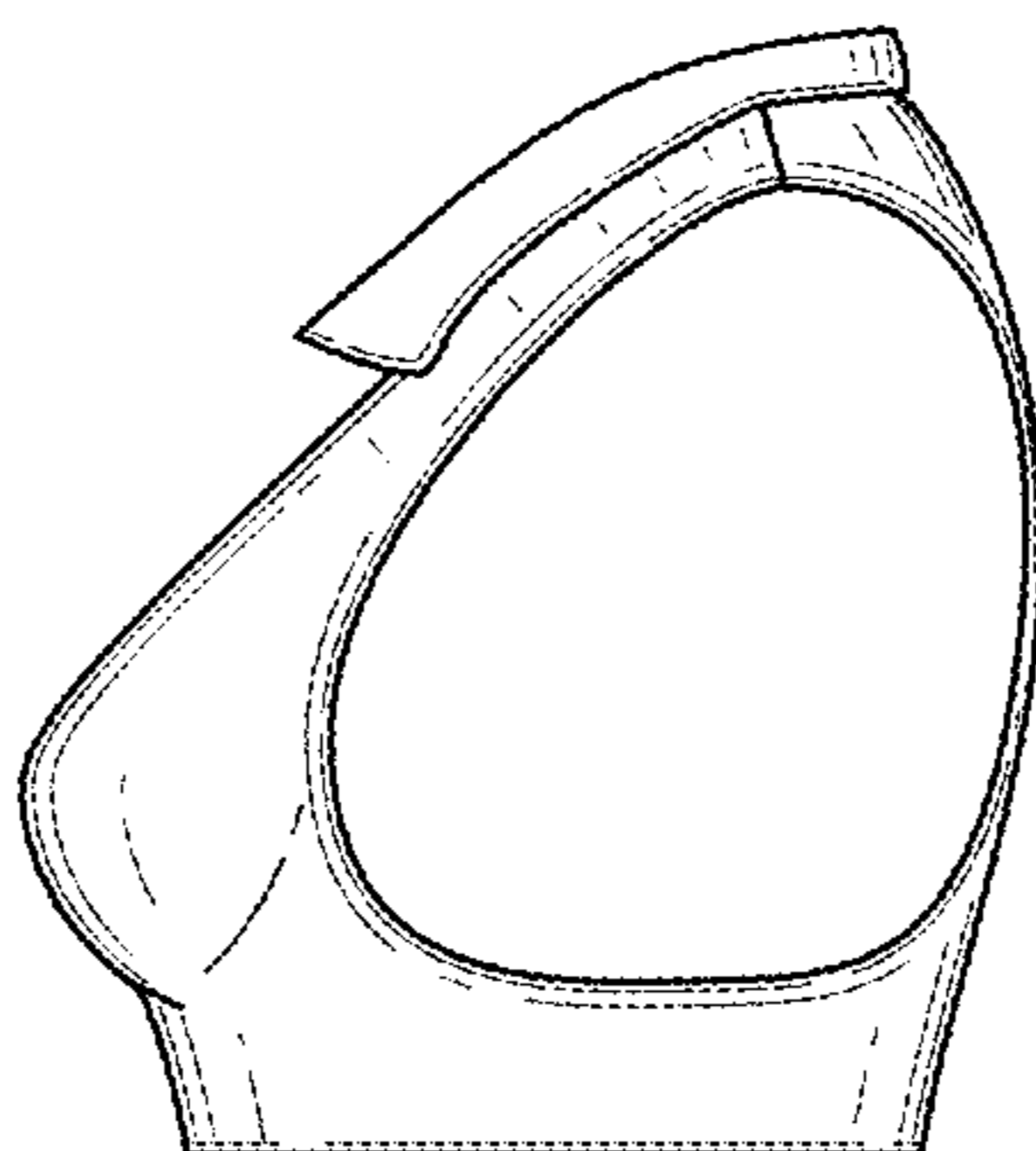

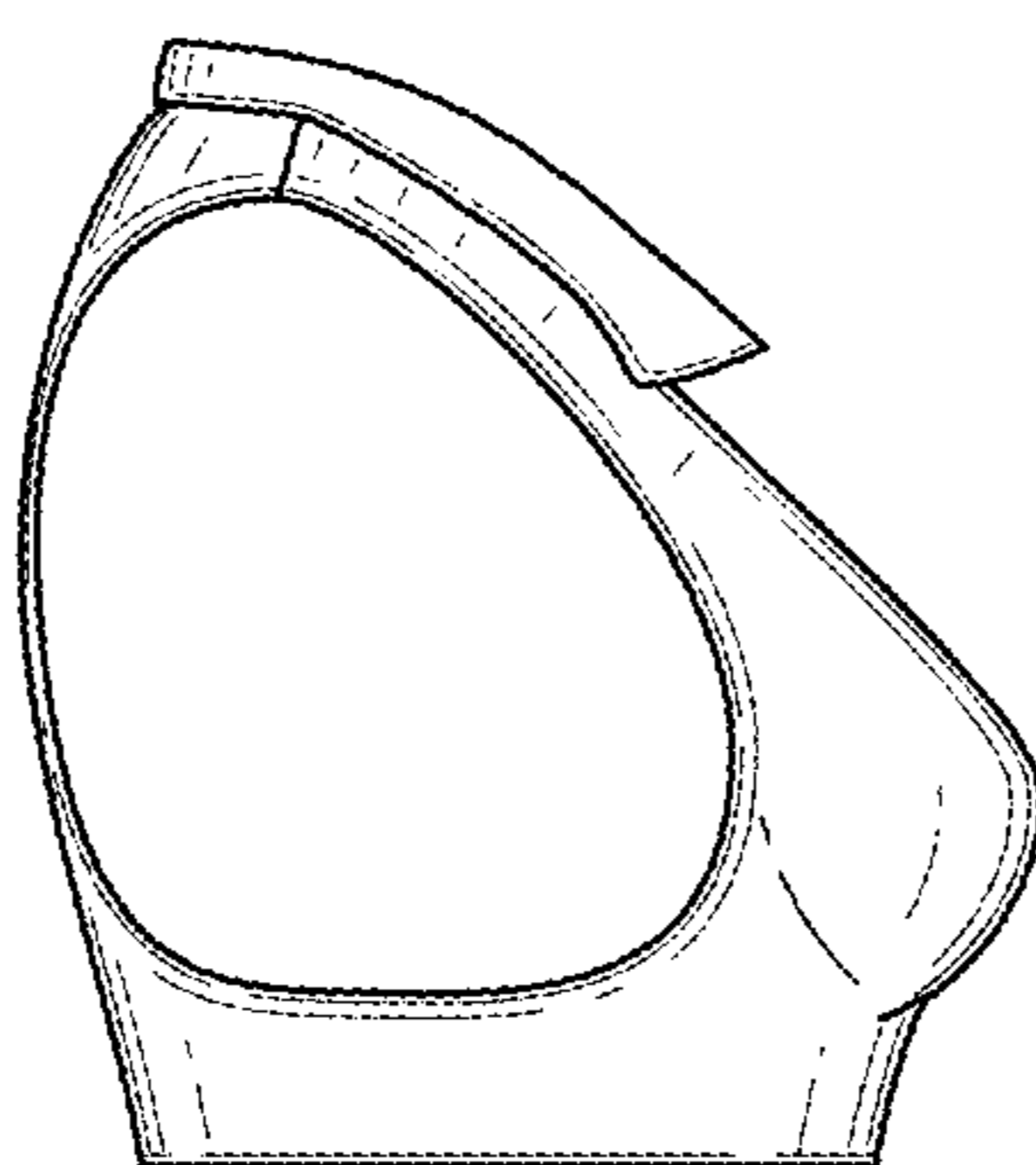

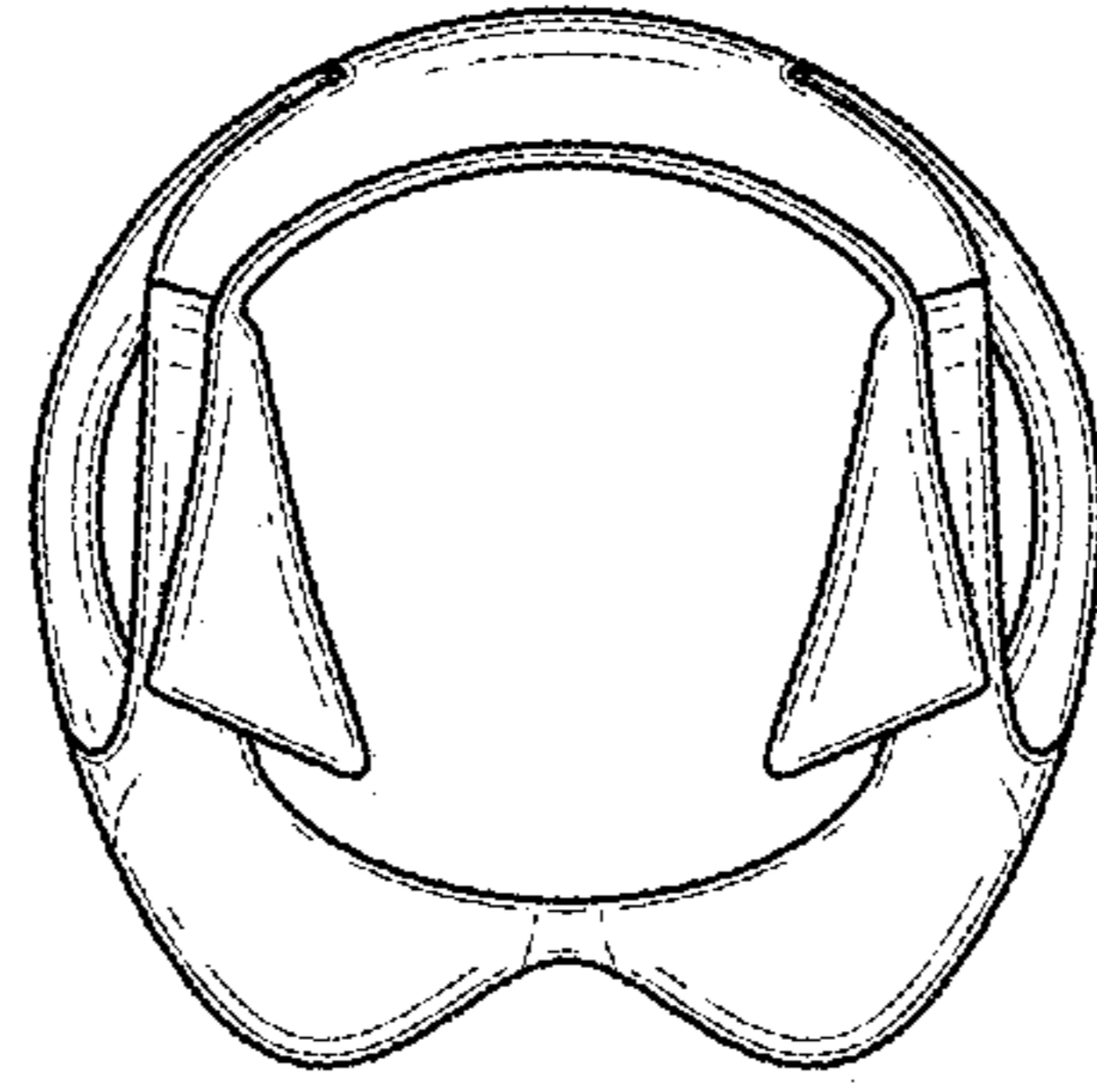

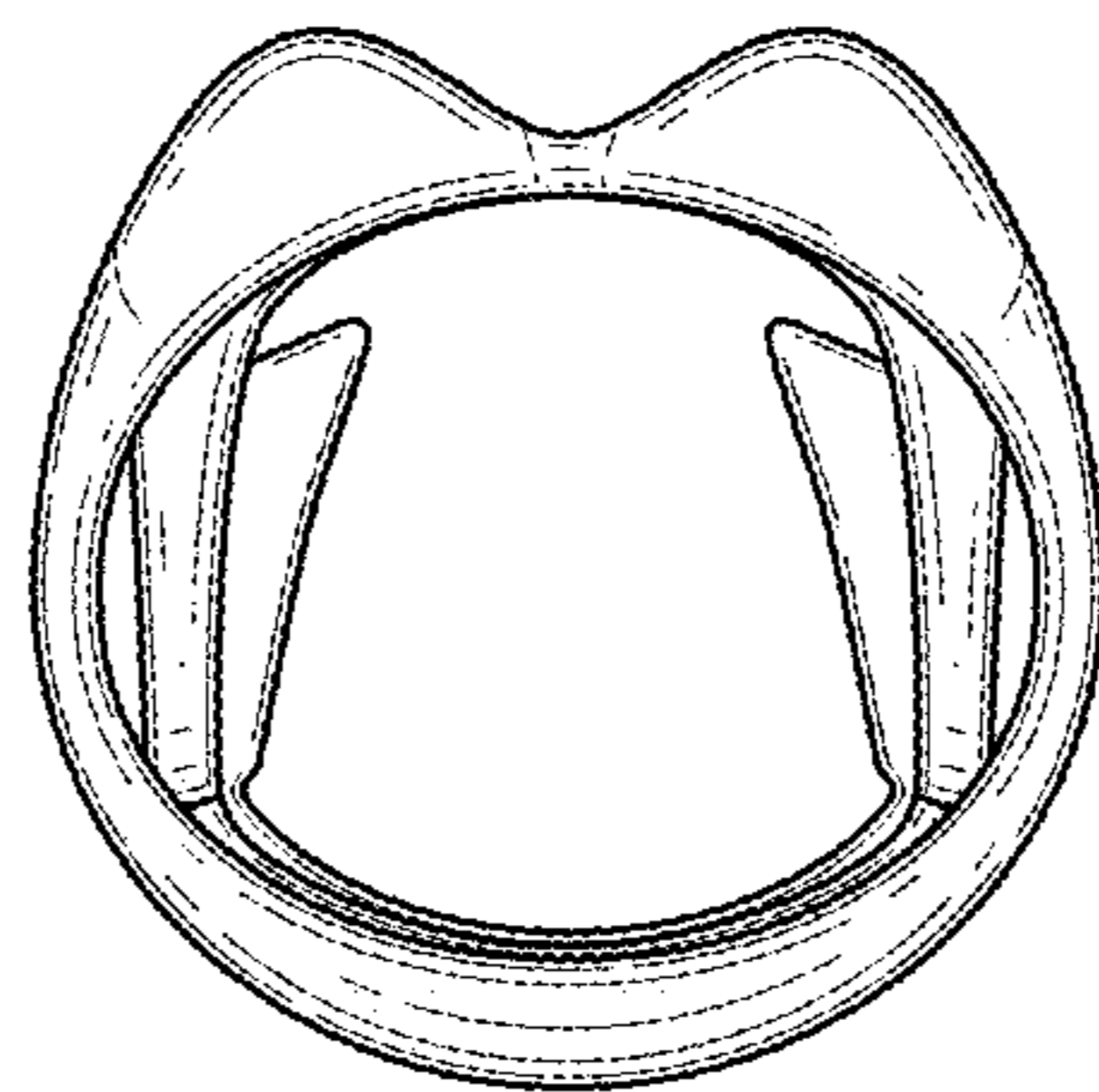
