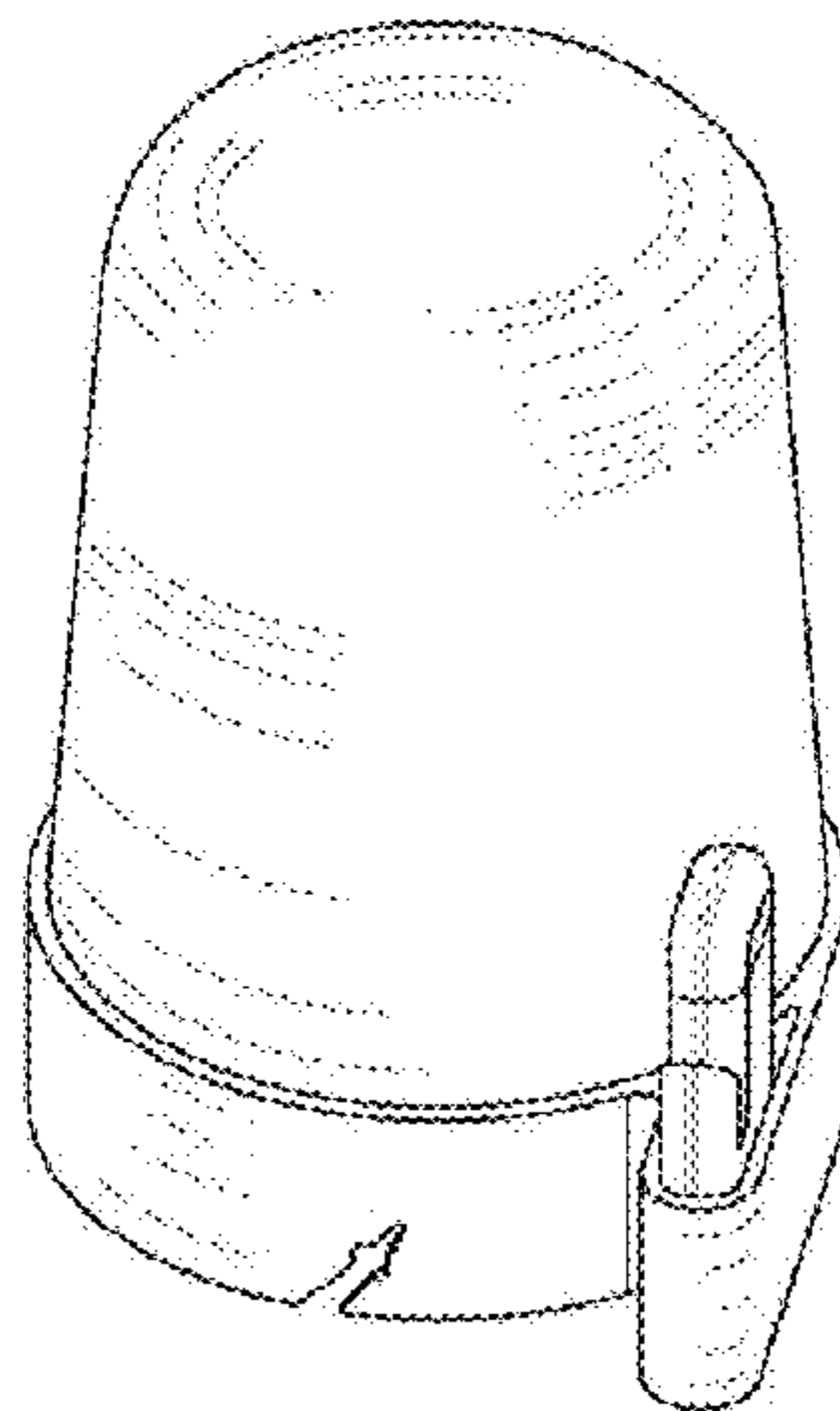
(57) **CLAIM**

The ornamental design for a twine dispenser with removable cutting device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a twine dispenser with removable cutting device showing our new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a bottom plan view thereof;  
FIG. 7 is a top, front and right perspective view thereof;  
FIG. 8 is a top, front and right perspective view thereof, shown in a use environment;  
FIG. 9 is a front elevational view thereof, shown in a use environment with its lid removed;  
FIG. 10 is a rear elevational view of the cutting device, the twine dispenser removed for ease of illustration;  
FIG. 11 is a rear perspective view thereof; and,  
FIG. 12 is a top plan view thereof.  
The broken lines showing a fragment of thread and a thread roll in FIGS. 8 and 9 are shown to illustrate environment and form no part of the claimed design.

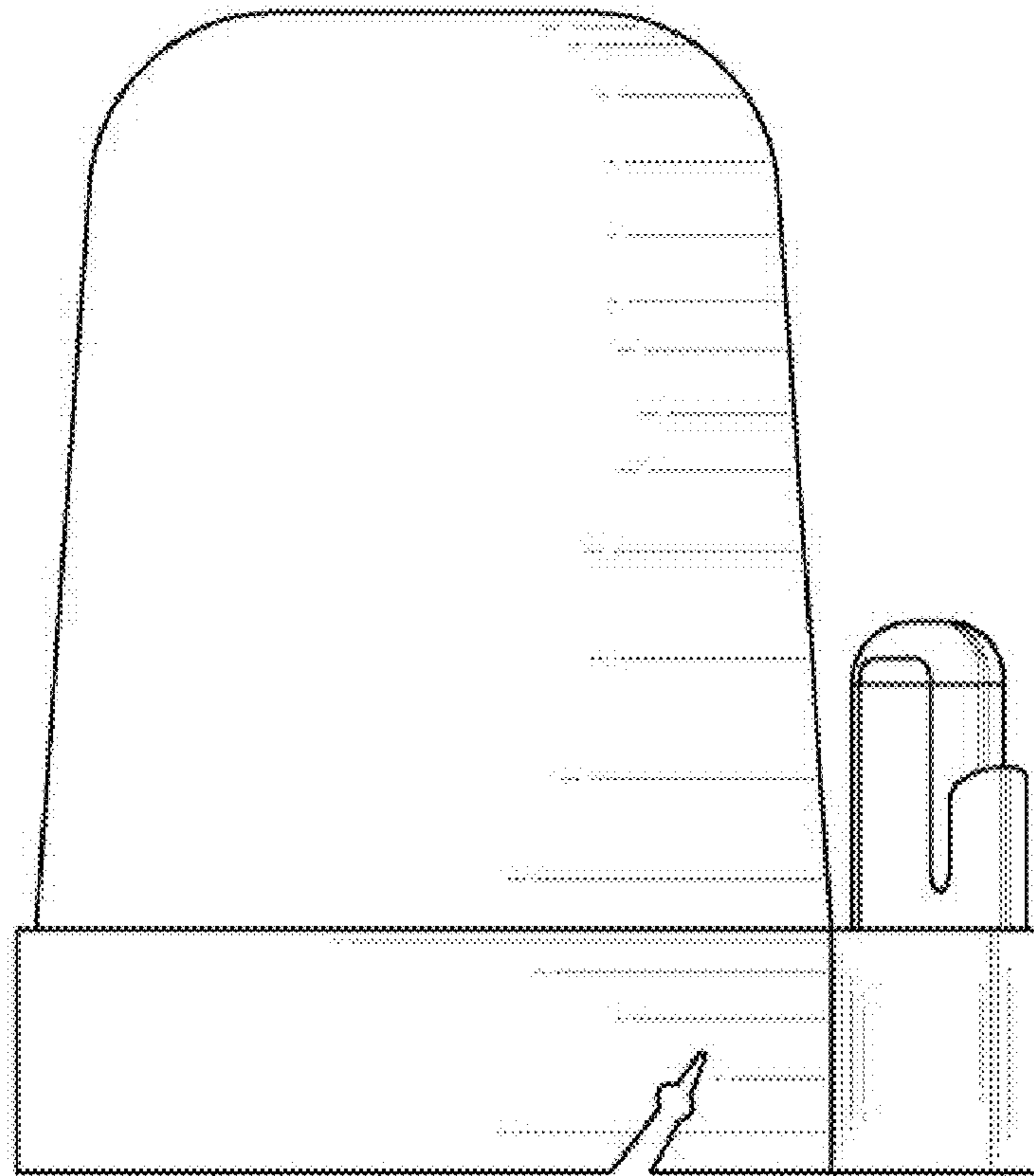

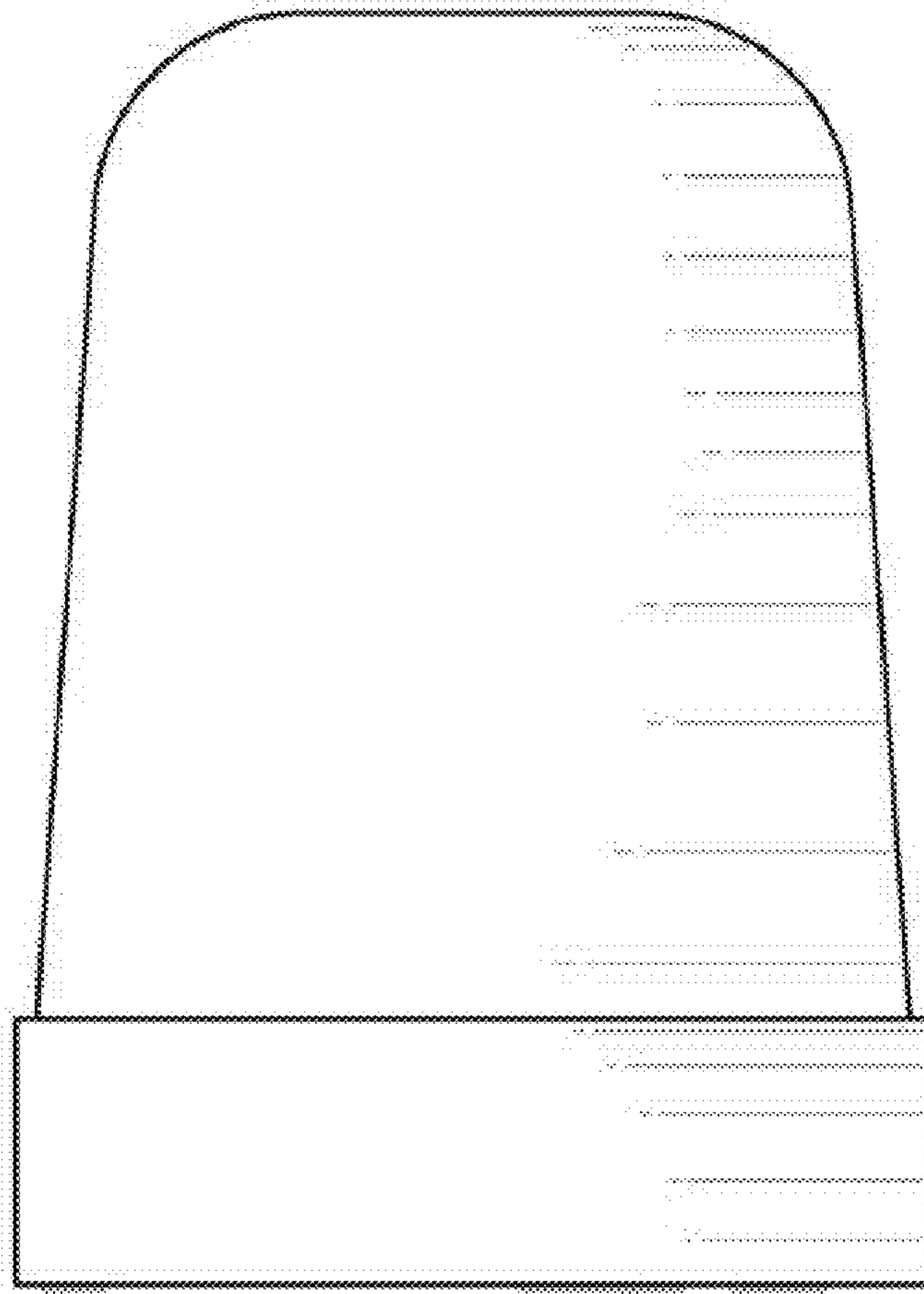

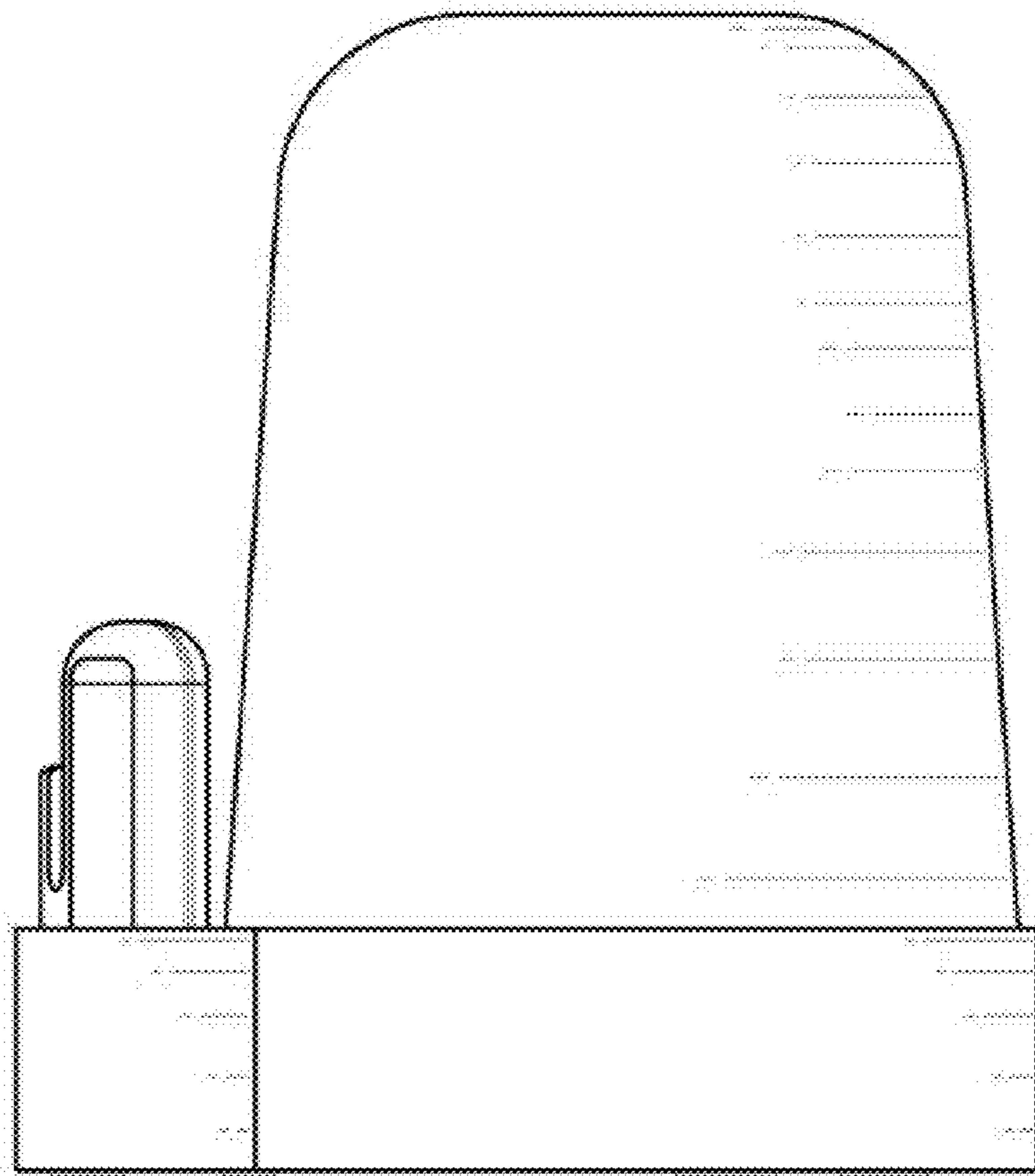

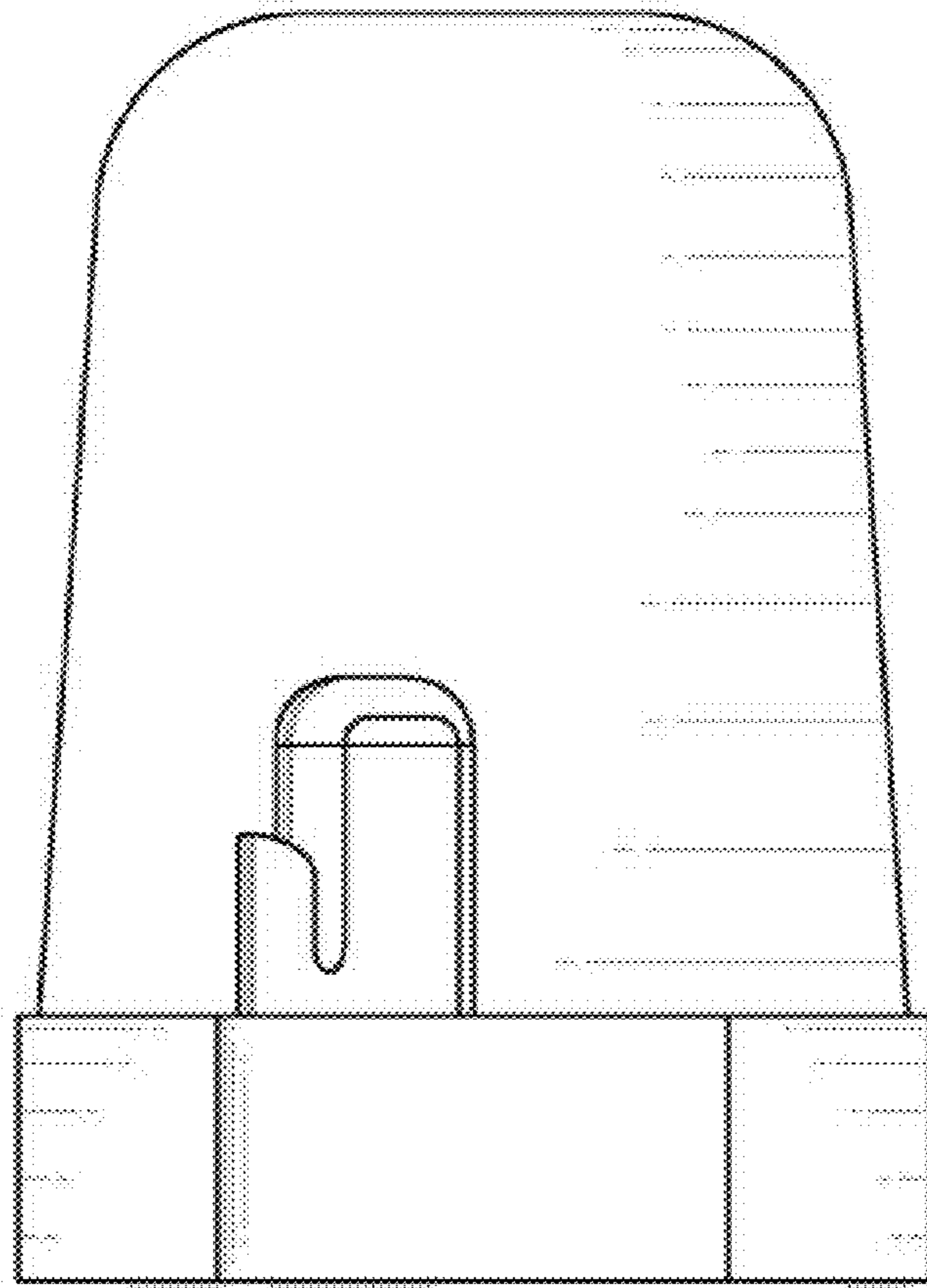

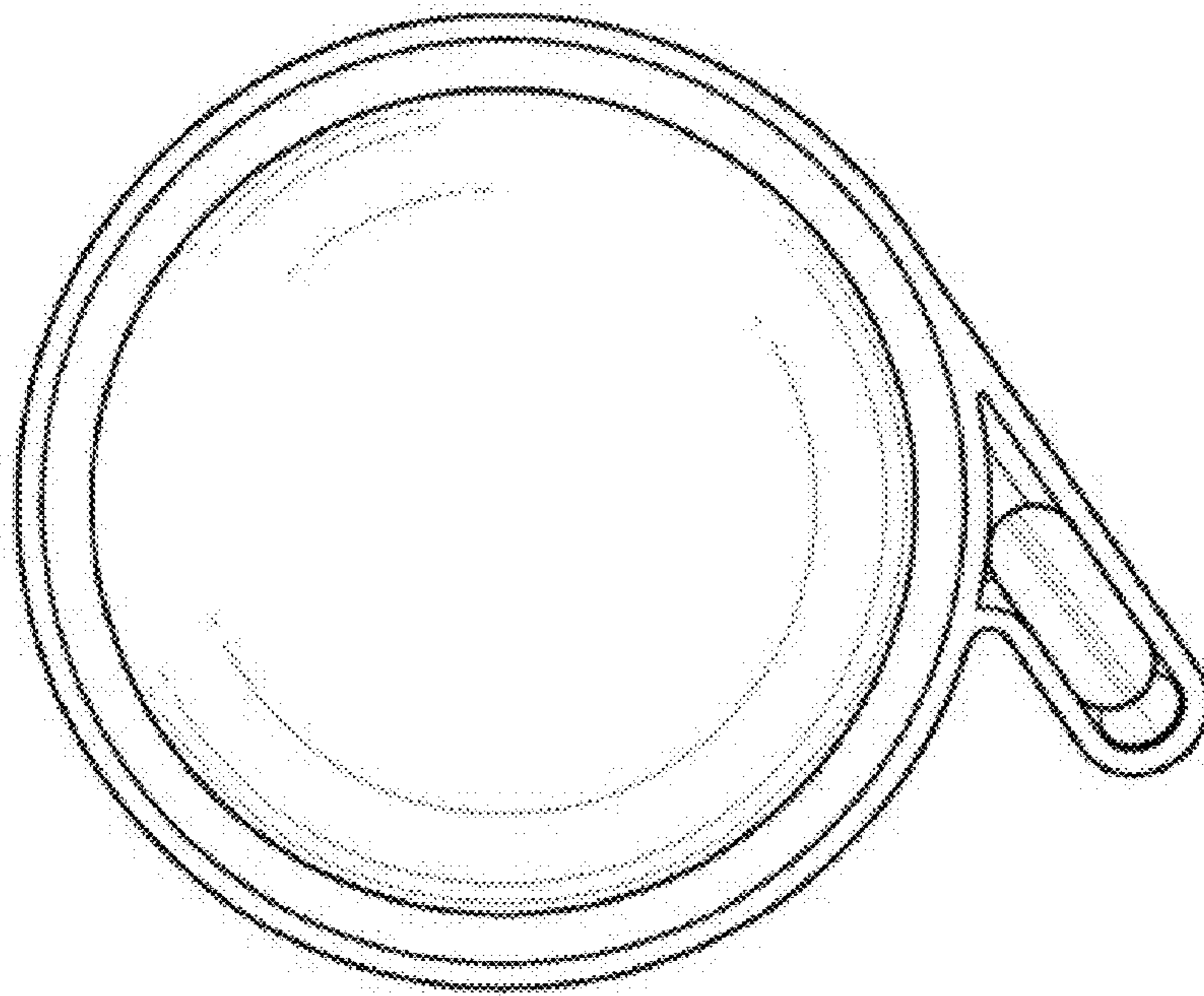

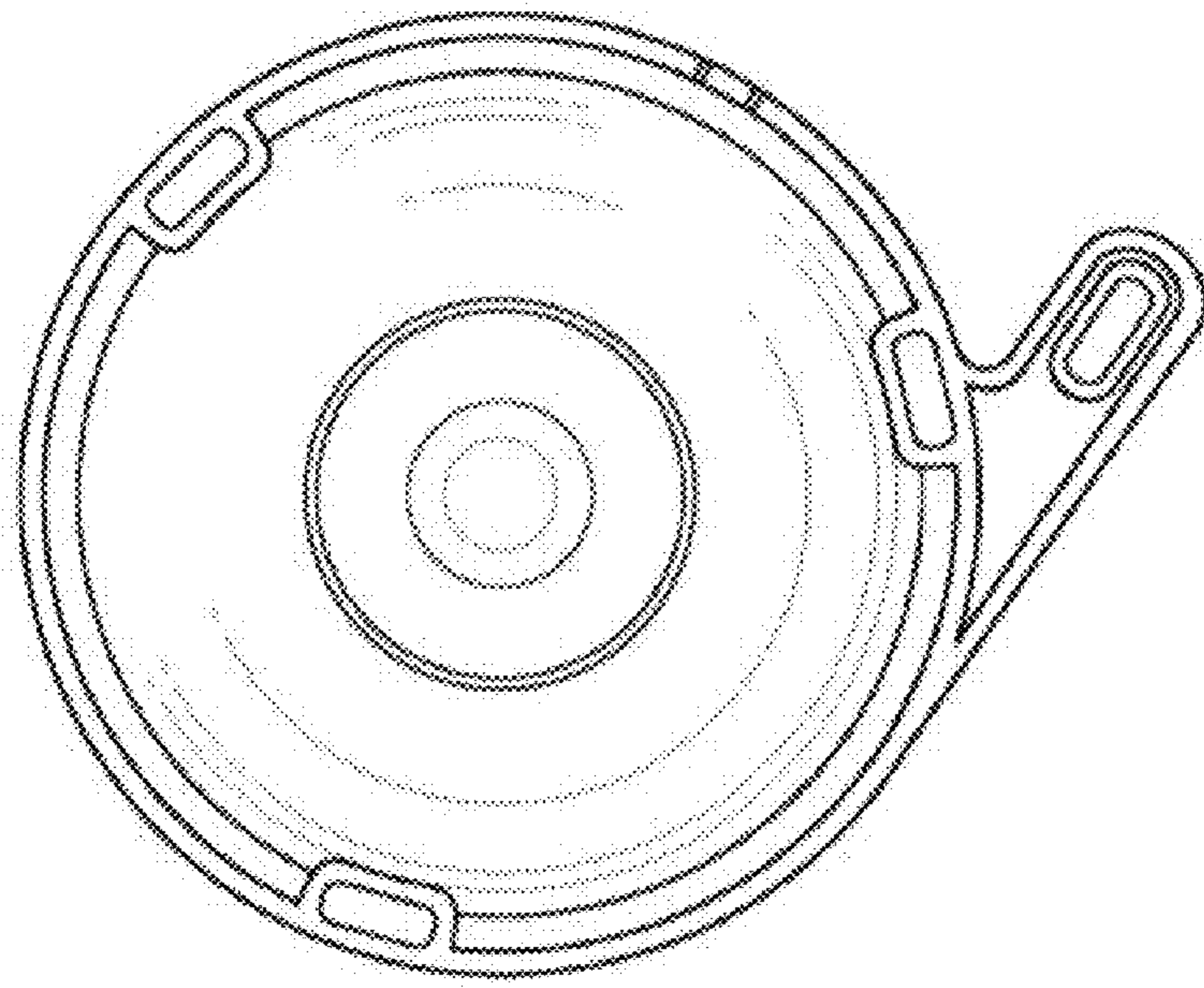

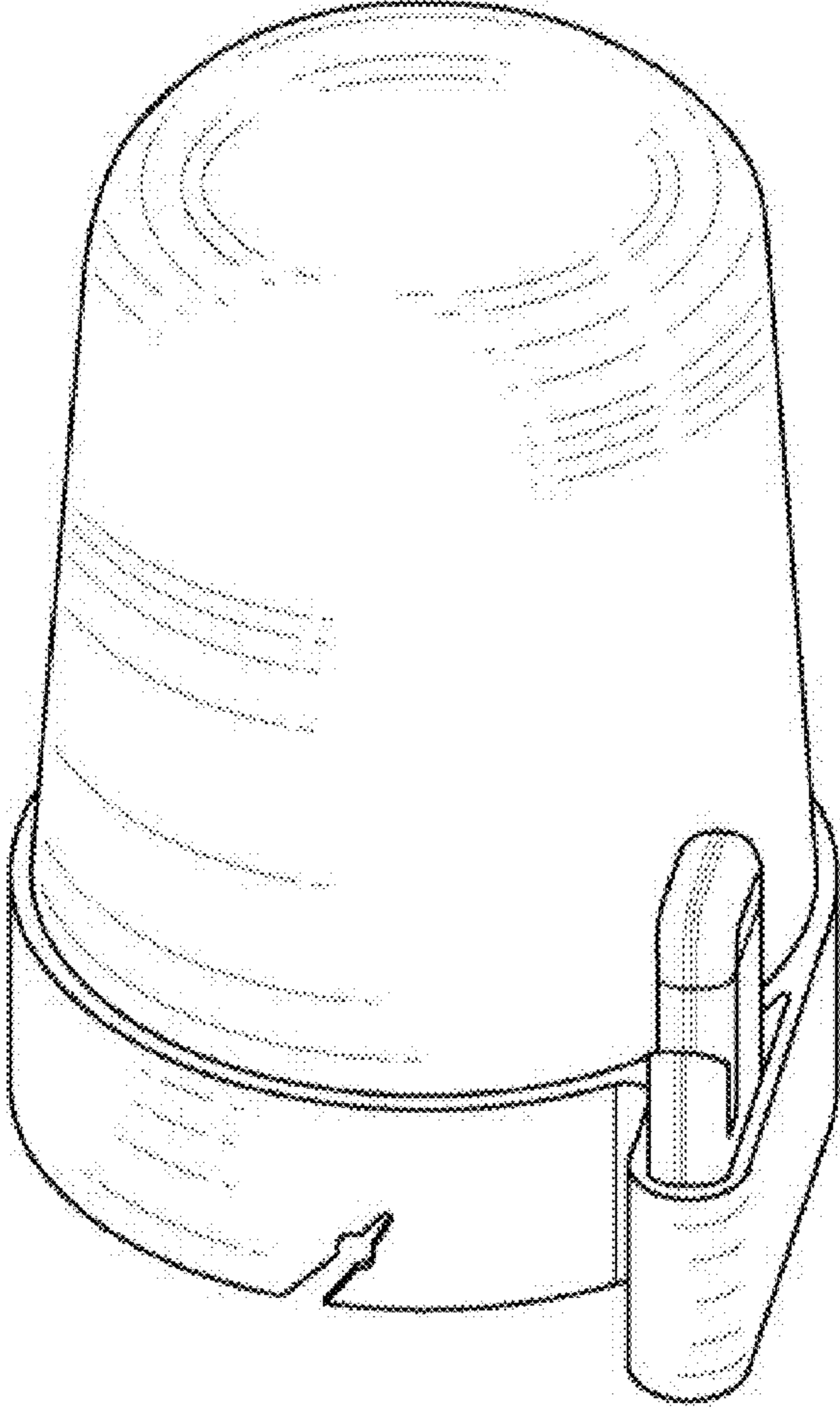

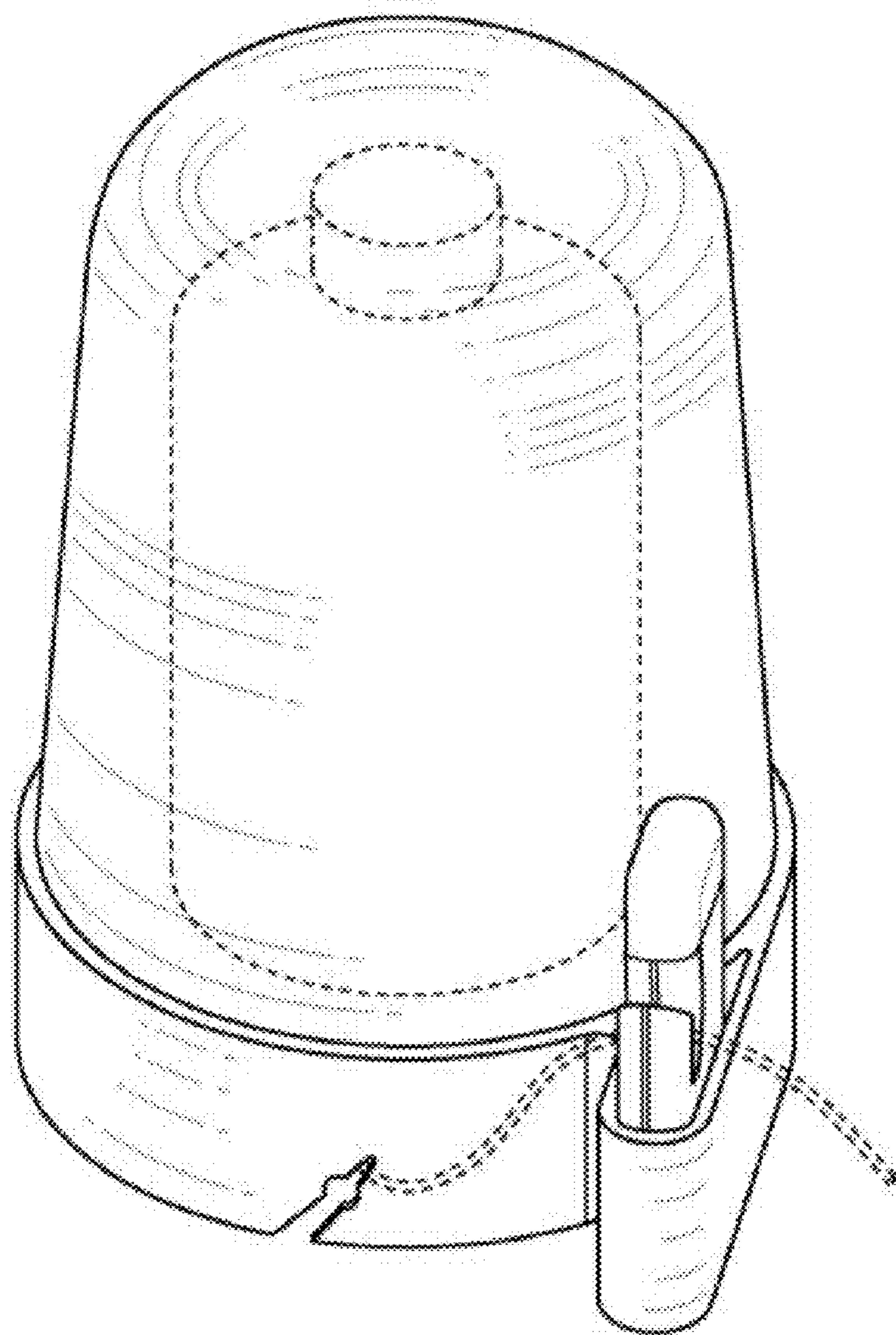

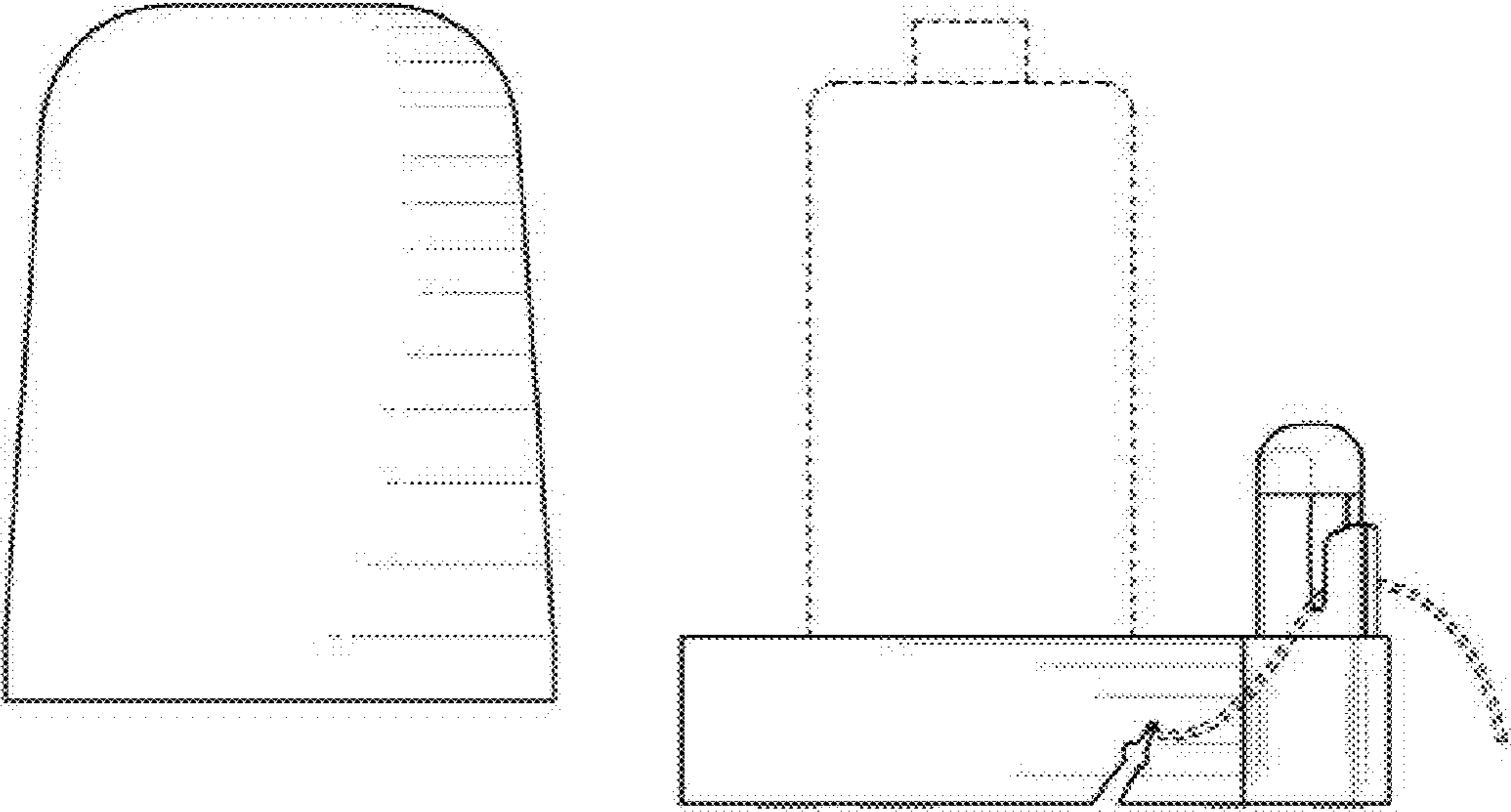

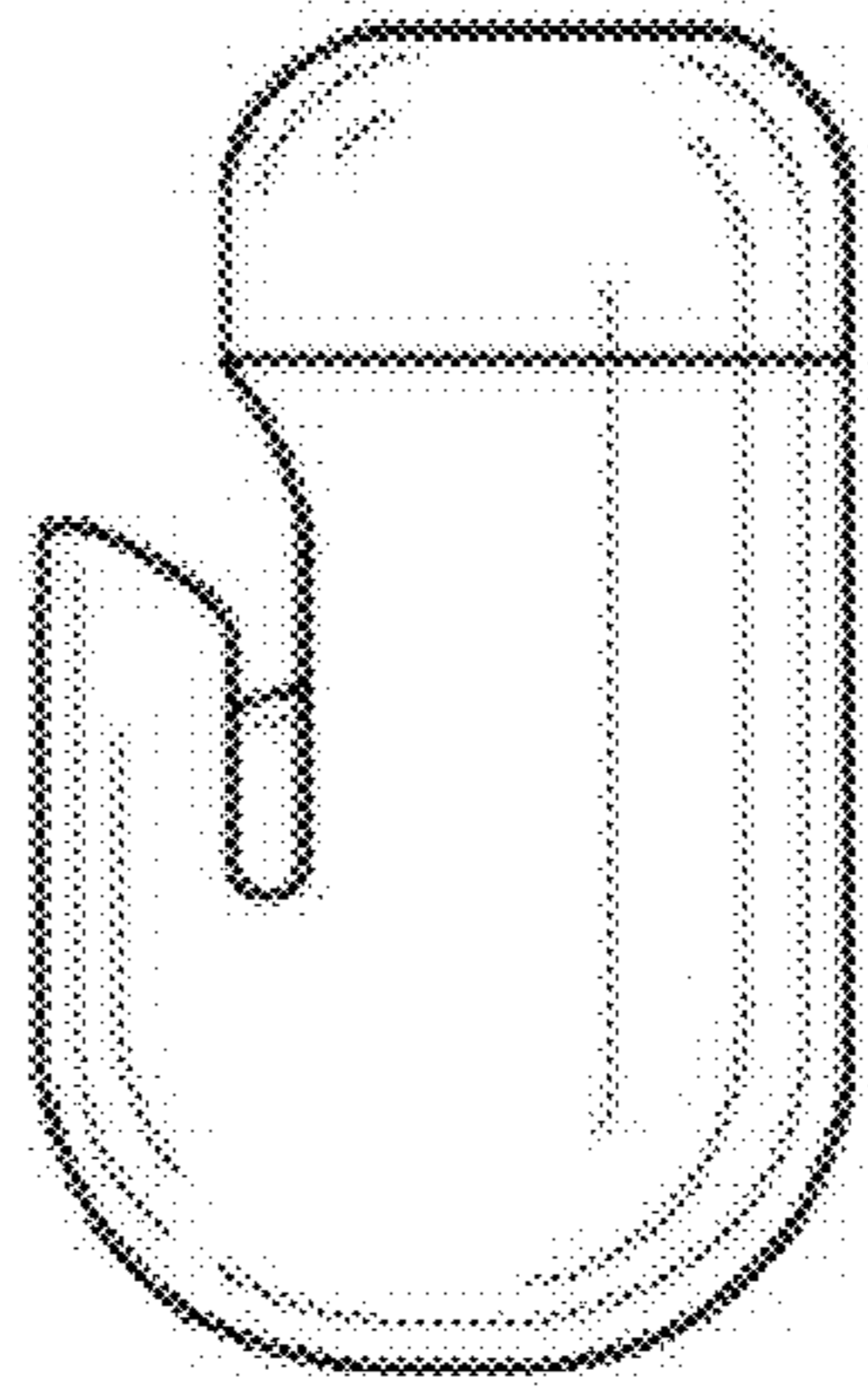

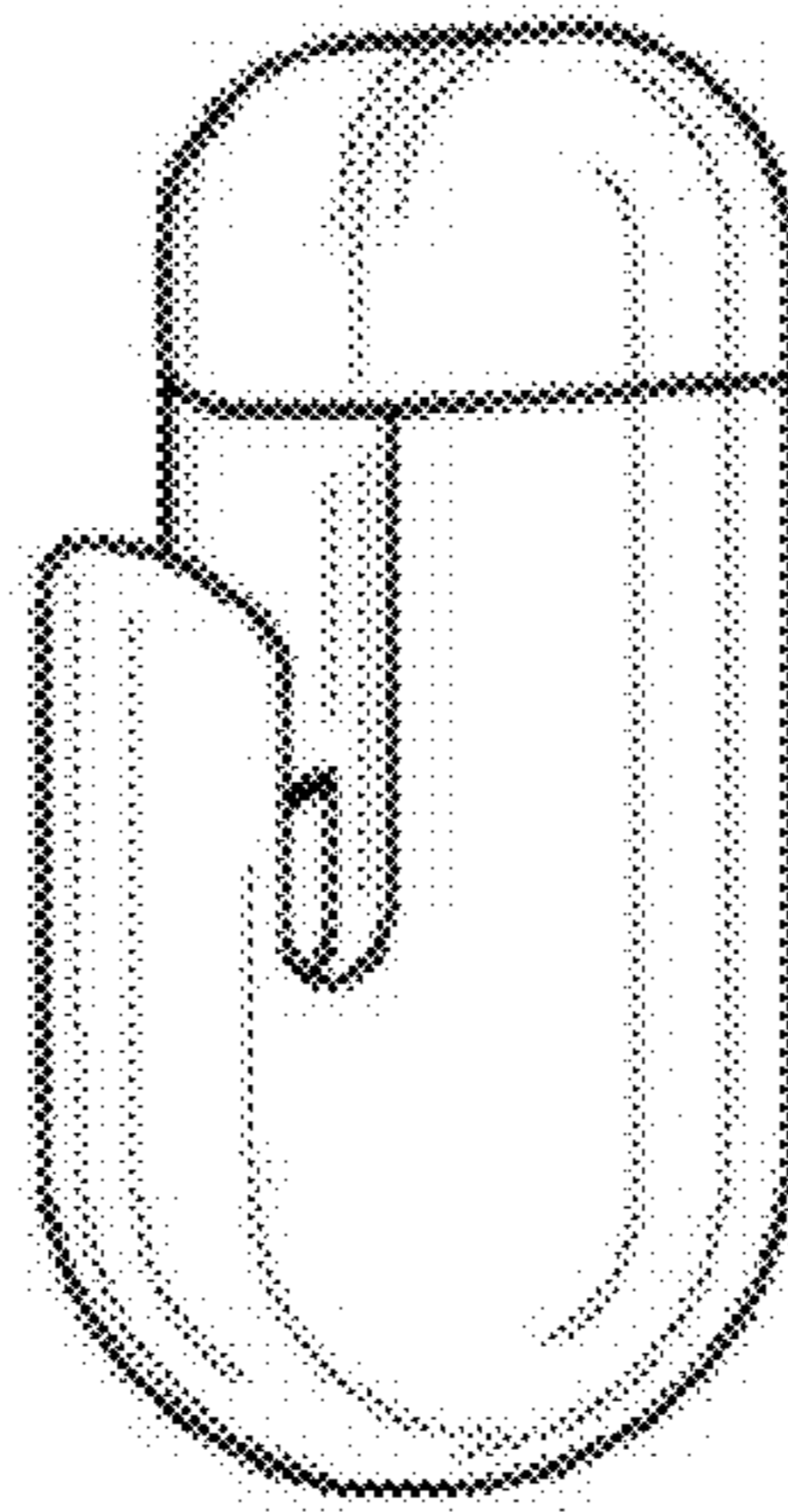

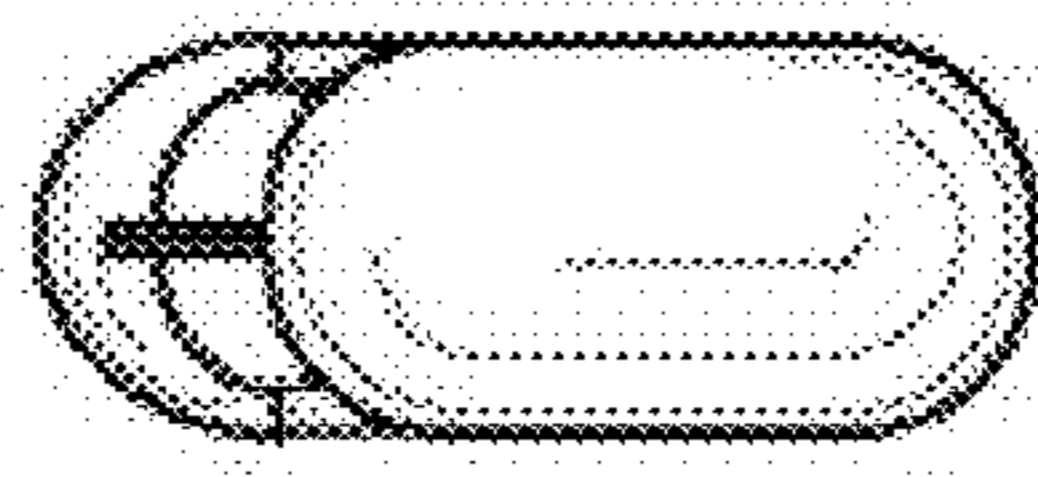
