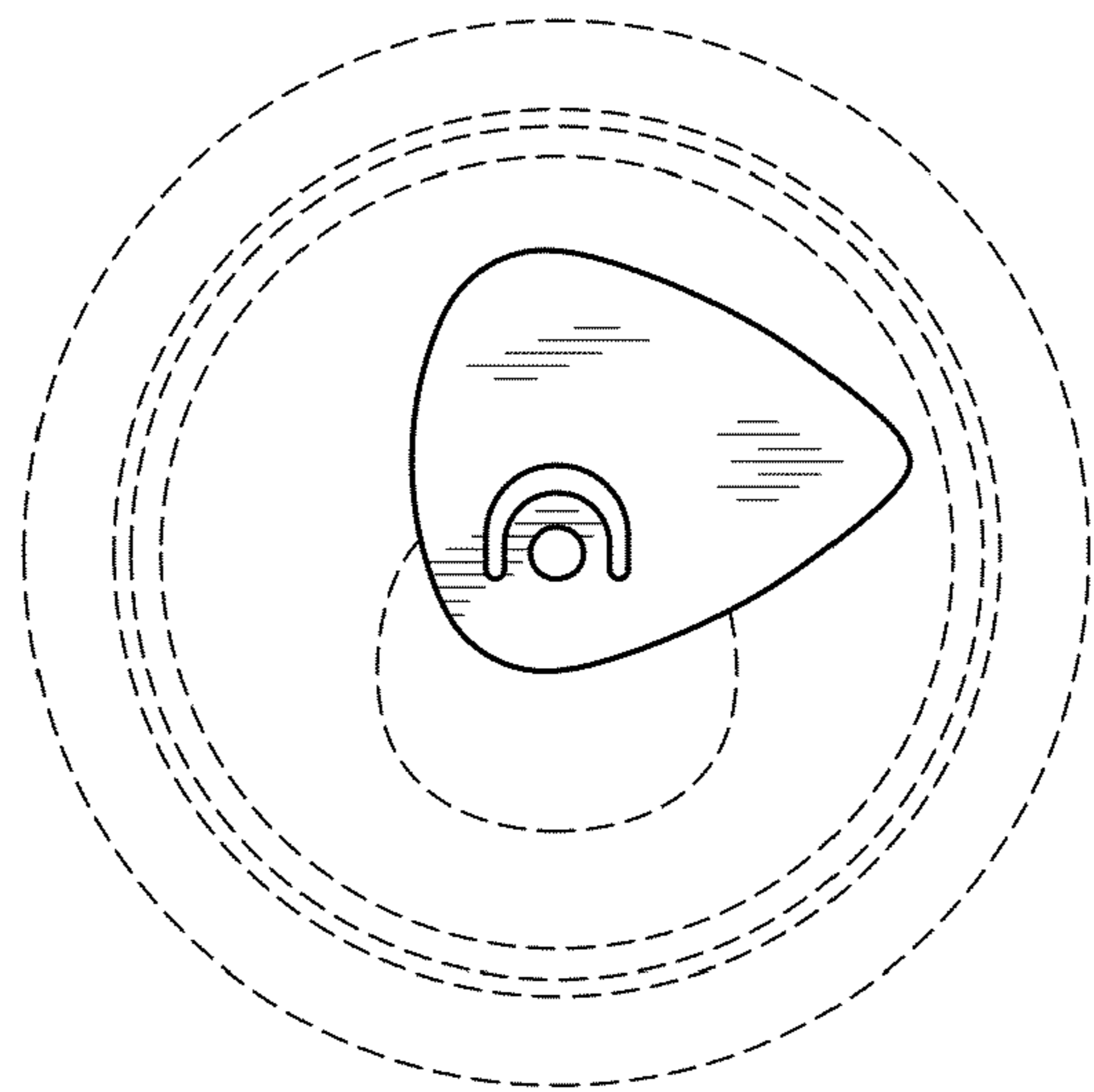

(57) **CLAIM**
The ornamental design for a beverage can tab, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a beverage can tab according to the present invention illustrating the front, top, and right side views of the beverage can tab; and, FIG. 2 is a top view of the beverage can tab of FIG. 1. The broken lines showing the curvature of the surfaces on the beverage can tab in FIGS. 1-2 depict environment only and form no part of the claimed invention.

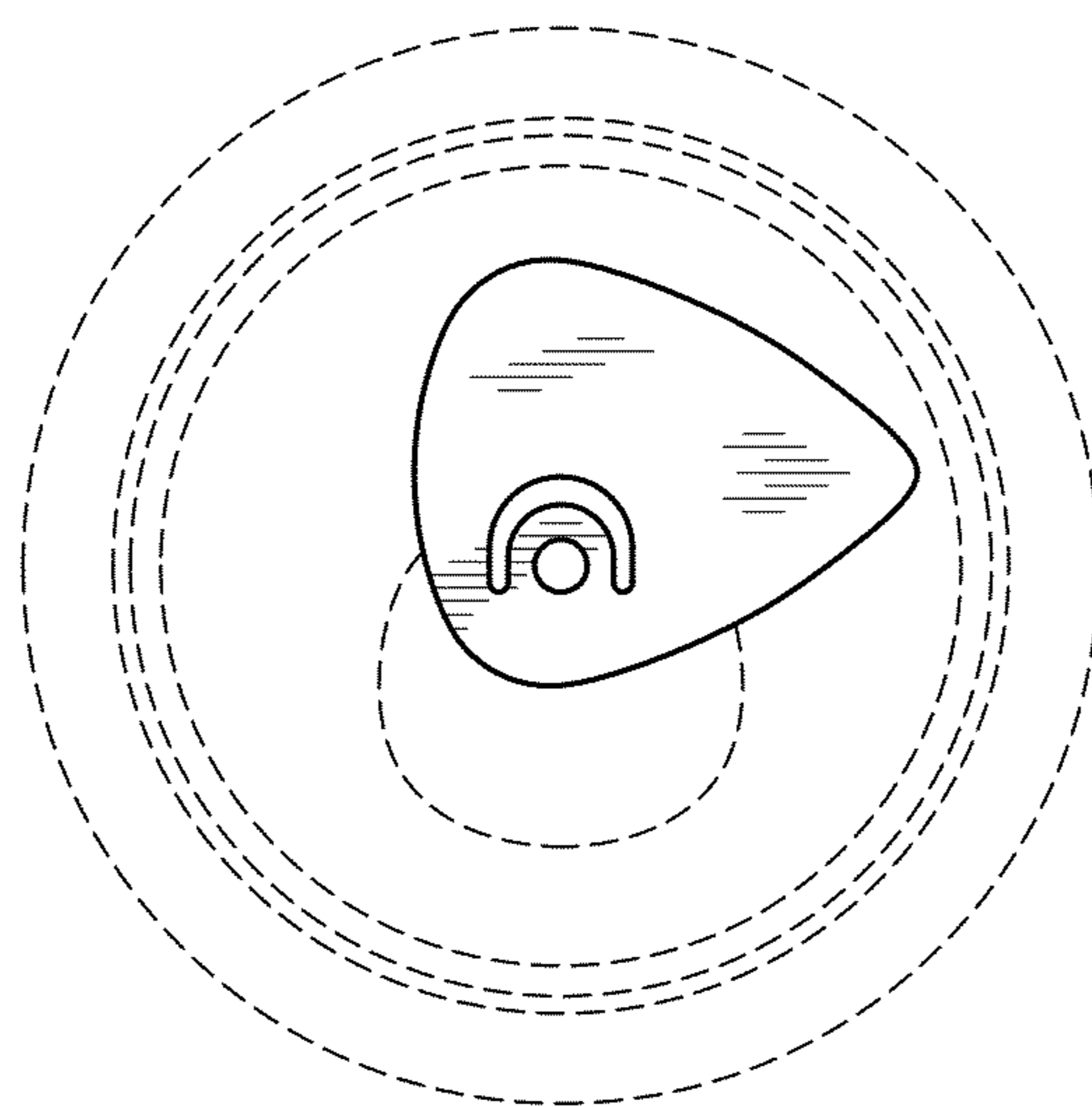

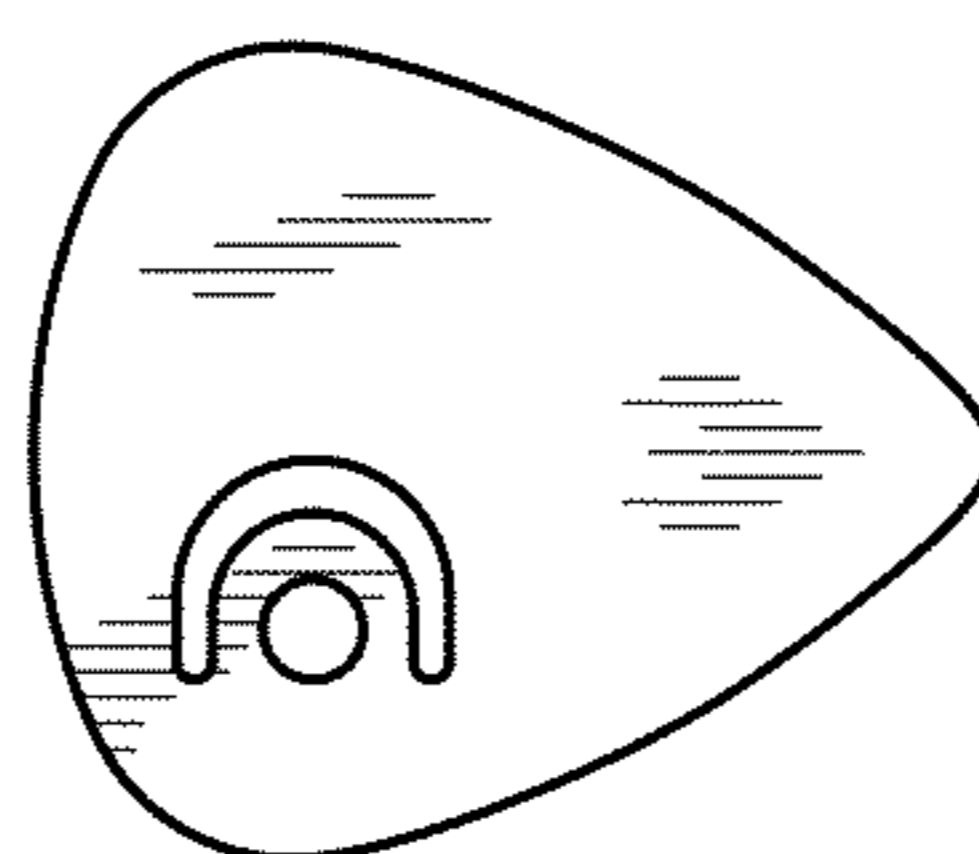
