(57) **CLAIM**

The ornamental design for a baseball memorabilia display device, as shown and described.

DESCRIPTION

FIG. 1 is a right, front, perspective view of a baseball memorabilia display device showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right-end elevational view thereof;

FIG. 6 is a left-end elevational view thereof; and,

FIG. 7 is a front elevational view thereof shown at a reduced scale and with an item of baseball memorabilia hanging therefrom.

The broken lines shown in the drawings illustrate portions of the baseball memorabilia display device that form no part of the claimed design.

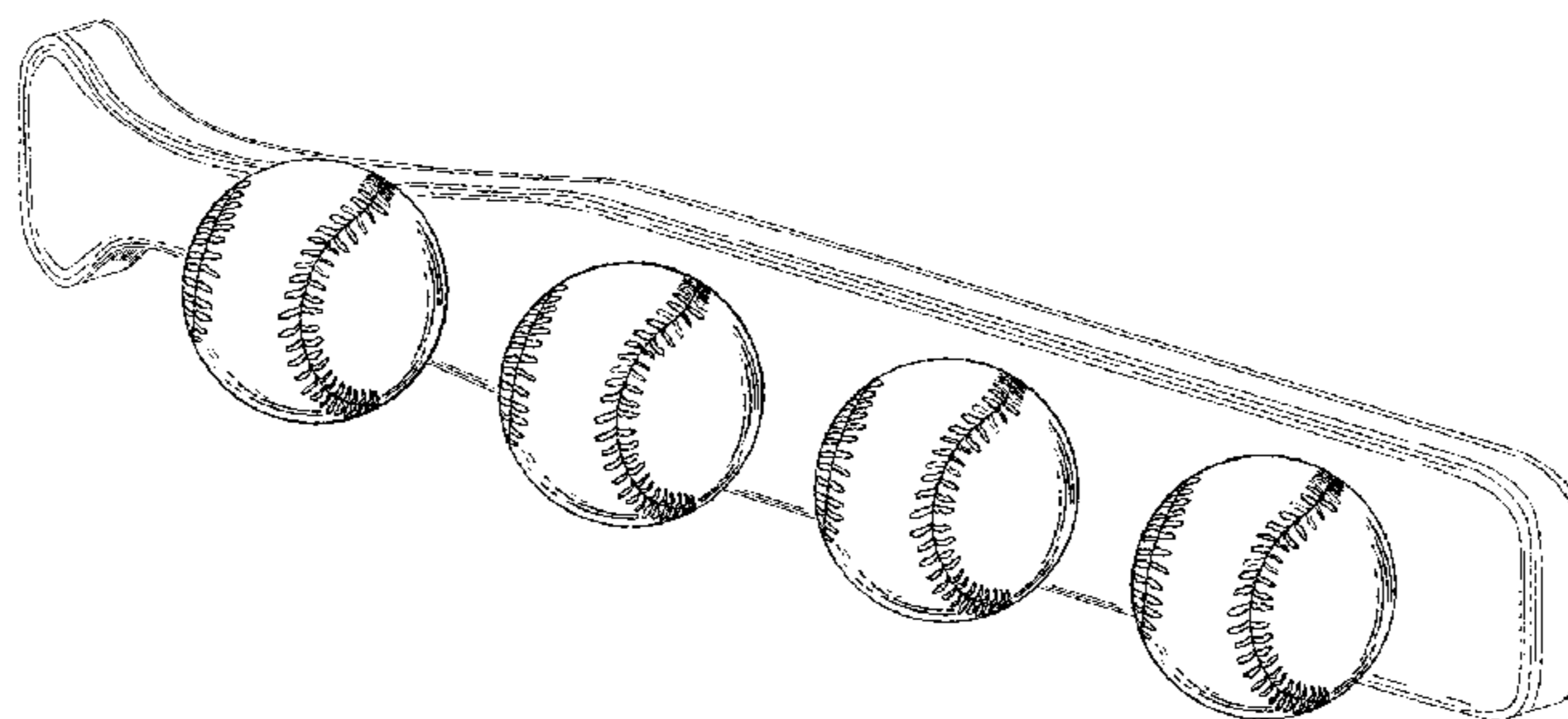

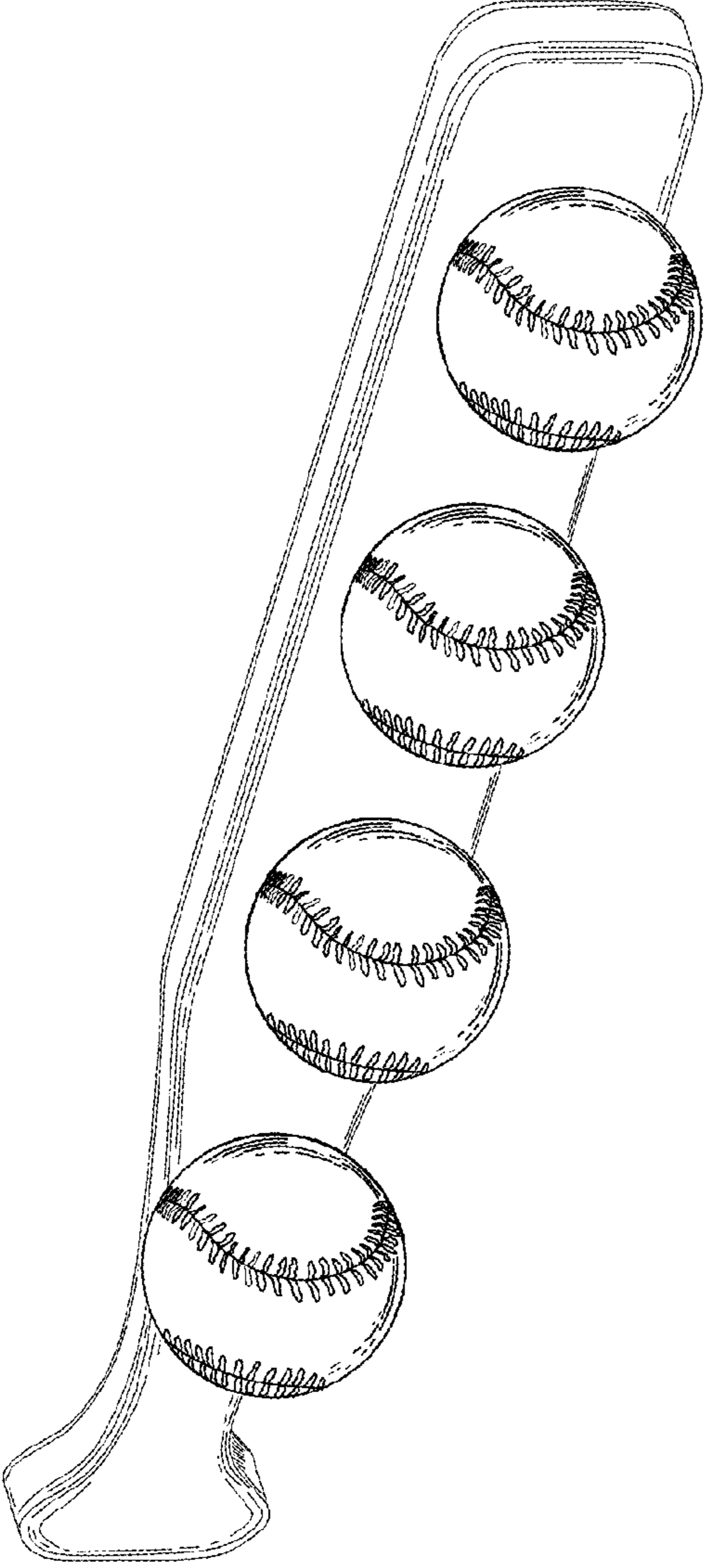

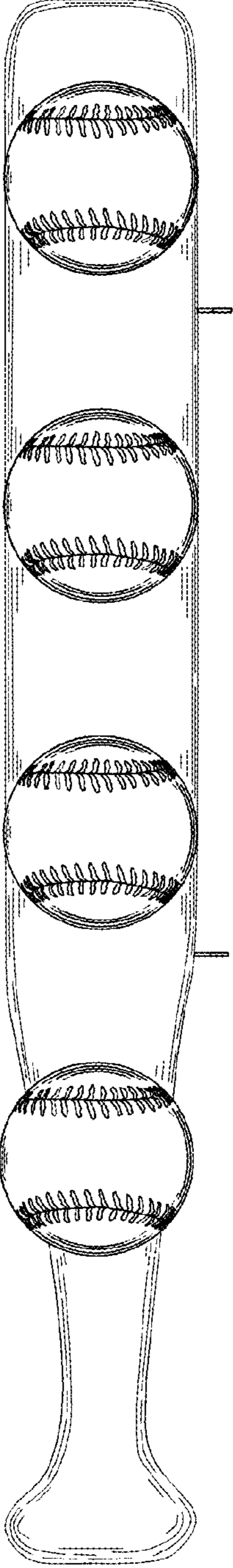

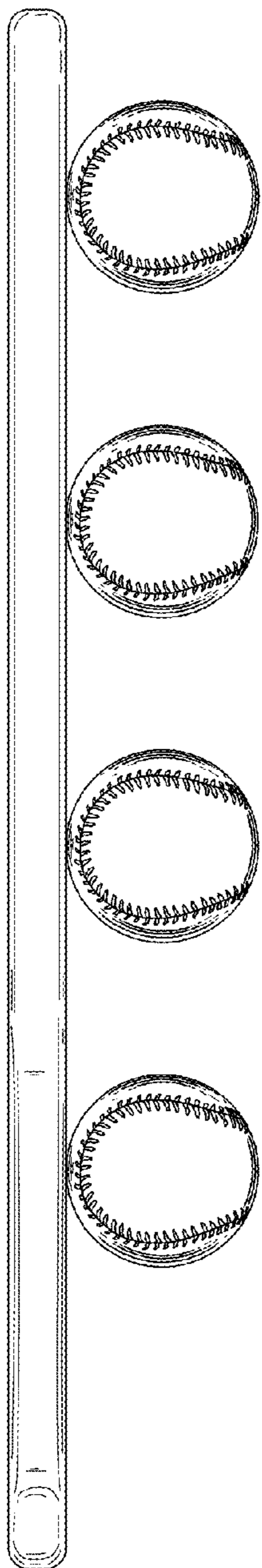

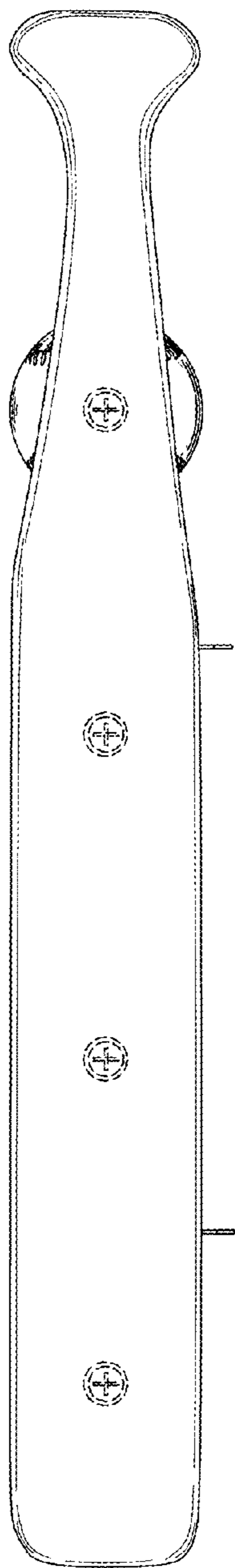

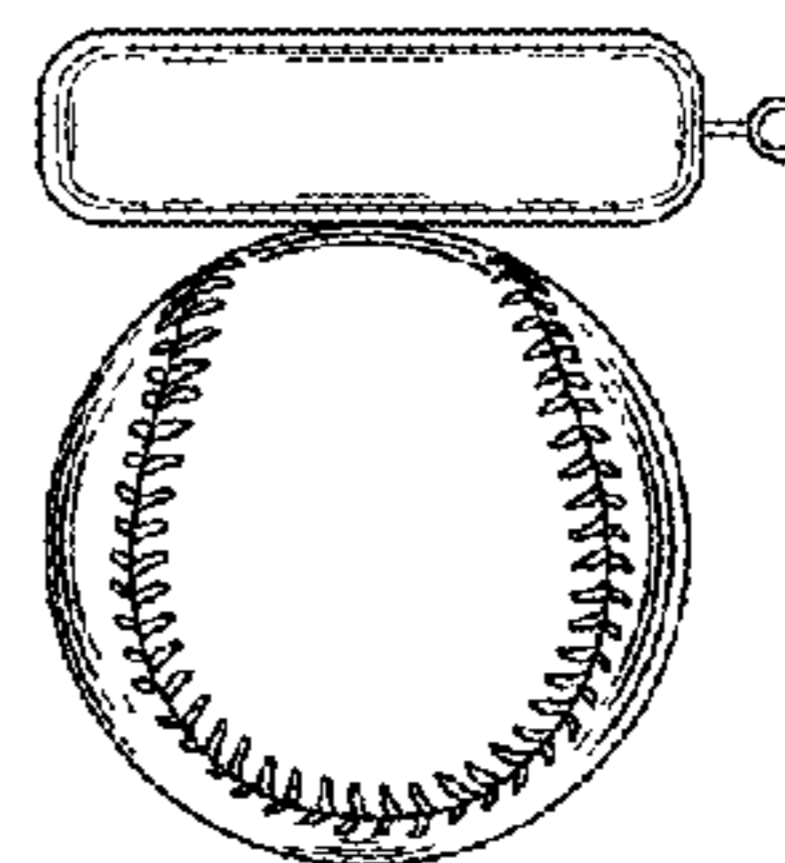

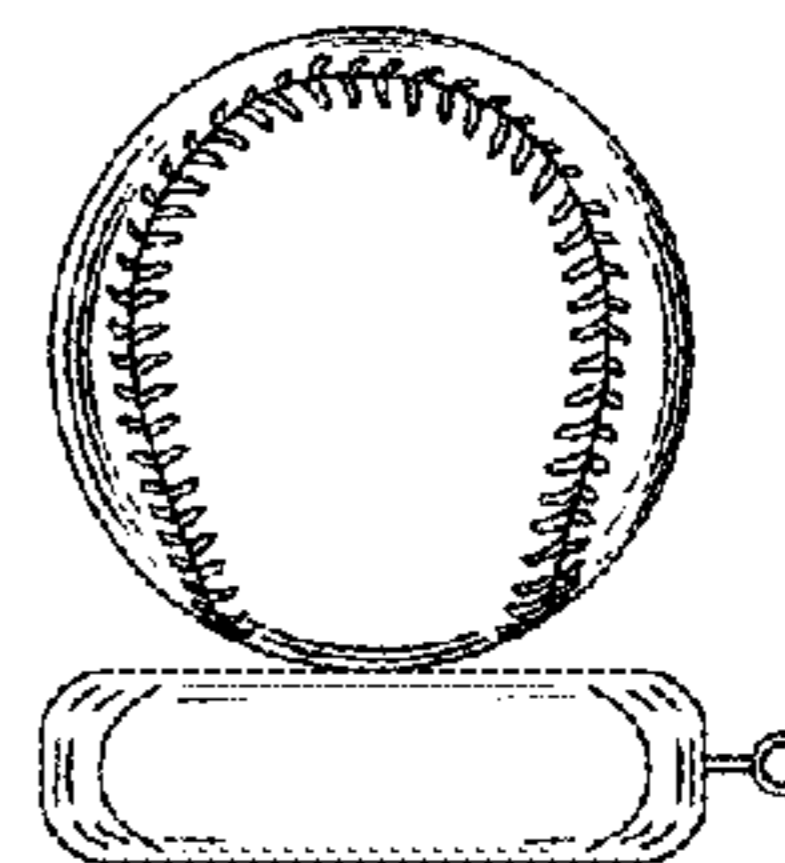
