**DESCRIPTION**

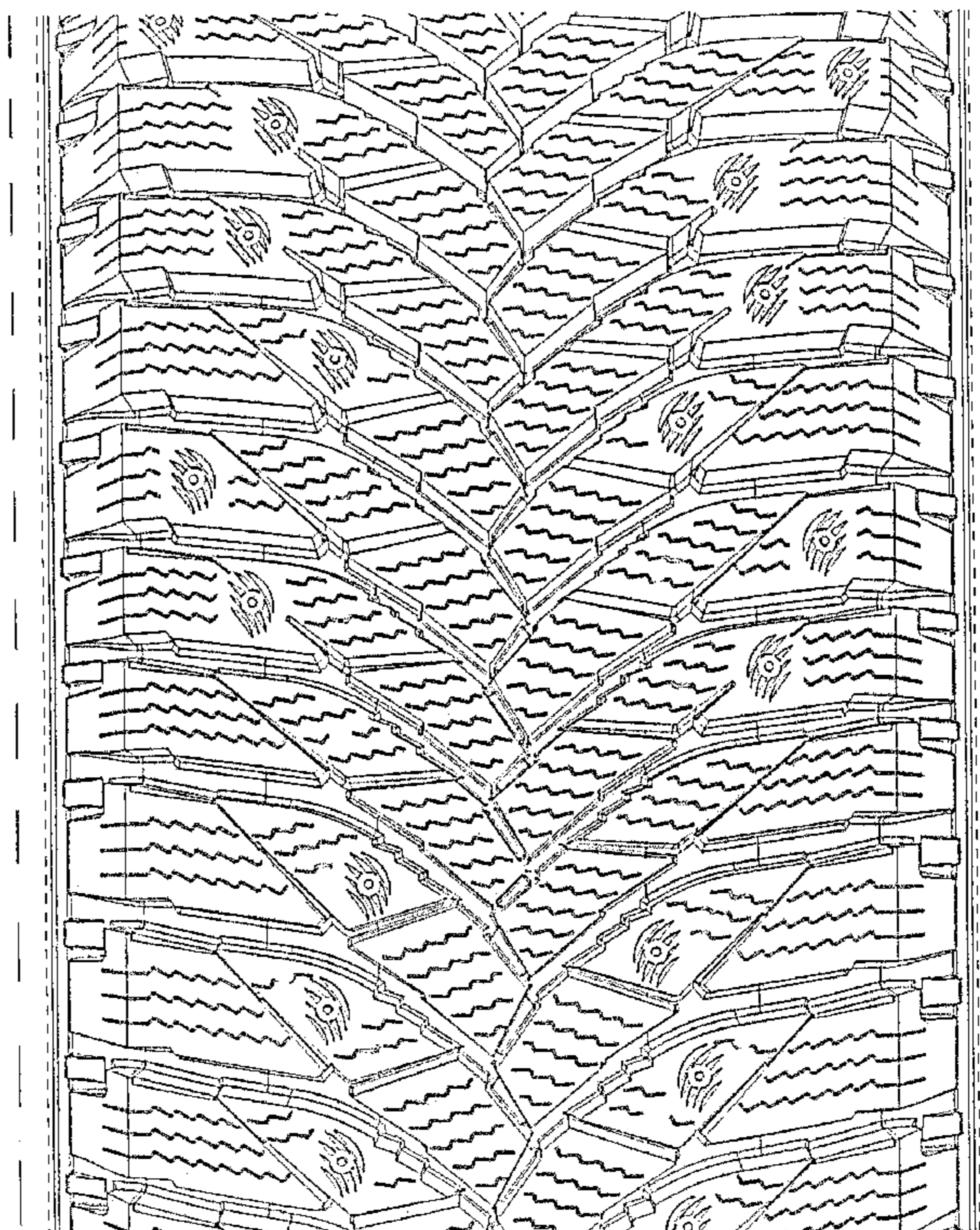
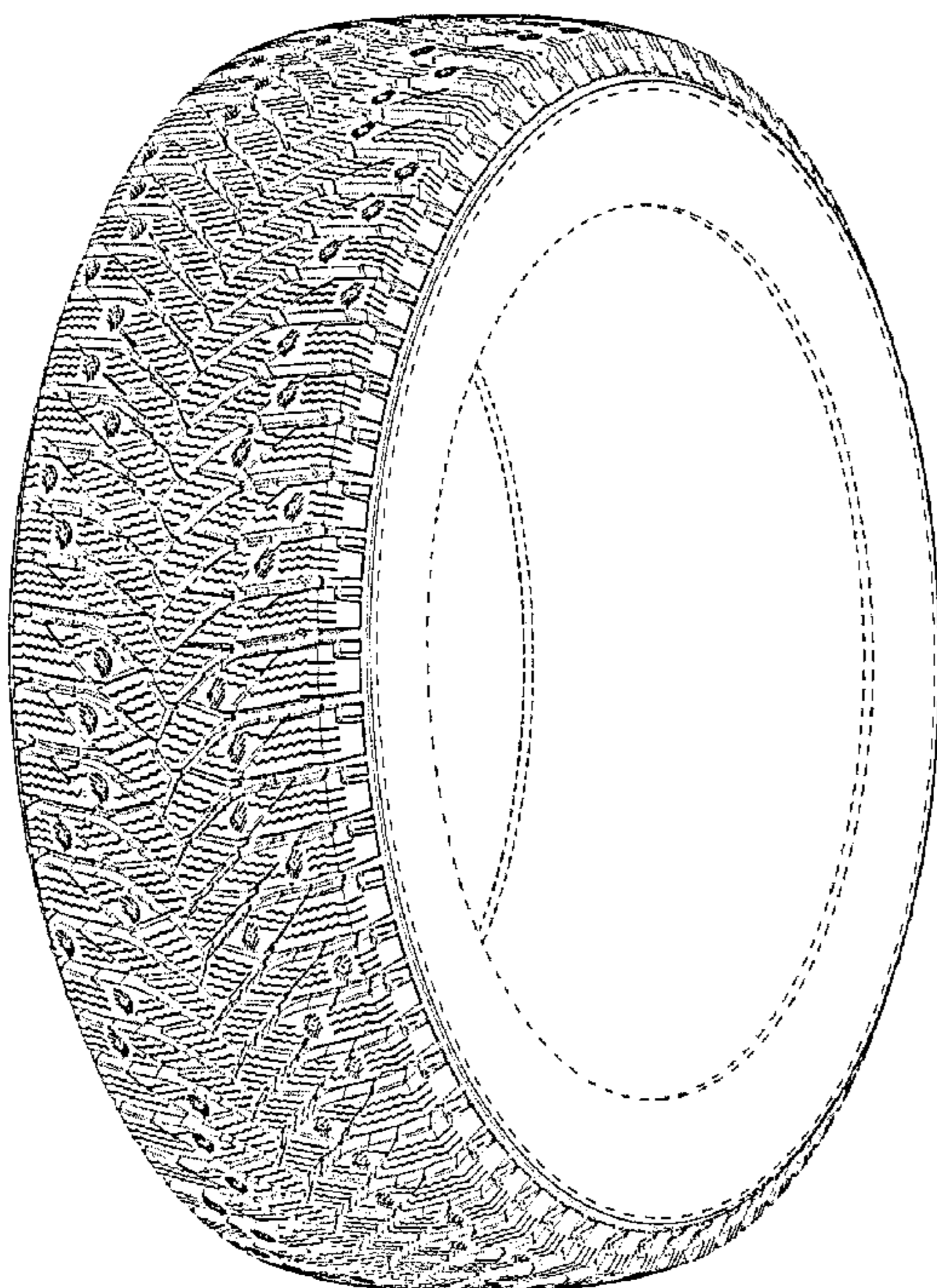

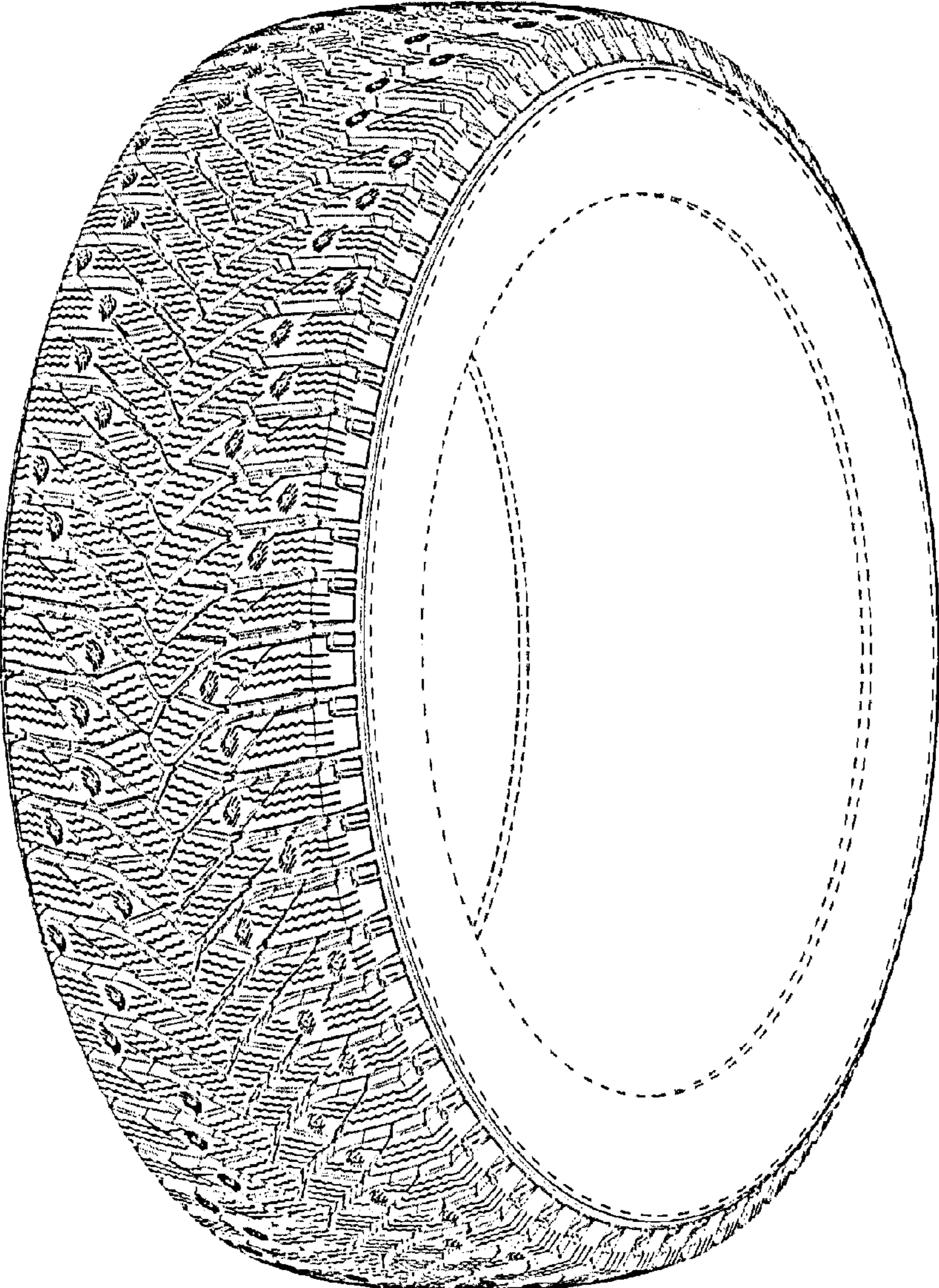

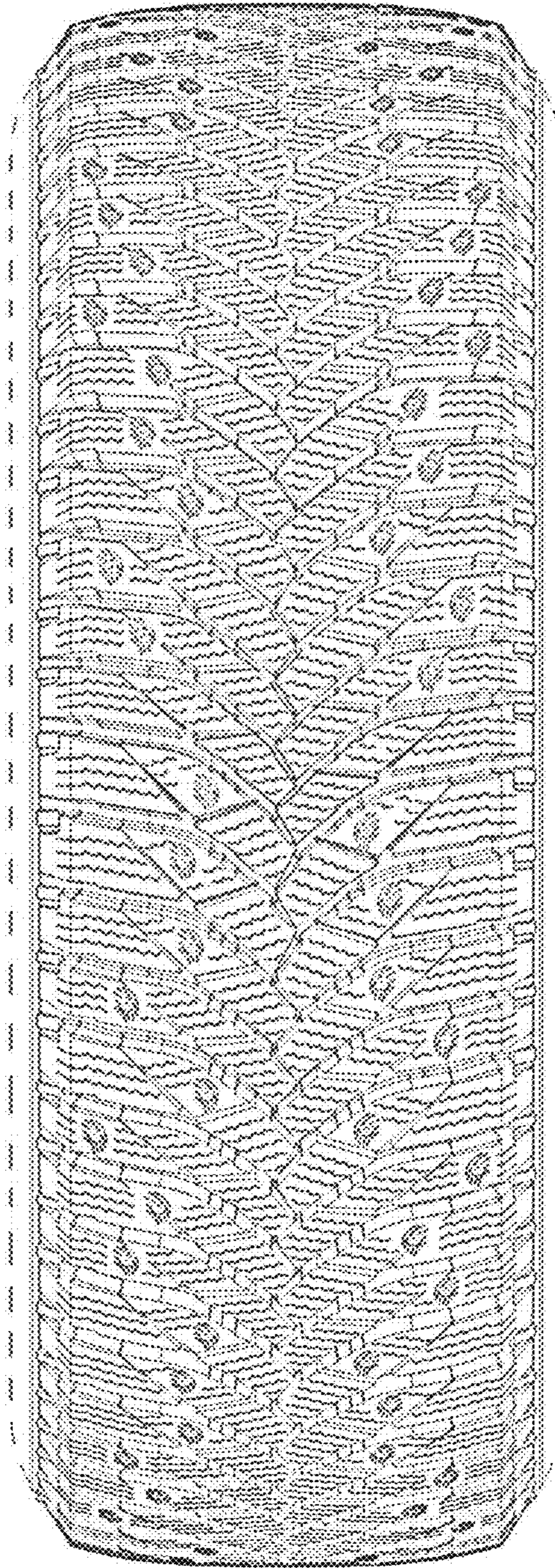

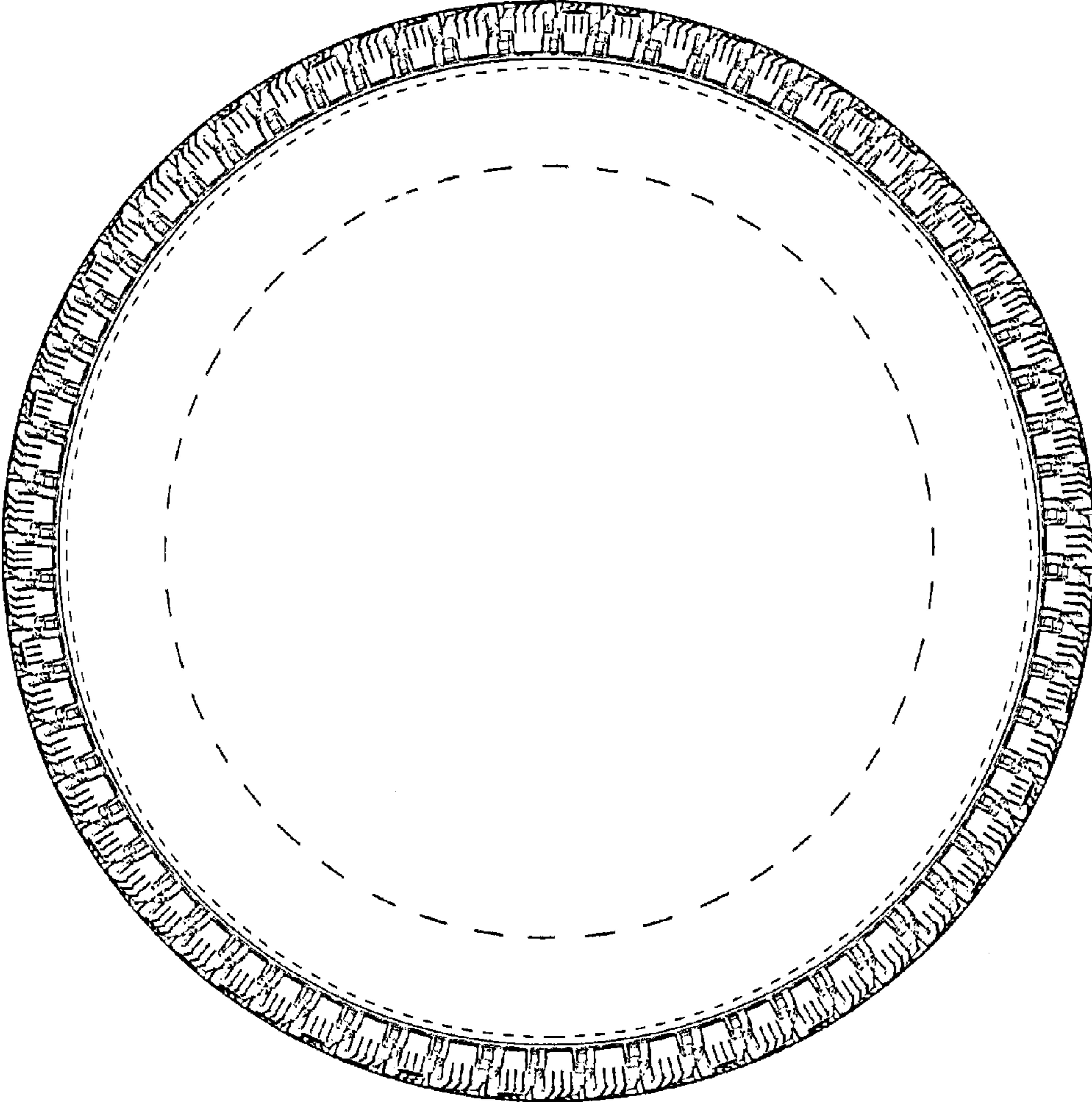

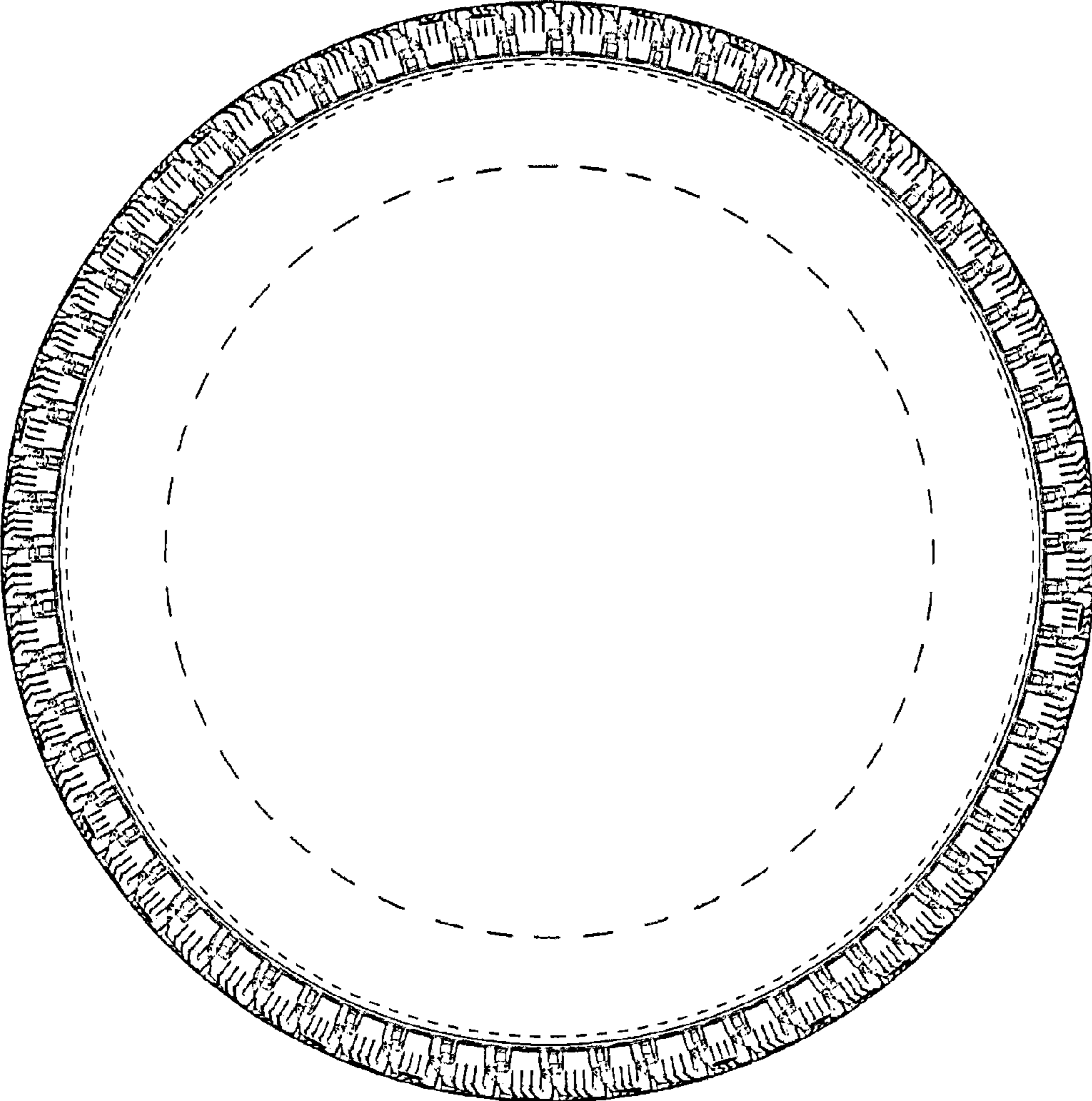

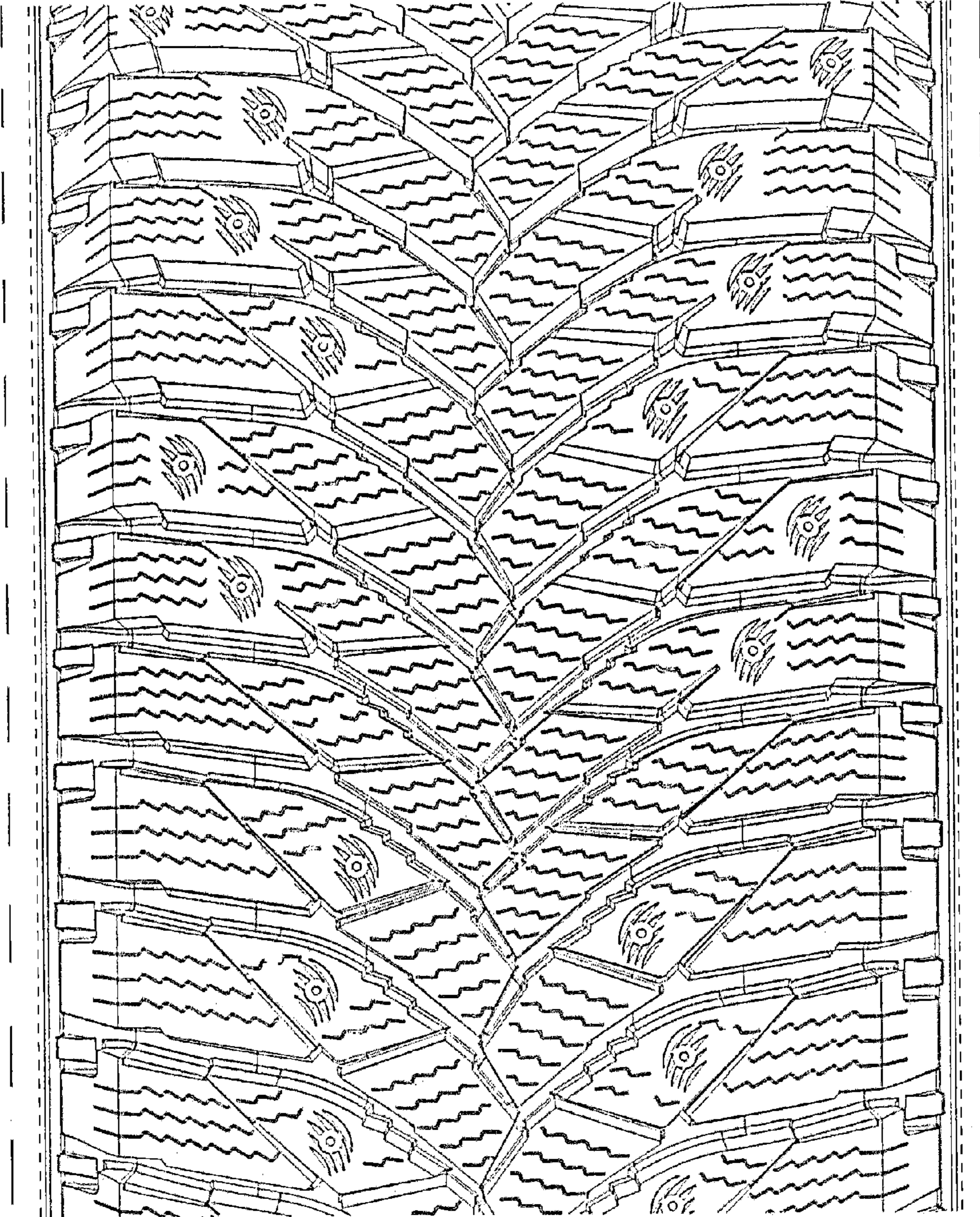
