**DESCRIPTION**

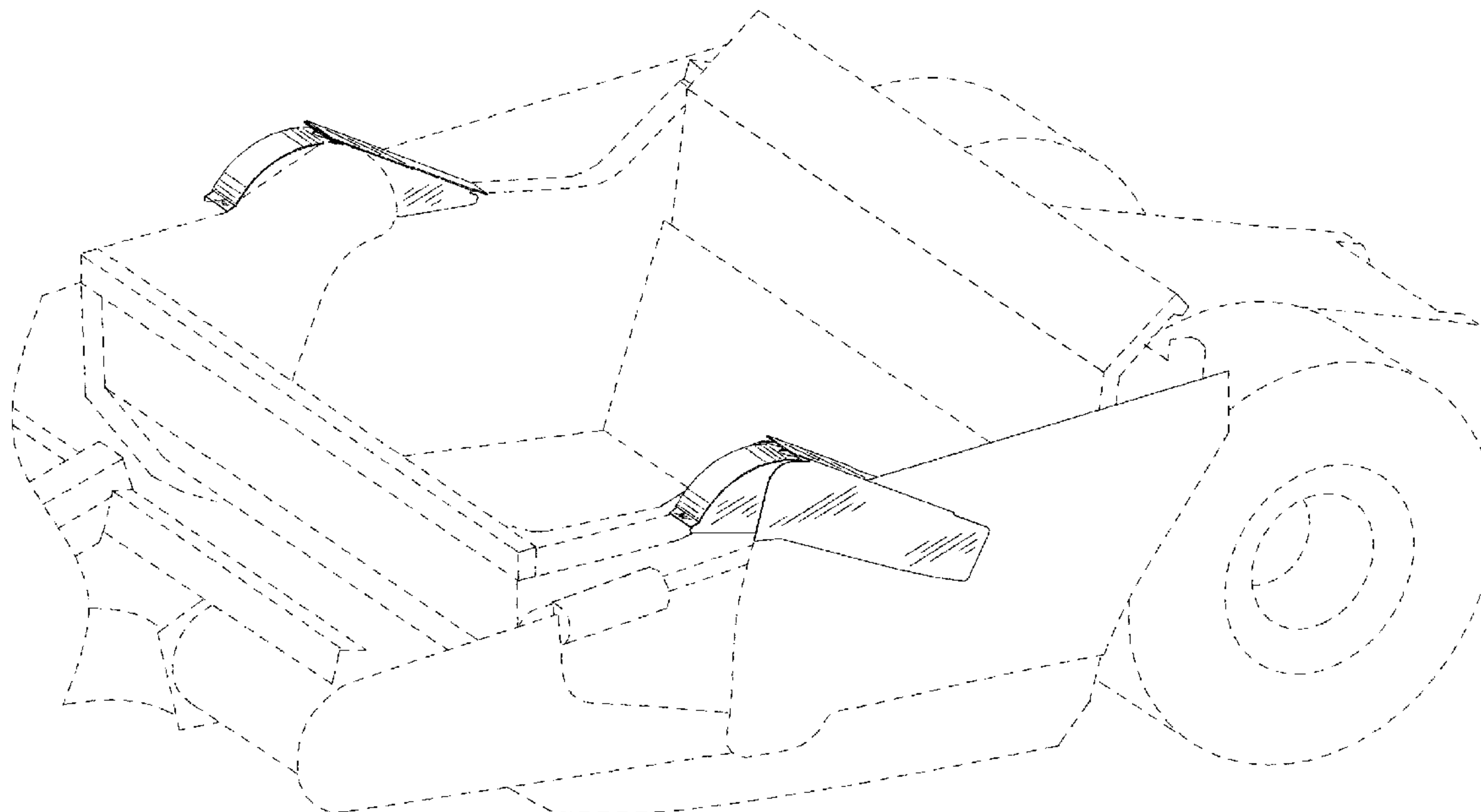
FIG. 1 is a side view of a scraper shield of the present invention.

FIG. 2 is a perspective view of the scraper shield of FIG. 1 with partially sectioned environment; and,

FIG. 3 is a top view of the scraper shield of FIG. 1 with partially sectioned environment.

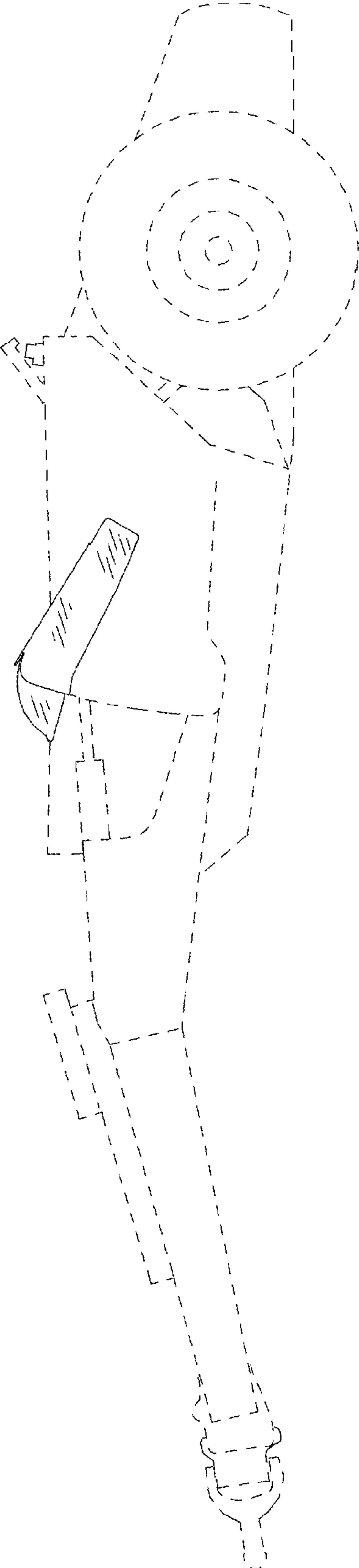

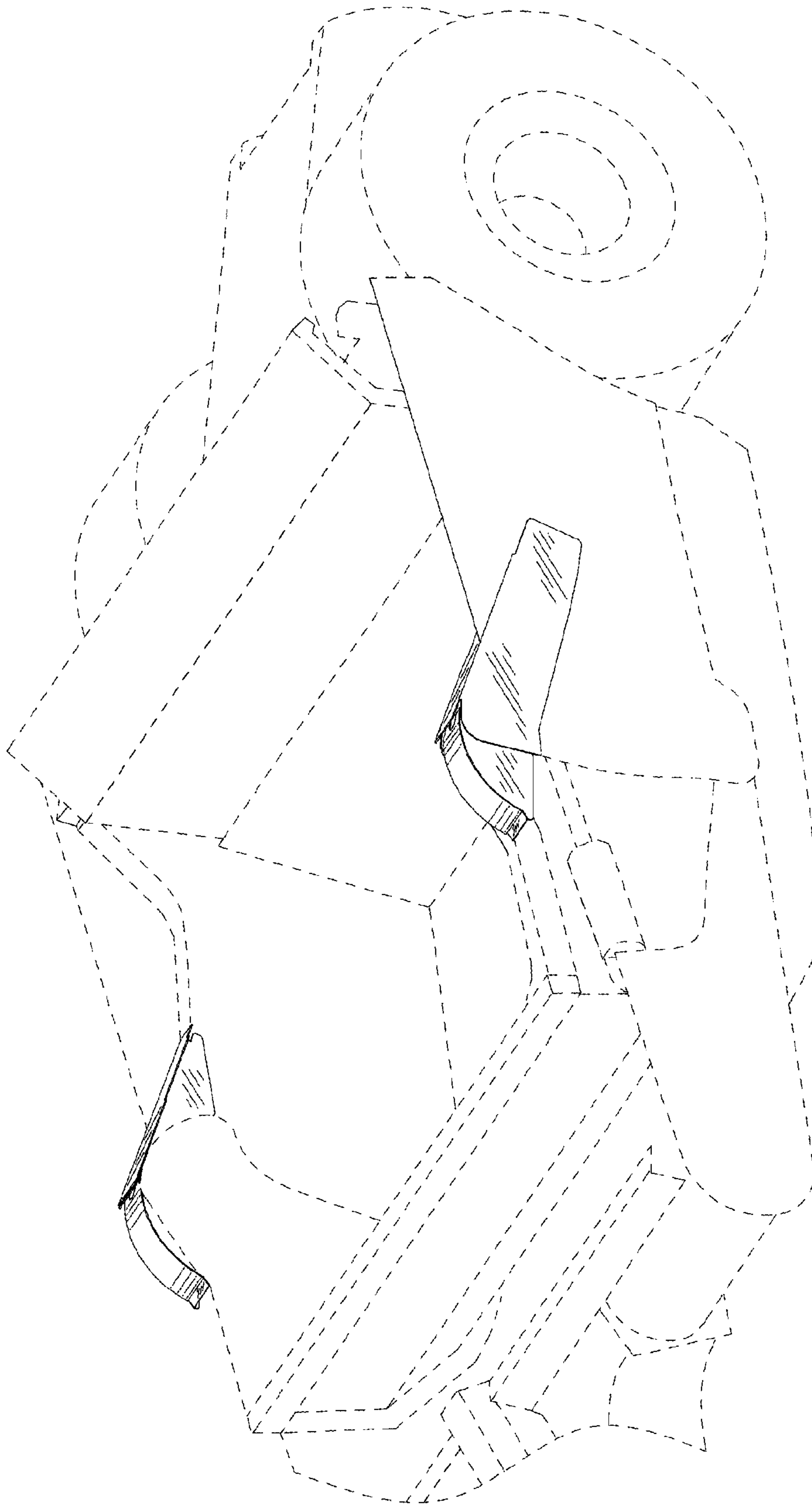

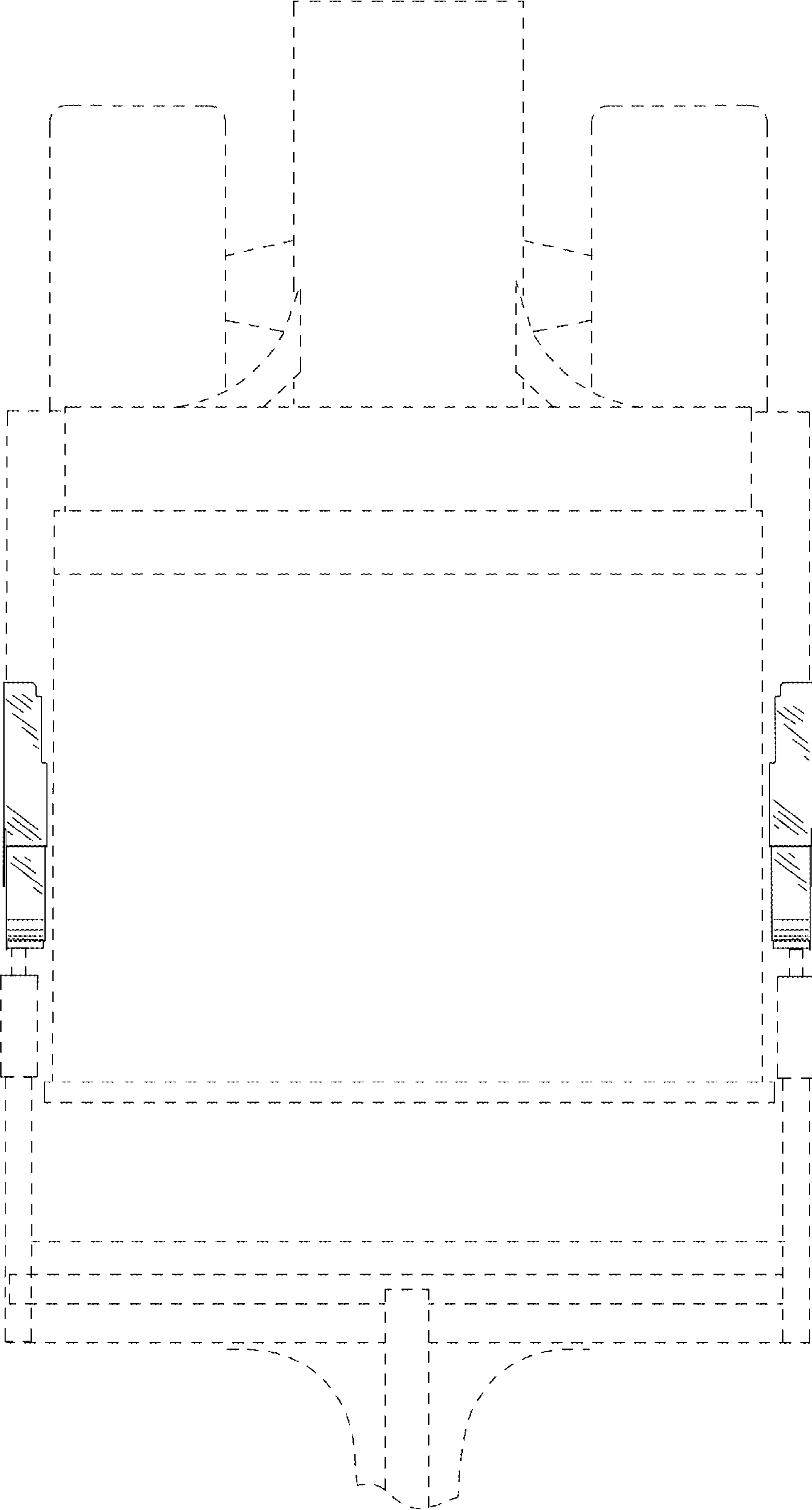
