(57) **CLAIM**

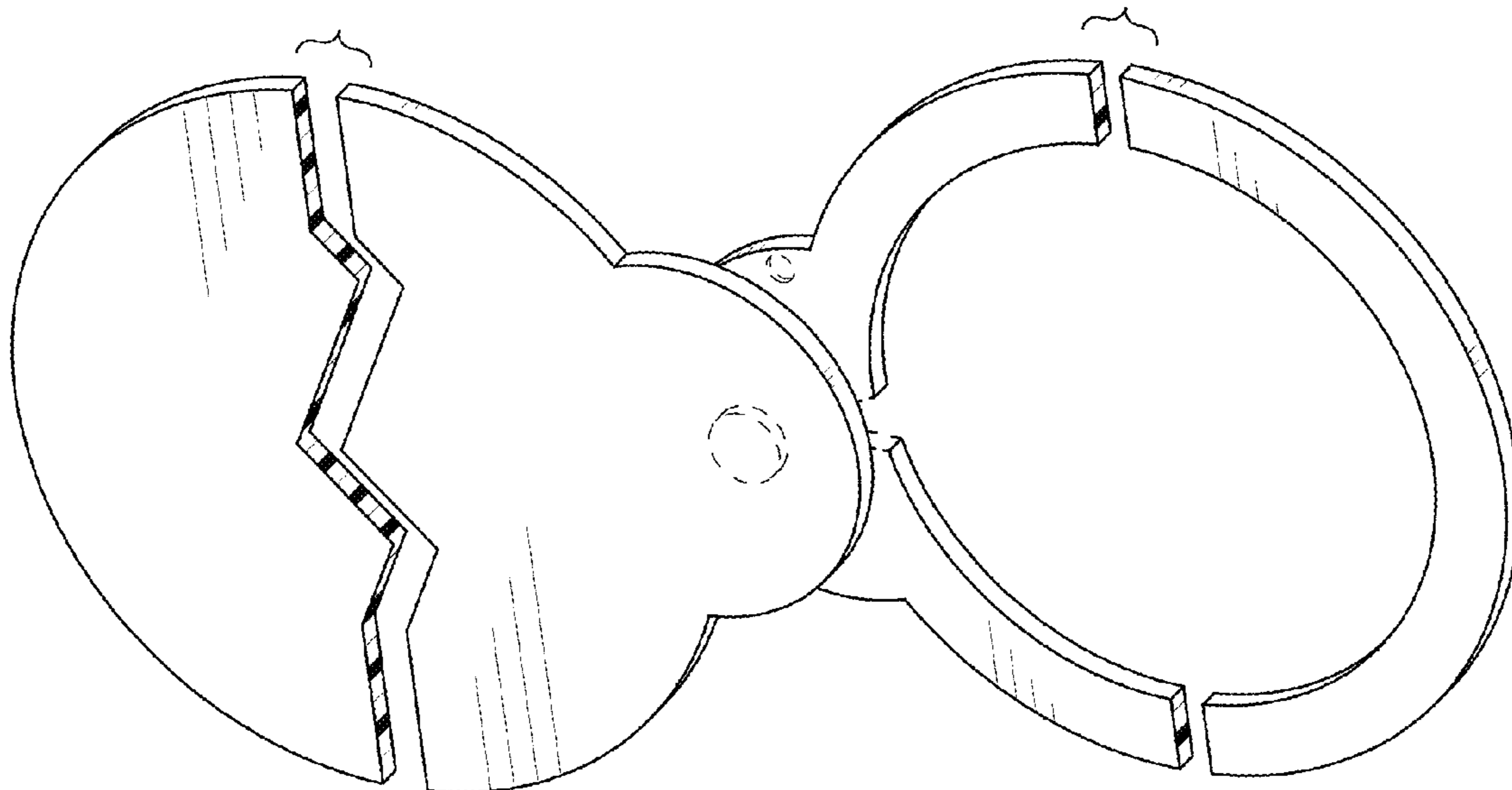
The ornamental design for a webcam cover, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of a webcam cover in an open configuration;

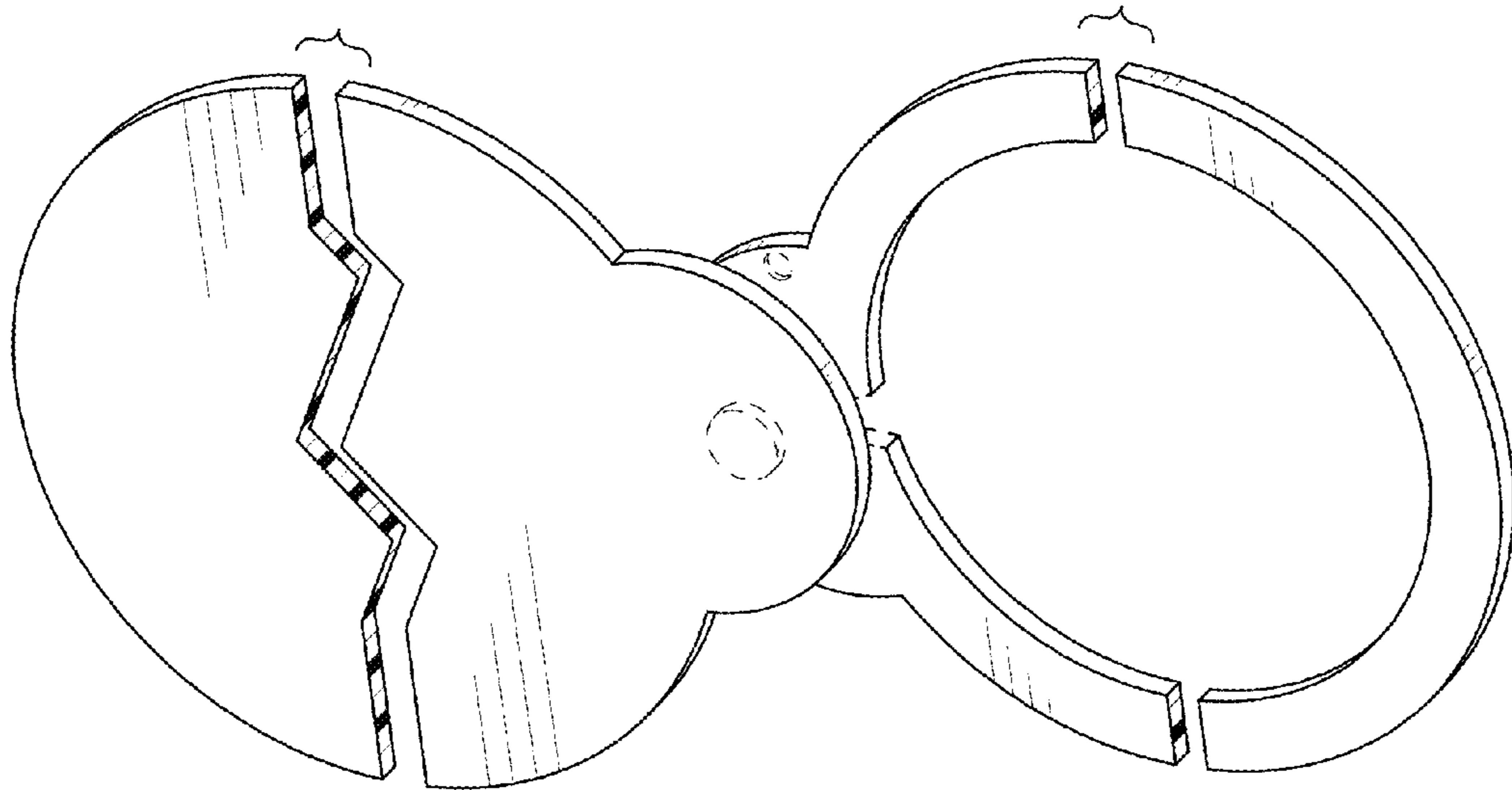

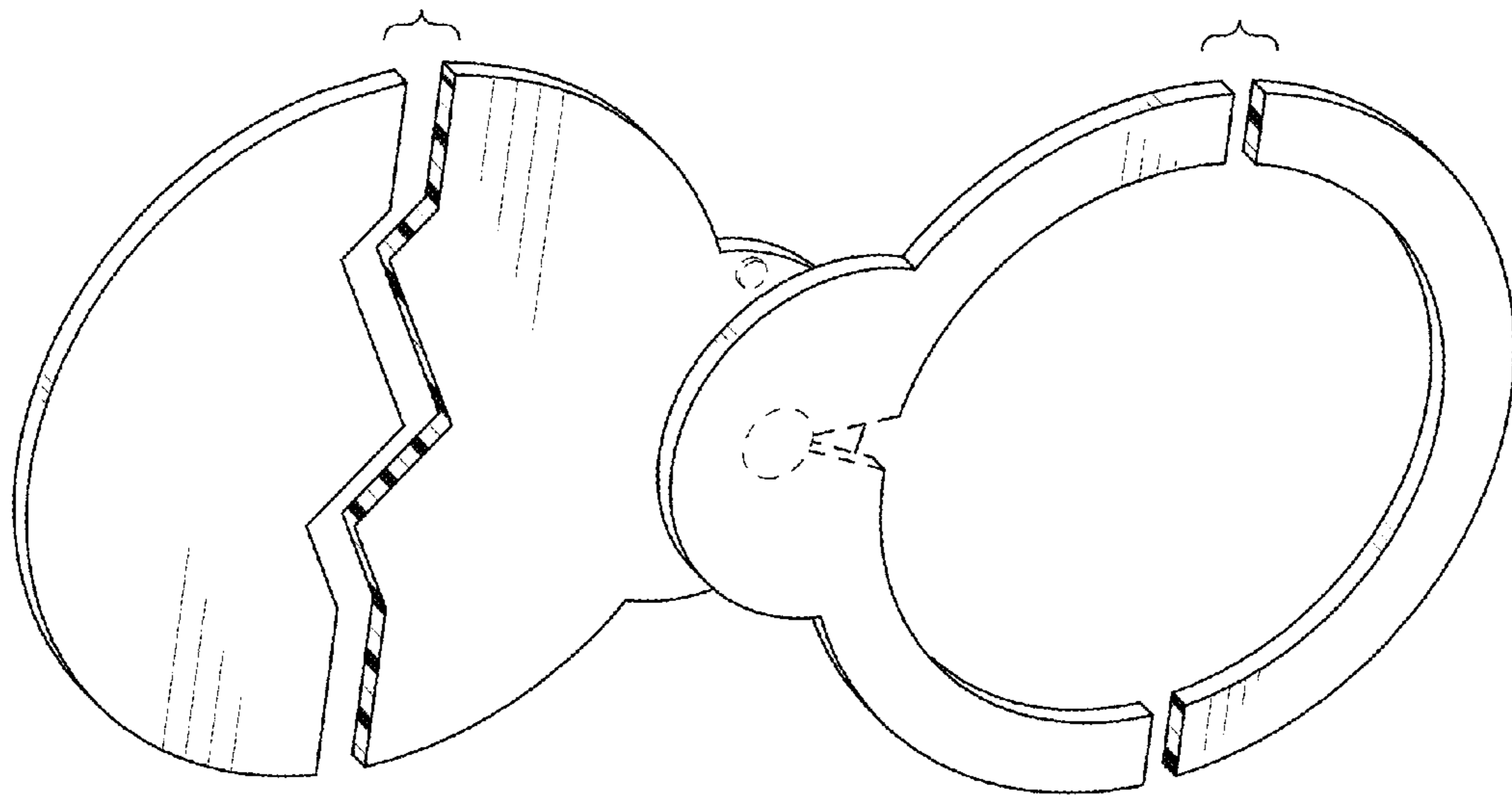

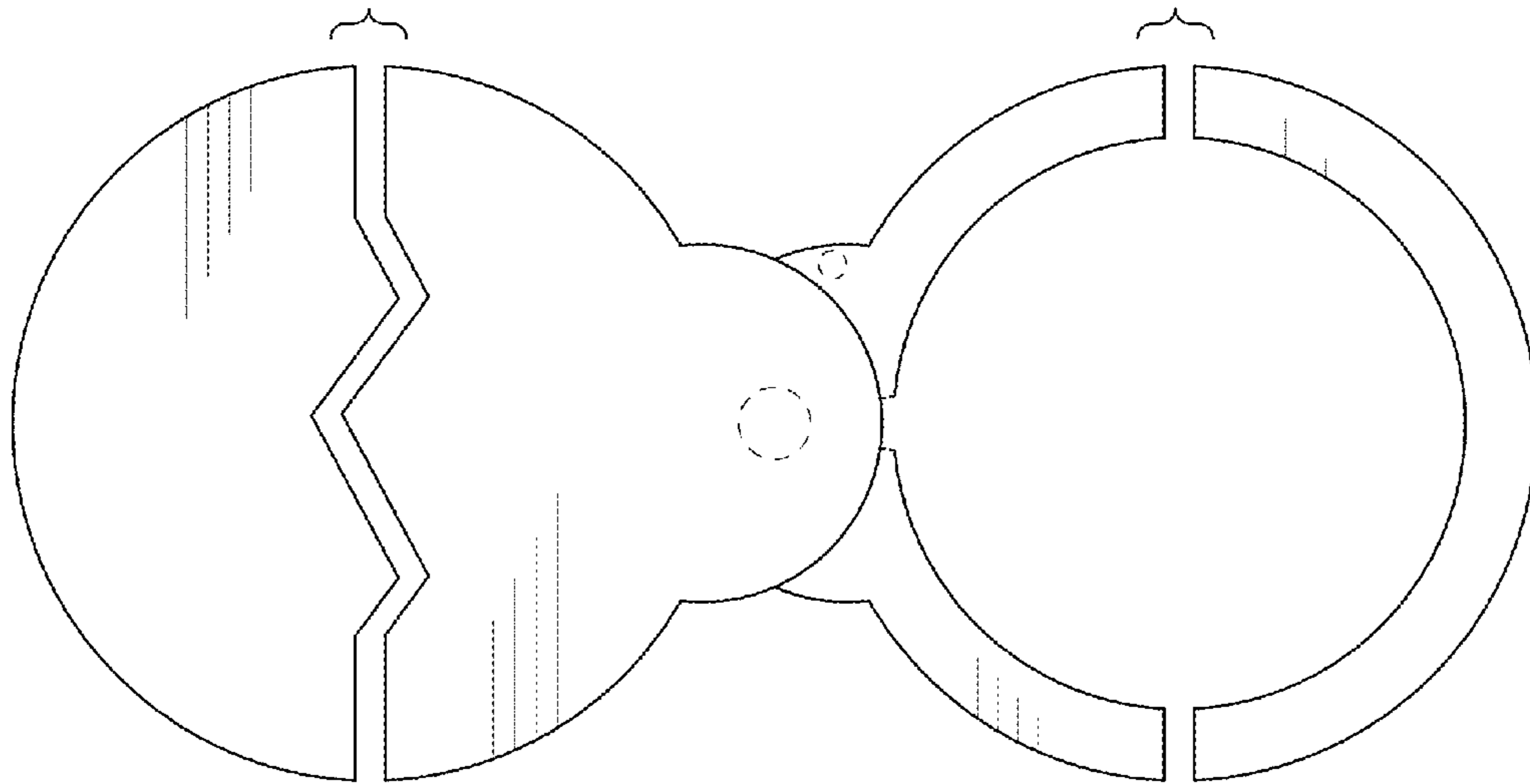

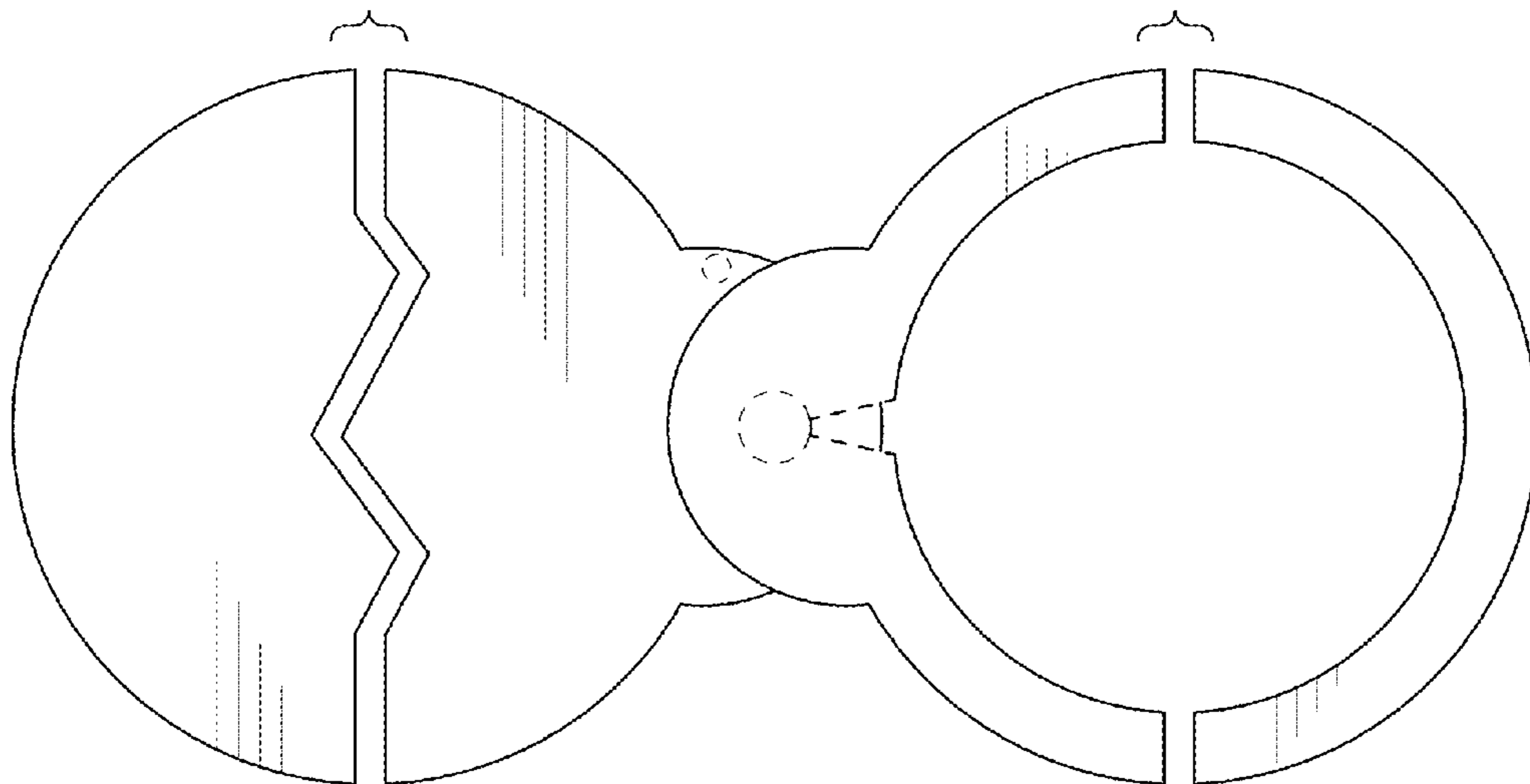

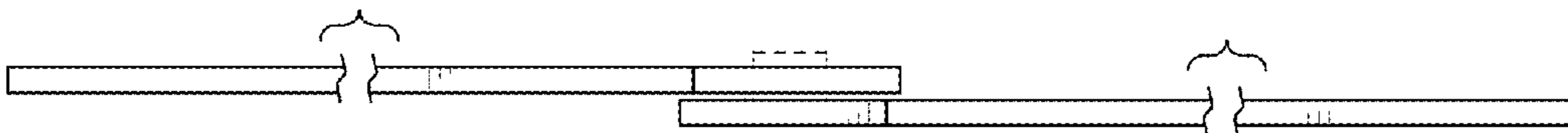

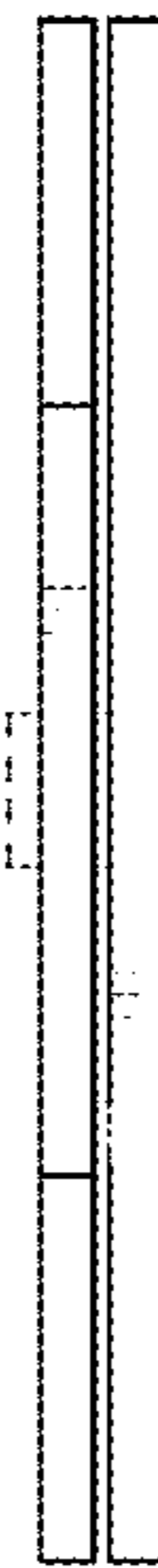

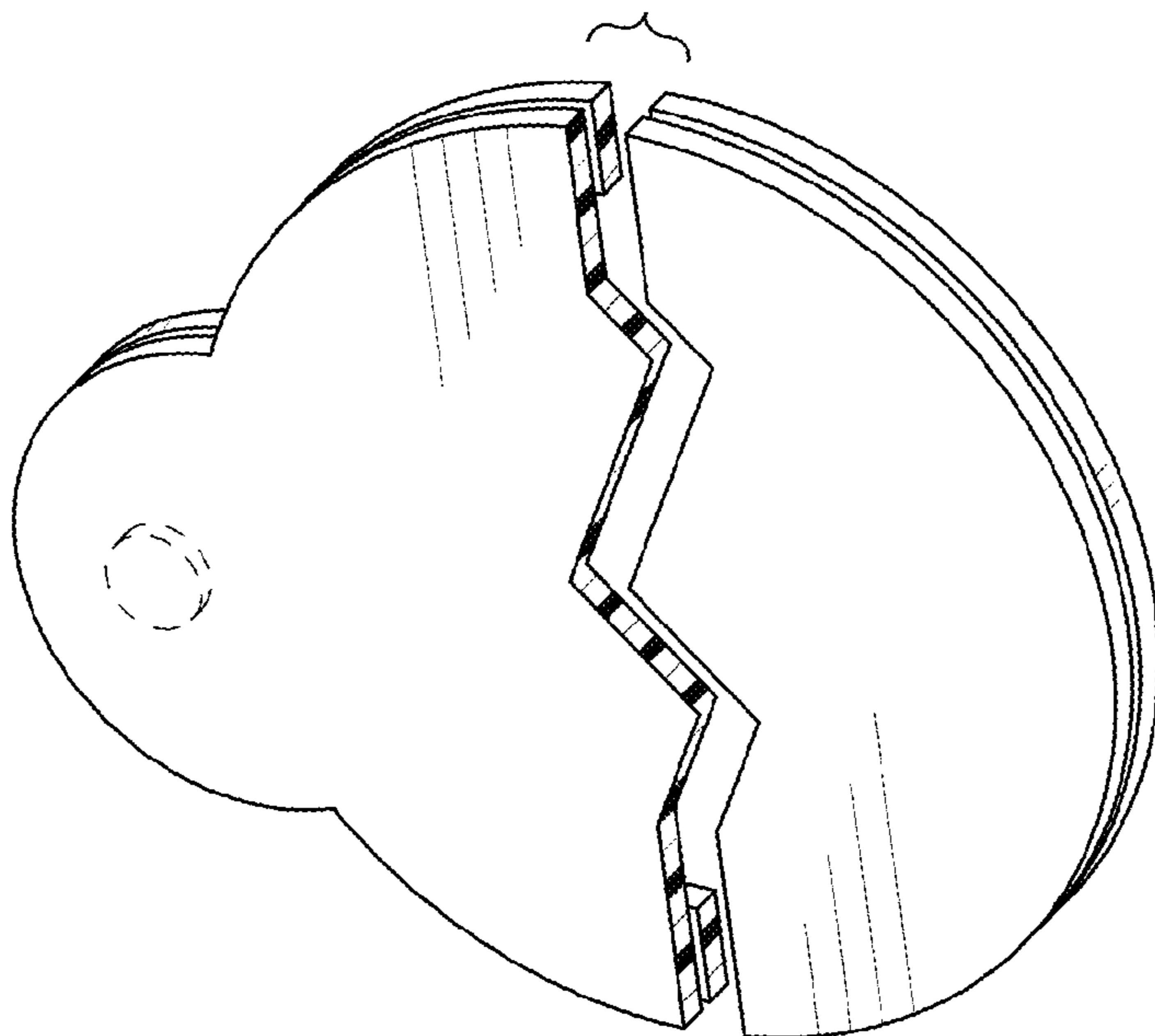

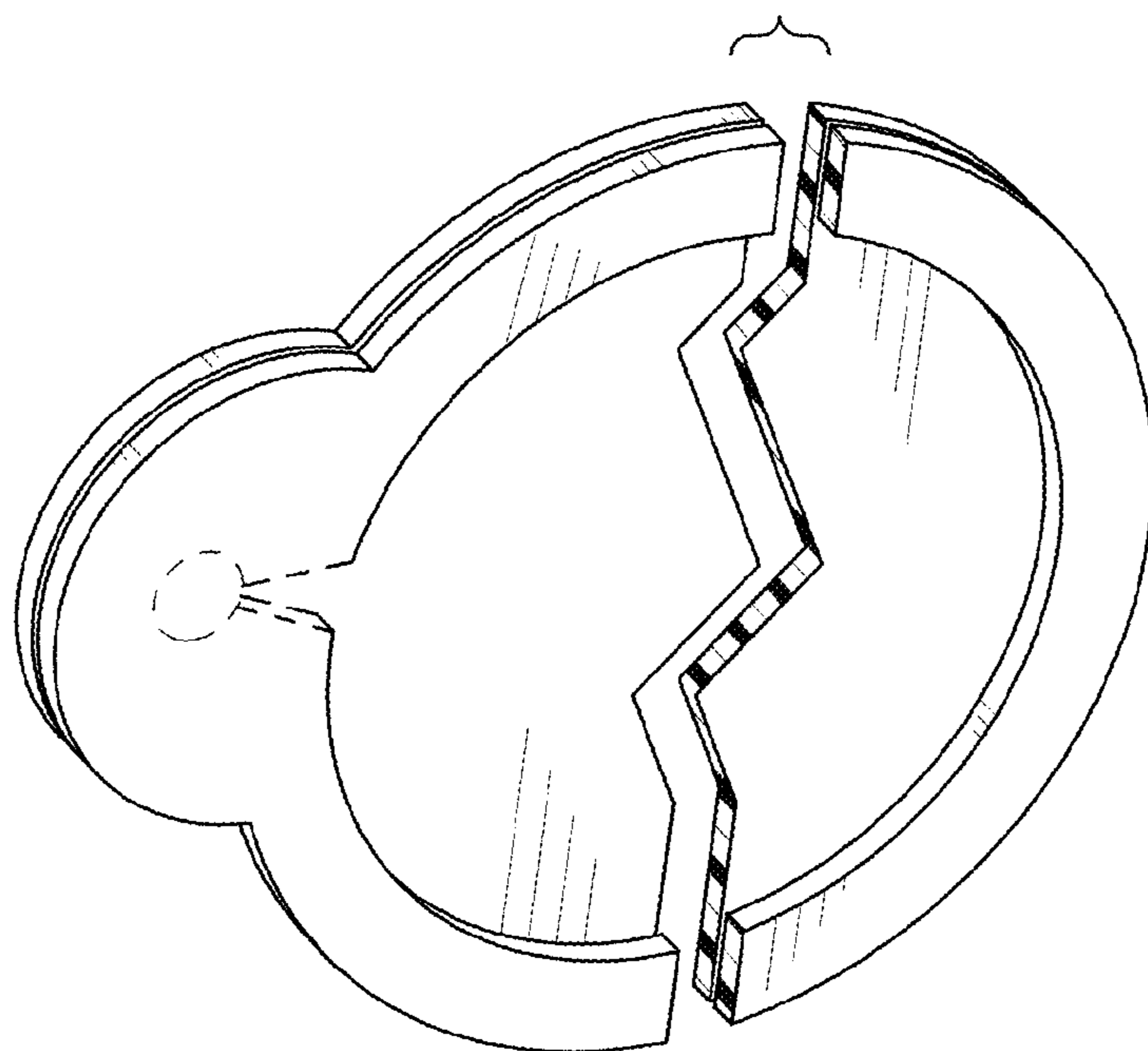

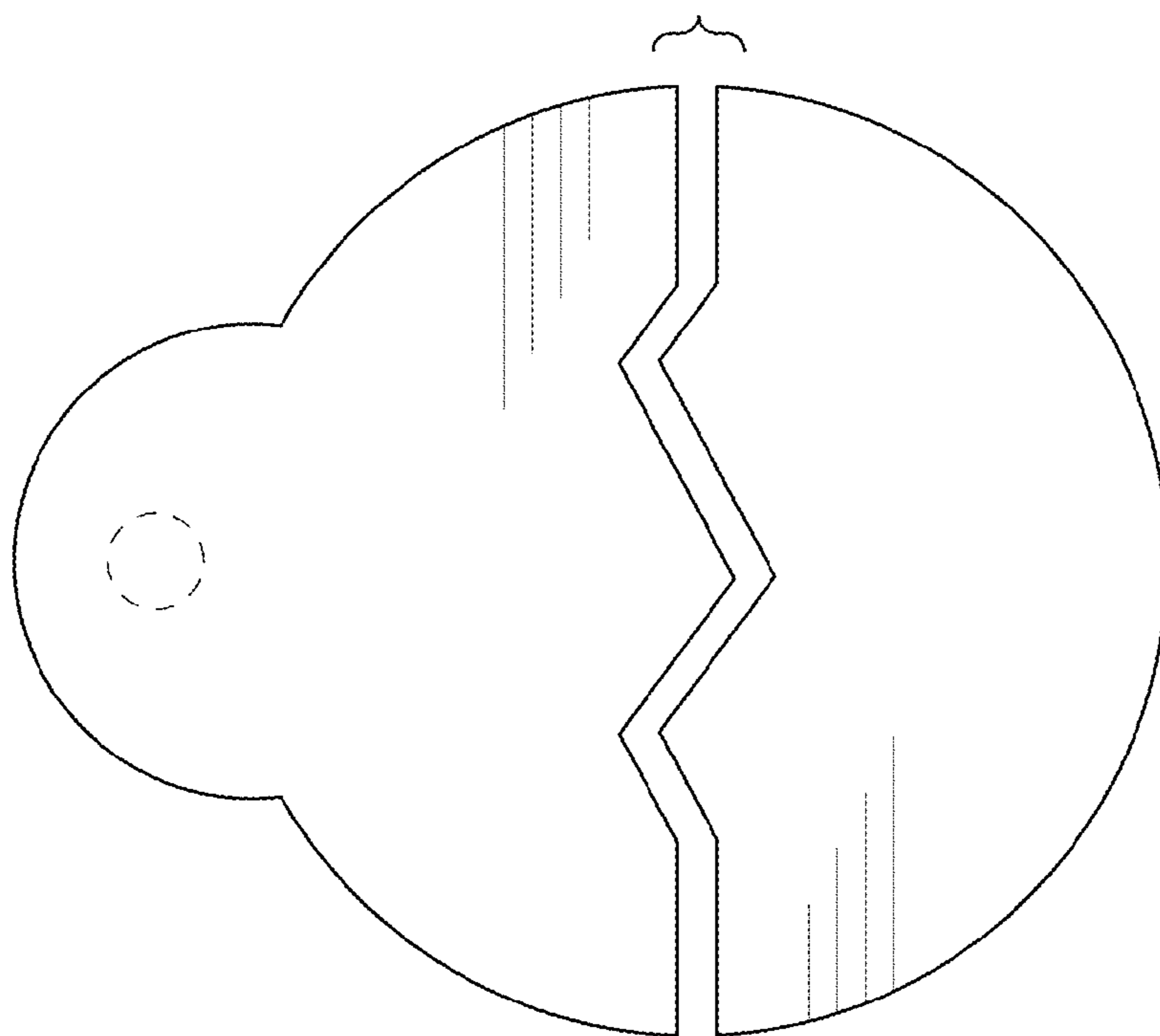

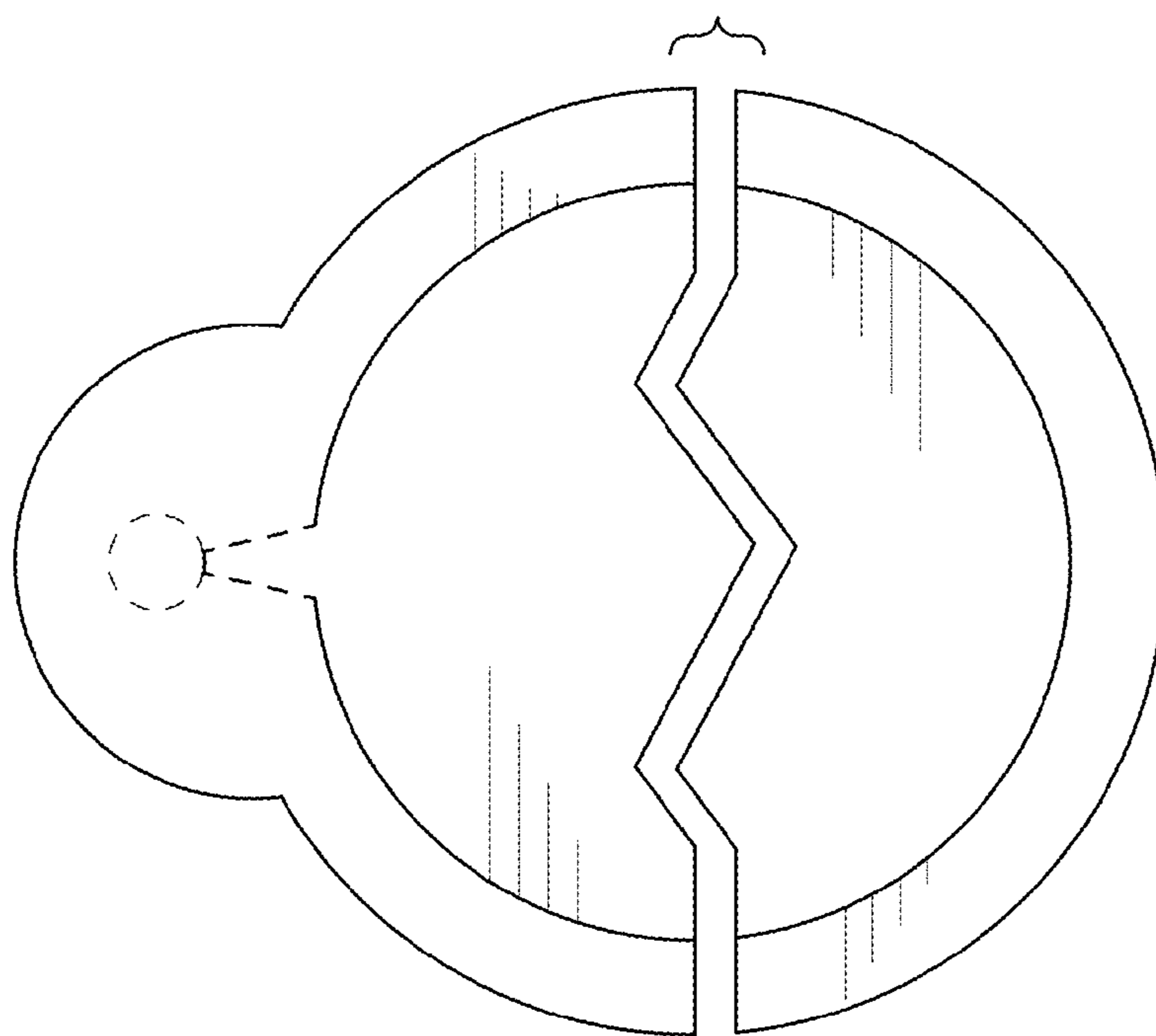

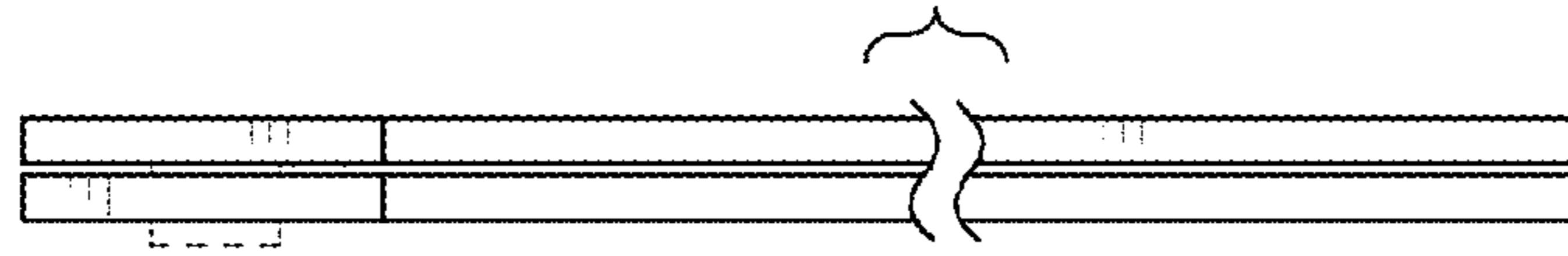

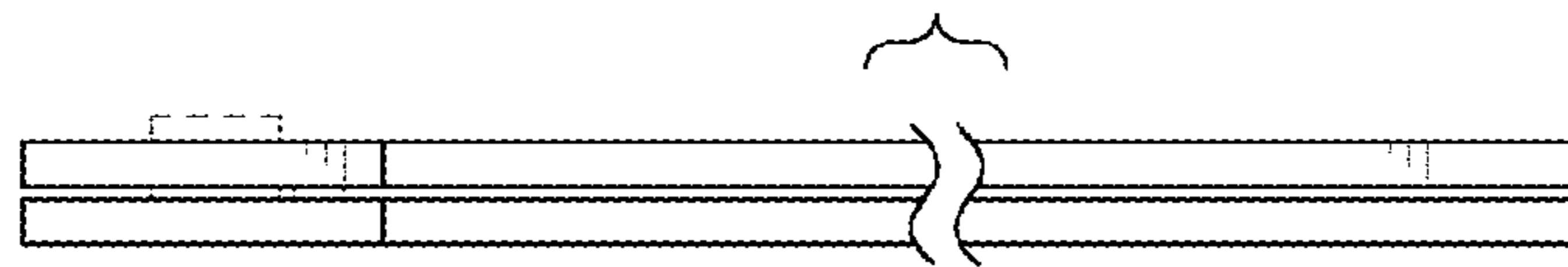

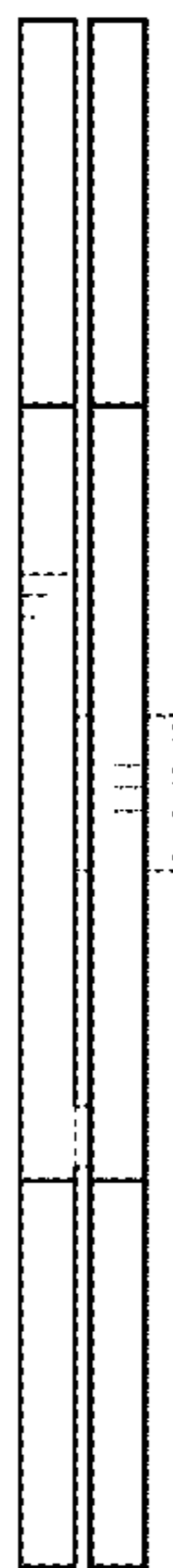

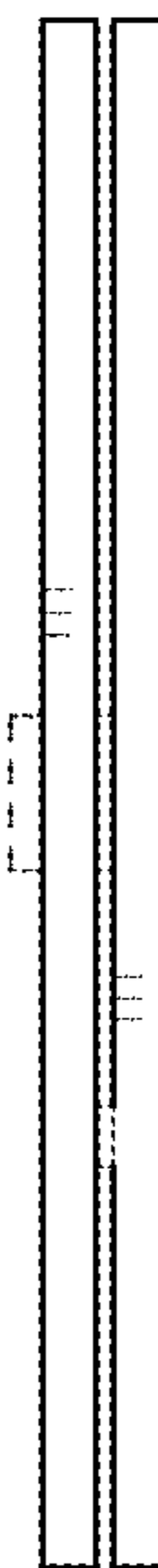
