(57) **CLAIM**

The ornamental design for a transformable and interconnectable toy, as shown and described.

FIGS. 1-3 are top perspective views of a transformable and interconnectable toy showing a new design, FIG. 1 showing a first portion of said toy, FIG. 2 showing a second portion of said toy, and FIG. 3 showing a third portion of said toy, each portion shown in a closed position;

FIGS. 4-6 are front elevation views thereof, FIG. 4 showing a first portion of said toy, FIG. 5 showing a second portion of said toy, and FIG. 6 showing a third portion of said toy, each portion shown in a closed position;

FIGS. 7-9 are back elevation views thereof, FIG. 7 showing a first portion of said toy, FIG. 8 showing a second portion of said toy, and FIG. 9 showing a third portion of said toy, each portion shown in a closed position;

FIGS. 10-12 are left side elevation views thereof, FIG. 10 showing a first portion of said toy, FIG. 11 showing a second portion of said toy, and FIG. 12 showing a third portion of said toy, each portion shown in a closed position;

FIGS. 13-15 are right side elevation views thereof, FIG. 13 showing a first portion of said toy, FIG. 14 showing a second portion of said toy, and FIG. 15 showing a third portion of said toy, each portion shown in a closed position;

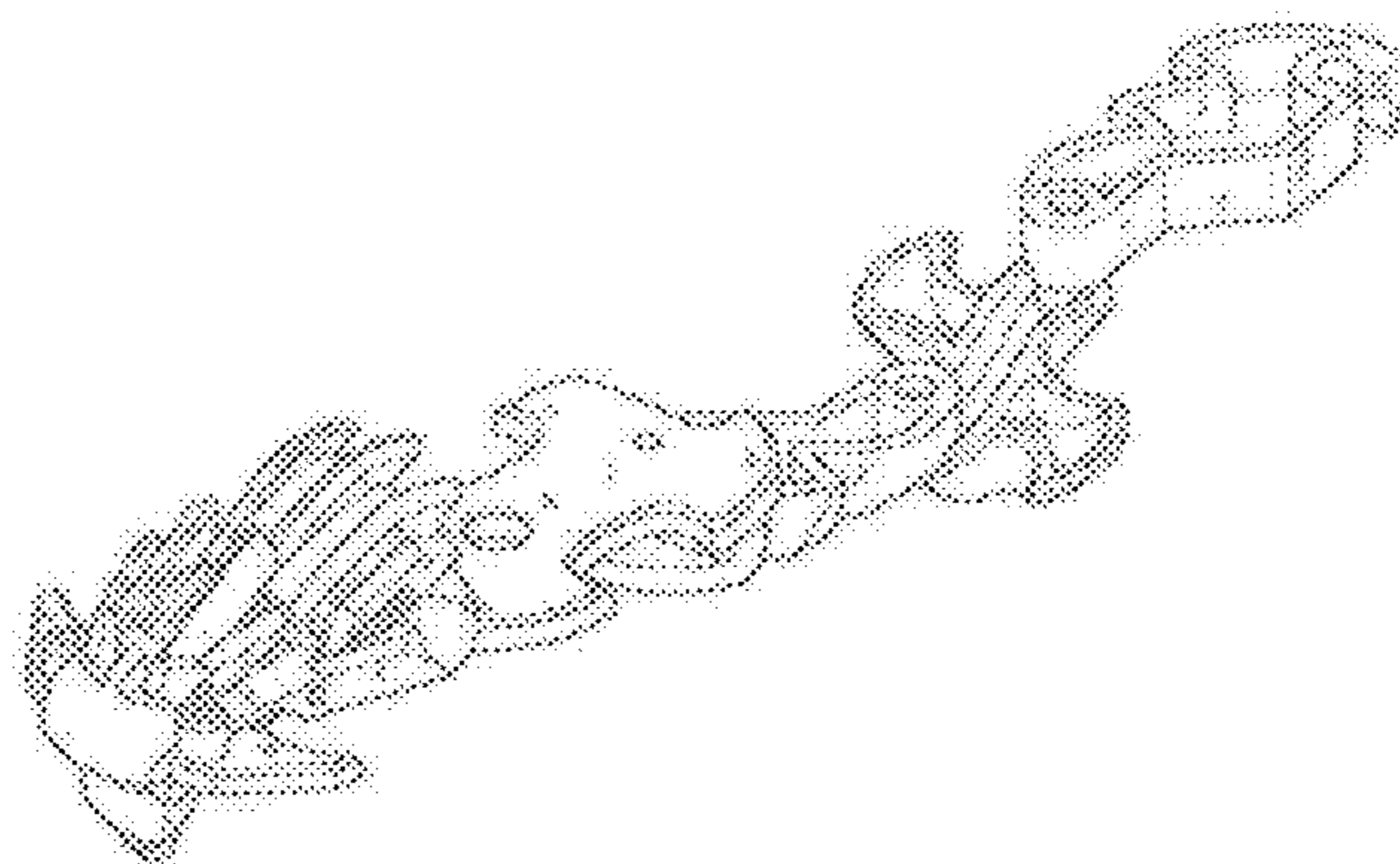
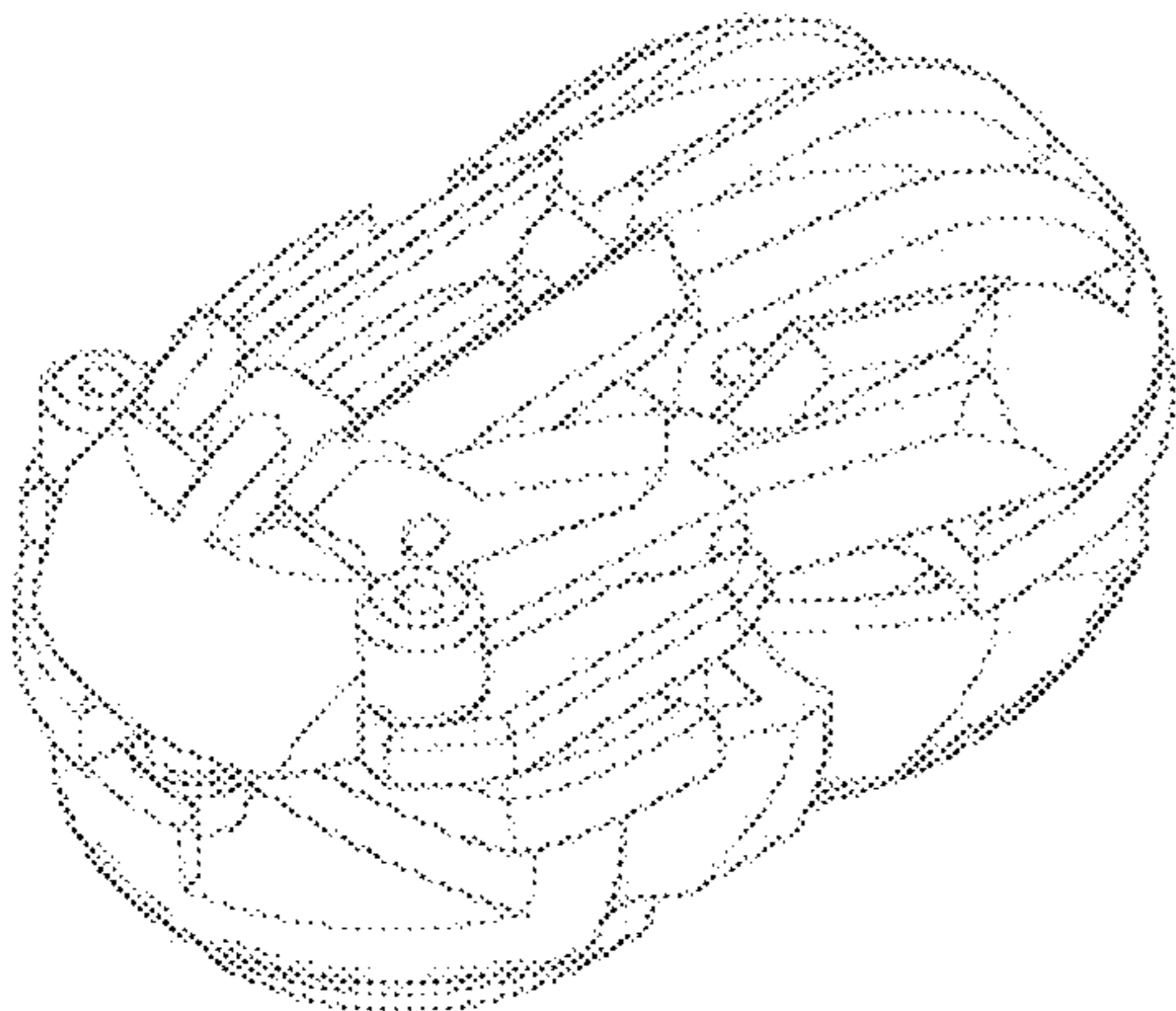

FIGS. **29-31** are front elevation views thereof, FIG. **29** showing a first portion of said toy, FIG. **30** showing a second portion of said toy, and FIG. **31** showing a third portion of said toy, each portion shown in an open position;

FIG. **32** is a back elevation view of the first, second, and third portions in an open position and interconnected to an adjacent portion;

FIGS. **33-35** are back elevation views thereof, FIG. **33** showing a first portion of said toy, FIG. **34** showing a second portion of said toy, and FIG. **35** showing a third portion of said toy, each portion shown in an open position;

FIG. **36** is a right side elevation view of the first, second, and third portions in an open position and interconnected to an adjacent portion;

FIG. **37** is a left side elevation view of the first, second, and third portions in an open position and interconnected to an adjacent portion;

FIG. **38** is a top elevation view of the first, second, and third portions in an open position and interconnected to an adjacent portion; and,

FIG. **39** is a bottom elevation view of the first, second, and third portions in an open position and interconnected to an adjacent portion.

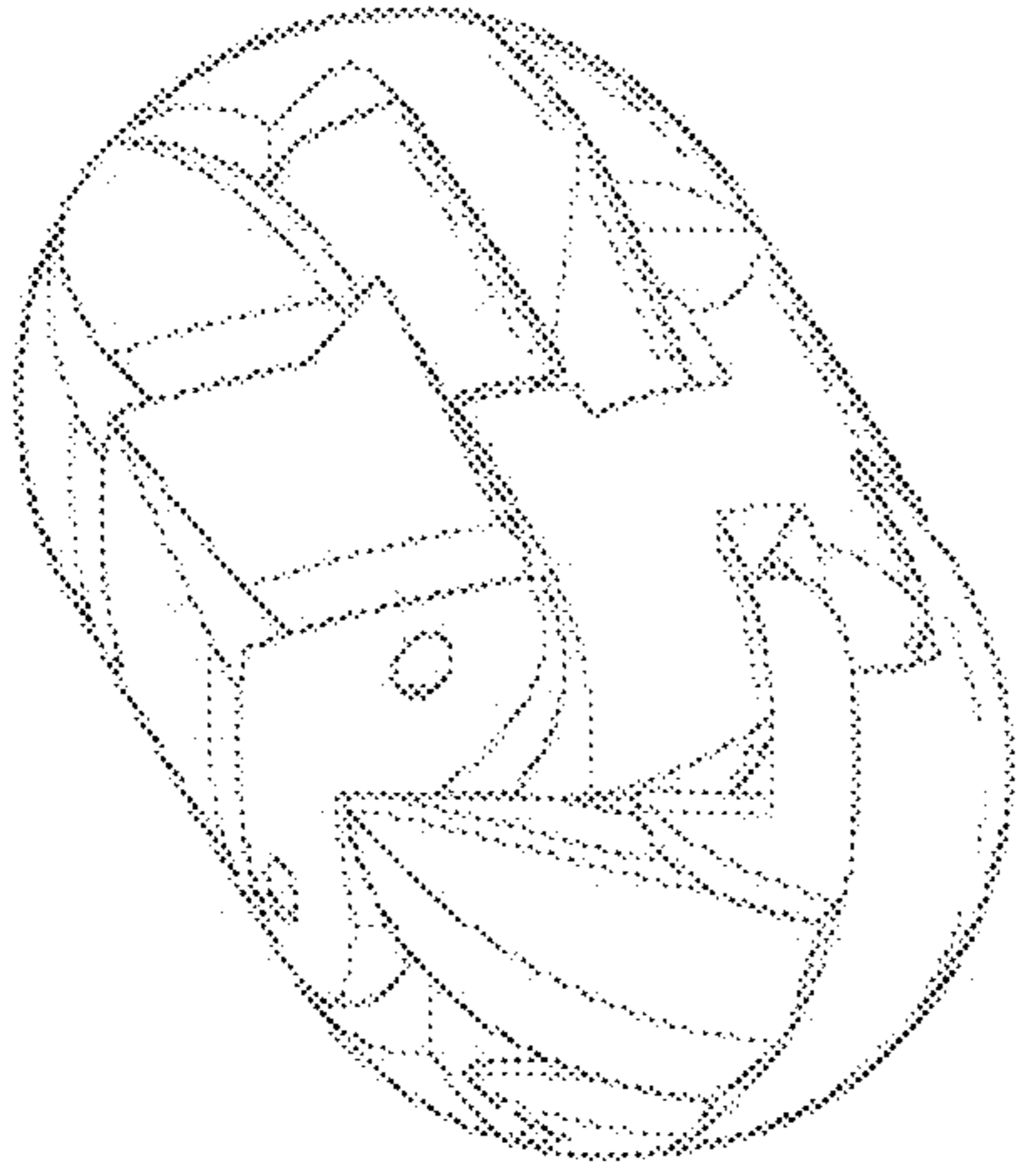

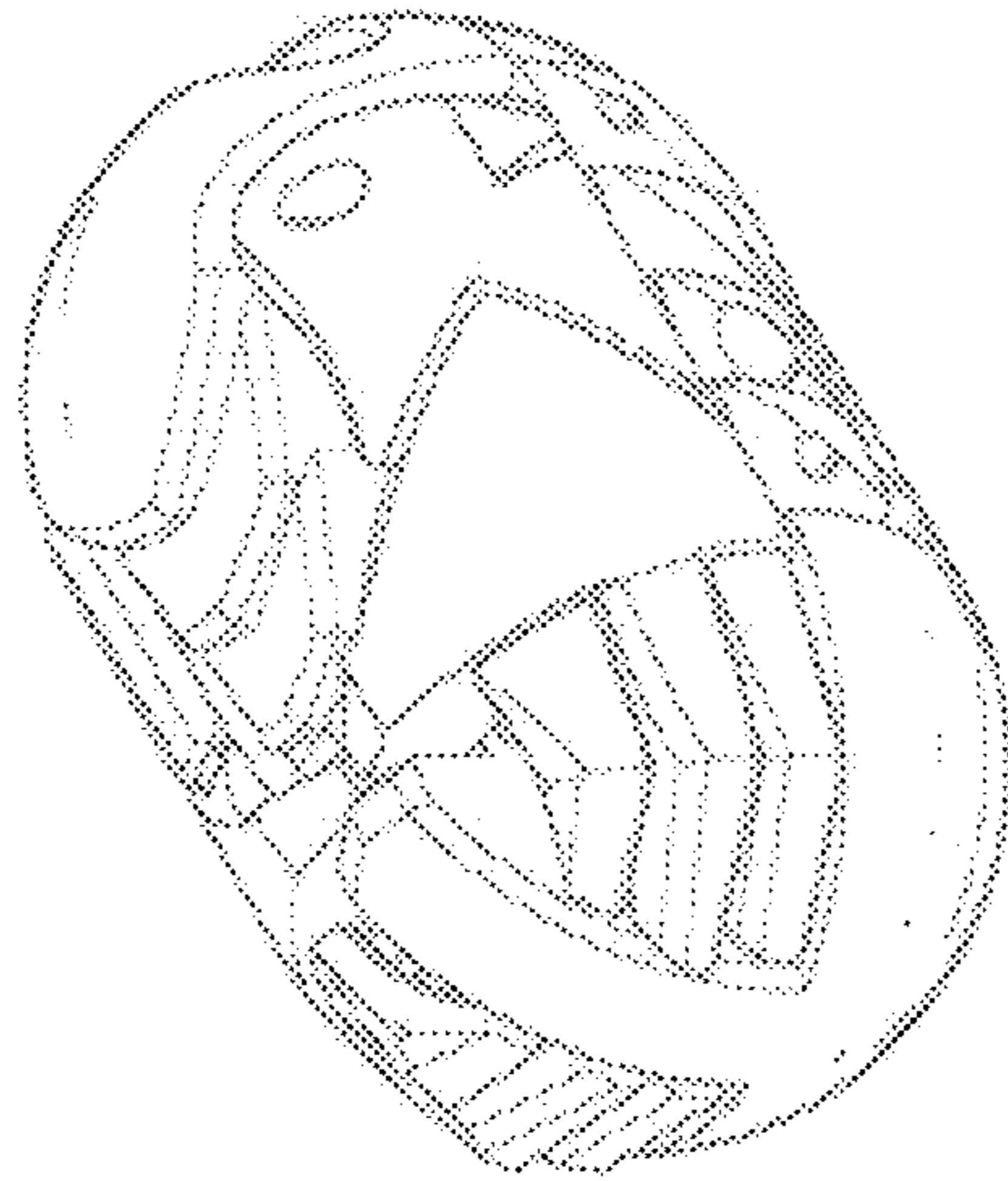

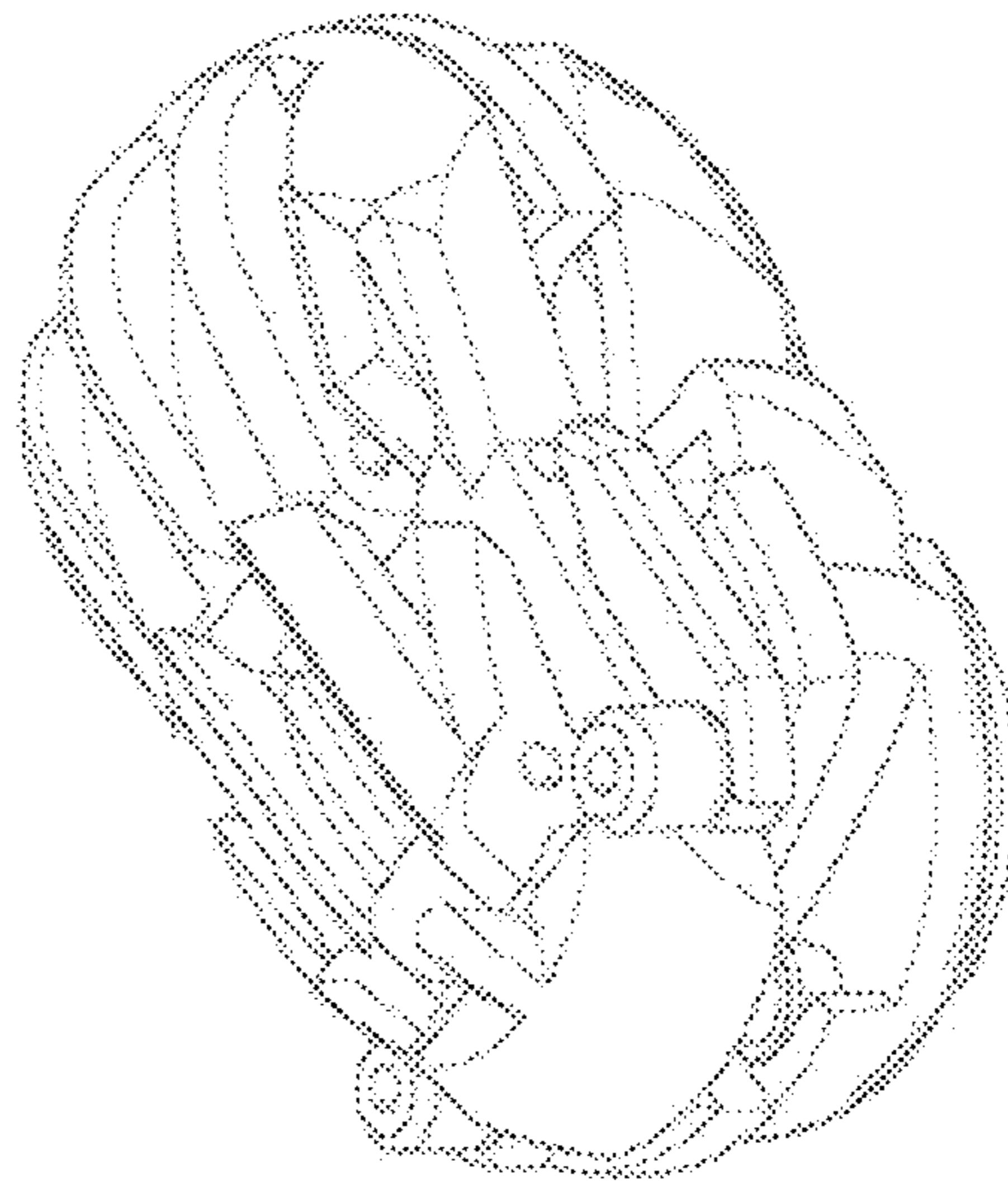

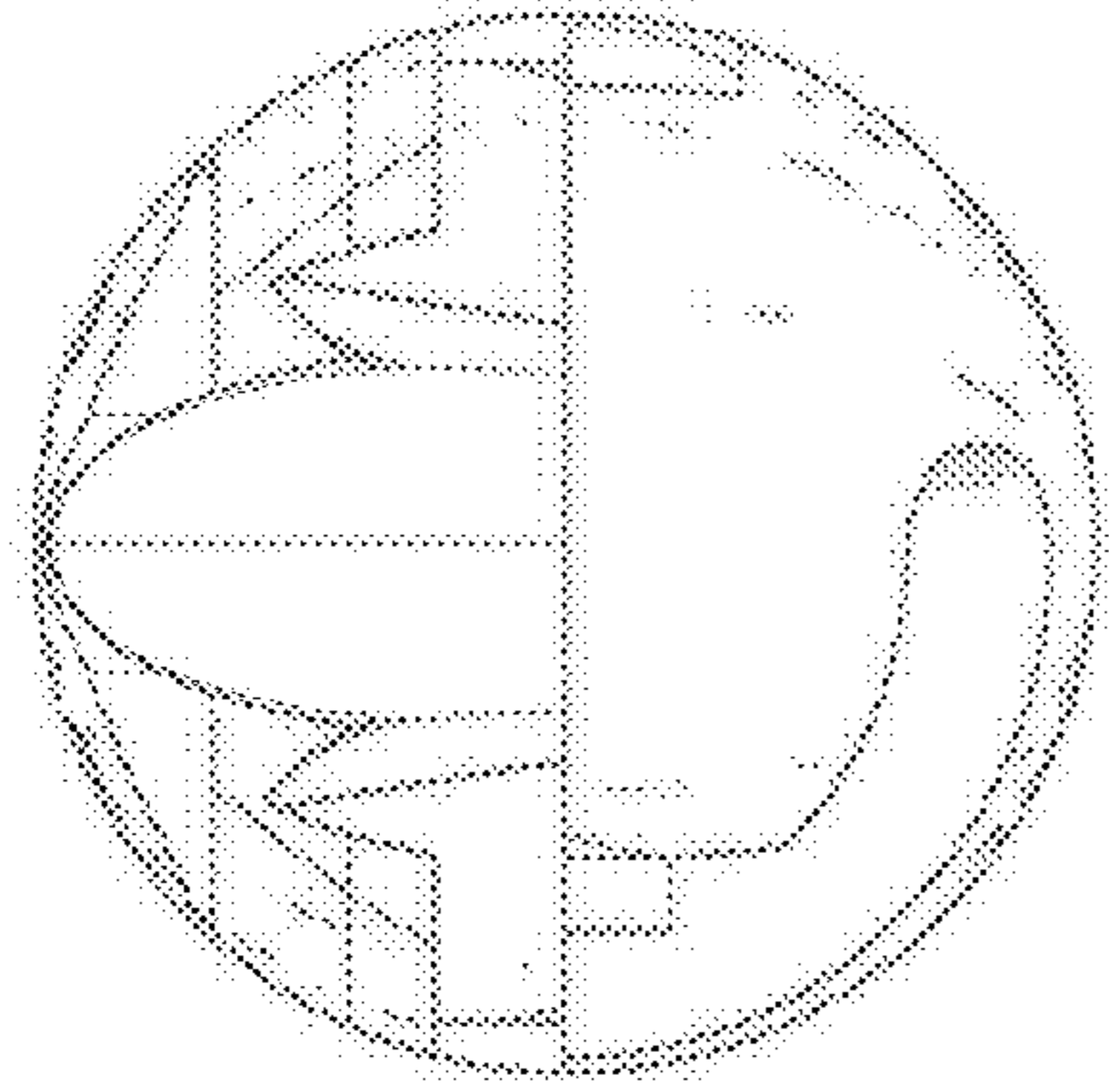

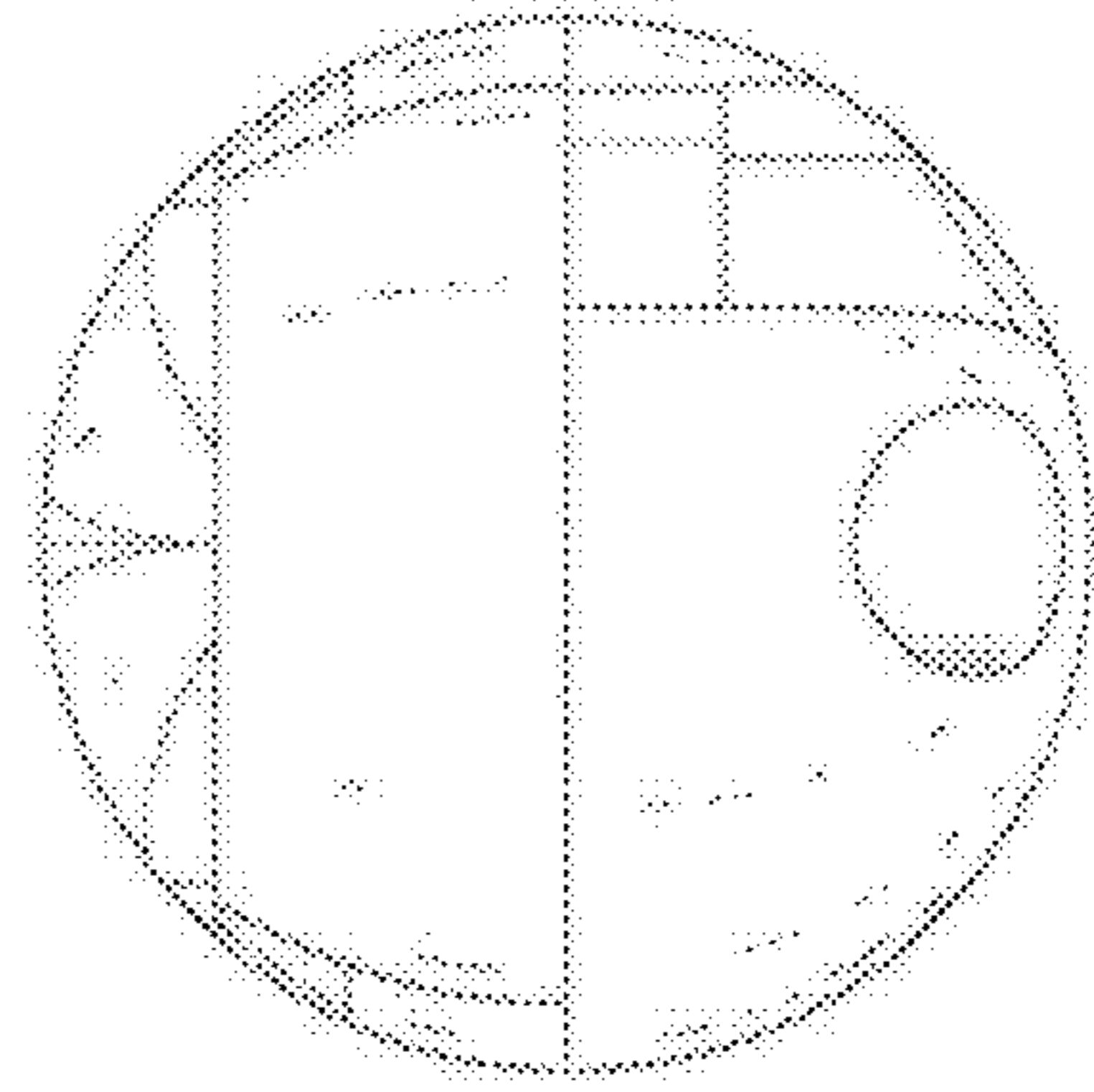

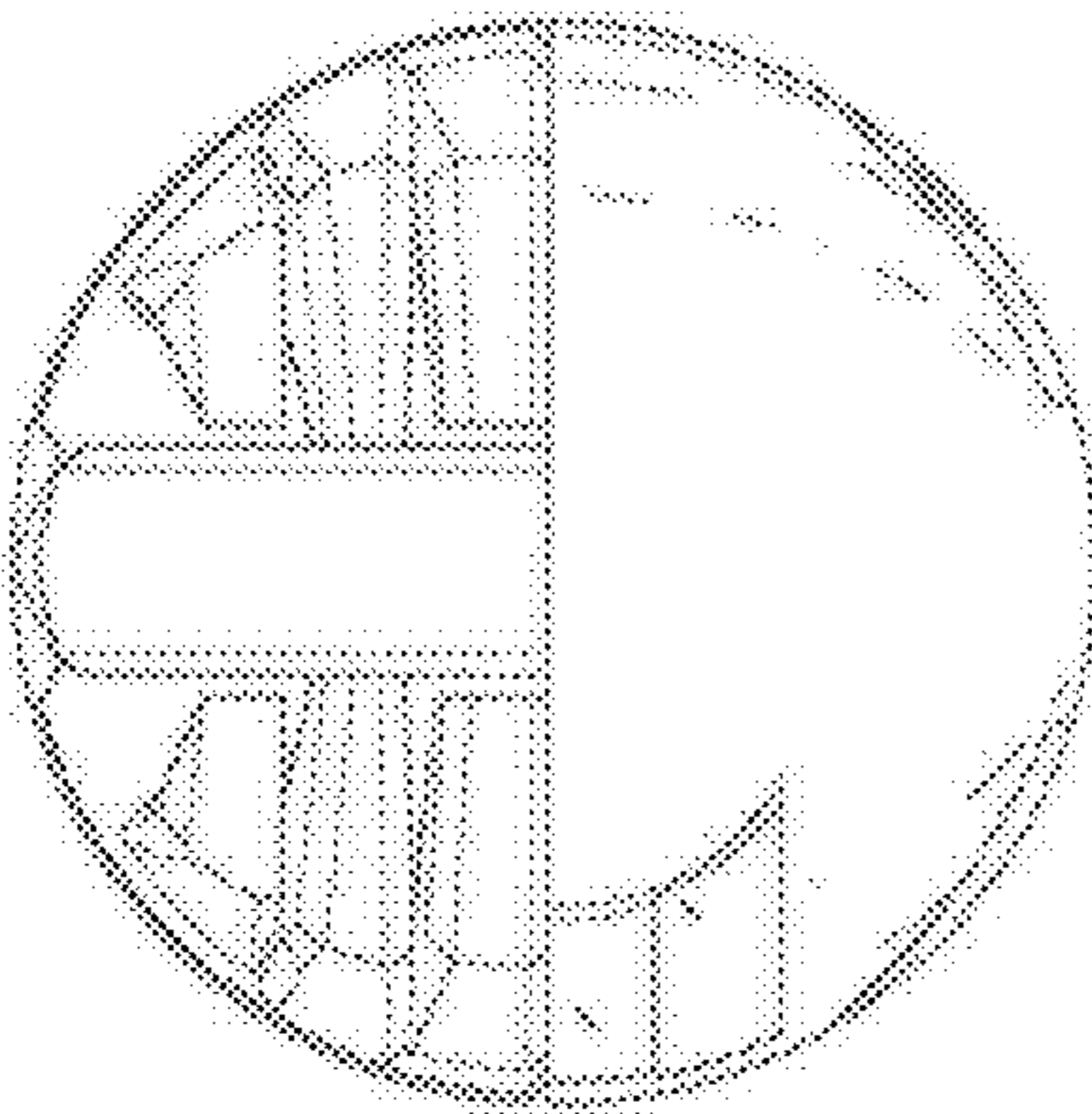

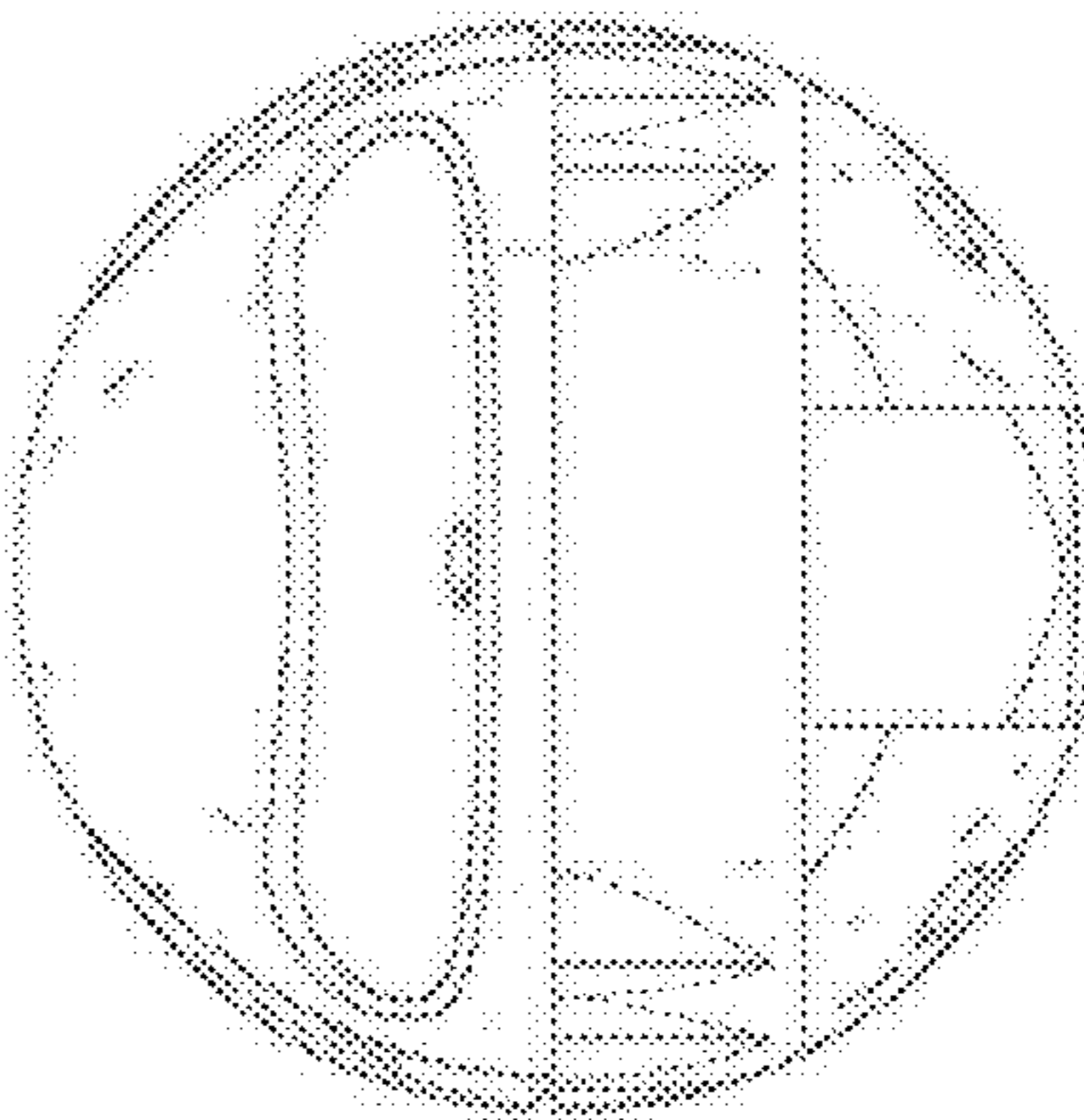

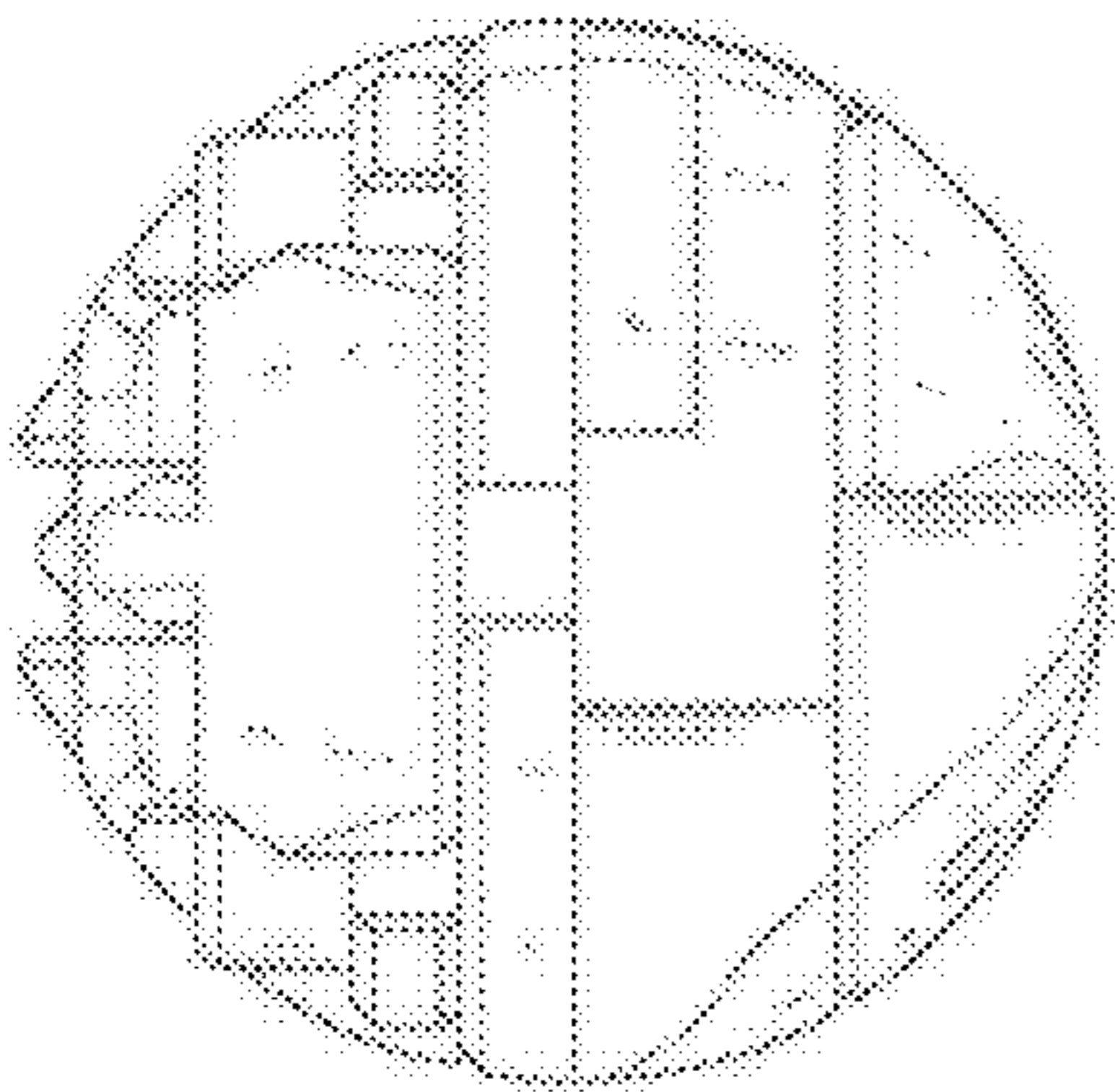

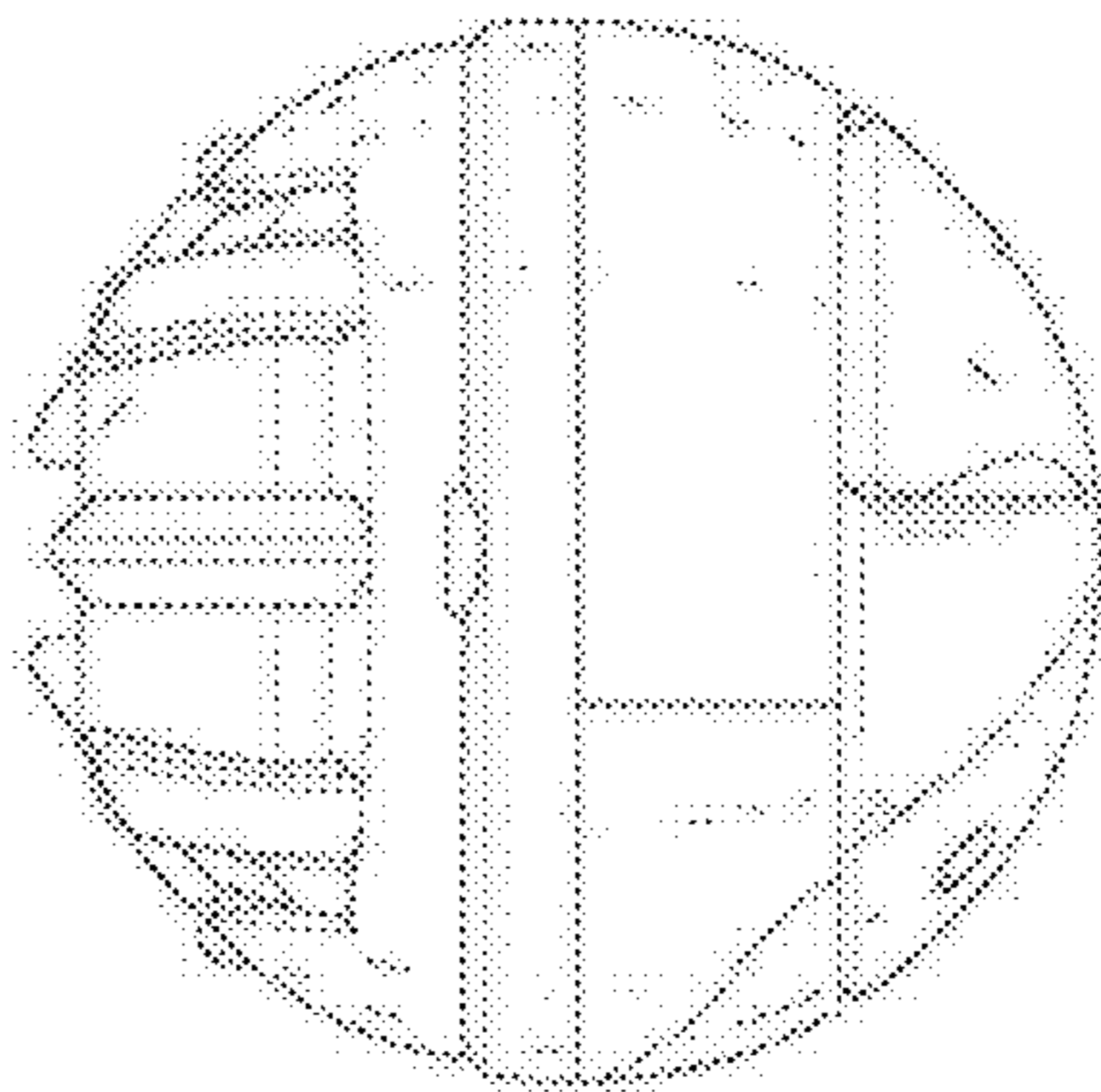

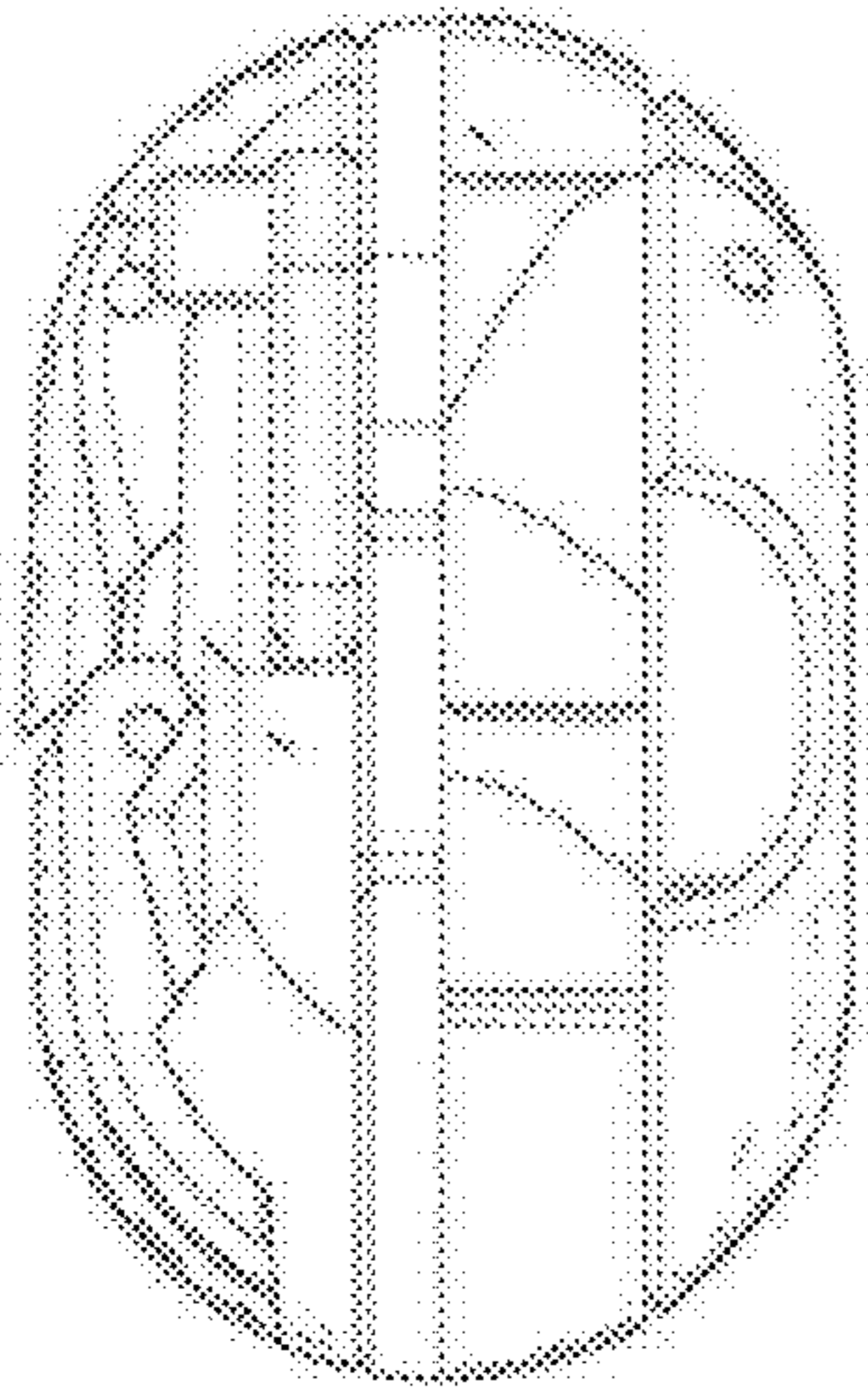

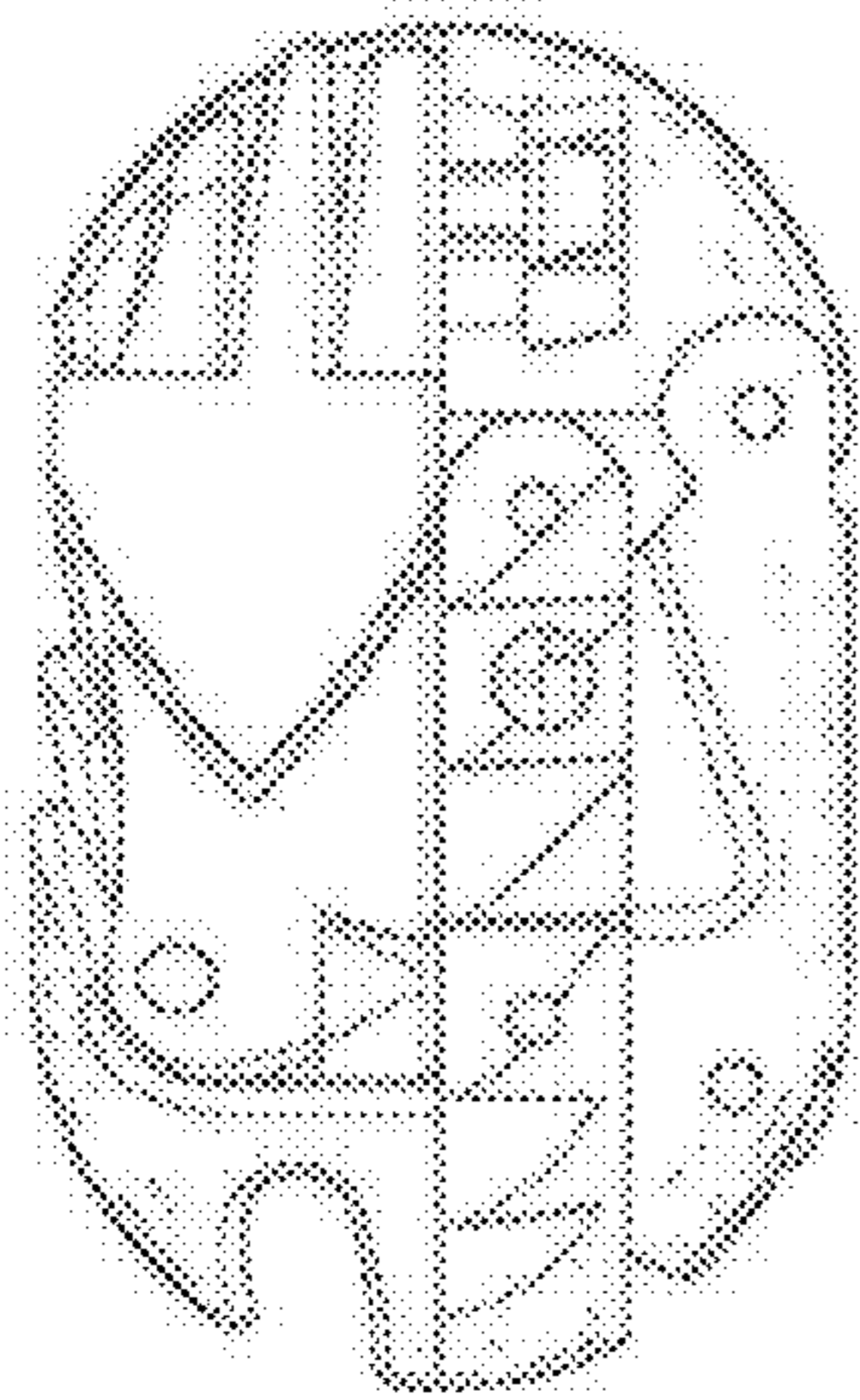

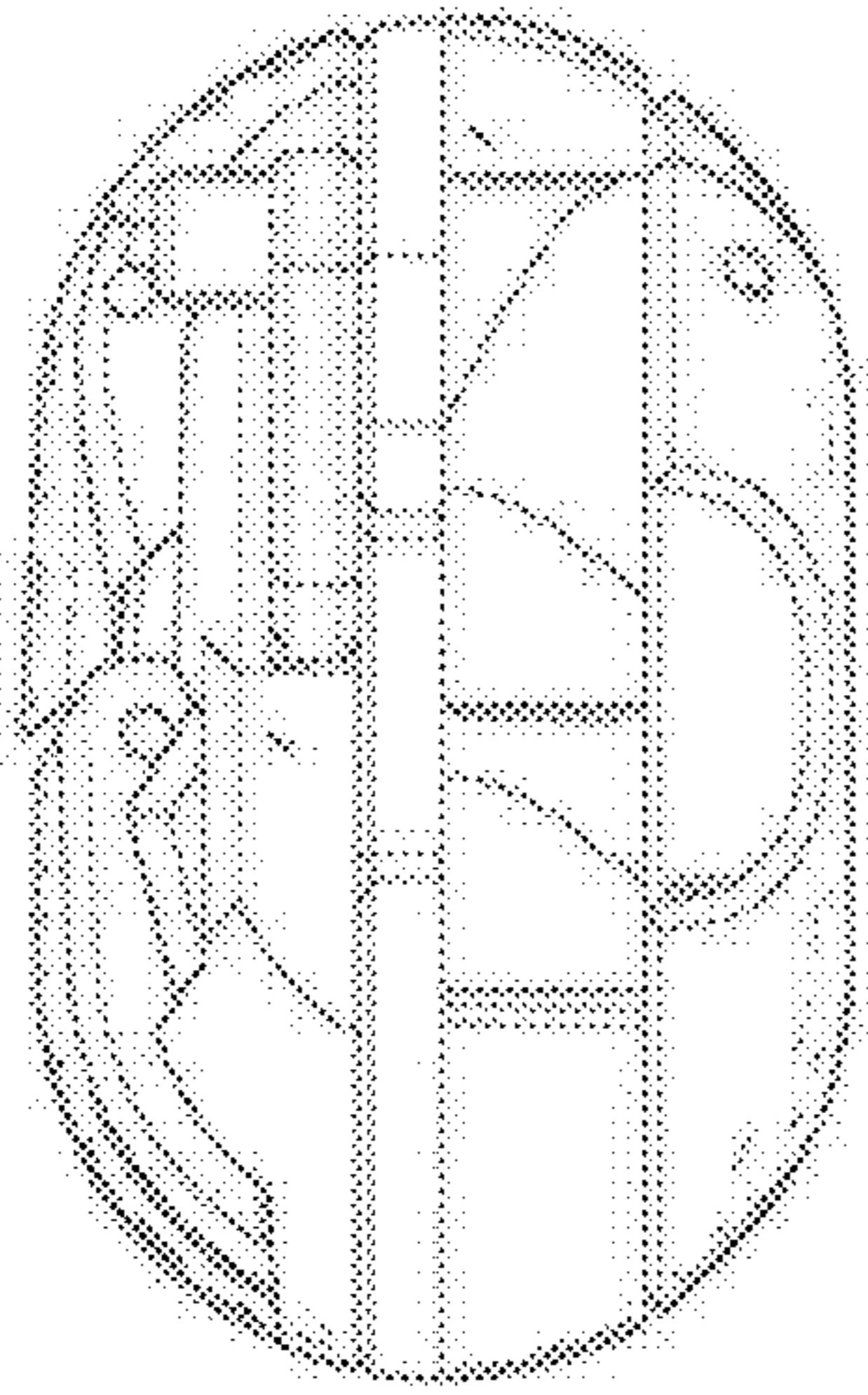

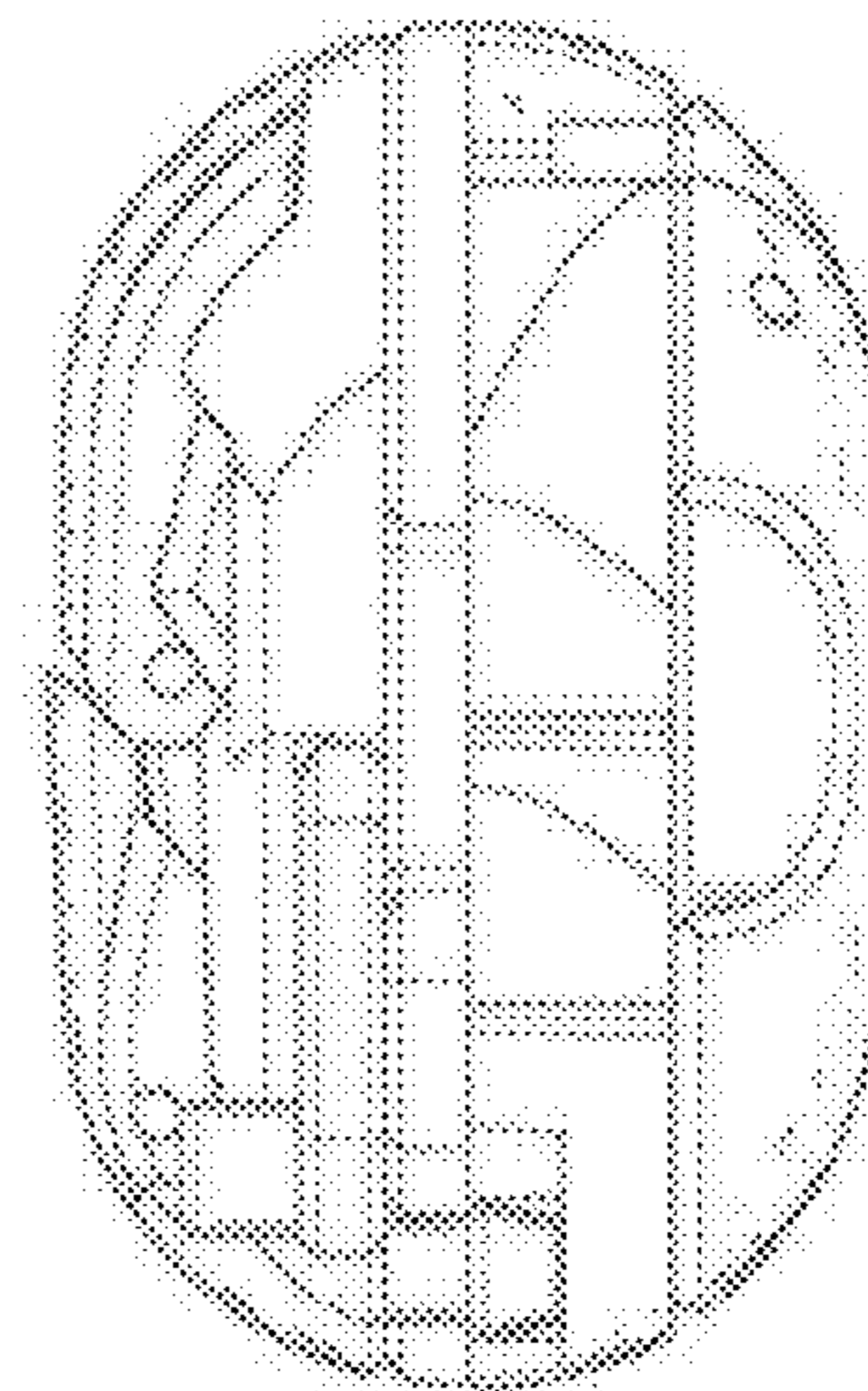

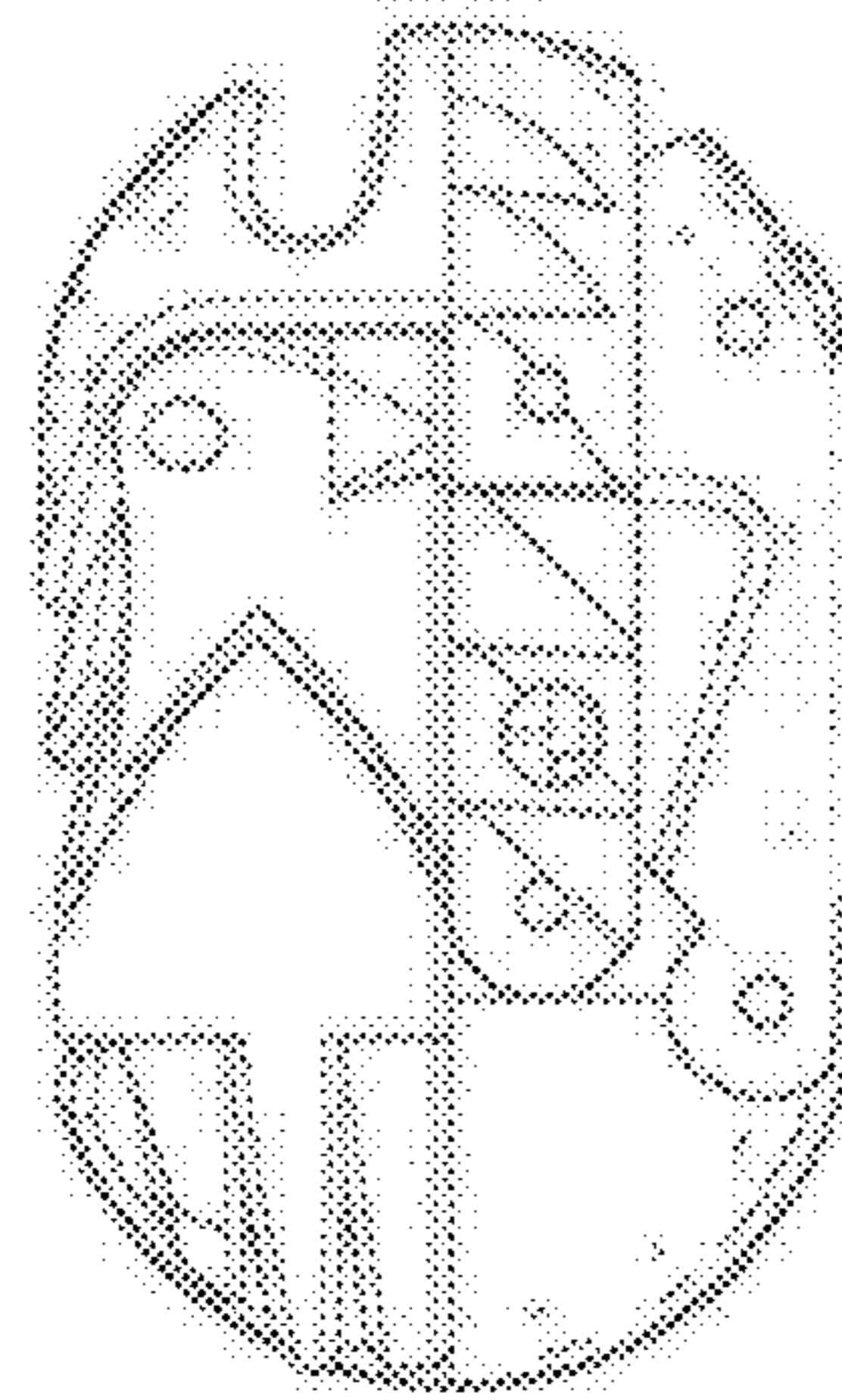

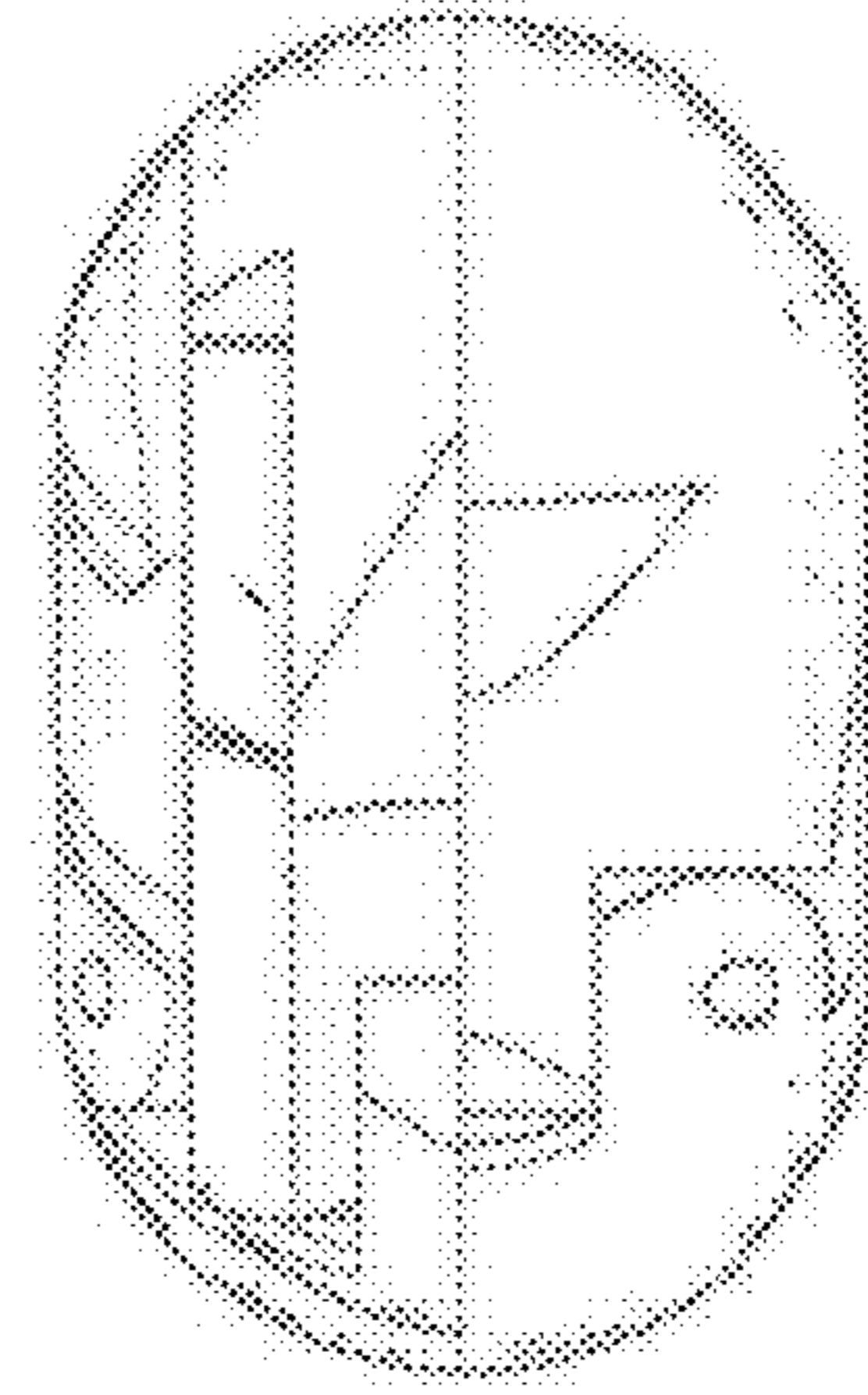

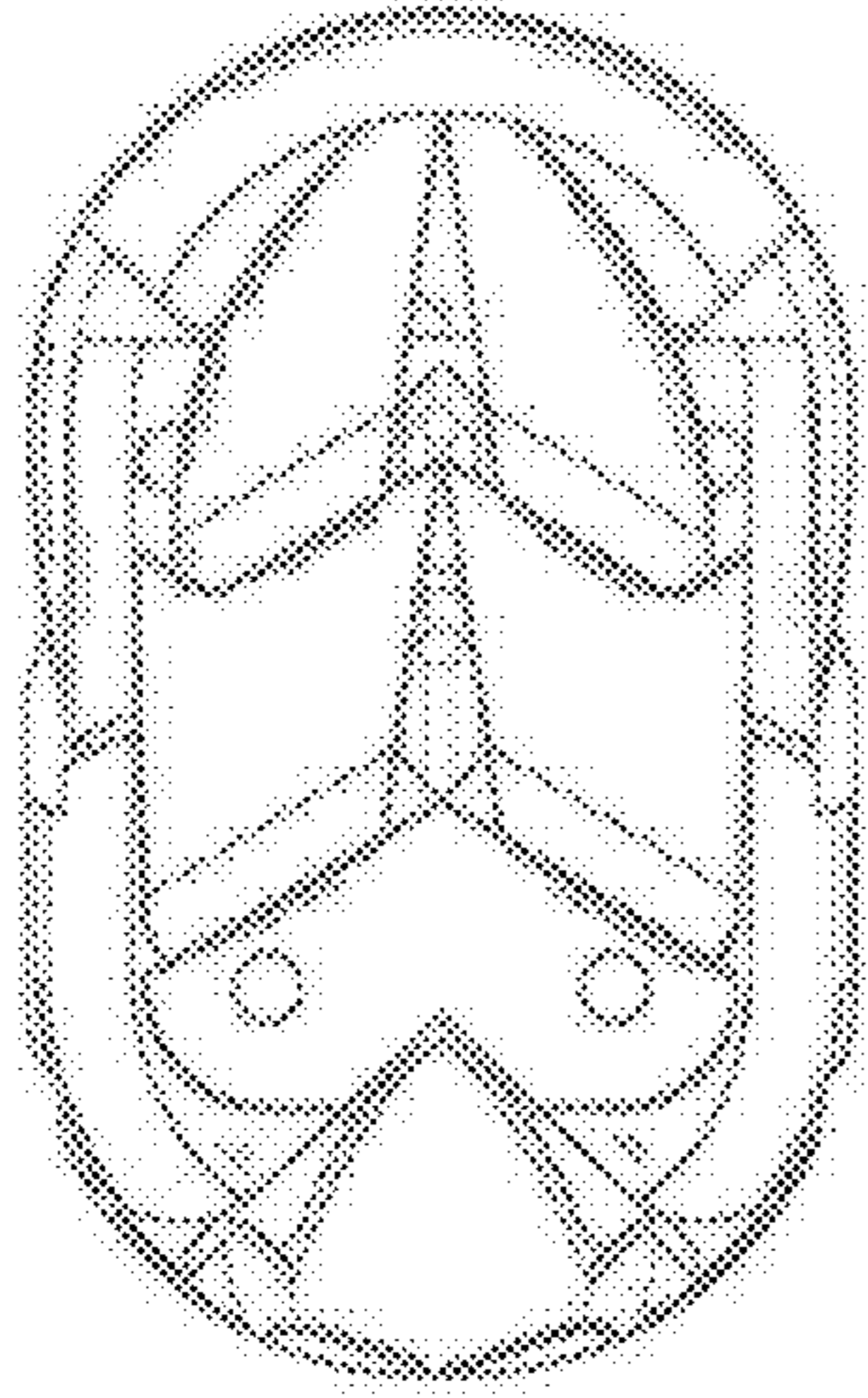

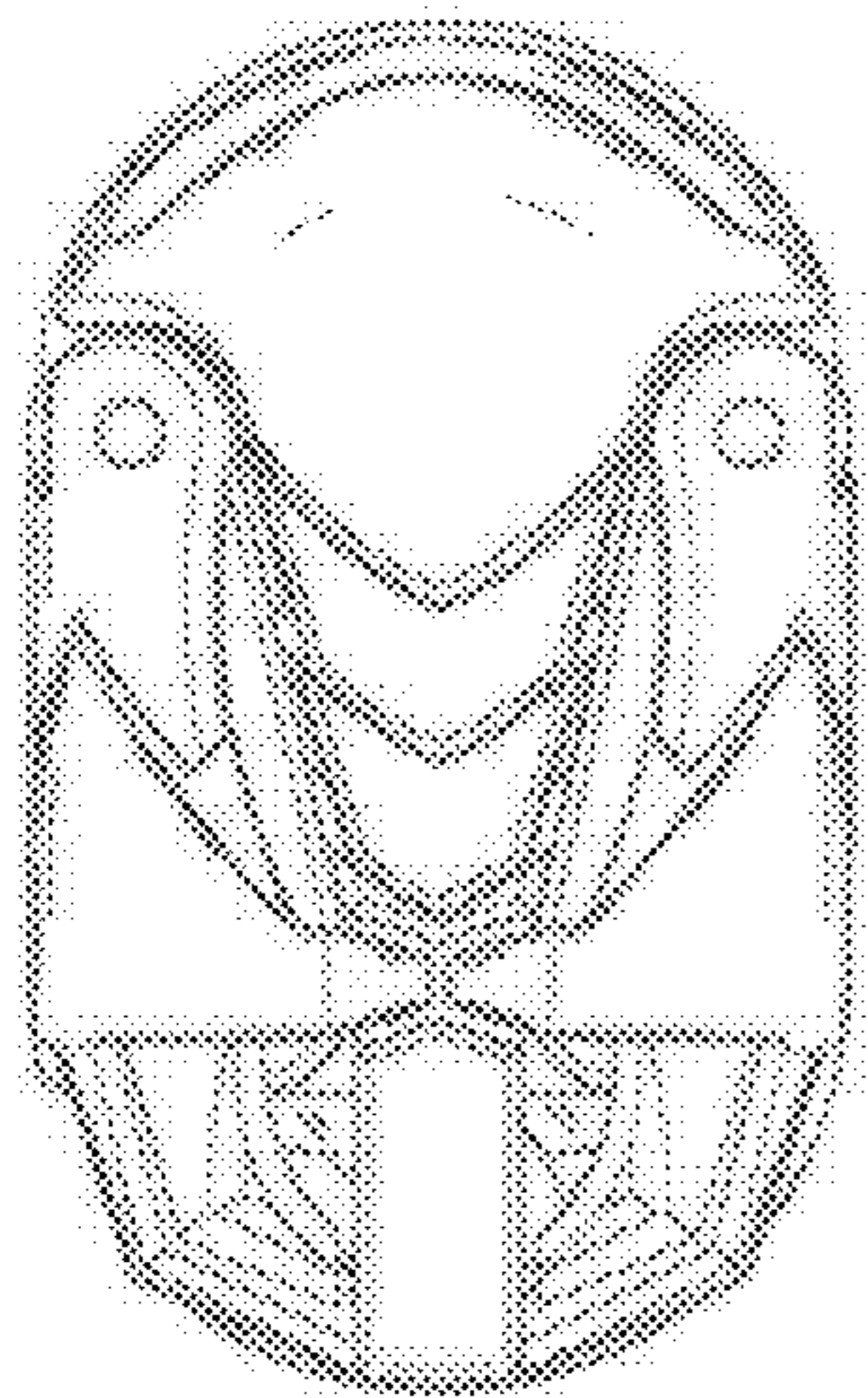

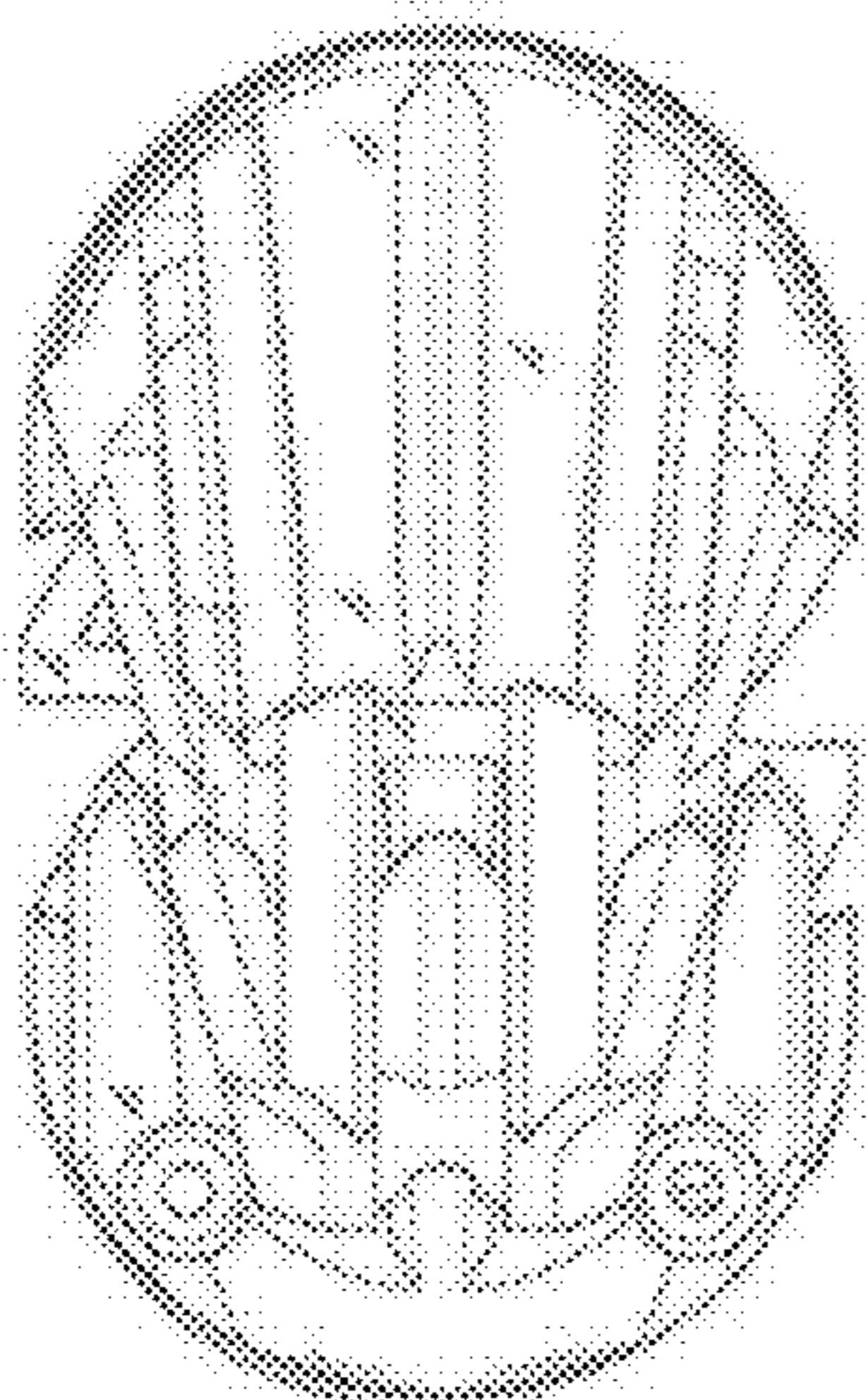

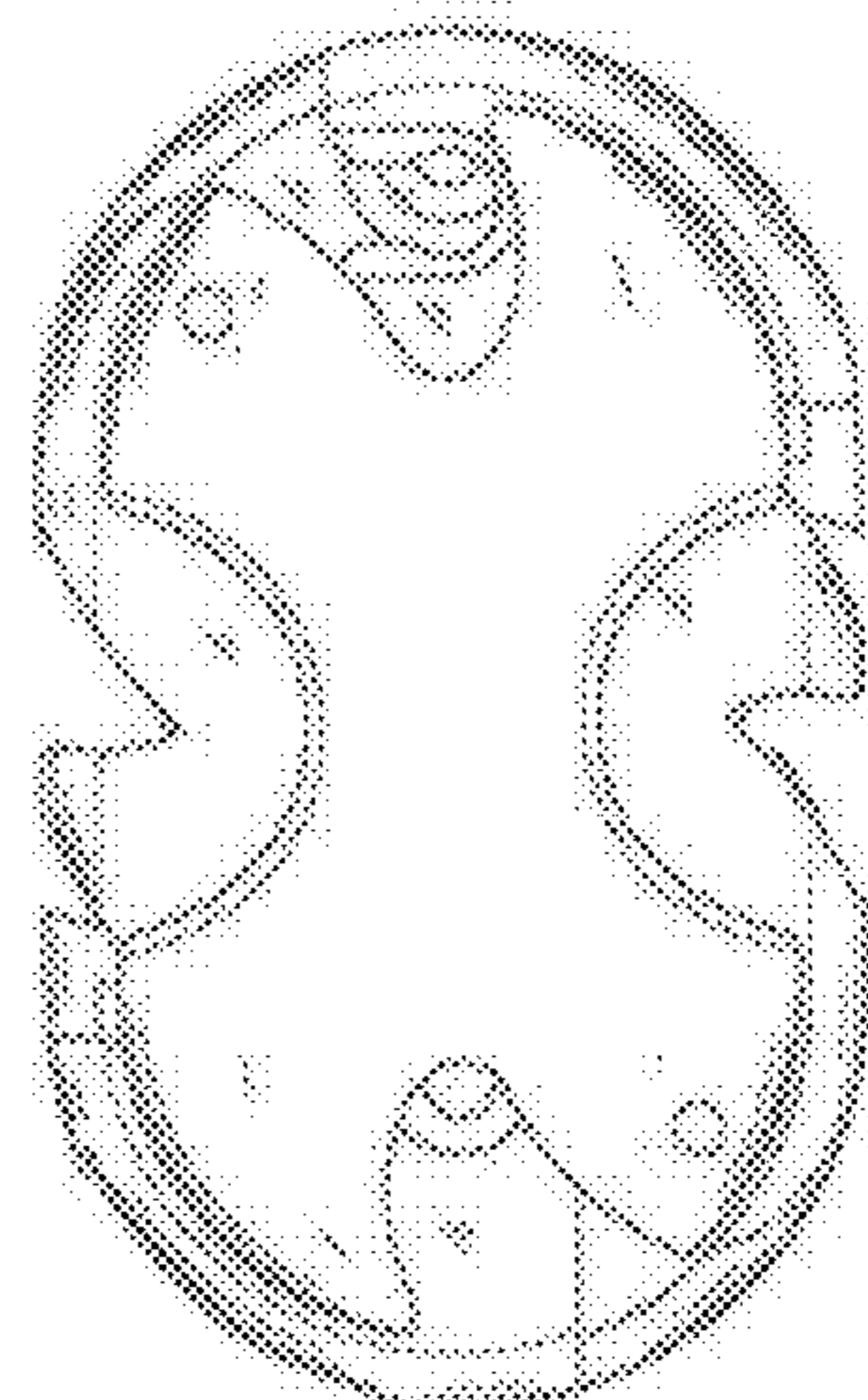

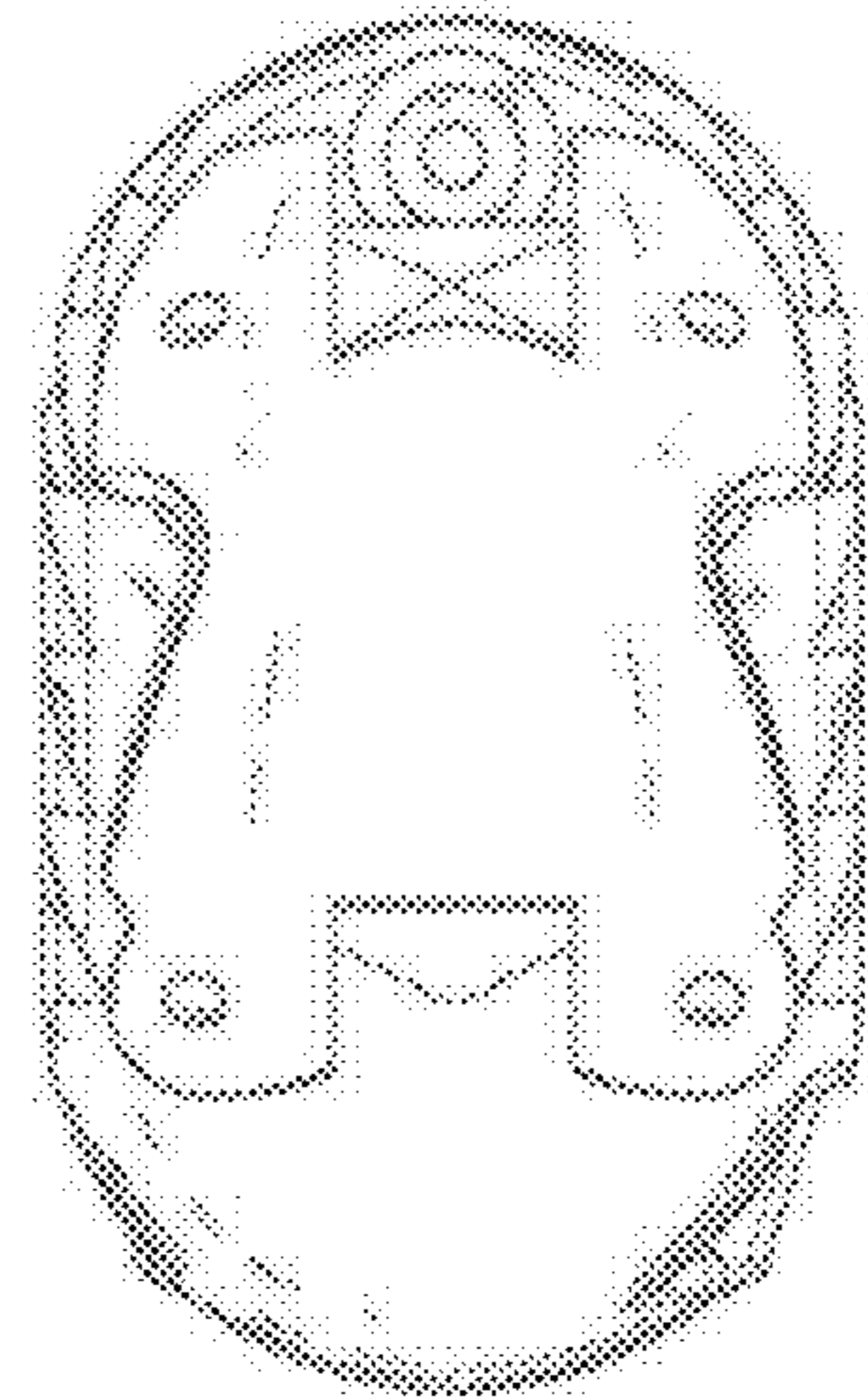

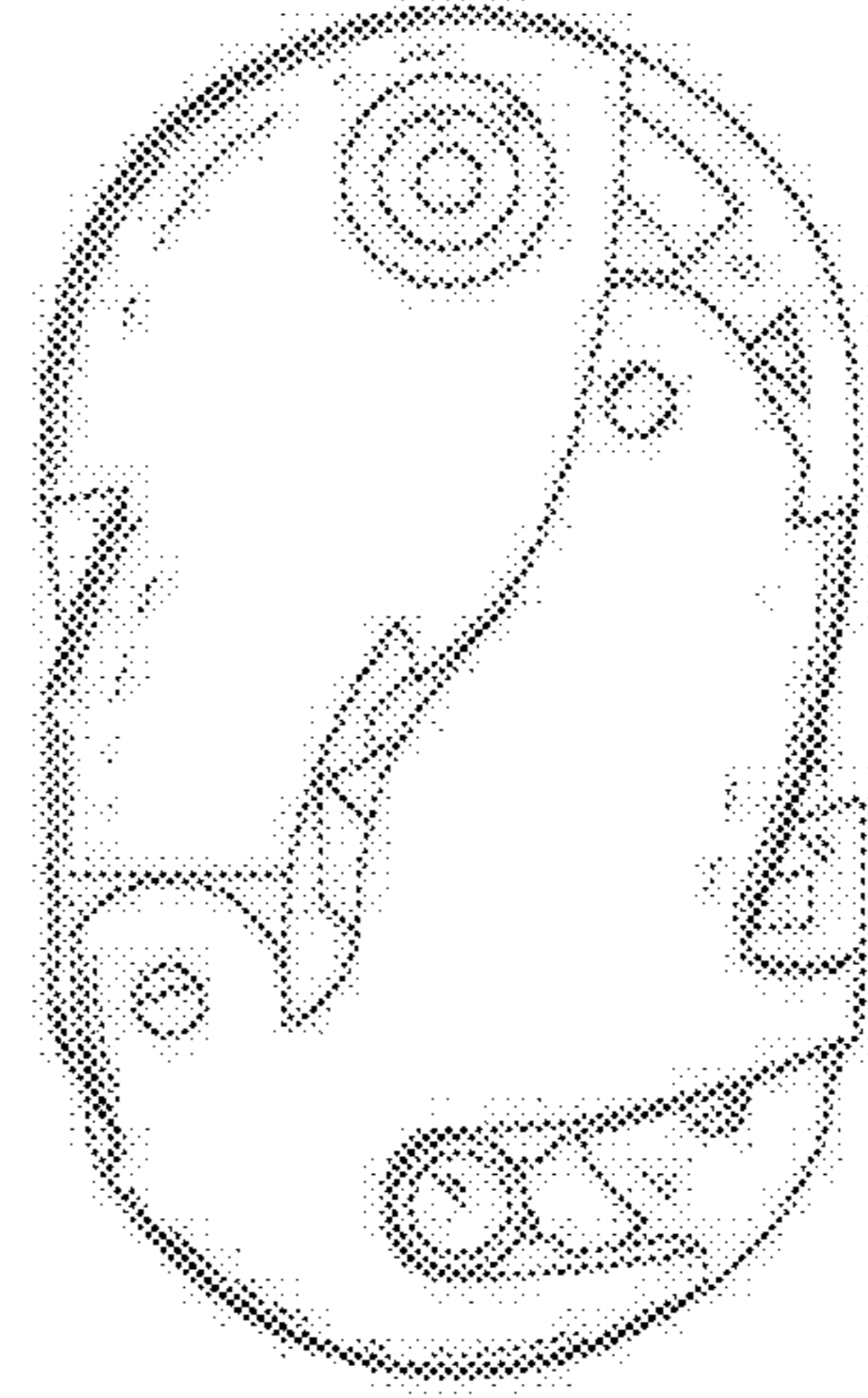

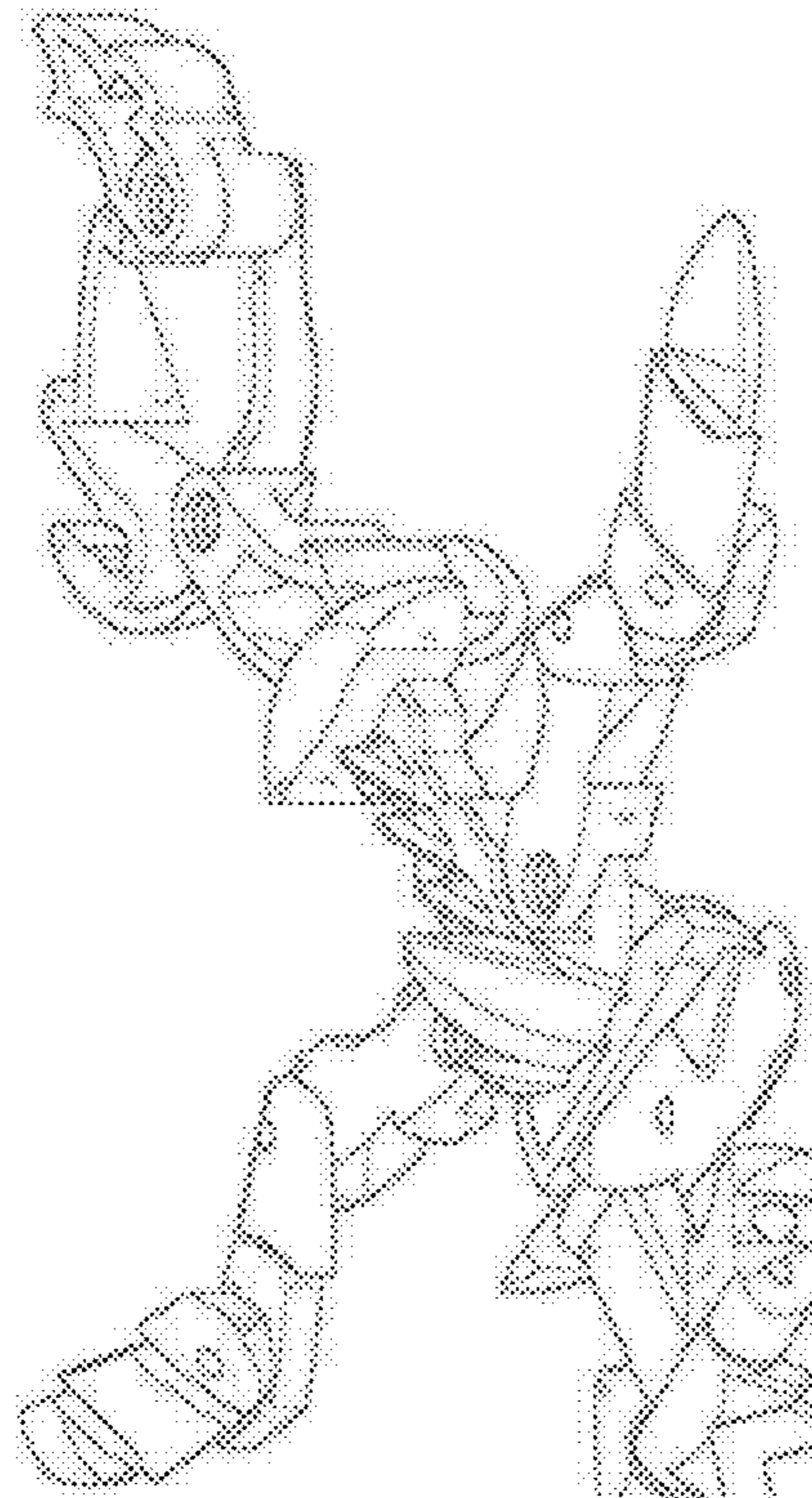

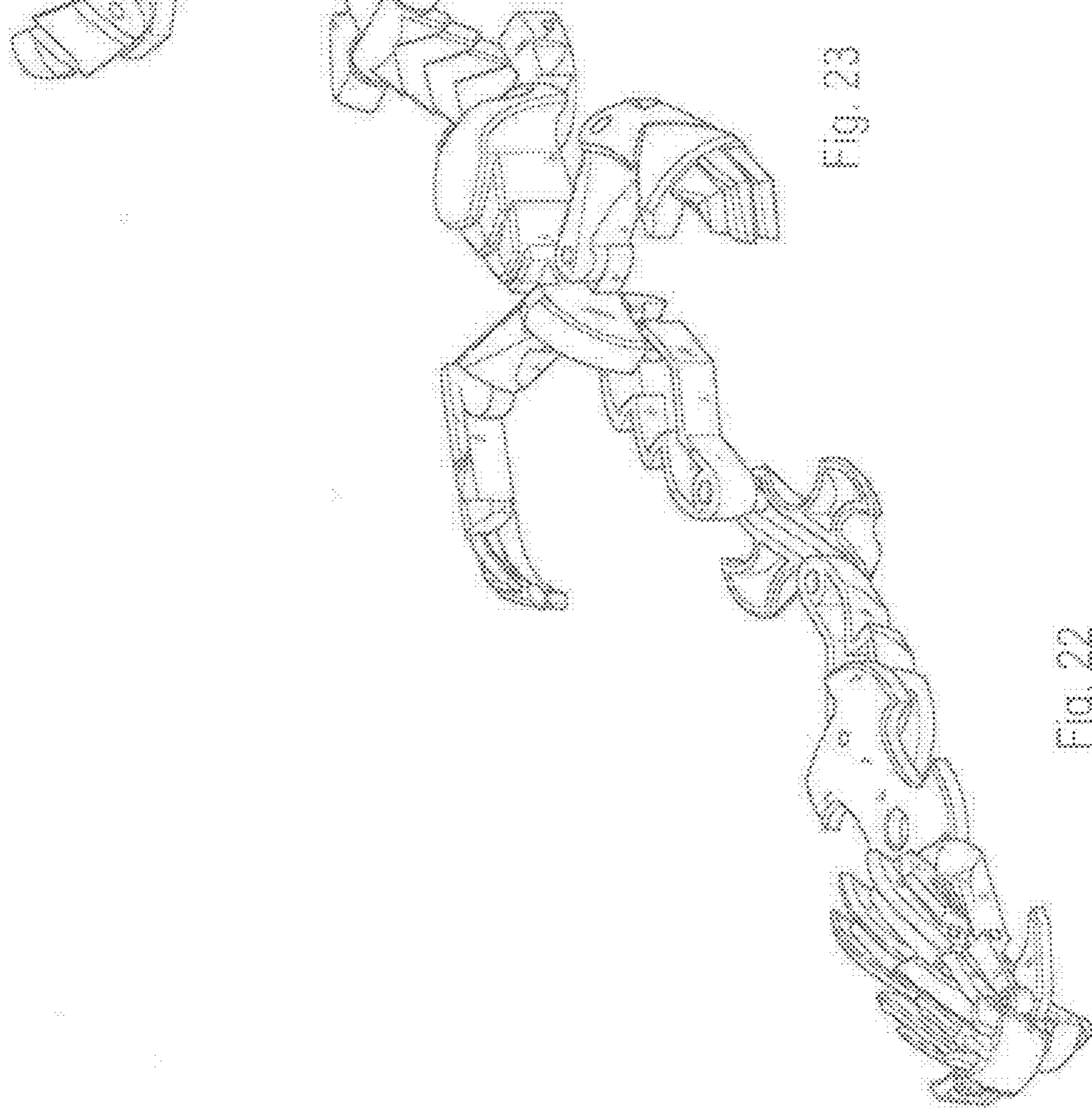

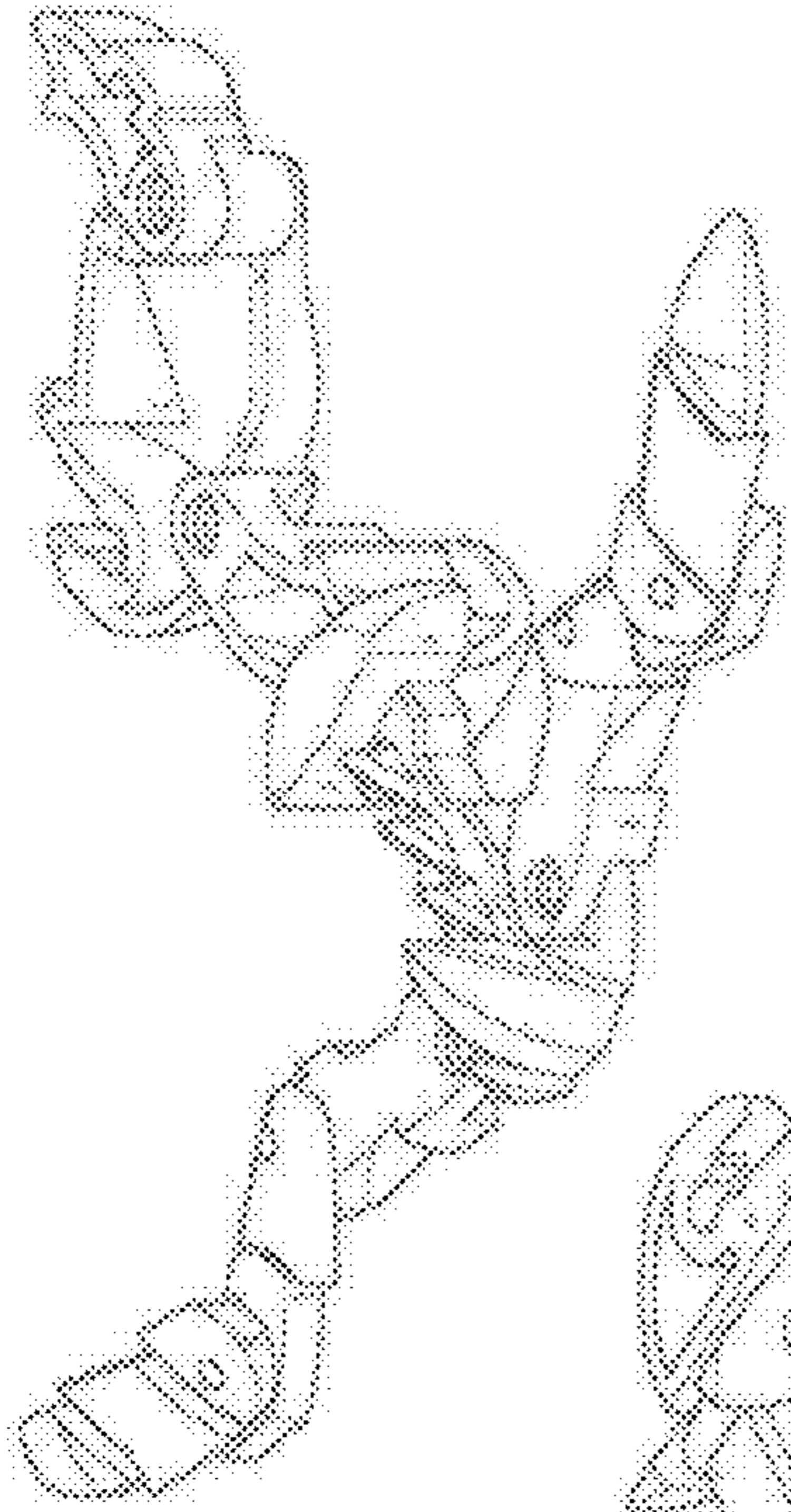

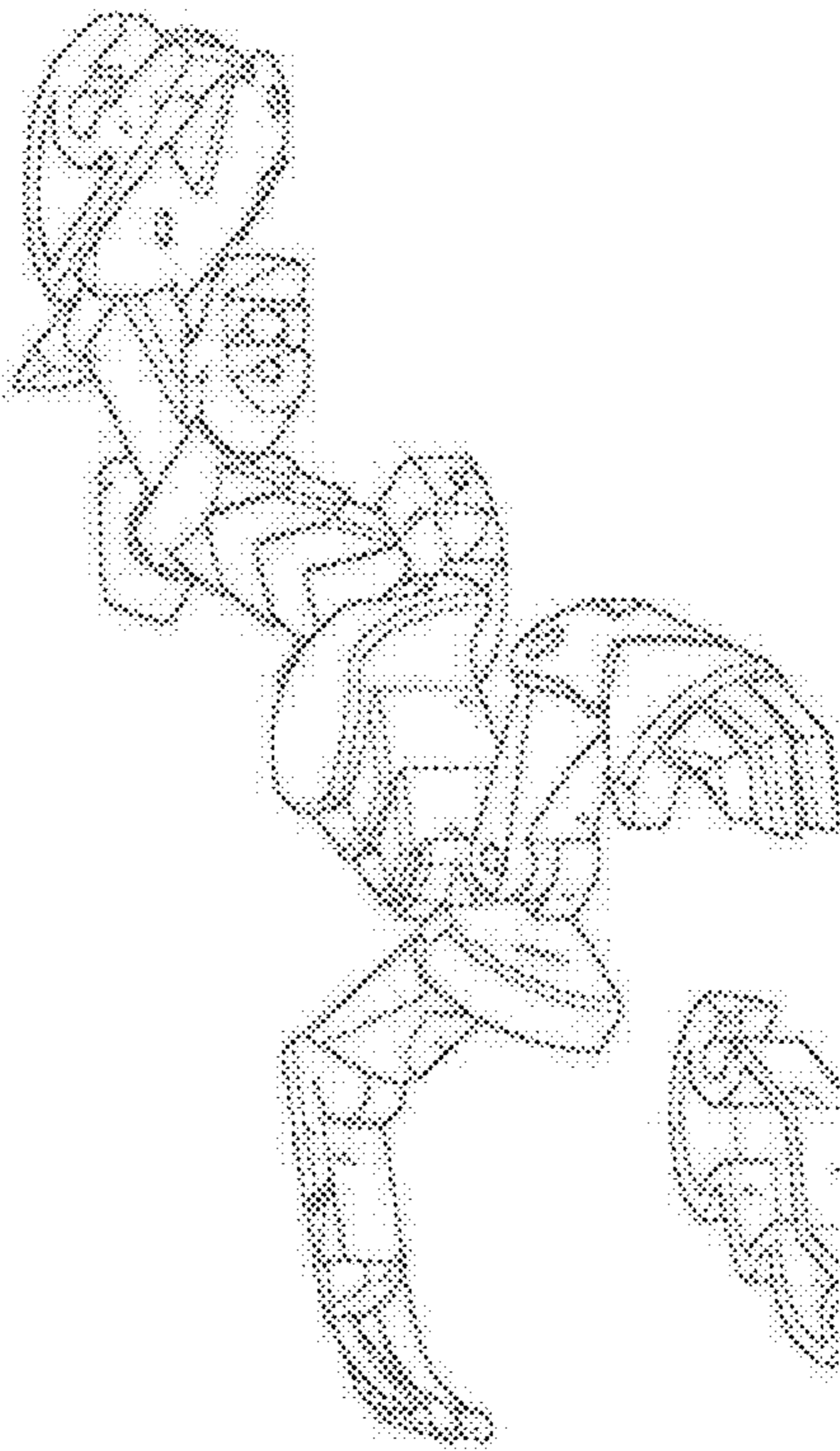

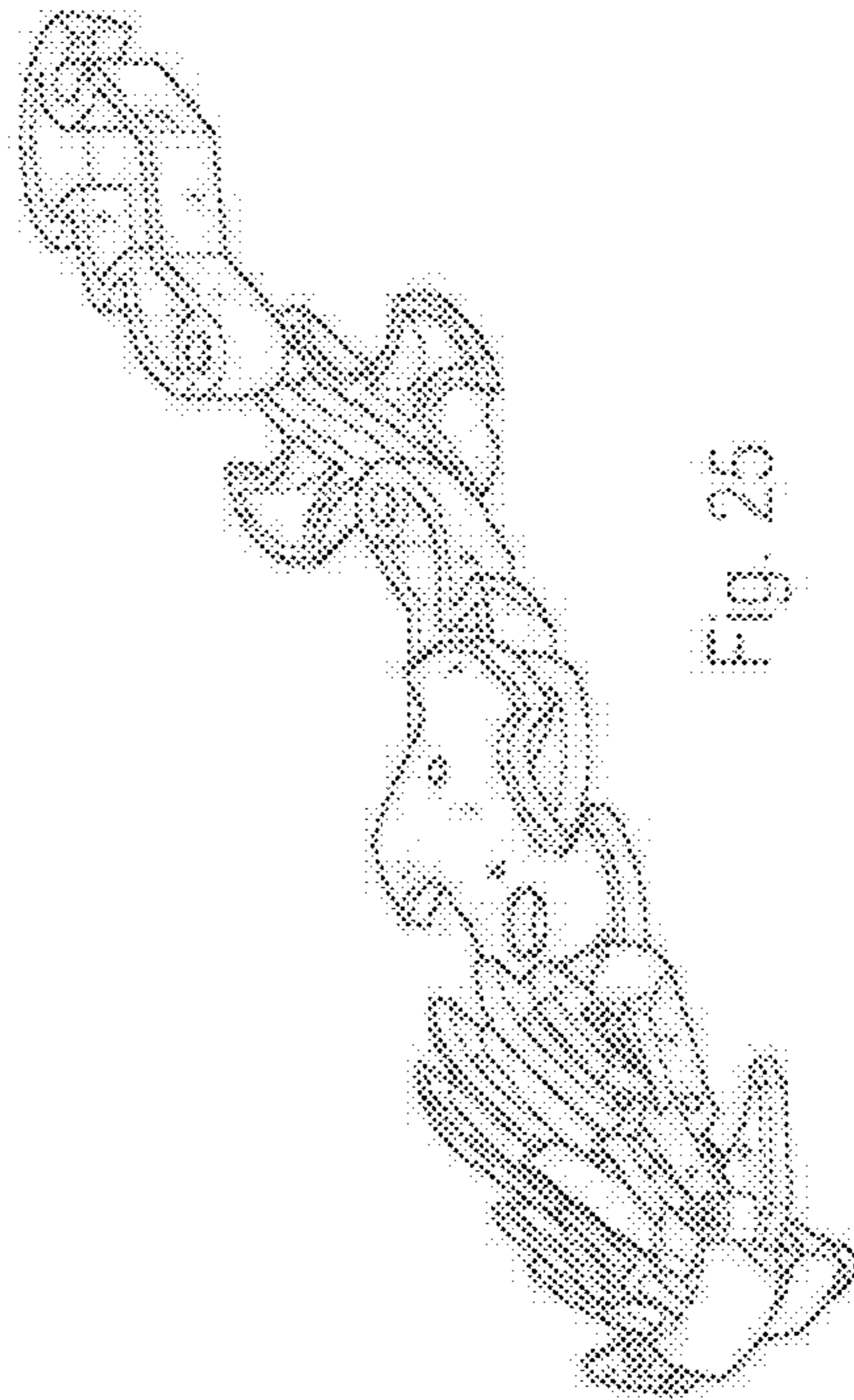

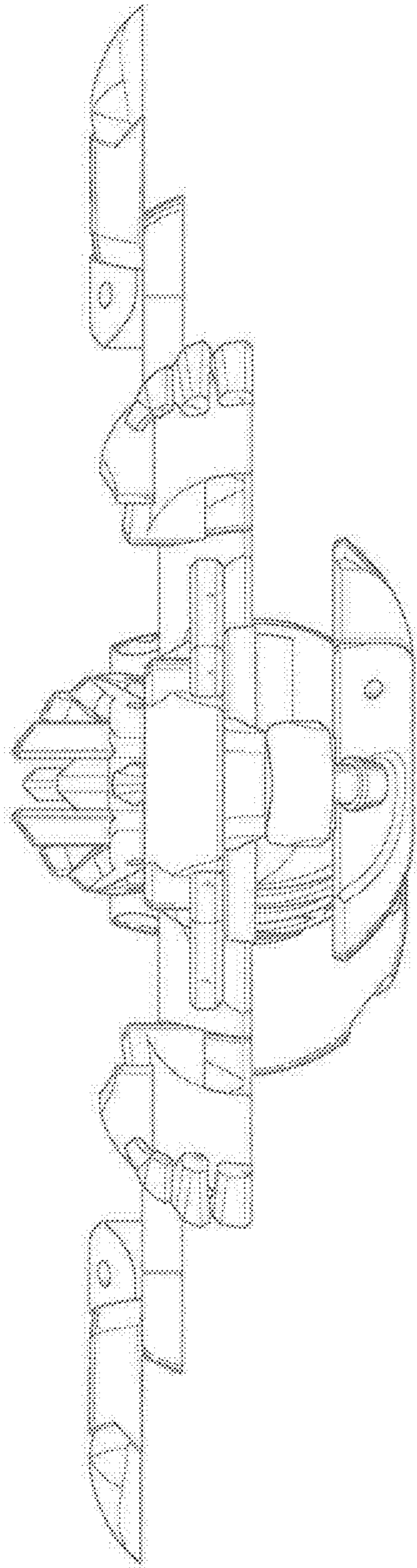

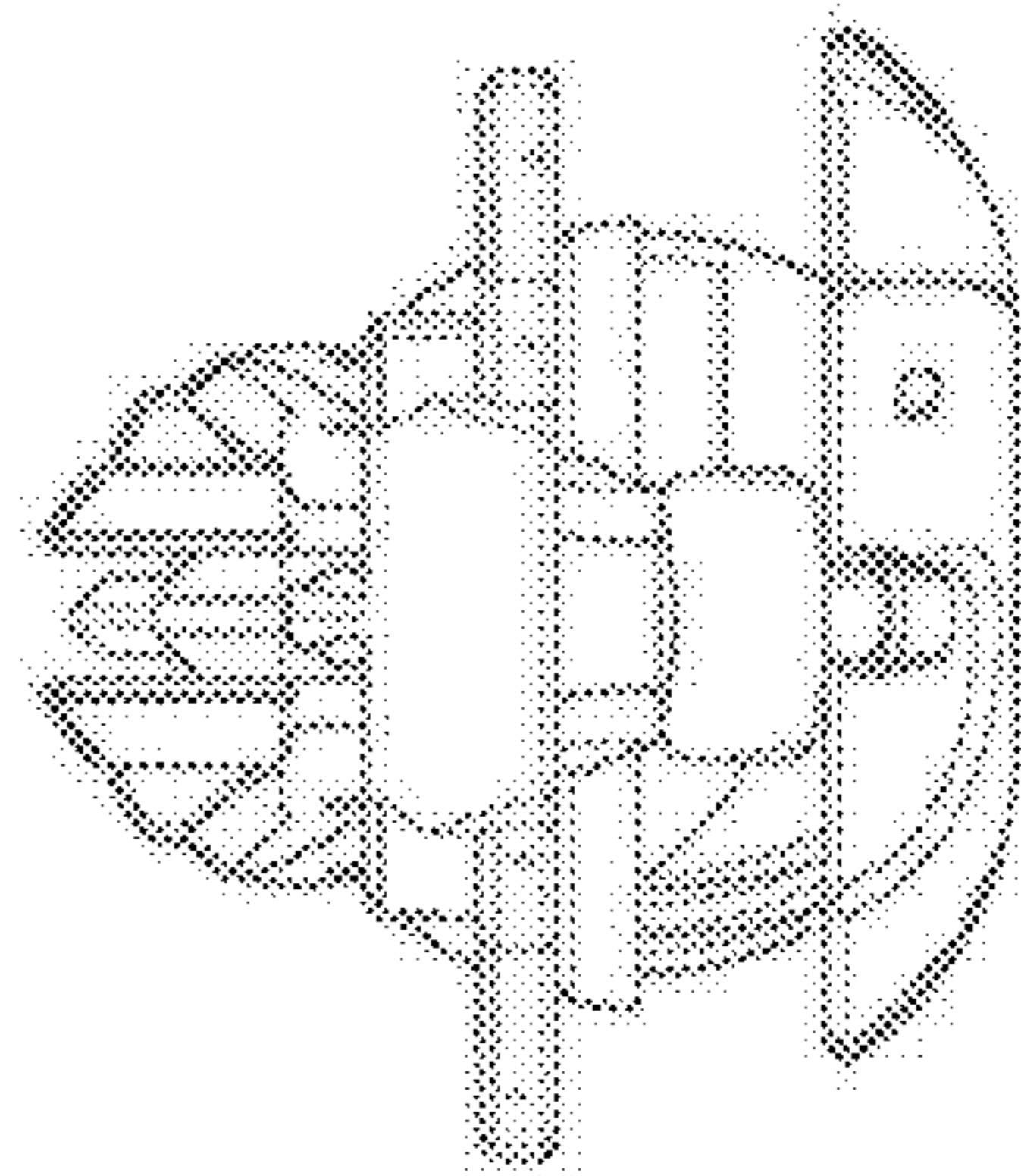

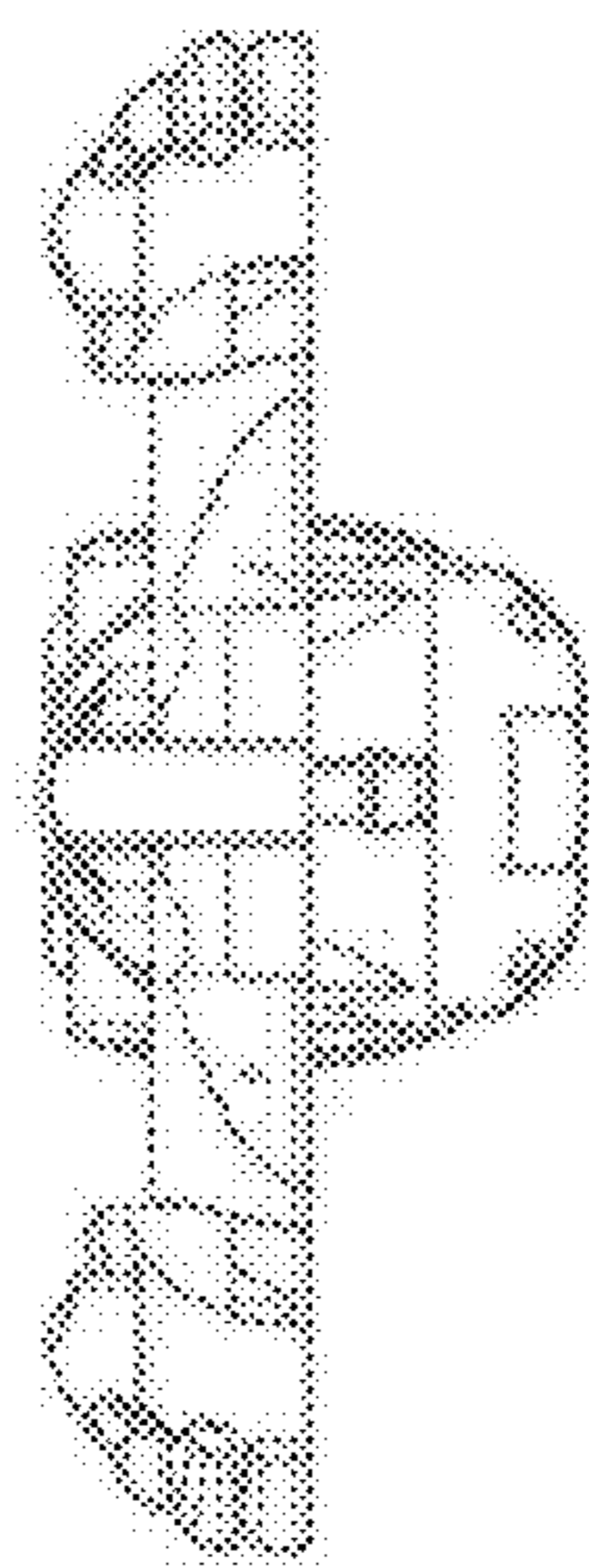

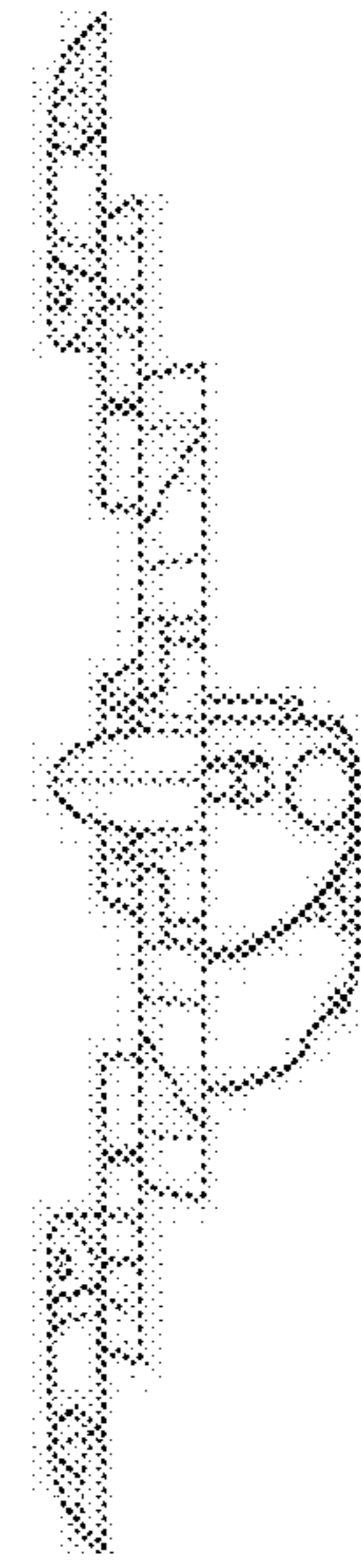

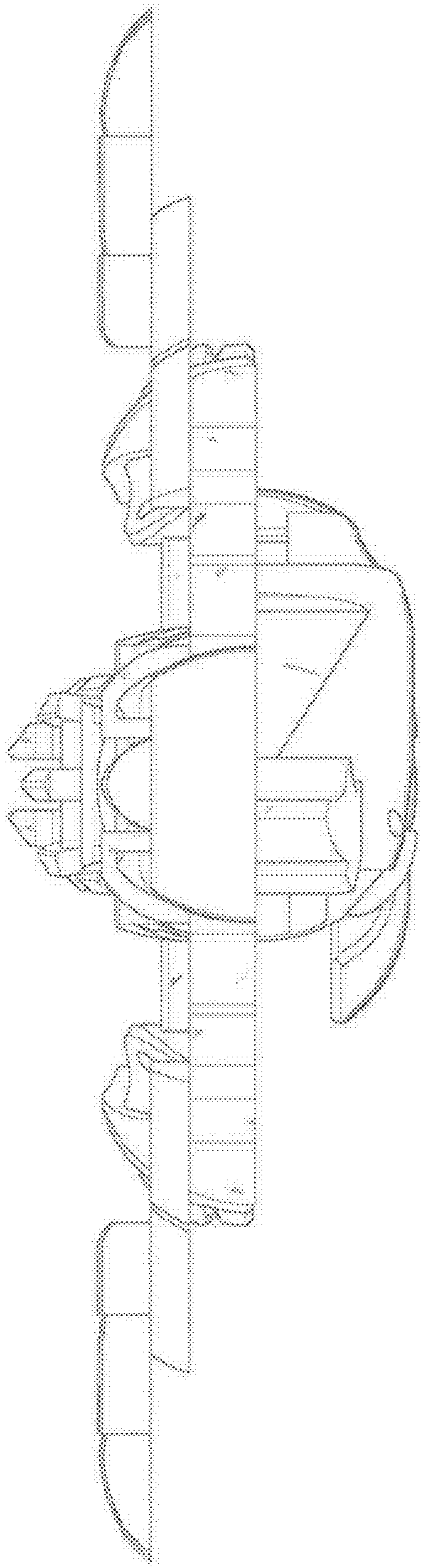

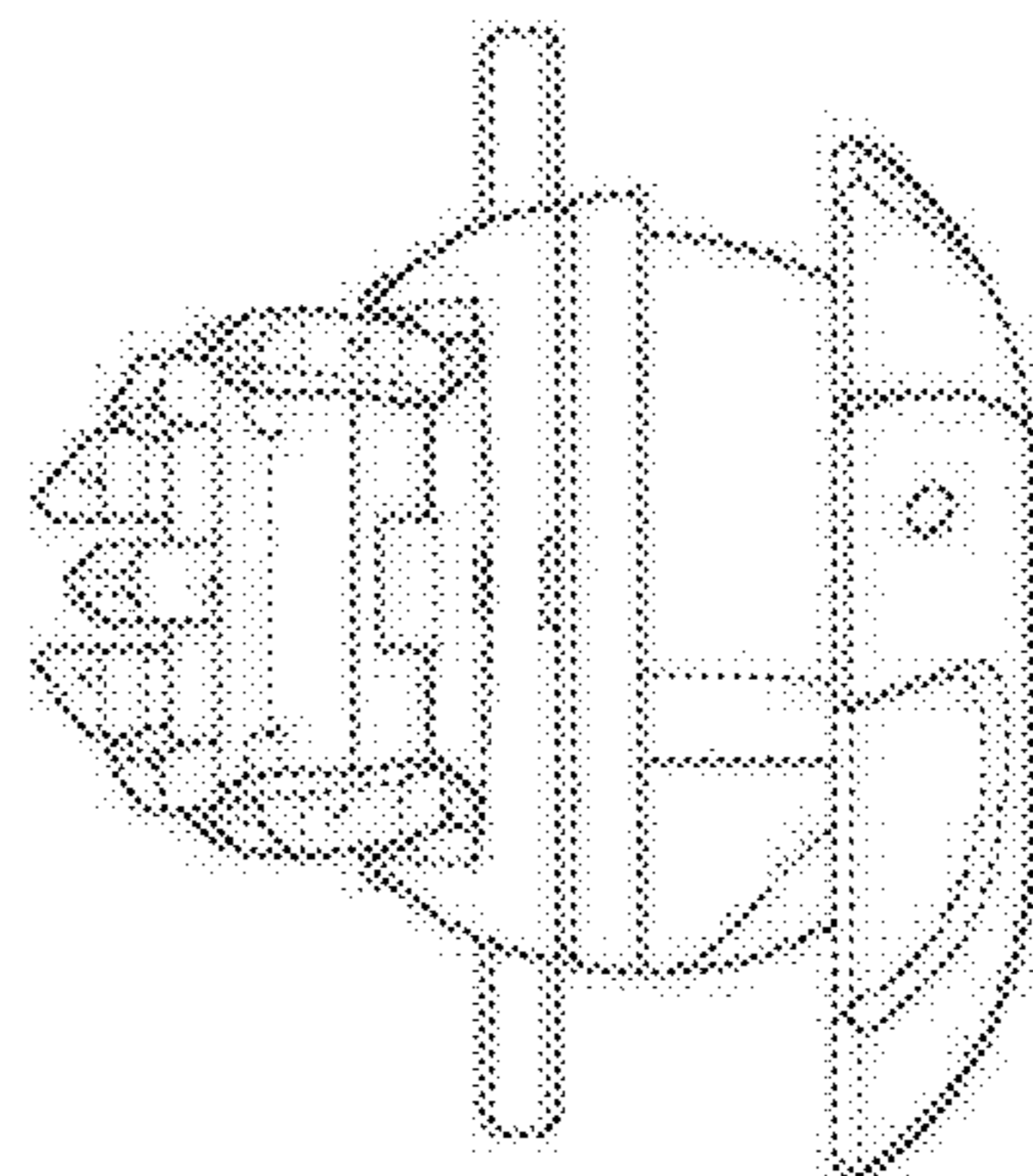

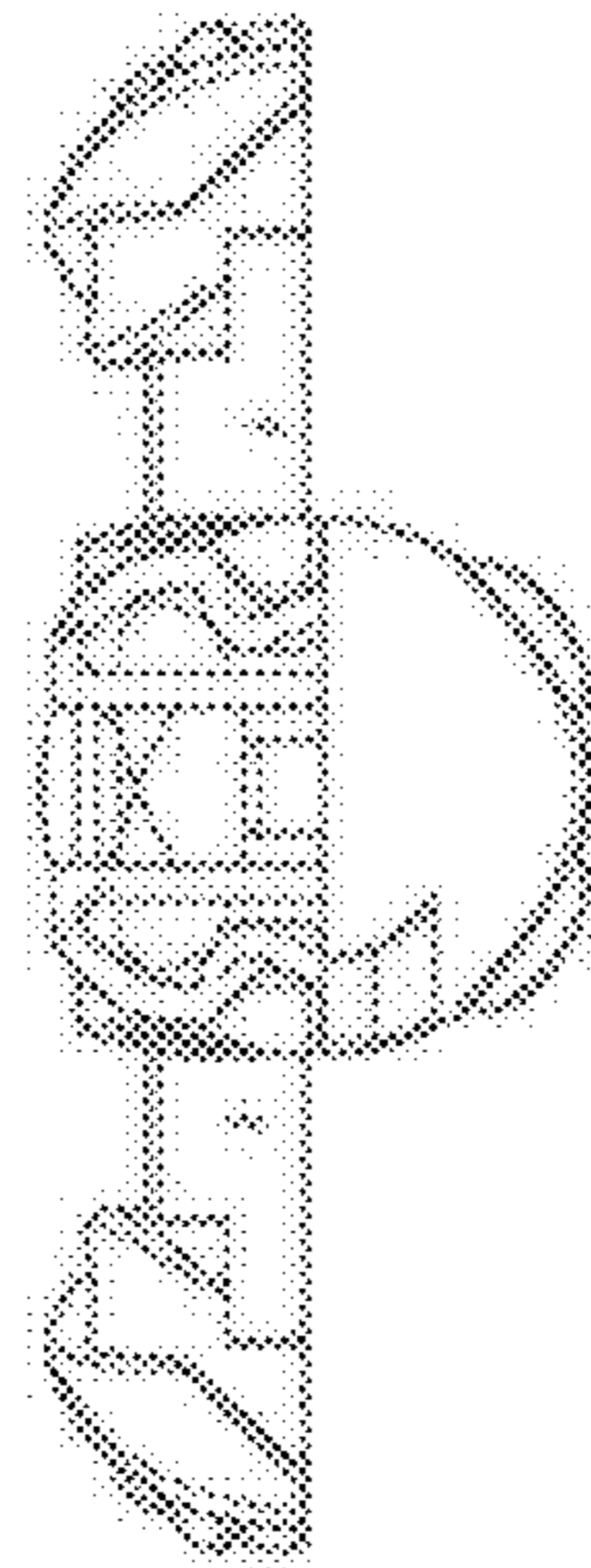

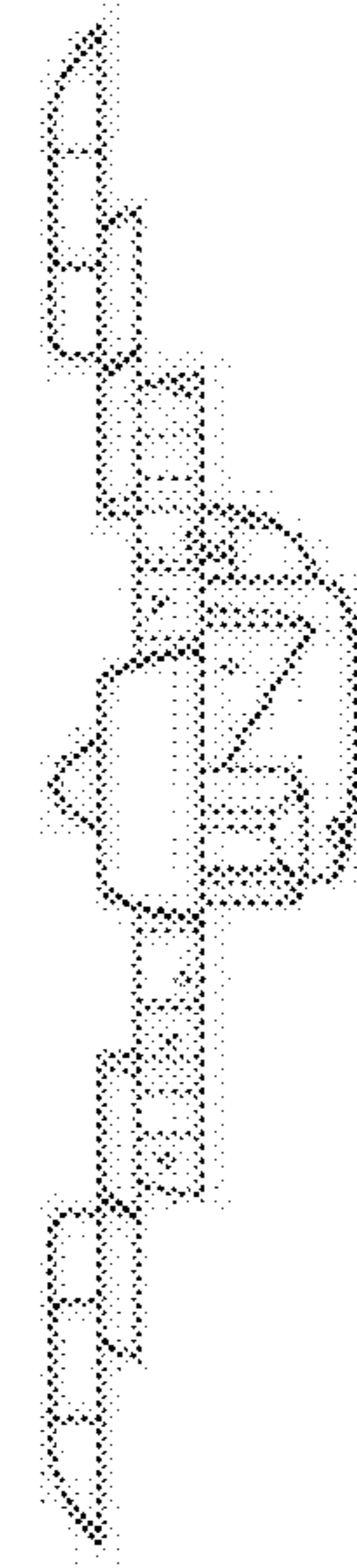

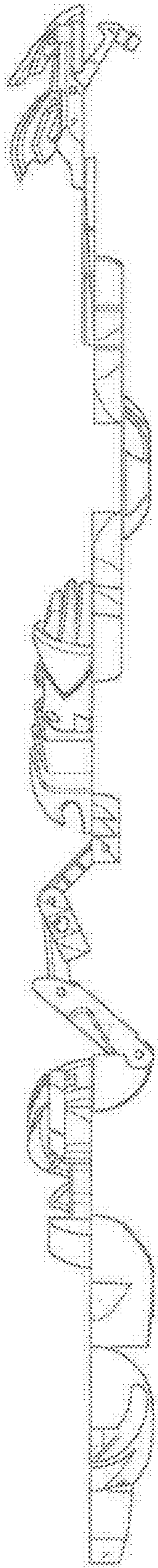

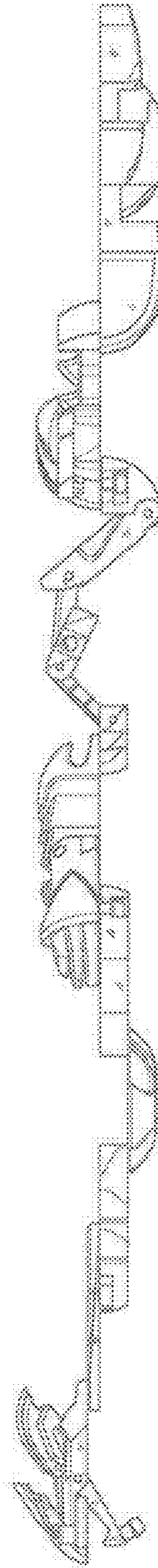

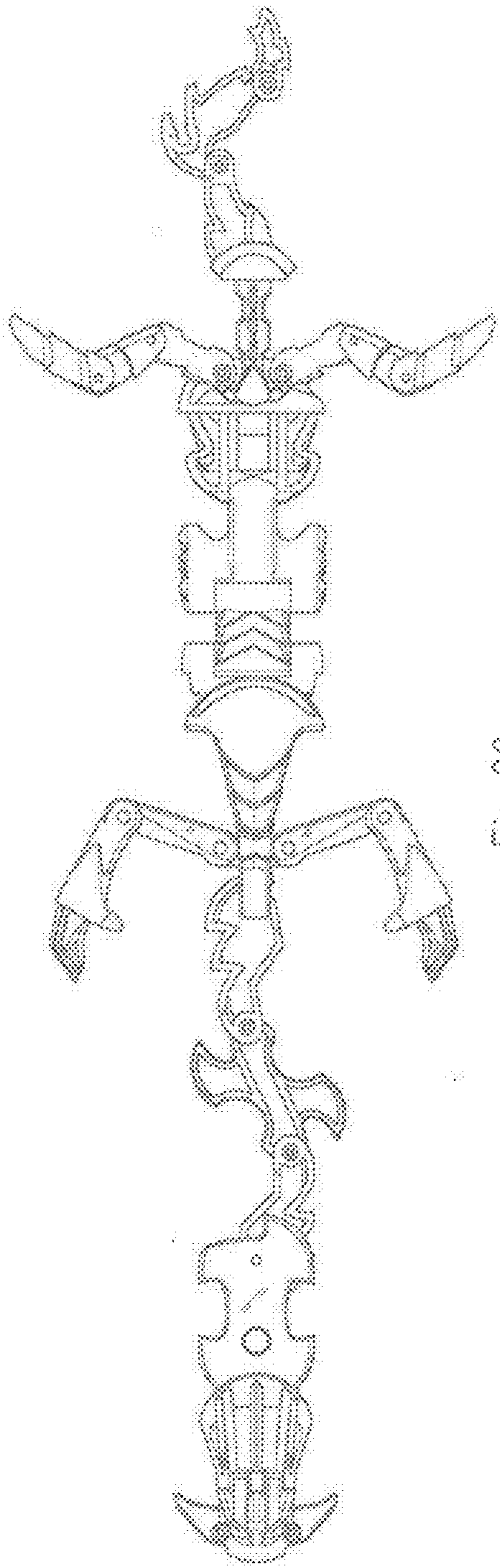

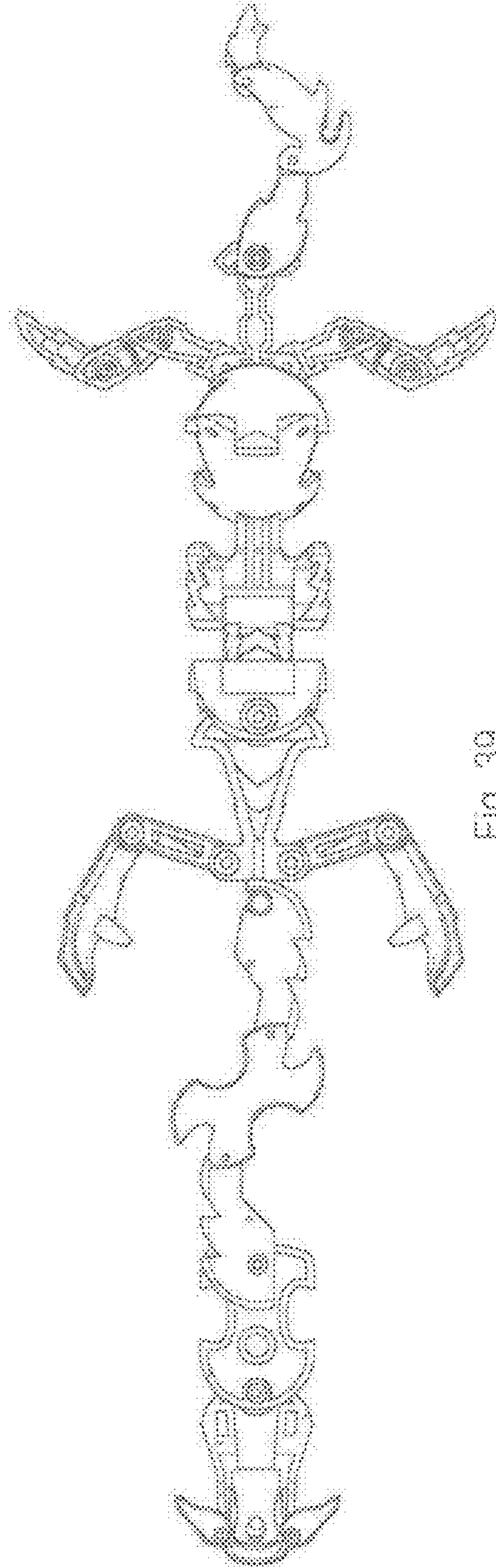
