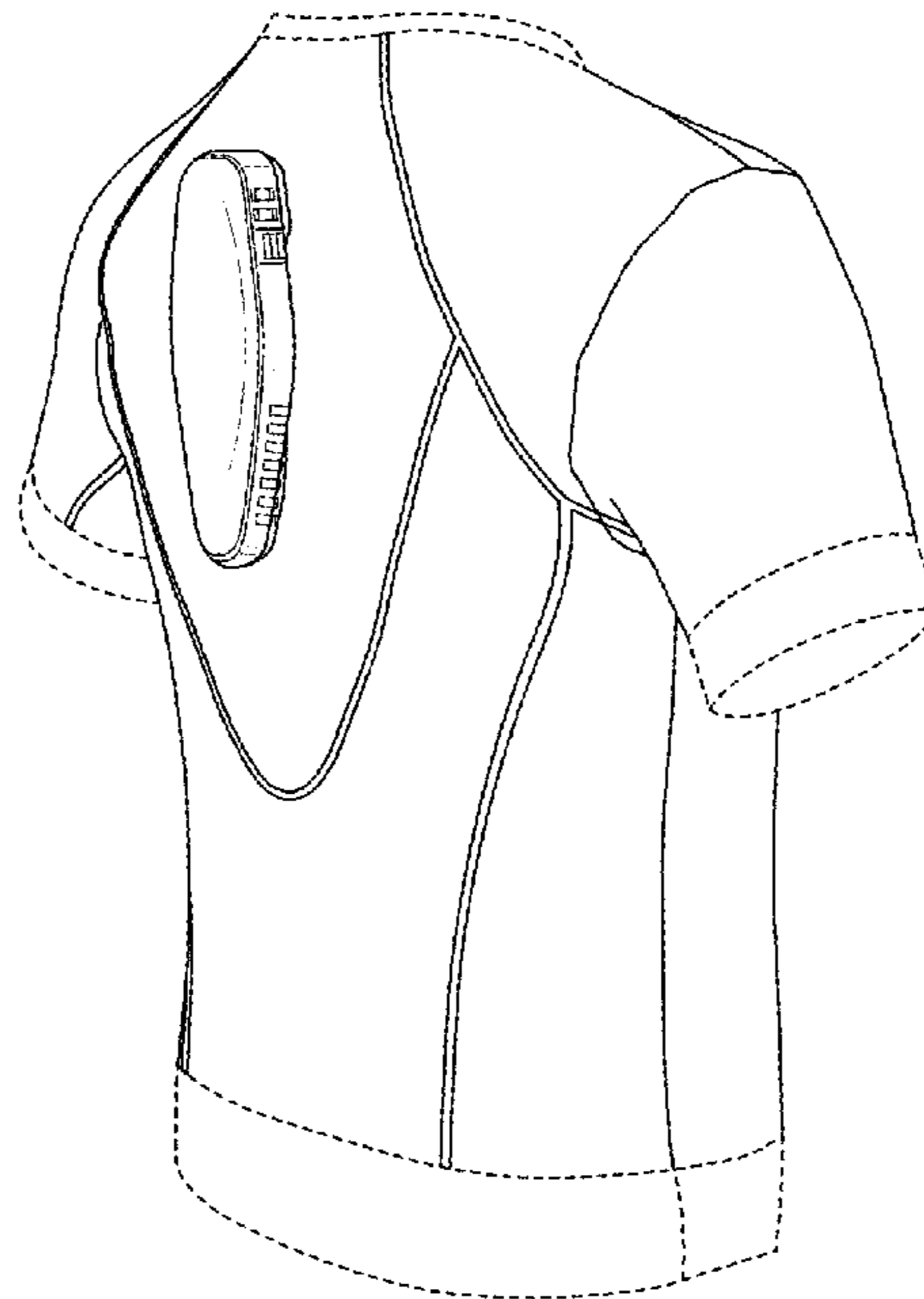
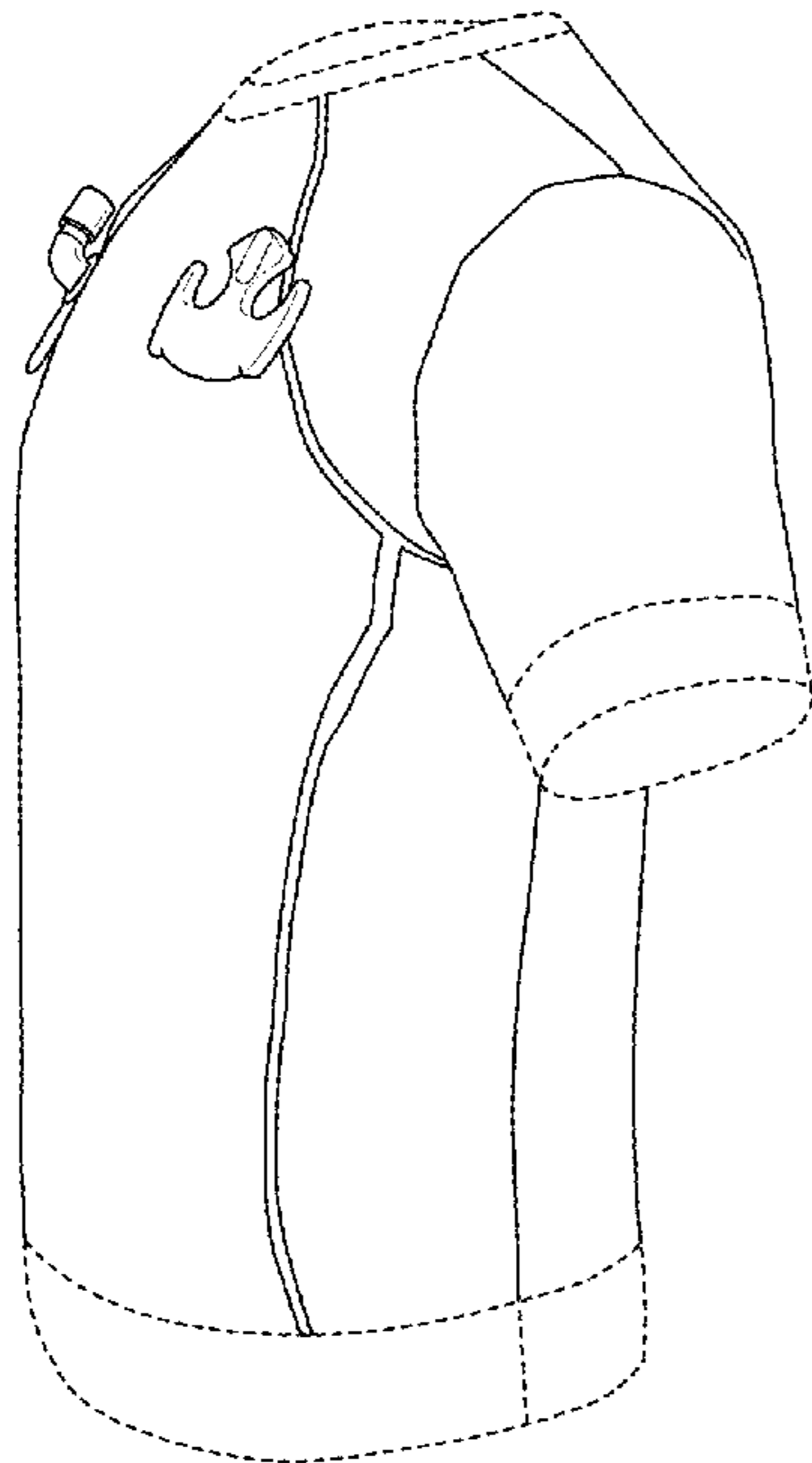
The ornamental design for a flotation shirt with inflation components, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a flotation shirt with inflation components showing my new design;
FIG. 2 is a side view as seen from the right of FIG. 1;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view as seen from the left of FIG. 1;
FIG. 5 is a front perspective view thereof;
FIG. 6 is a rear perspective view thereof; and,
FIG. 7 is a top plan view thereof.

The broken lines, shown throughout the views, represent the portions of the shirt, which form no part of the claimed design.

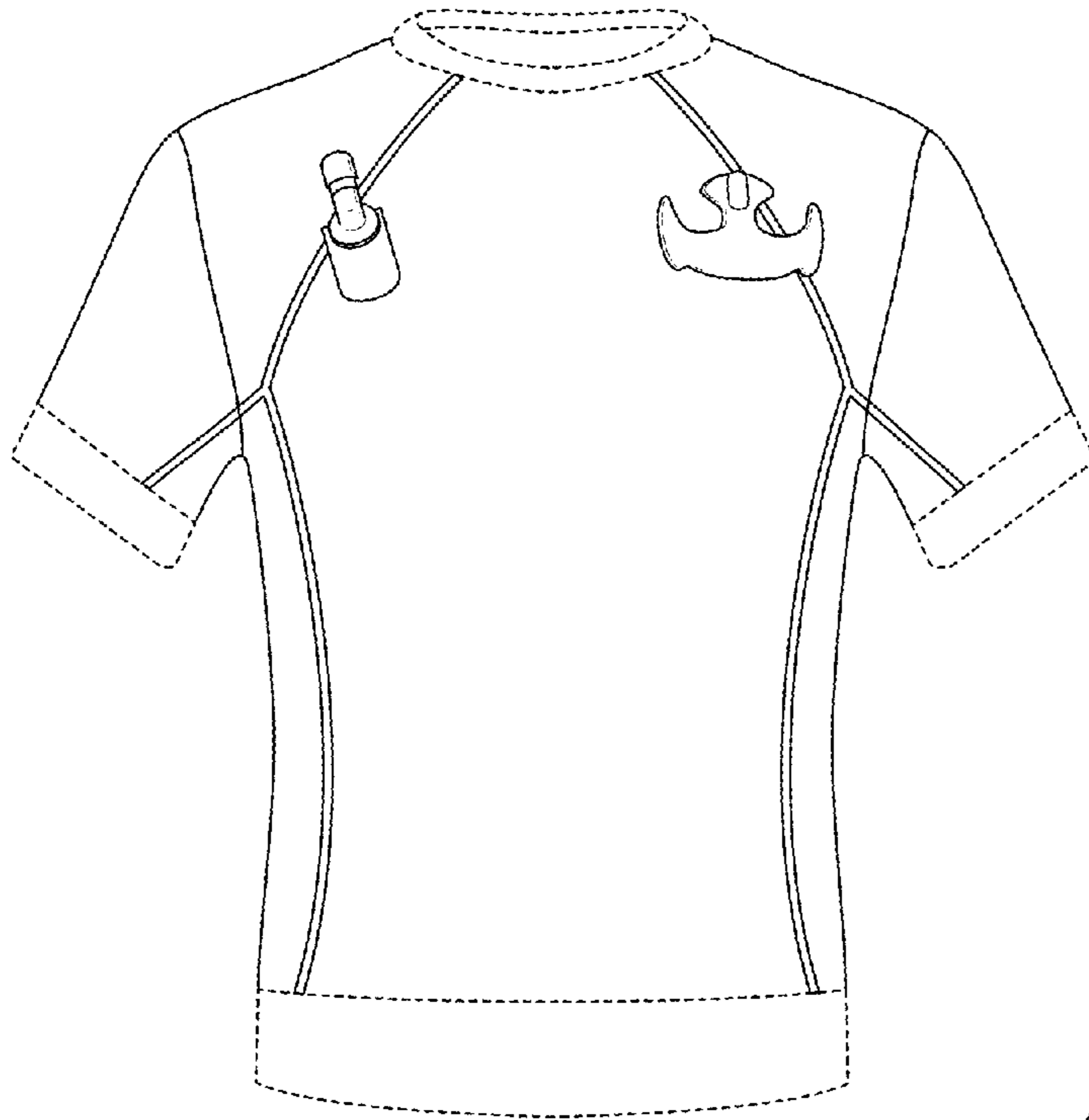

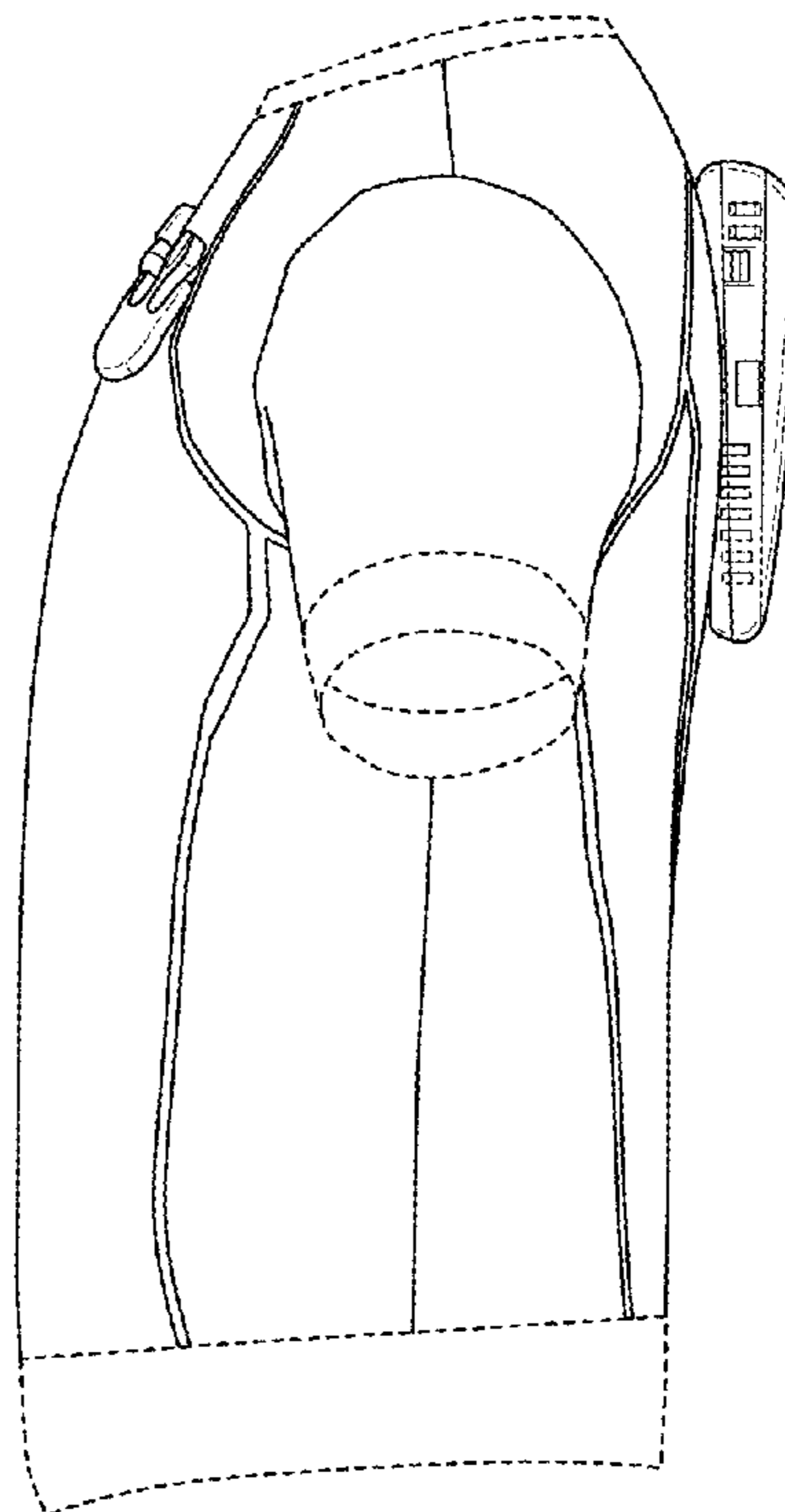

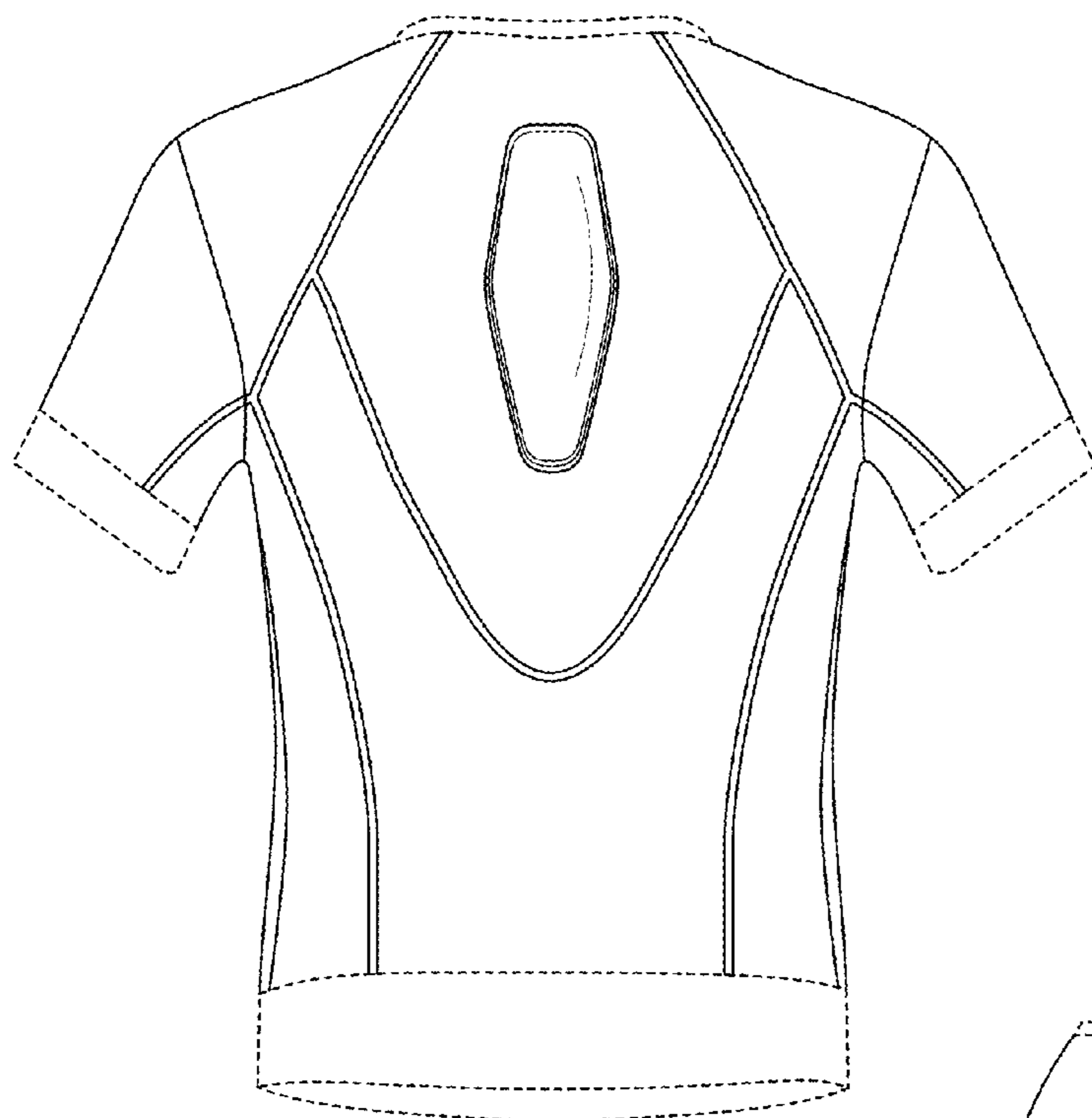

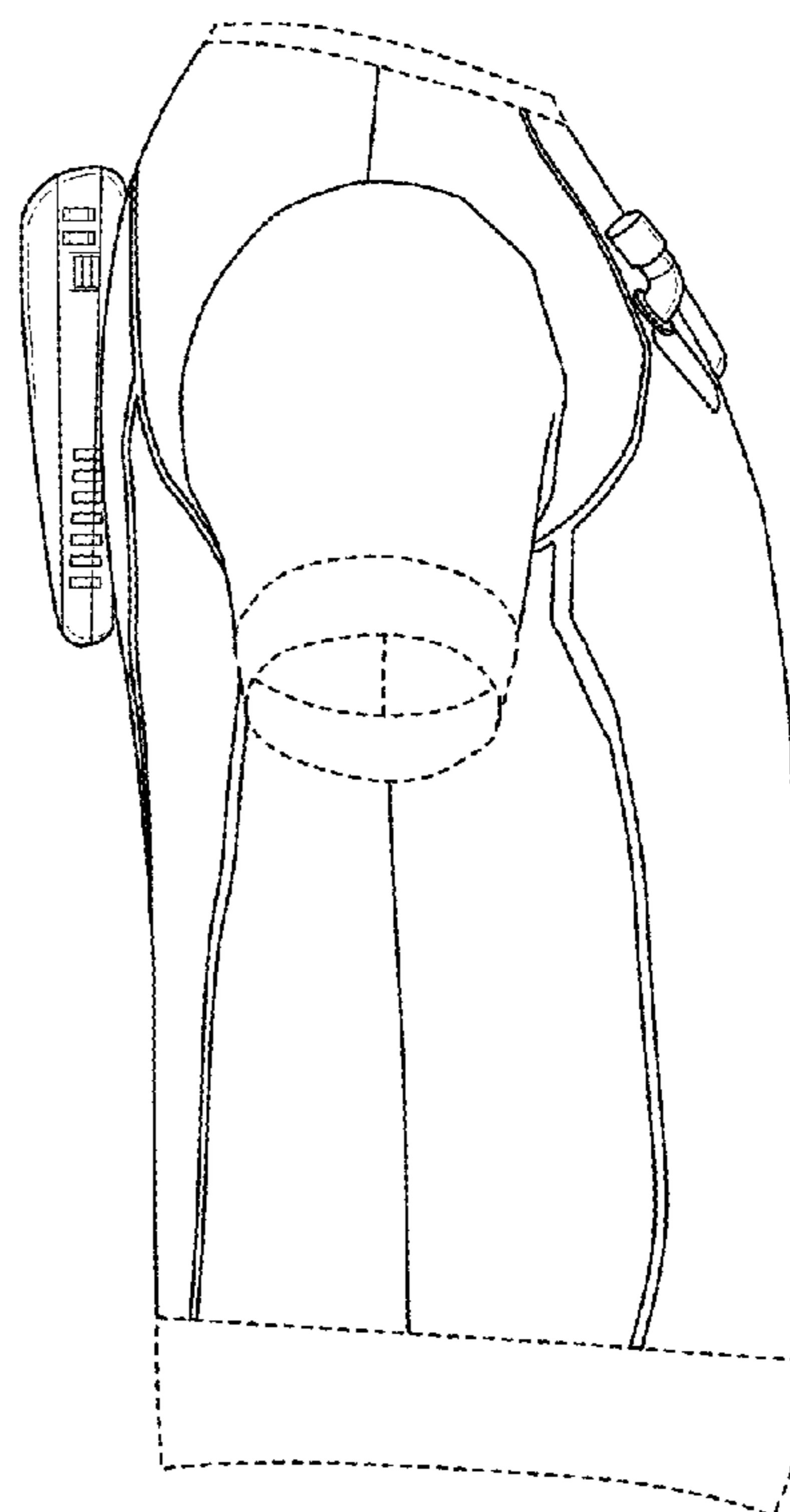

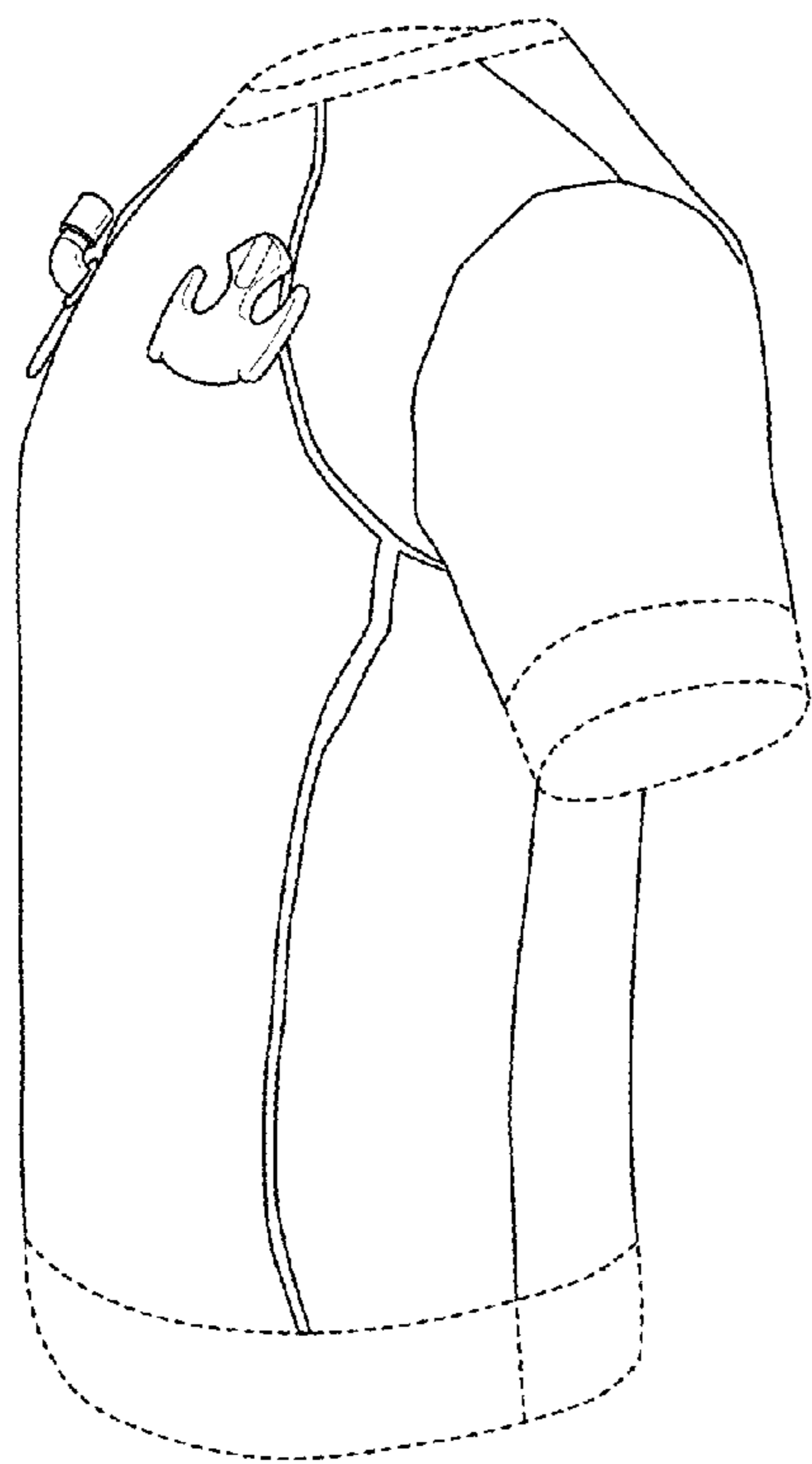

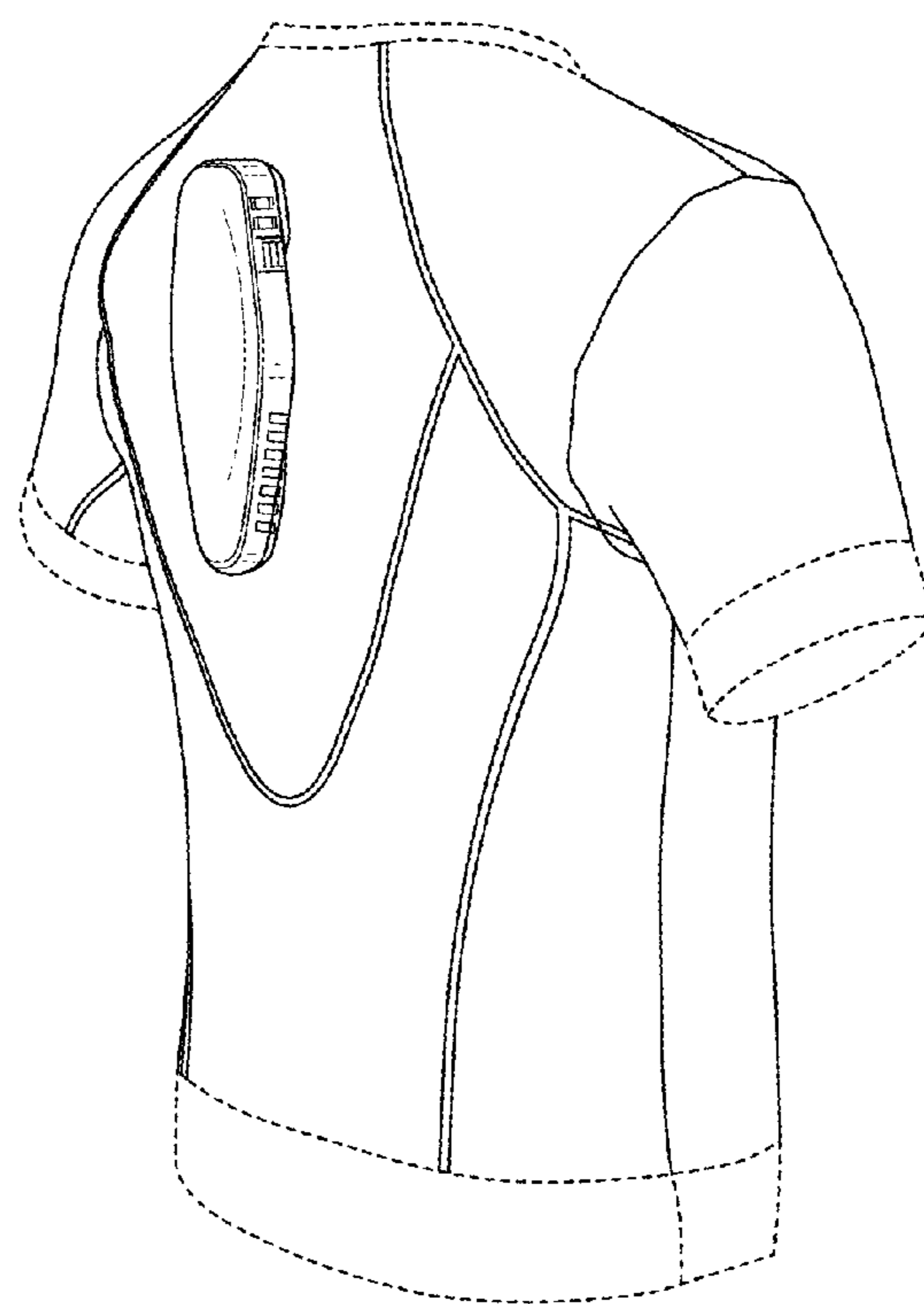

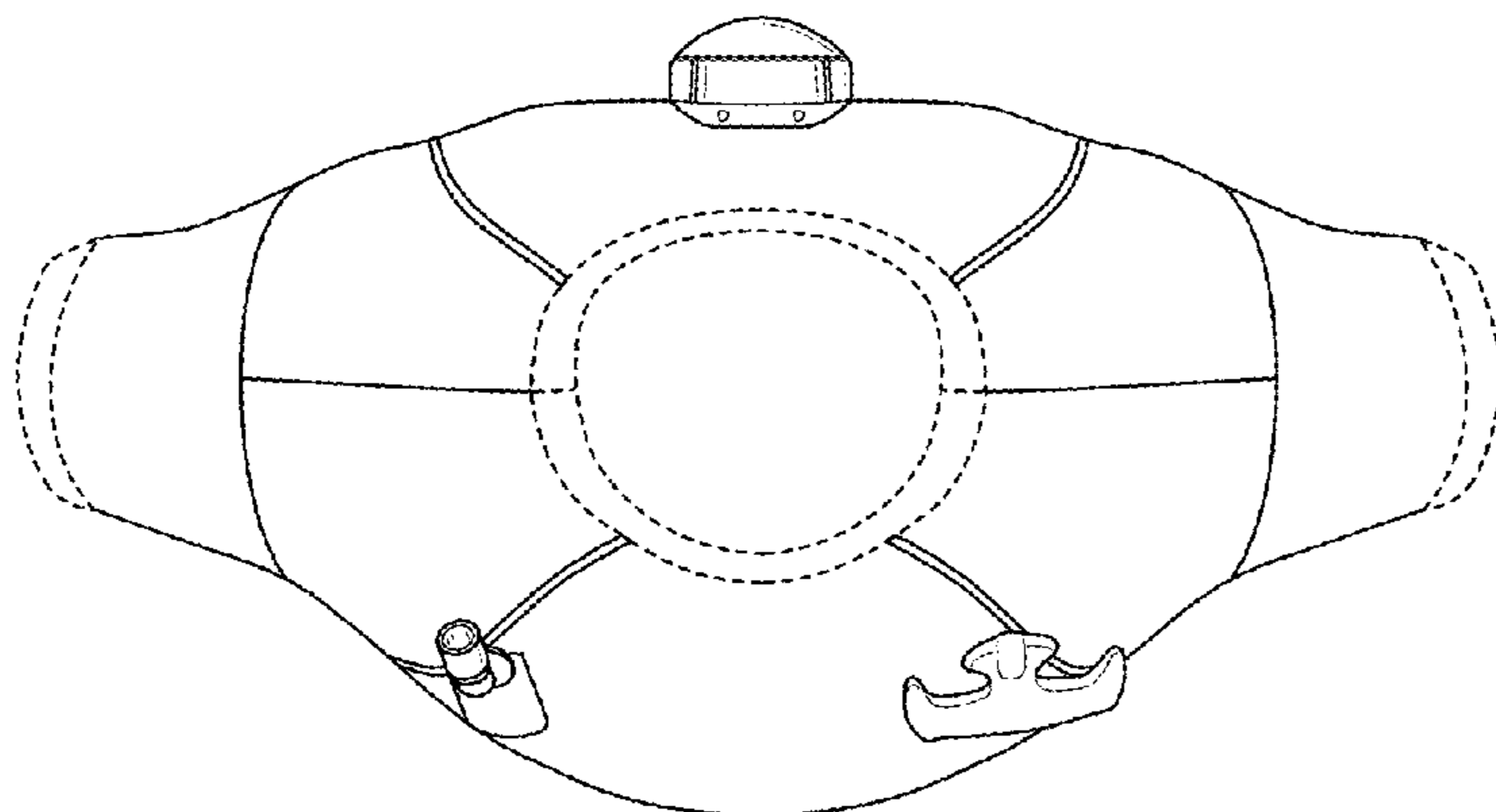
