(57) **CLAIM**

The ornamental design for a lens cover for a vehicle lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first, unilluminated embodiment of the ornamental lens cover for a vehicle lamp; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; and FIG. 5 is a top elevational view thereof, the bottom view being the same.

FIG. 6 is a front perspective view of a second, illuminated embodiment of the ornamental lens cover for a vehicle lamp; FIG. 7 is a right side elevational view of the second embodiment;

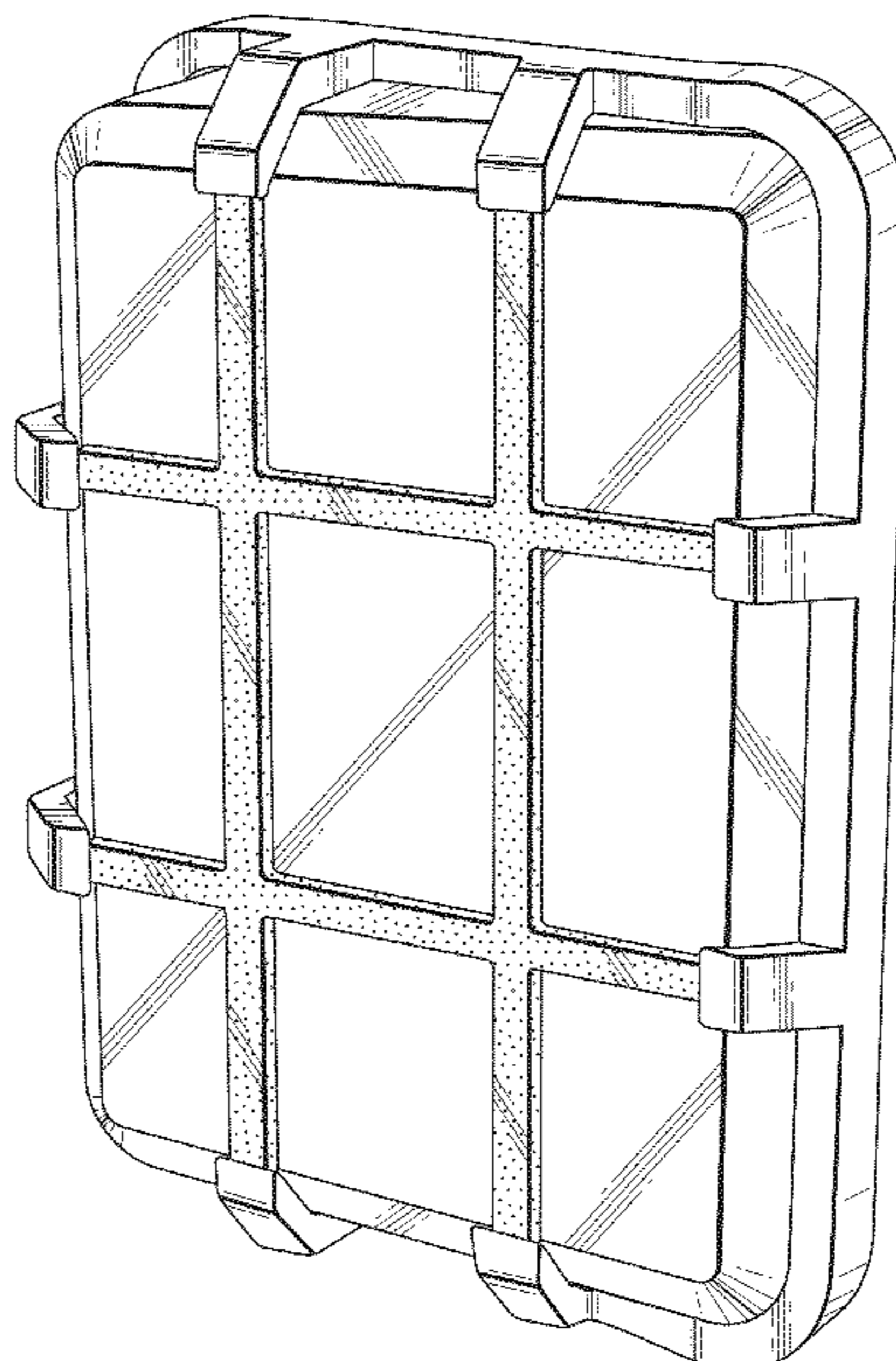
FIG. 8 is a left side elevational view of the second embodiment;

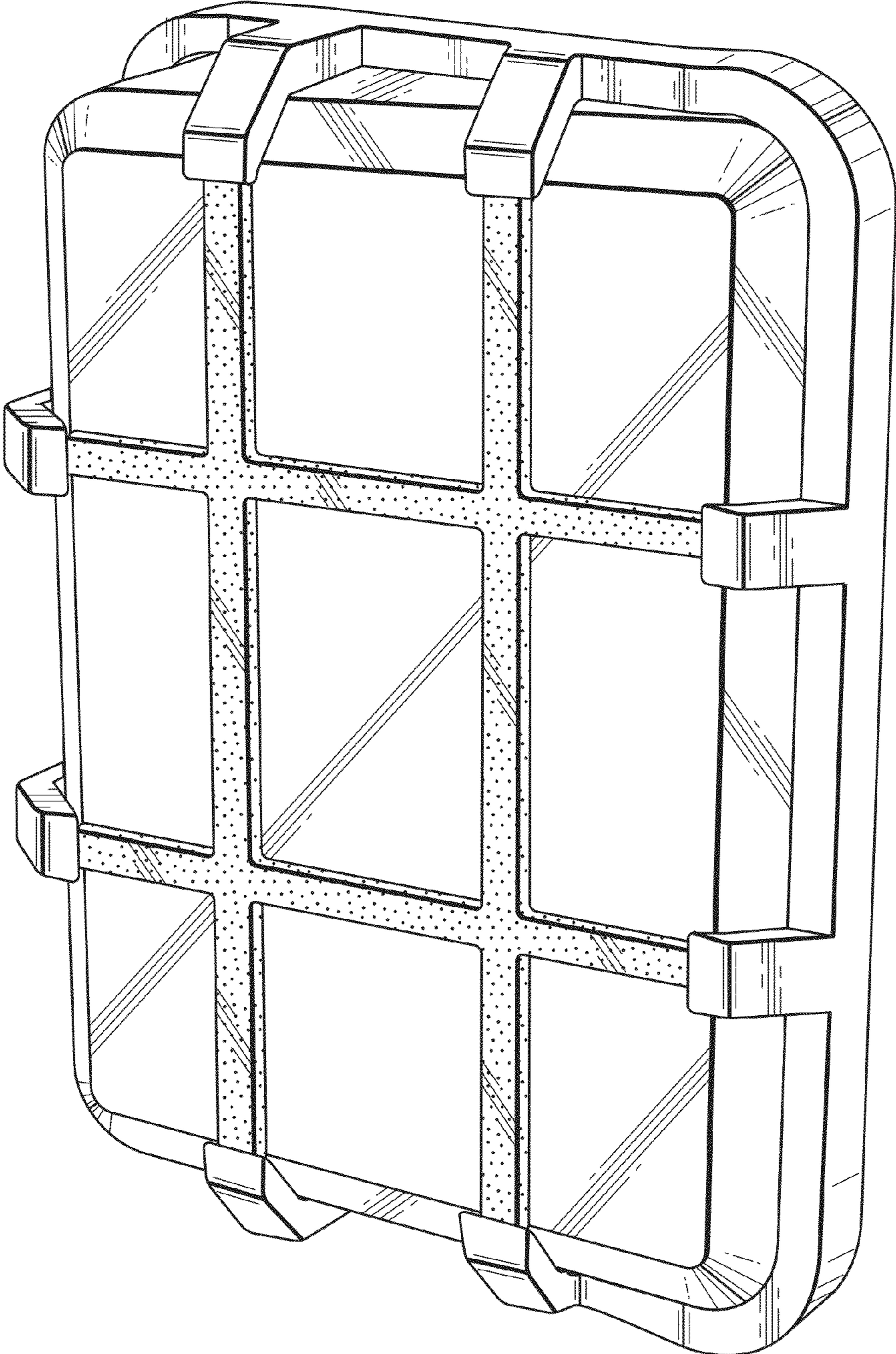

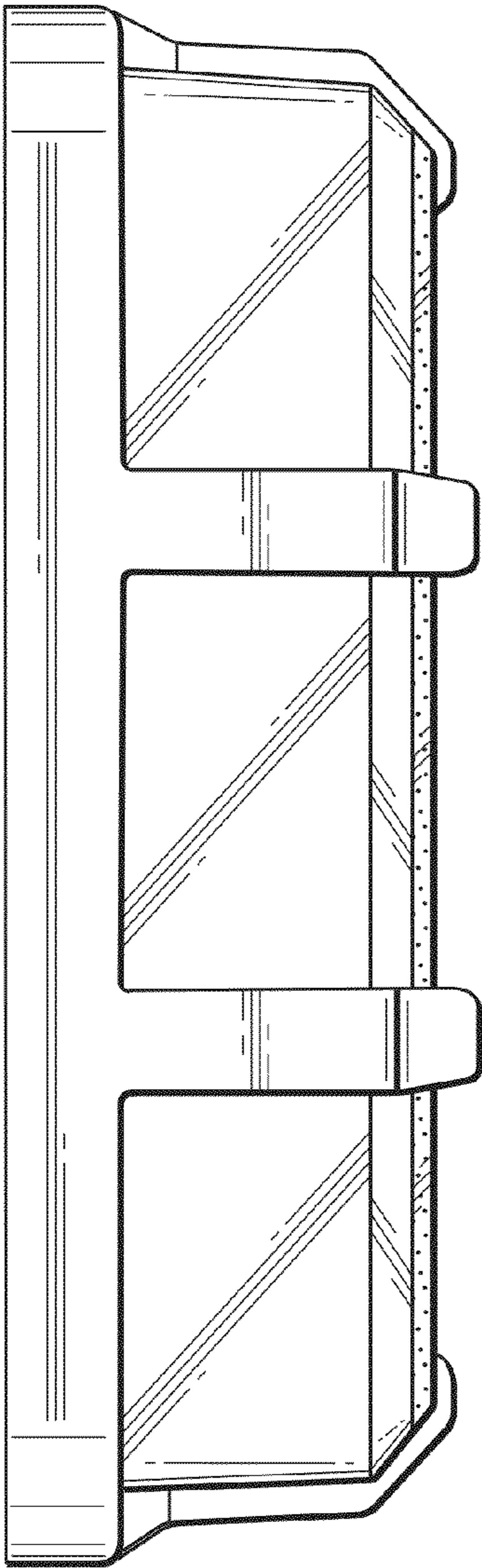

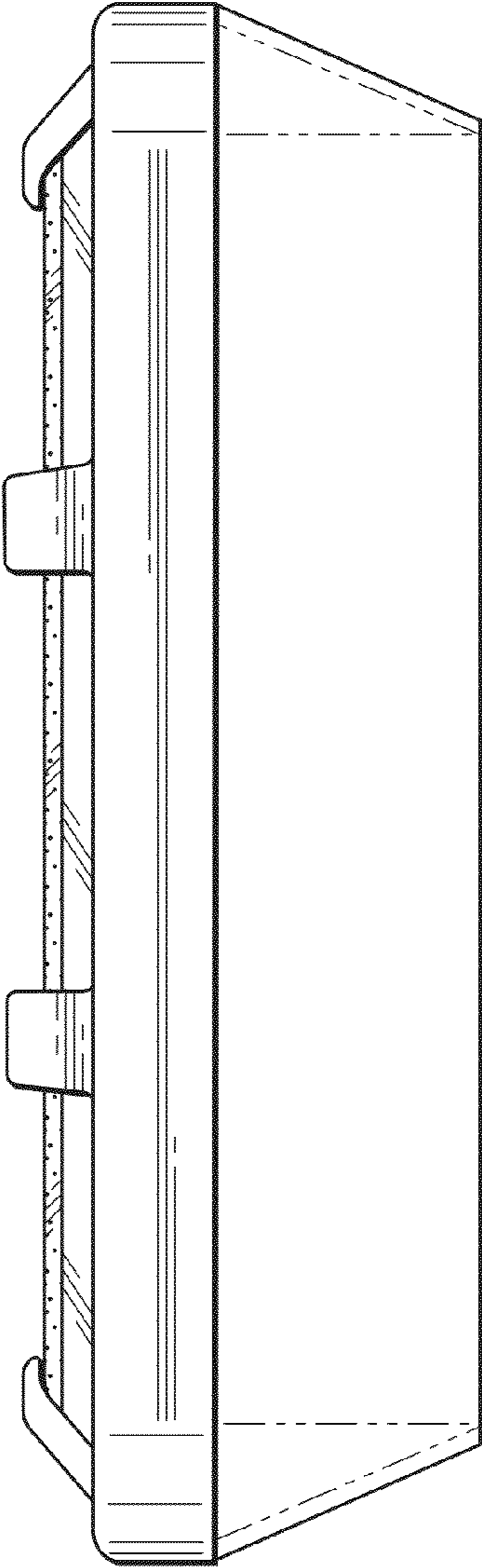

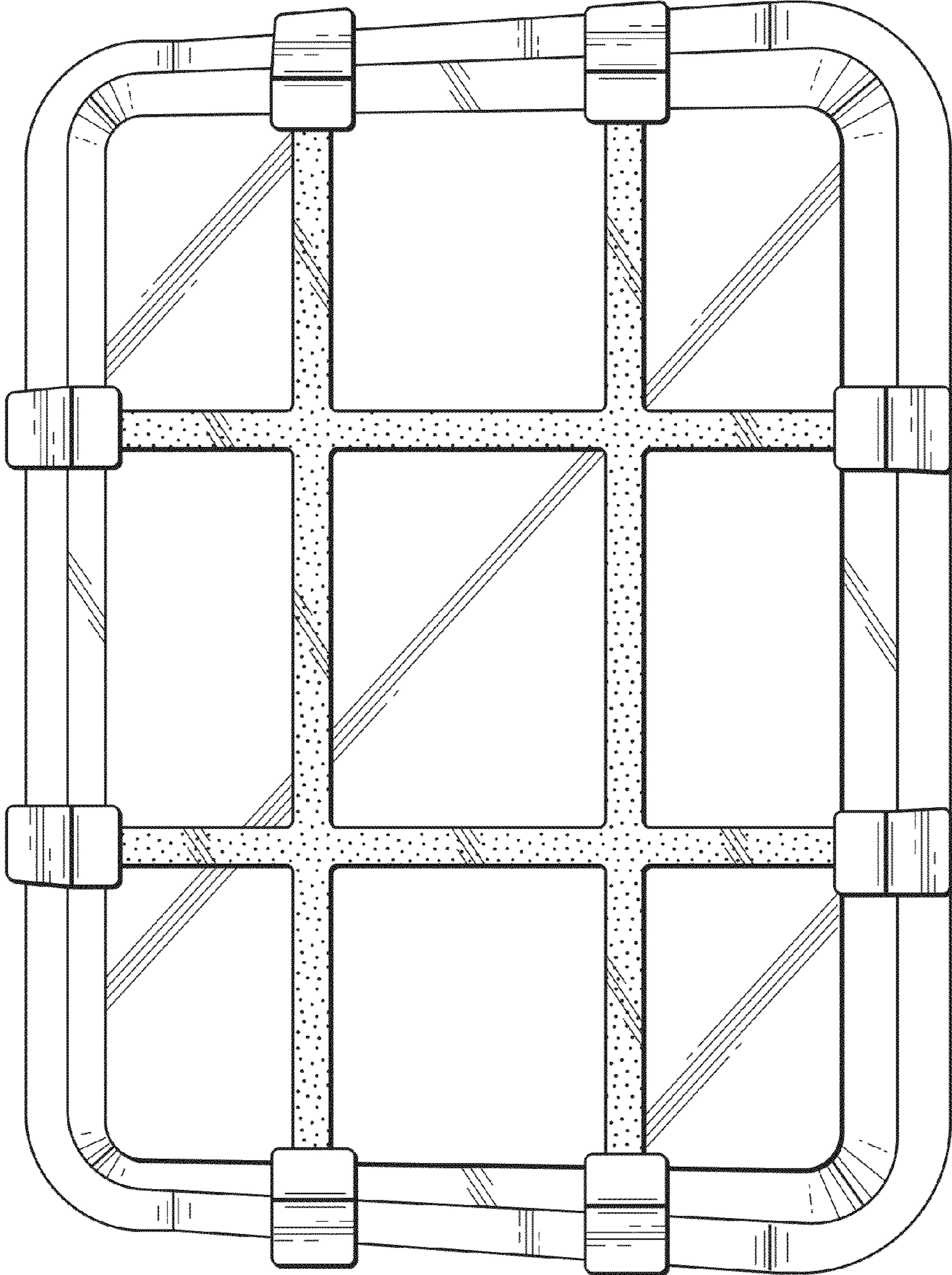

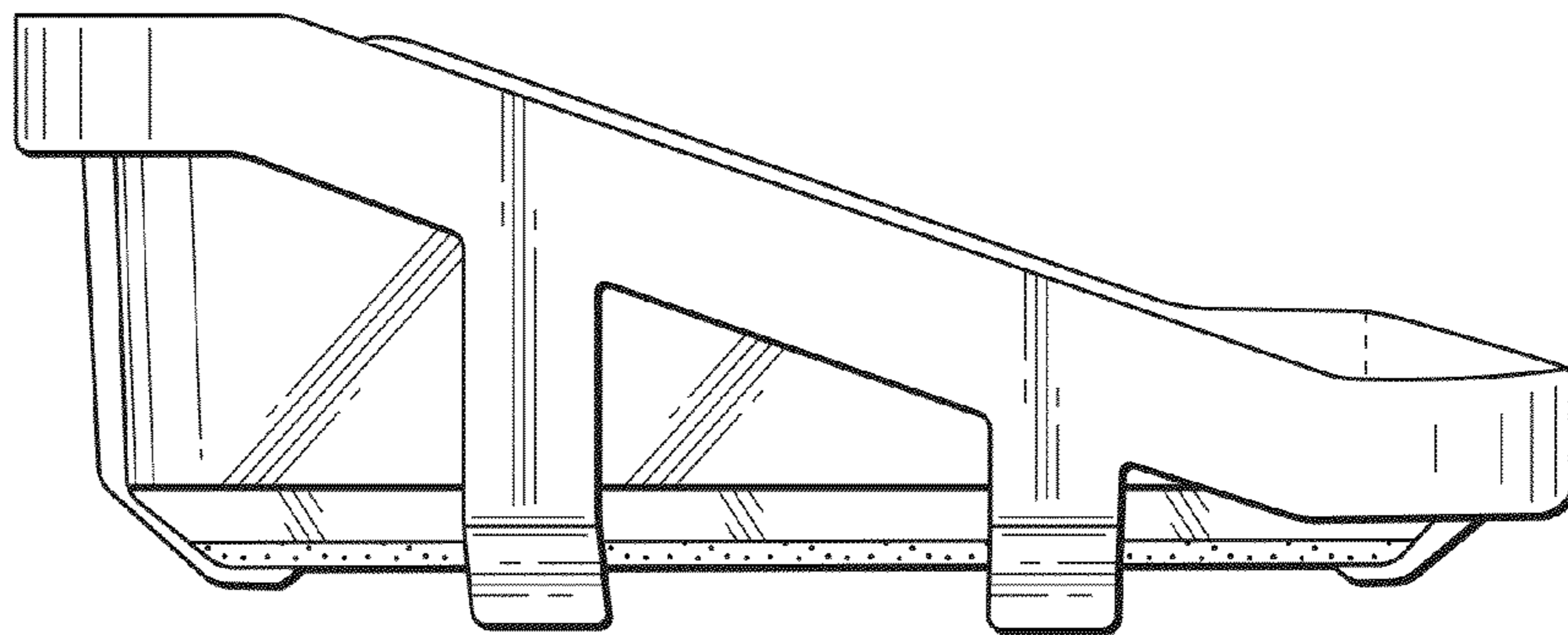

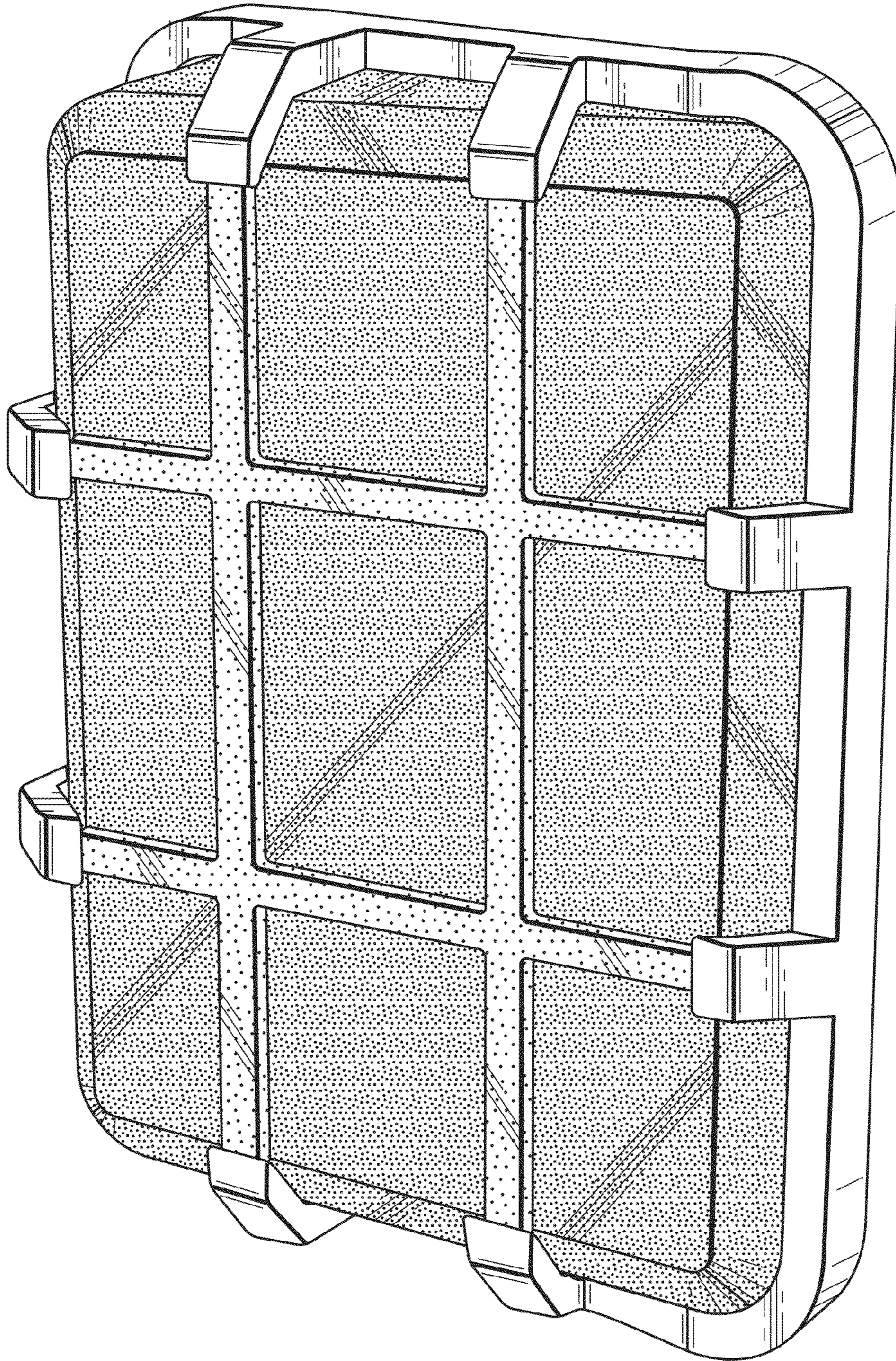

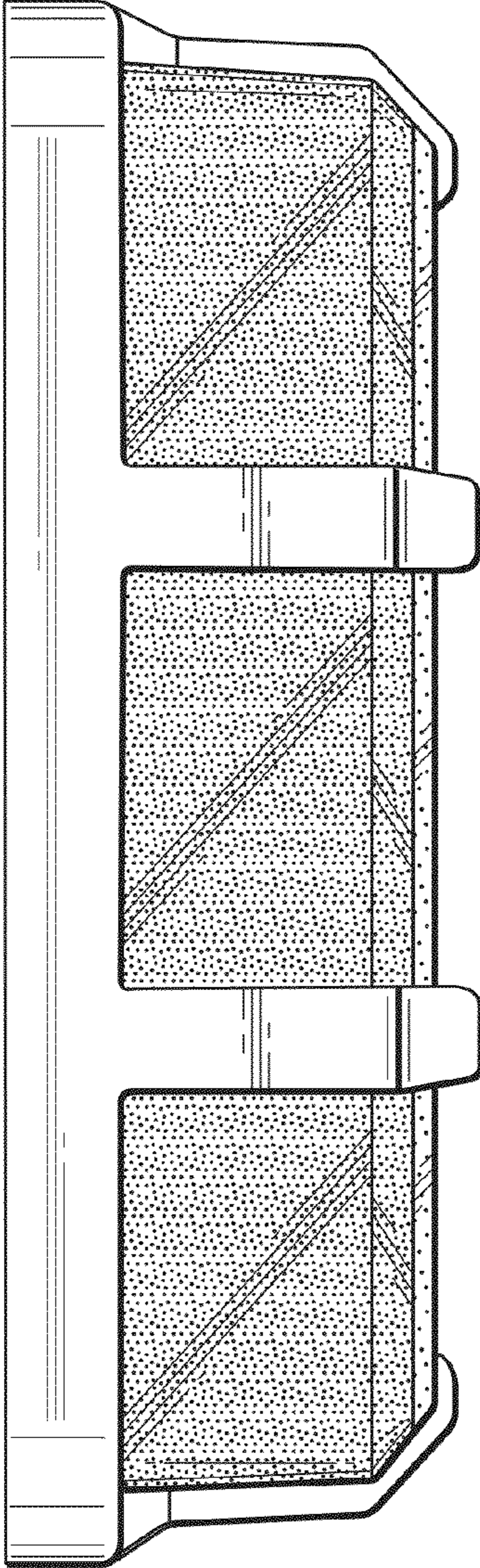

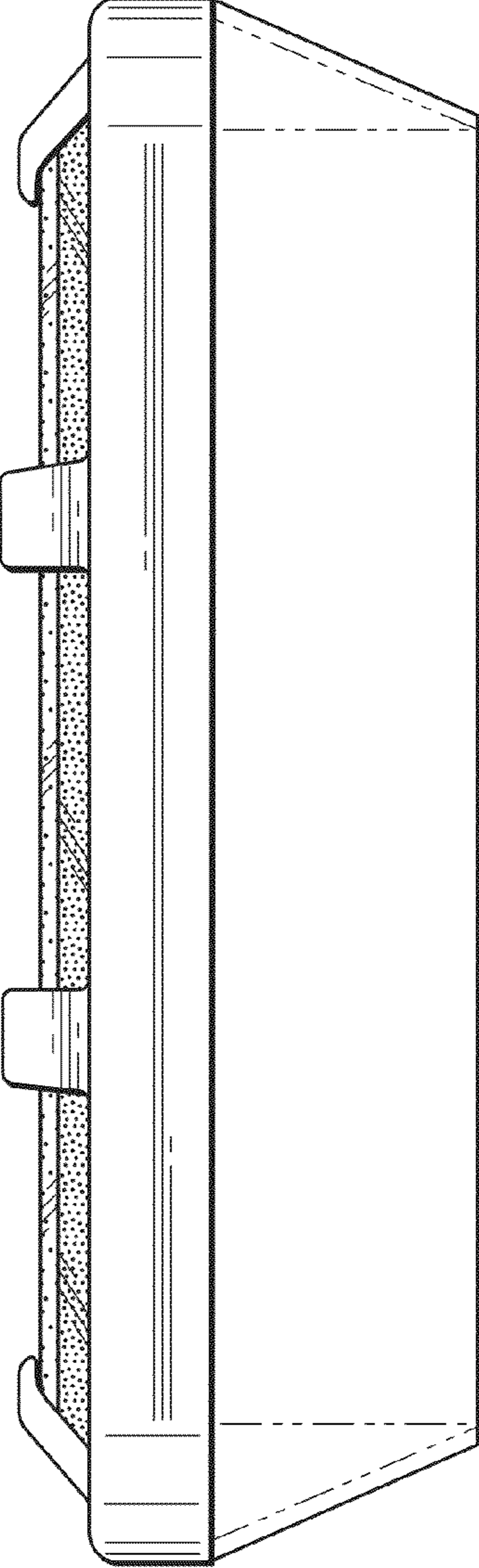

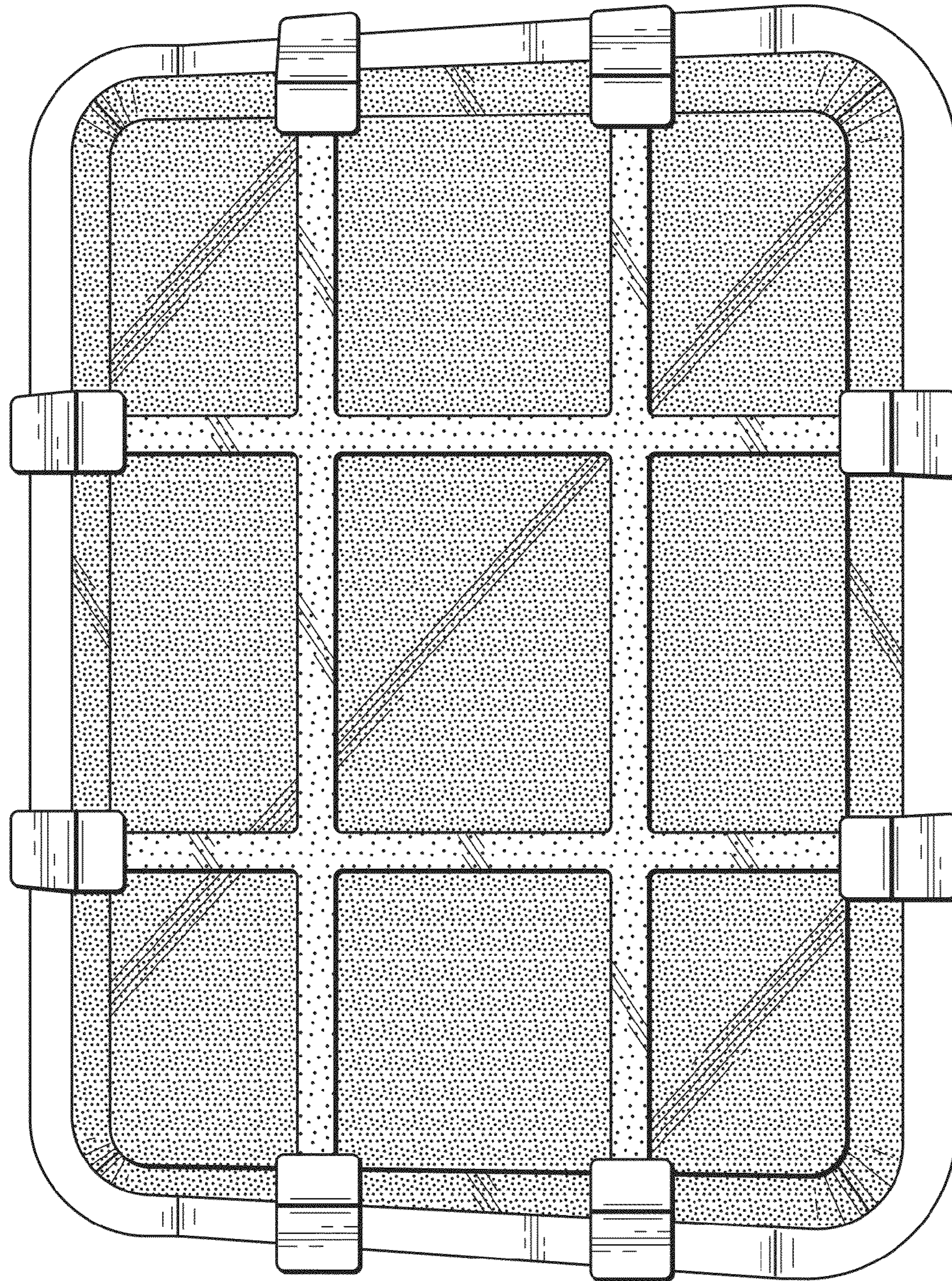

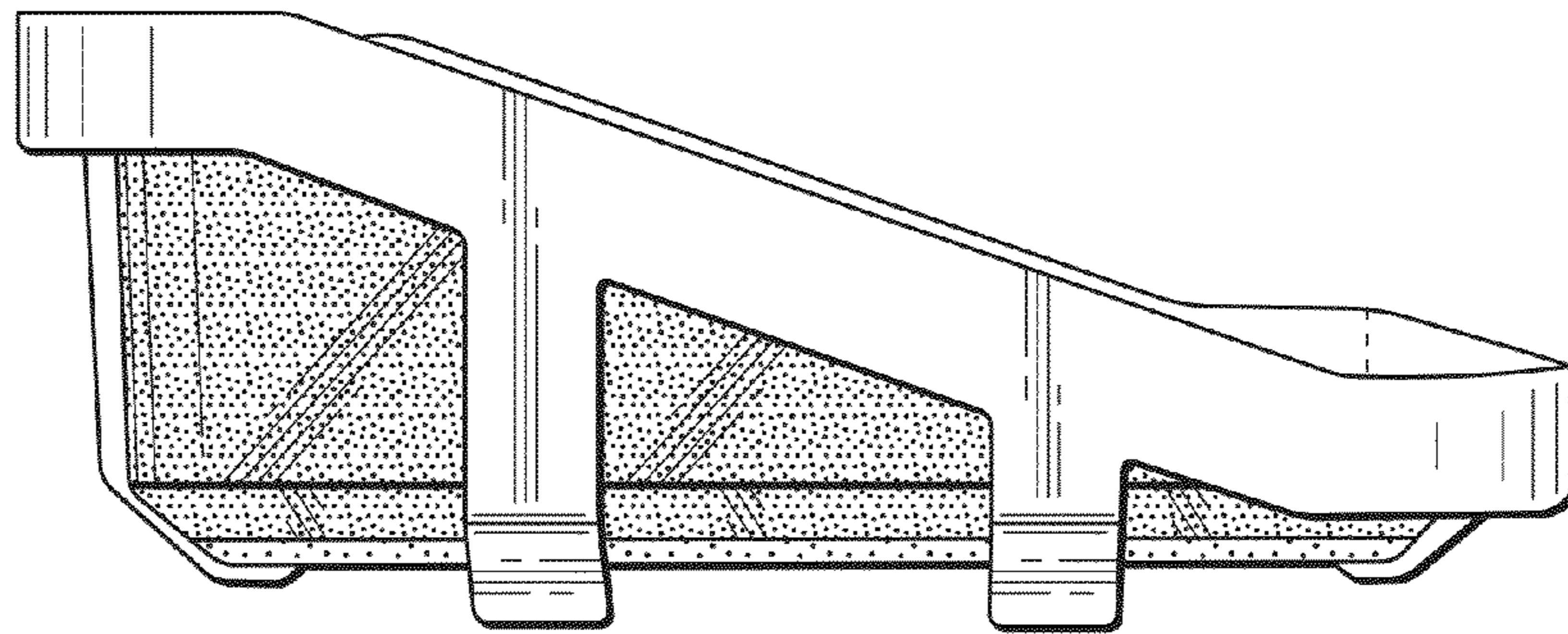
