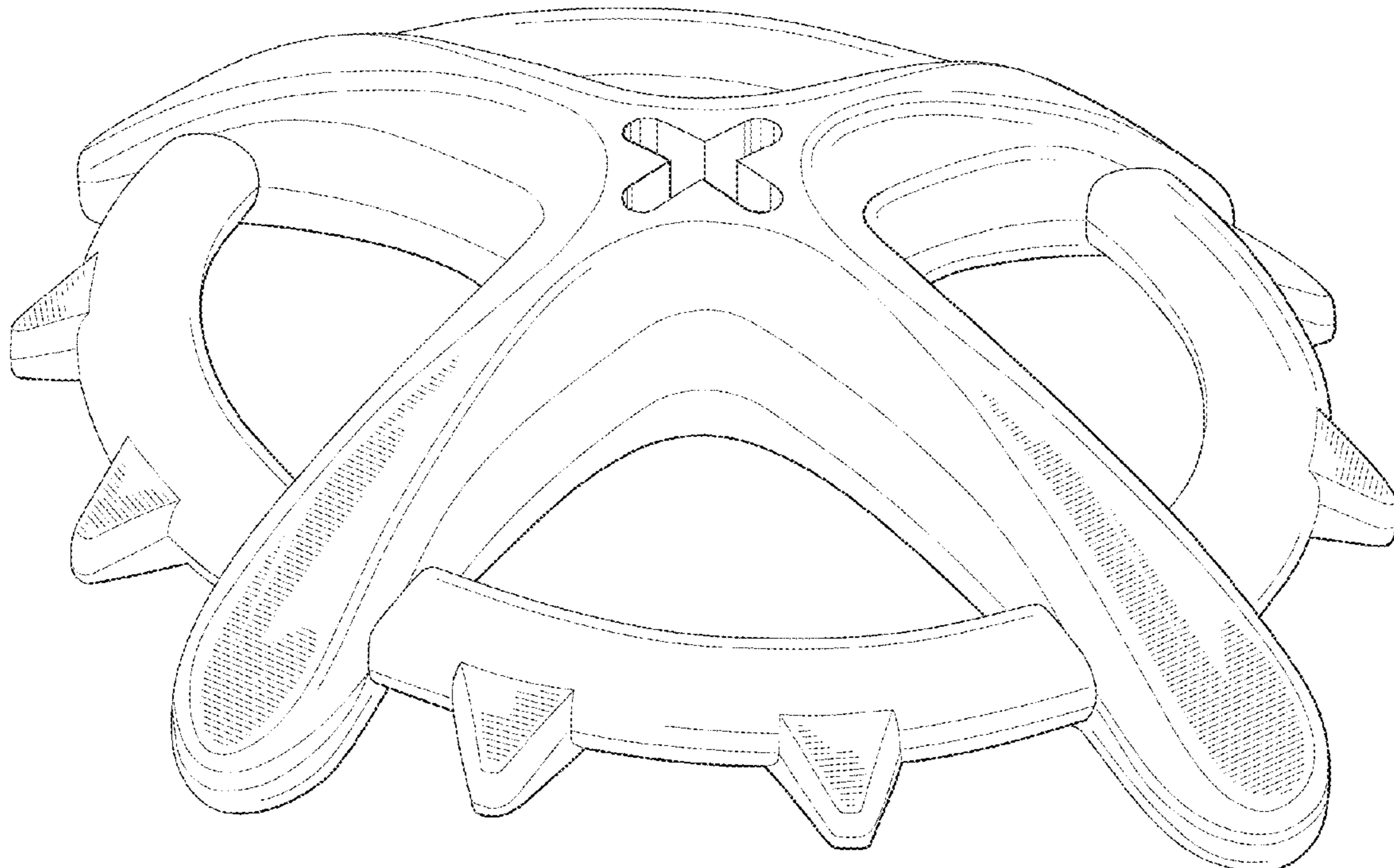

The ornamental design for an “animal welfare toy,” as shown and described.

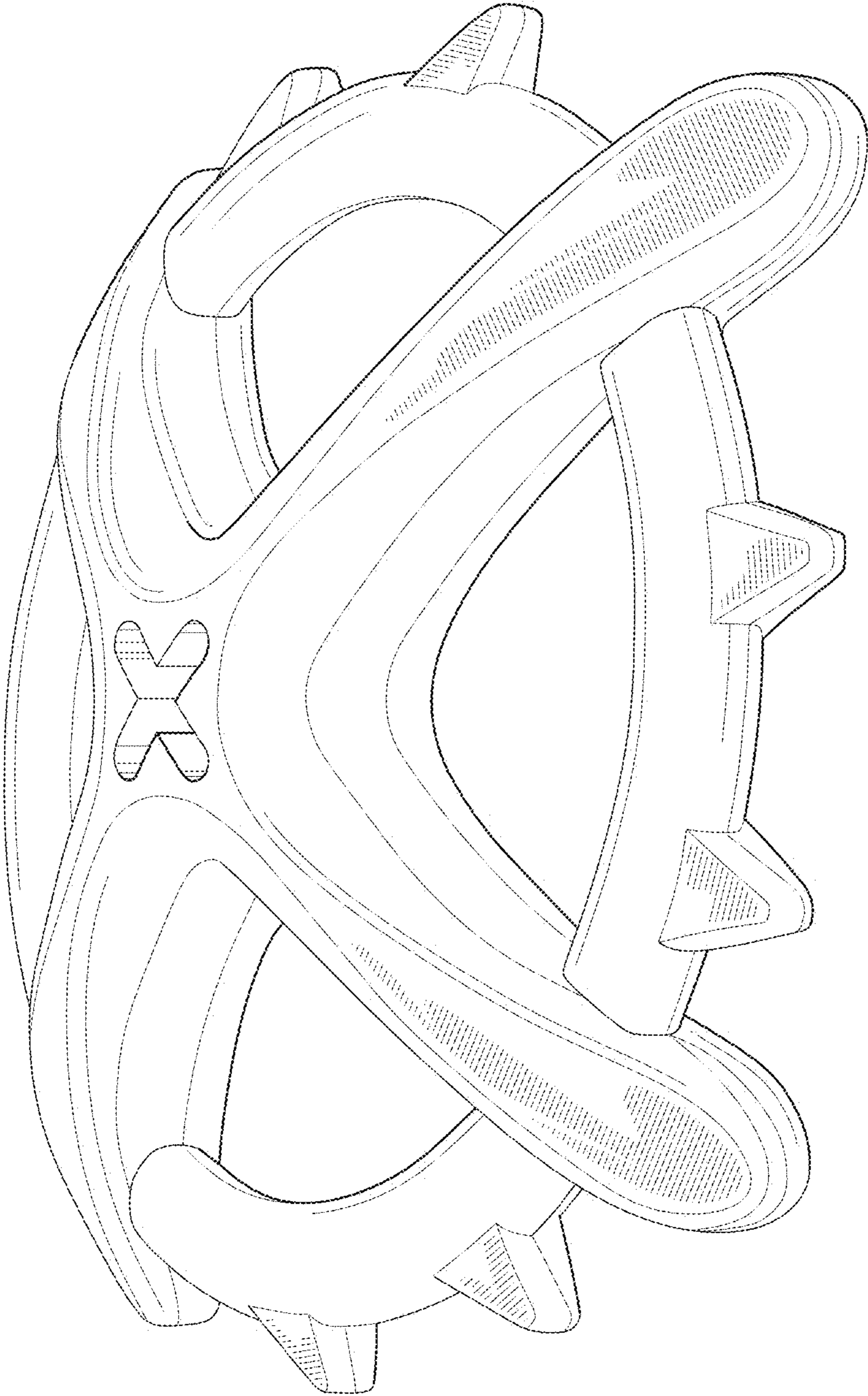
**DESCRIPTION**

FIG. 1 is a top, front, and left side perspective view showing my new design for an animal welfare toy.  
FIG. 2 is a top plan view of the animal welfare toy shown in FIG. 1.

The broken lines are for illustration only and form no part of the claimed design.

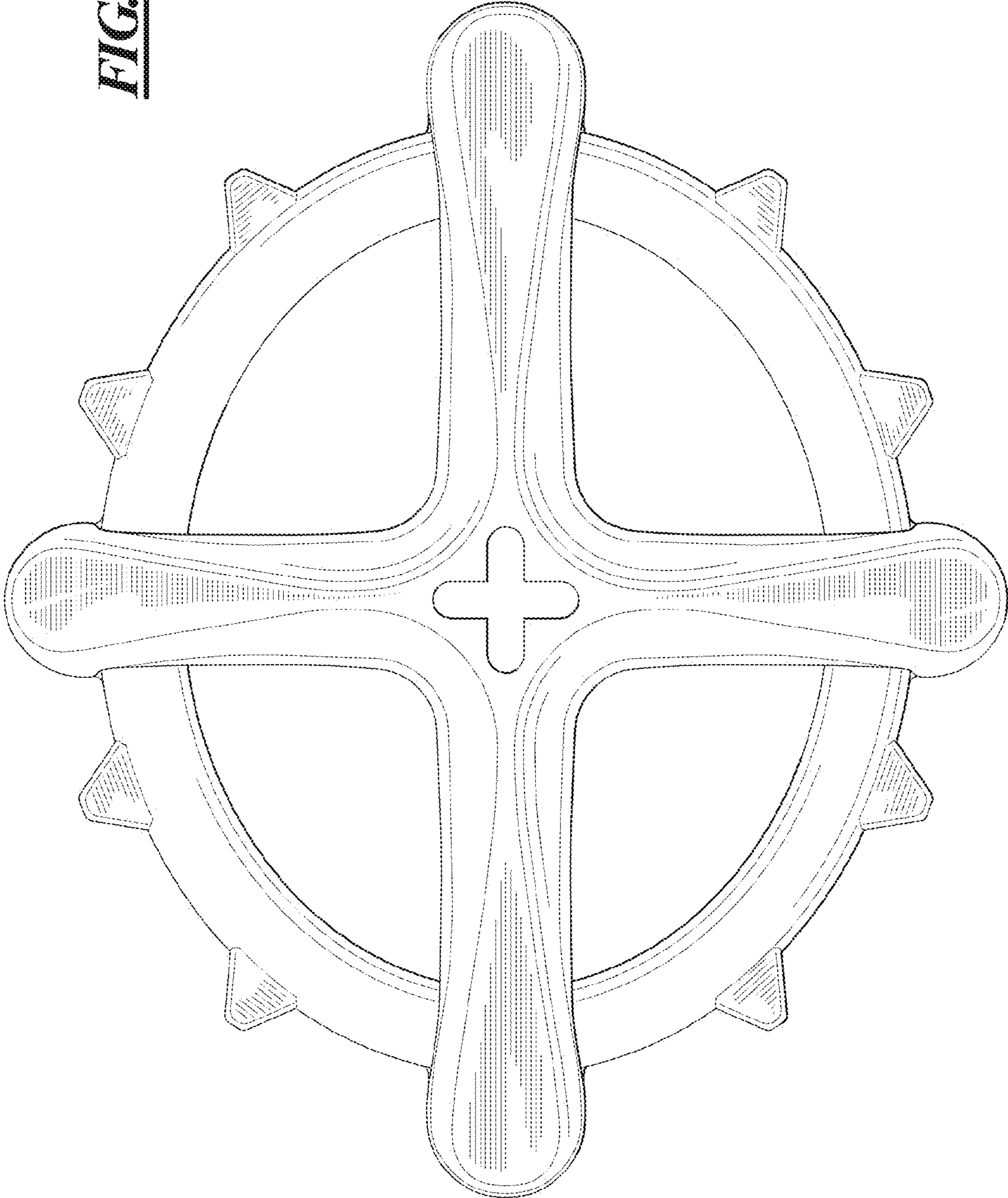

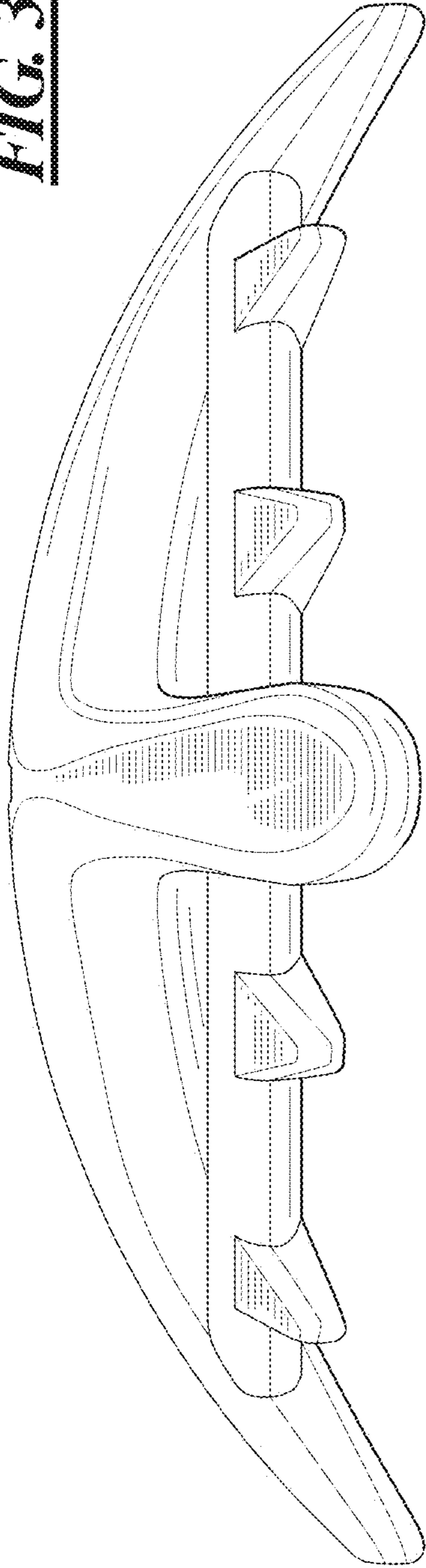

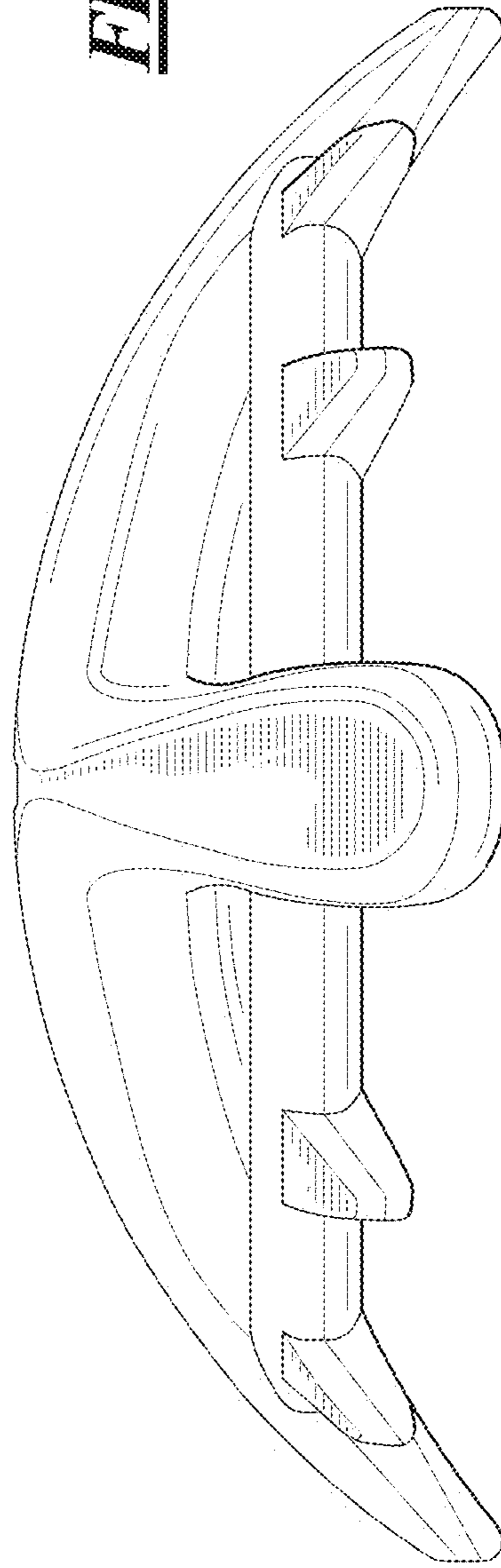
