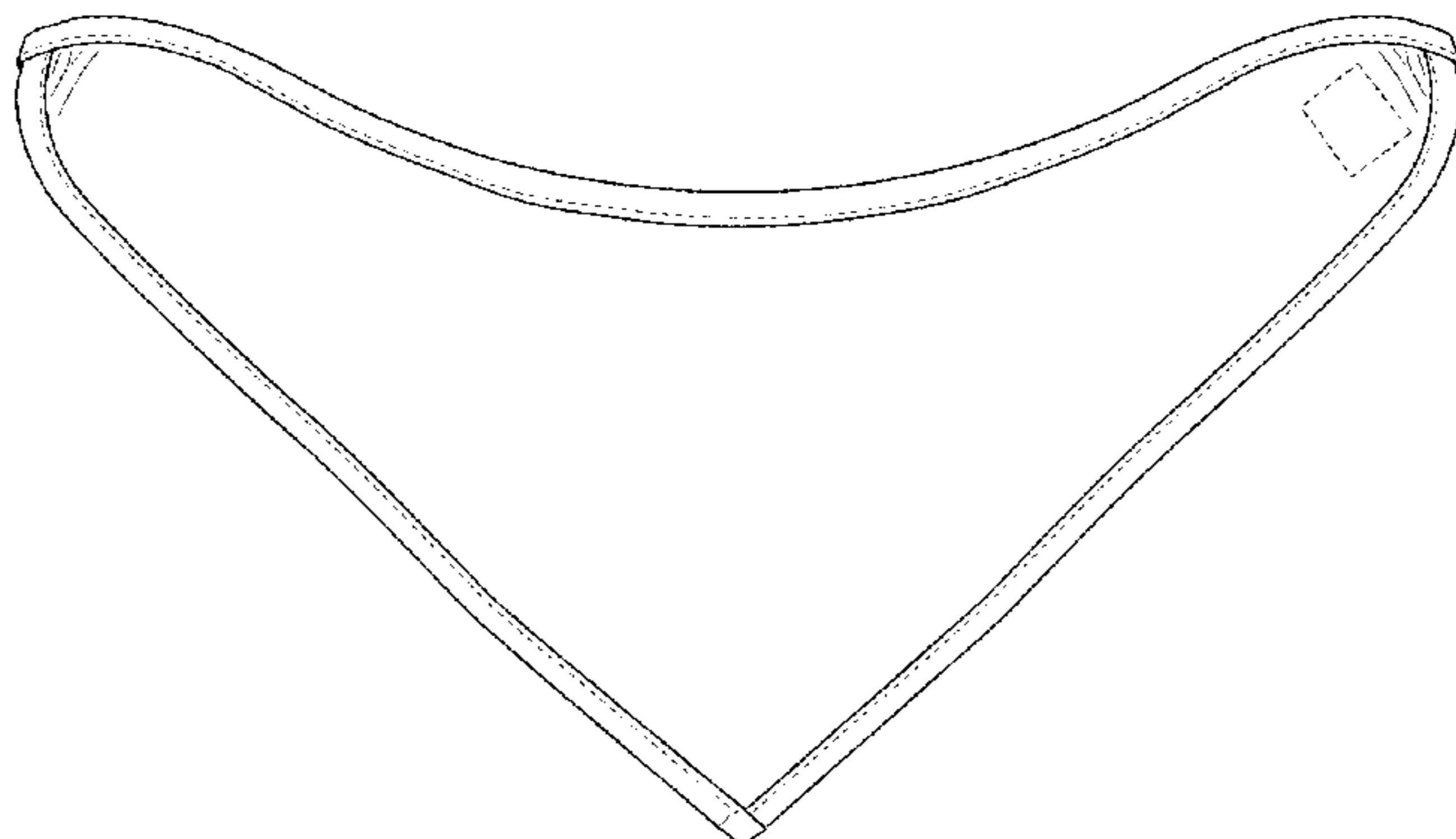
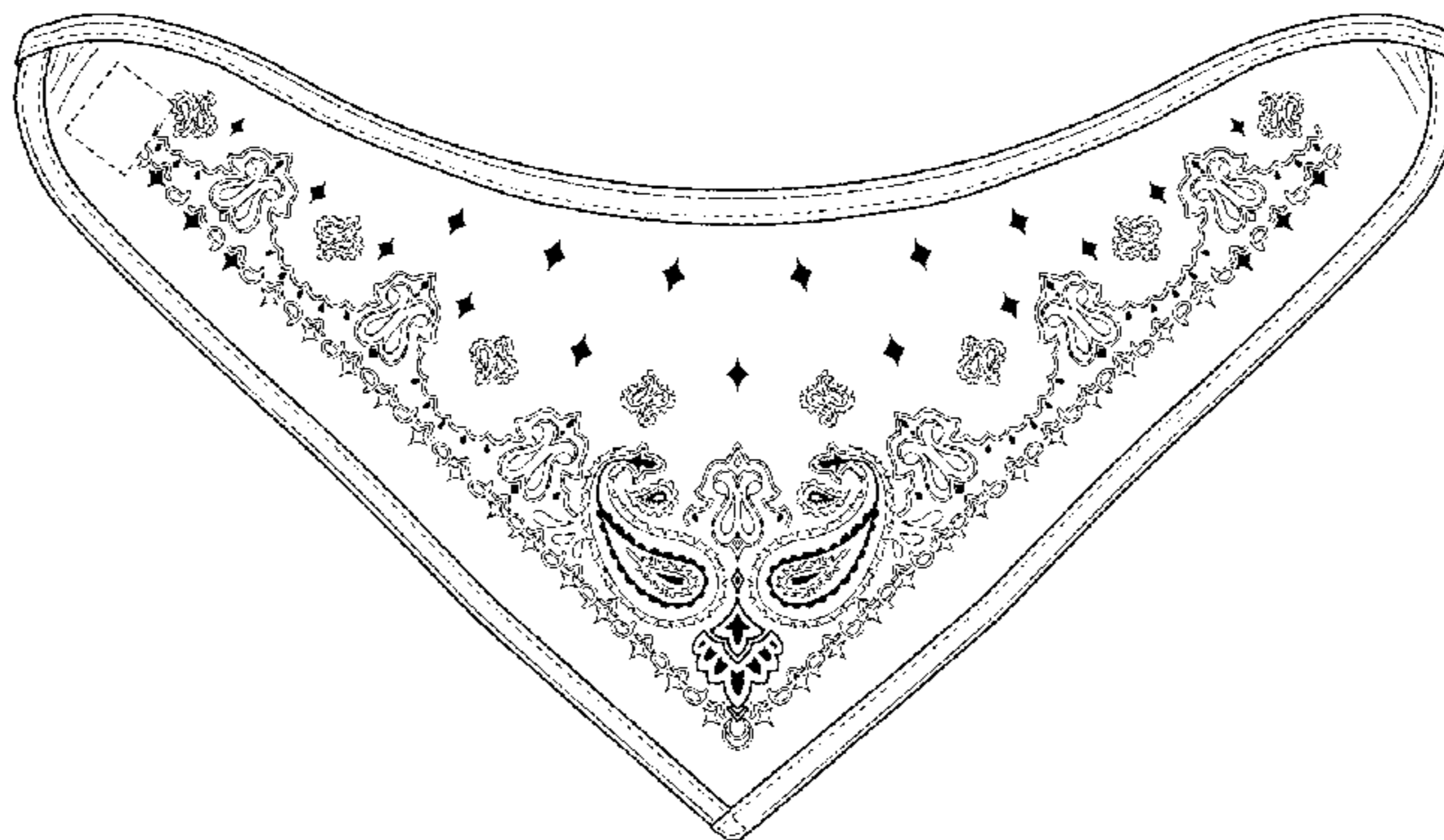
**DESCRIPTION**

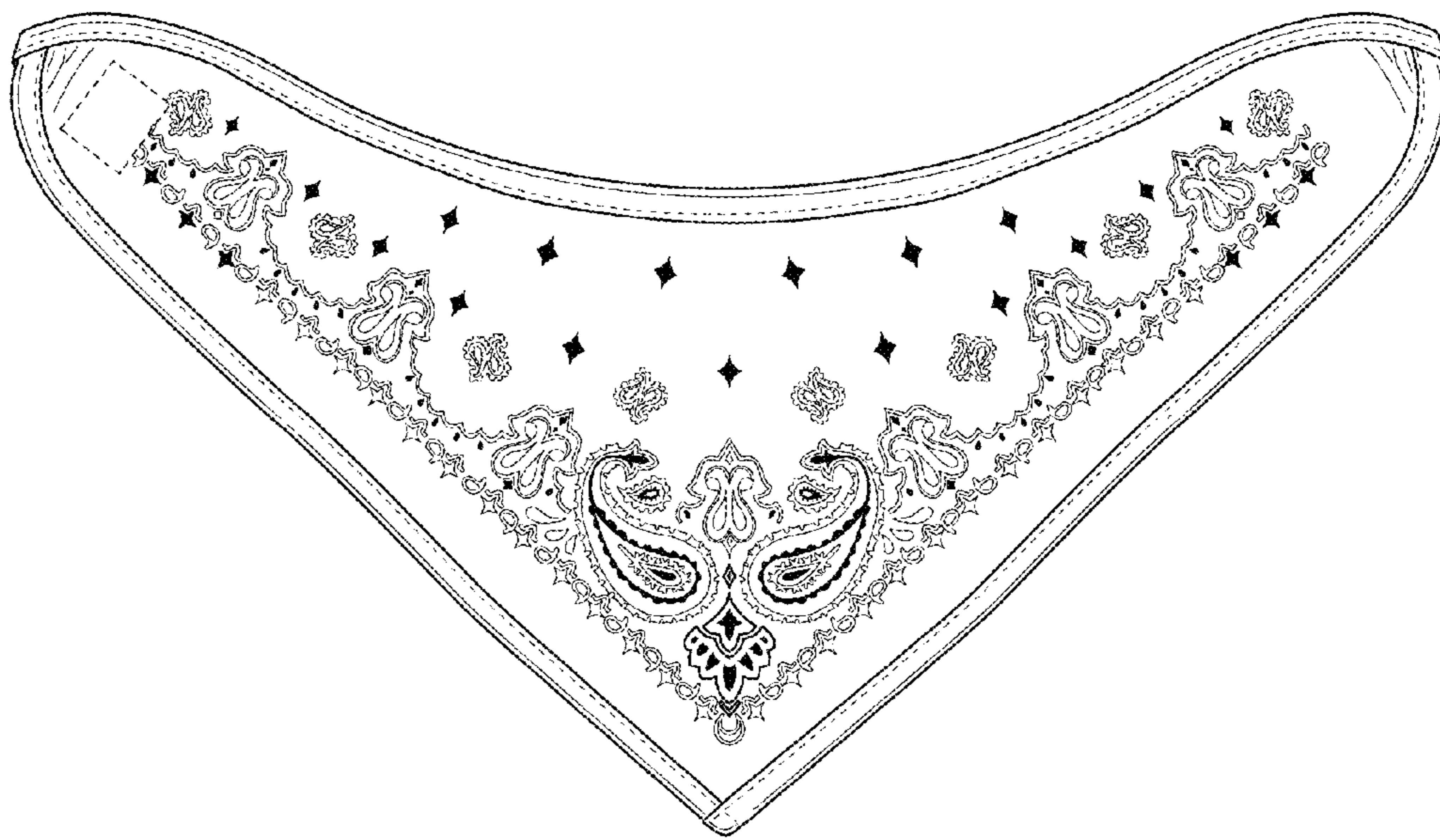

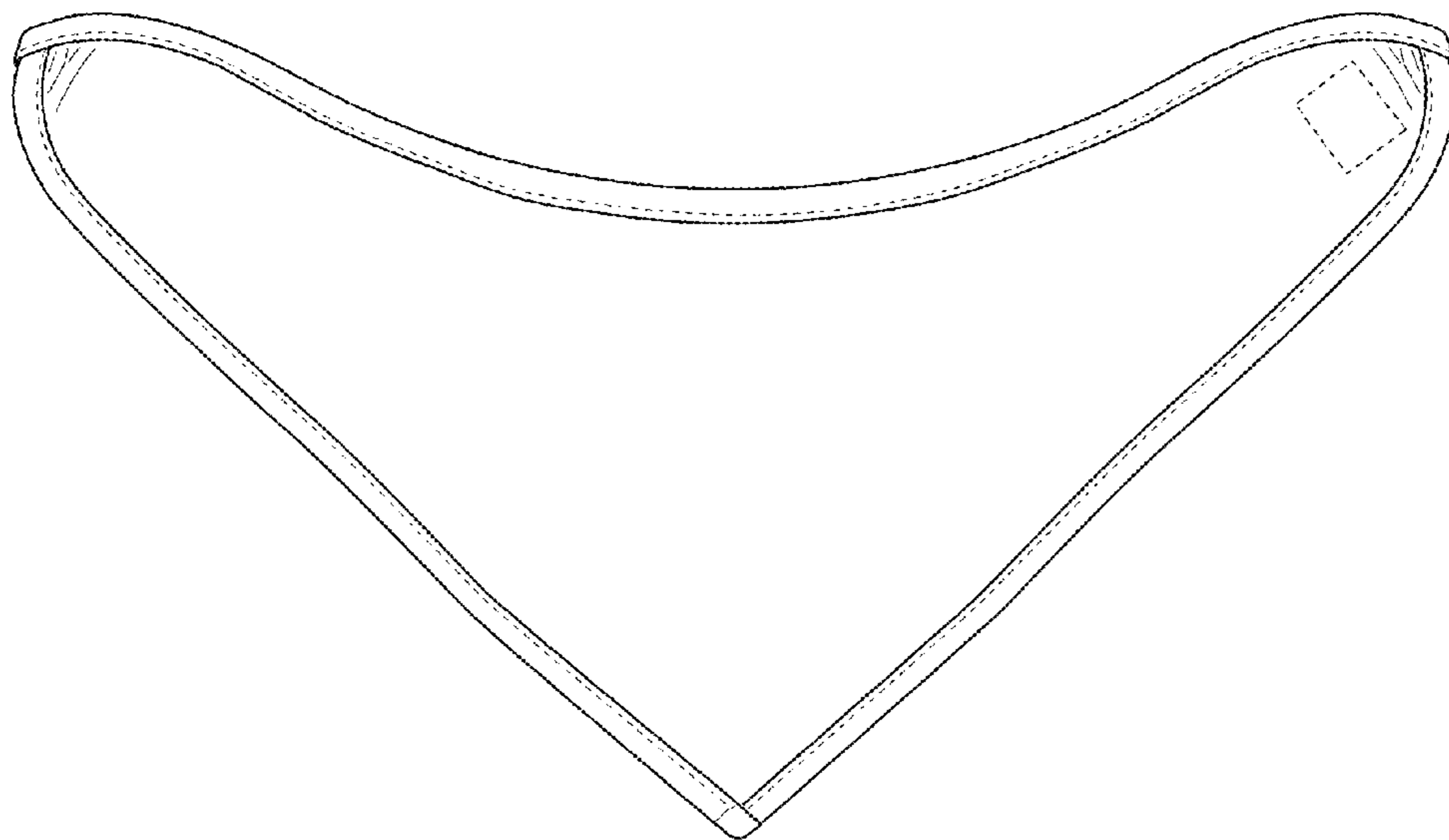
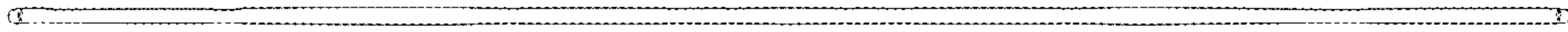
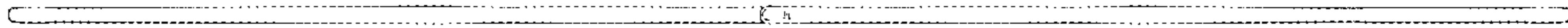


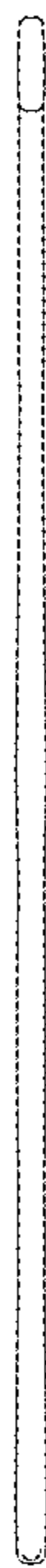

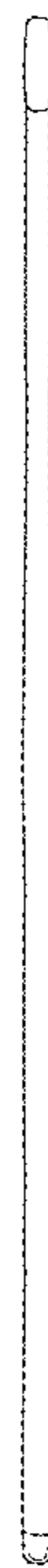
