FIG. 6 is a bottom view of the purse in an expanded view;

FIG. 7 is a top view thereof;

FIG. 8 is a perspective top view thereof showing cans in broken lines disposed in the pockets therein; and,

FIG. 9 is bottom view of the purse in the collapsed view.

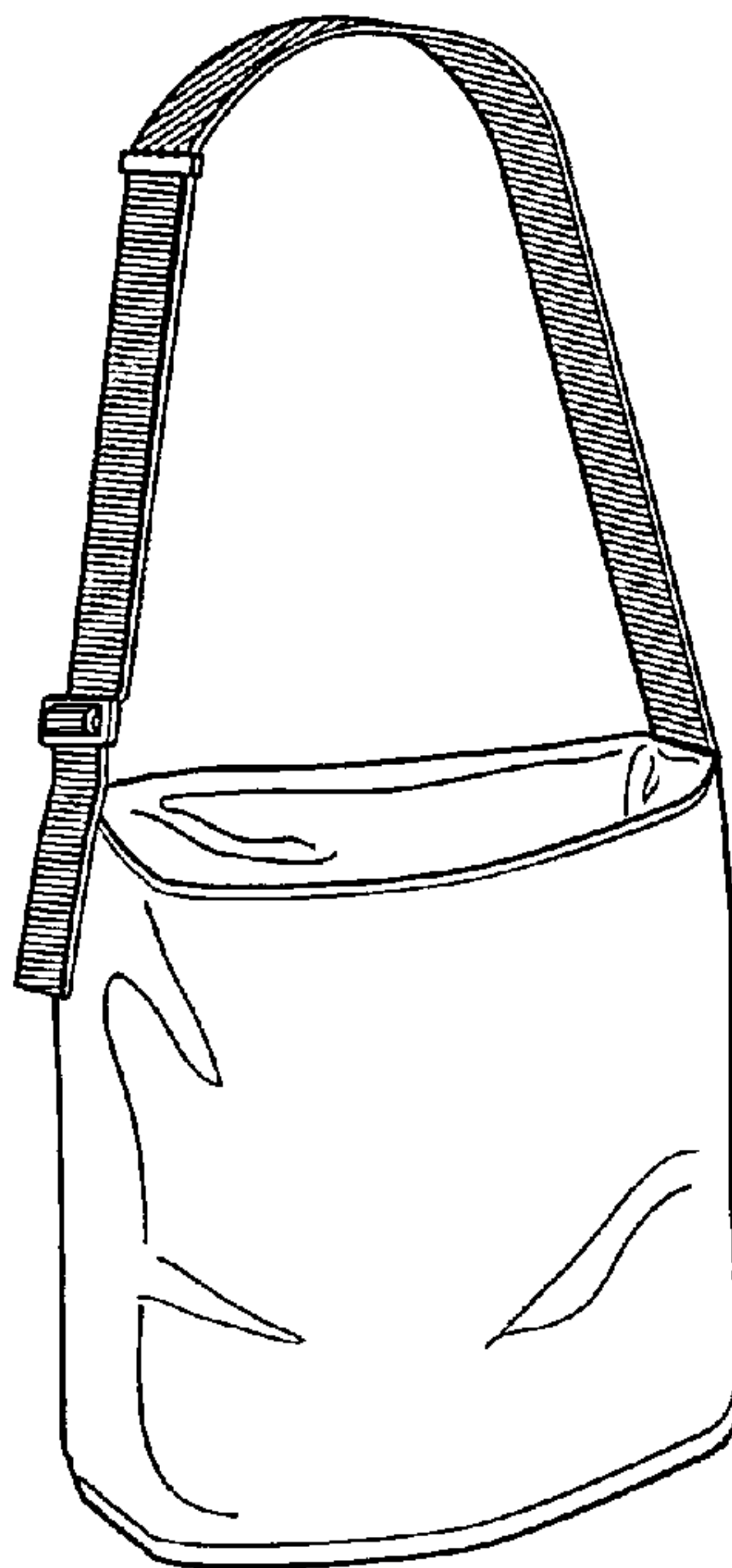
The broken lines in the drawings represent stitching and are part of the claimed design.

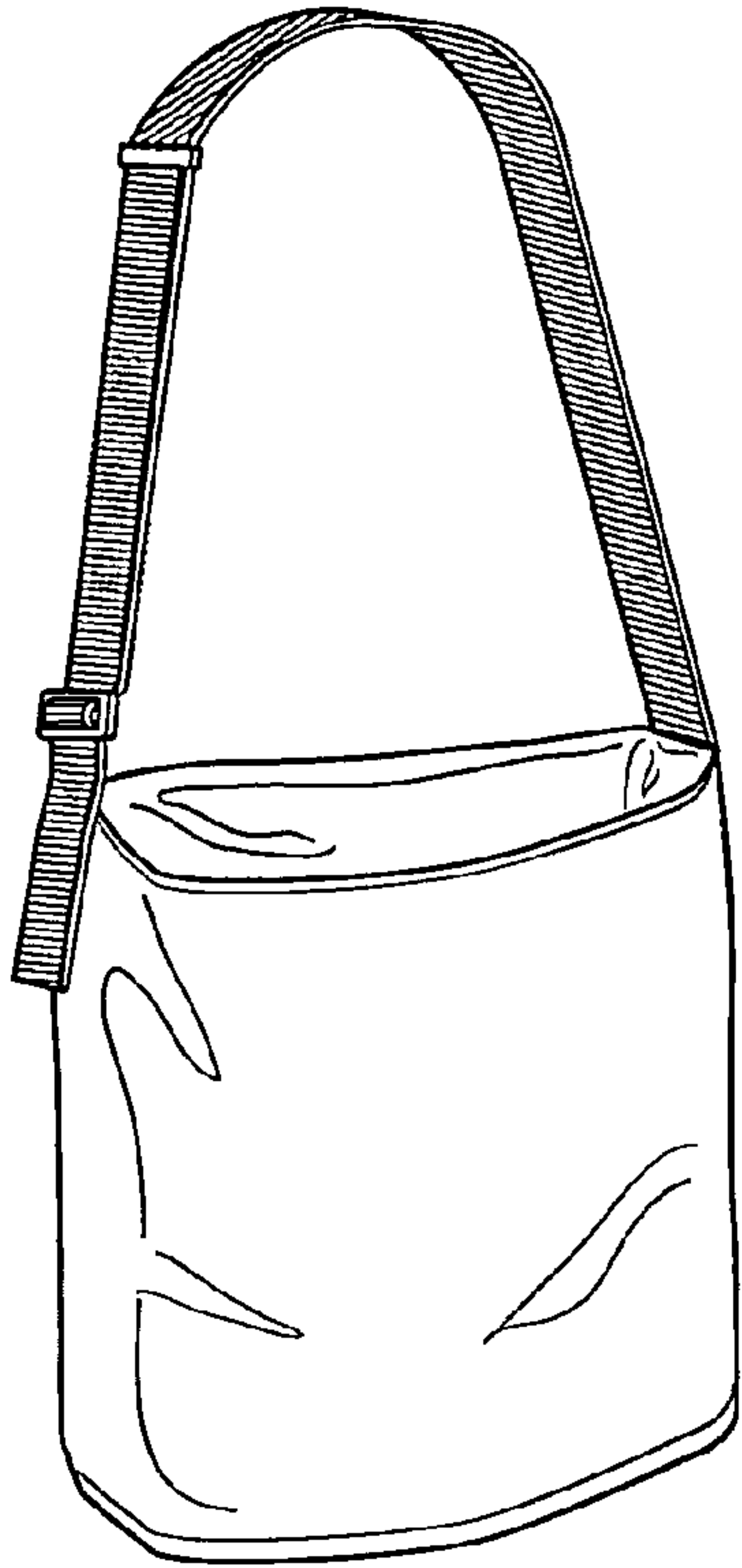

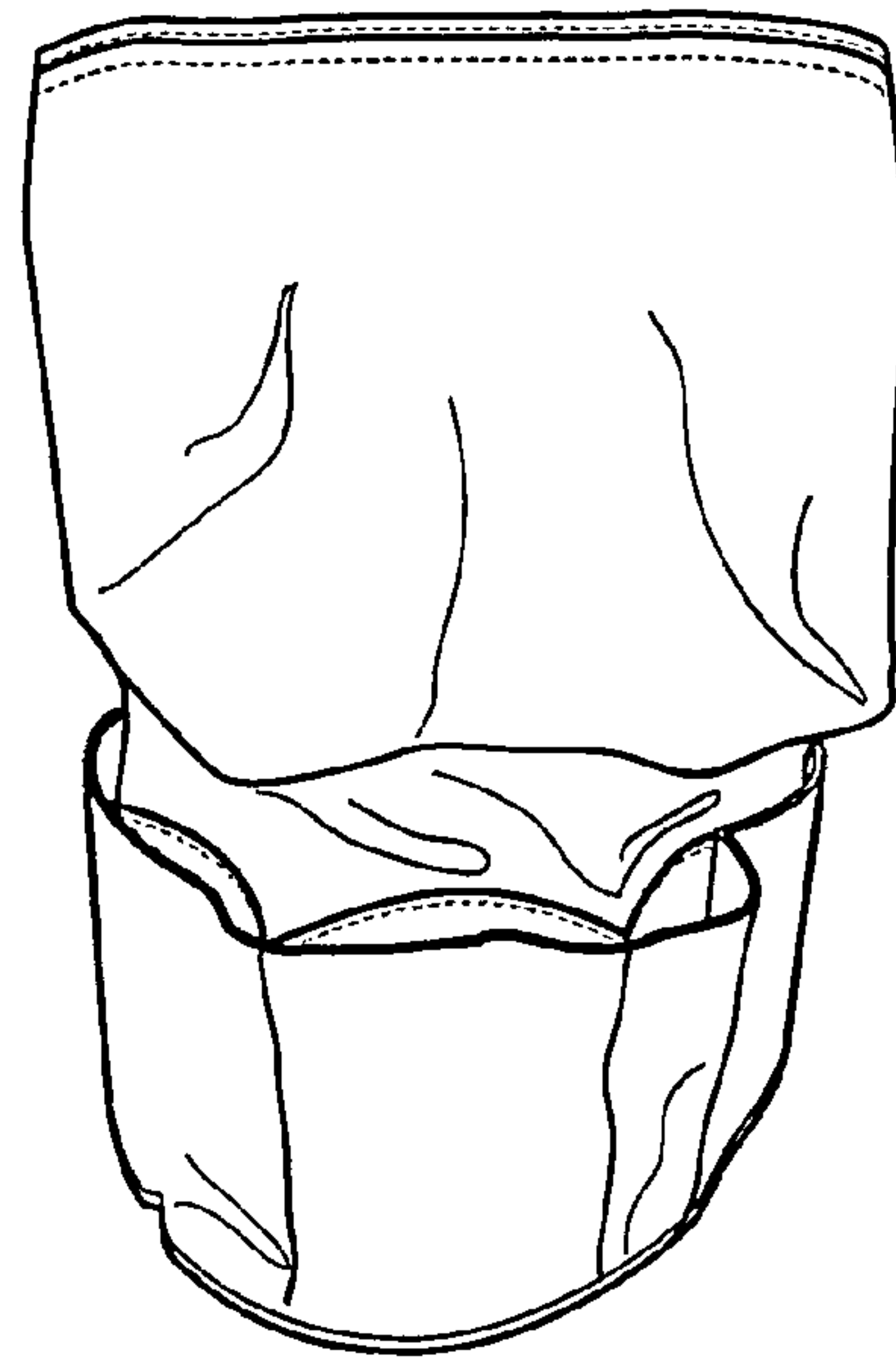

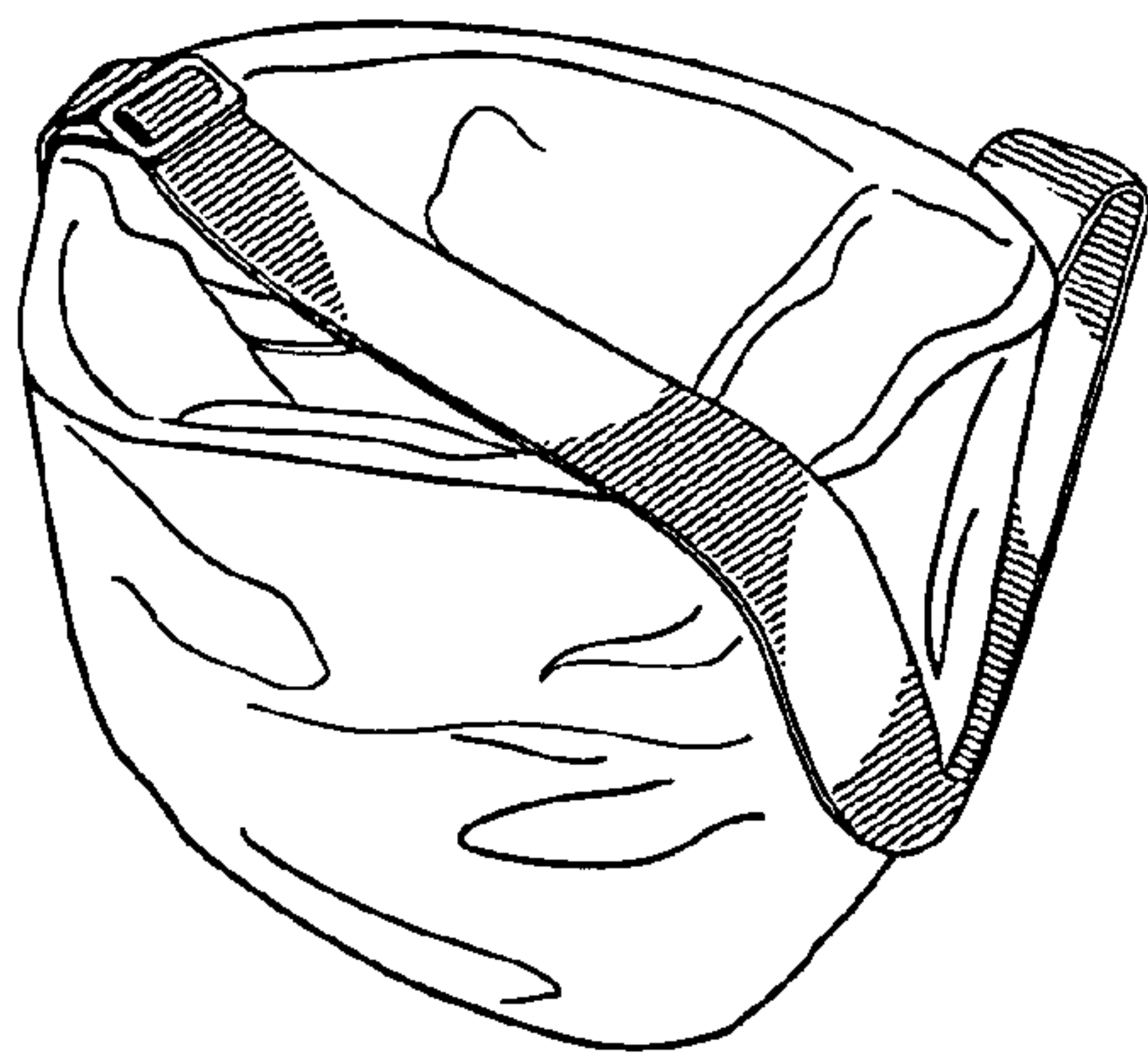

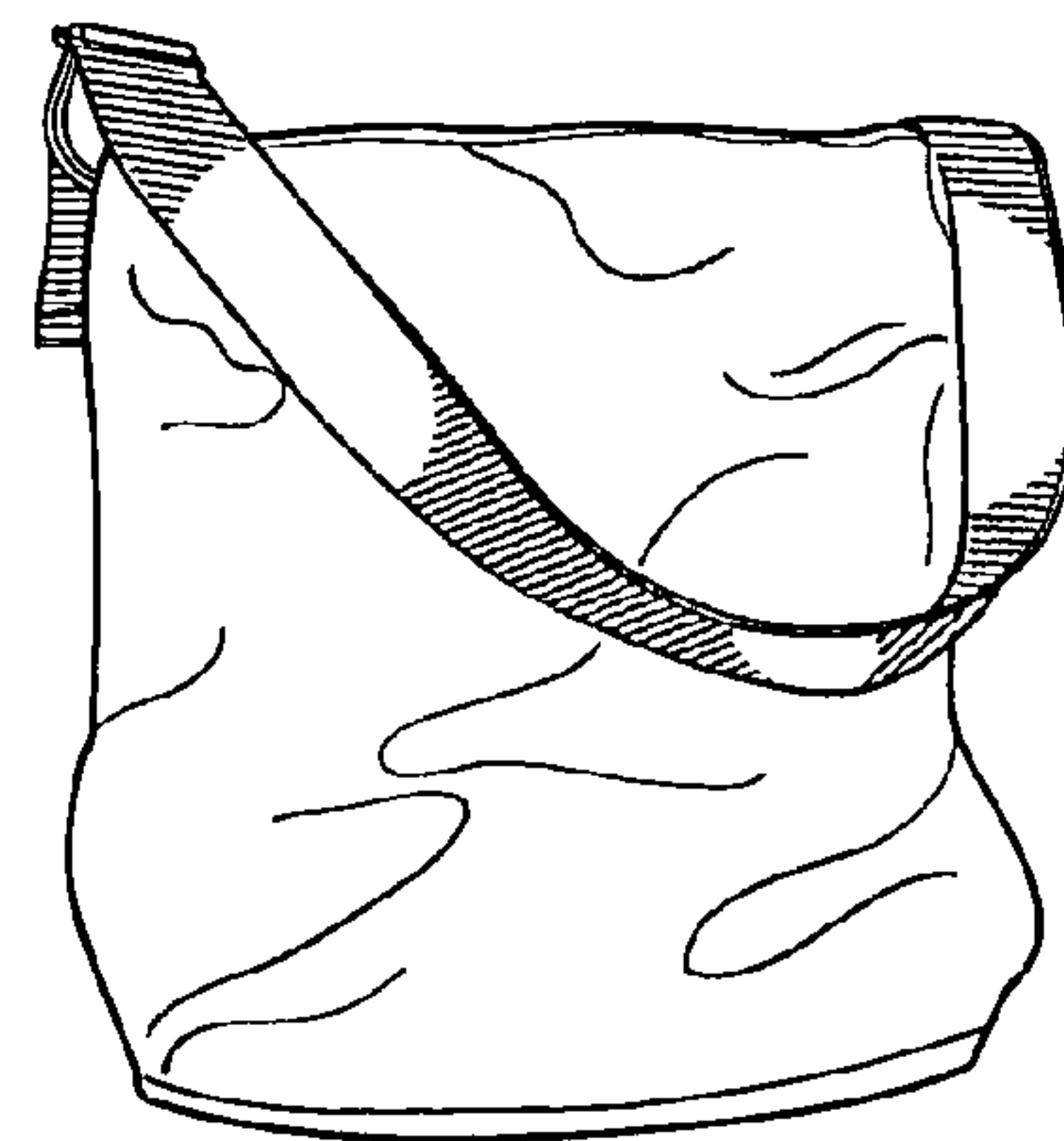

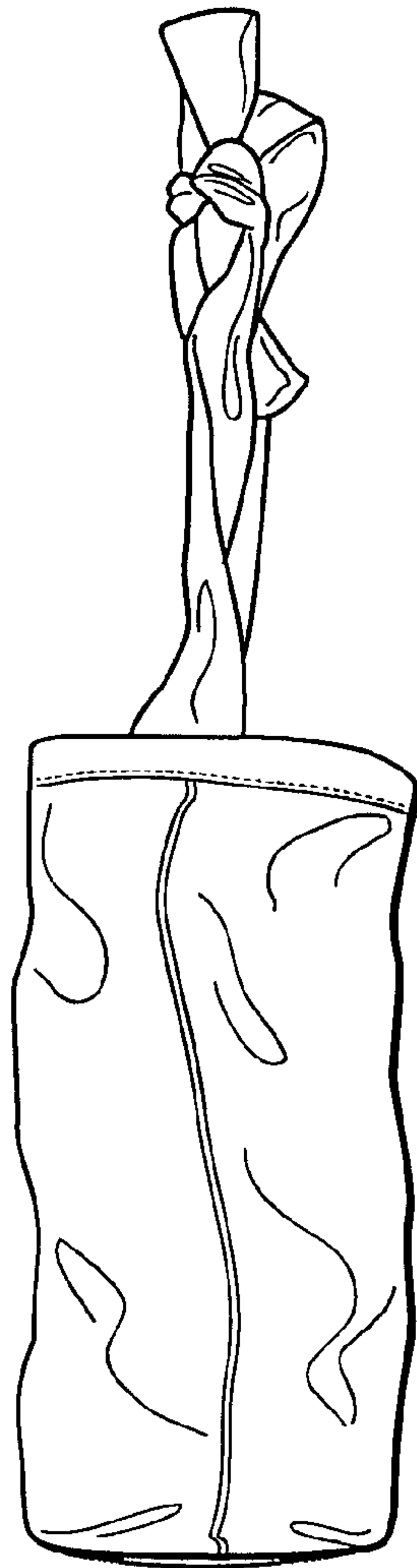

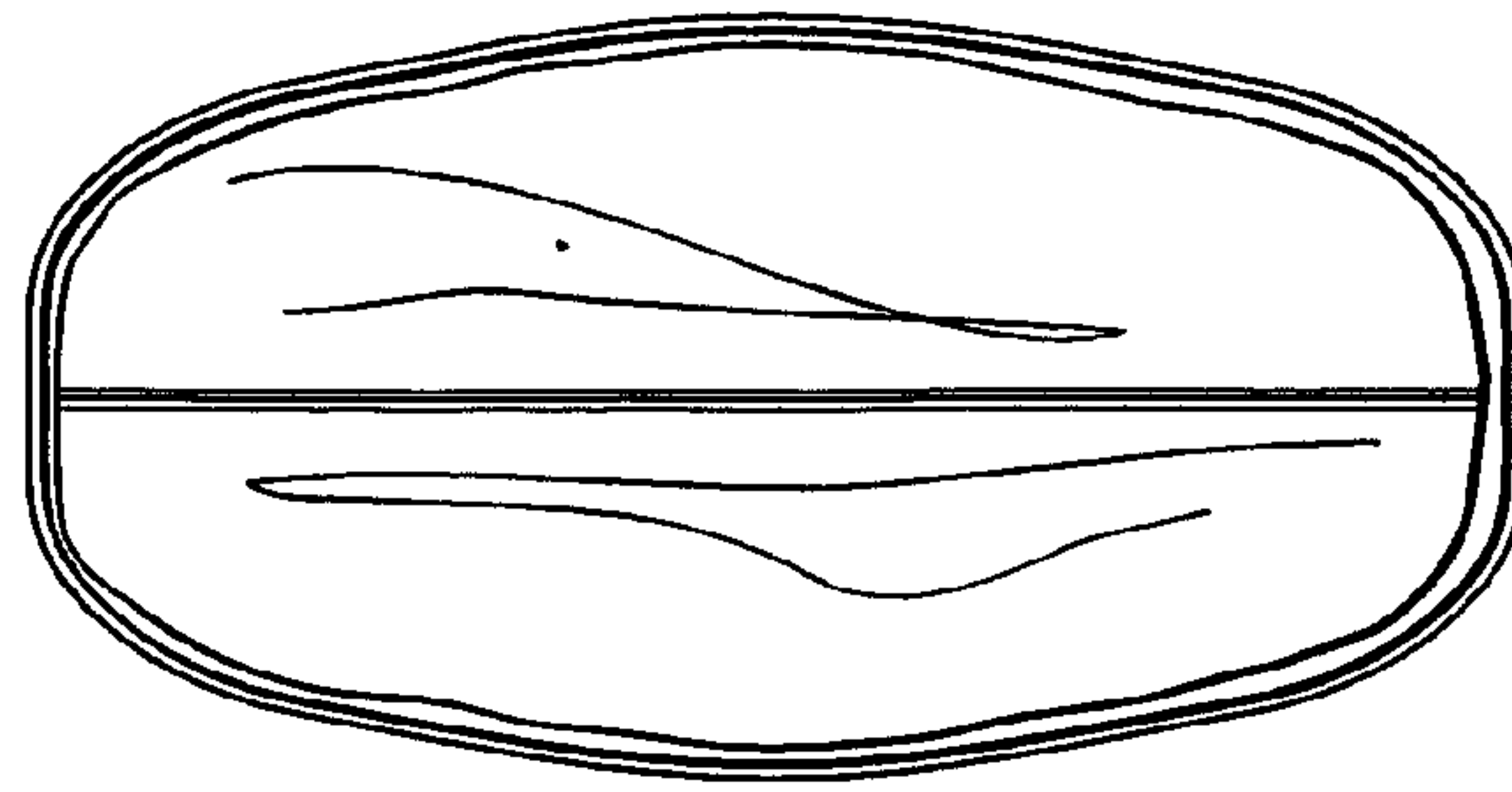

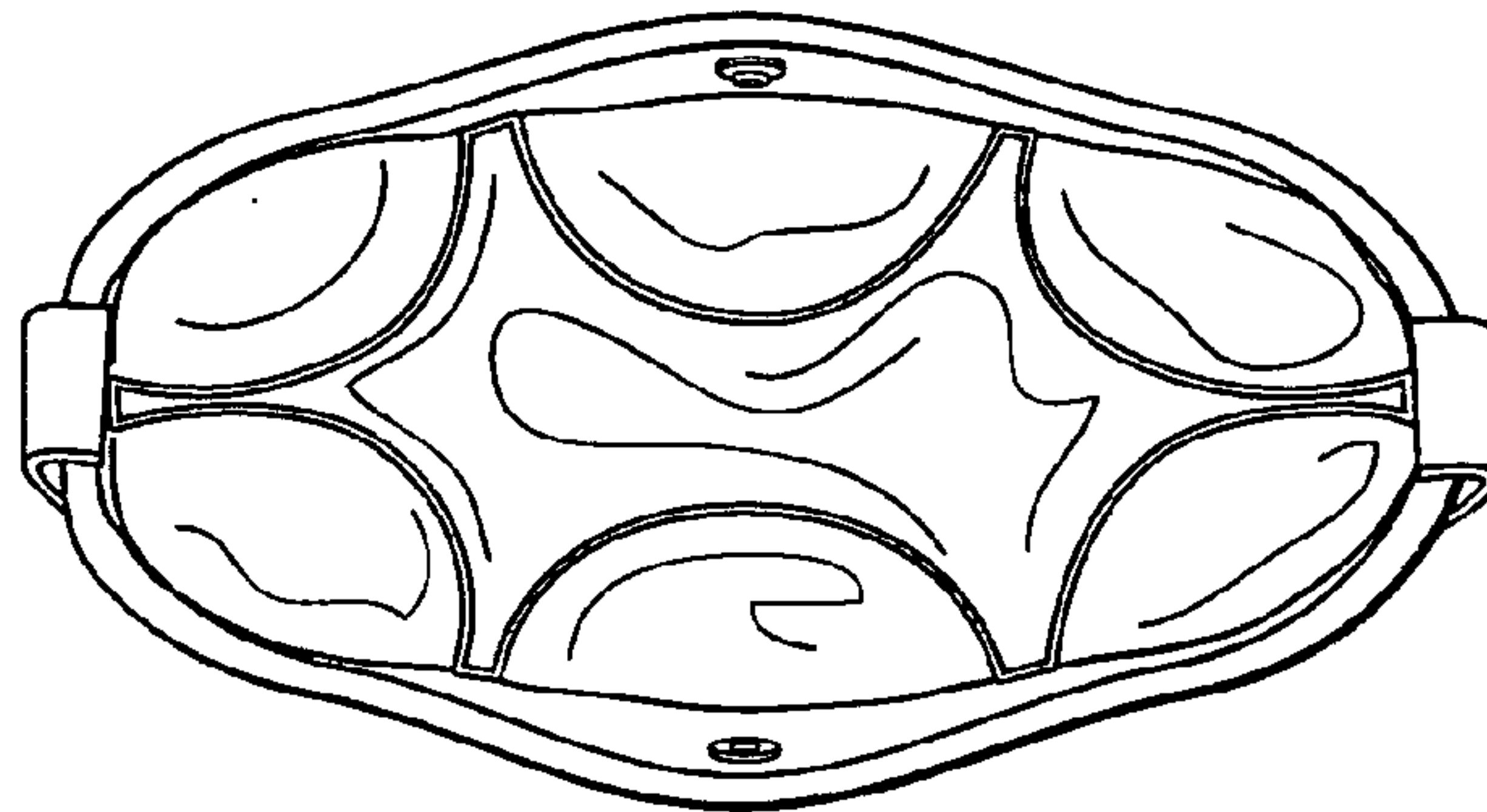

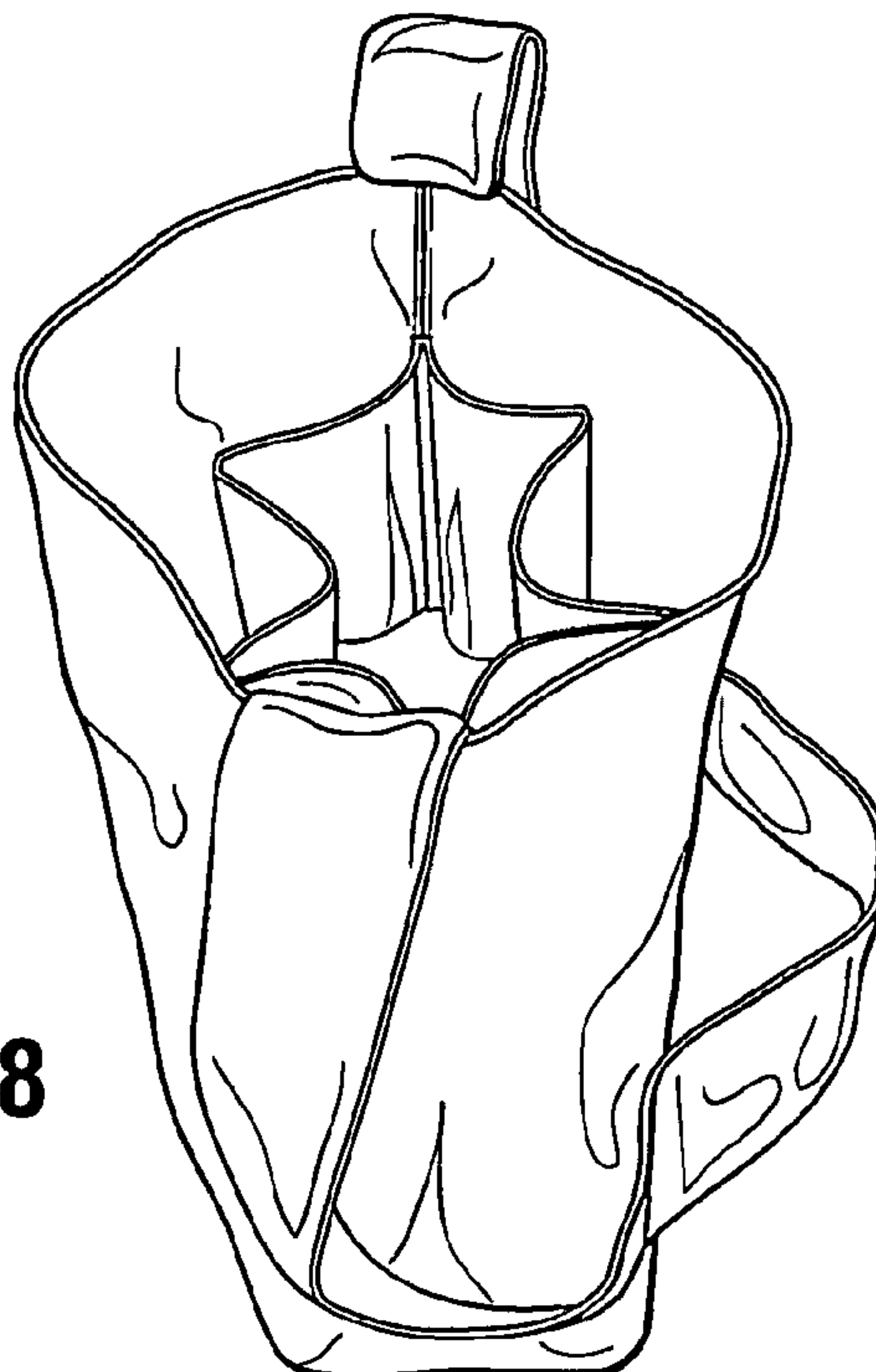

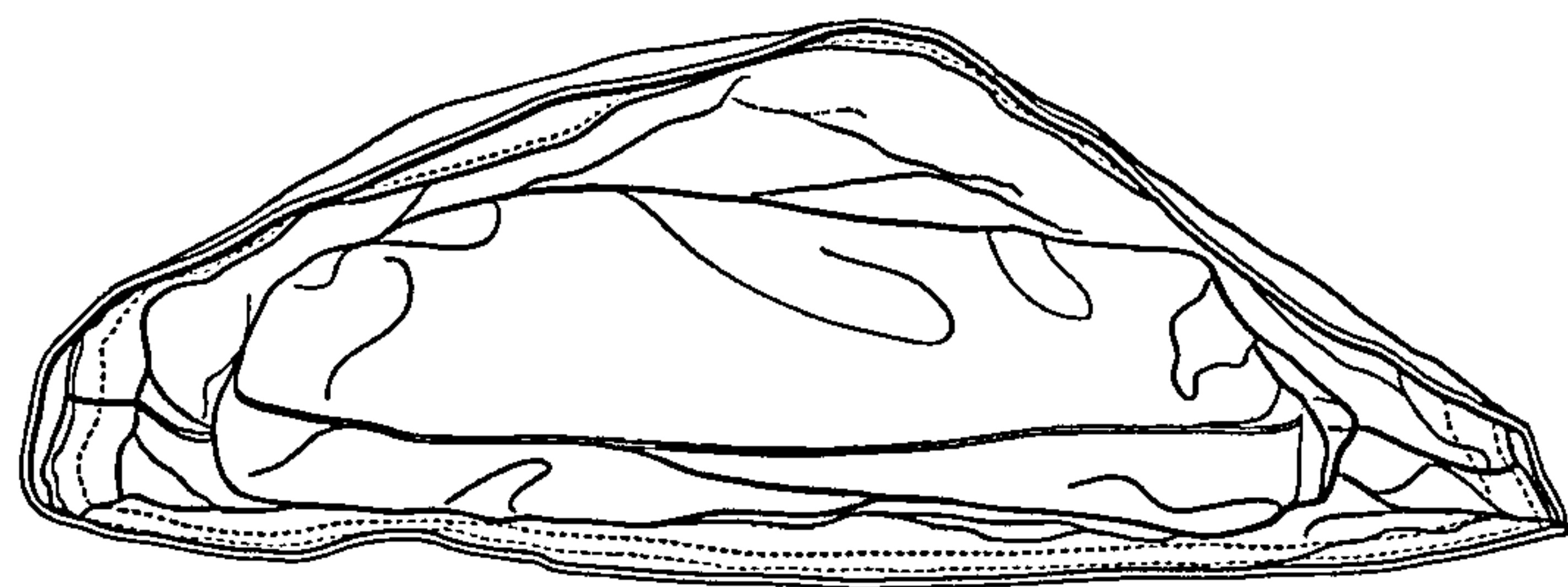
