(57) **CLAIM**

The ornamental design for a case for skis, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of the case for skis, showing my new design;

FIG. 2 is a top view of the case for skis, as shown in FIG. 1; FIG. 3 is a bottom view of the case for skis, as shown in FIG. 1;

FIG. 4 is a back perspective view of the case for skis, as shown in FIG. 1, and with straps shown;

FIG. 5 is a side view of the case for skis in an open position showing a bag in an extended position;

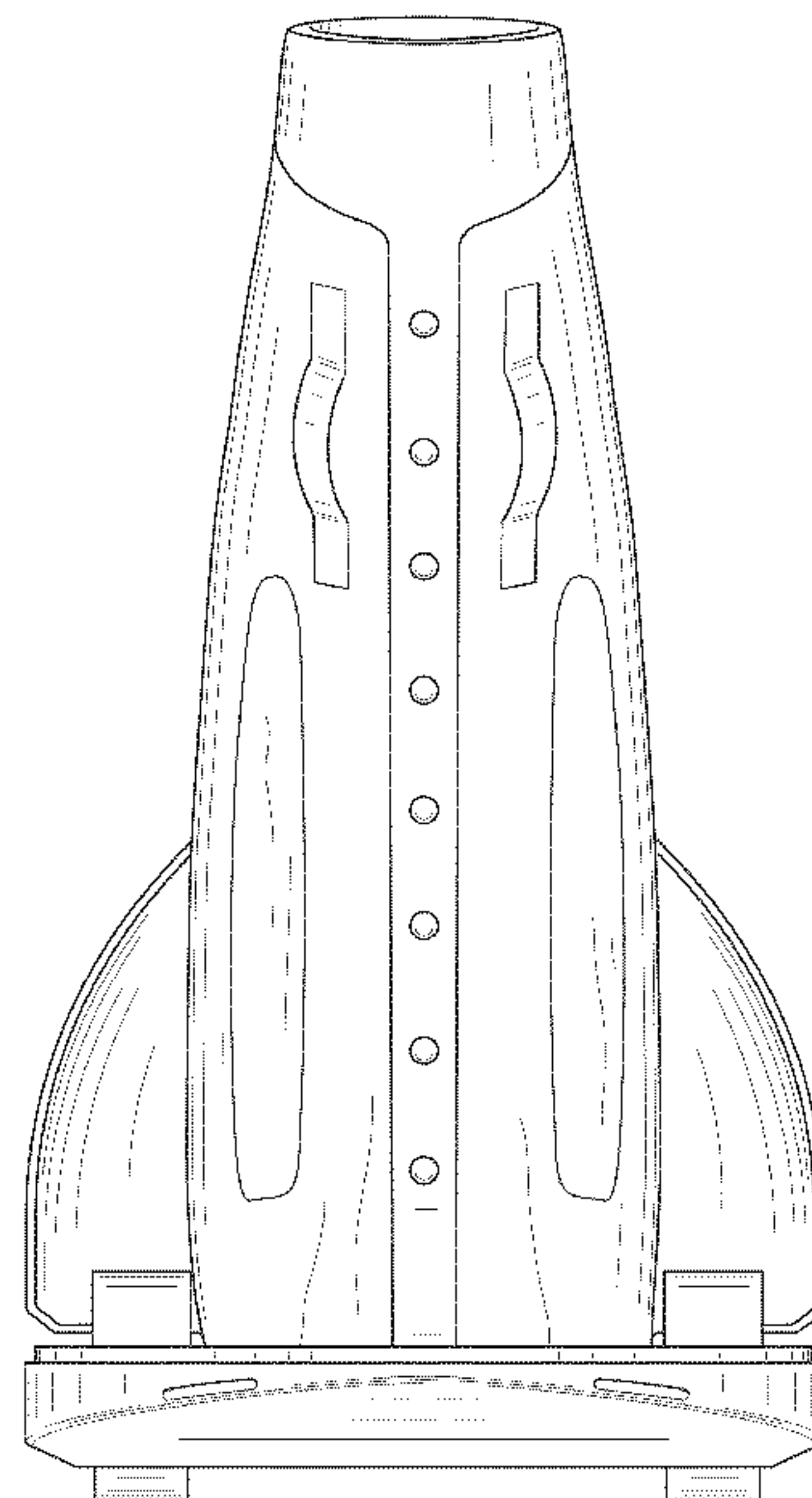
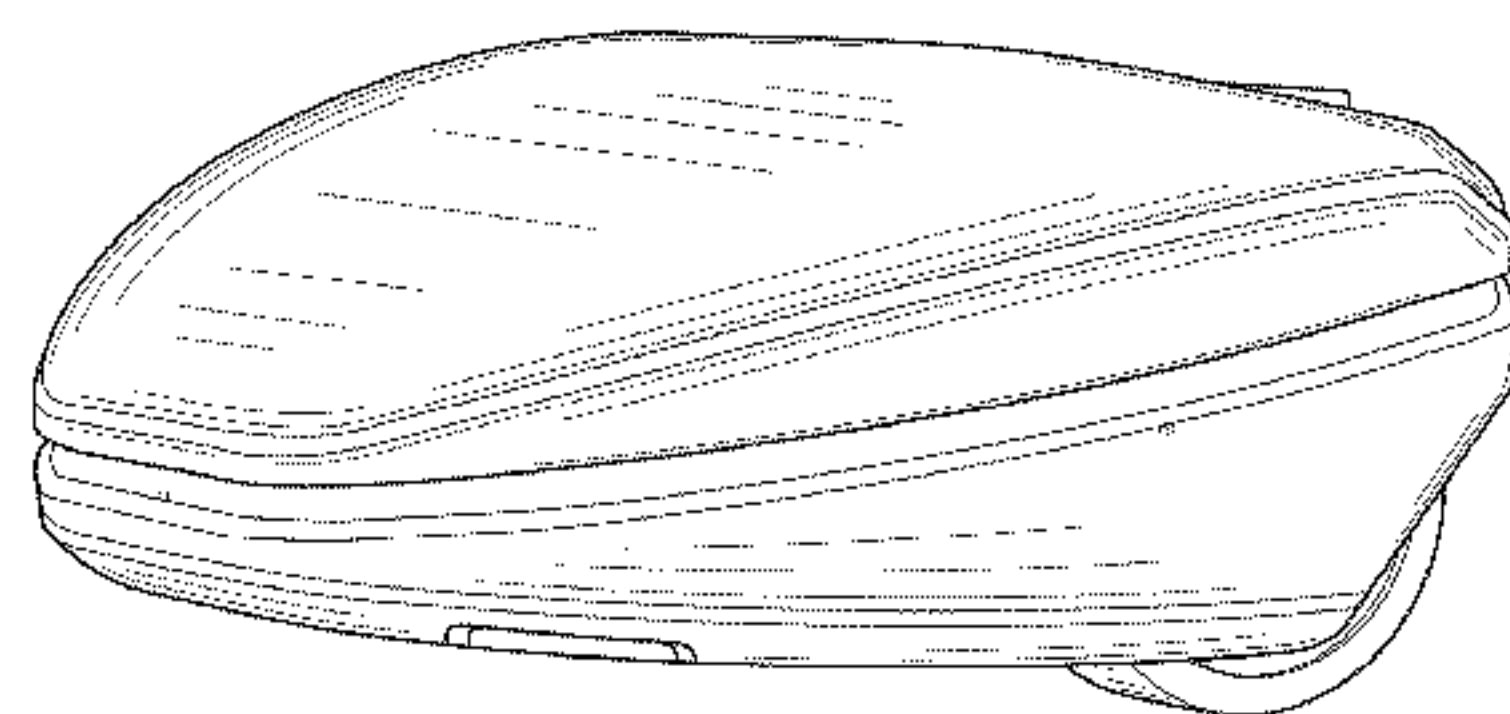
FIG. 6 is another side view of the case for skis and the bag, as shown in FIG. 5;

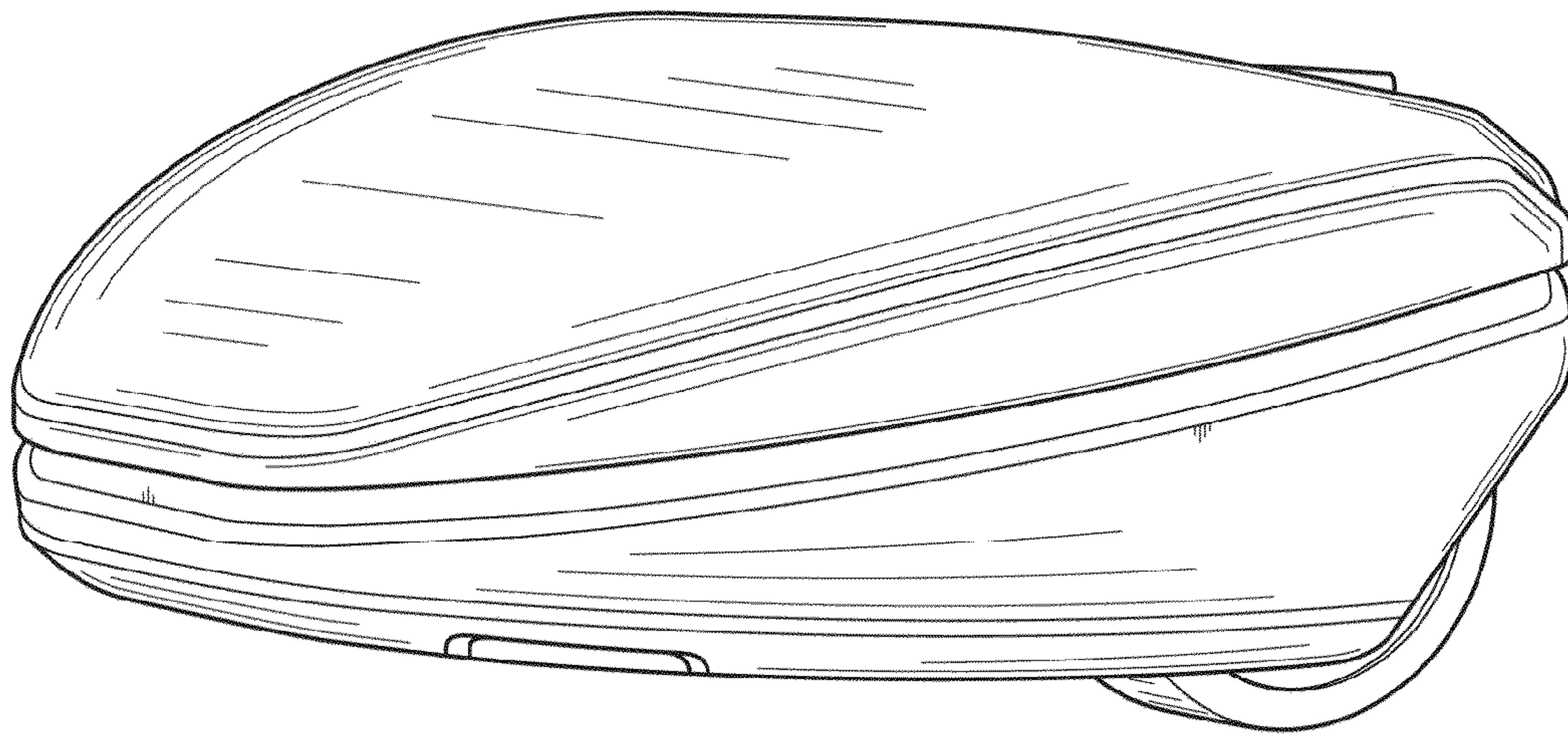

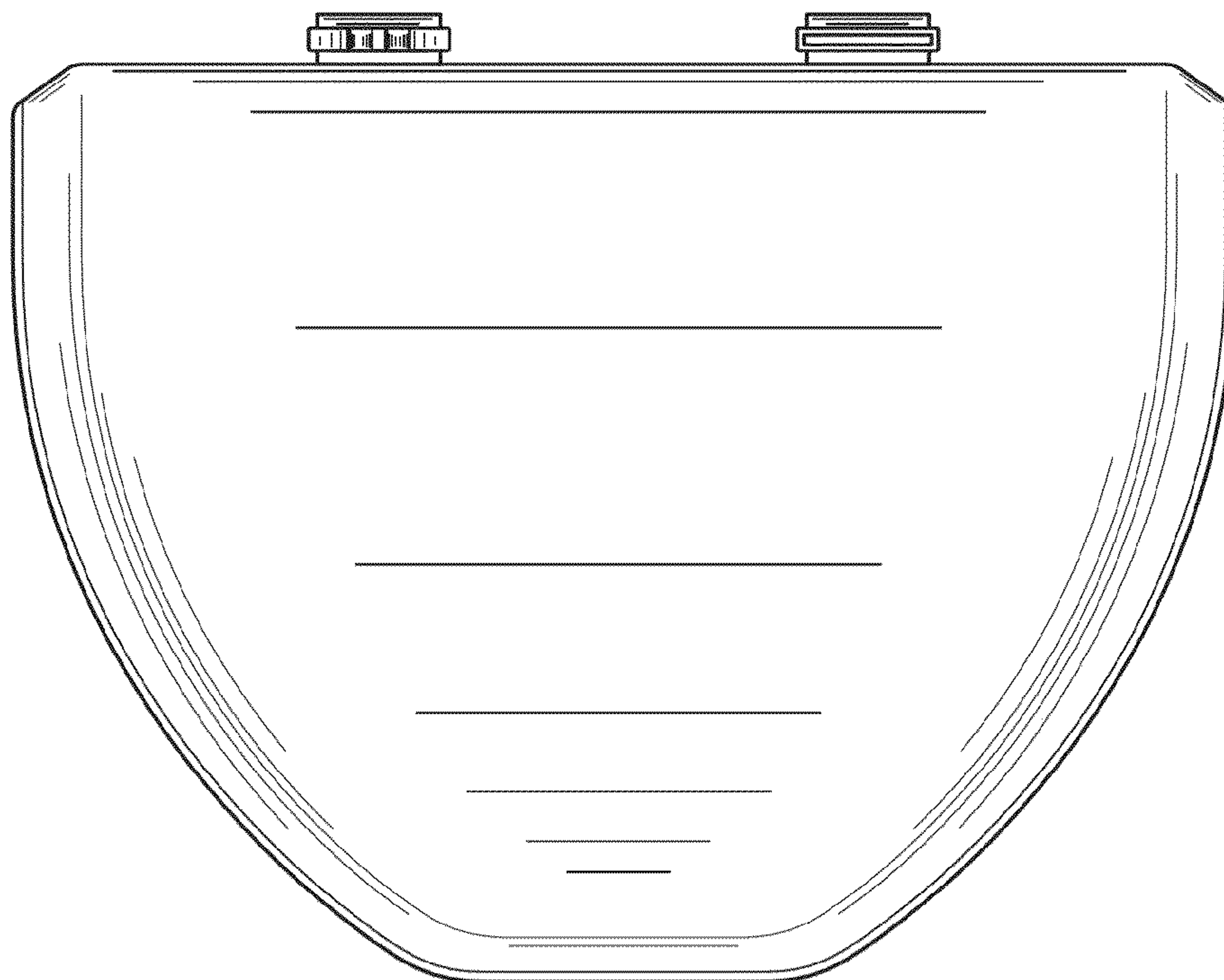

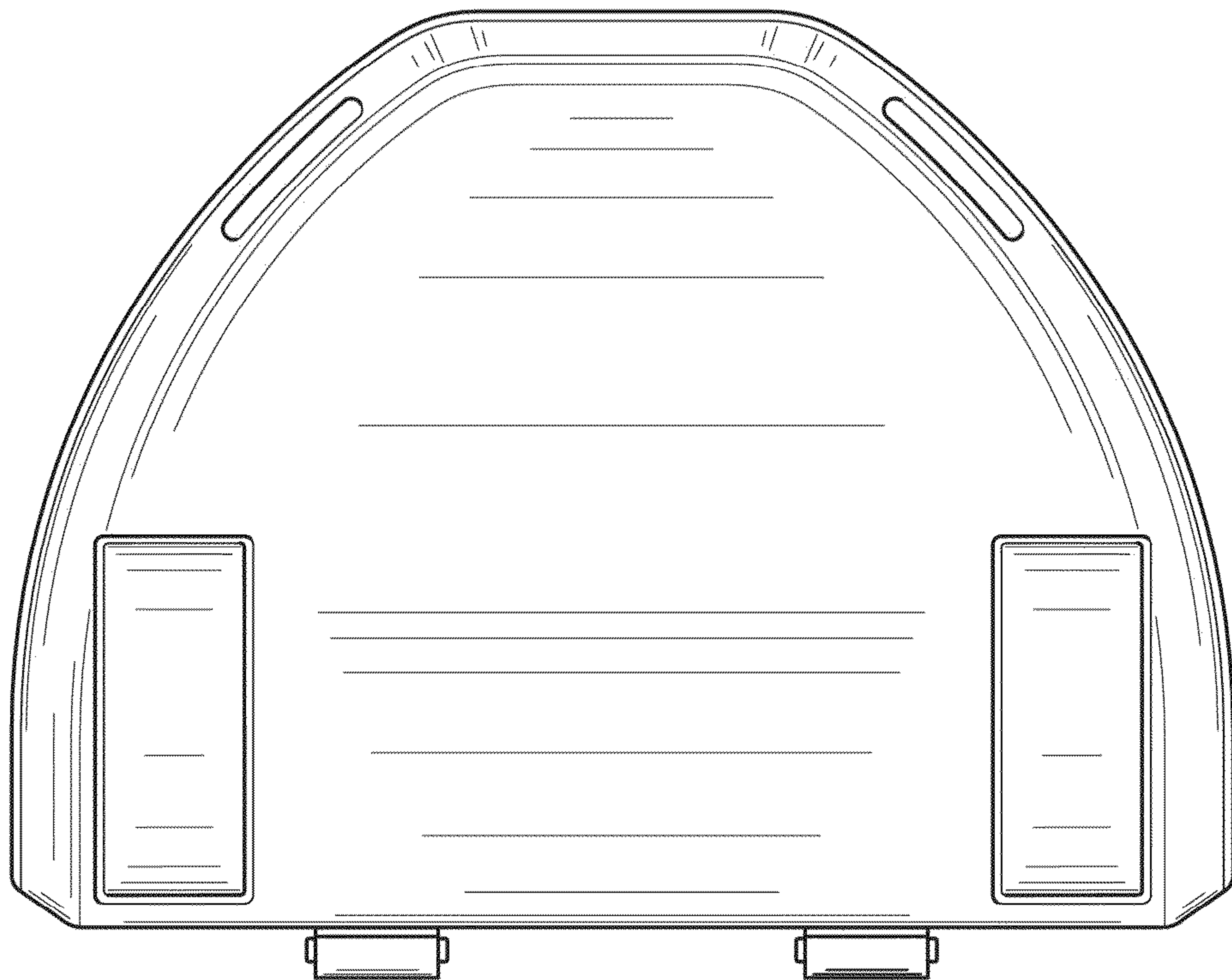

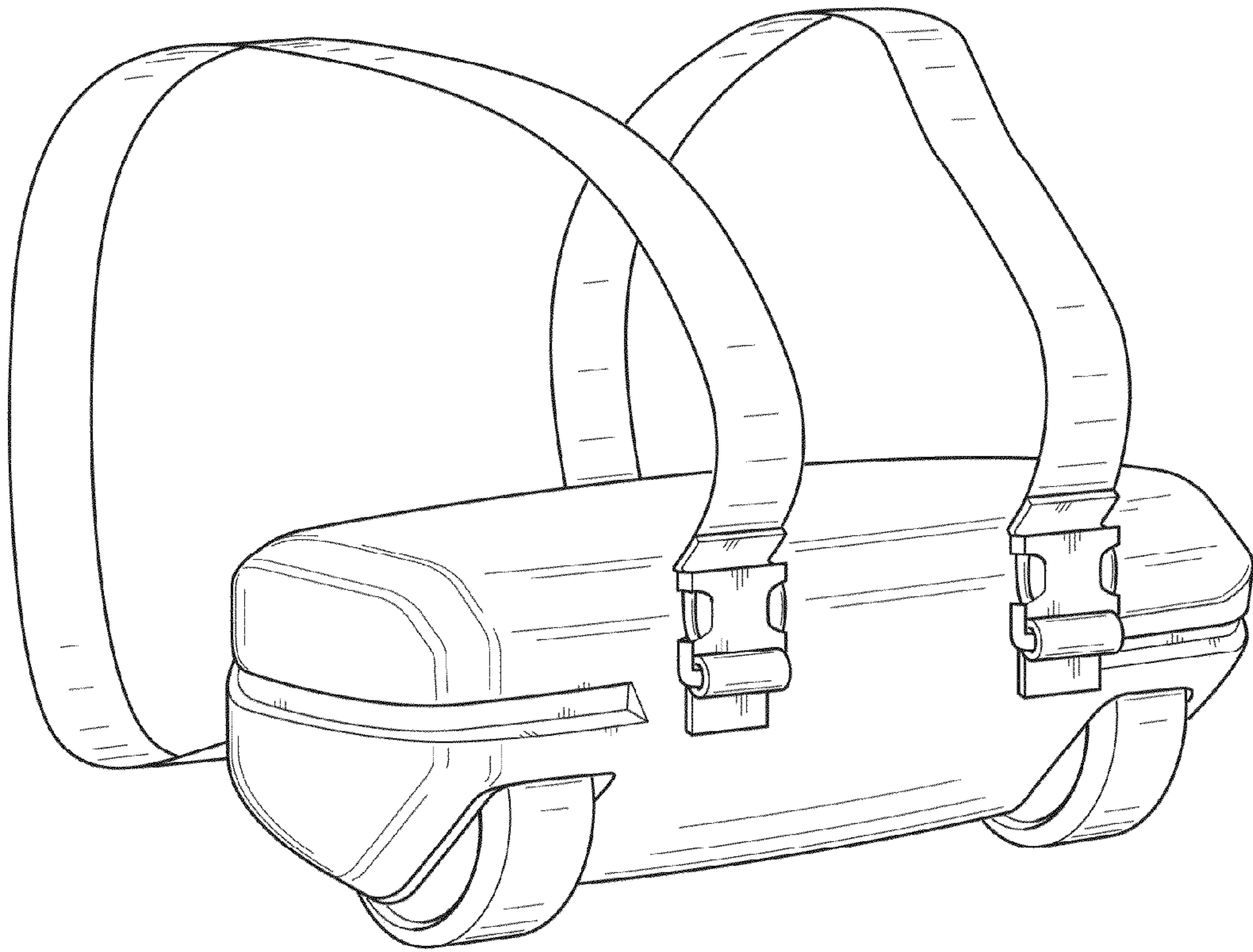

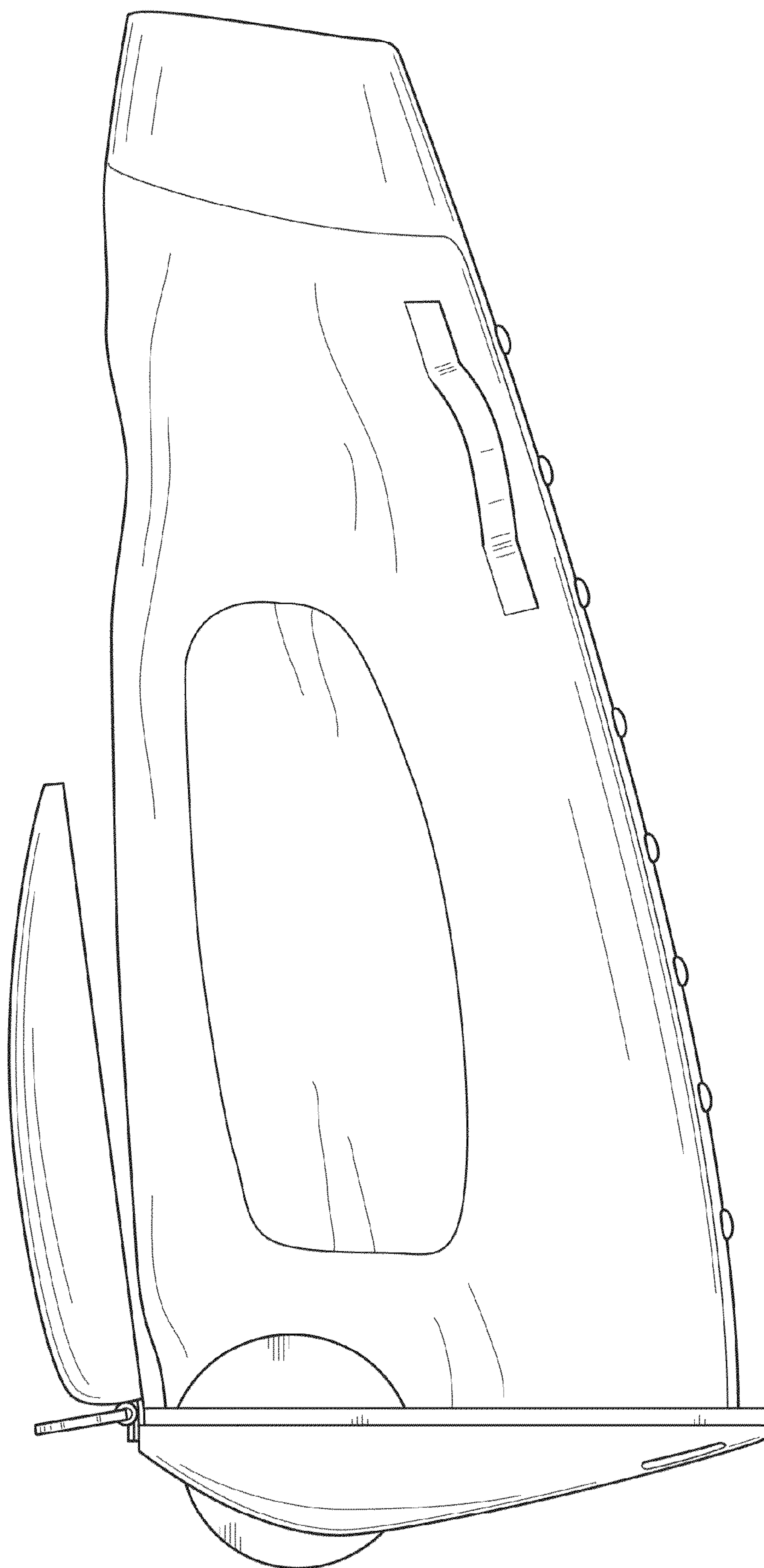

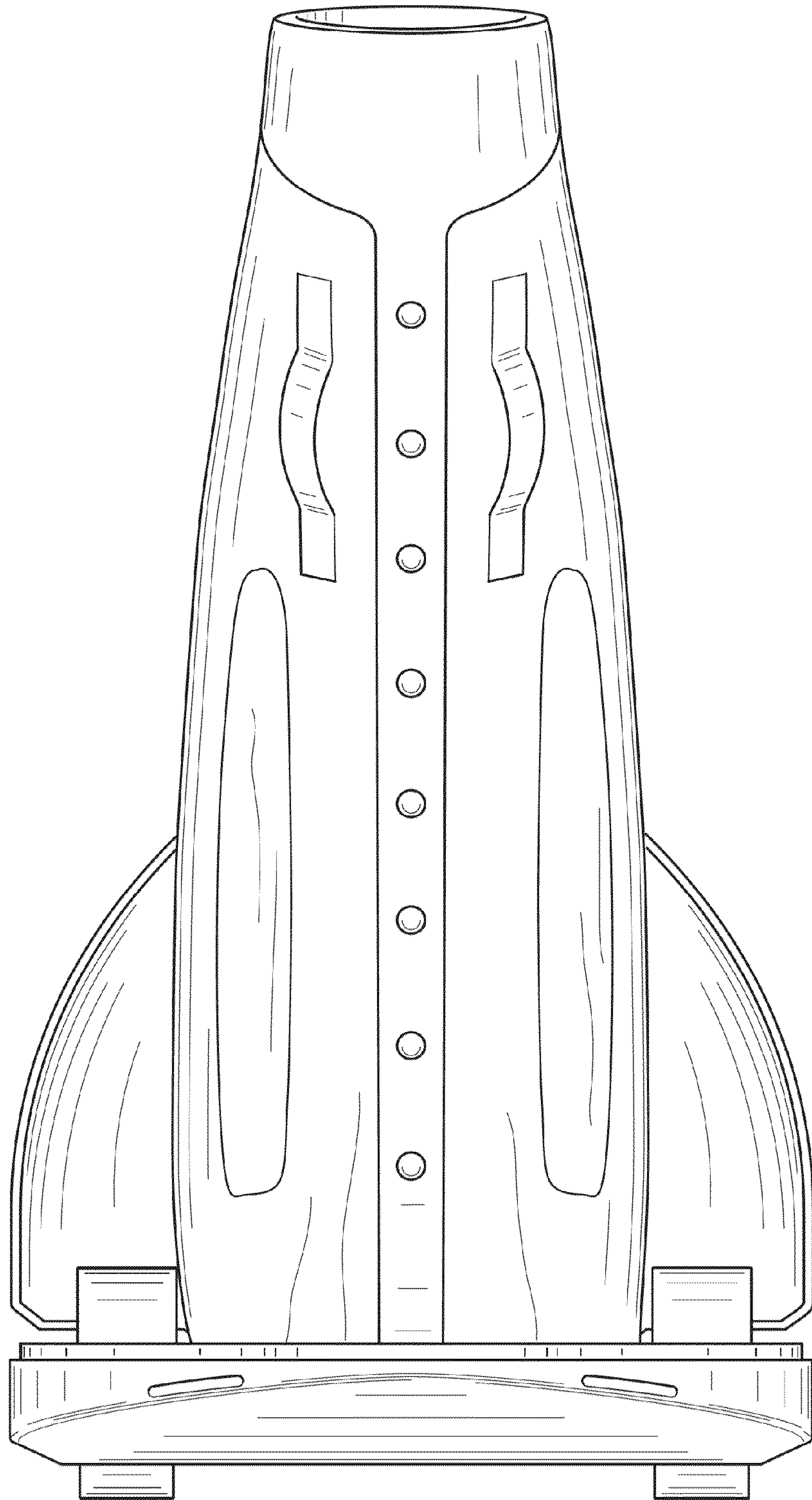

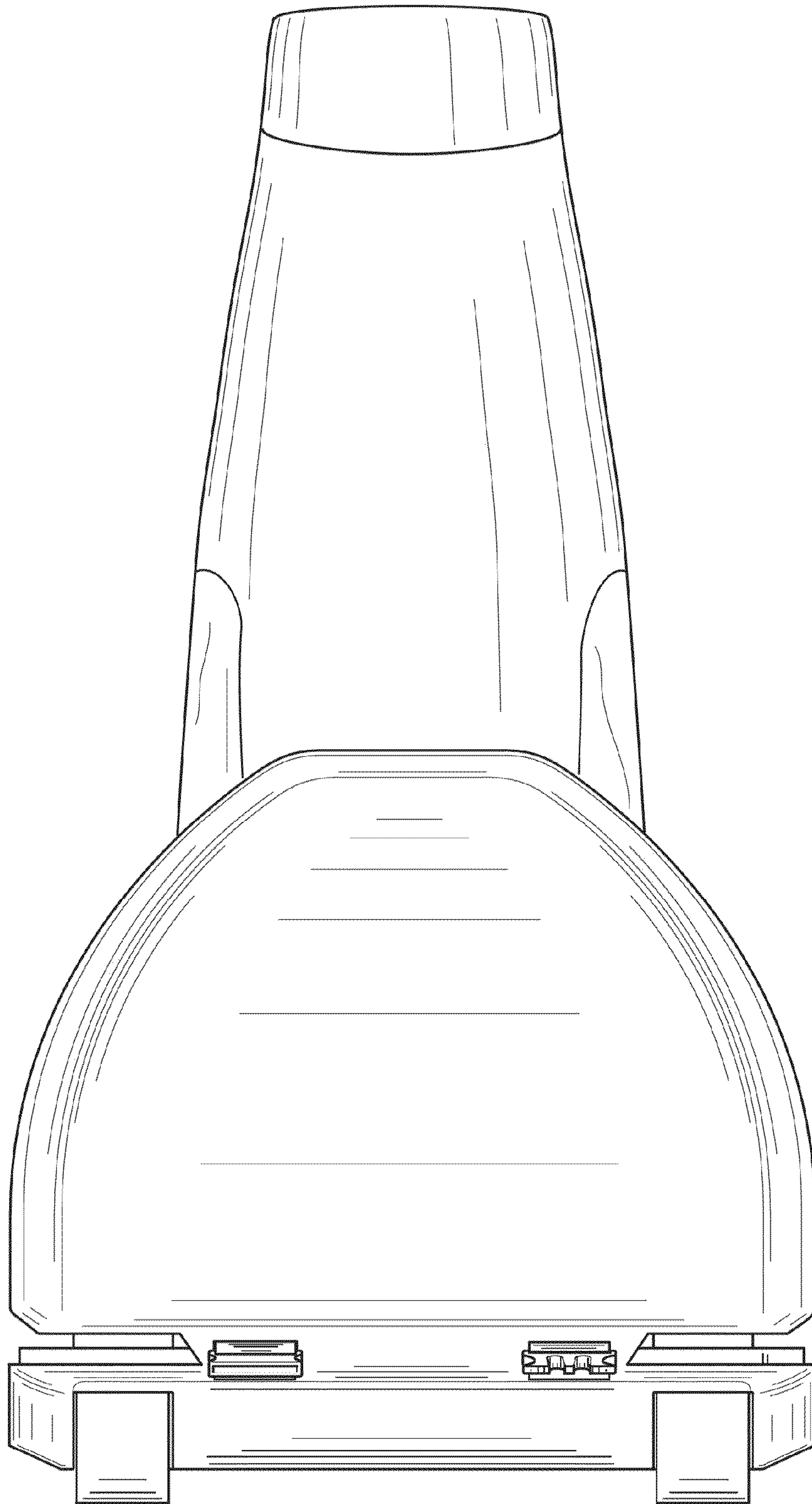

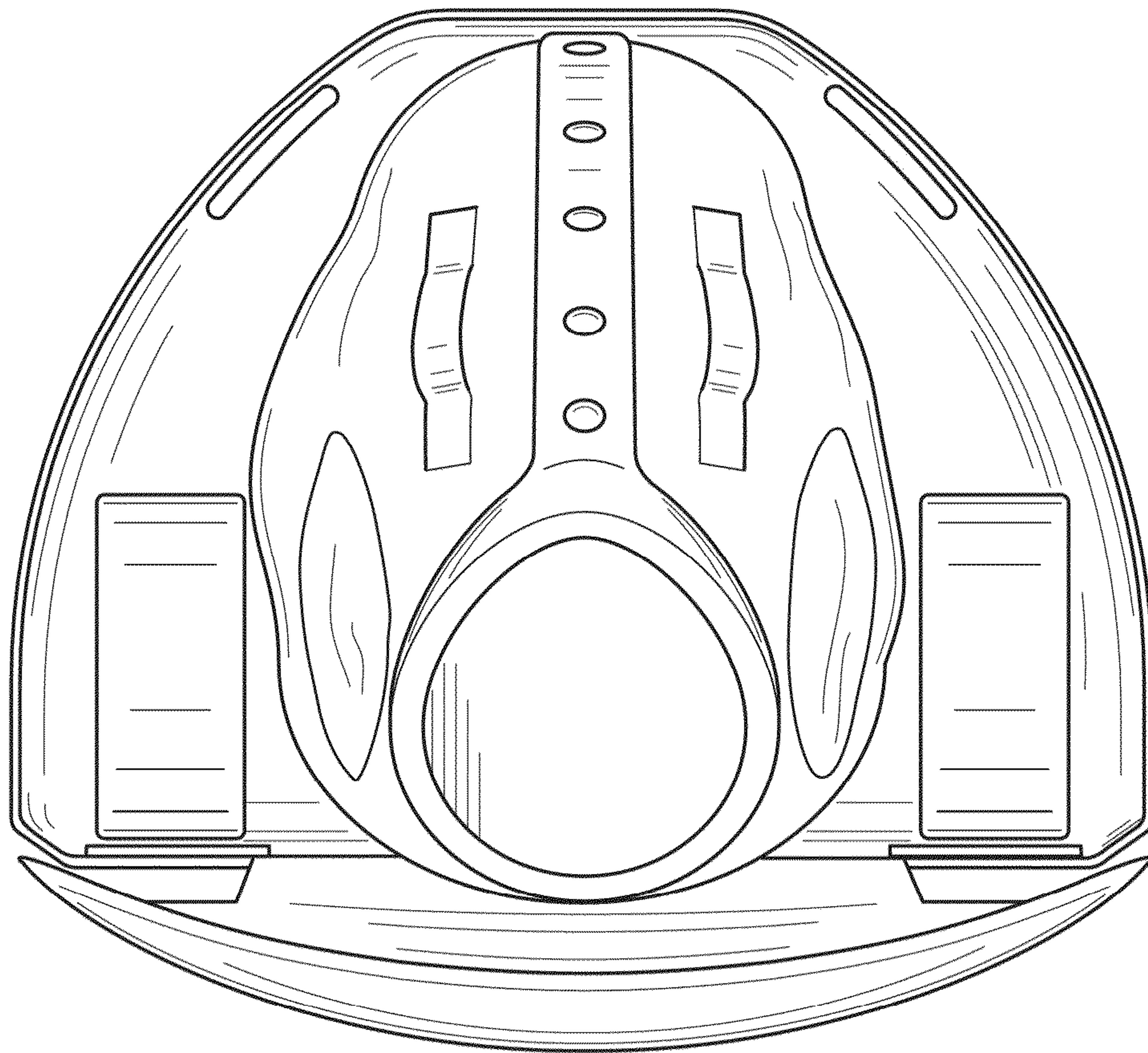
