FIG. 4 is a right side elevation view.

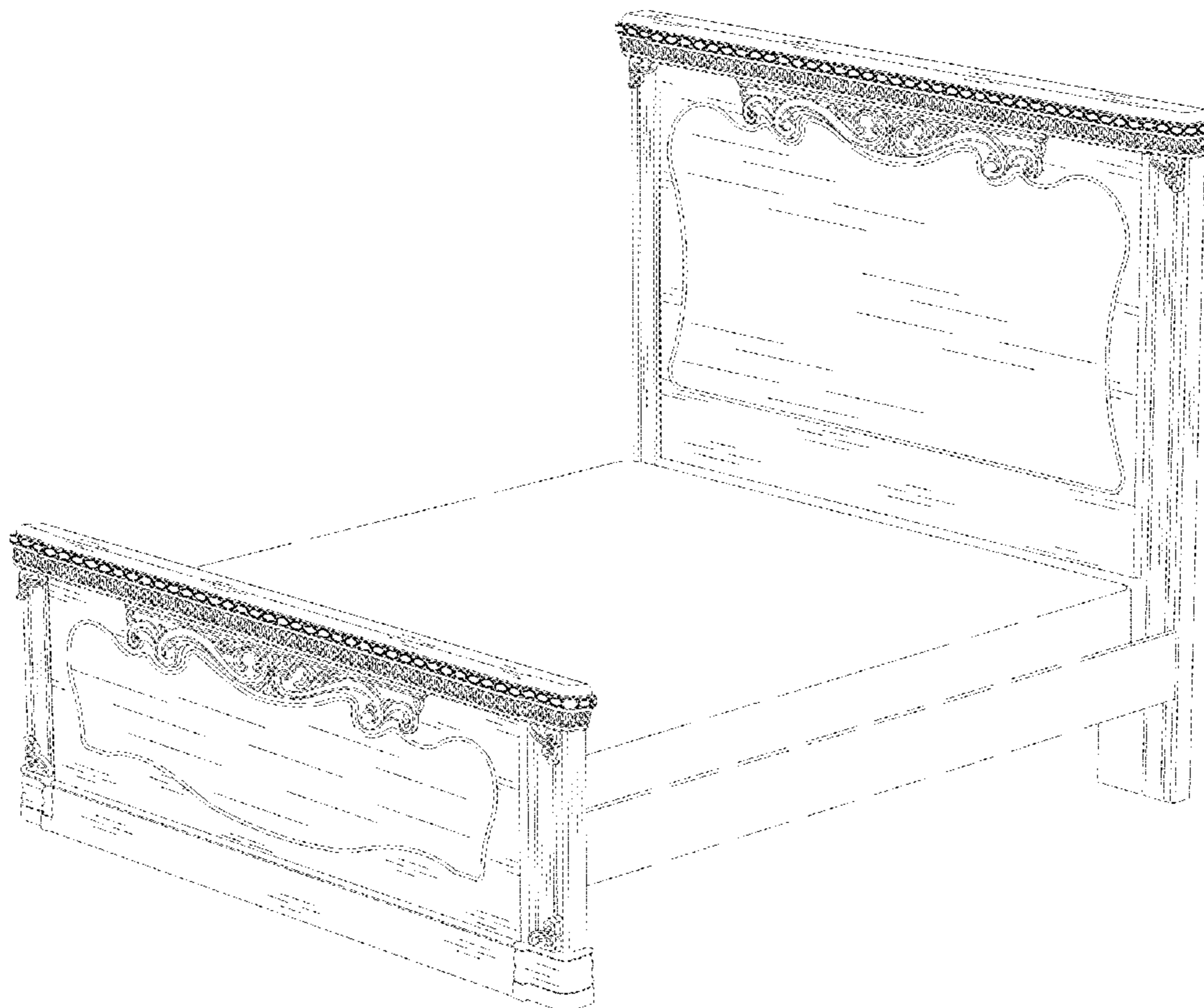

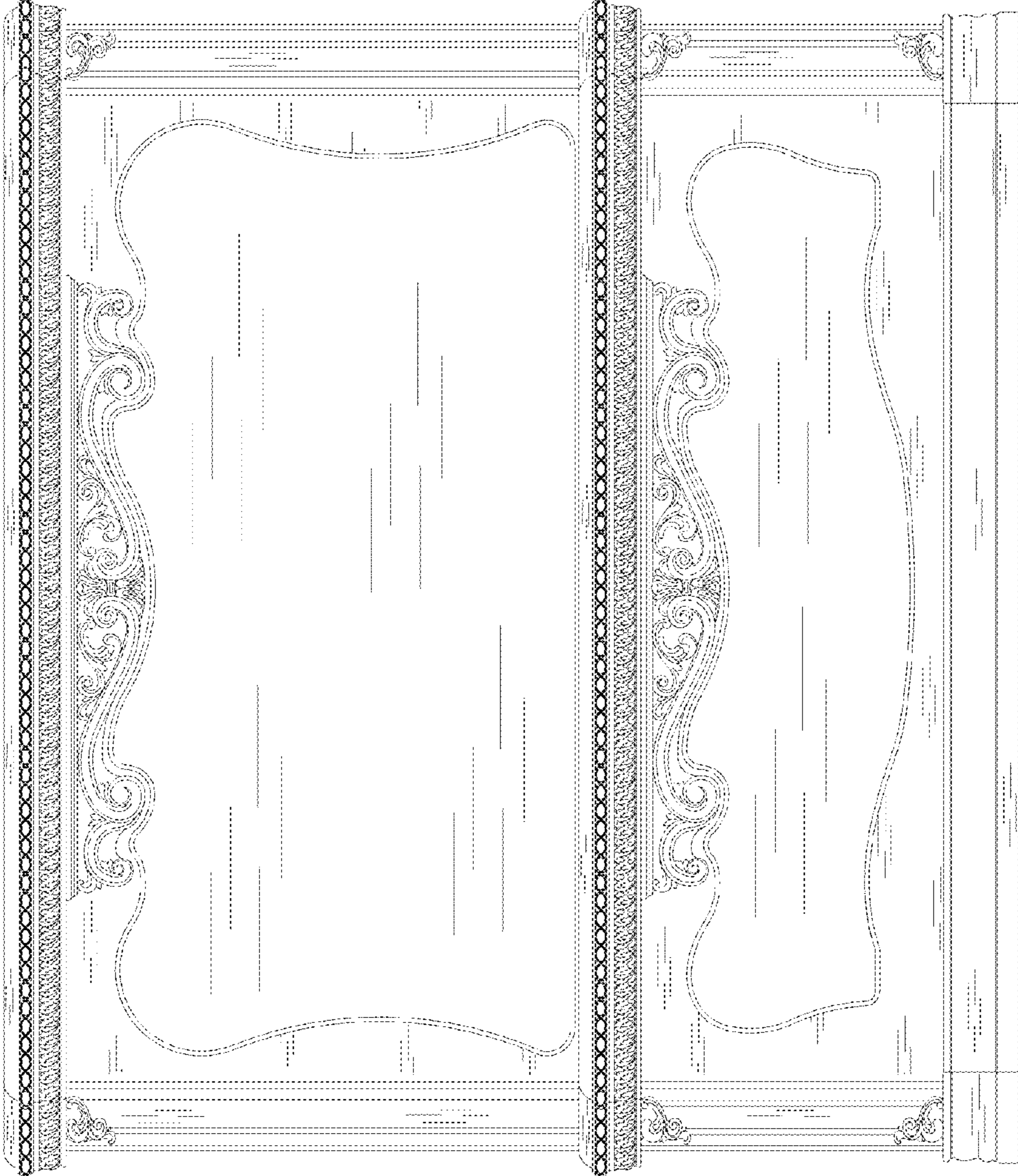

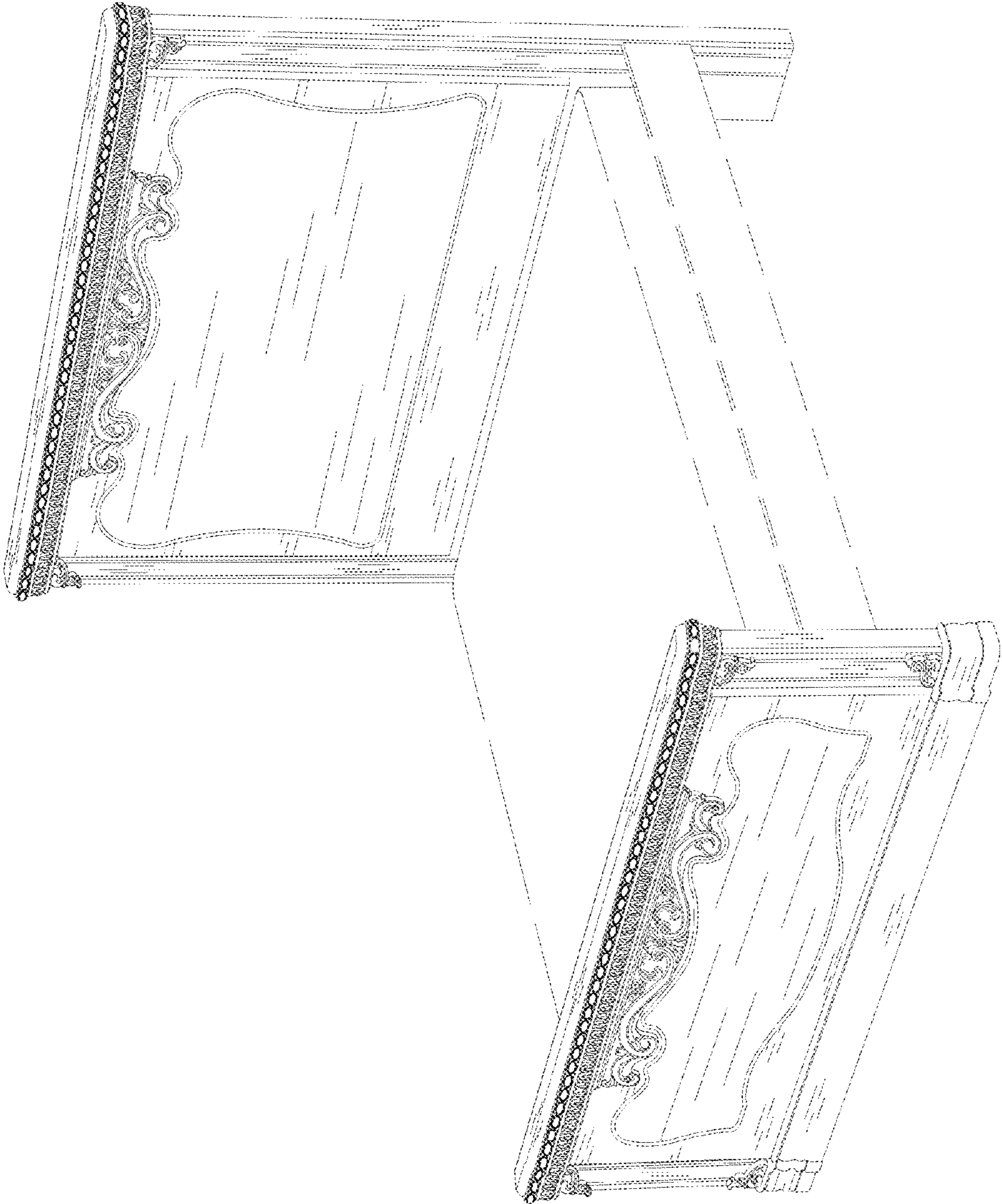

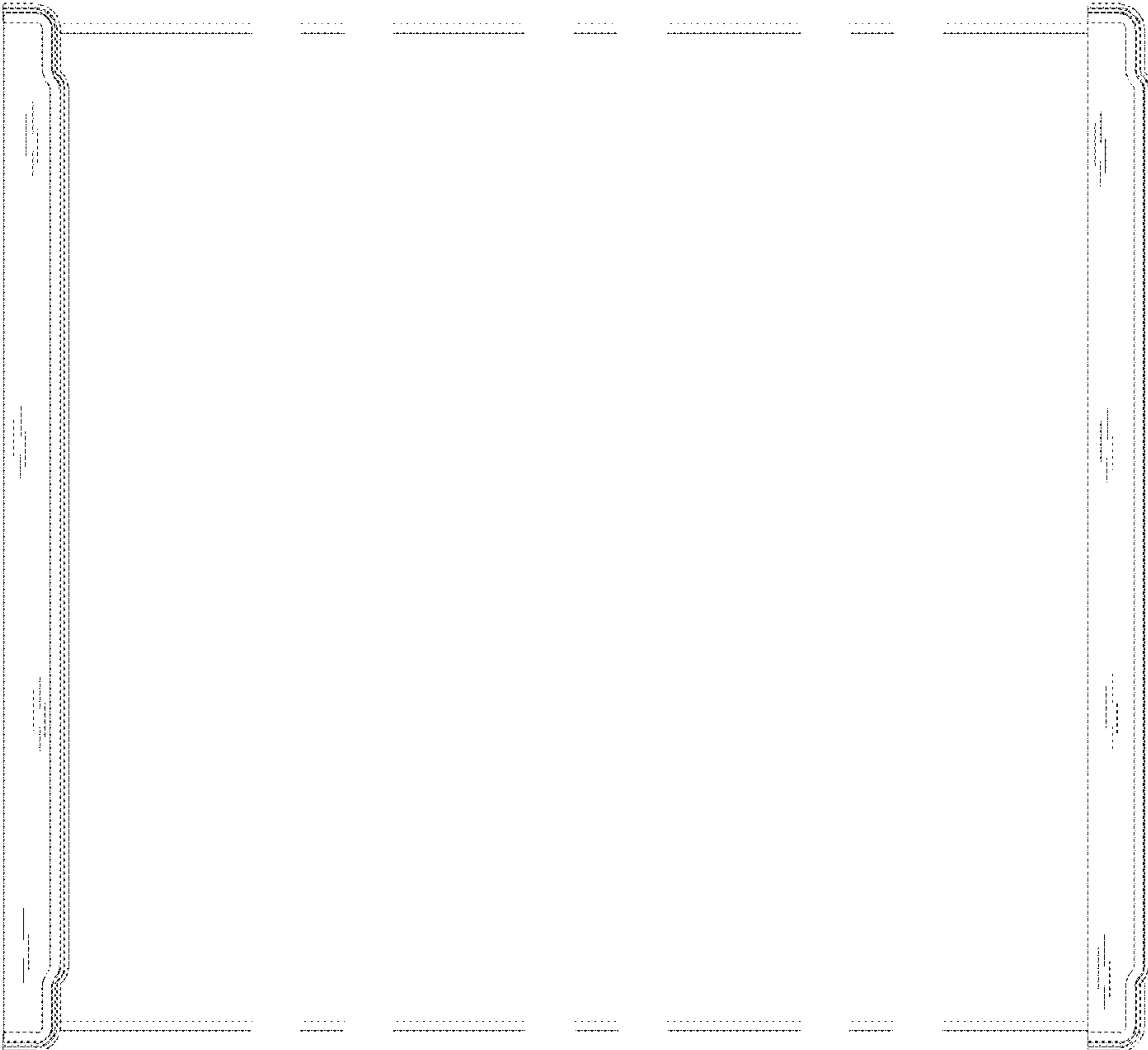

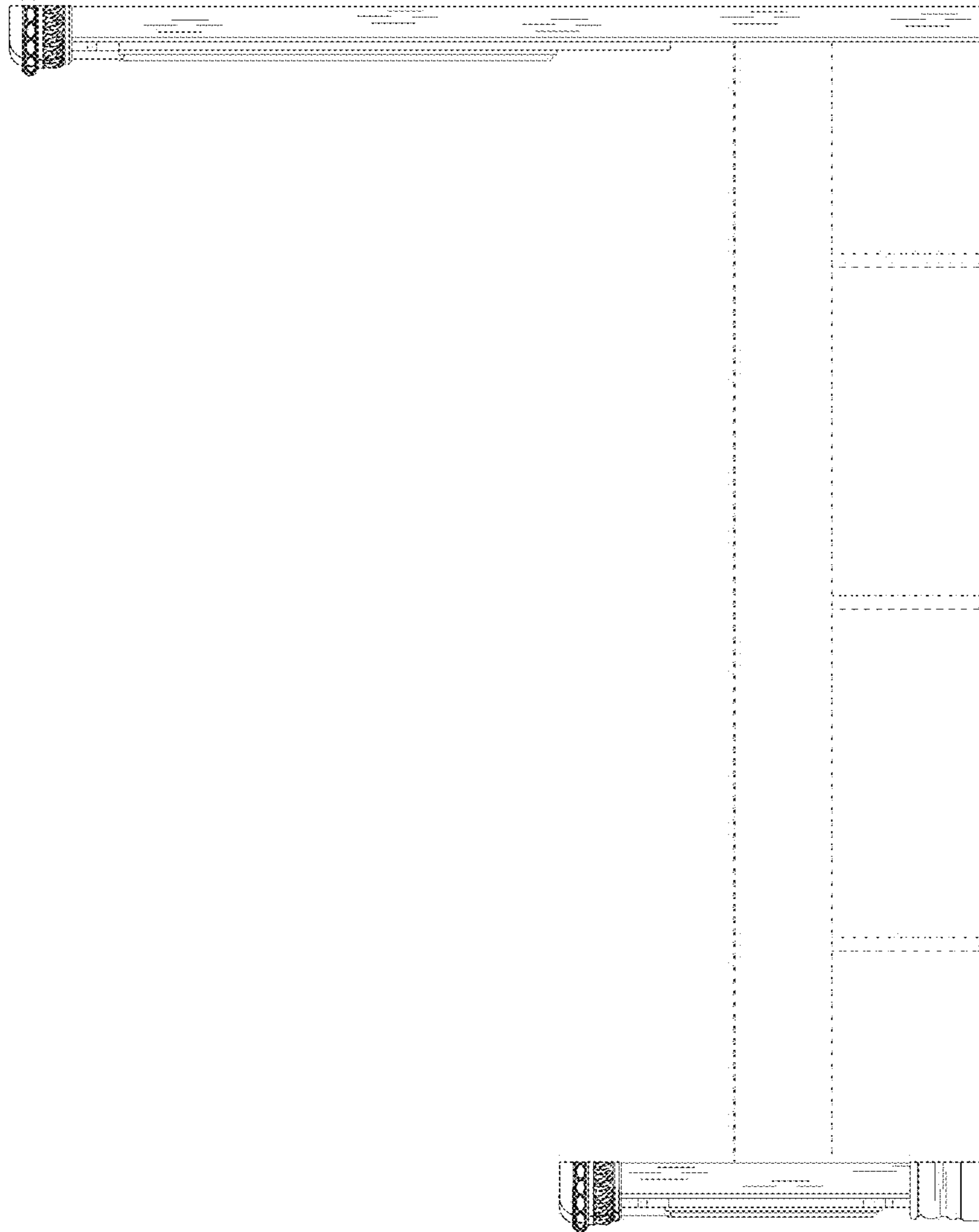
