(57) **CLAIM**

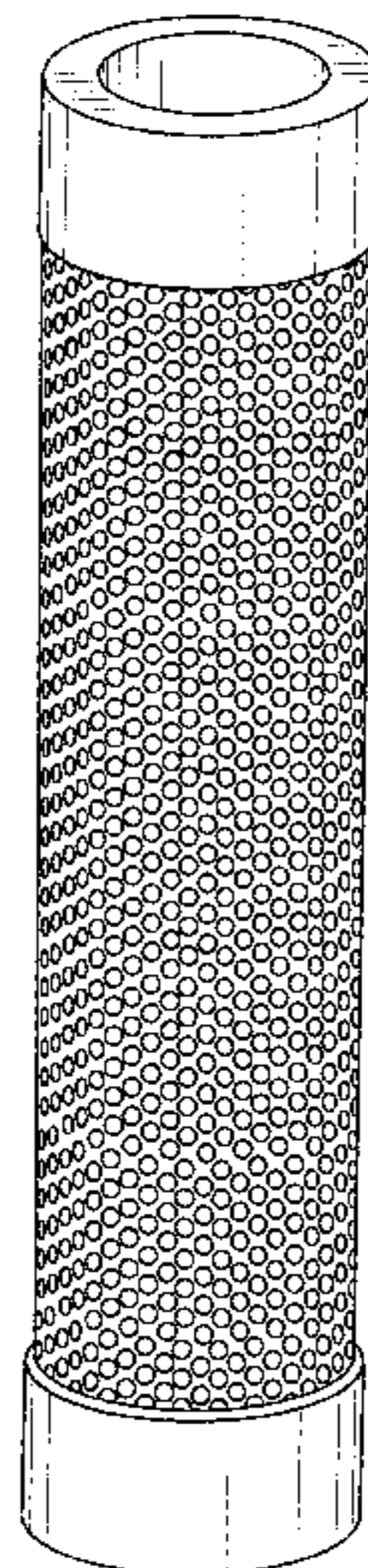
The ornamental design for a tubular smoker device, as shown and described.

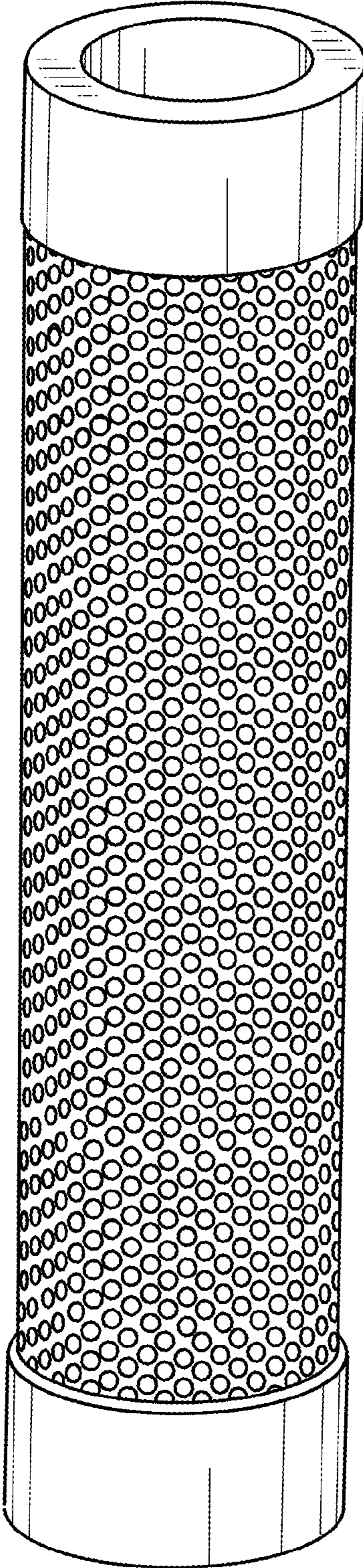

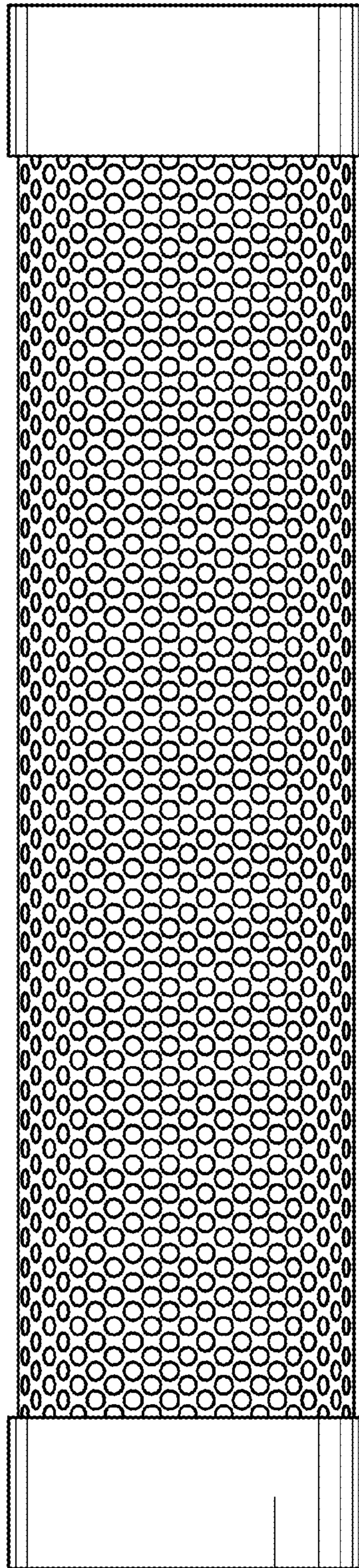

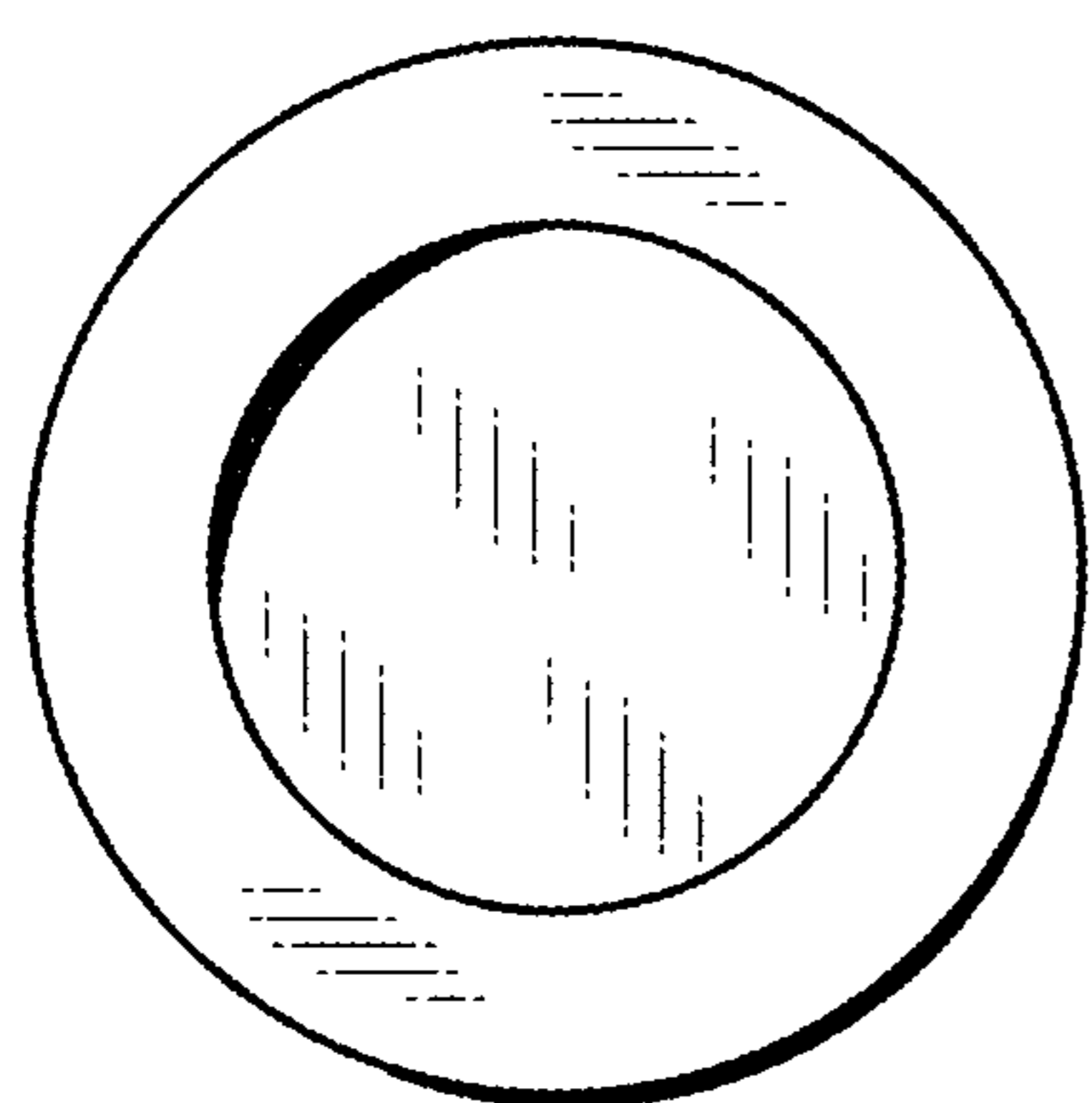

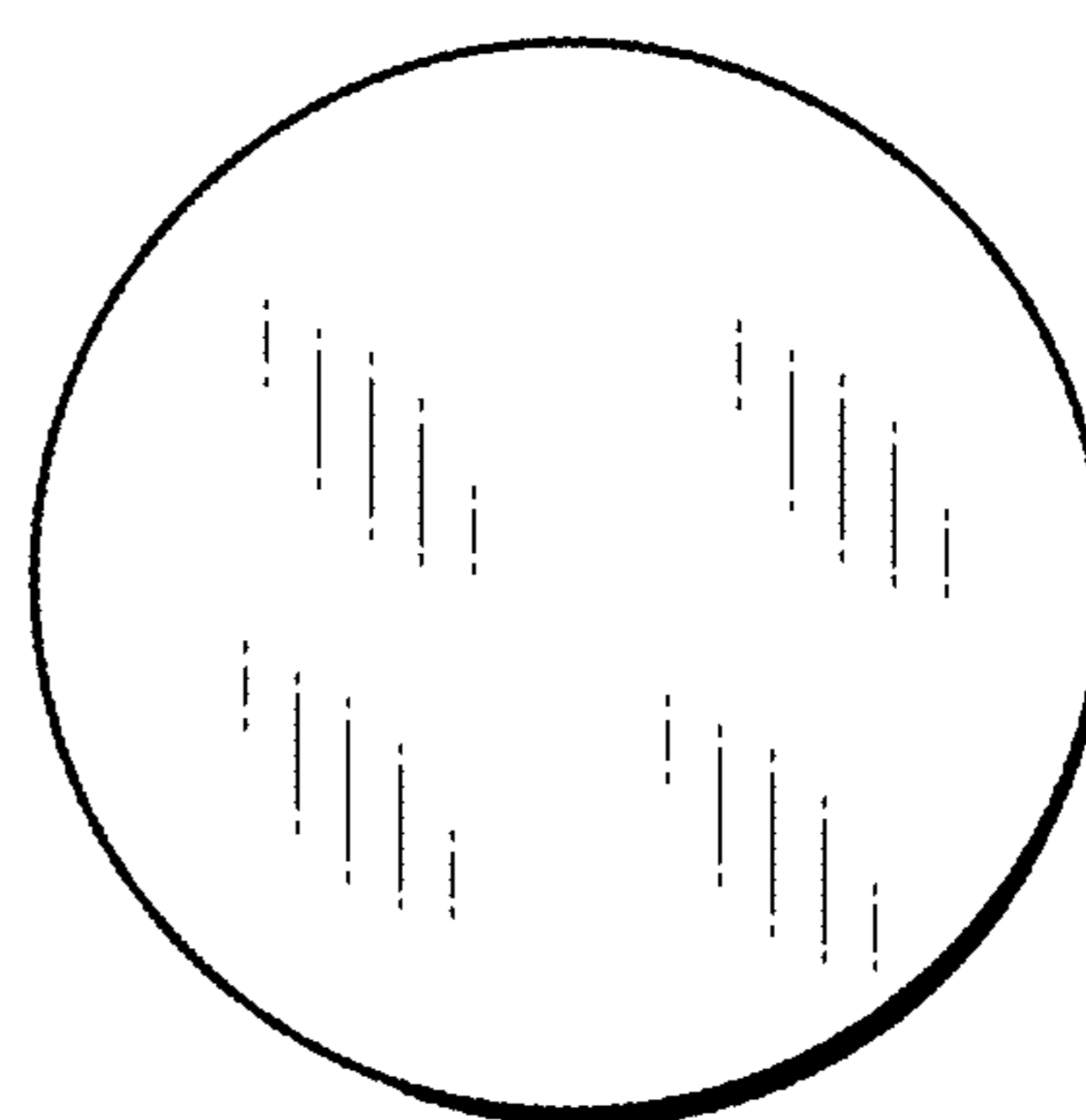
