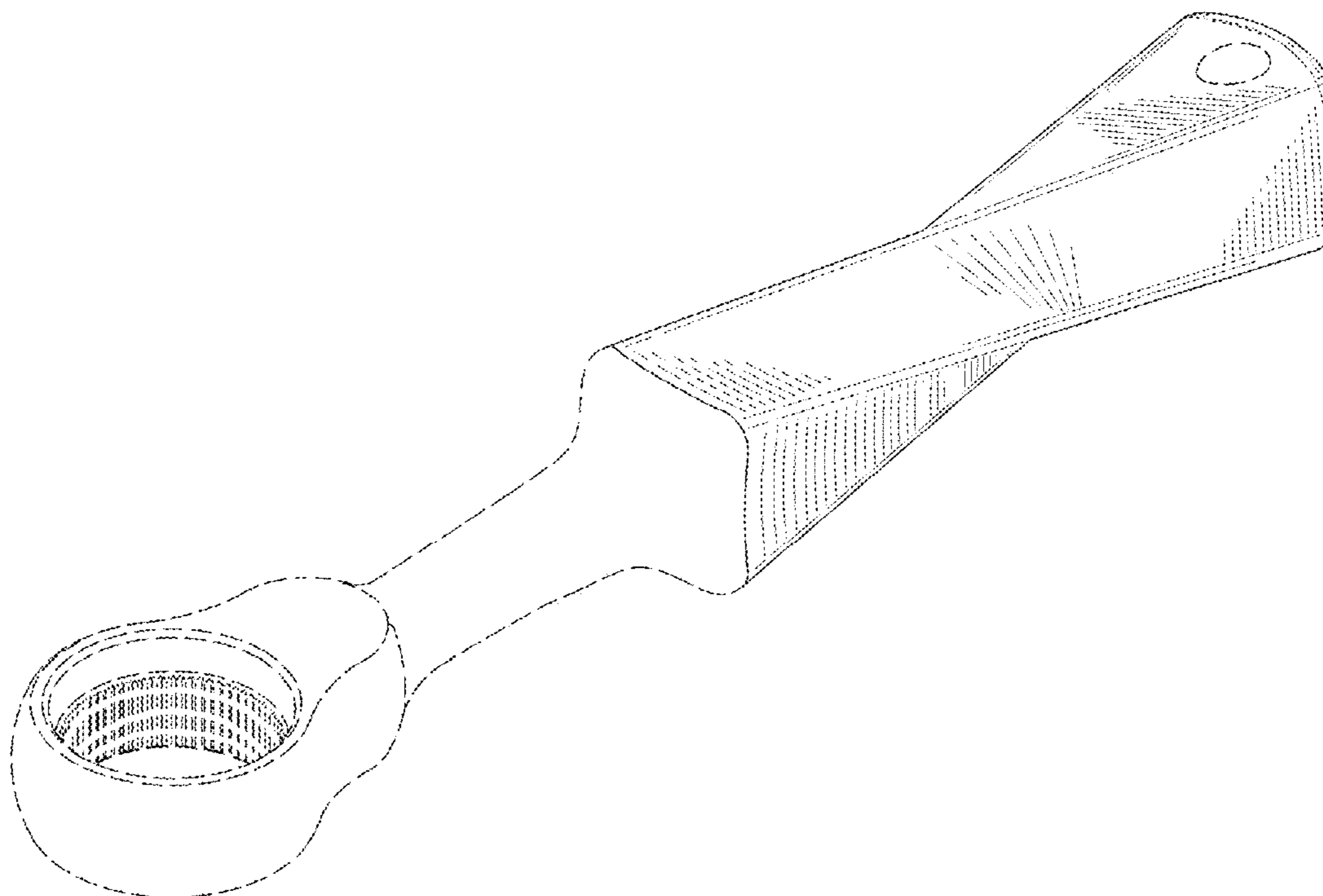
(57) **CLAIM**

The ornamental design for a wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wrench, showing my new design;
FIG. 2 is front view of the wrench shown in FIG. 1;
FIG. 3 is a rear view of the wrench shown in FIG. 1;
FIG. 4 is a left side view of the wrench shown in FIG. 1;
FIG. 5 is a right side view of the wrench shown in FIG. 1;

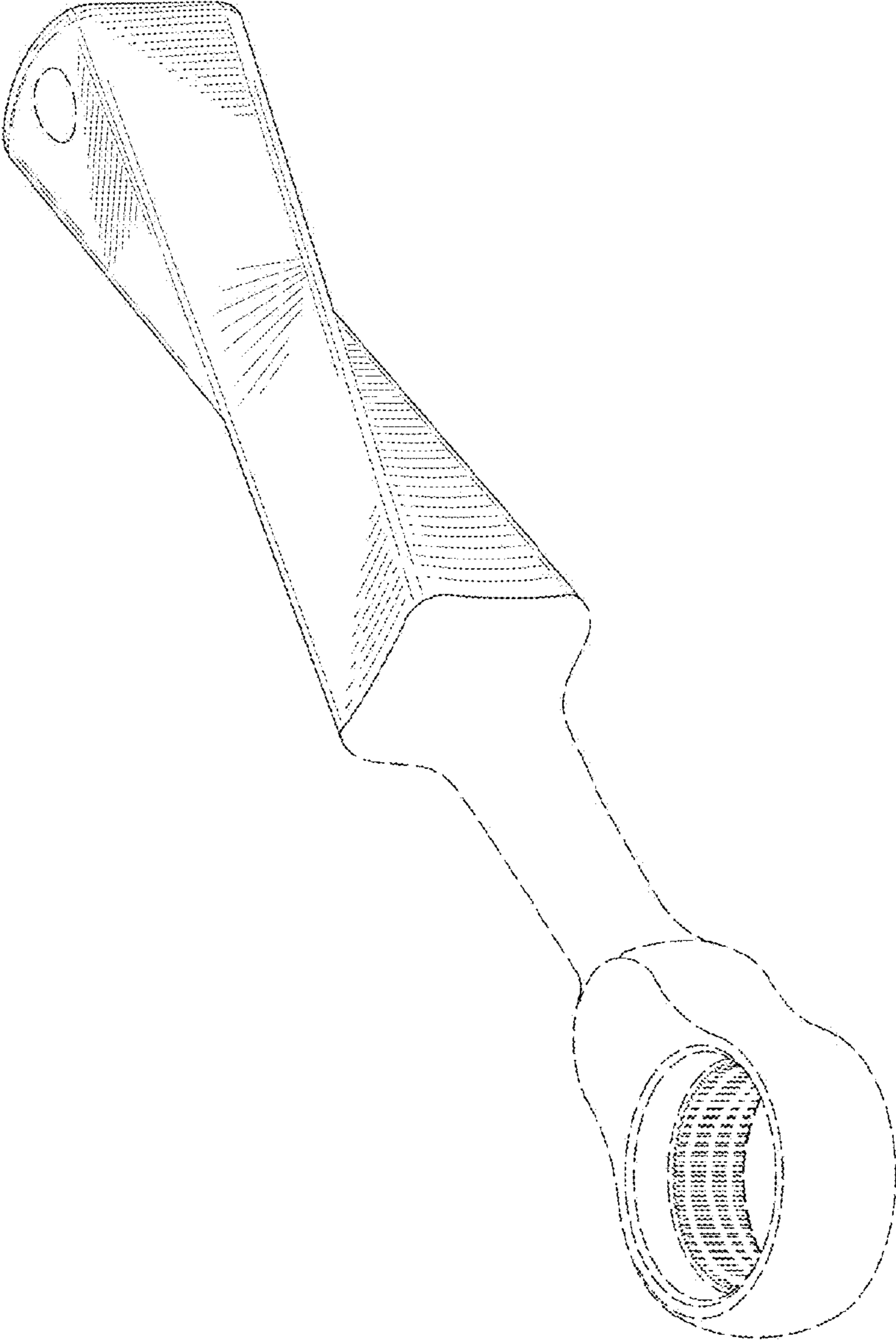

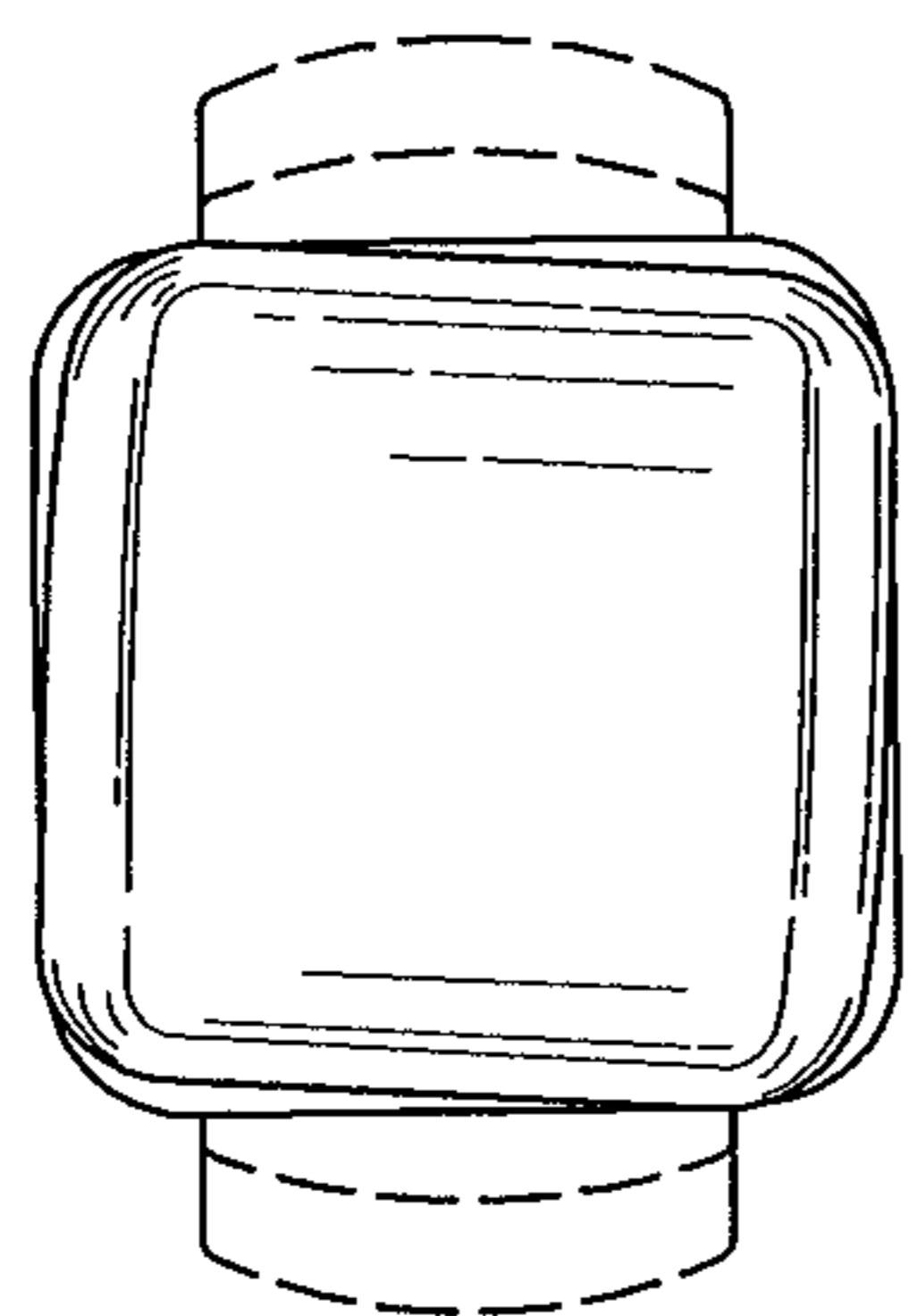

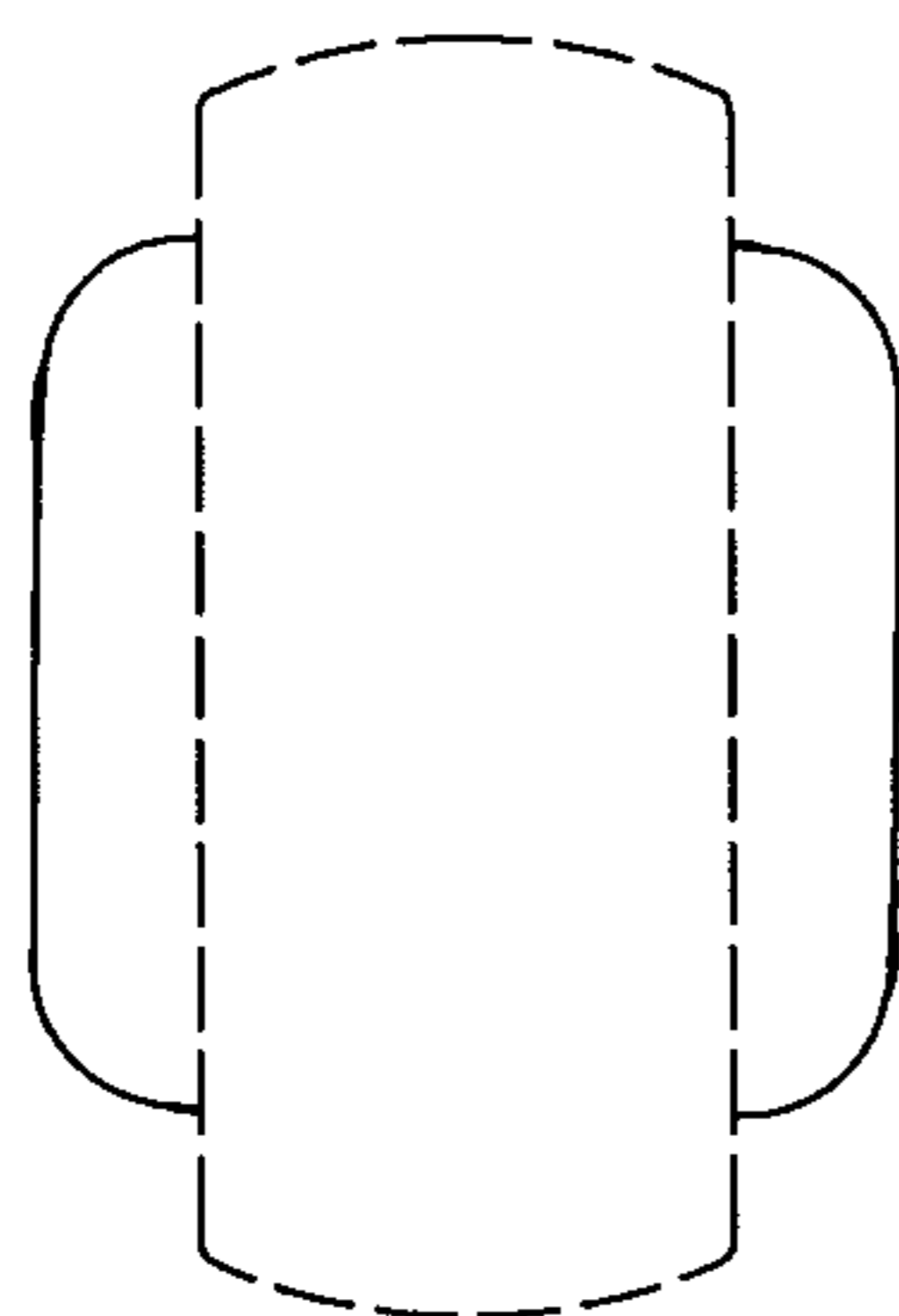

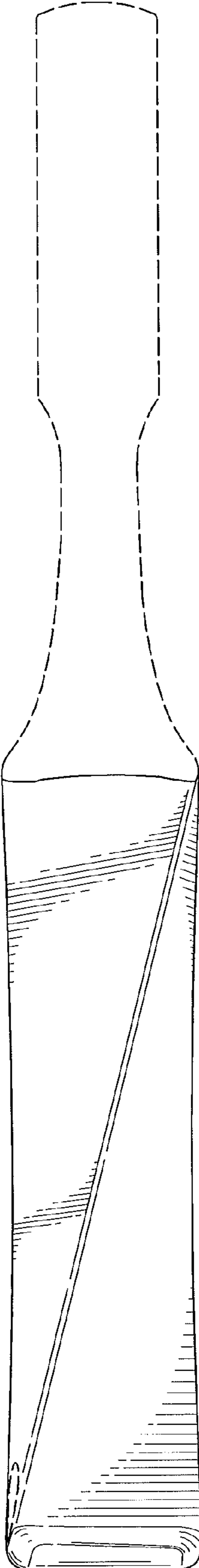

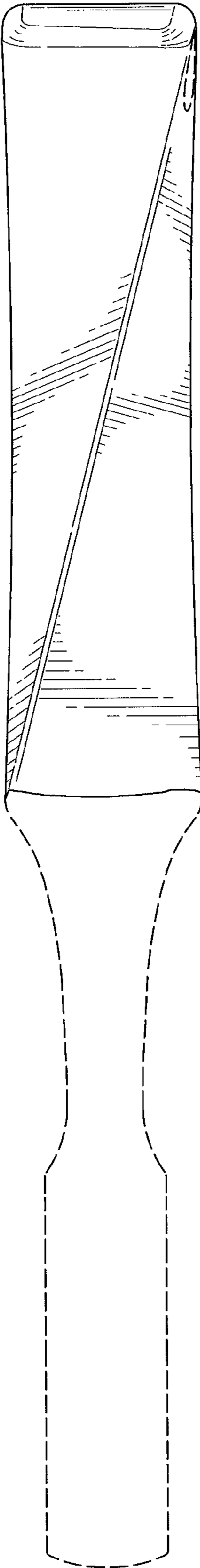

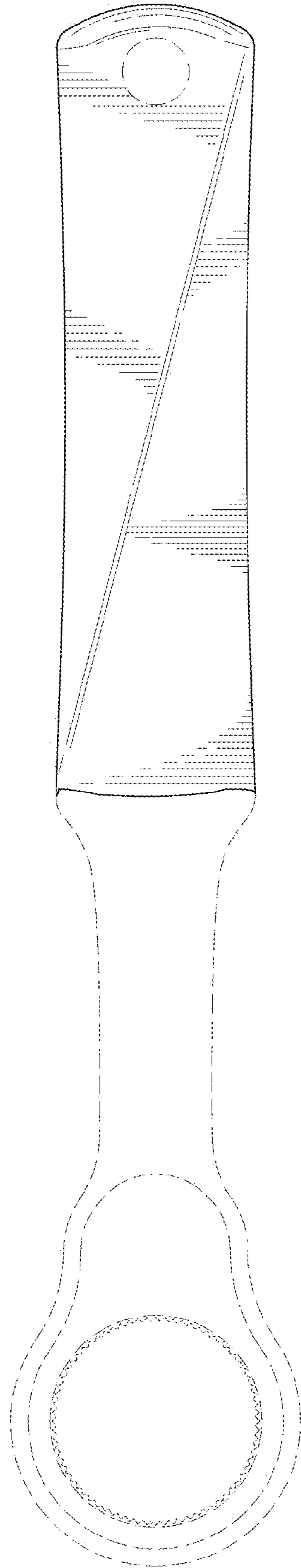

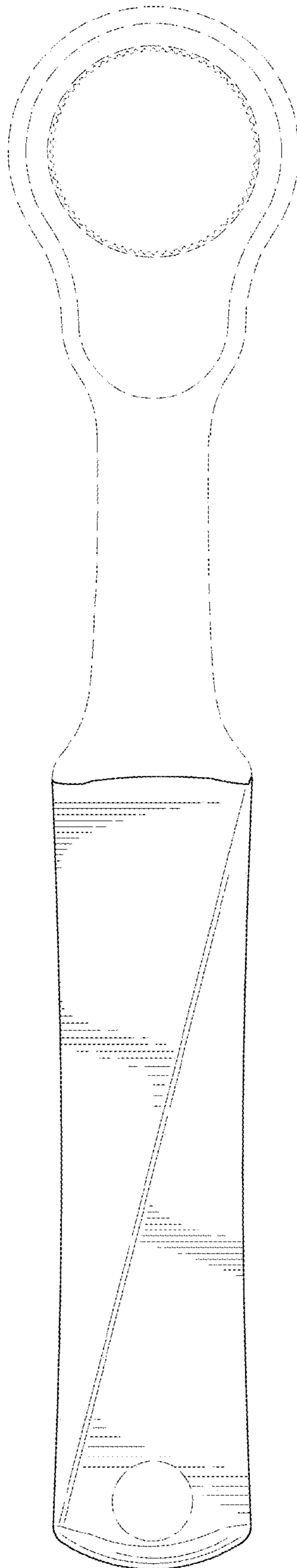
