The ornamental design for a battery module base, as shown and described.

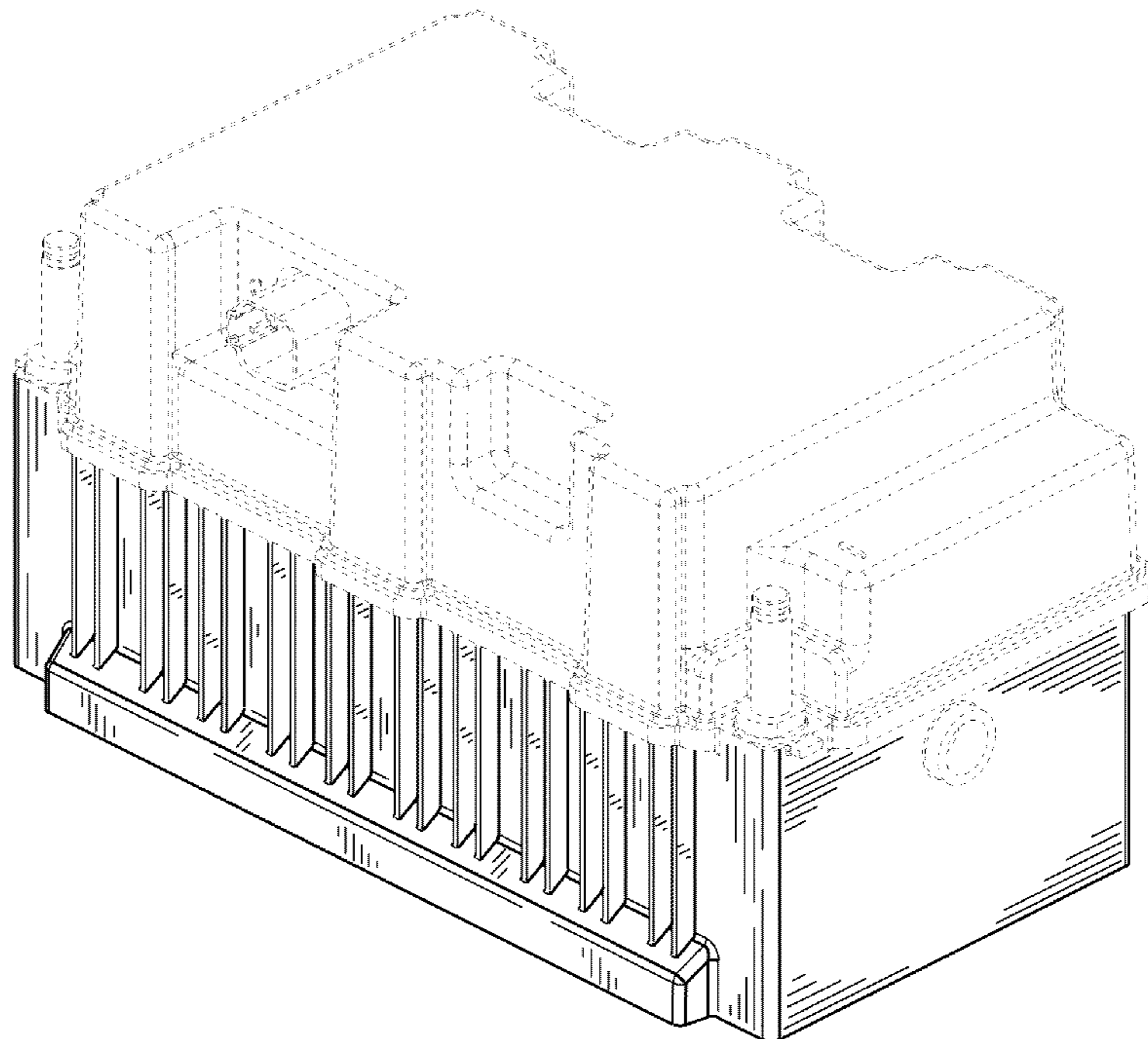
DESCRIPTION

FIG. 1 is a front top perspective view of an embodiment of the design for the battery module base;

 FIG. 4 is a right side elevational view of the embodiment set forth in FIG. 1;

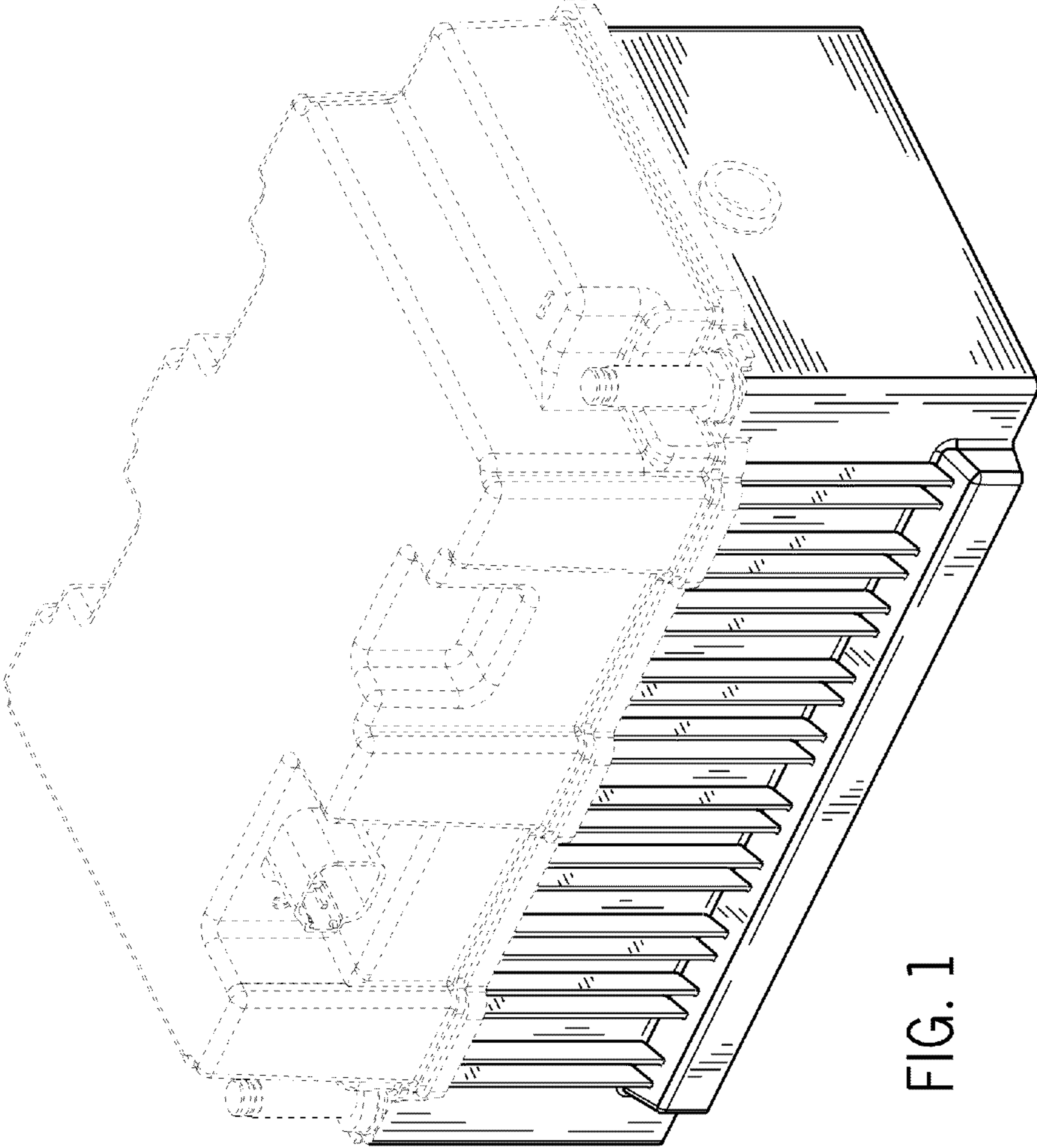

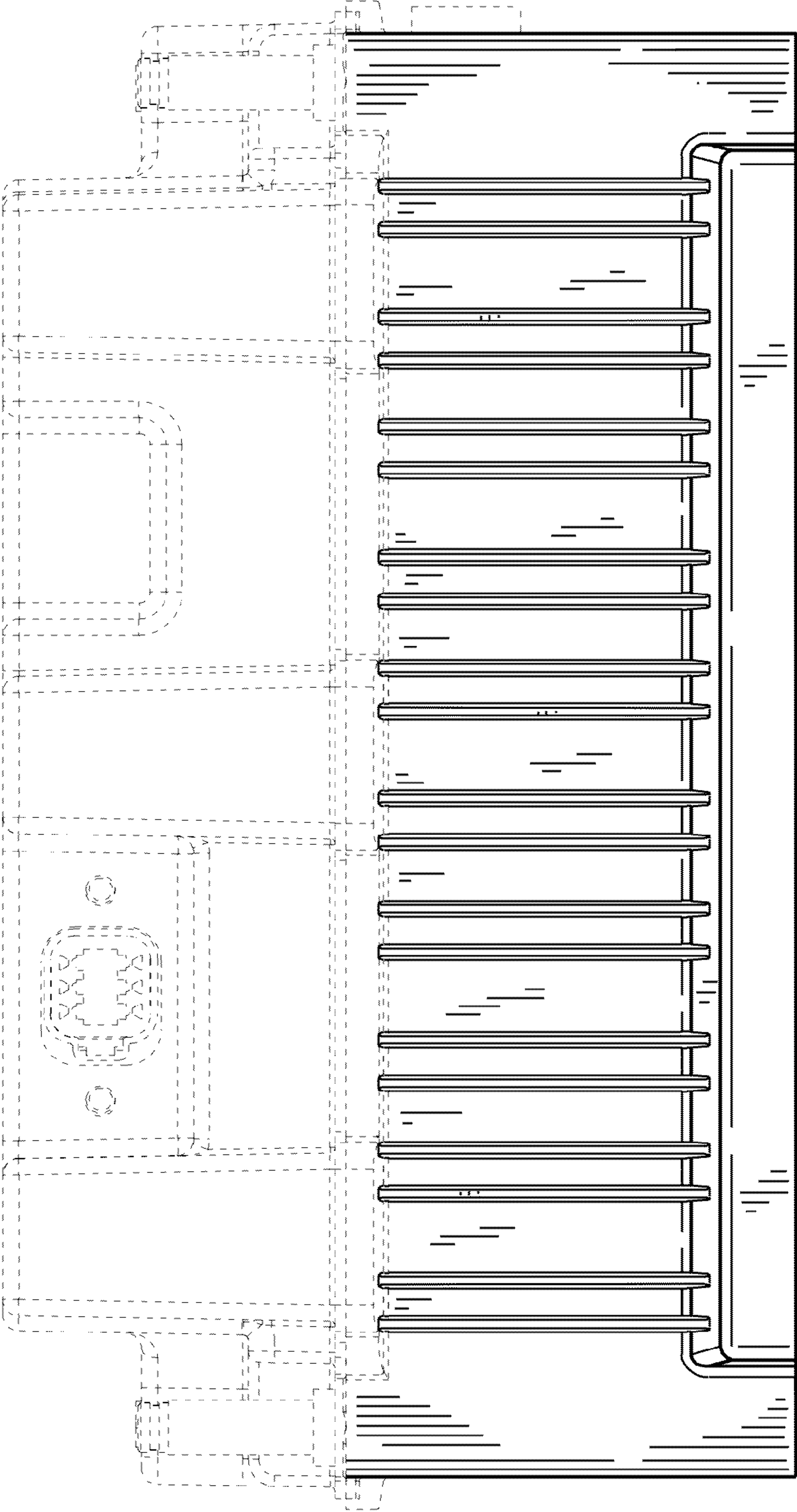

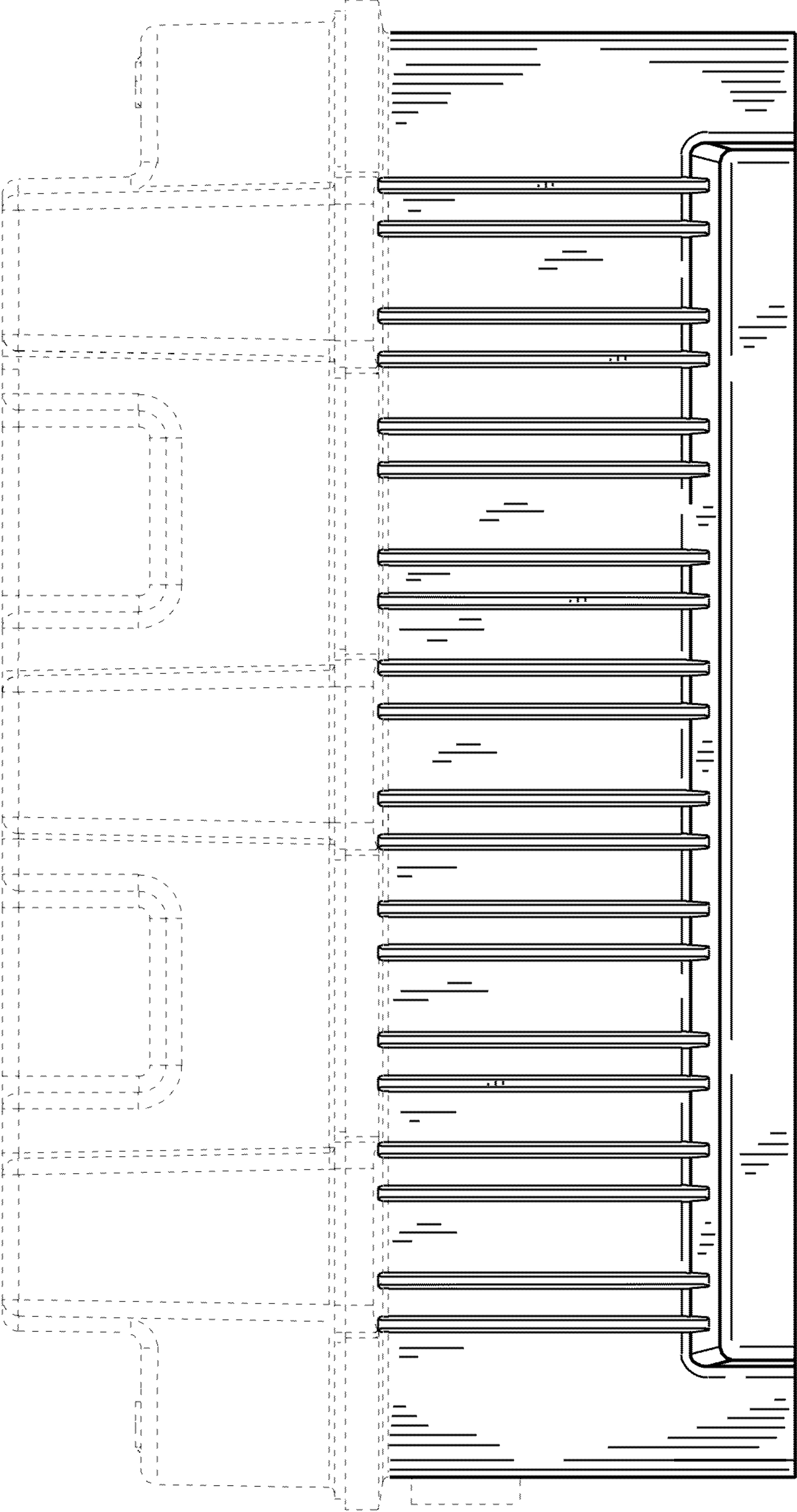

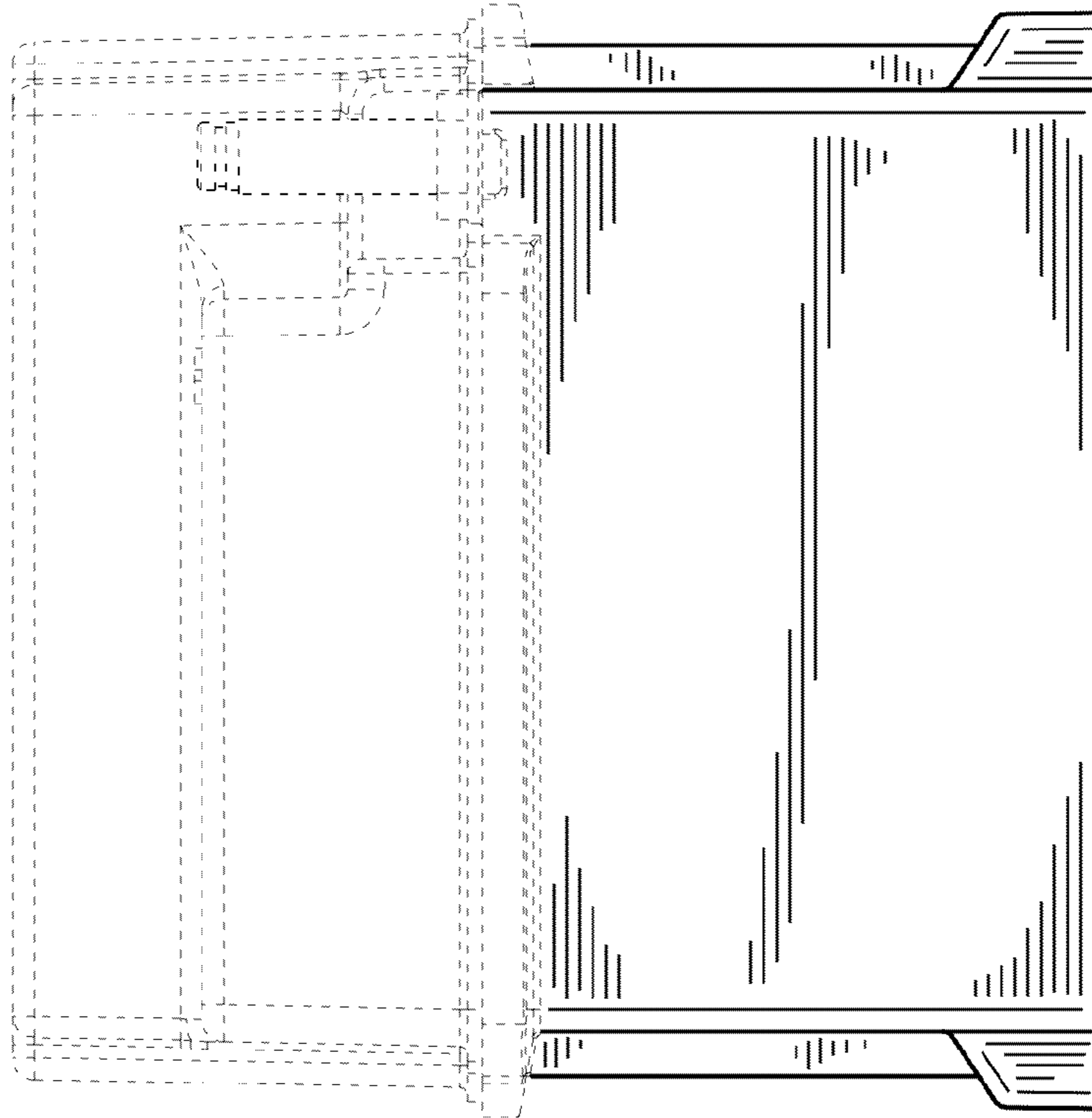

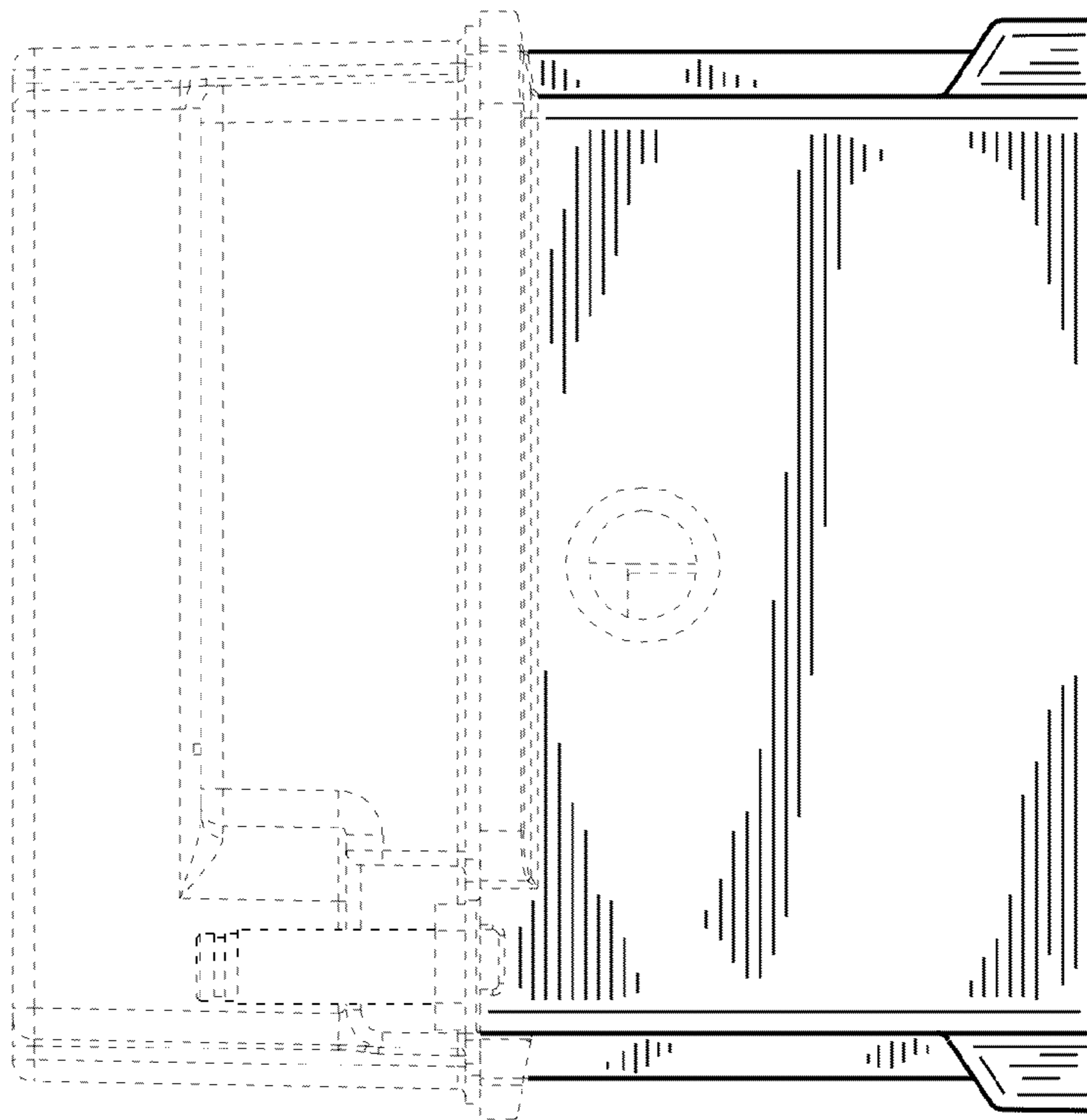

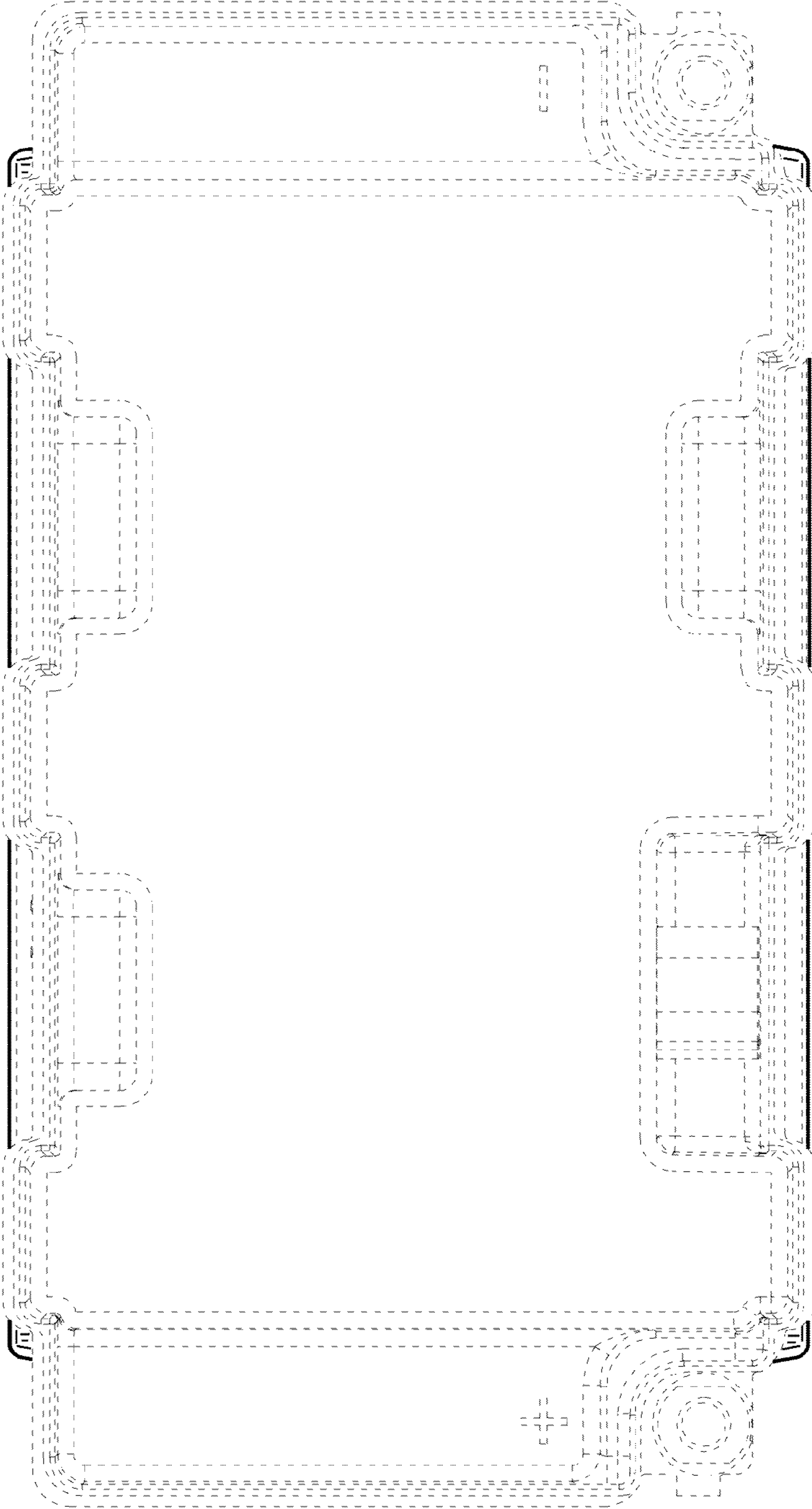

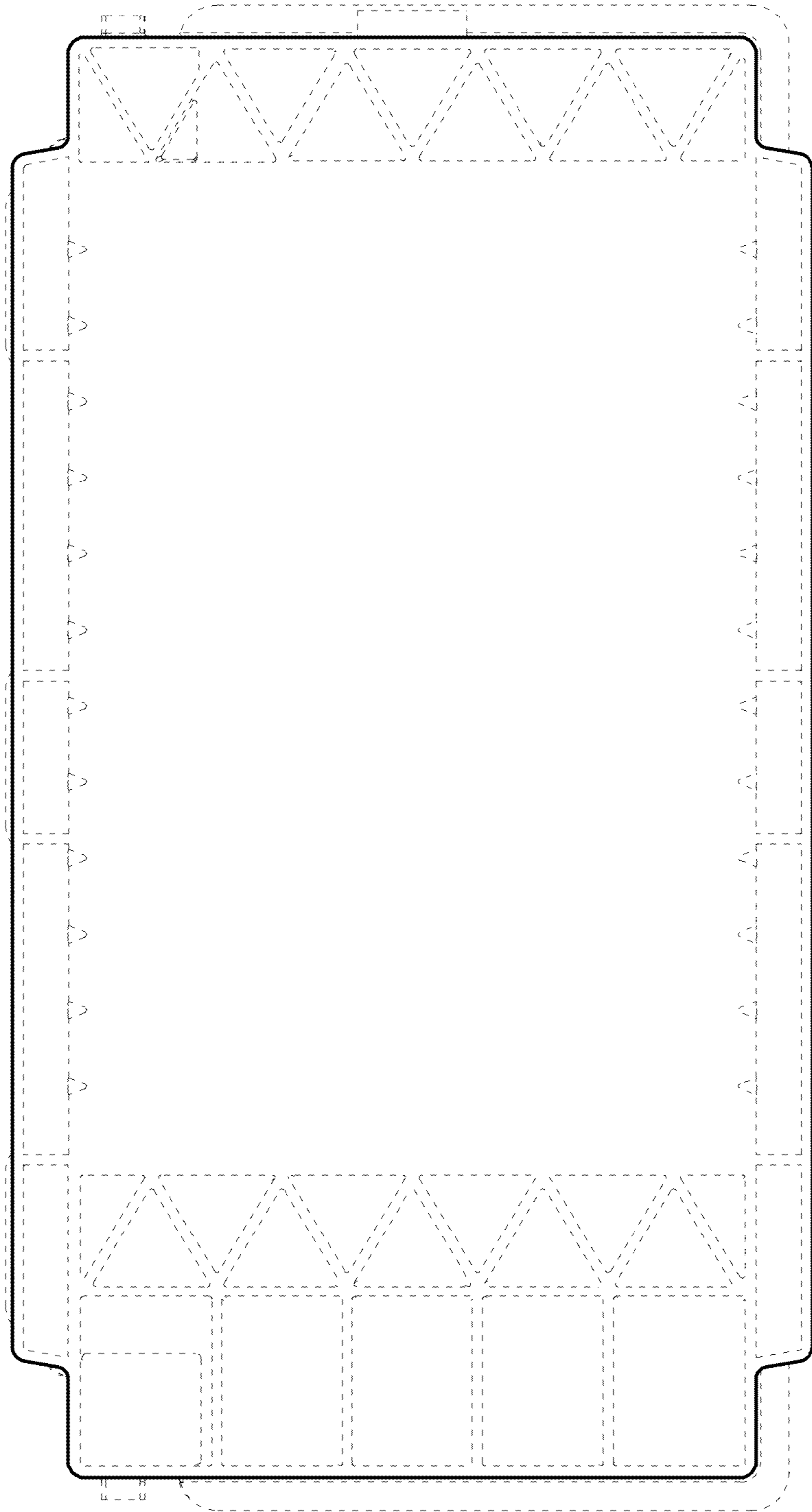
