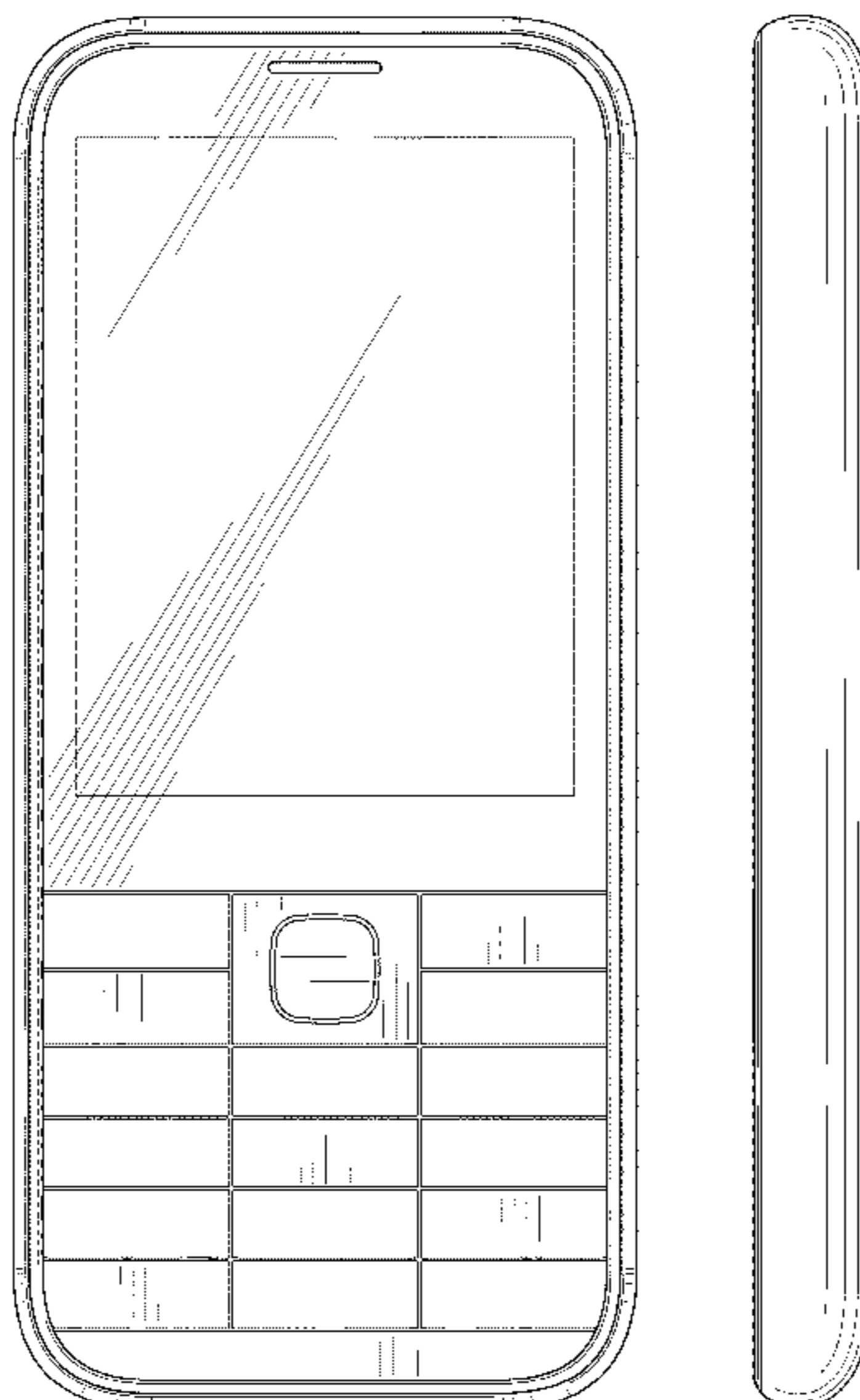

DESCRIPTION

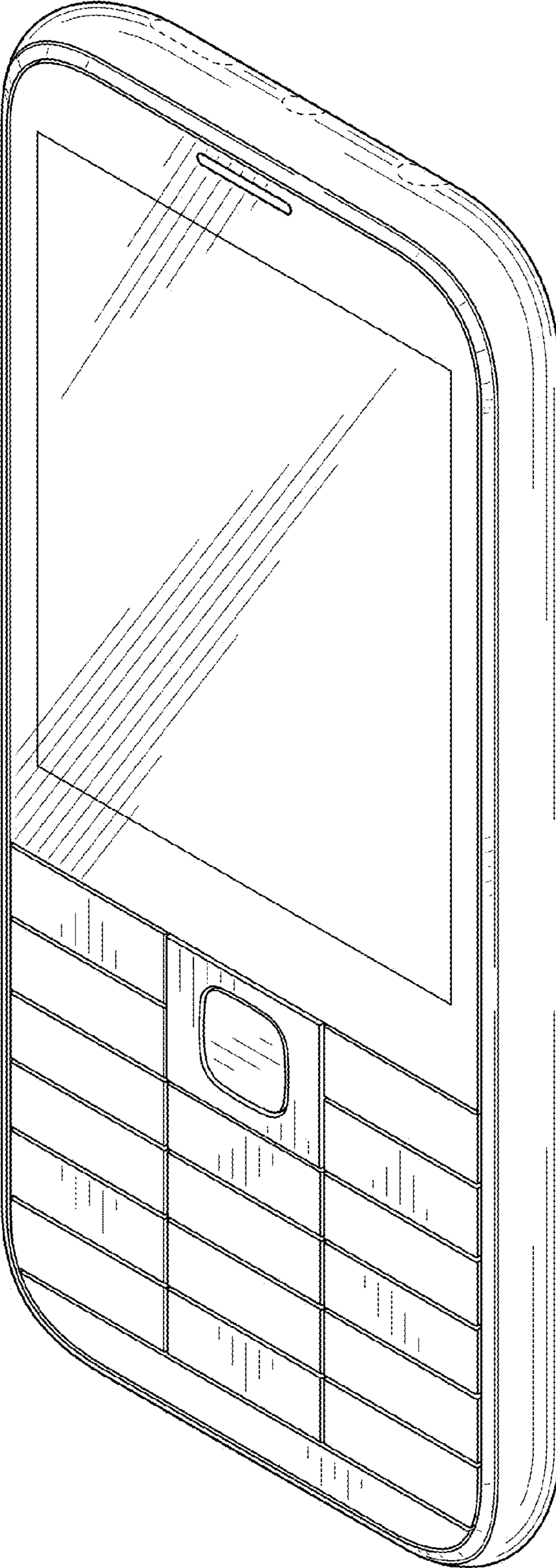

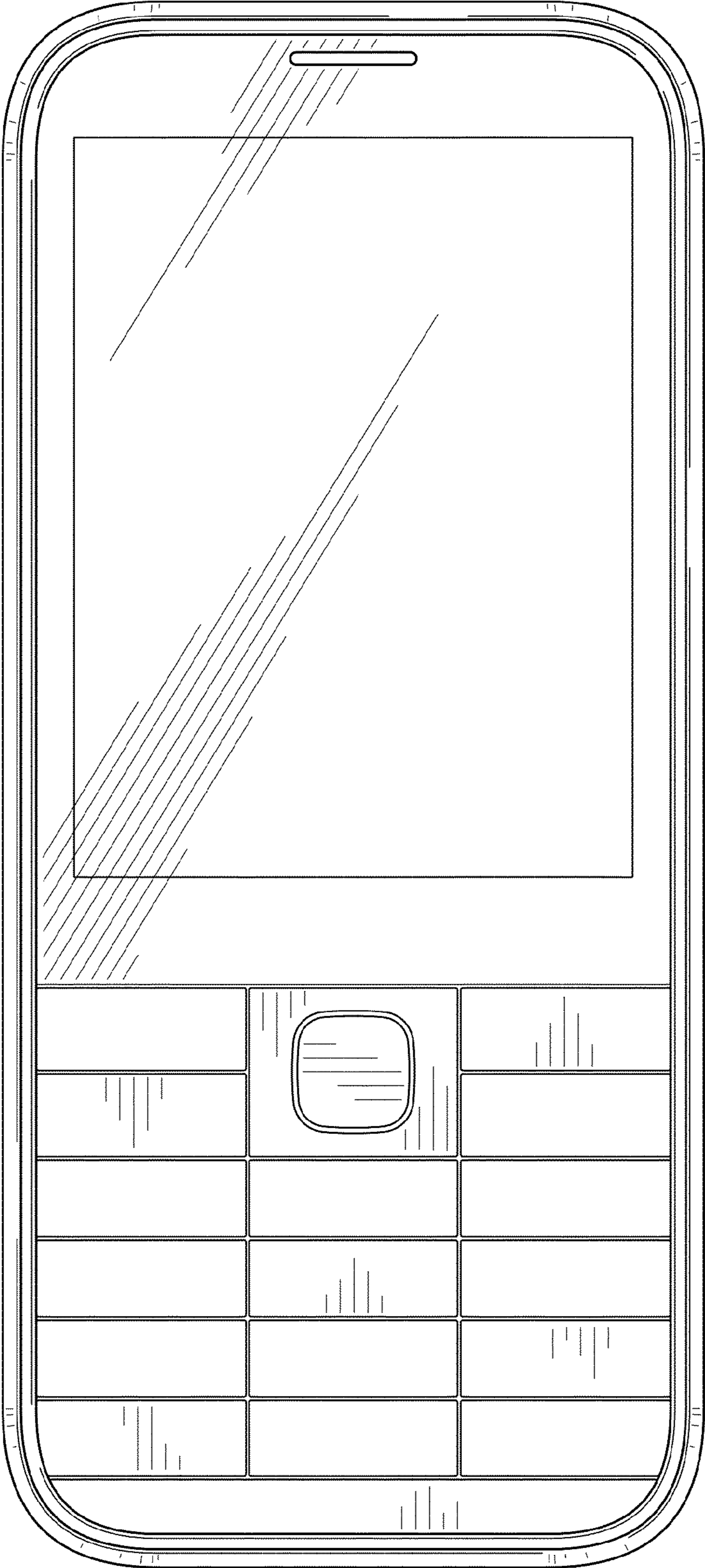

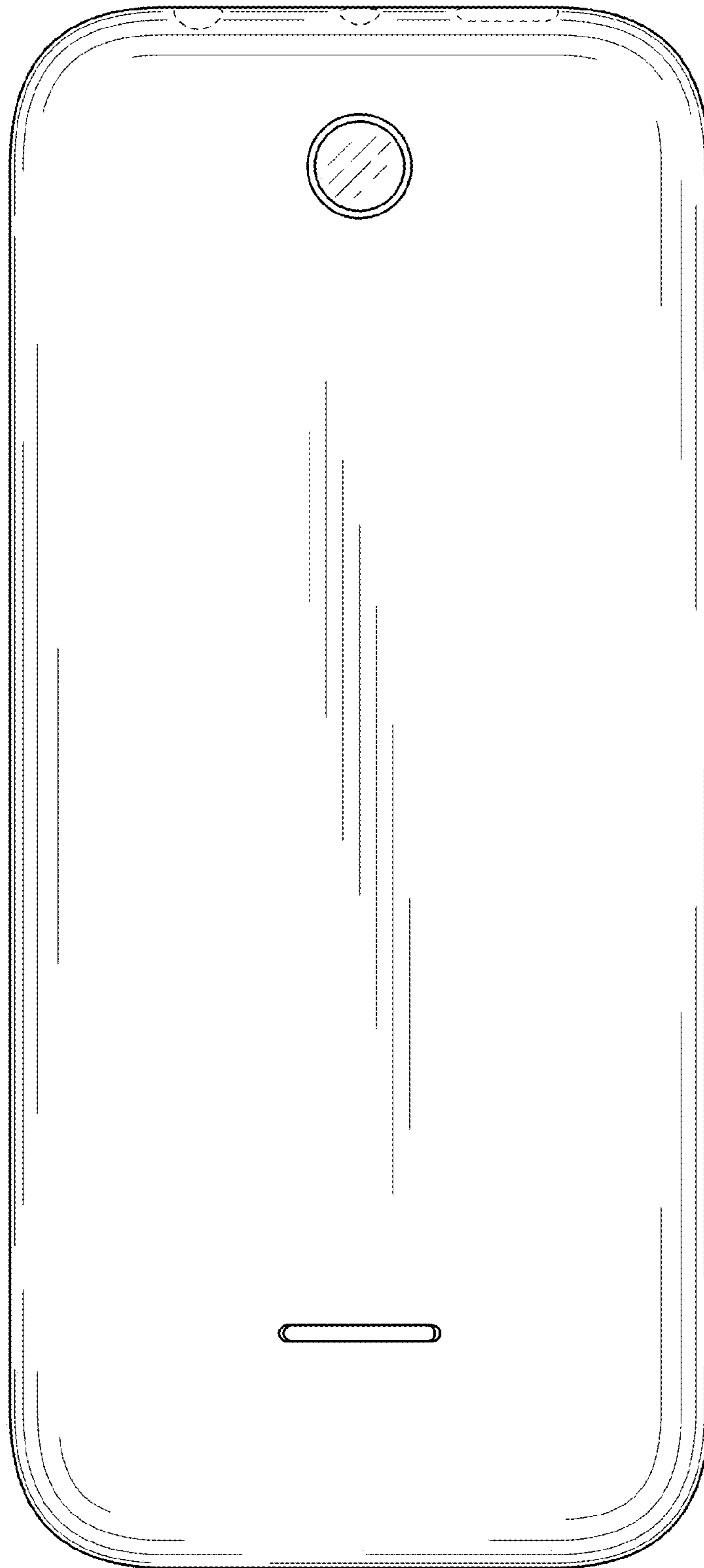

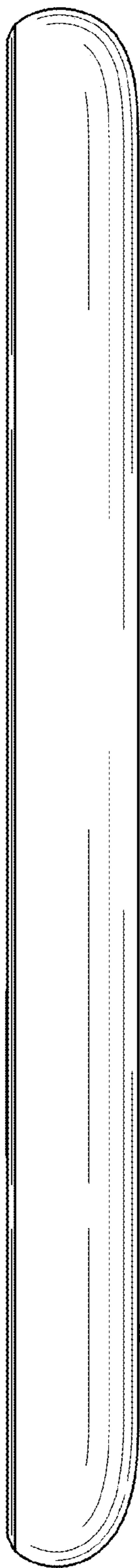

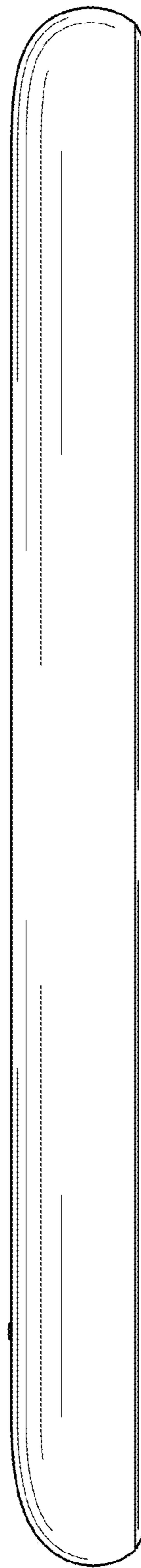

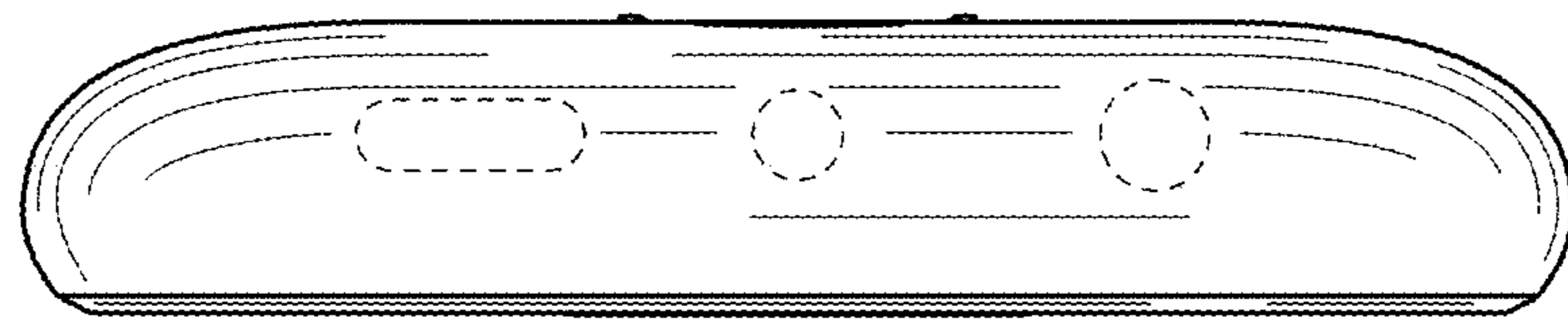

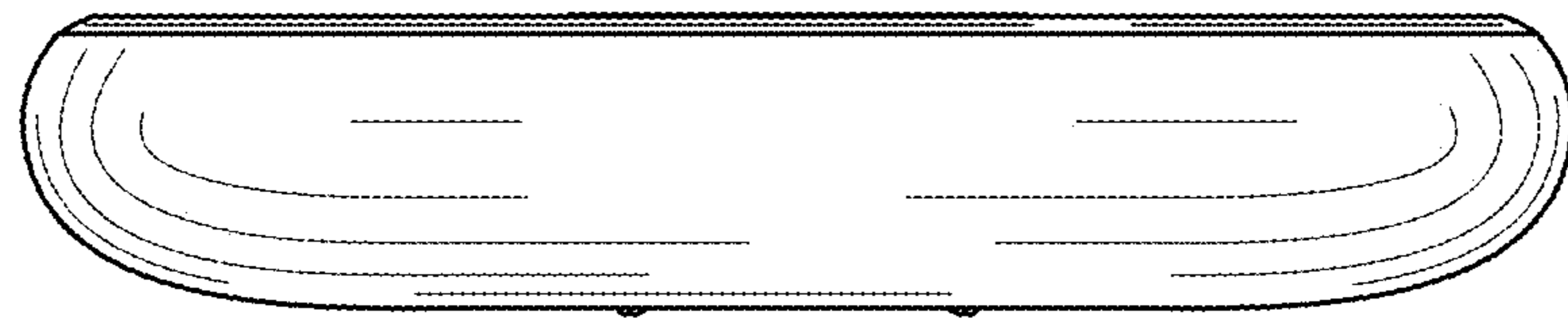
