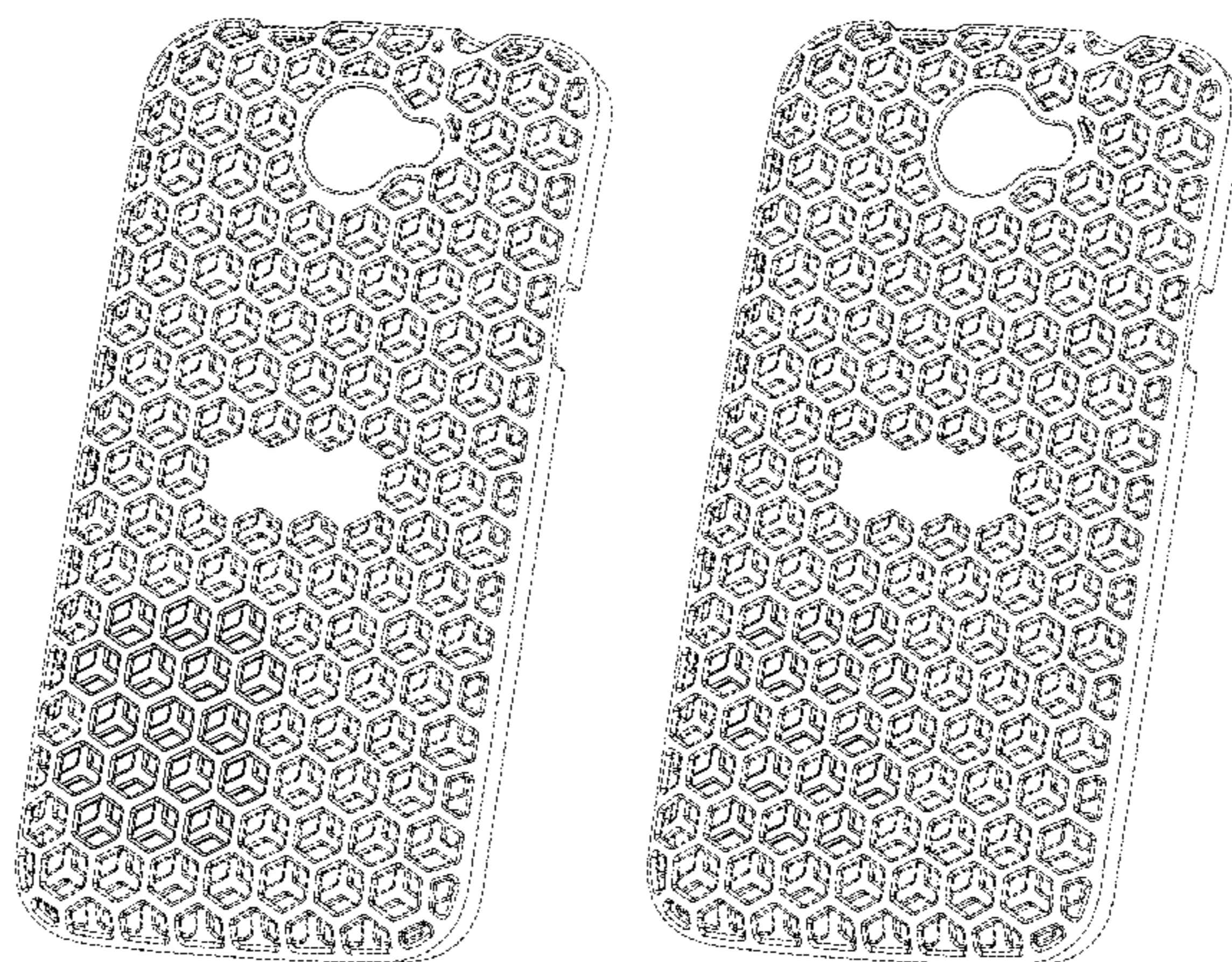
The ornamental design for a cover, as shown and described.

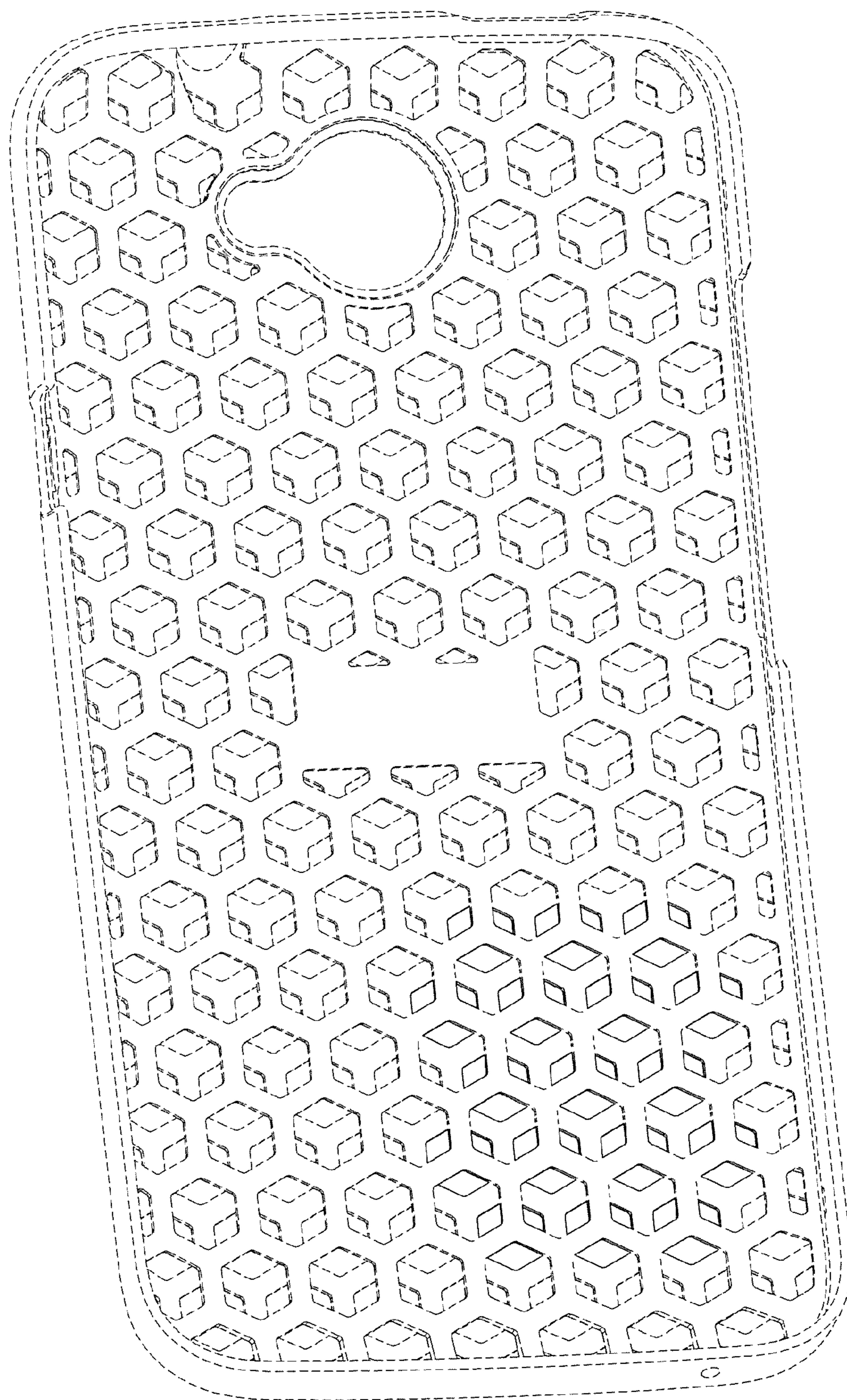

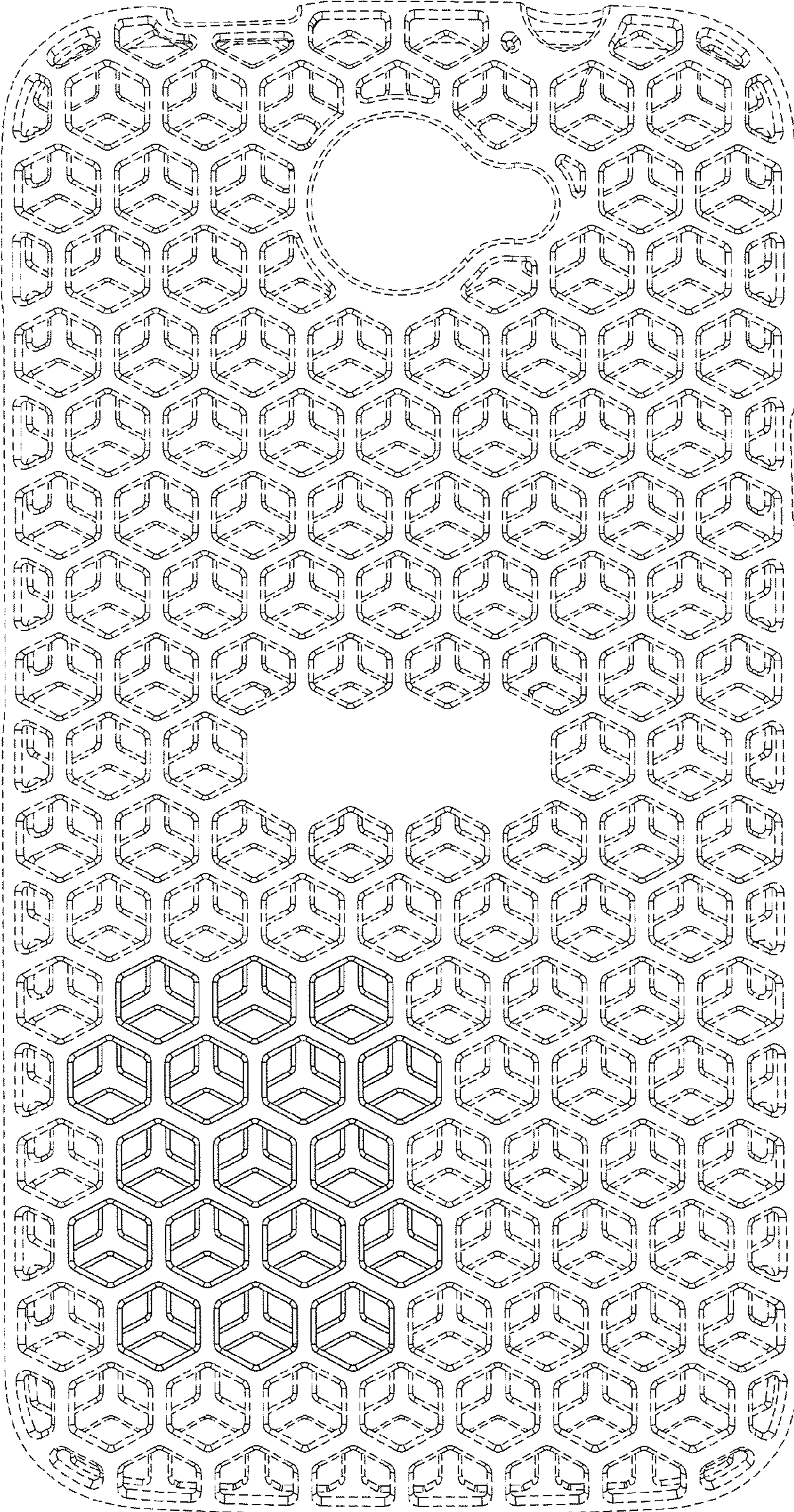

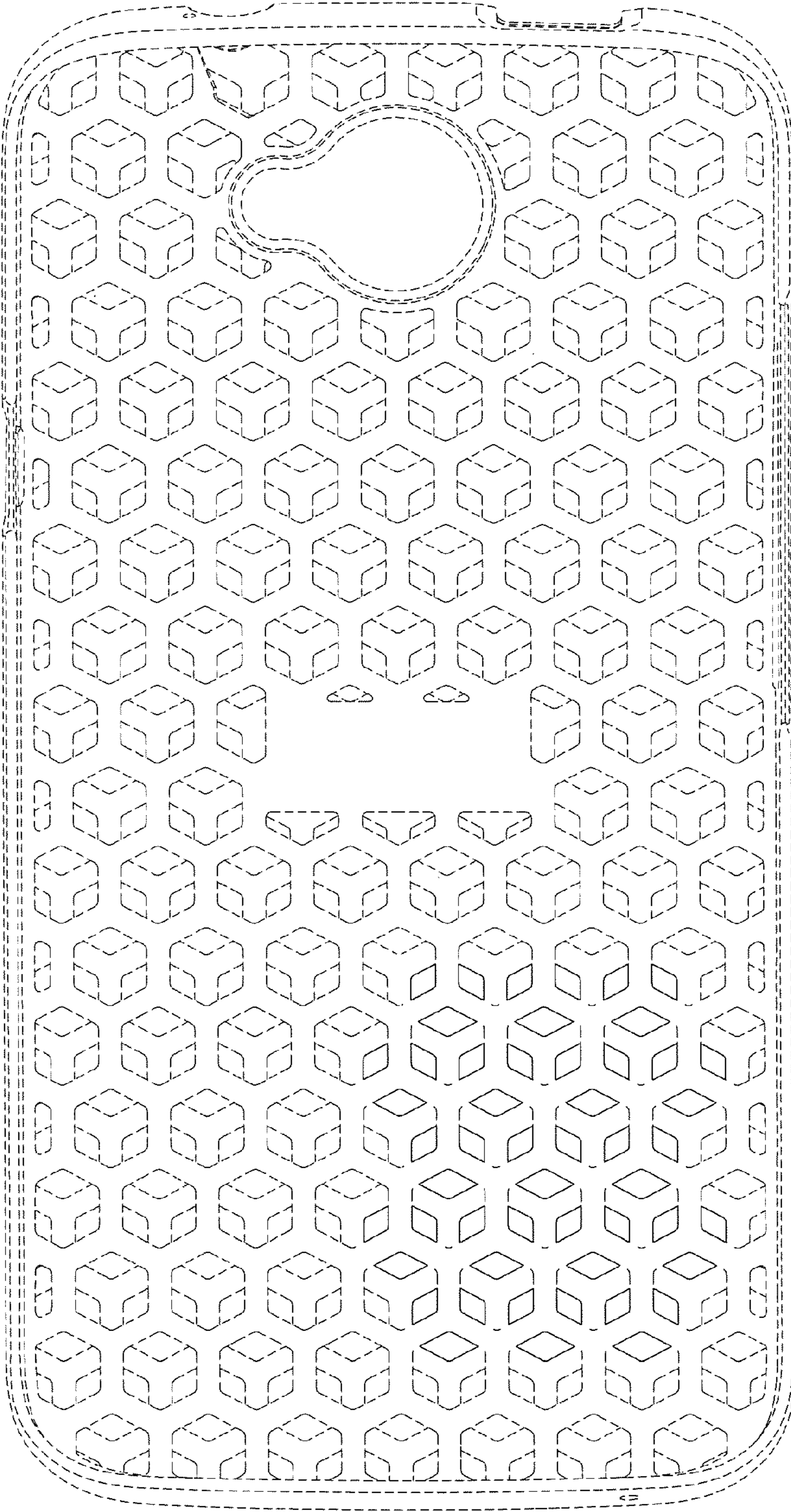

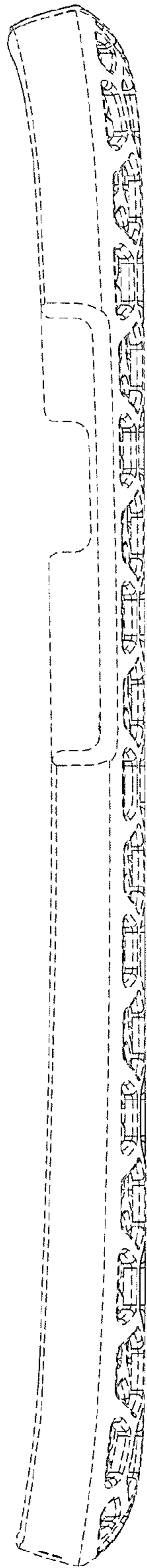

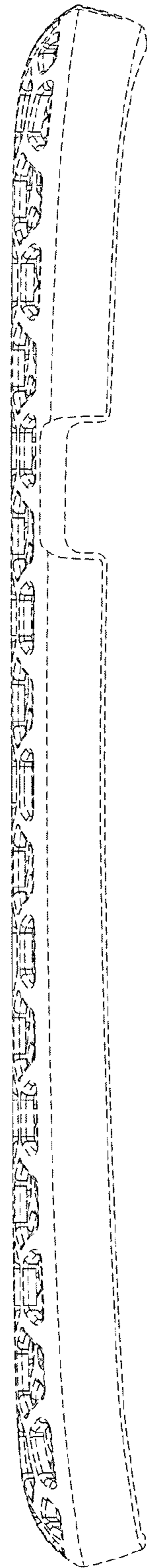

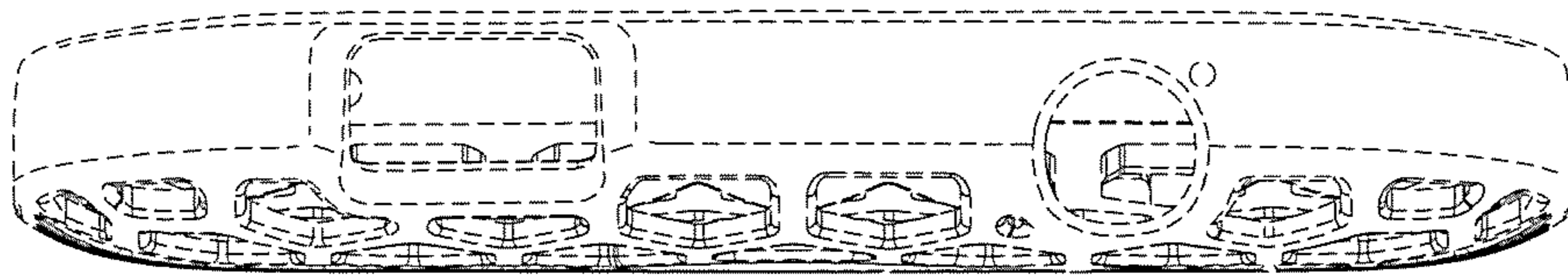

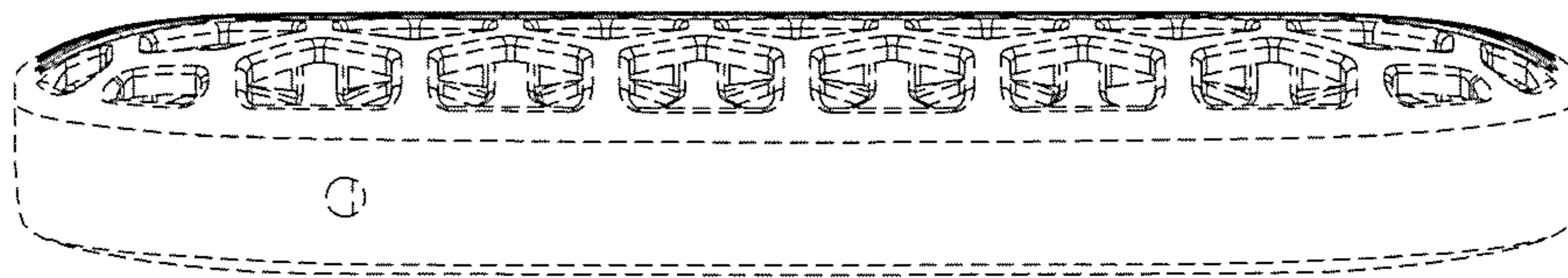

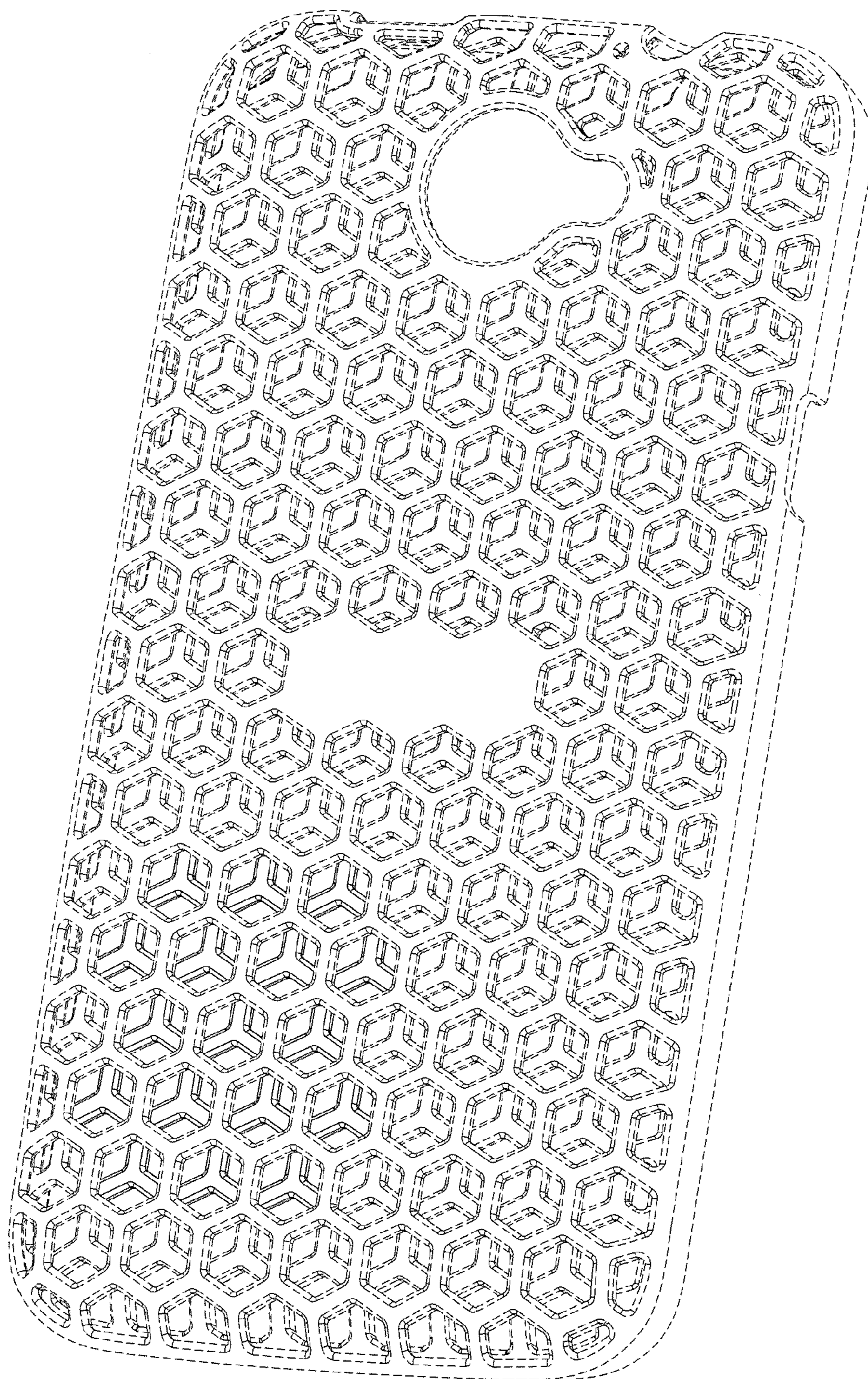

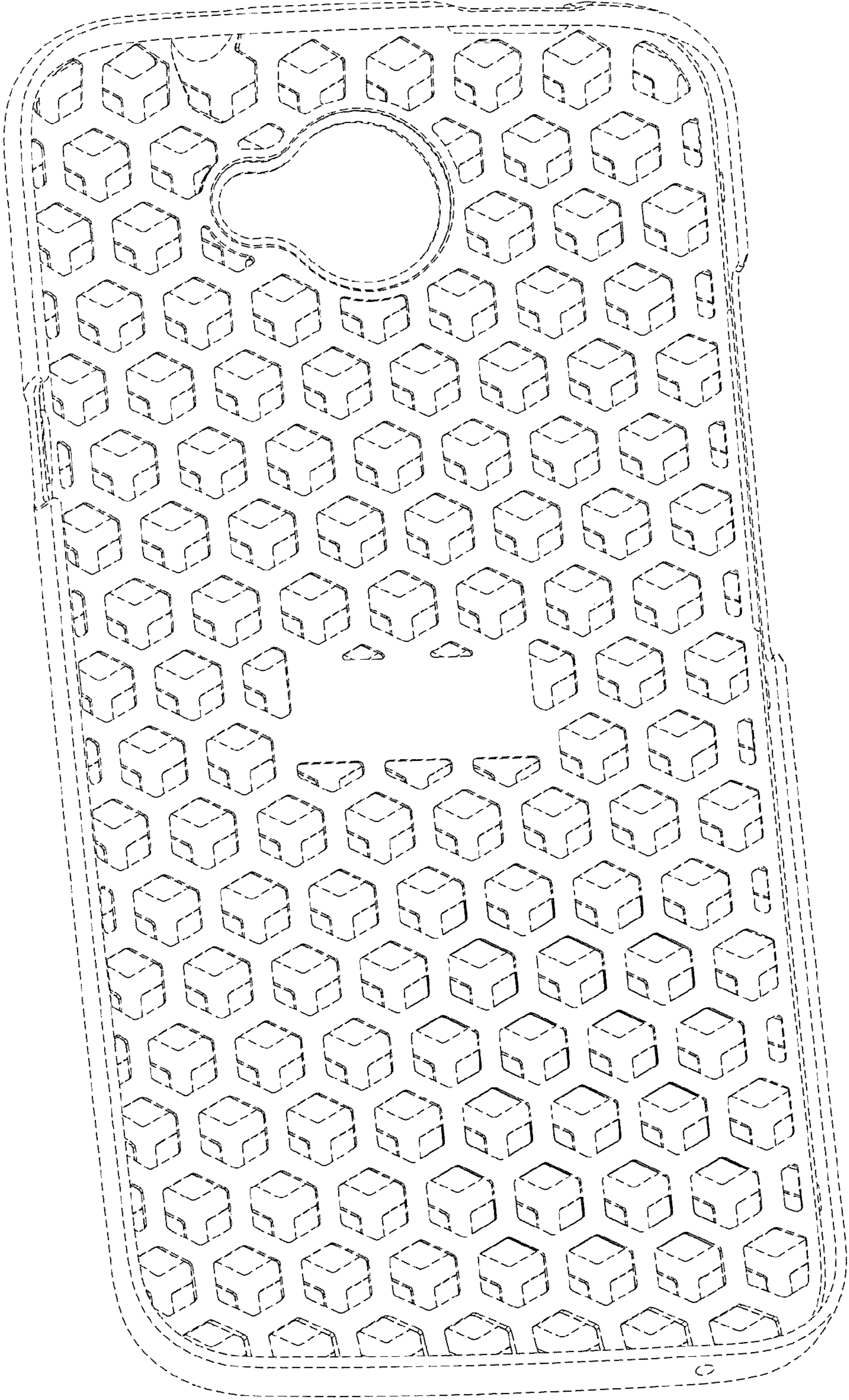

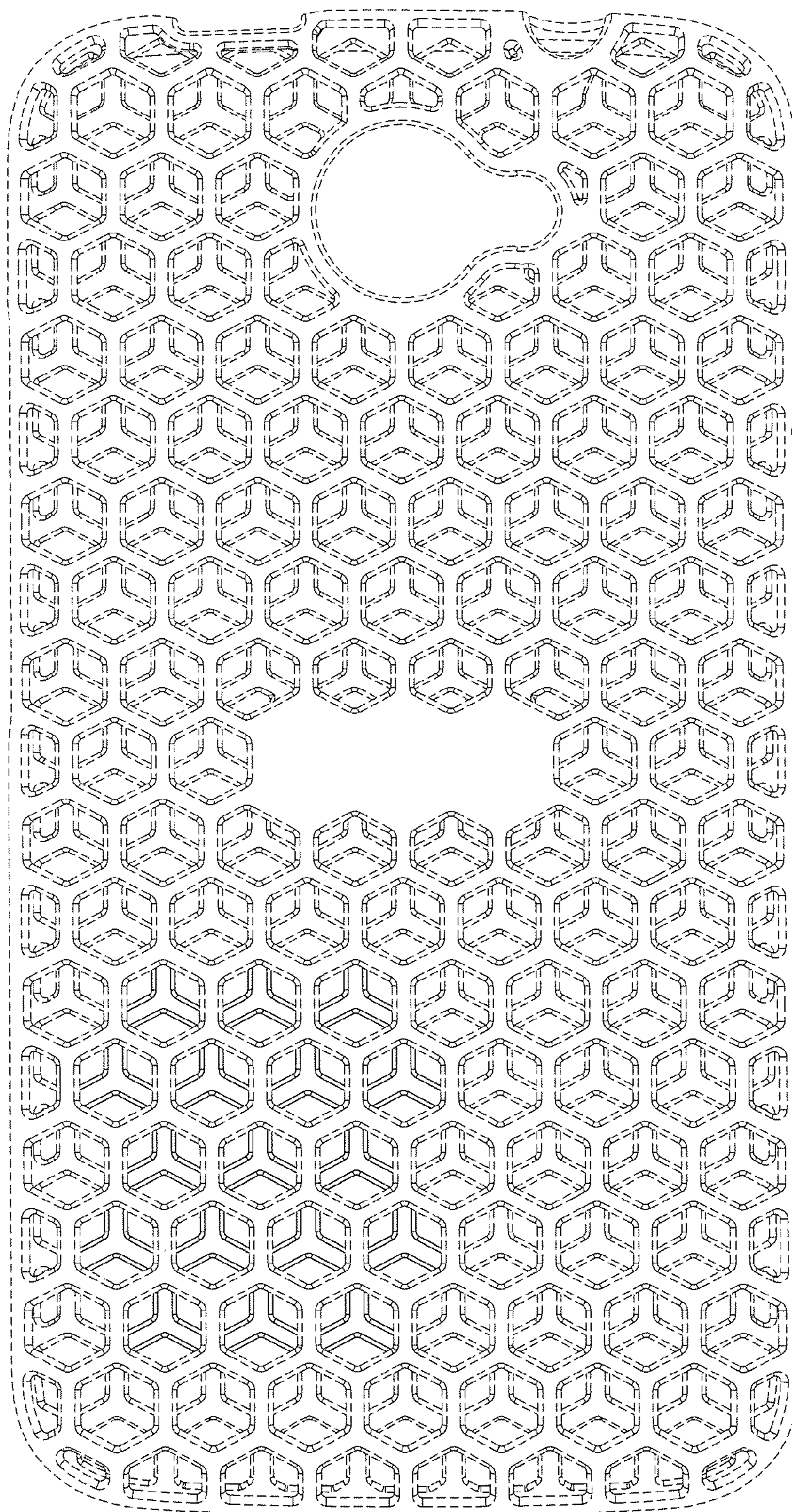

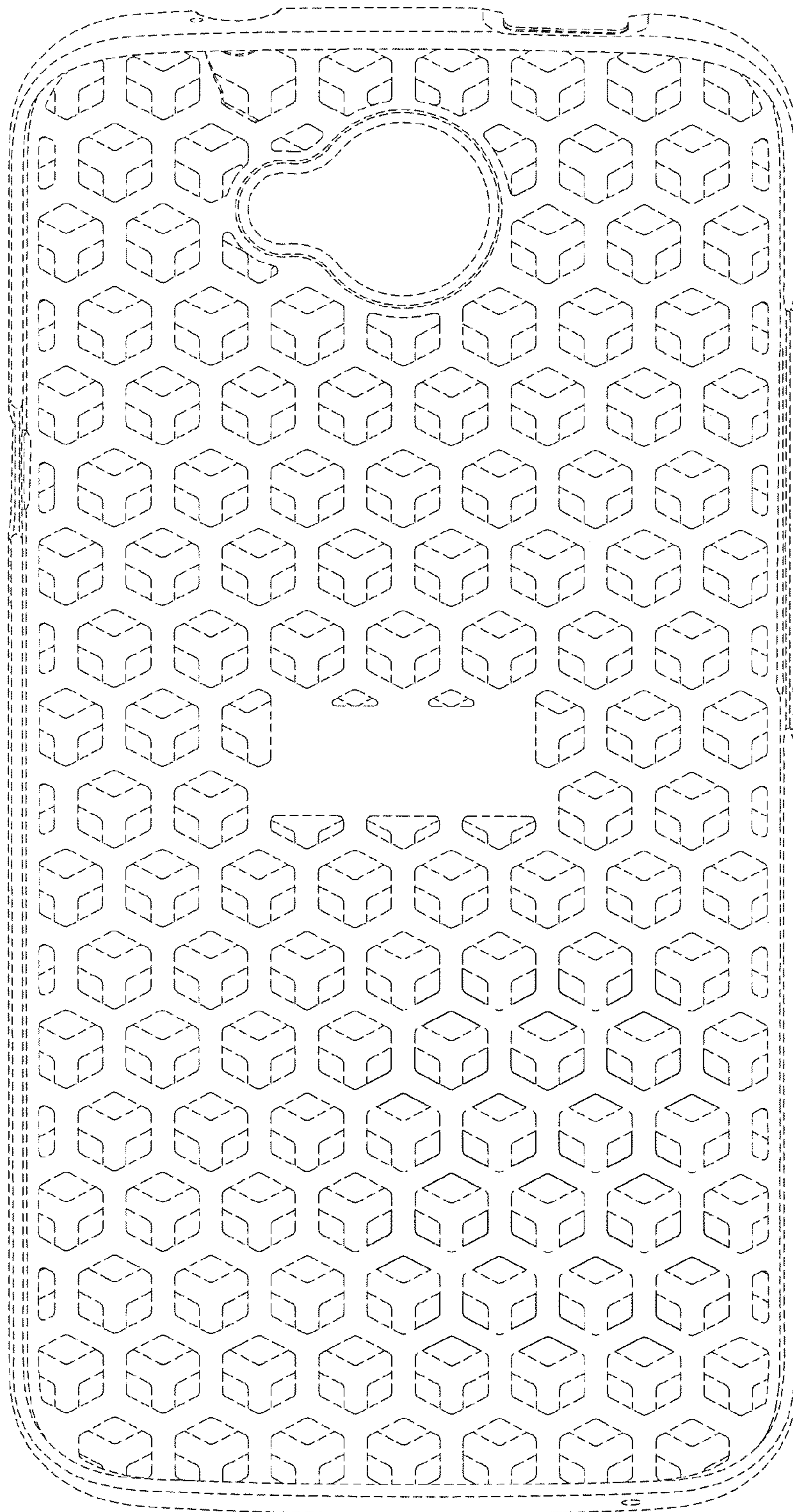

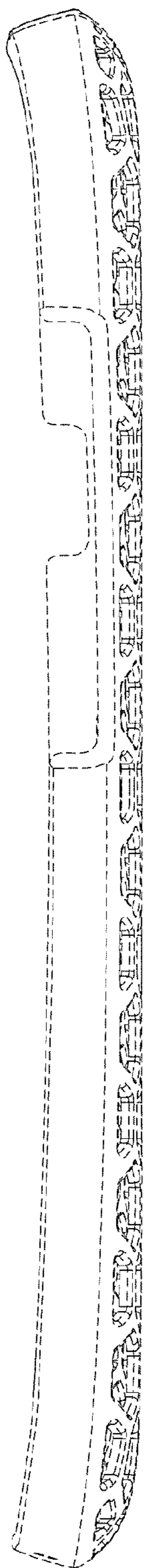

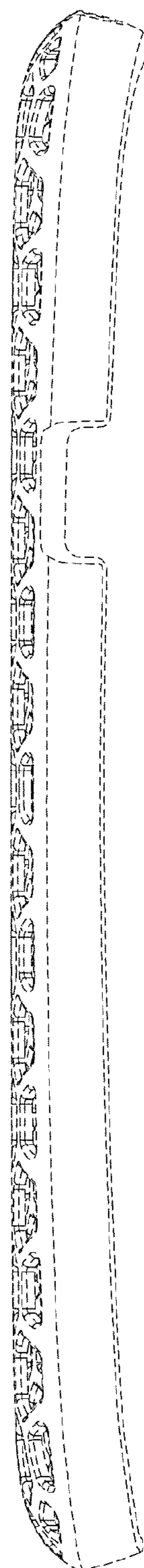

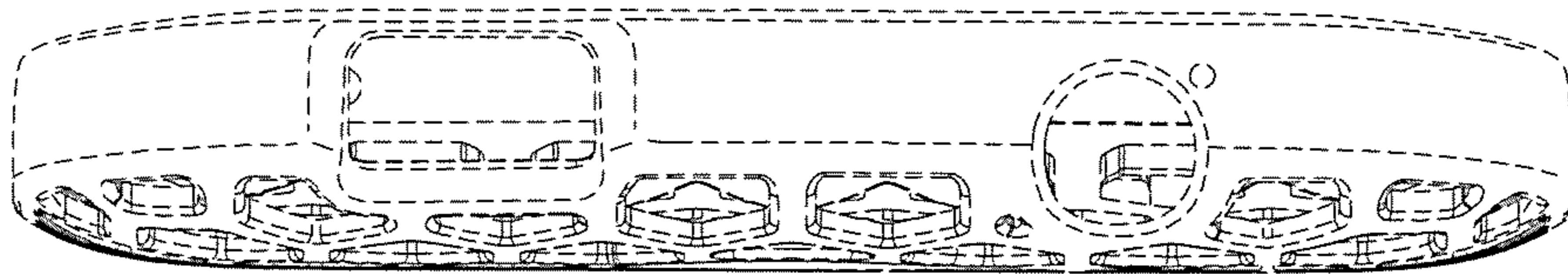

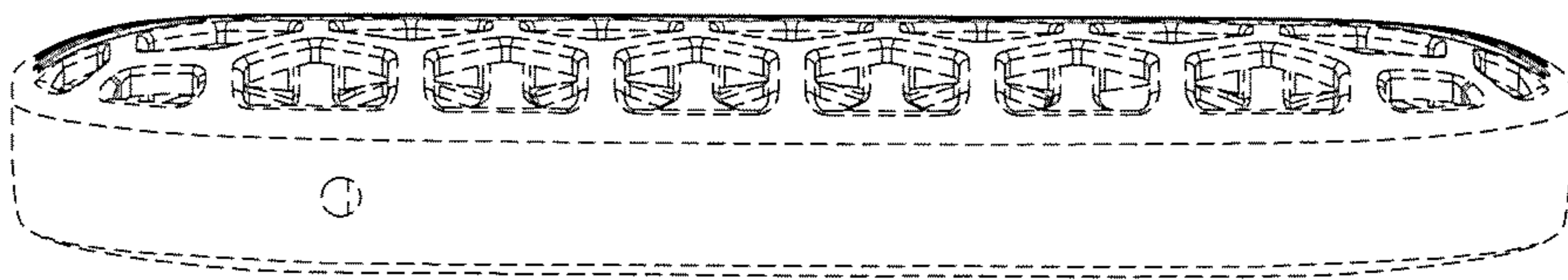
