(57) **CLAIM**

The ornamental design for a case for cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of a case for cellular phone showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a front perspective view thereof, showing the case for cellular phone in a state of use with an unclaimed cellular phone.

The broken lines in FIG. 8 depict an unclaimed cellular phone and form no part of the claimed design.

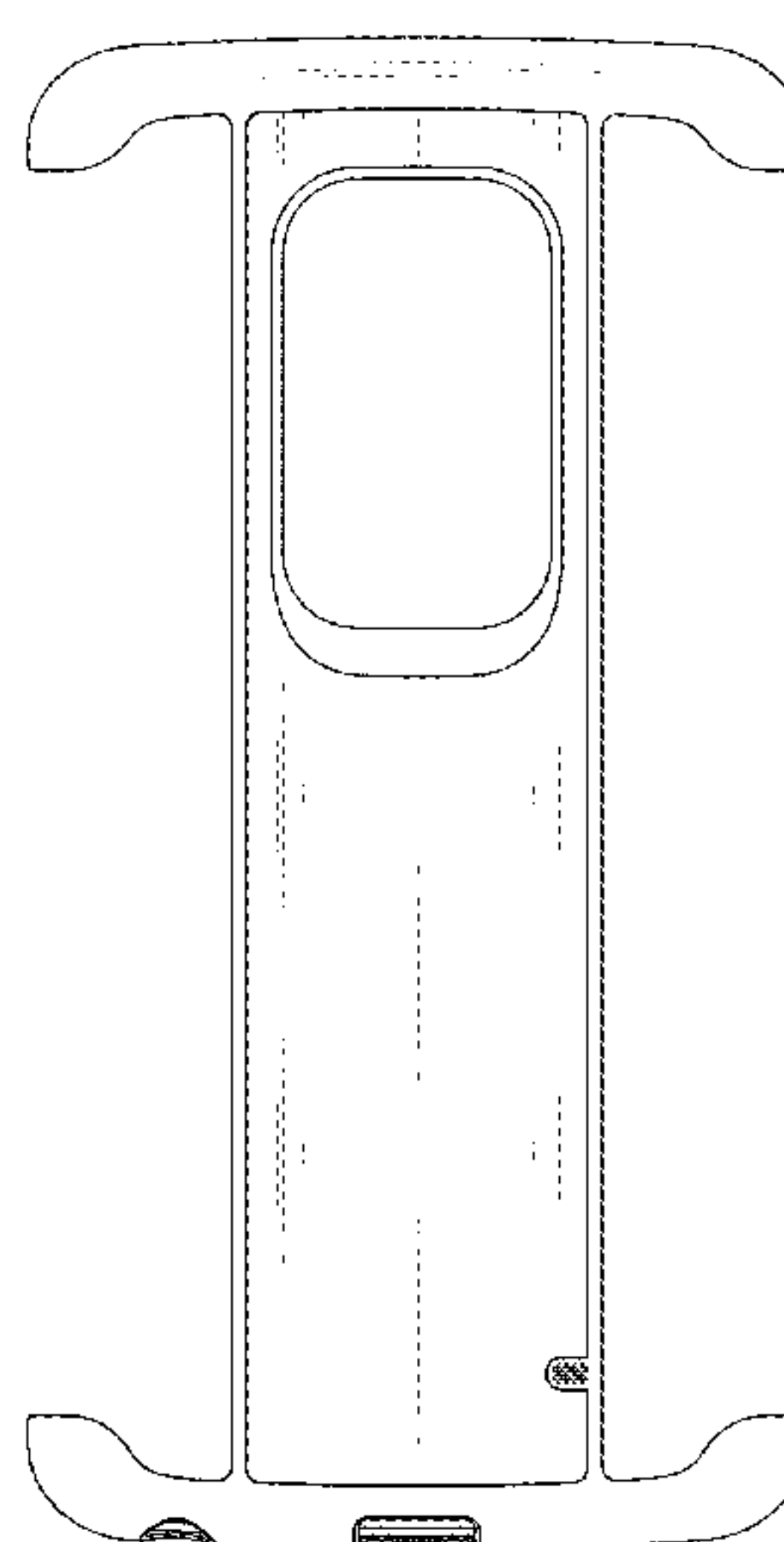
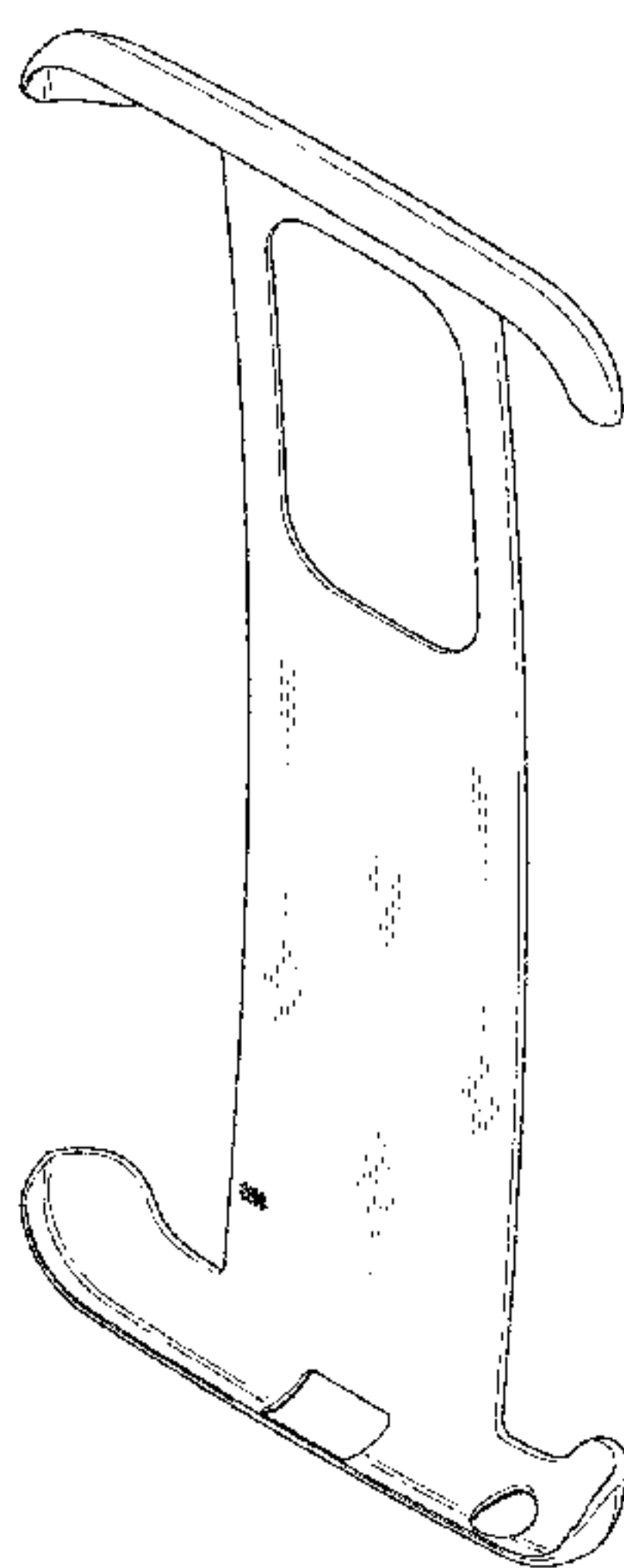

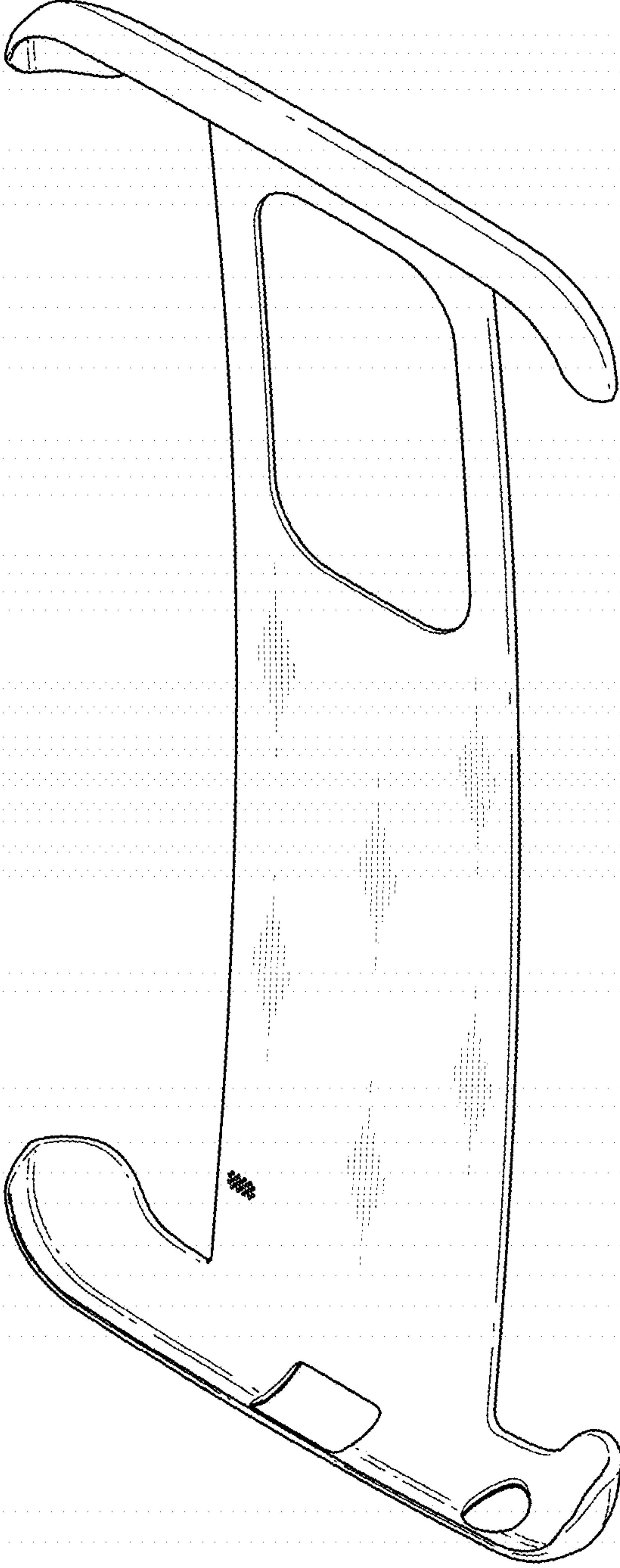

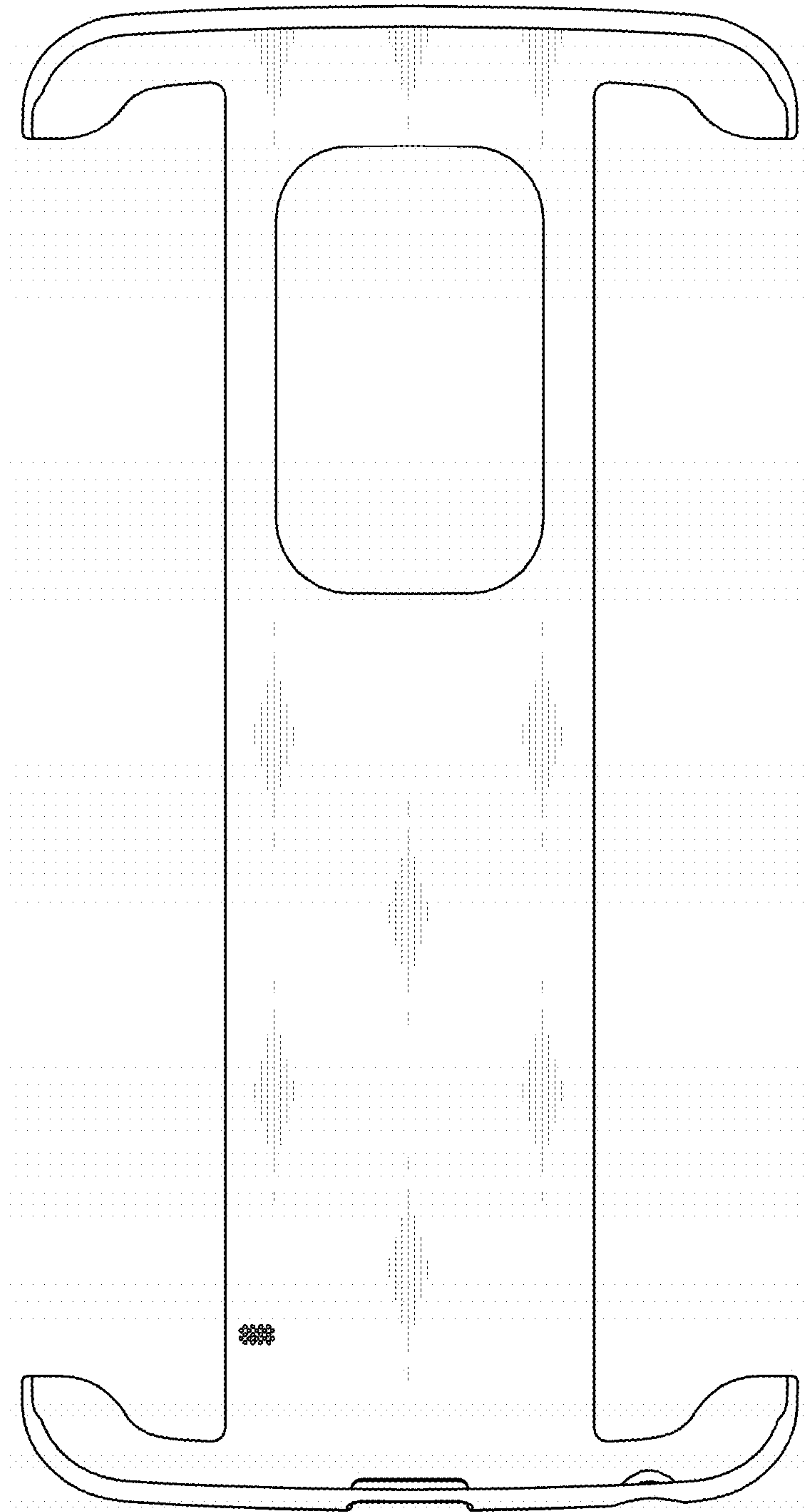

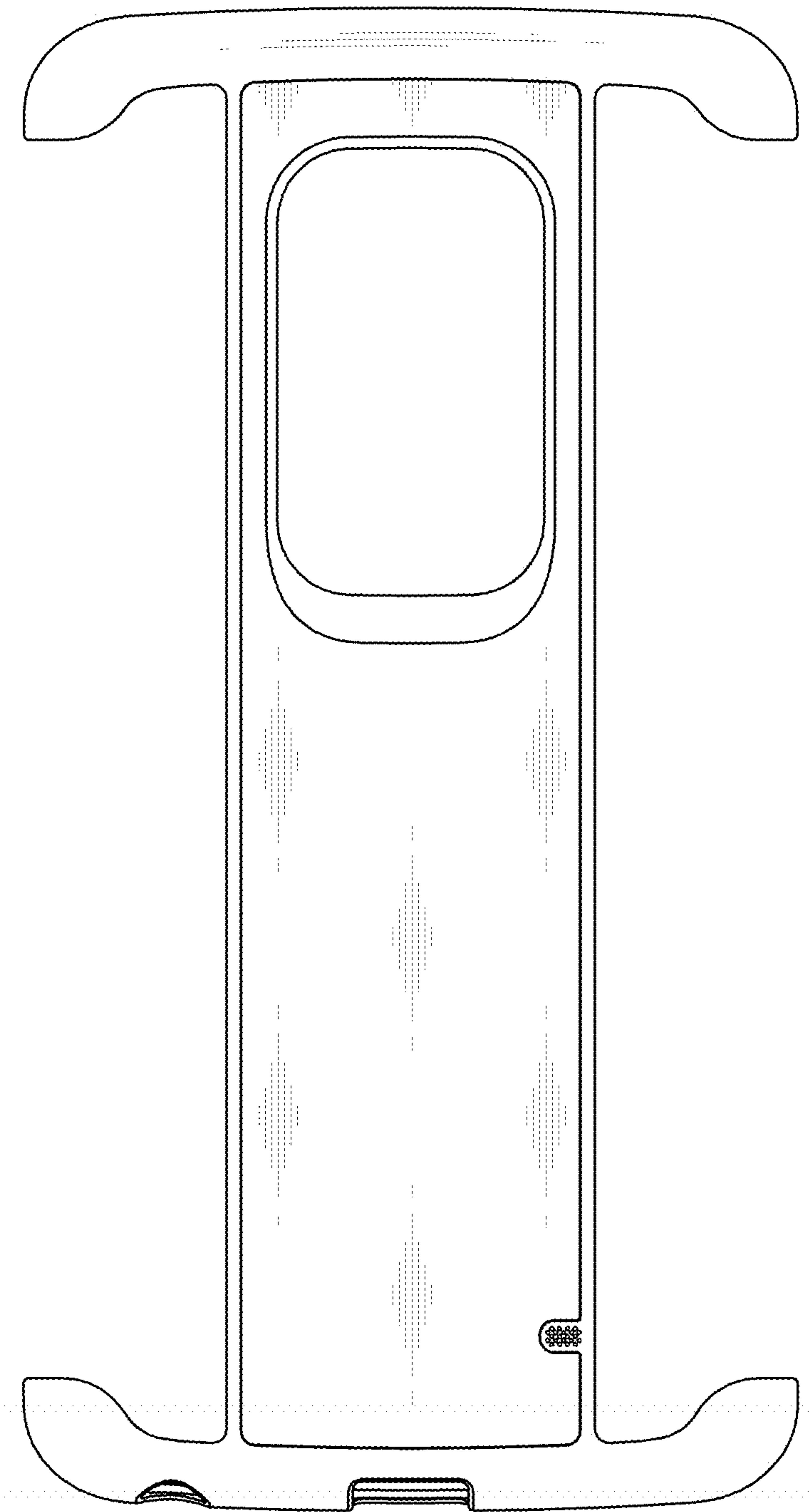

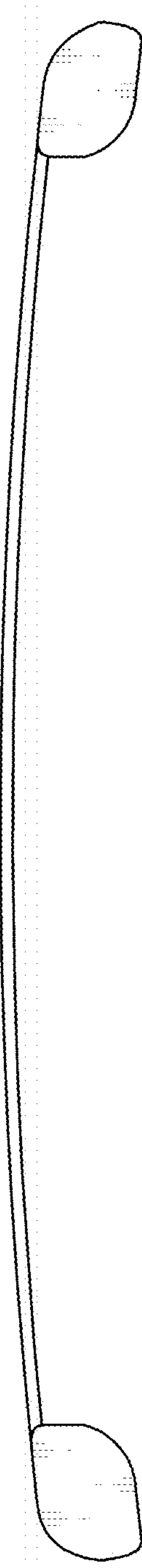

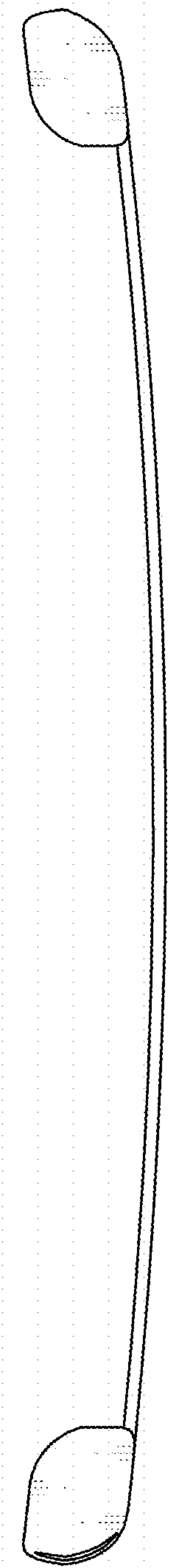

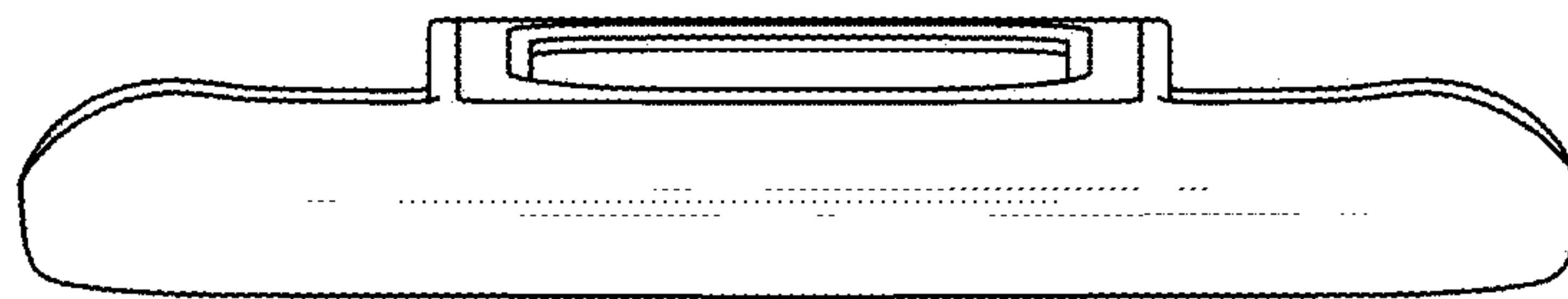

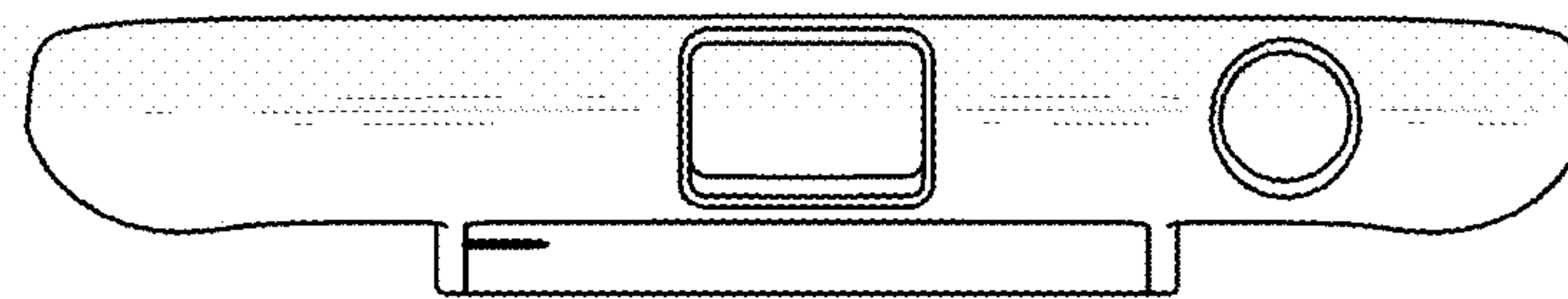
