(57) **CLAIM**

I claim the ornamental design for a portable electronic device, as shown.

DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of a portable electronic device showing my new design; FIG. 2 is a front-side elevational view thereof; FIG. 3 is a rear-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a top-side elevational view thereof; FIG. 7 is a bottom-side elevational view thereof; and, FIG. 8 is a rear/right-side/top perspective view thereof.

The parts showing with crossed hatching have a matt surface and other parts have a glossy surface.

The portions of the portable electronic device shown in broken lines disclose environmental structure and form no part of the claimed design.

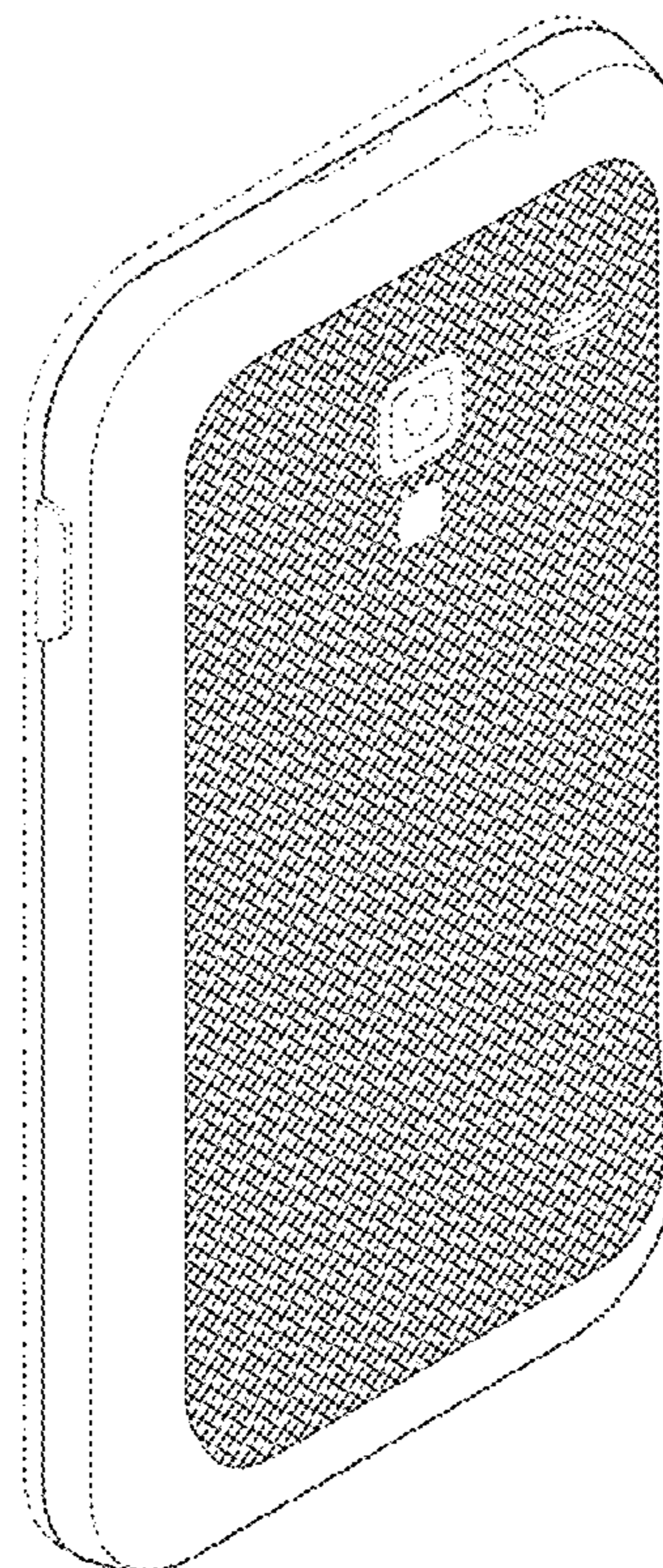
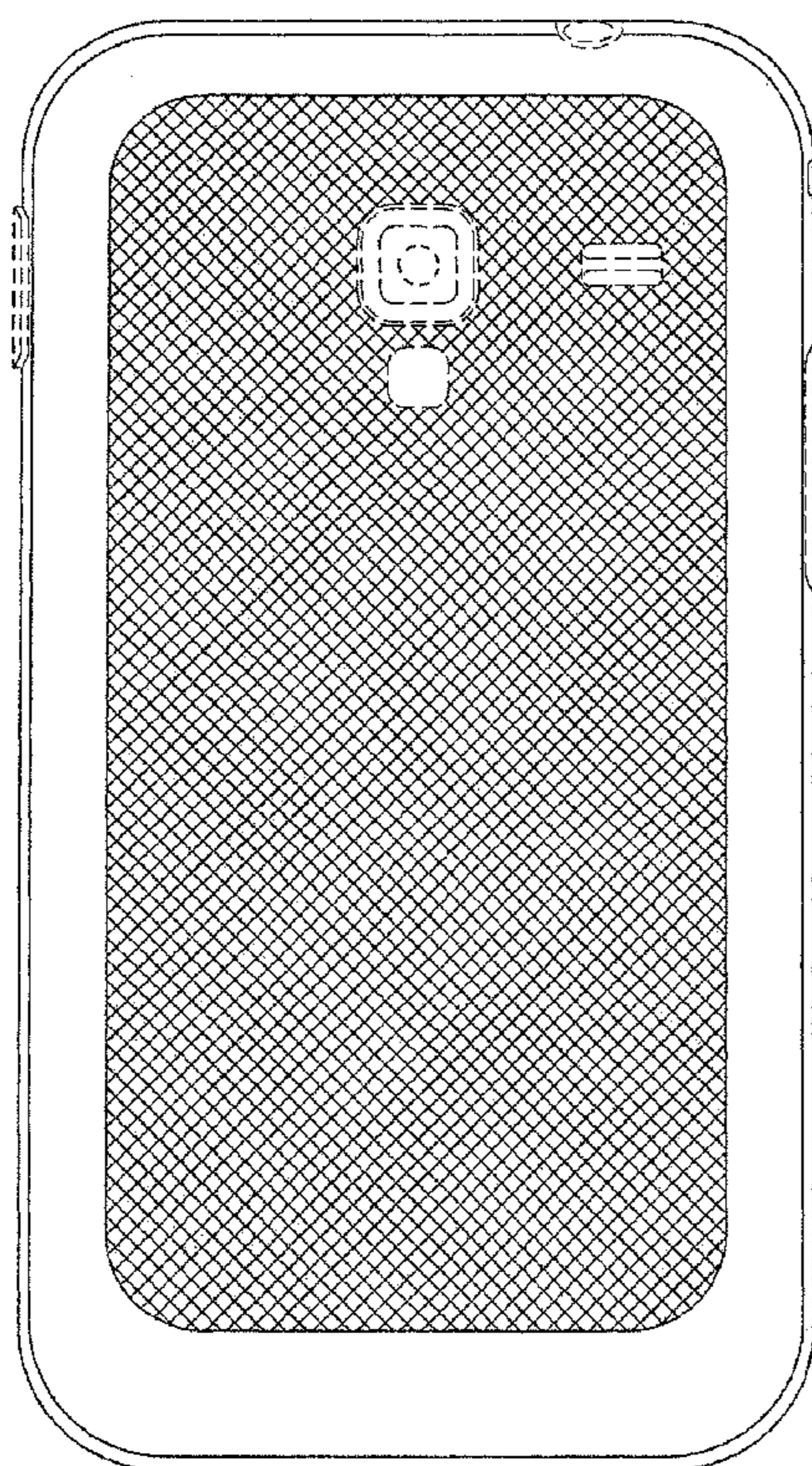

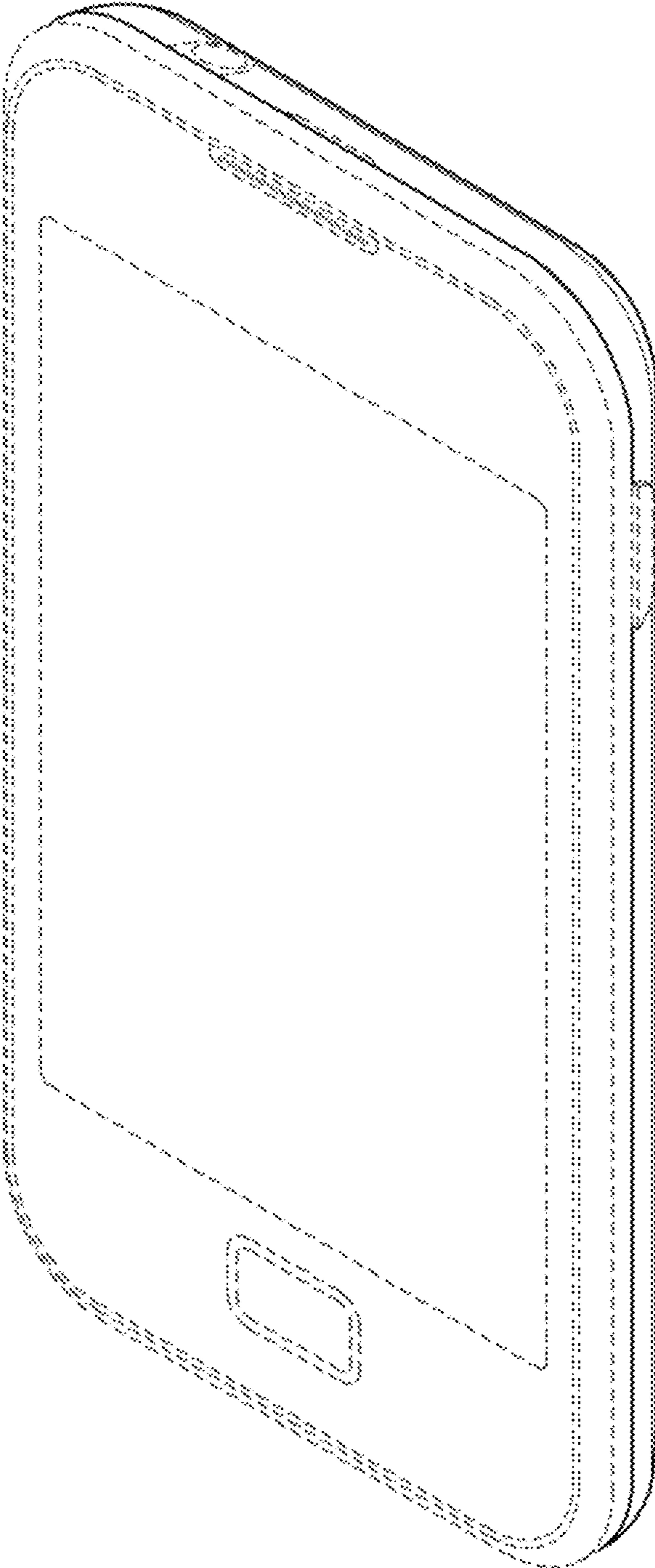

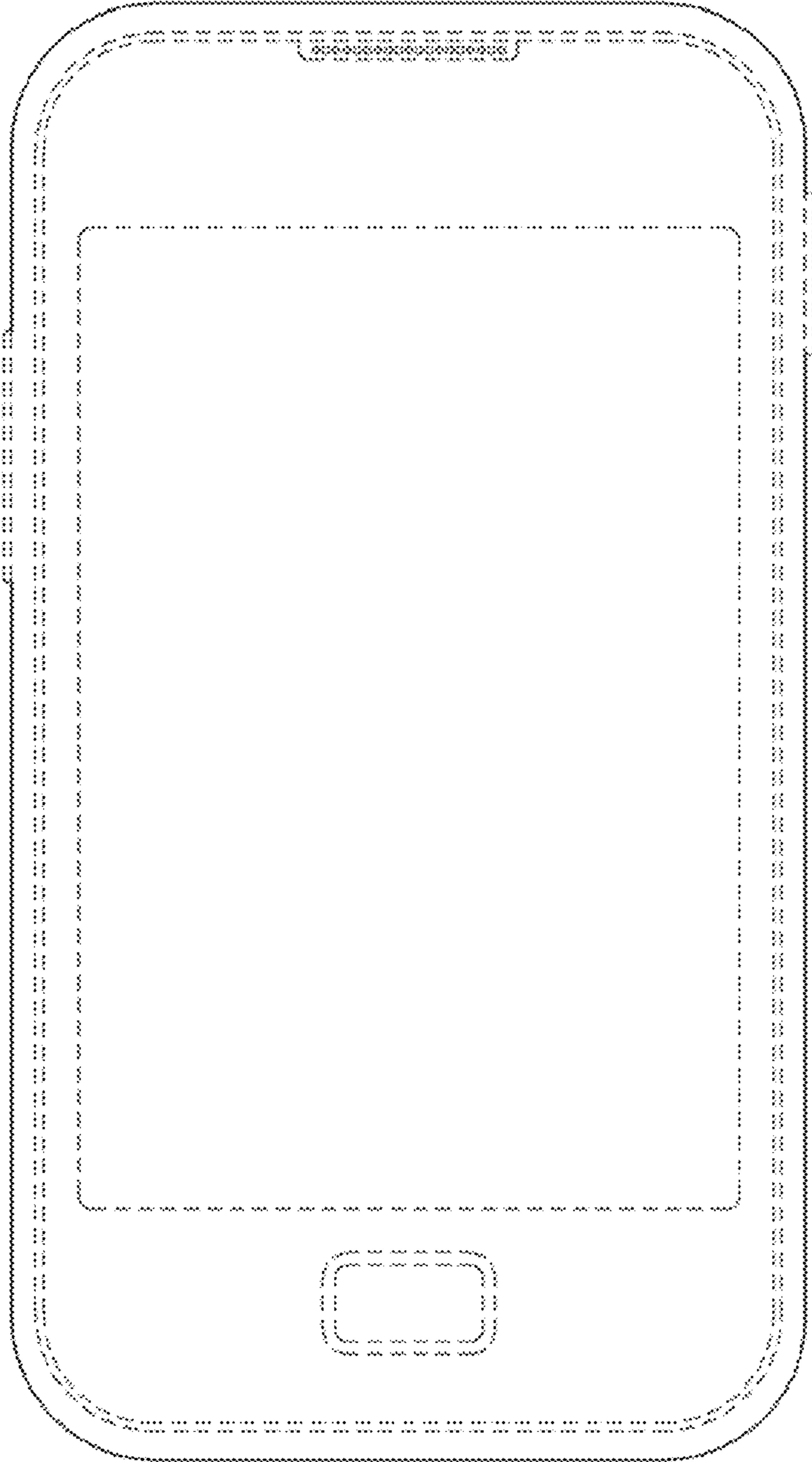

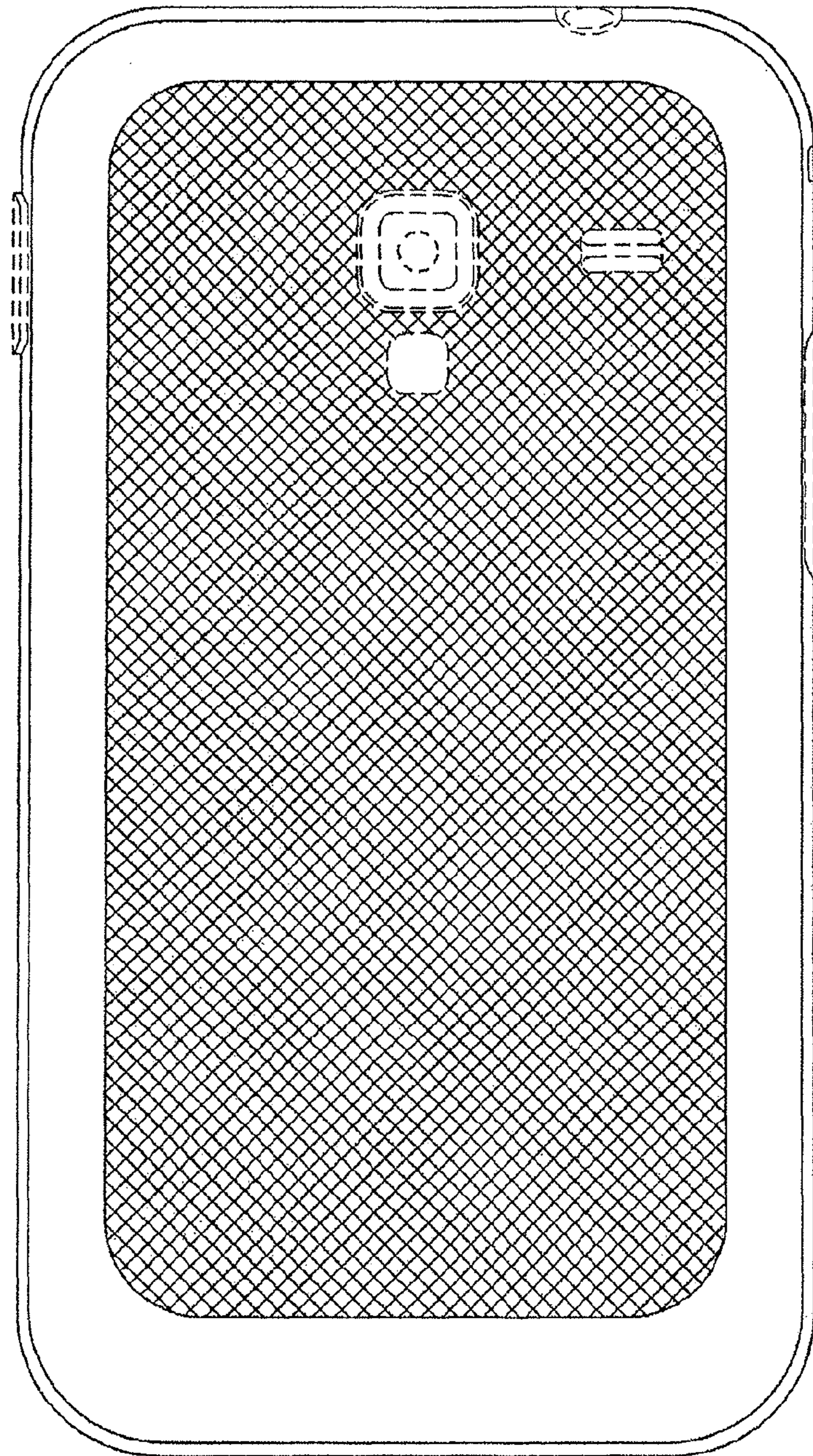

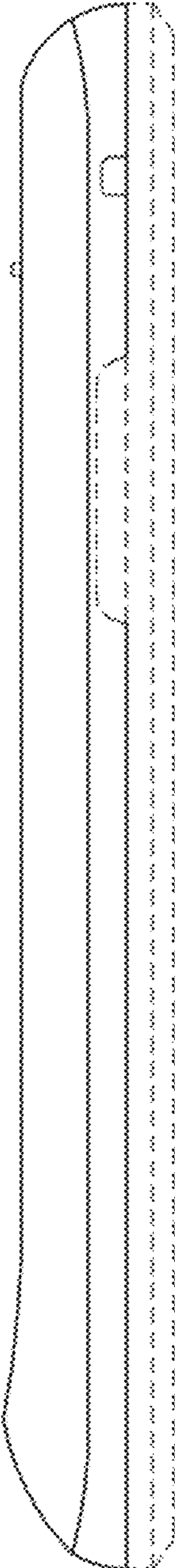

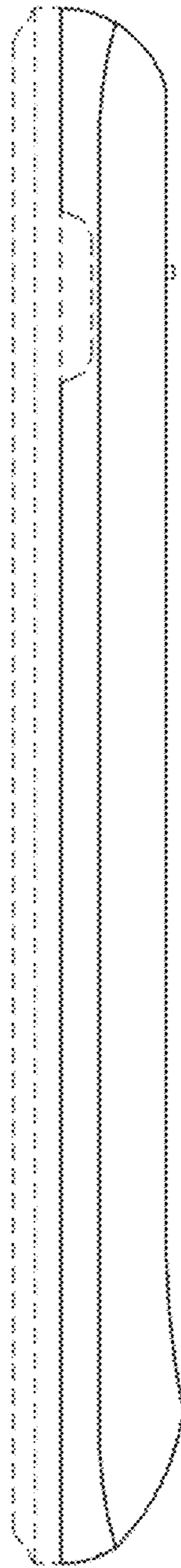

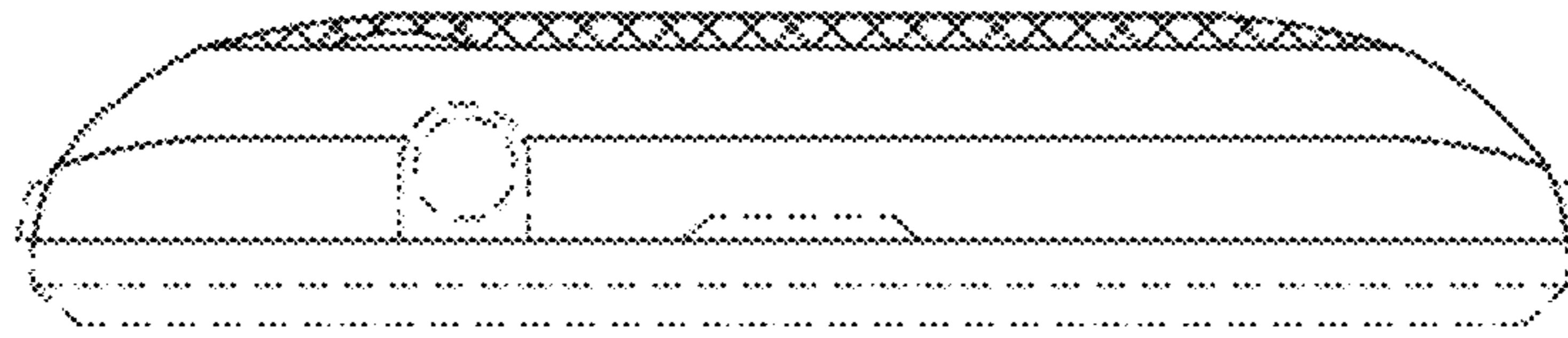

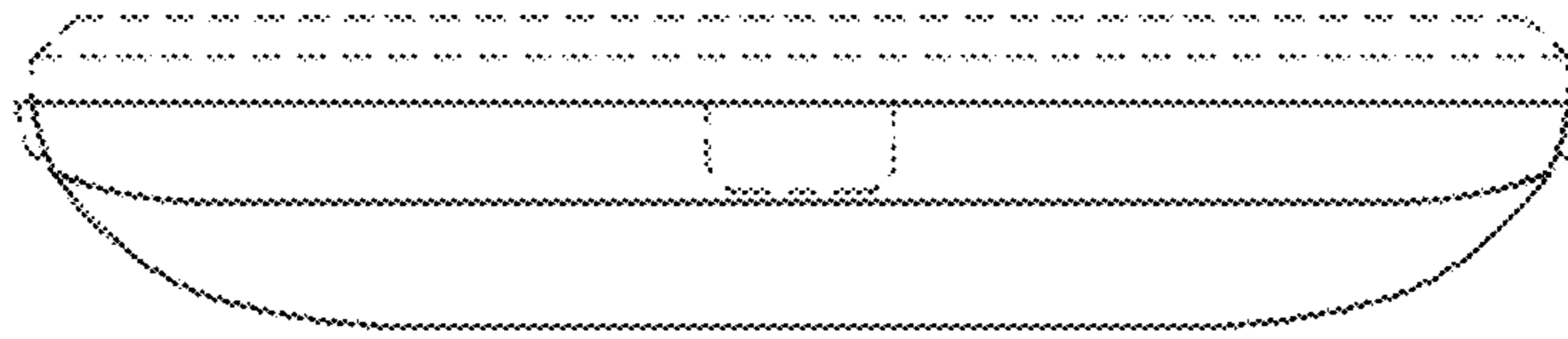
