DESCRIPTION

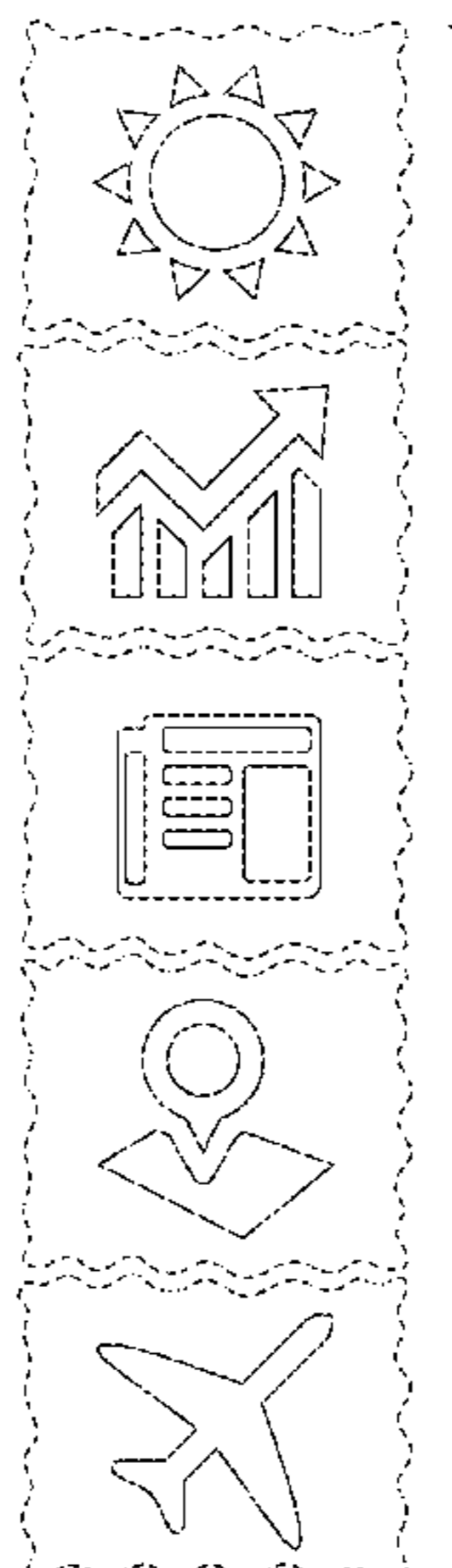
FIG. 1 is a front view of a display screen with icon set showing the new design; and,

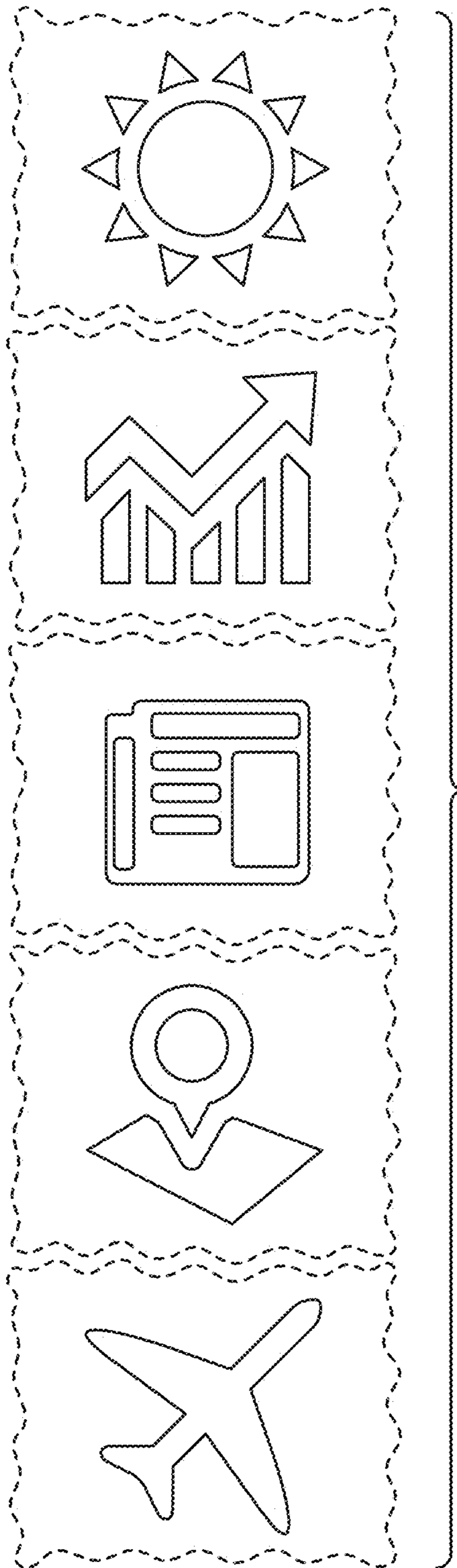

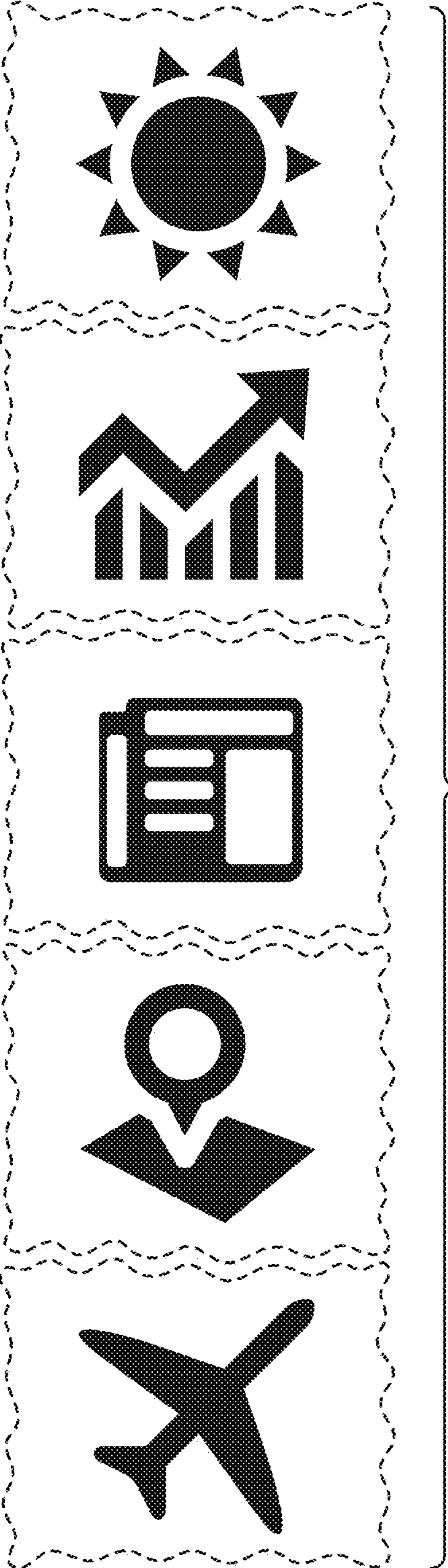
