(57) **CLAIM**

I claim the ornamental design for a tooth for use on the wheel of a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a plan view of the of the tooth for use on the wheel of a vehicle;

FIG. 2 is a front elevation view of the tooth for use on the wheel of a vehicle;

FIG. 3 is a top perspective view of the tooth for use on the wheel of a vehicle;

FIG. 4 is a rear elevation view of the tooth for use on the wheel of a vehicle;

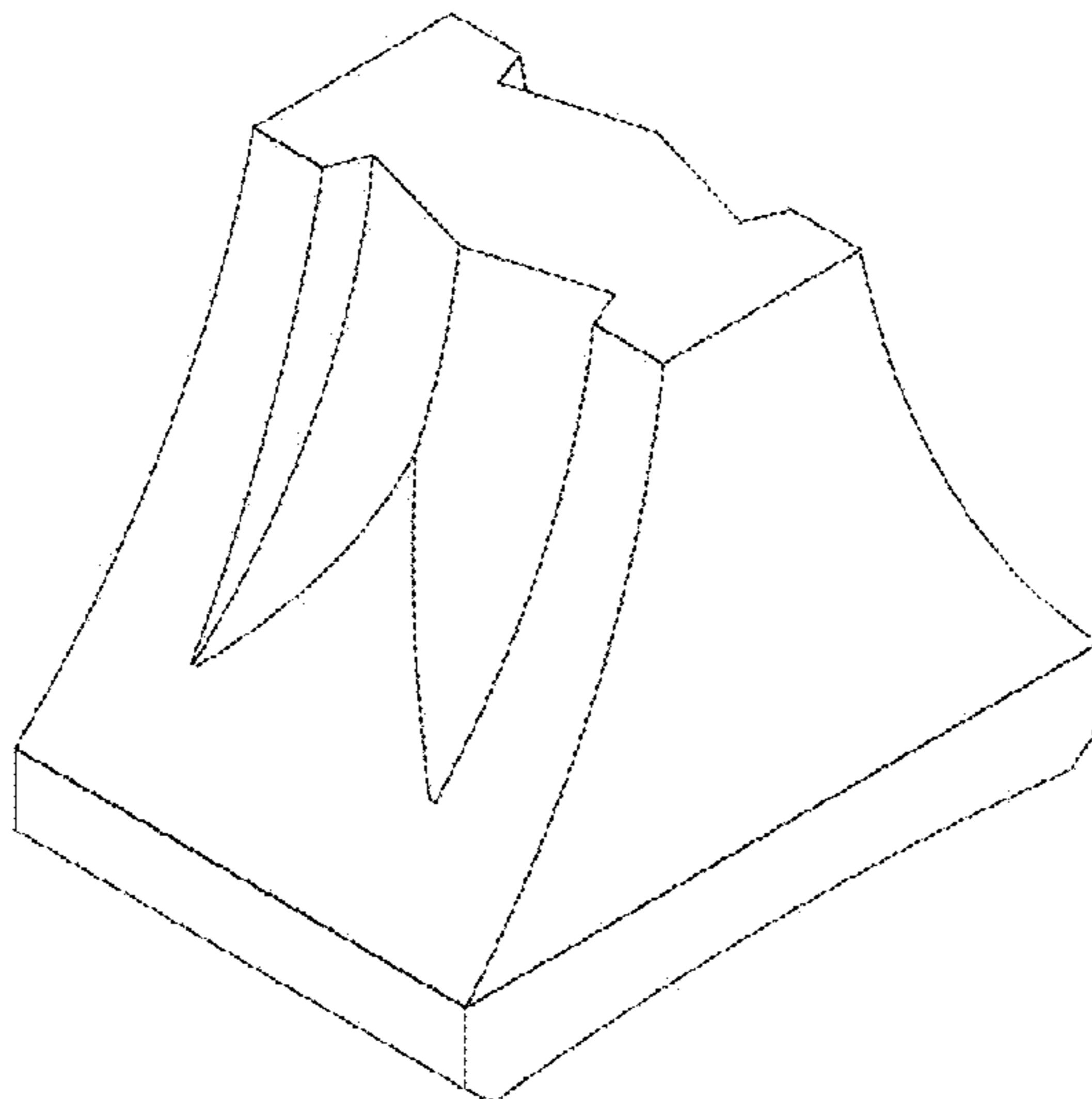
FIG. 5 is a left side elevation view of the tooth for use on the wheel of a vehicle;

FIG. 6 is a right side elevation view of the tooth for use on the wheel of a vehicle; and,

FIG. 7 is a bottom perspective view of the tooth for use on the wheel of a vehicle.

The broken line showing of the surface features in FIG. 7 is included for the purpose of illustrating portions of the tooth for use on the wheel of a vehicle and forms no part of the claimed design.

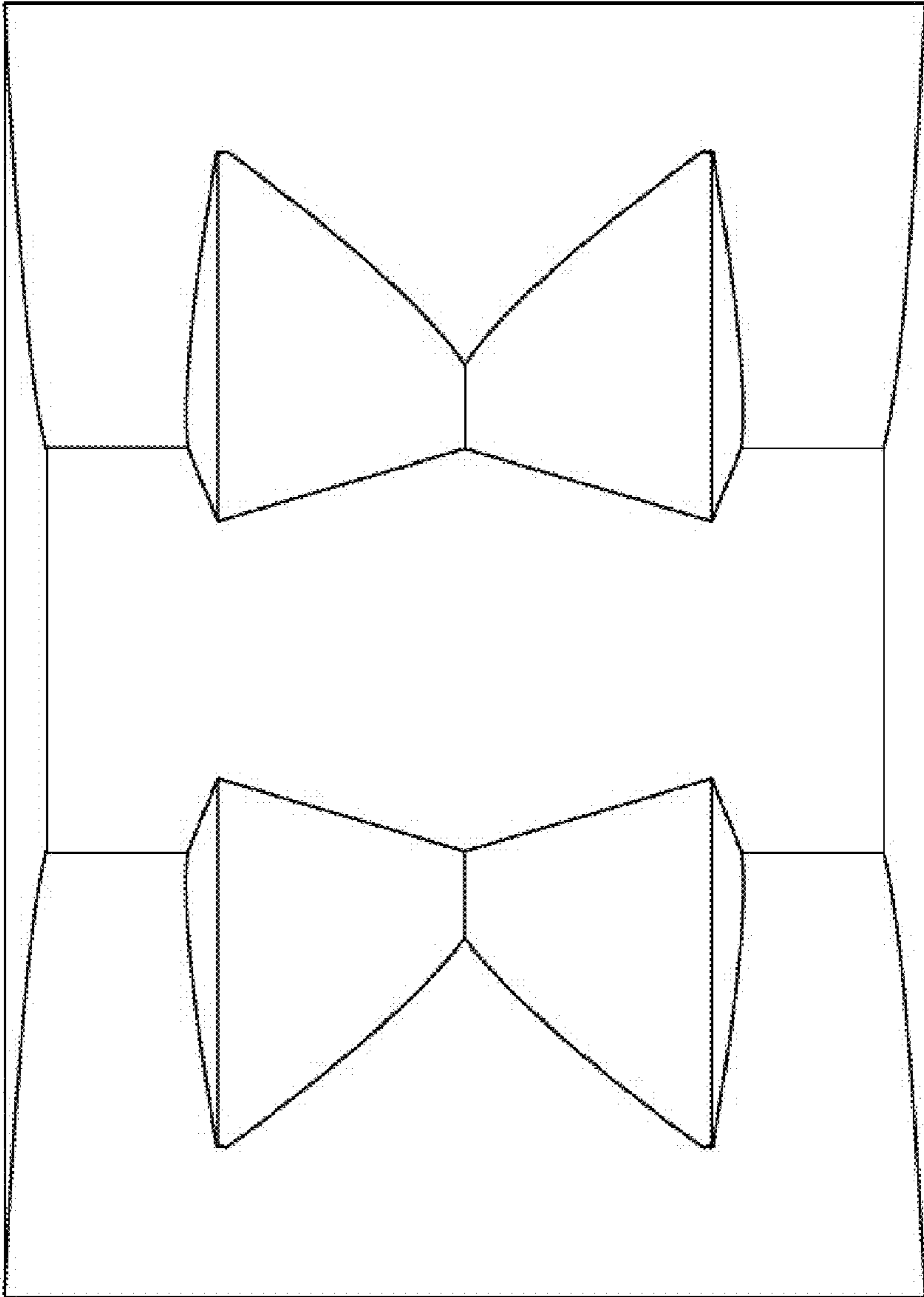

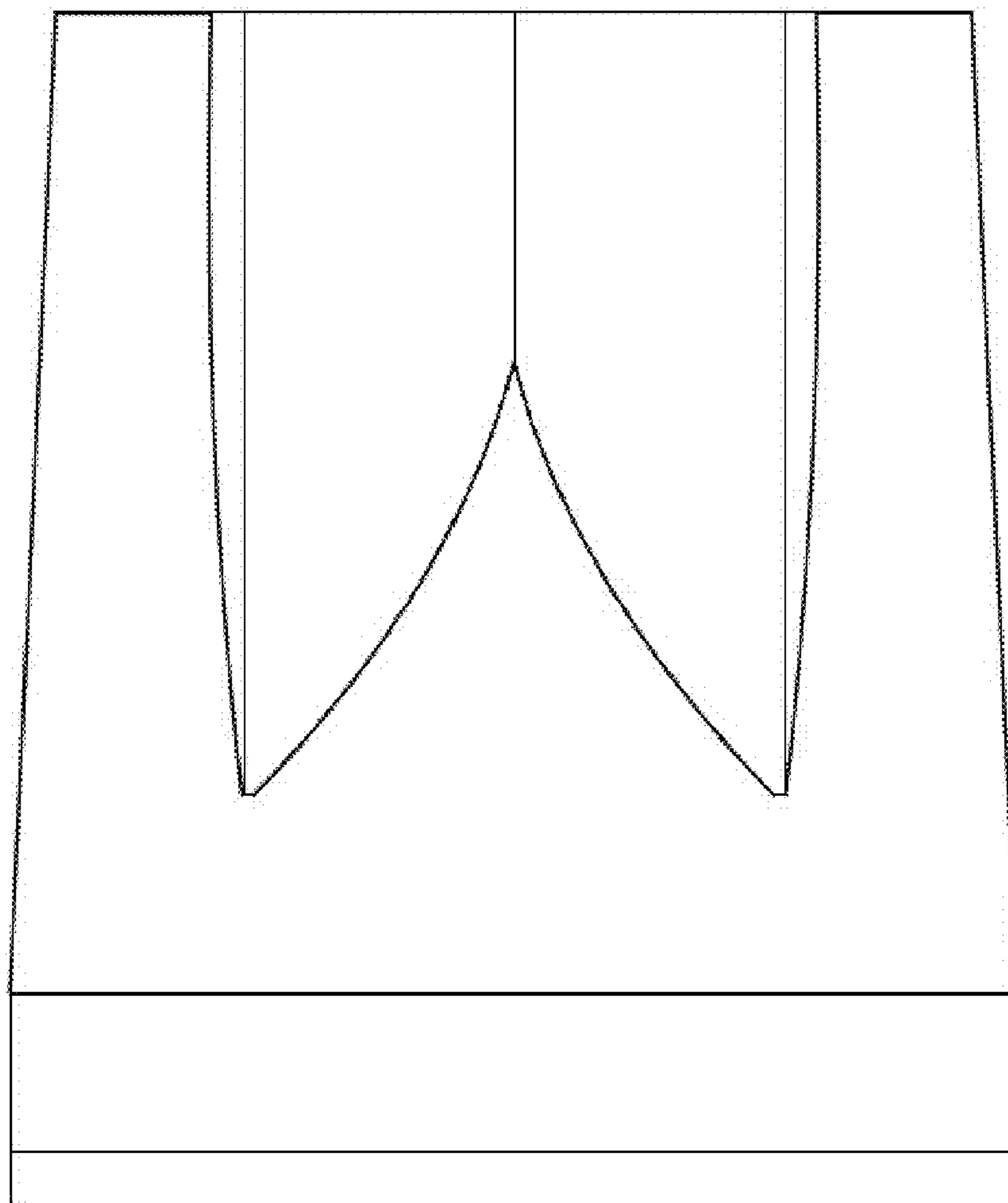

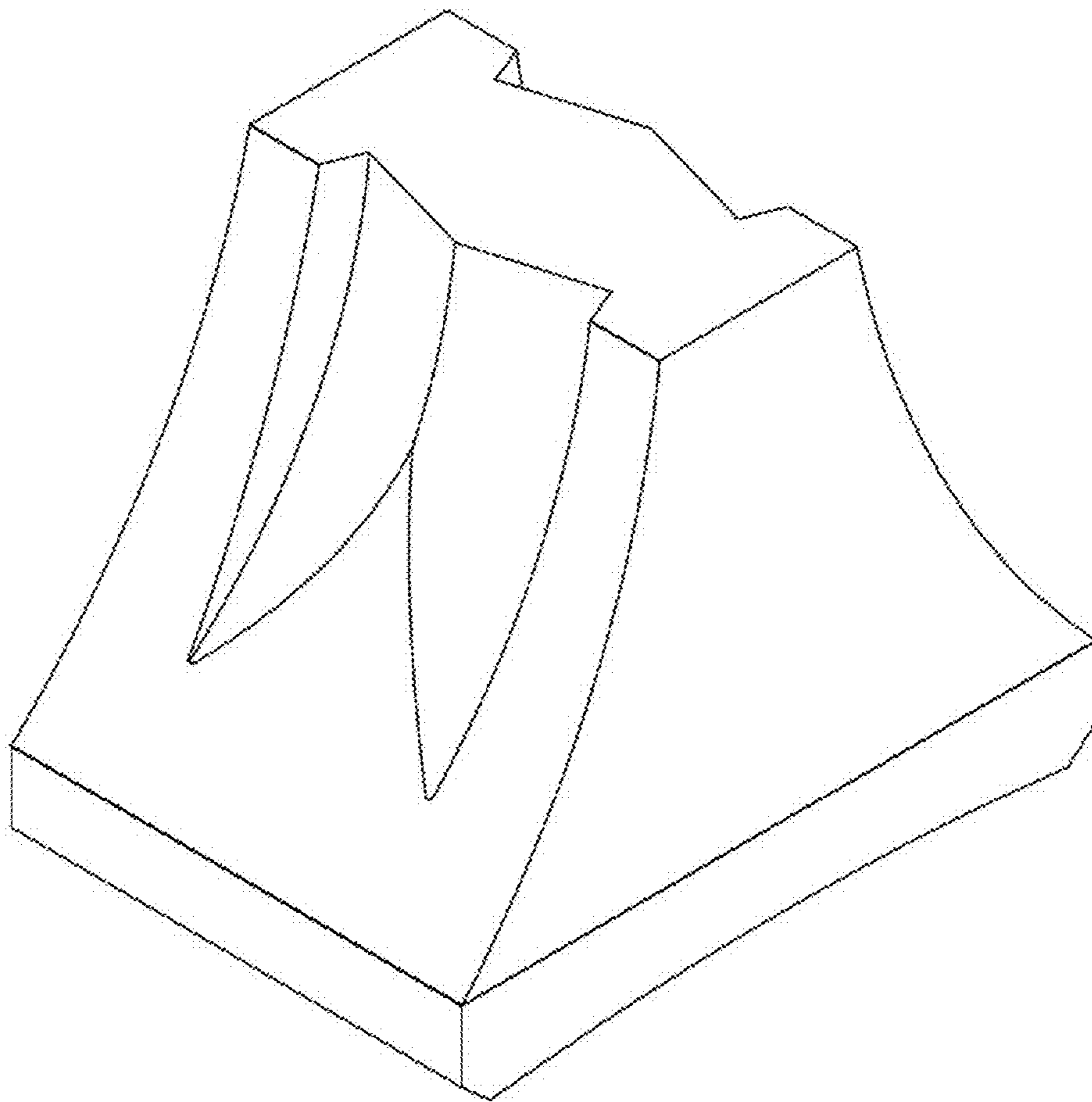

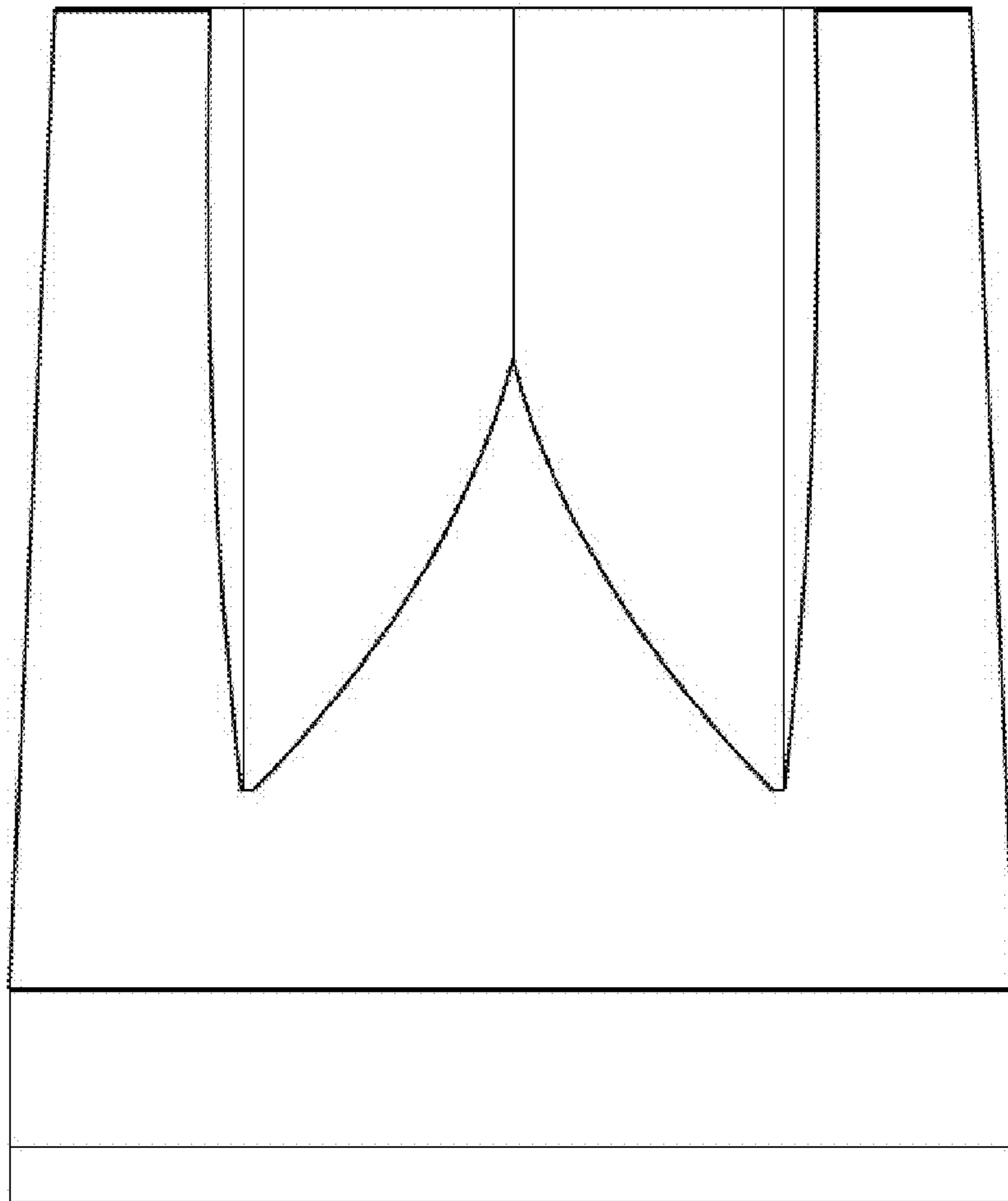

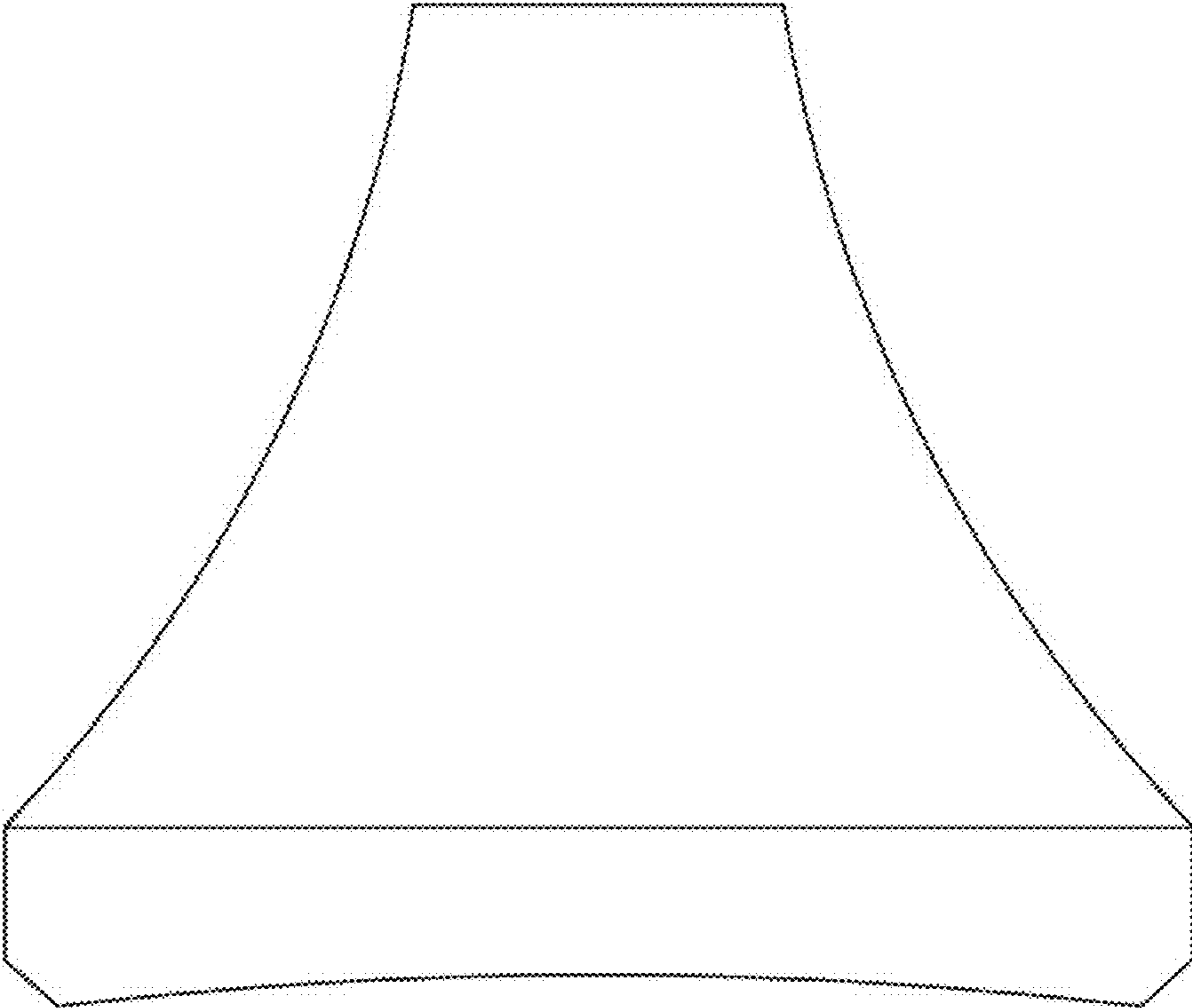

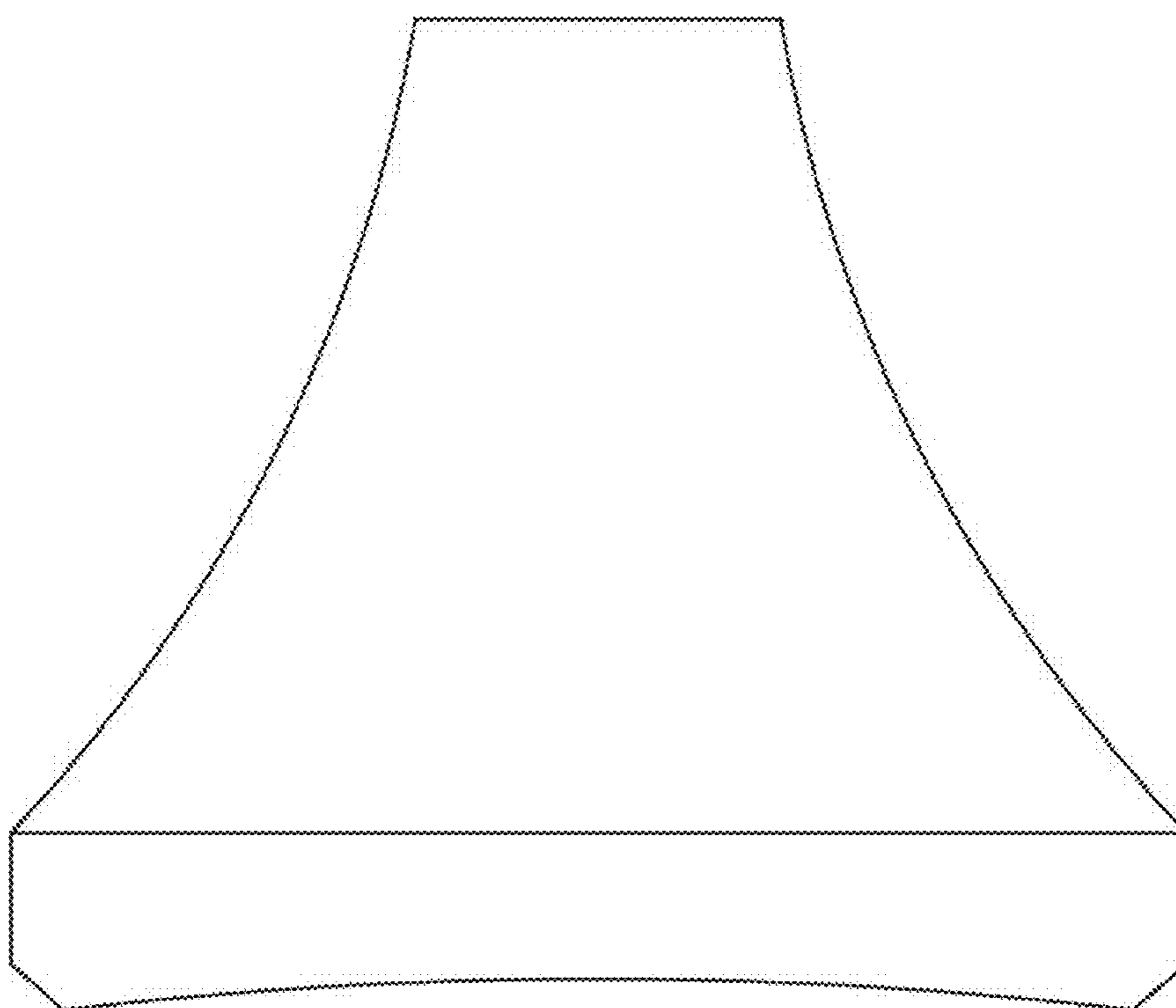

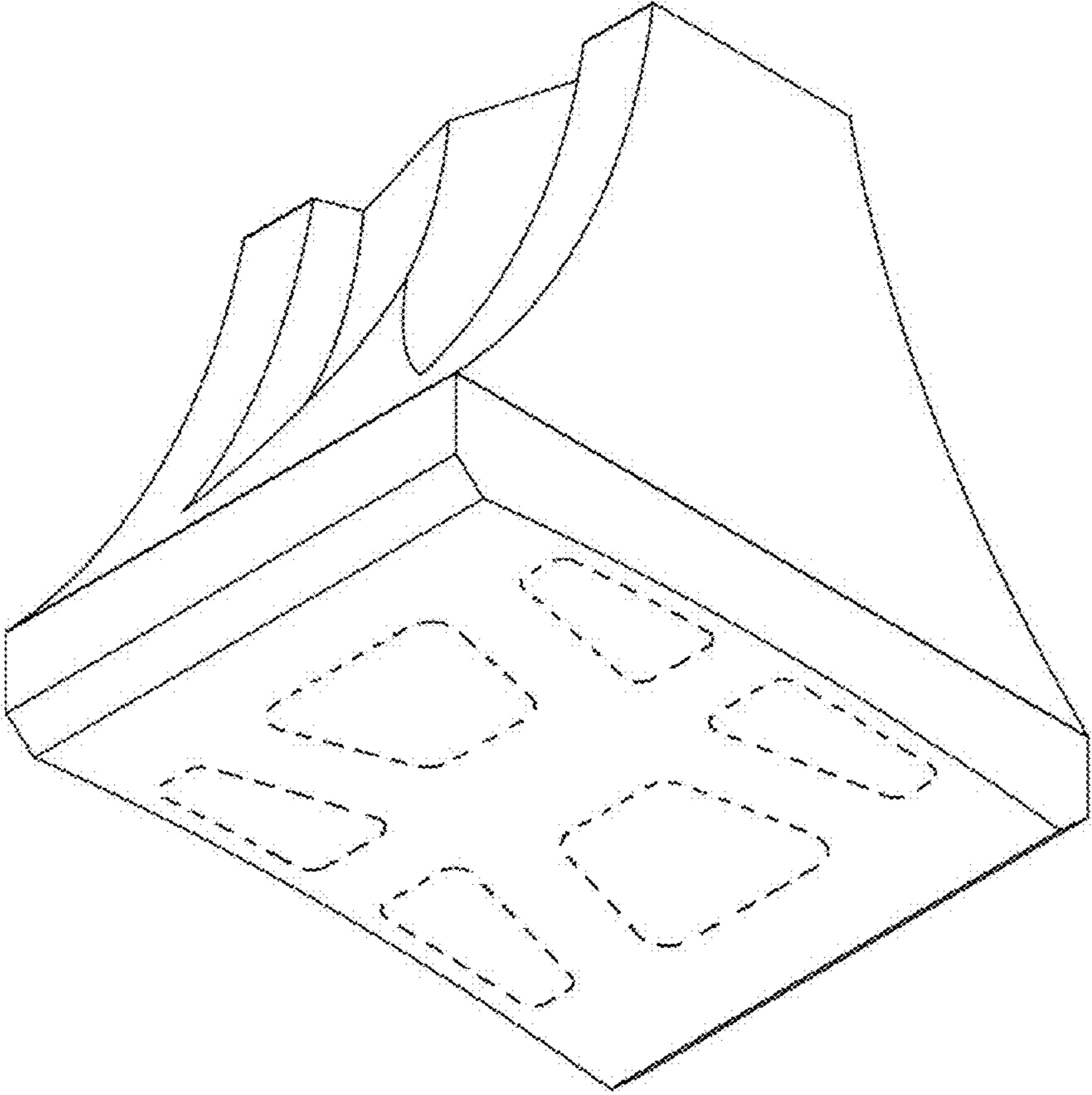
