I claim the ornamental design for a raingutter sun shade for open animal shelter, as shown and described.

**DESCRIPTION**

FIG. 4 is a first end elevation view of the design of FIG. 1;

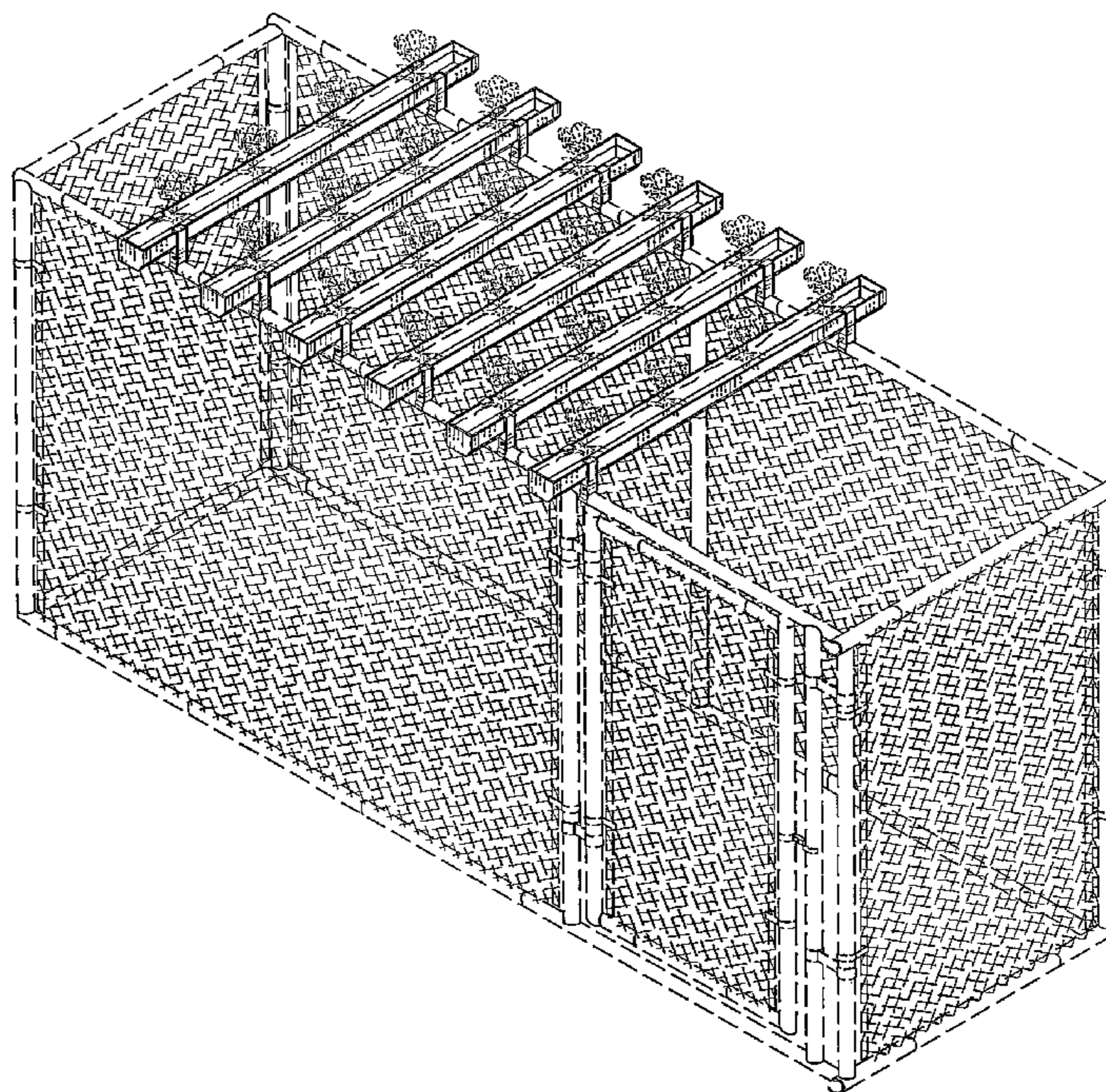
FIG. 5 is a second end elevation view of the design of FIG. 1;

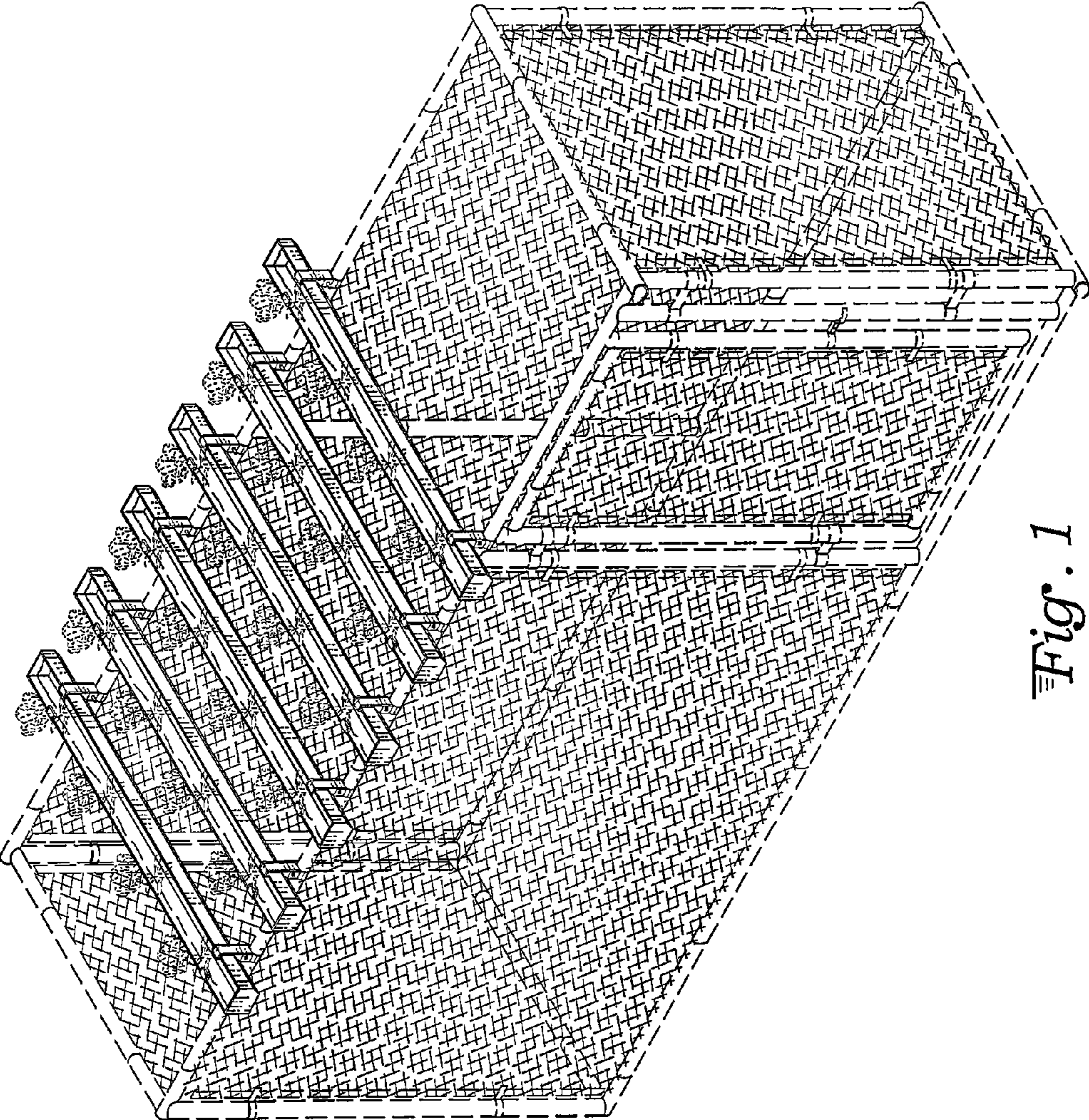

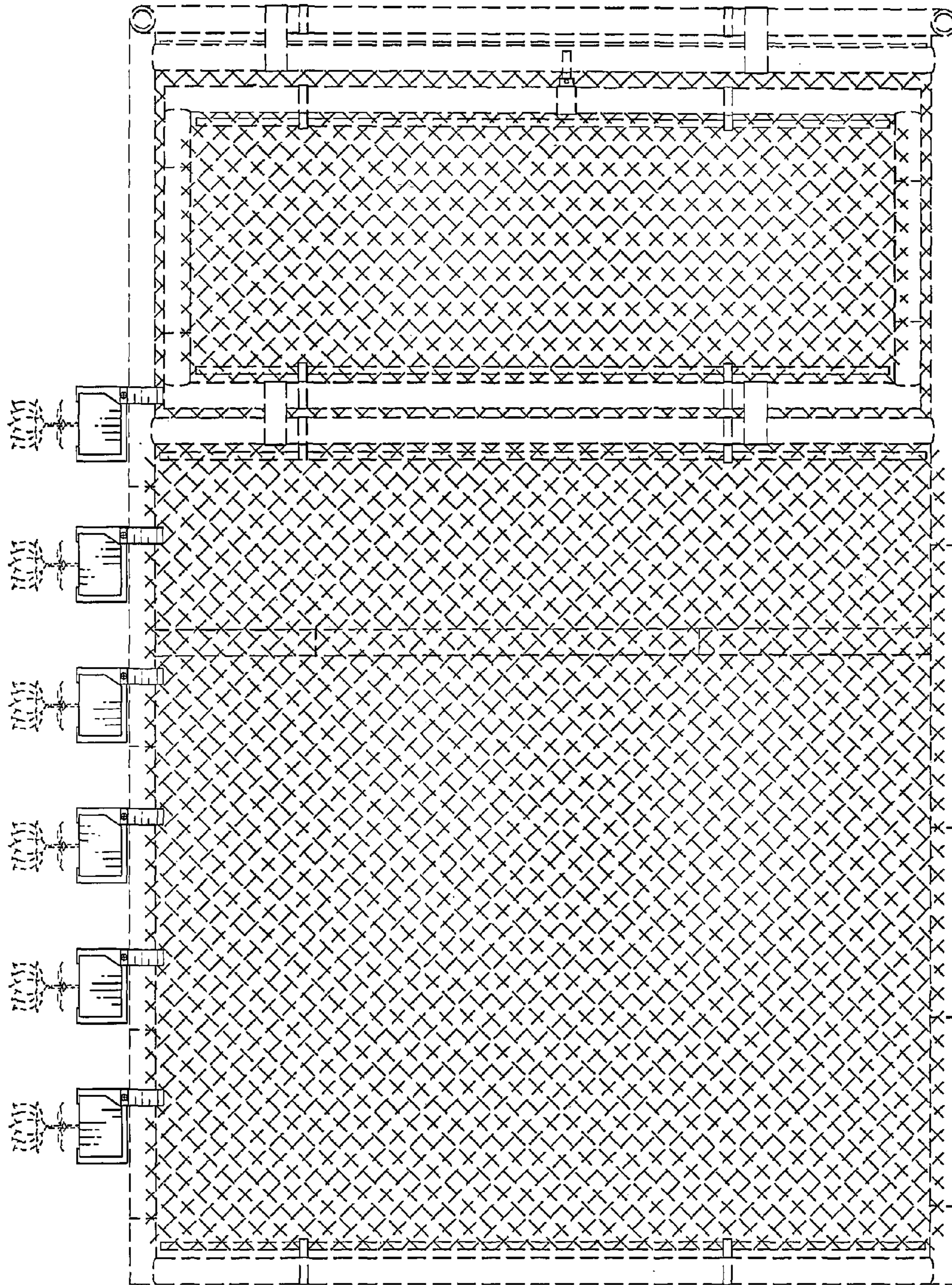

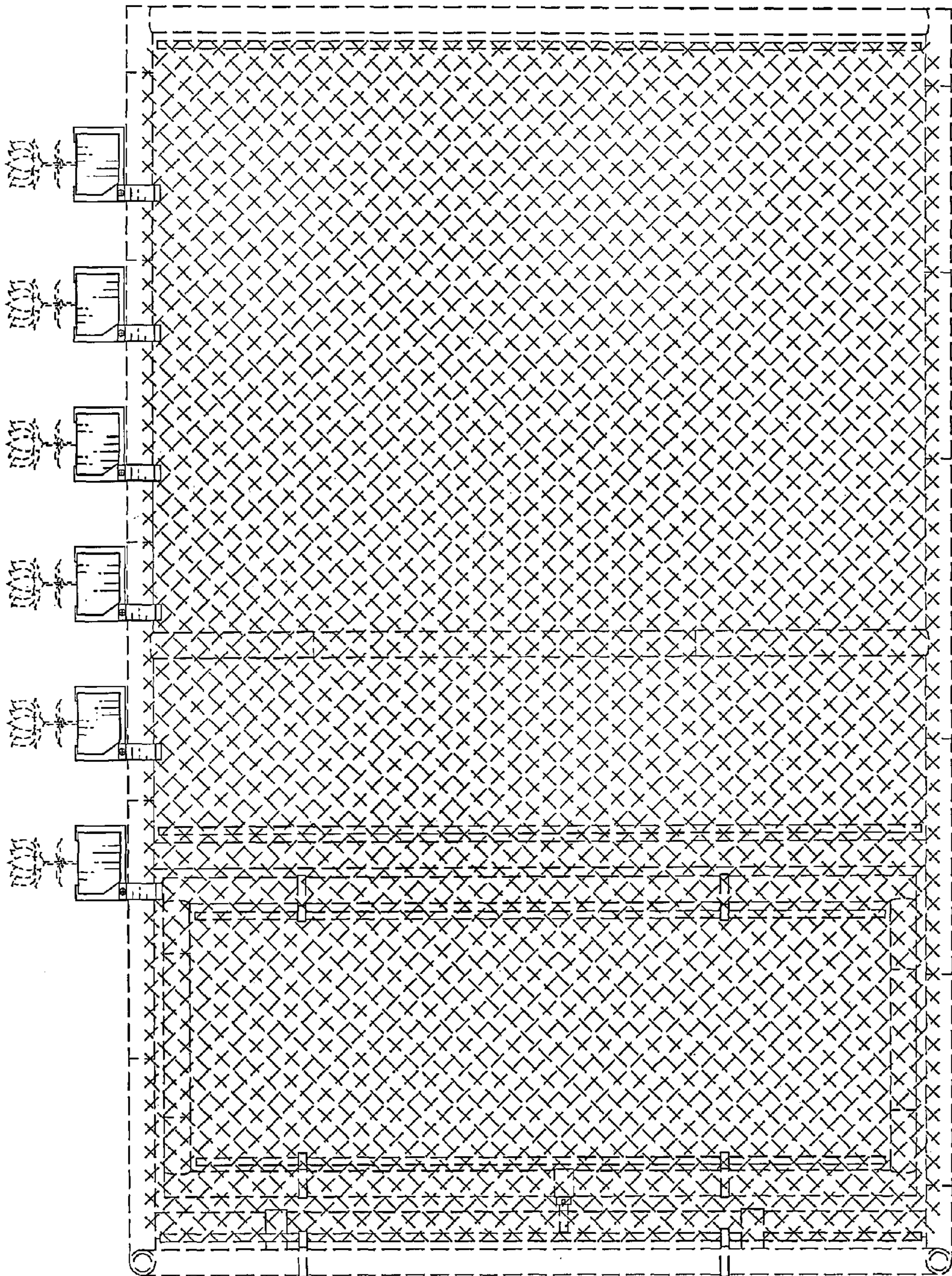

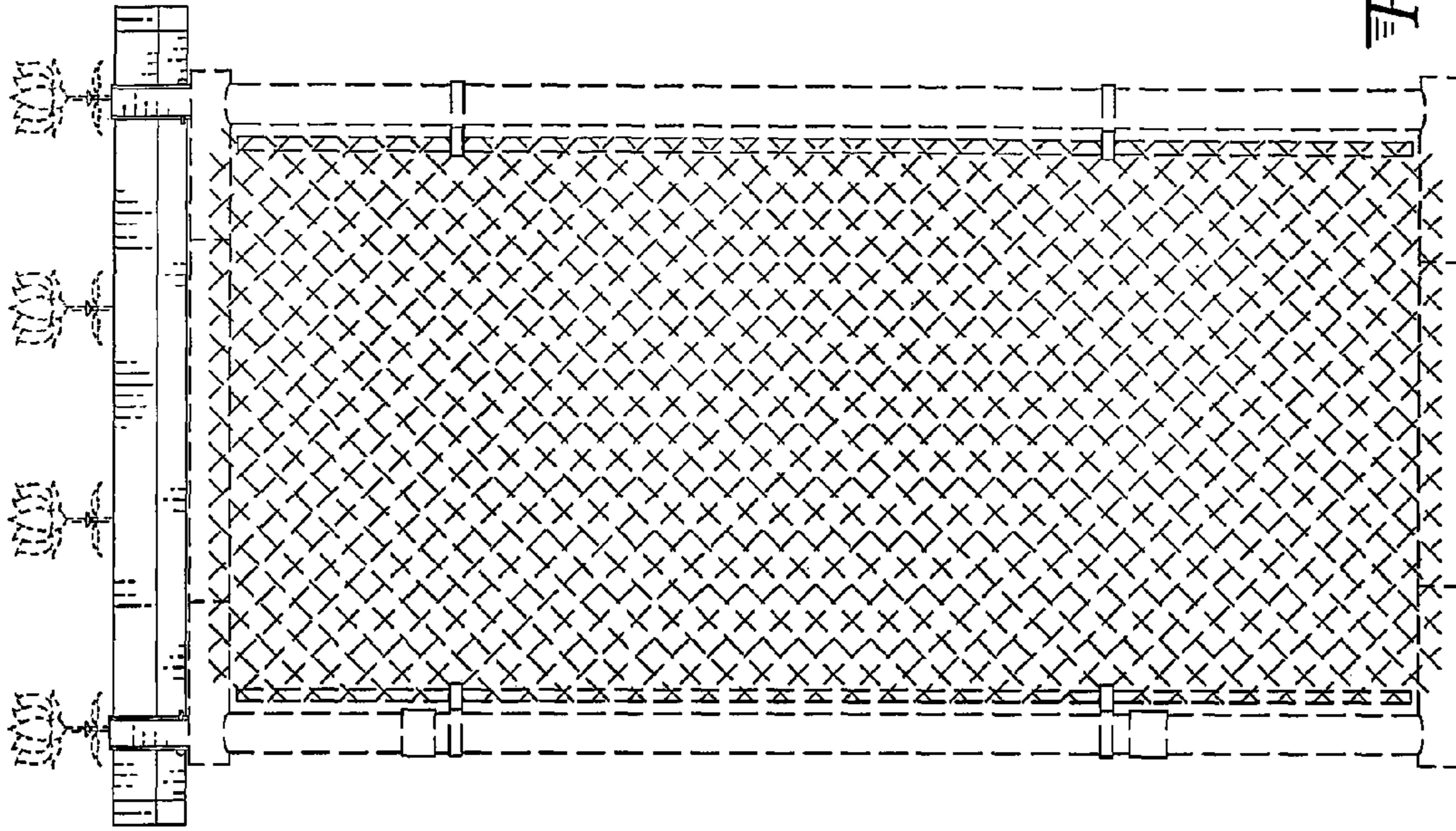

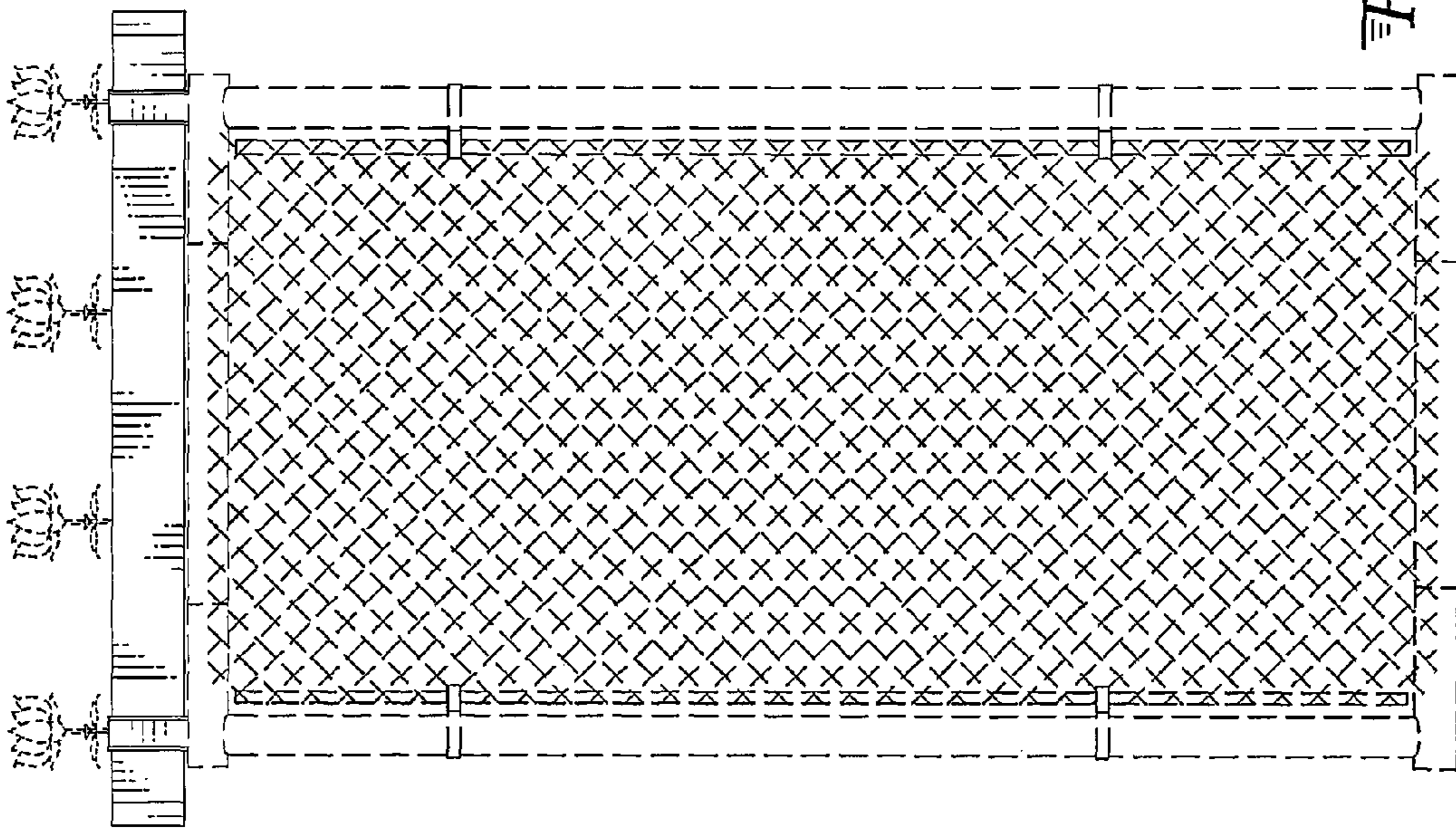

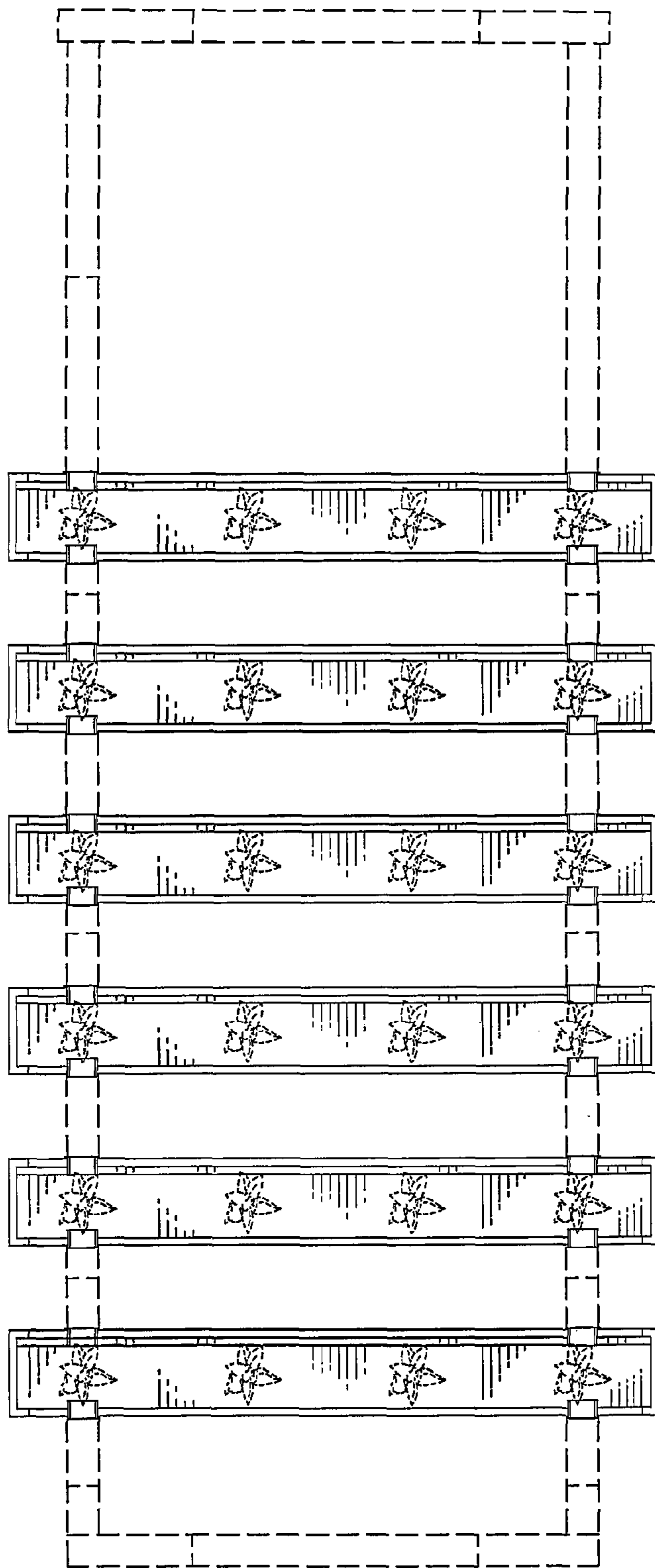

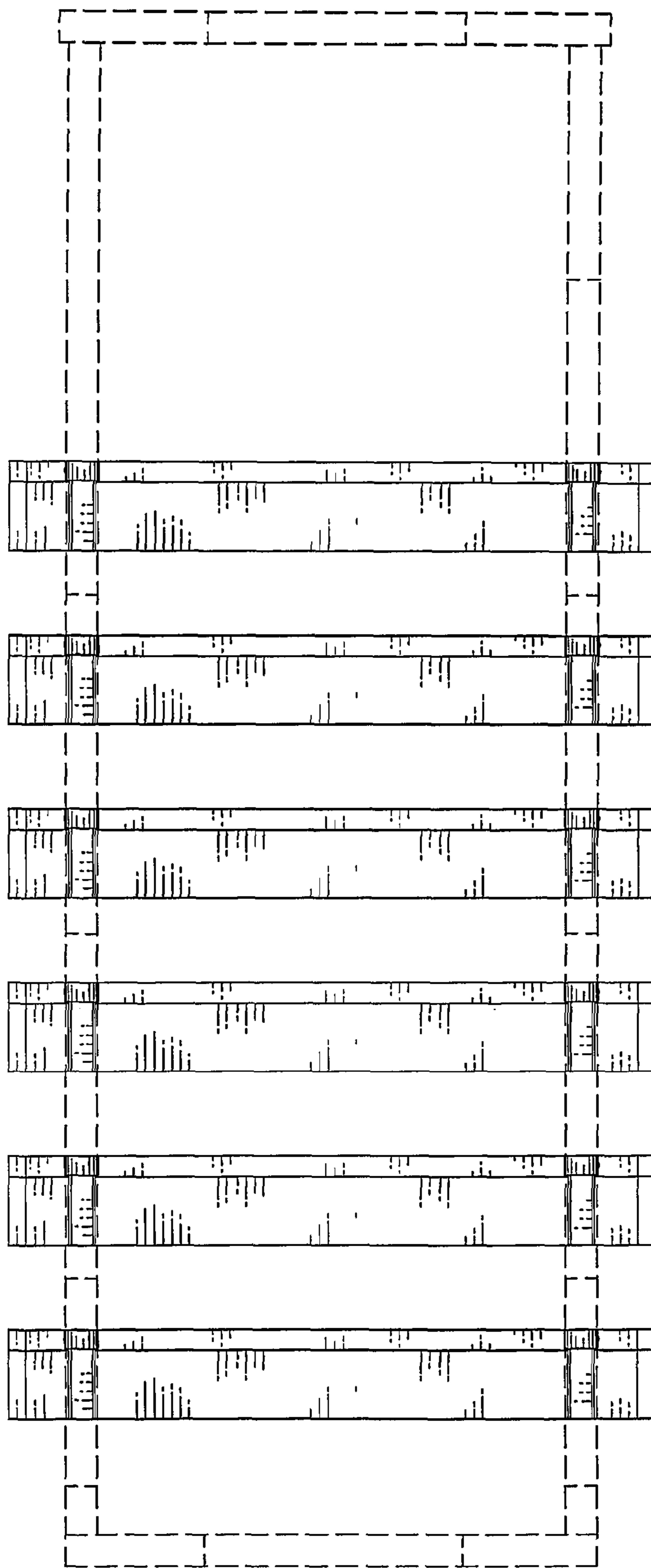
