FIG. 14 is a bottom view of the dental matrix band of FIG. 8.

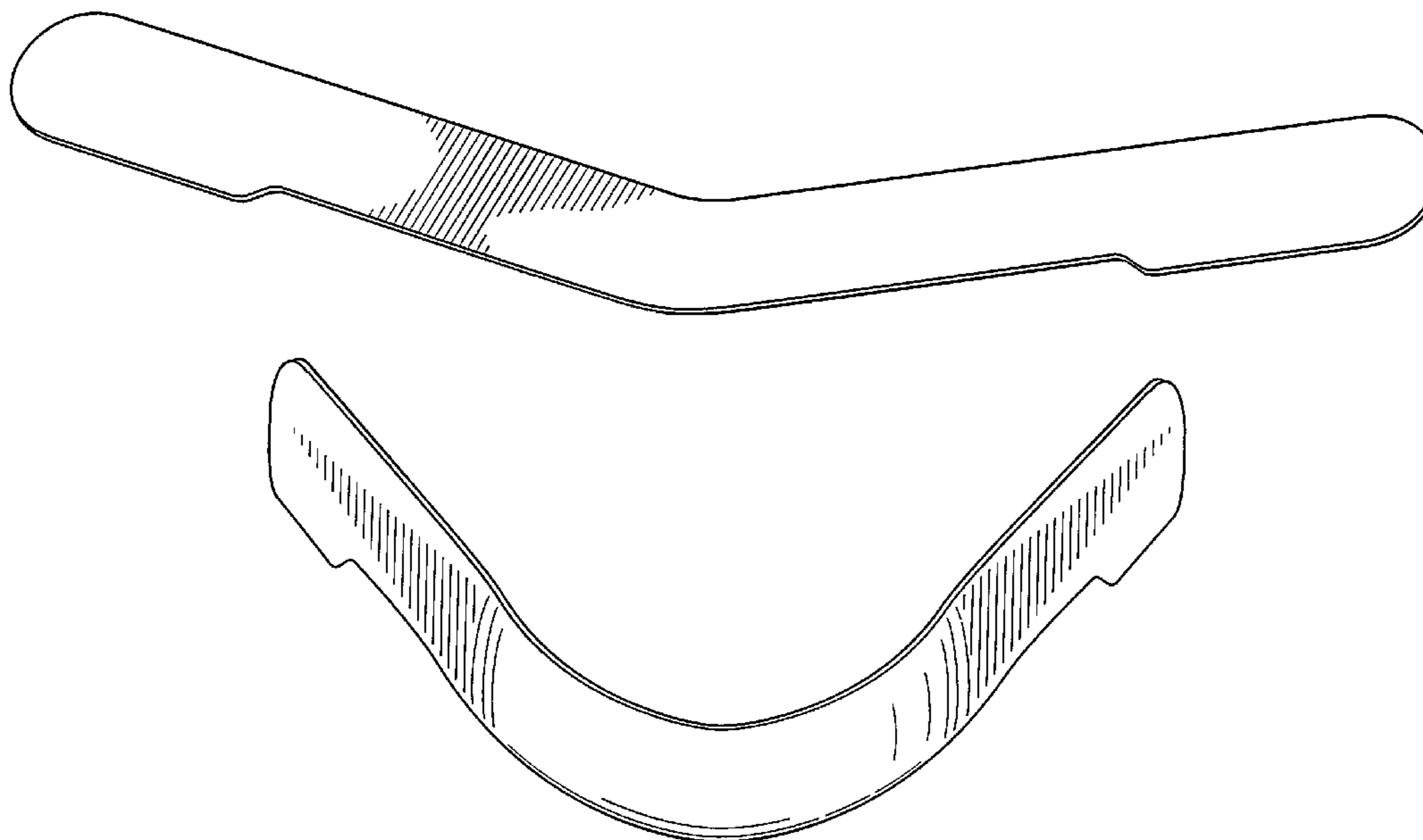

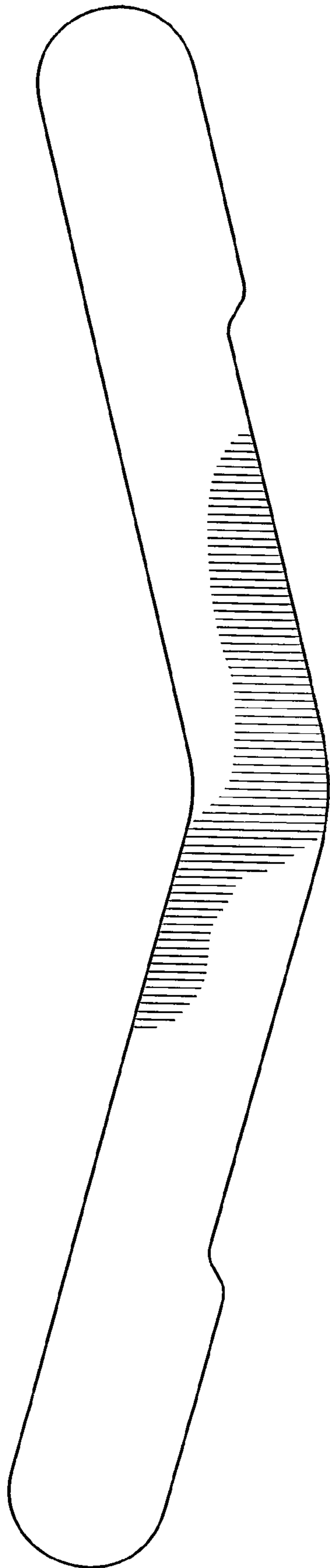

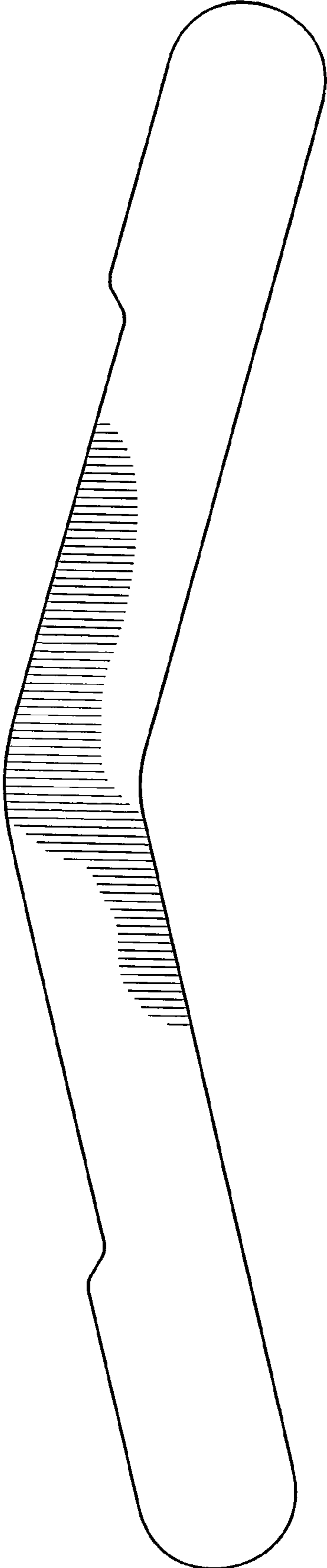
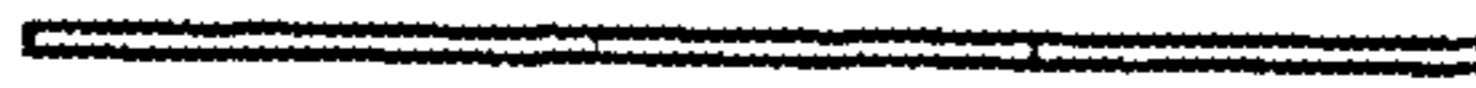
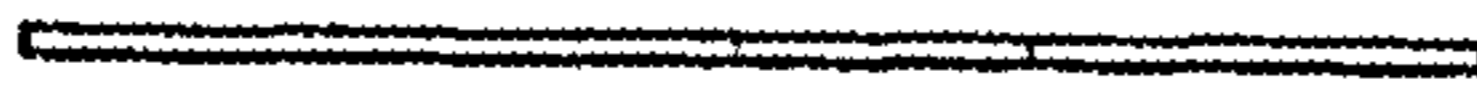

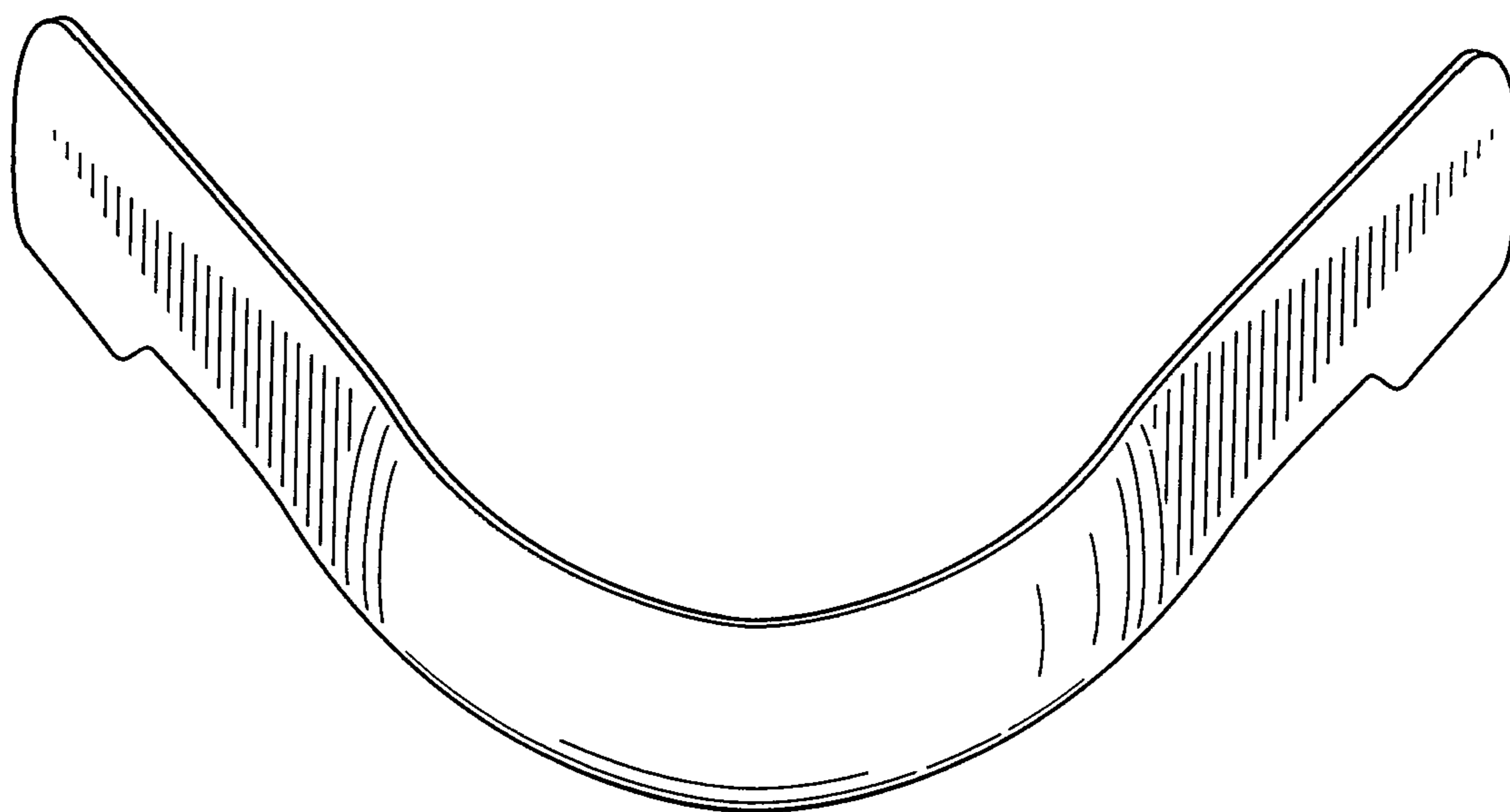

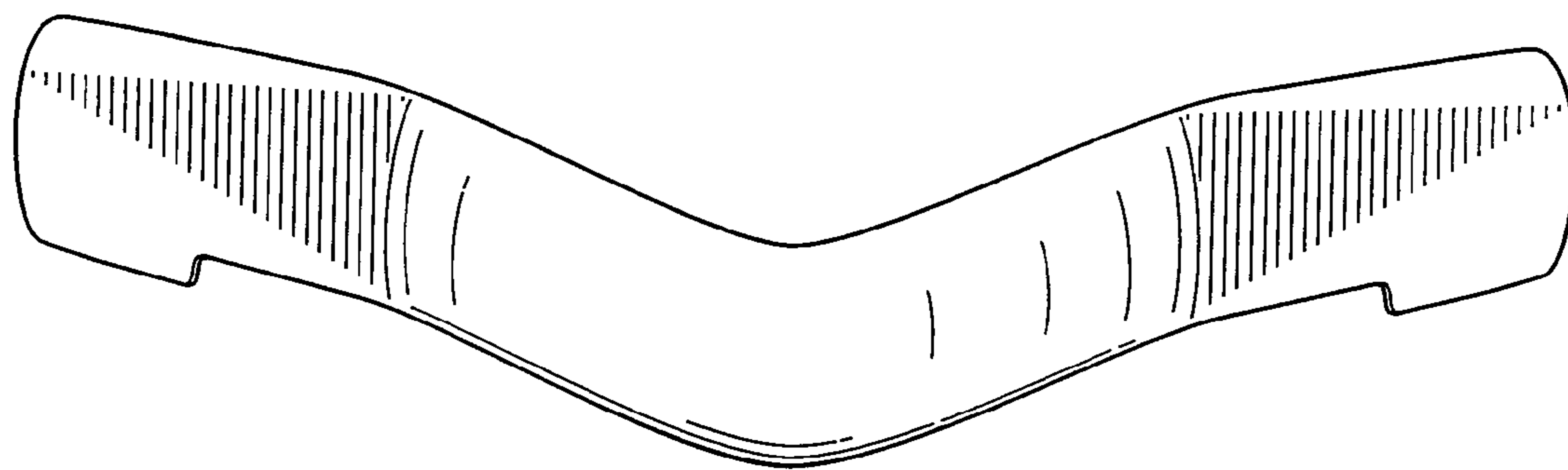

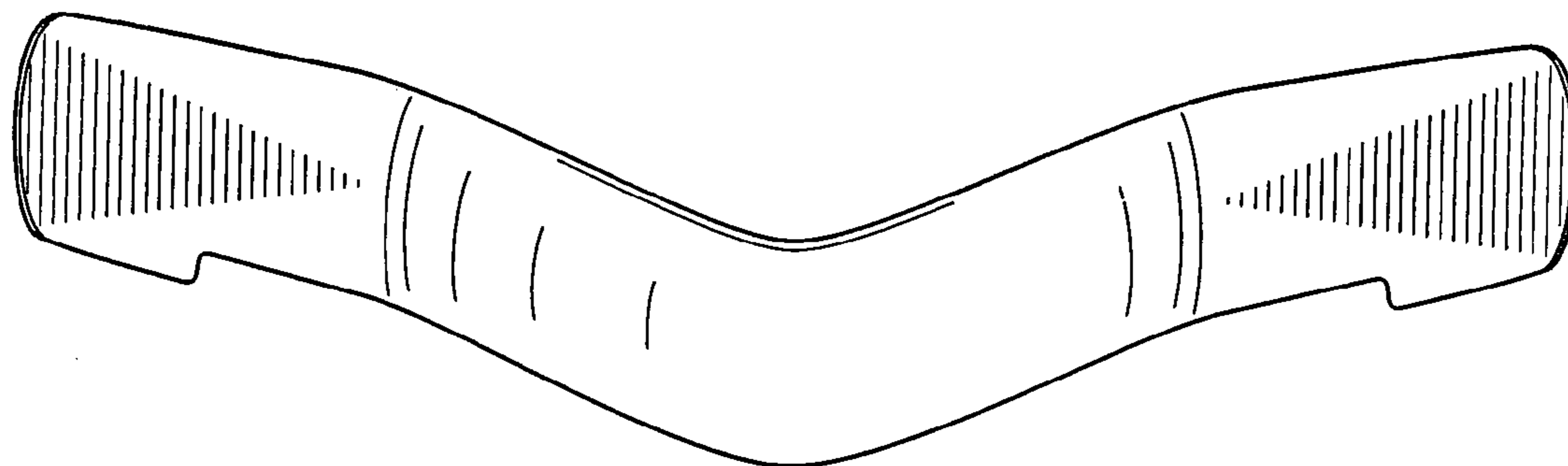

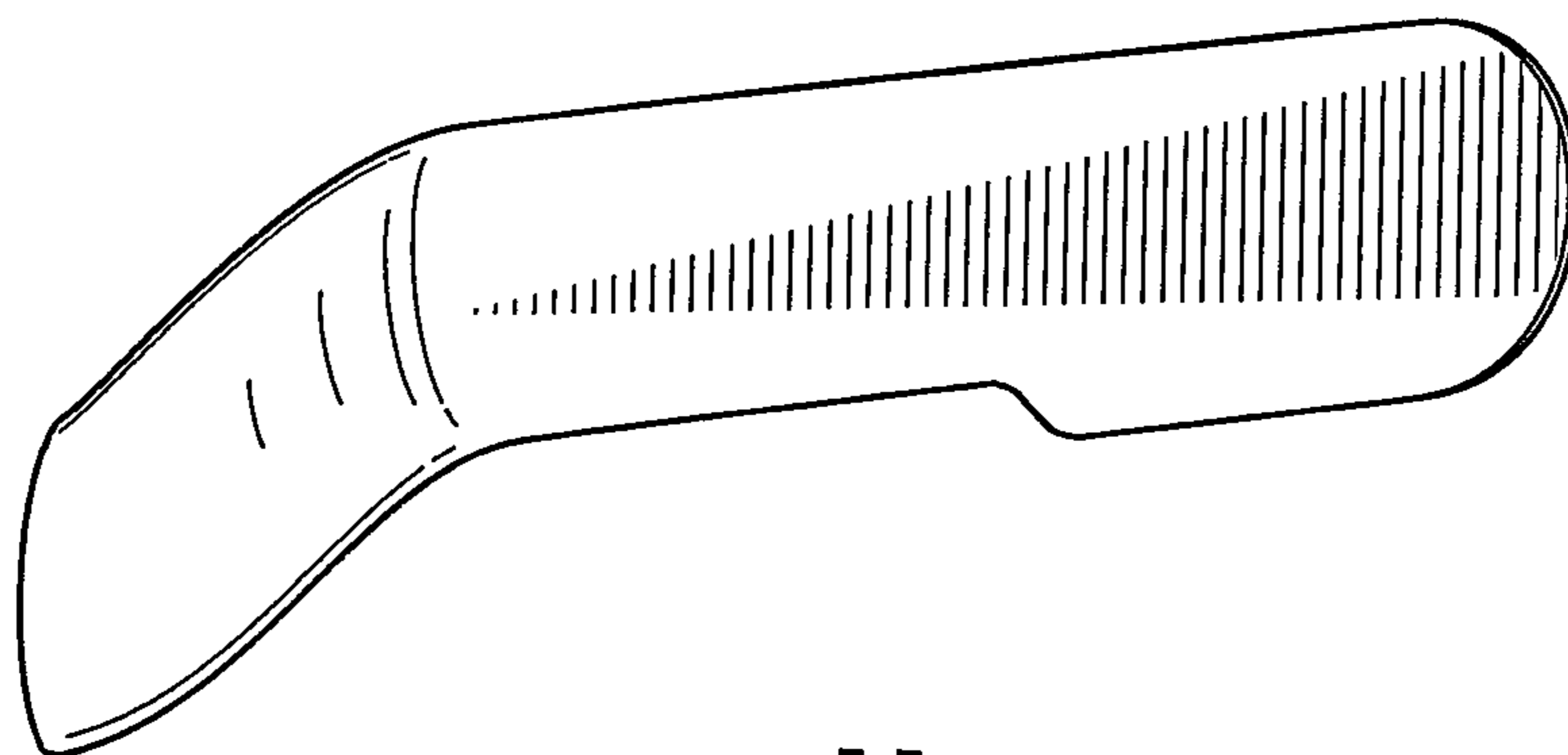




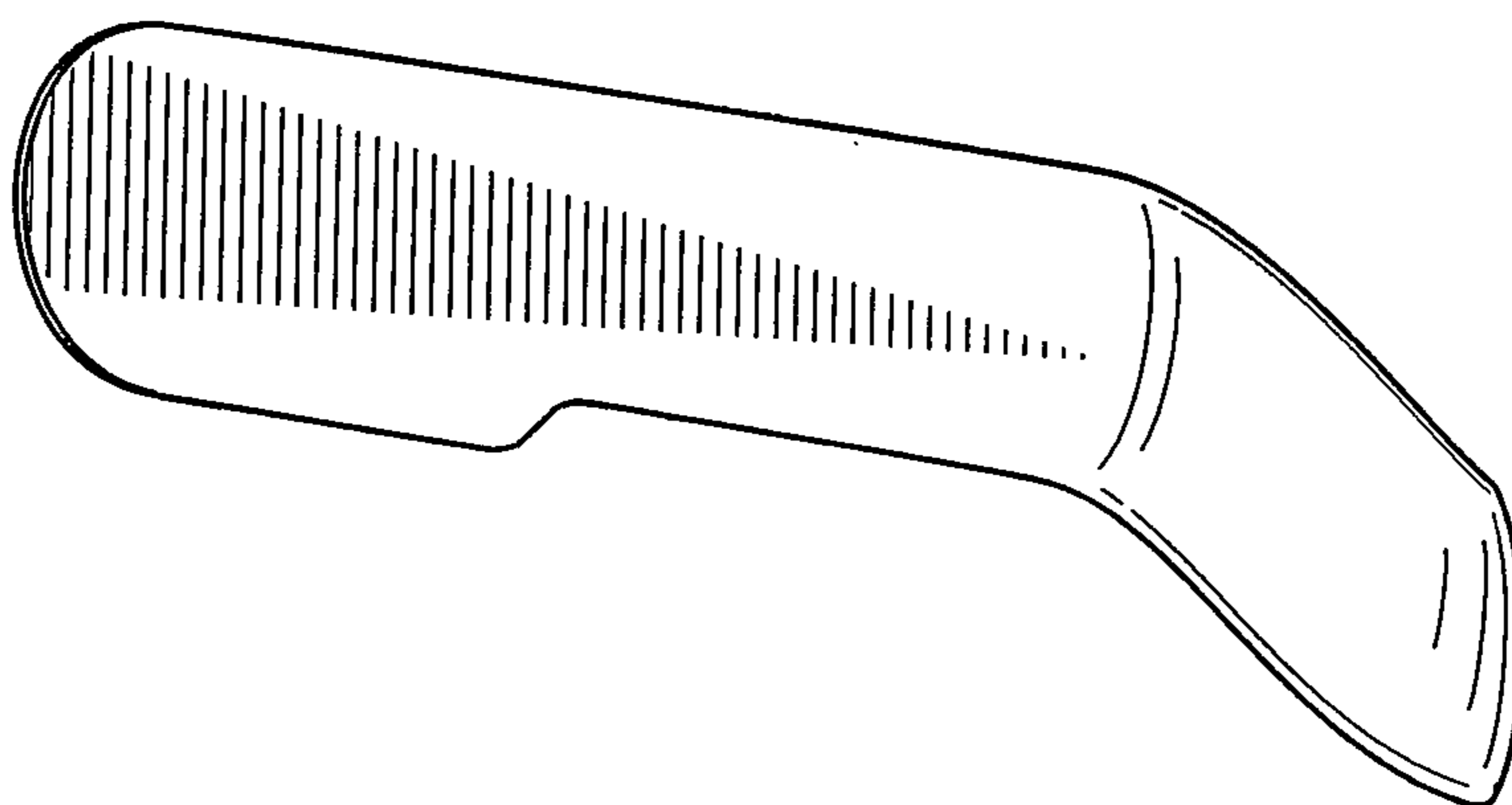

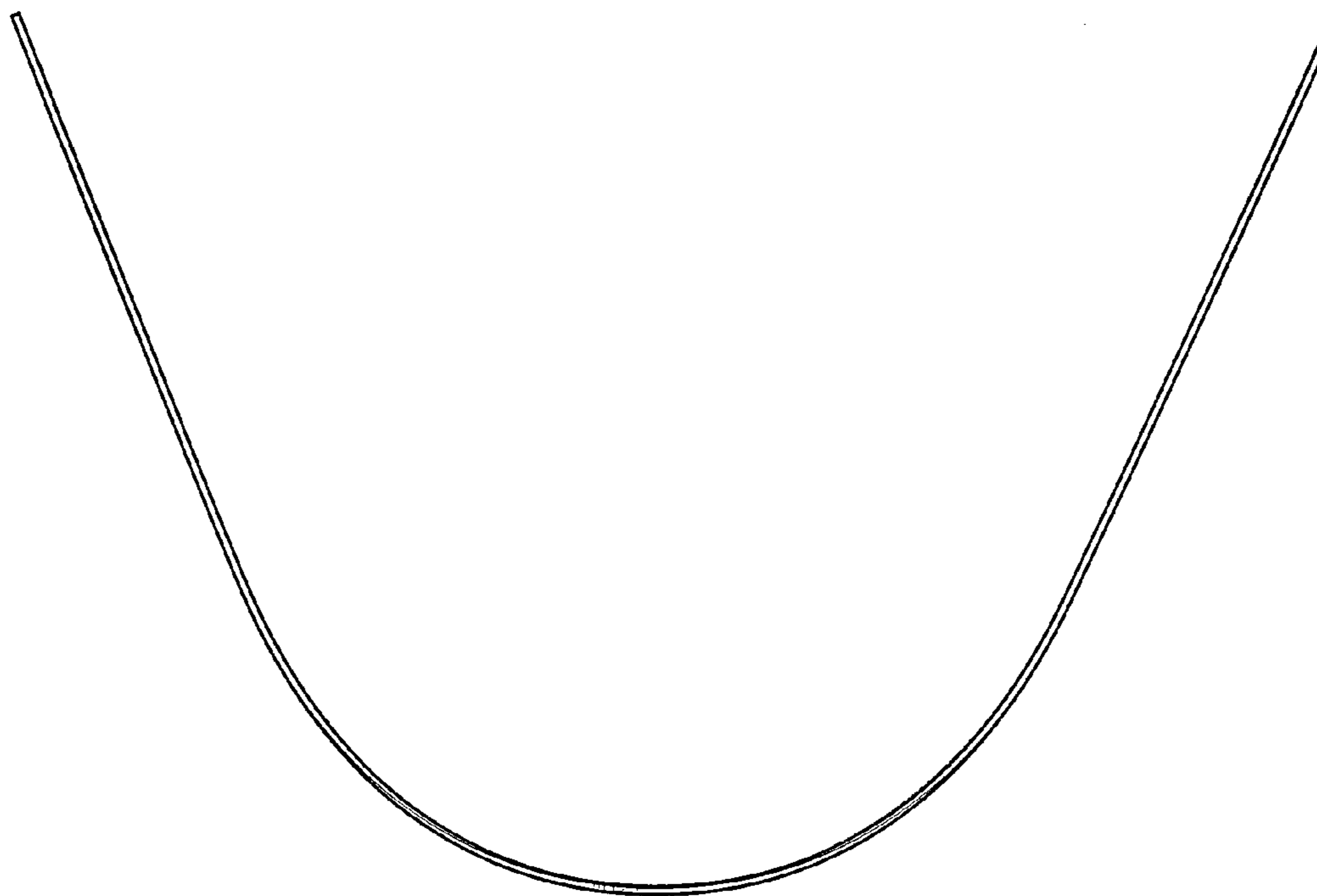

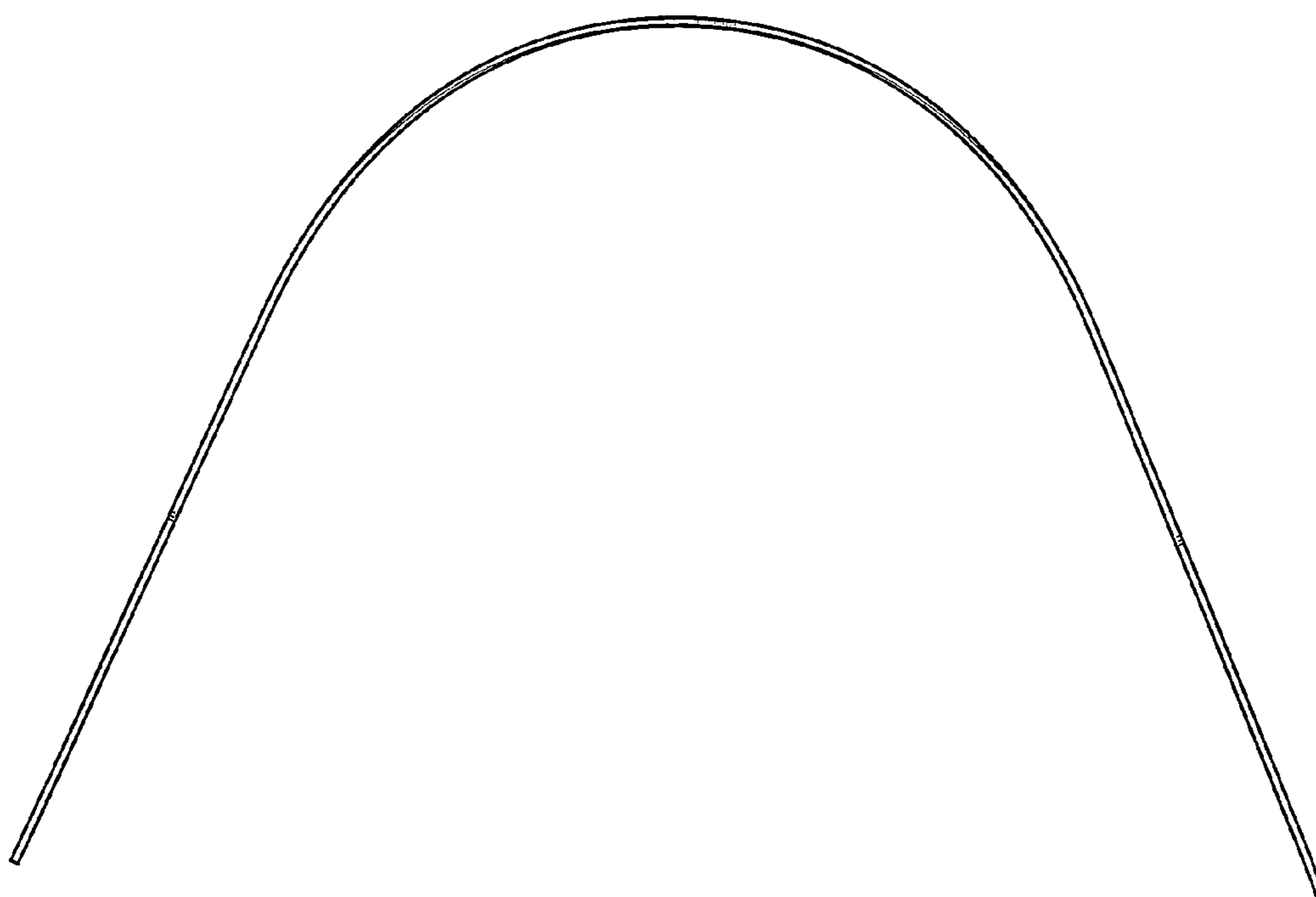
