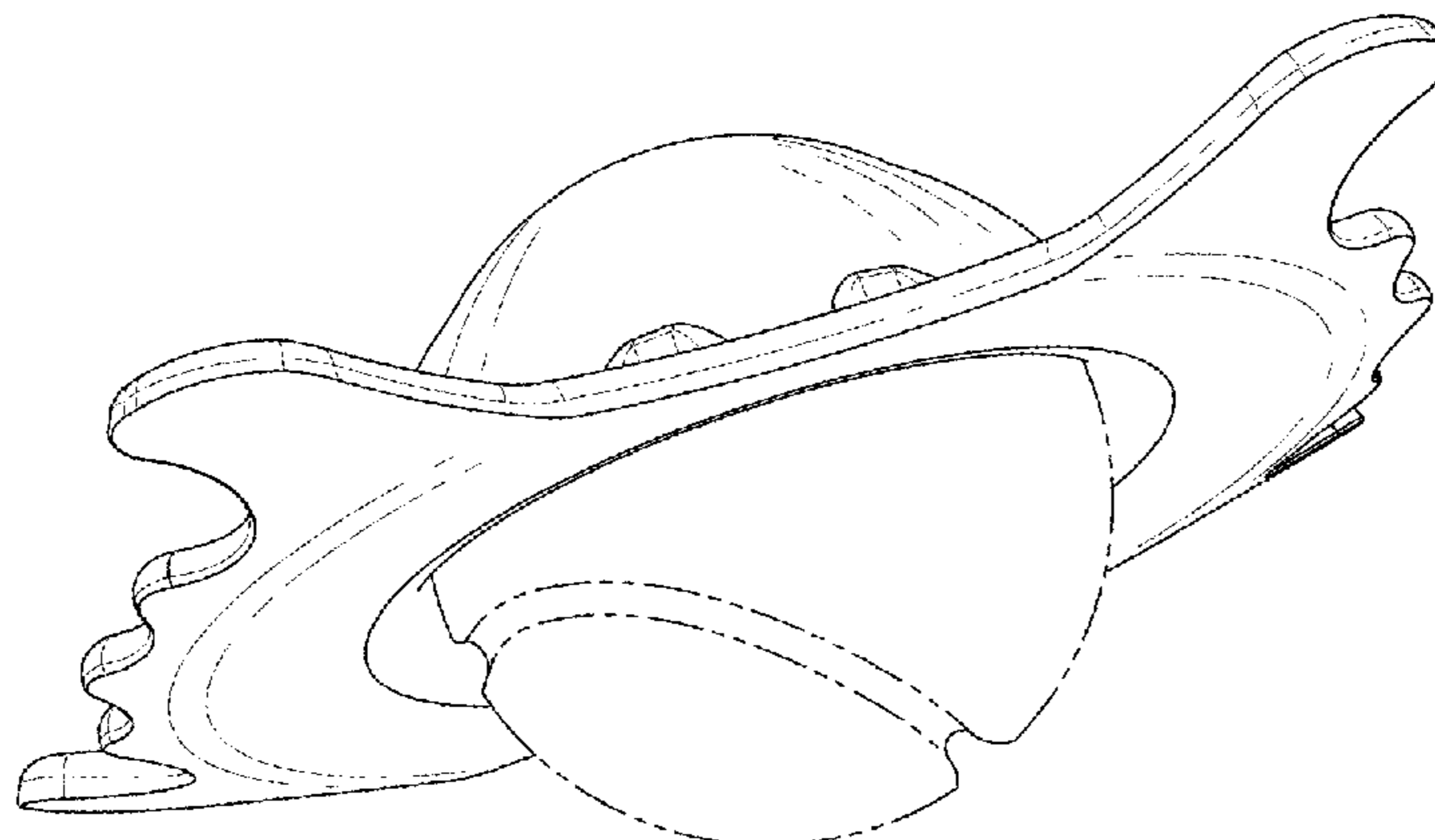
(57) **CLAIM**

FIG. 5 is an end elevation view of the embodiments shown in
FIGS. 1 and 2, the other end being a mirror image.
FIG. 6 is a side elevation view of the embodiments shown in
FIGS. 1 and 2, the other side being a mirror image; and,
FIG. 7 is a perspective view of one embodiment of the present
teachings including a ball to illustrate environment.

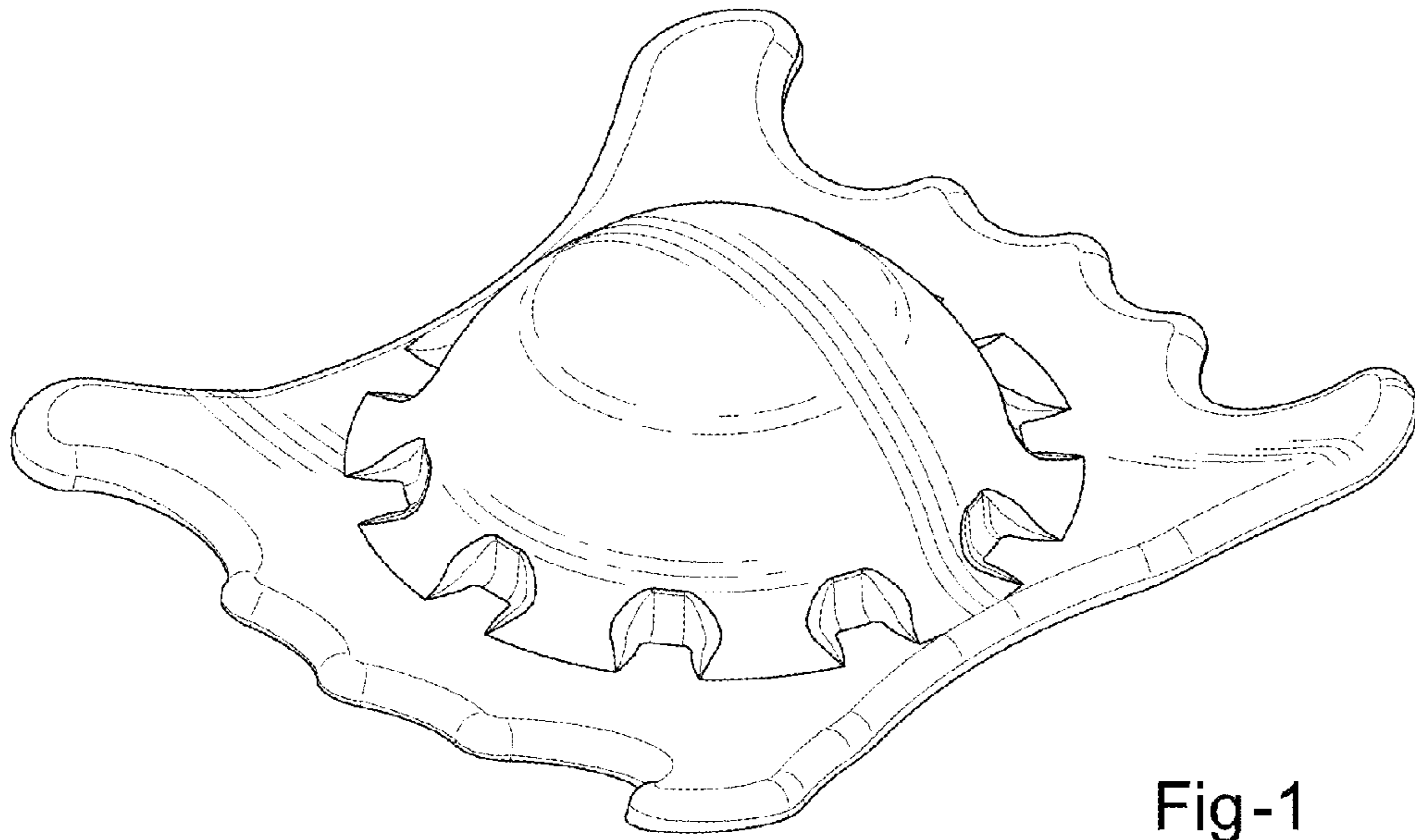

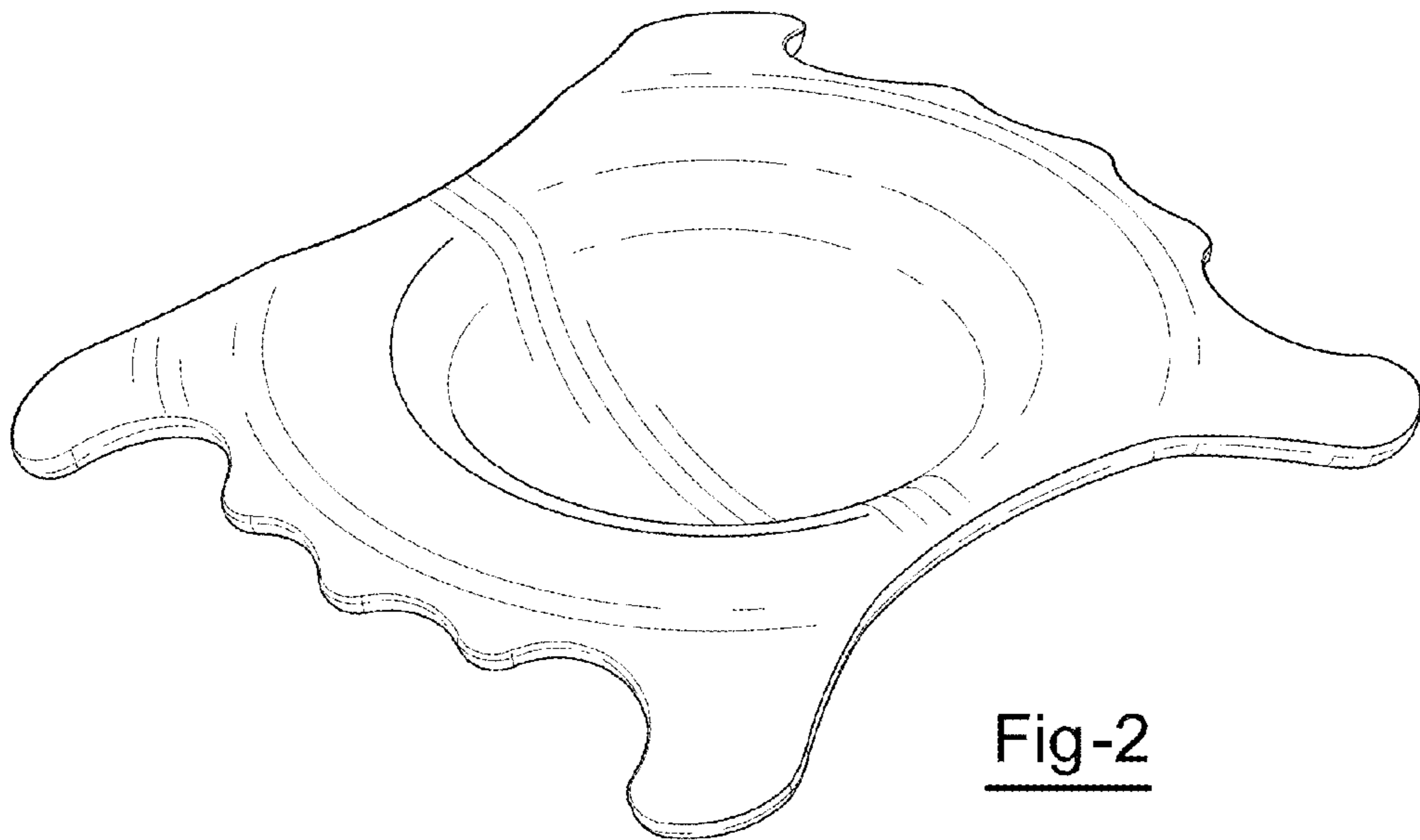

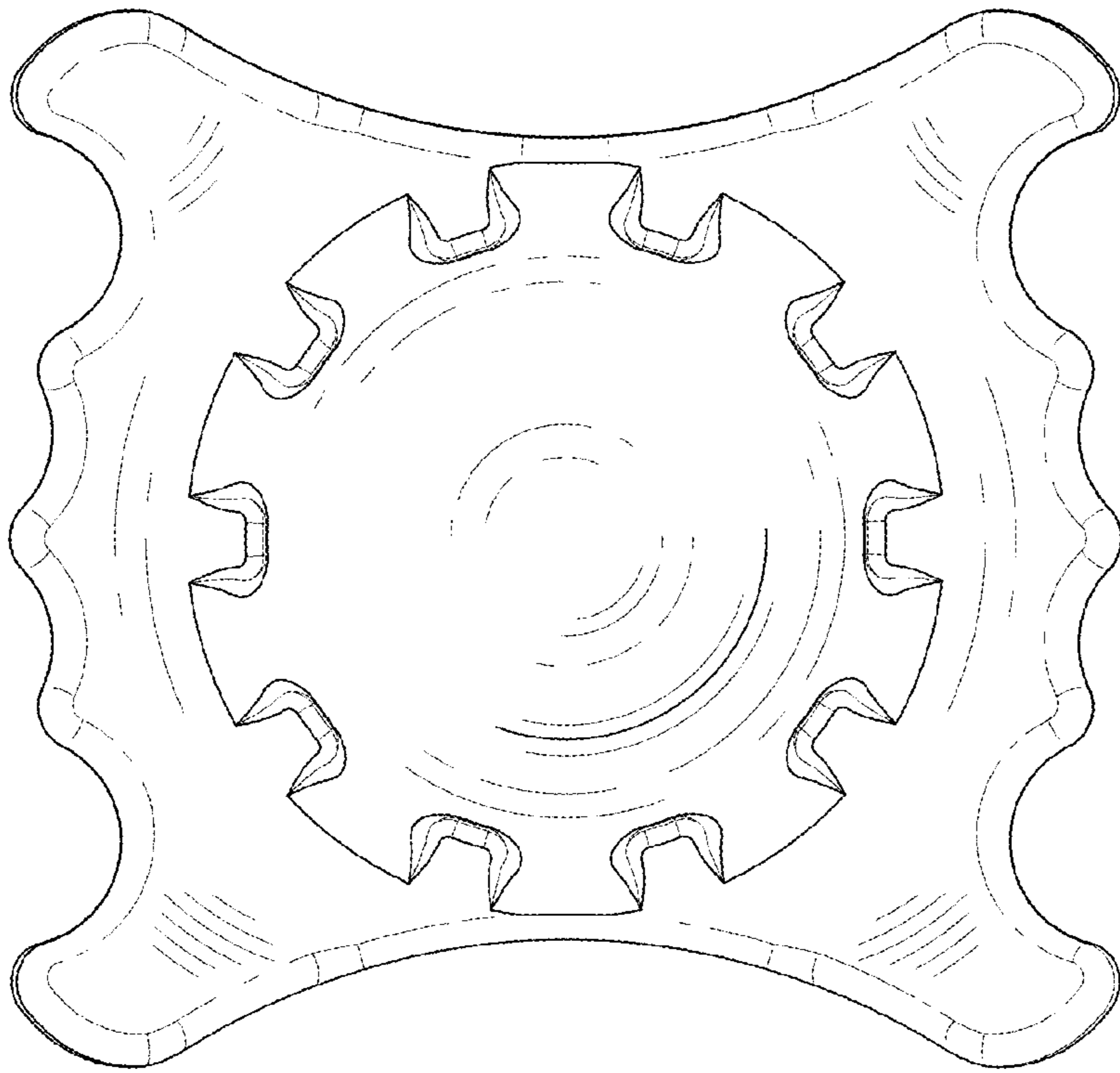

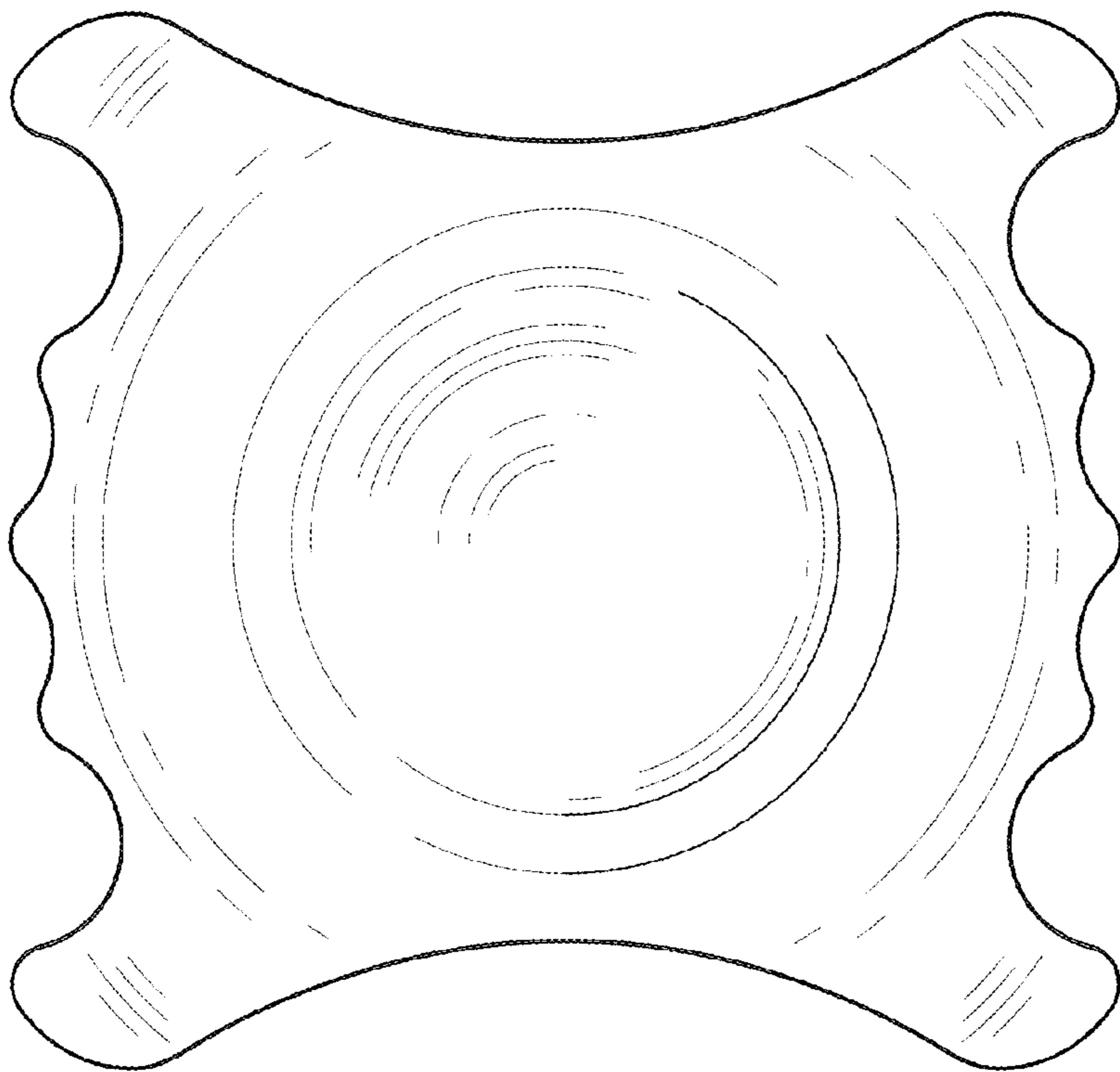

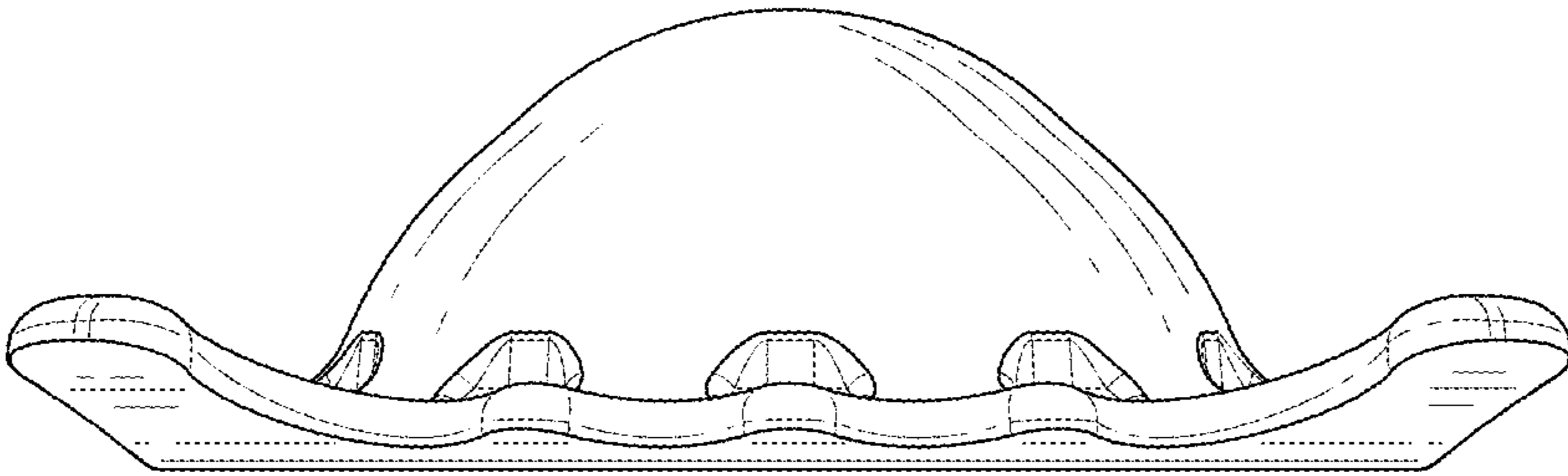

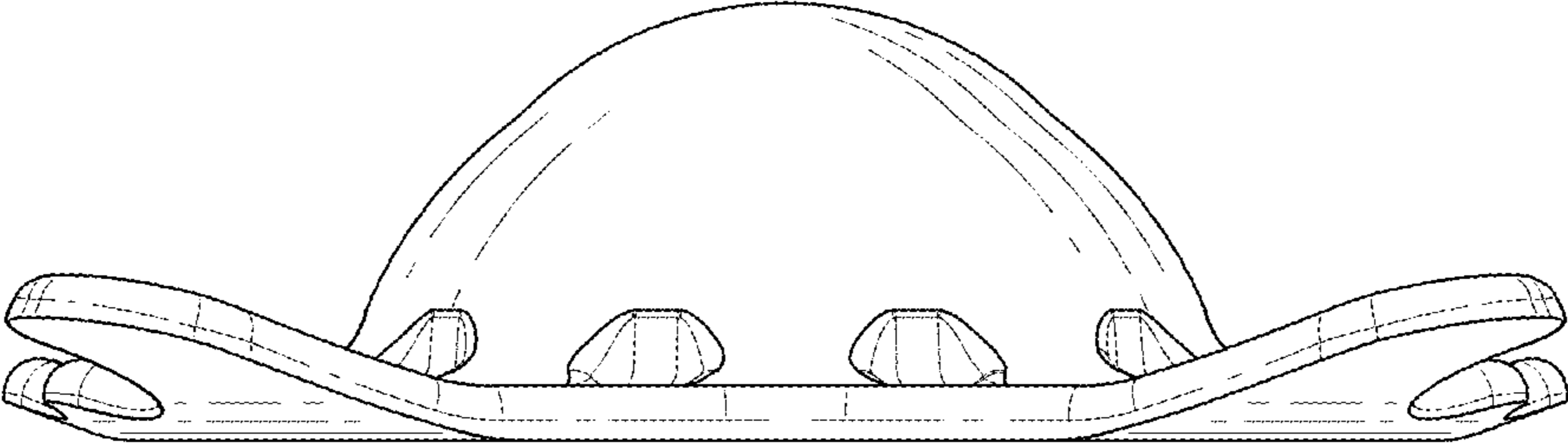

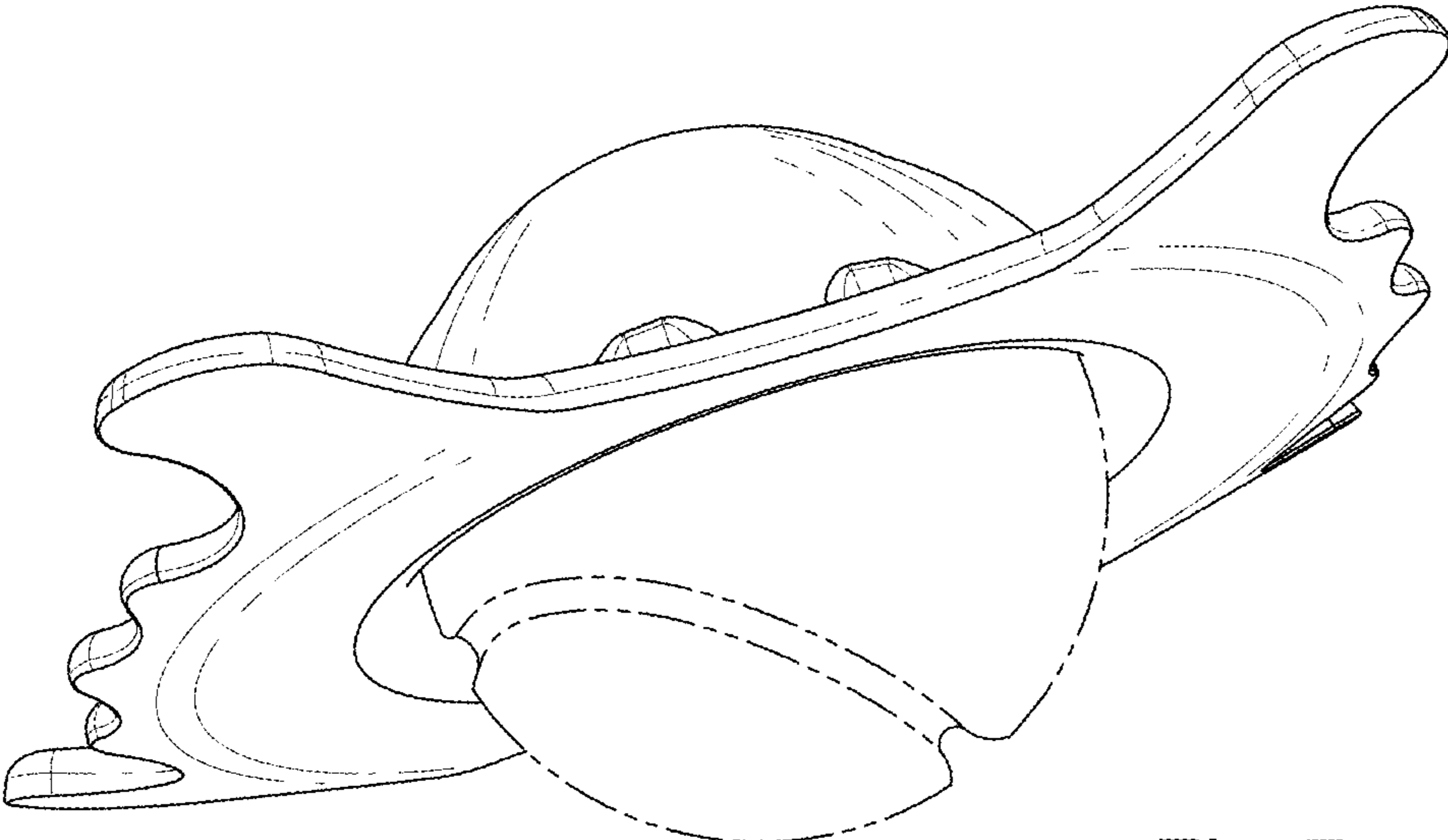
