(57) **CLAIM**

We claim the ornamental design for mixed martial arts shorts, as shown and described.

**DESCRIPTION**

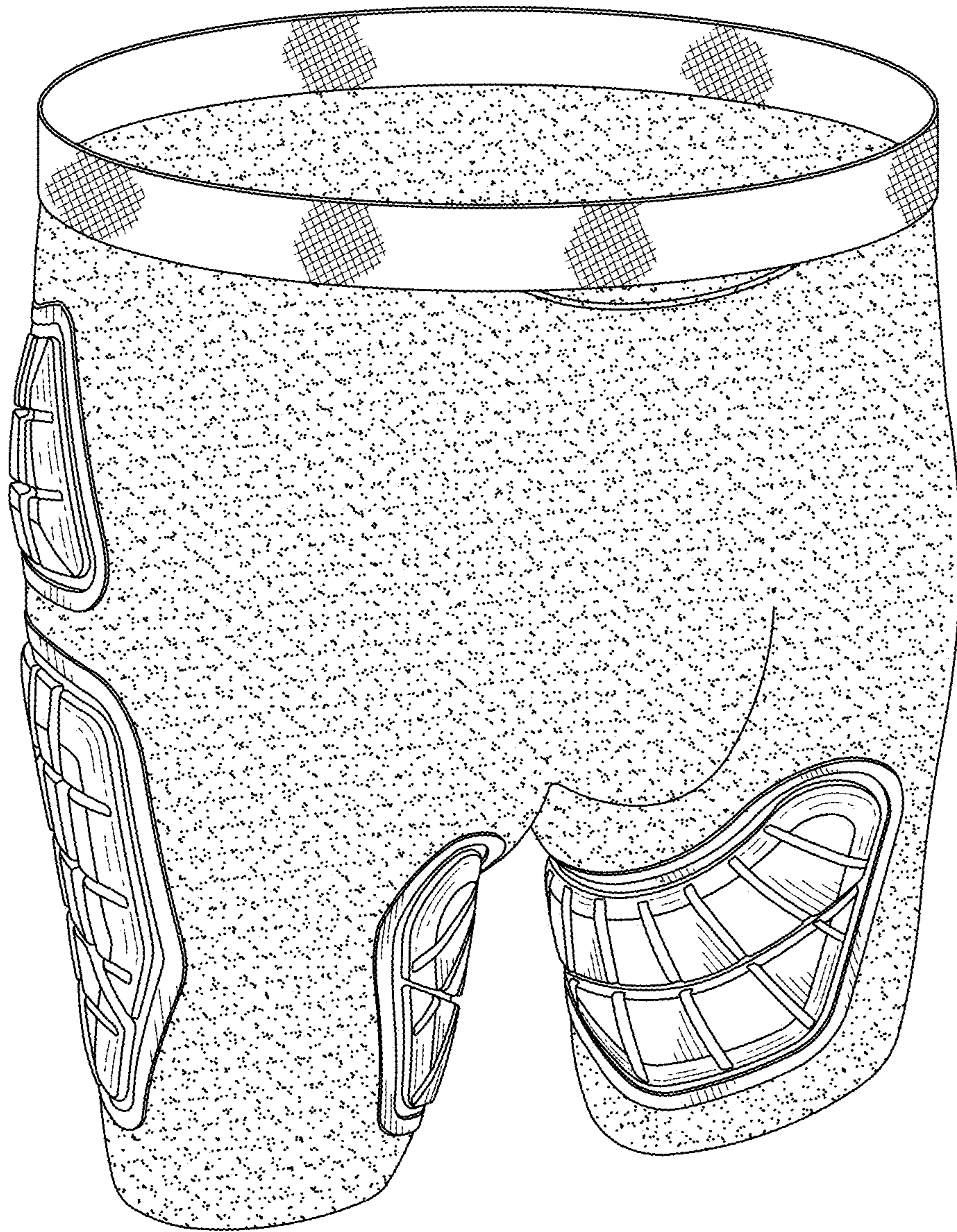

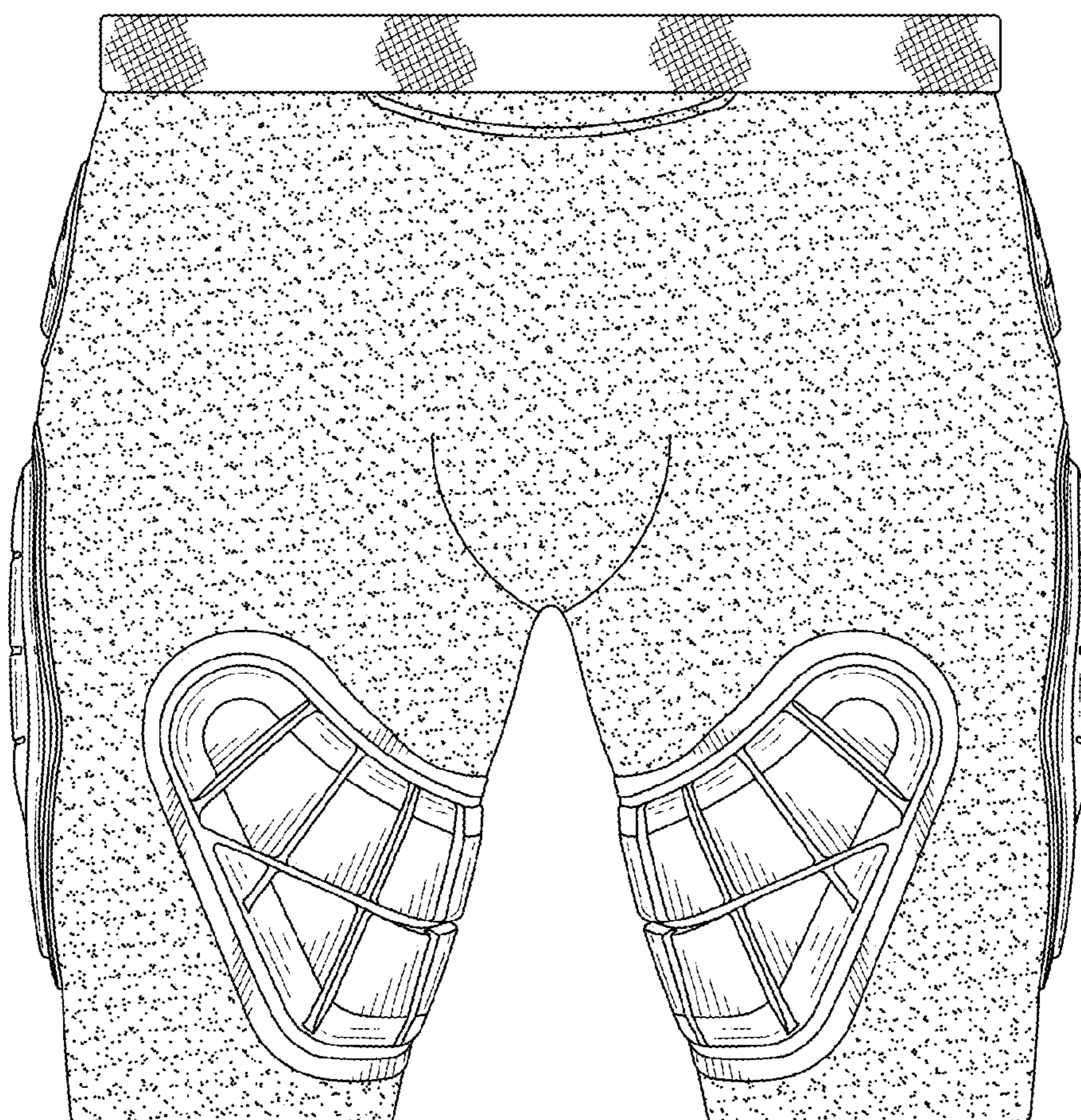

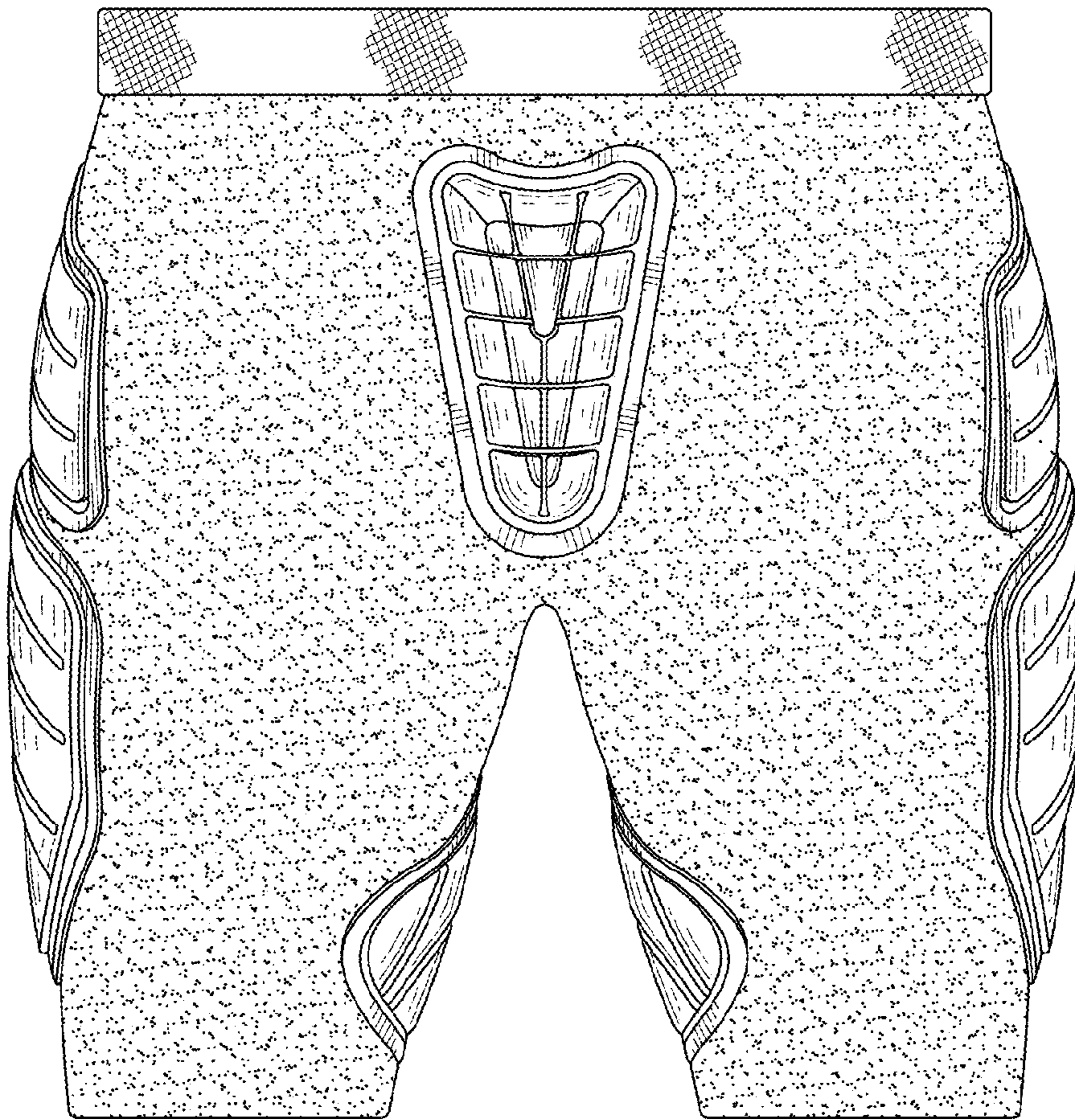

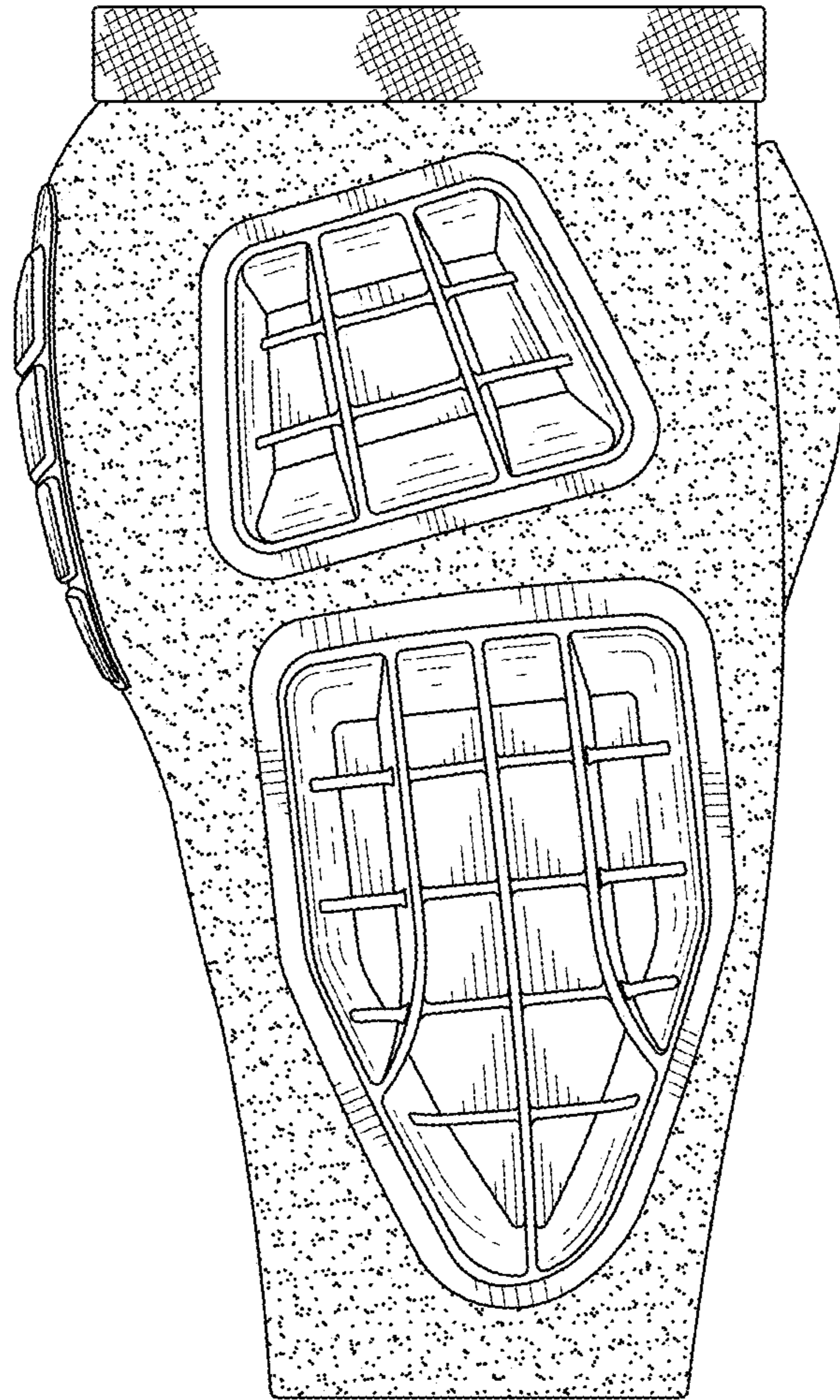

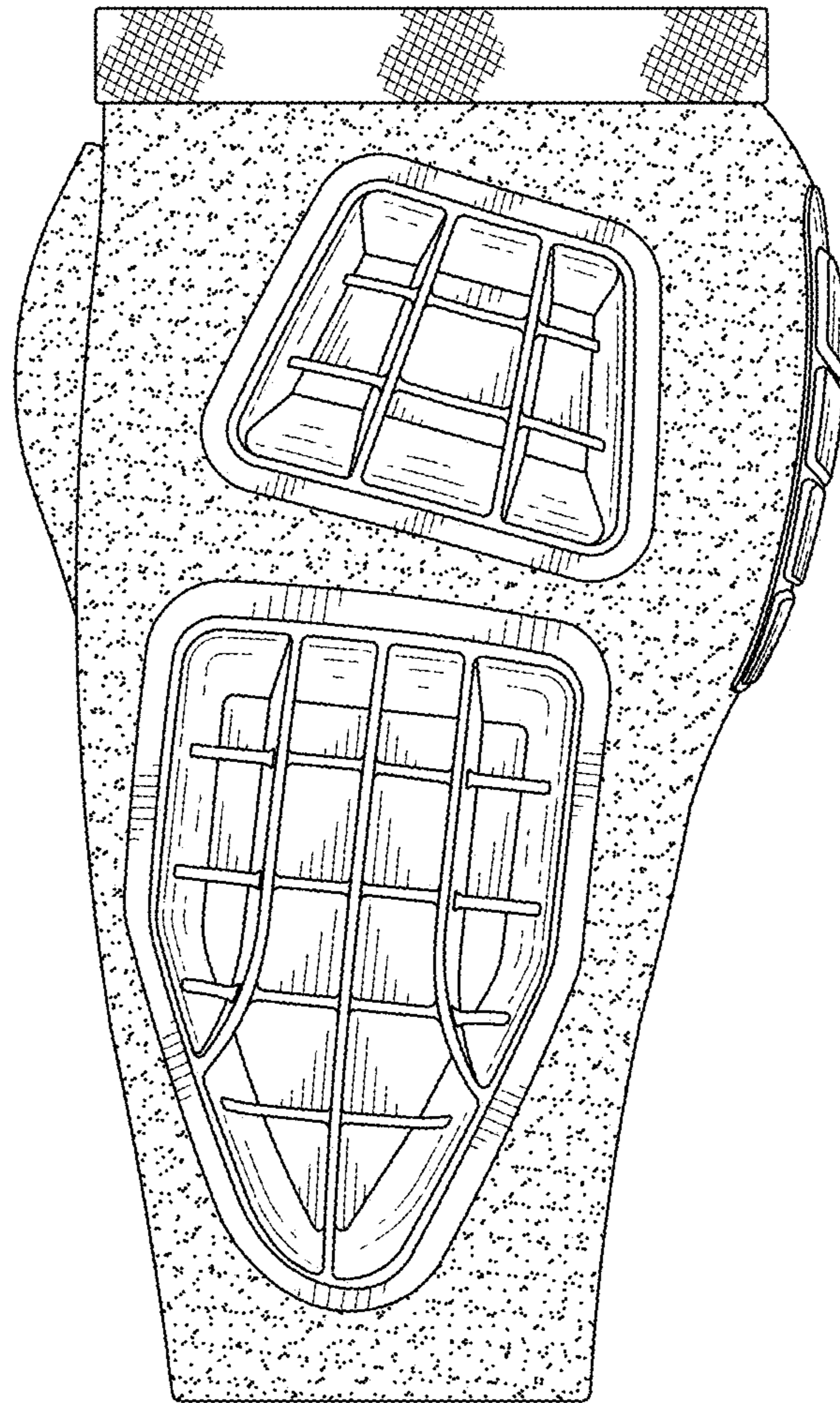

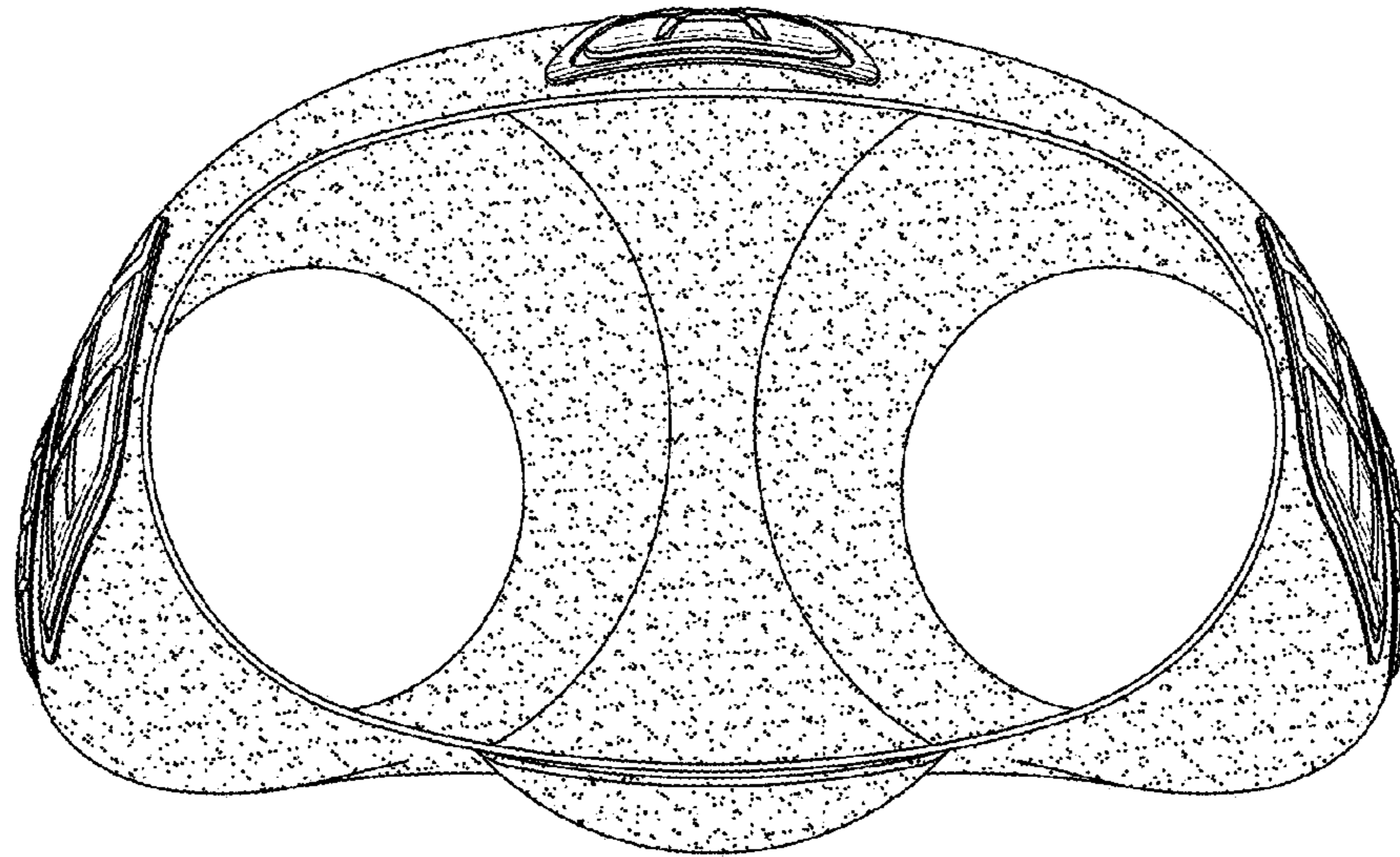

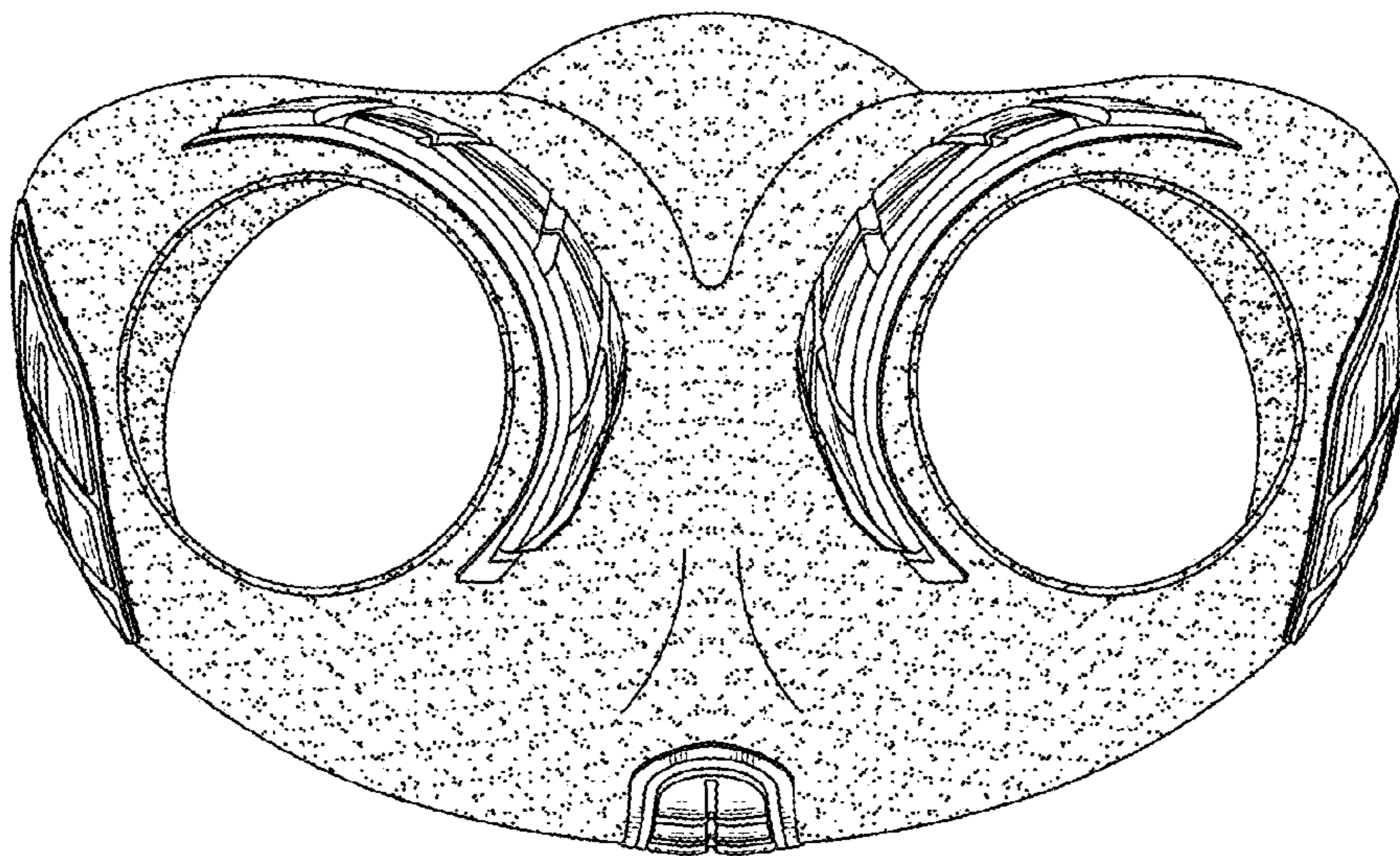
