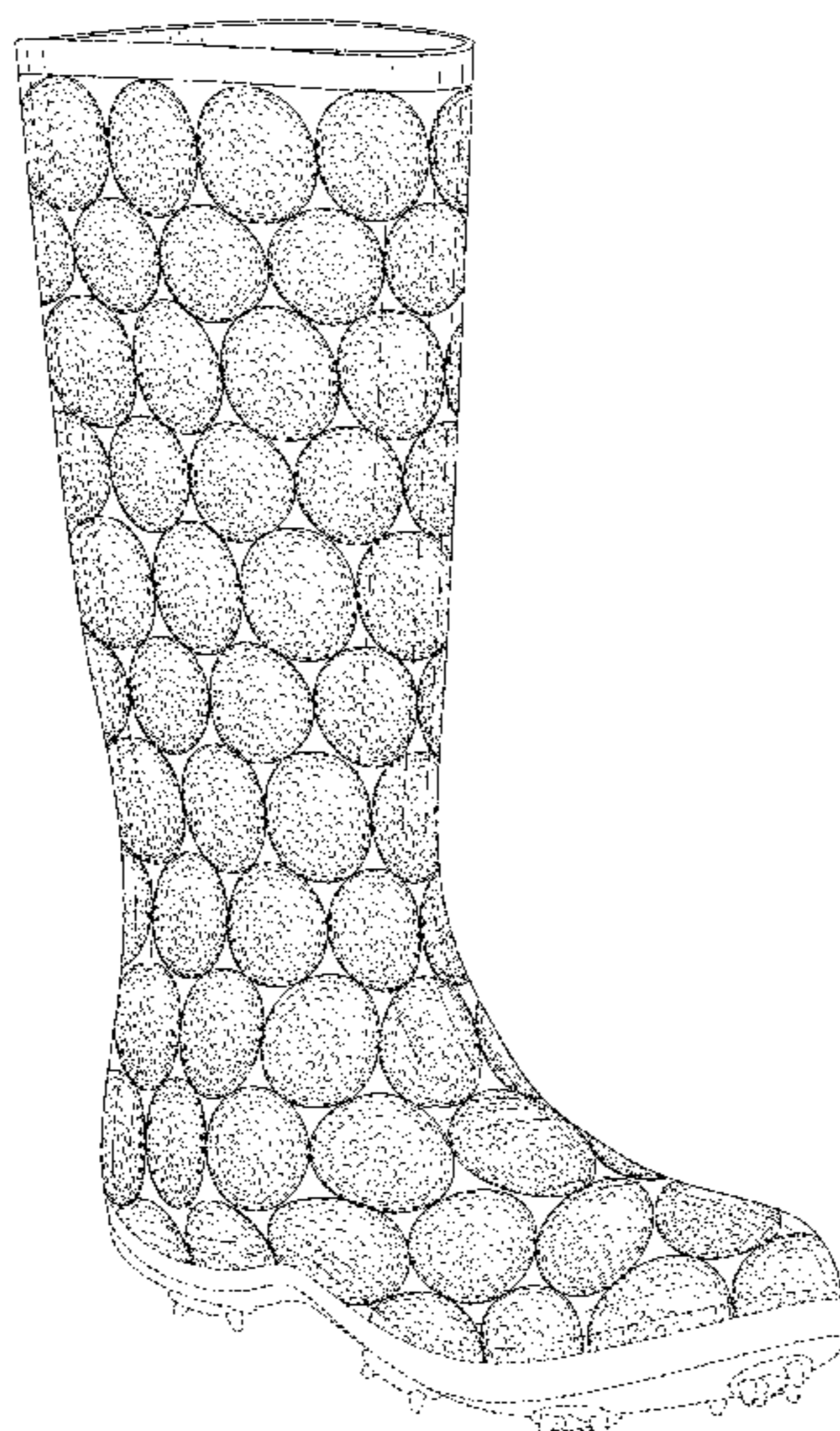
FIG. 12 is a bottom plan view of the left golf boot shown in FIG. 8;

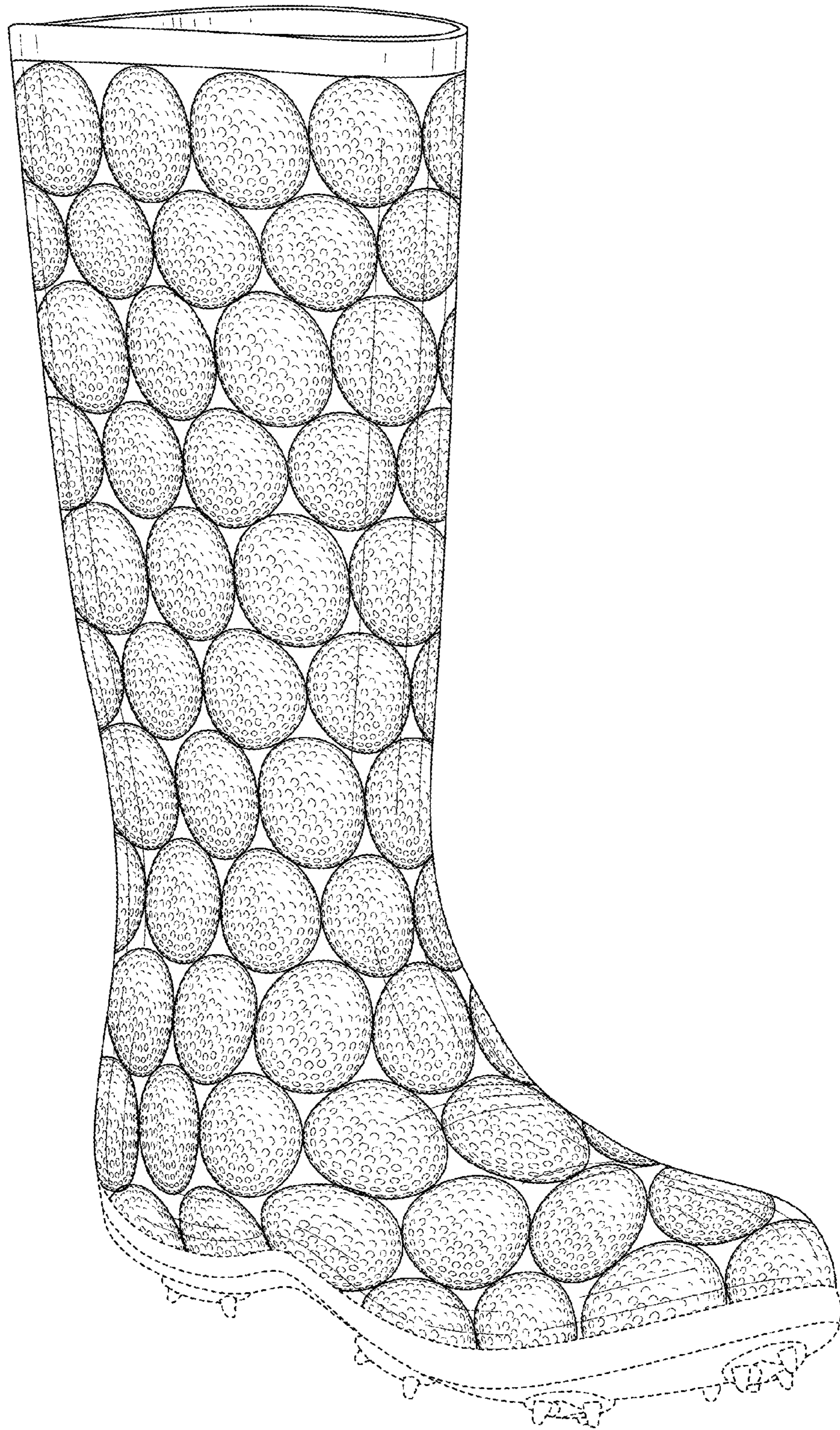

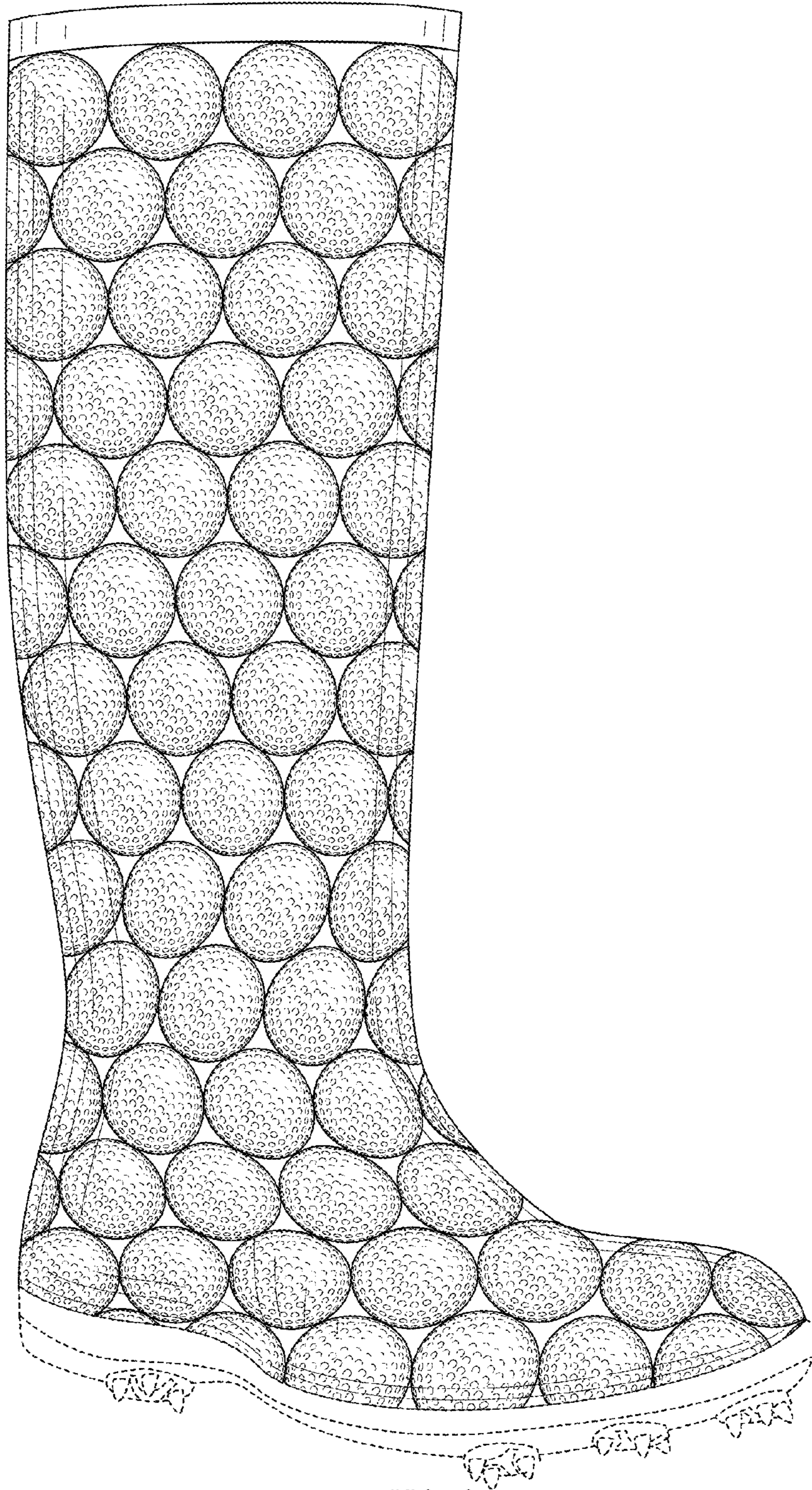

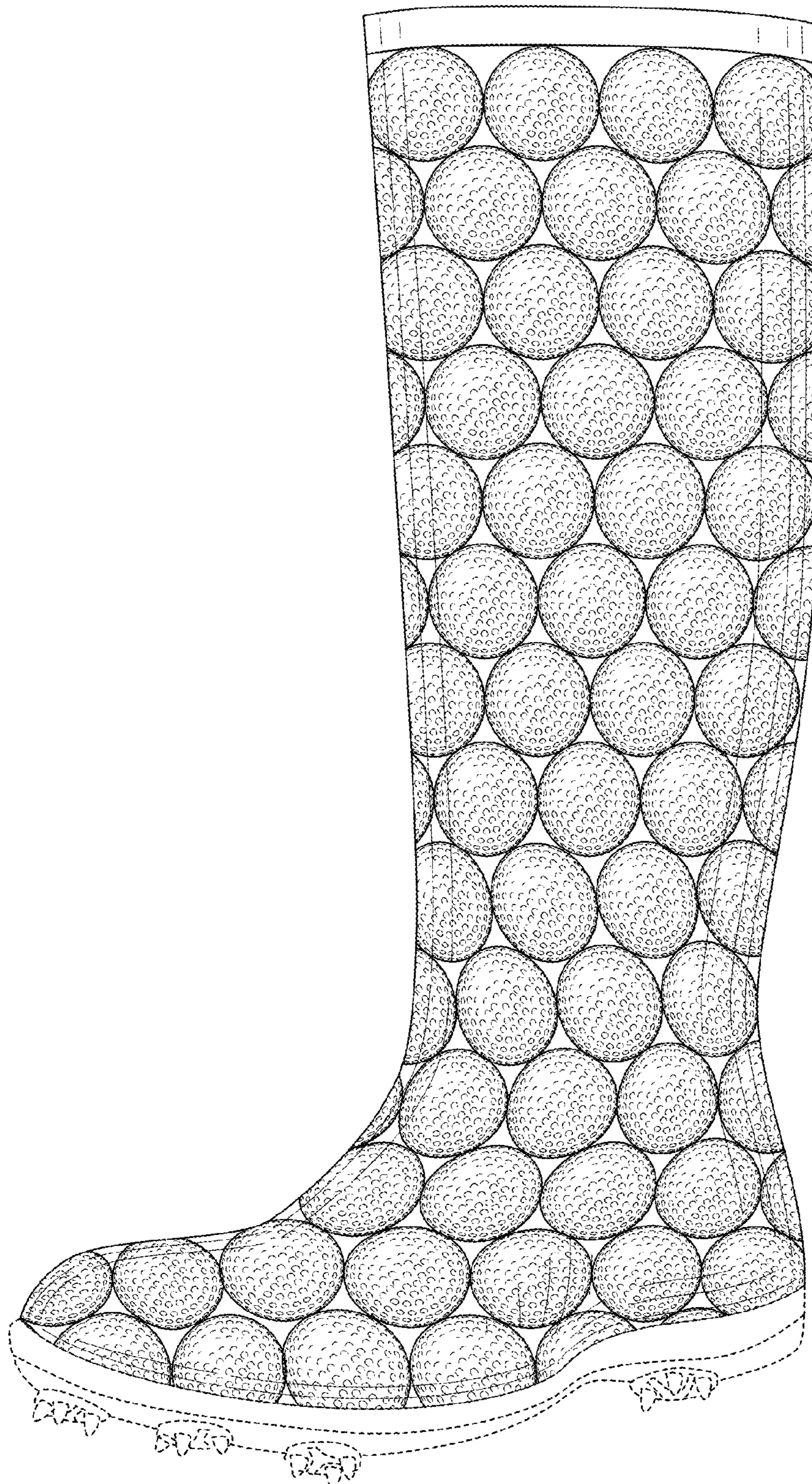

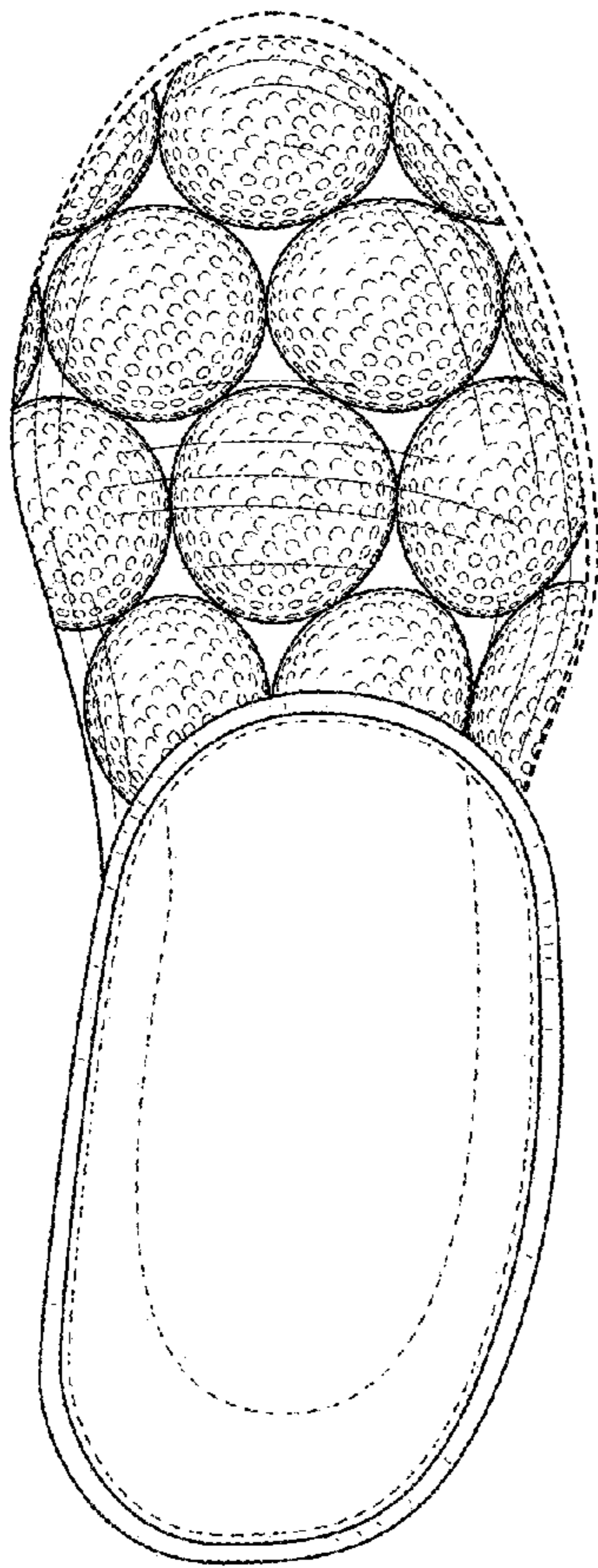

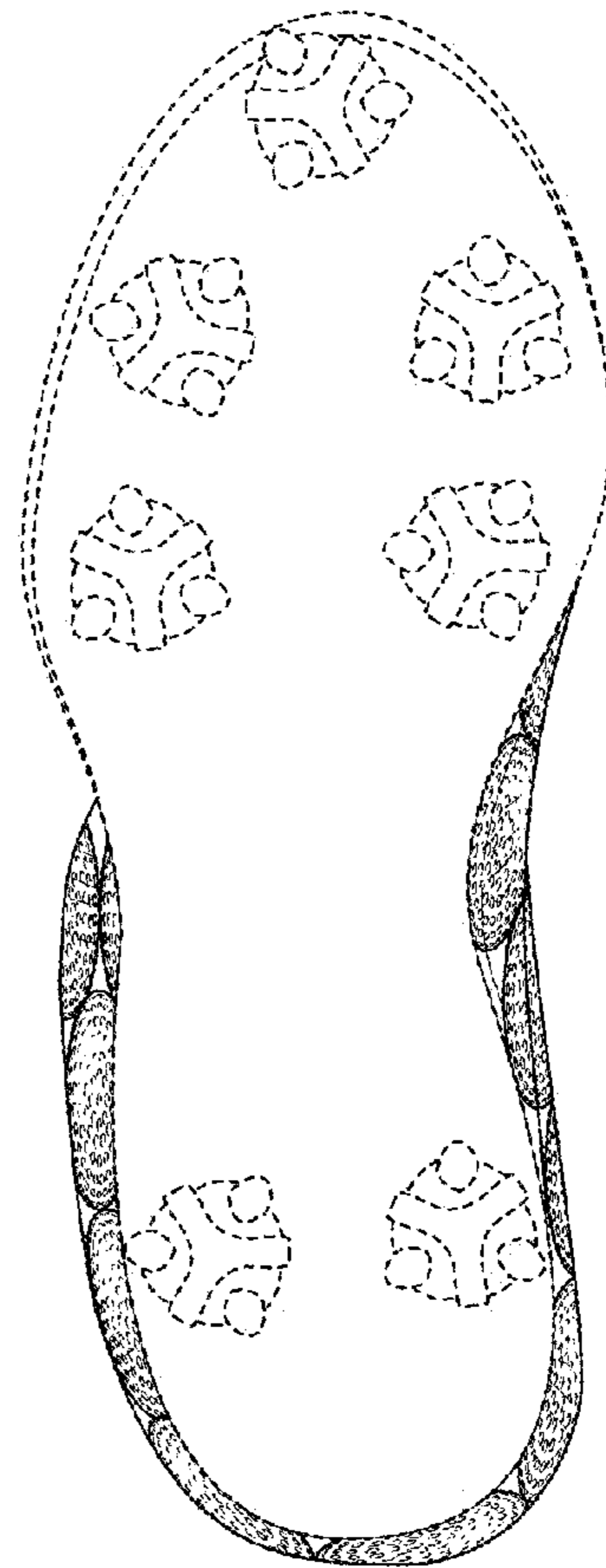

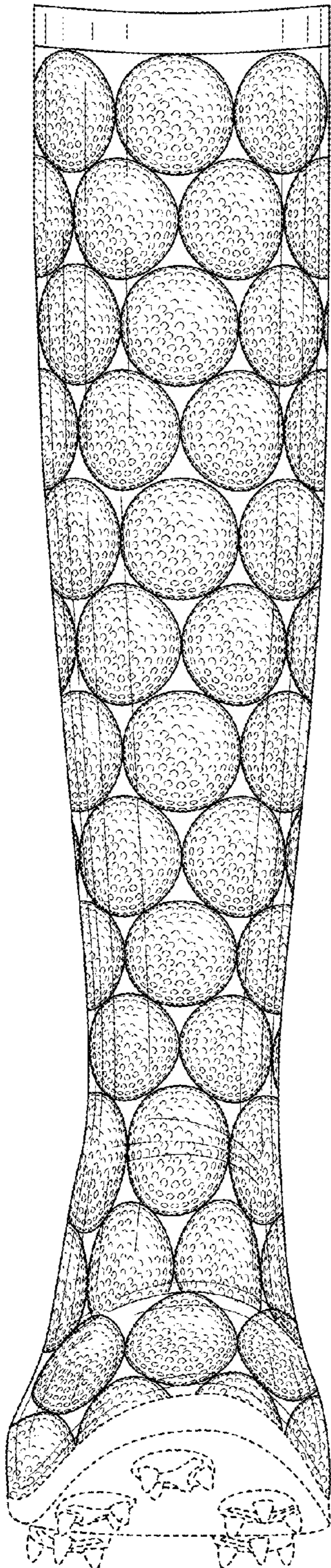

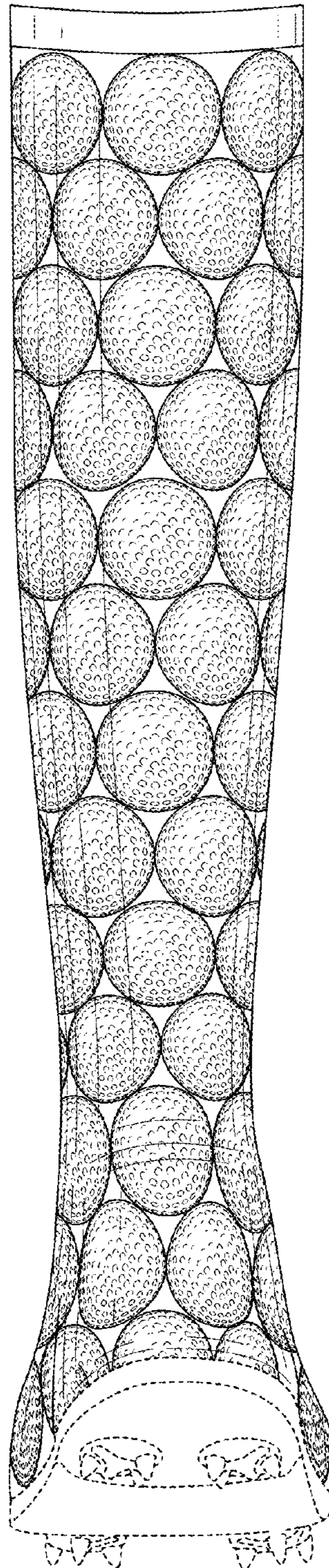

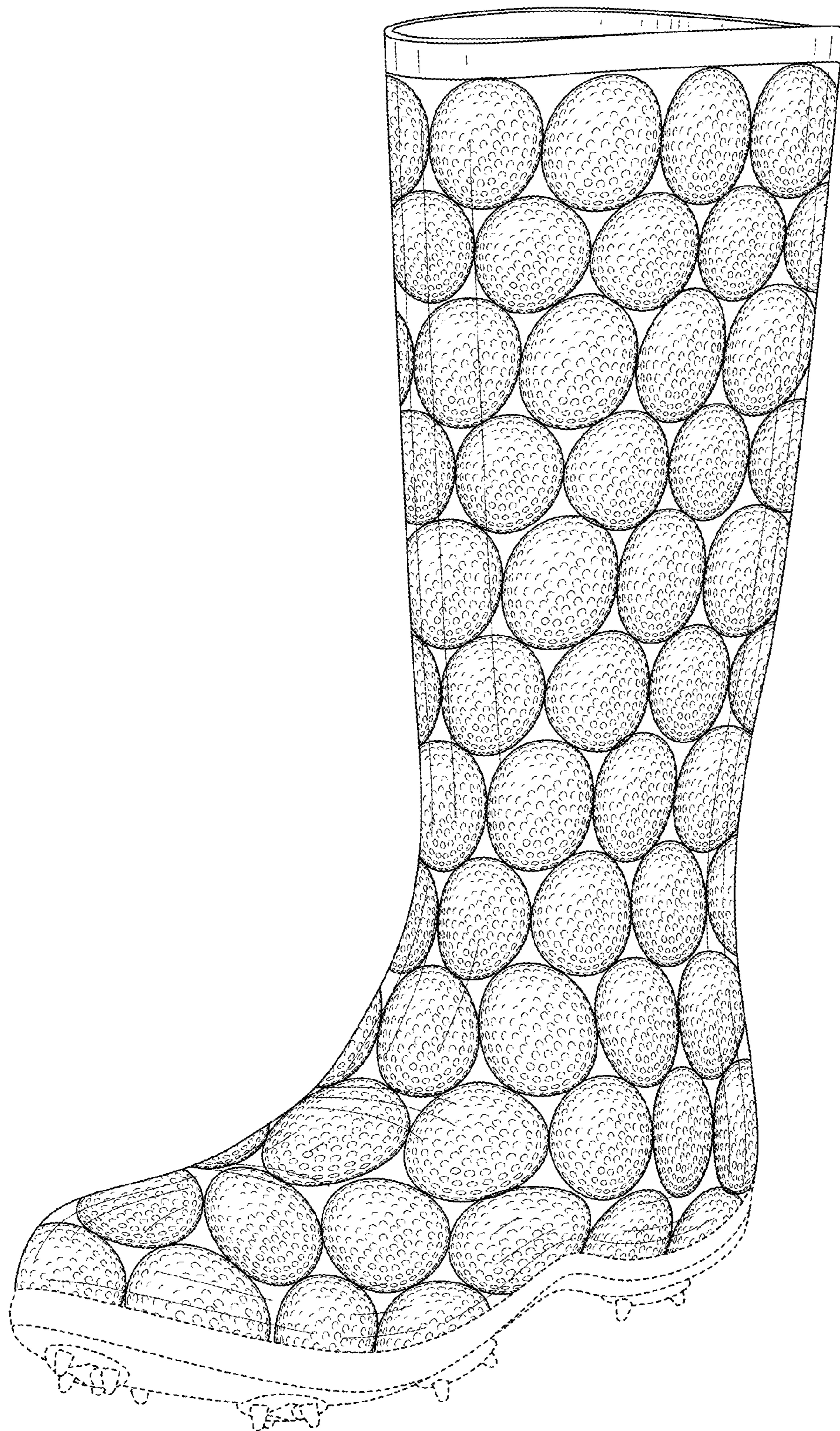

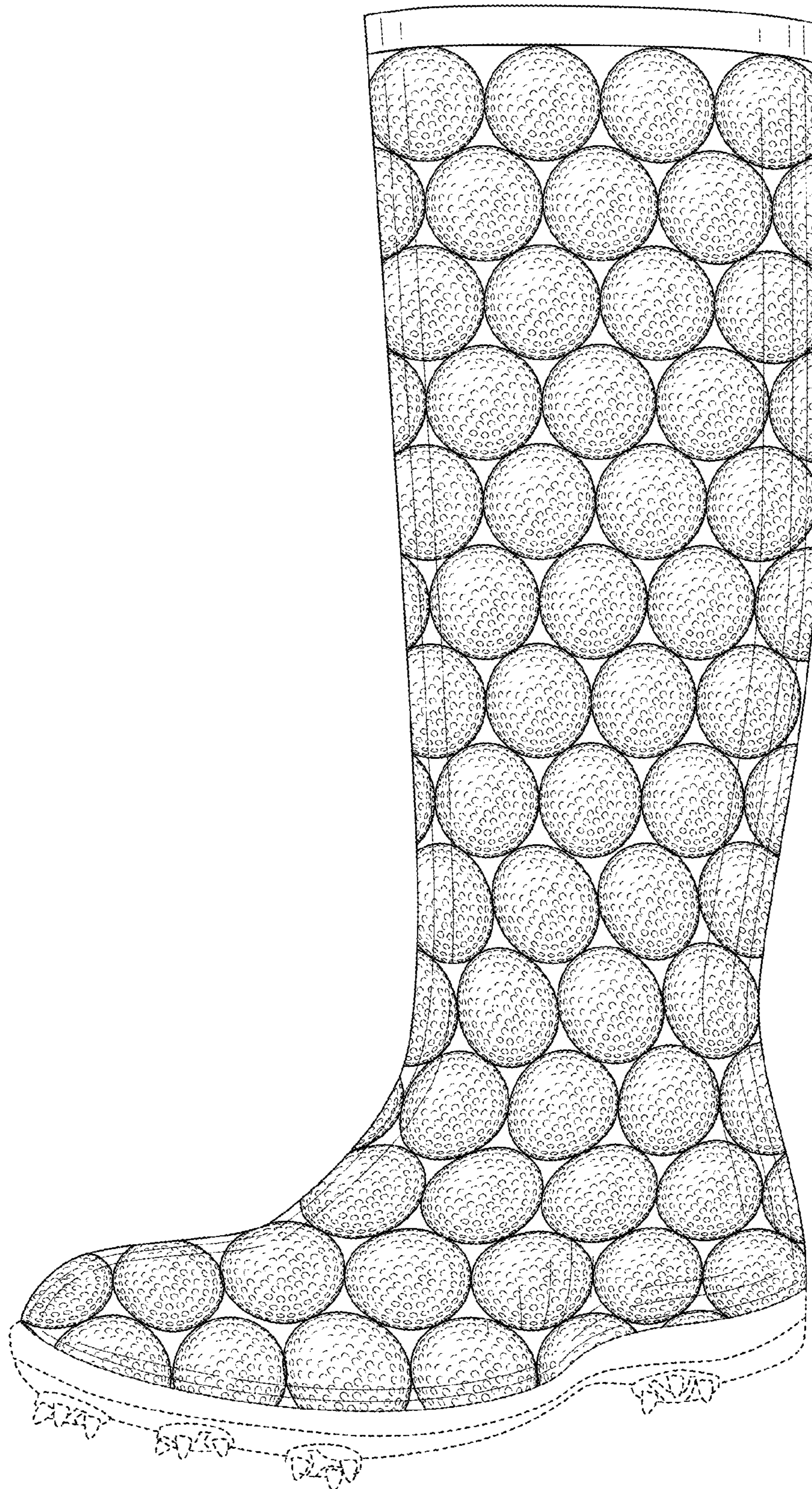

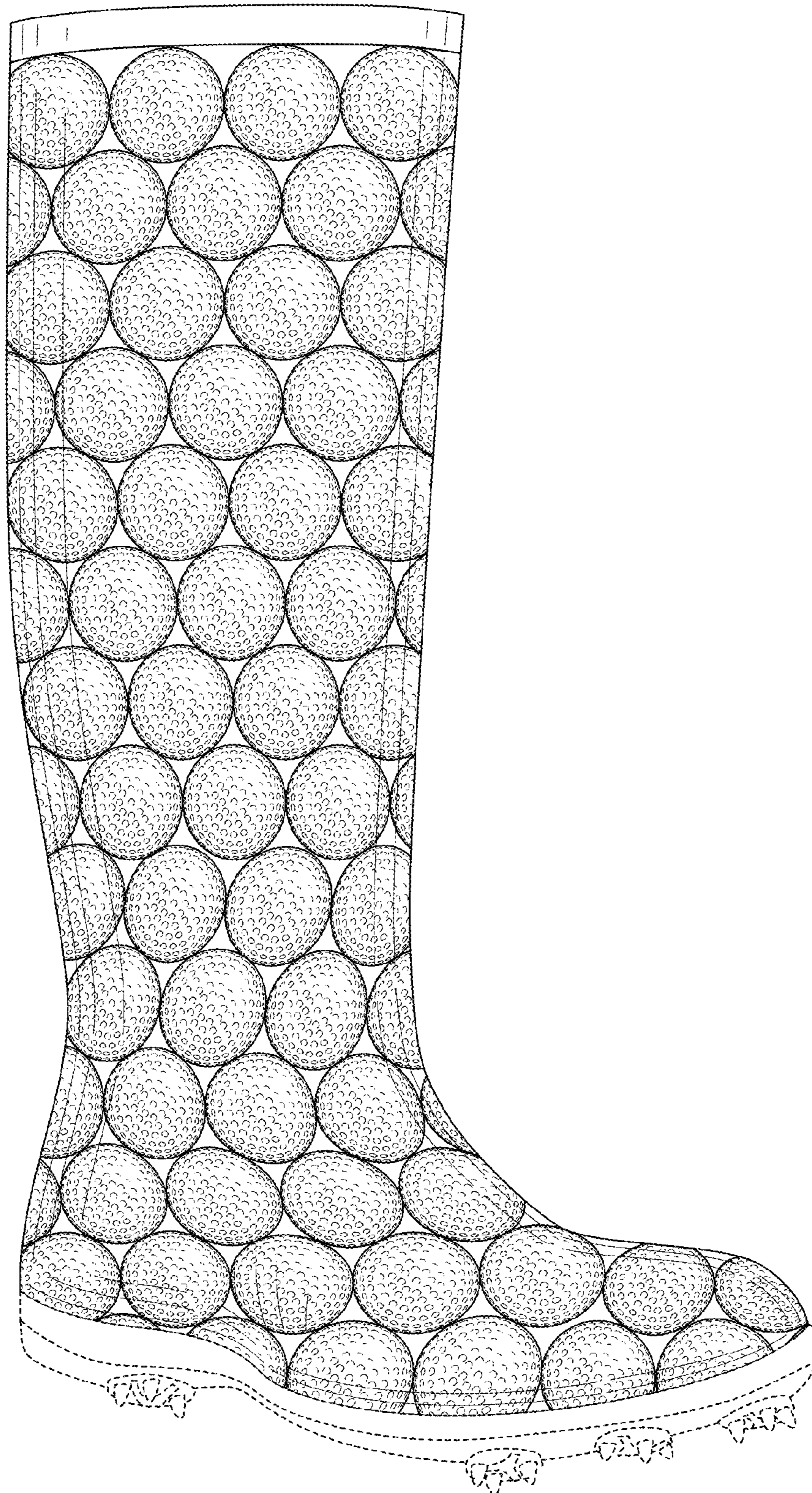

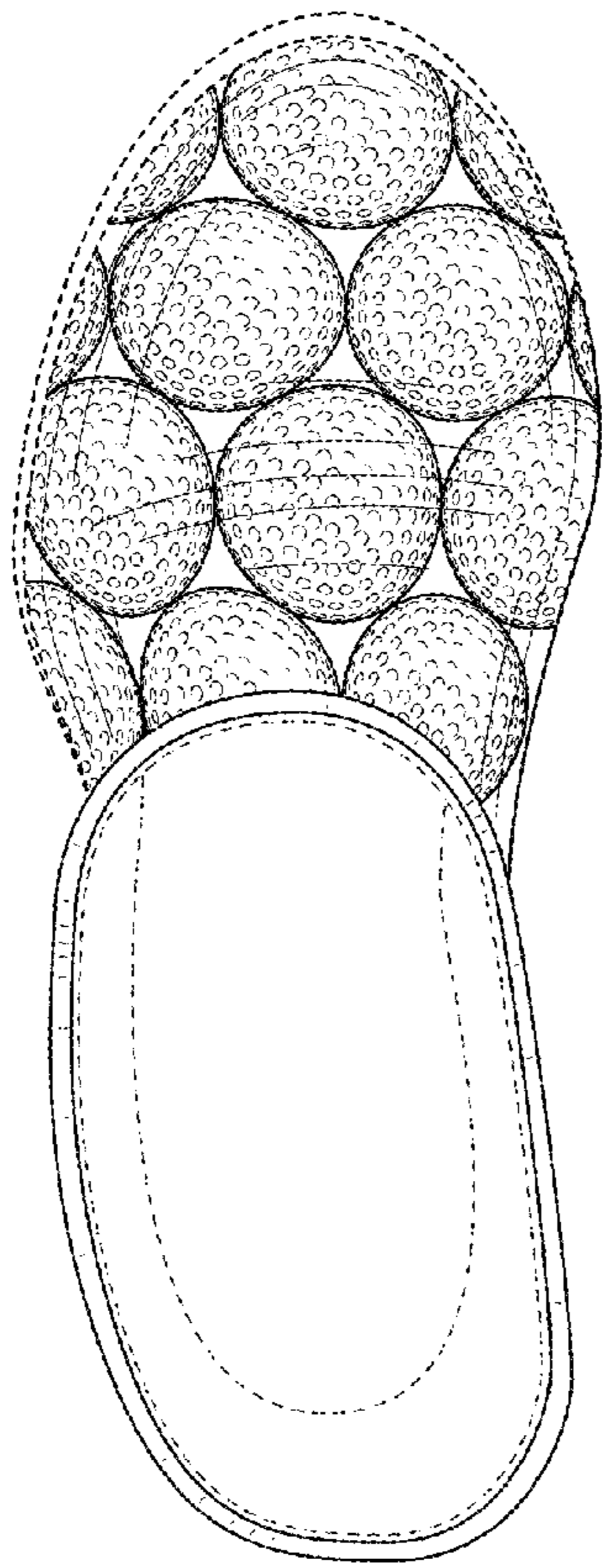

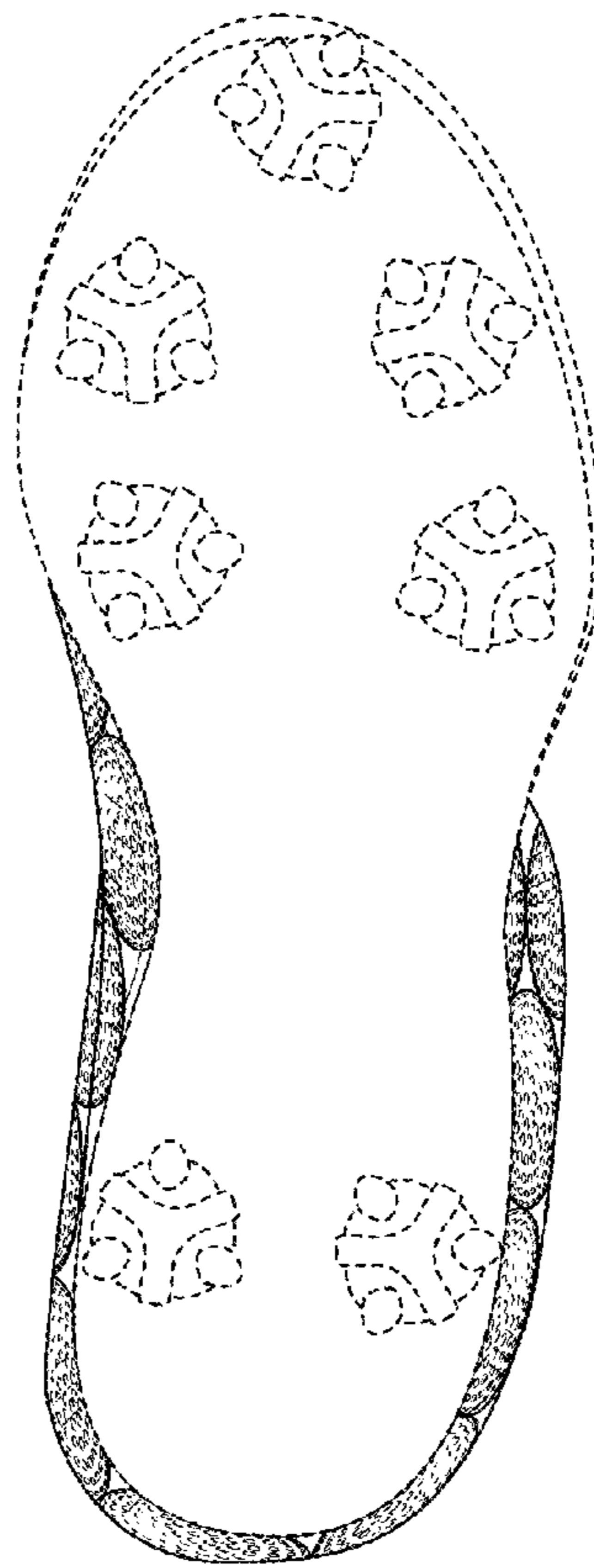

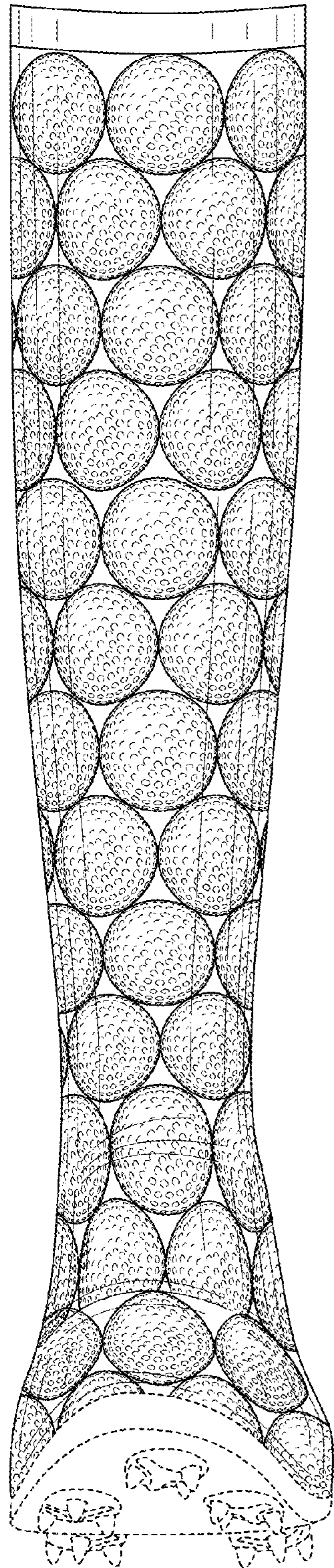

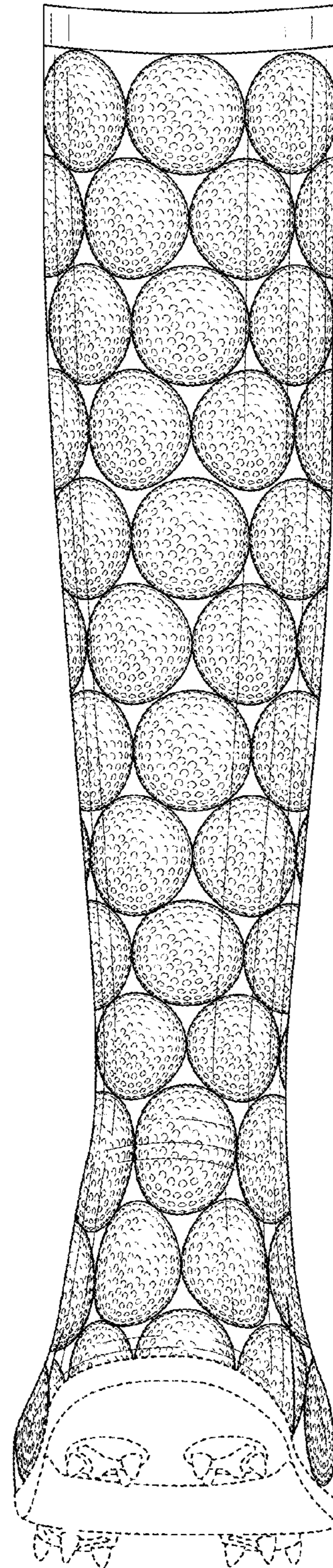
