(57) **CLAIM**

We claim the ornamental design for rail lubrication bar, as shown and described.

DESCRIPTION

FIG. 1 is top, perspective view of a rail lubrication bar according to an embodiment of the invention.

FIG. 2 is a bottom, perspective view of the rail lubrication bar depicted in FIG. 1.

FIG. 3 is a top view of the rail lubrication bar depicted in FIG. 1.

FIG. 4 is a front view of the rail lubrication bar depicted in FIG. 1.

FIG. 5 is a rear view of the rail lubrication bar depicted in FIG. 1.

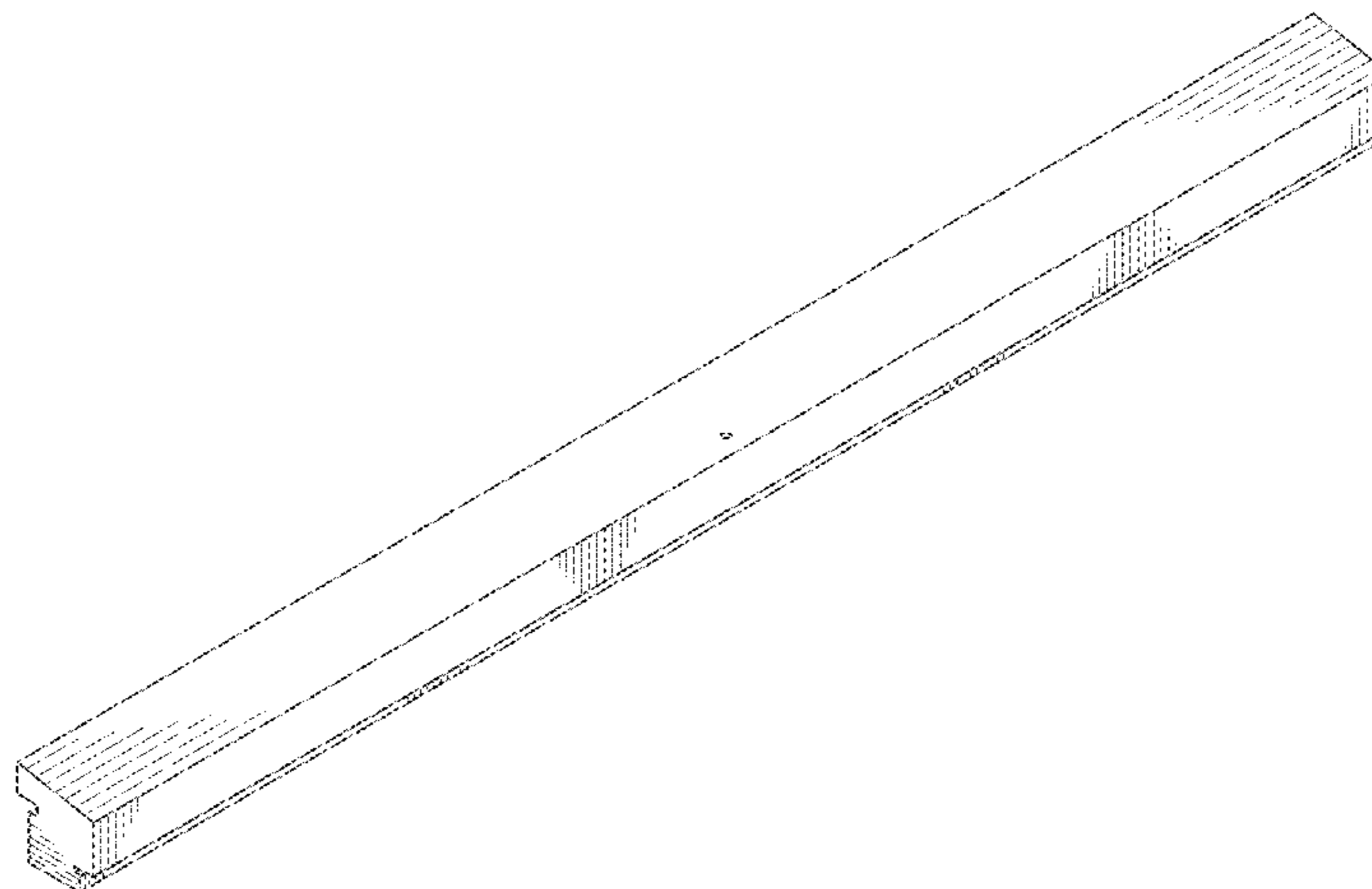
FIG. 6 is a bottom view of the rail lubrication bar depicted in FIG. 1.

FIG. 7 is a side view of the rail lubrication bar depicted in FIG. 1; and,

FIG. 8 is a top view of the rail lubrication bar depicted in FIG. 1 illustrating use in a rail environment.

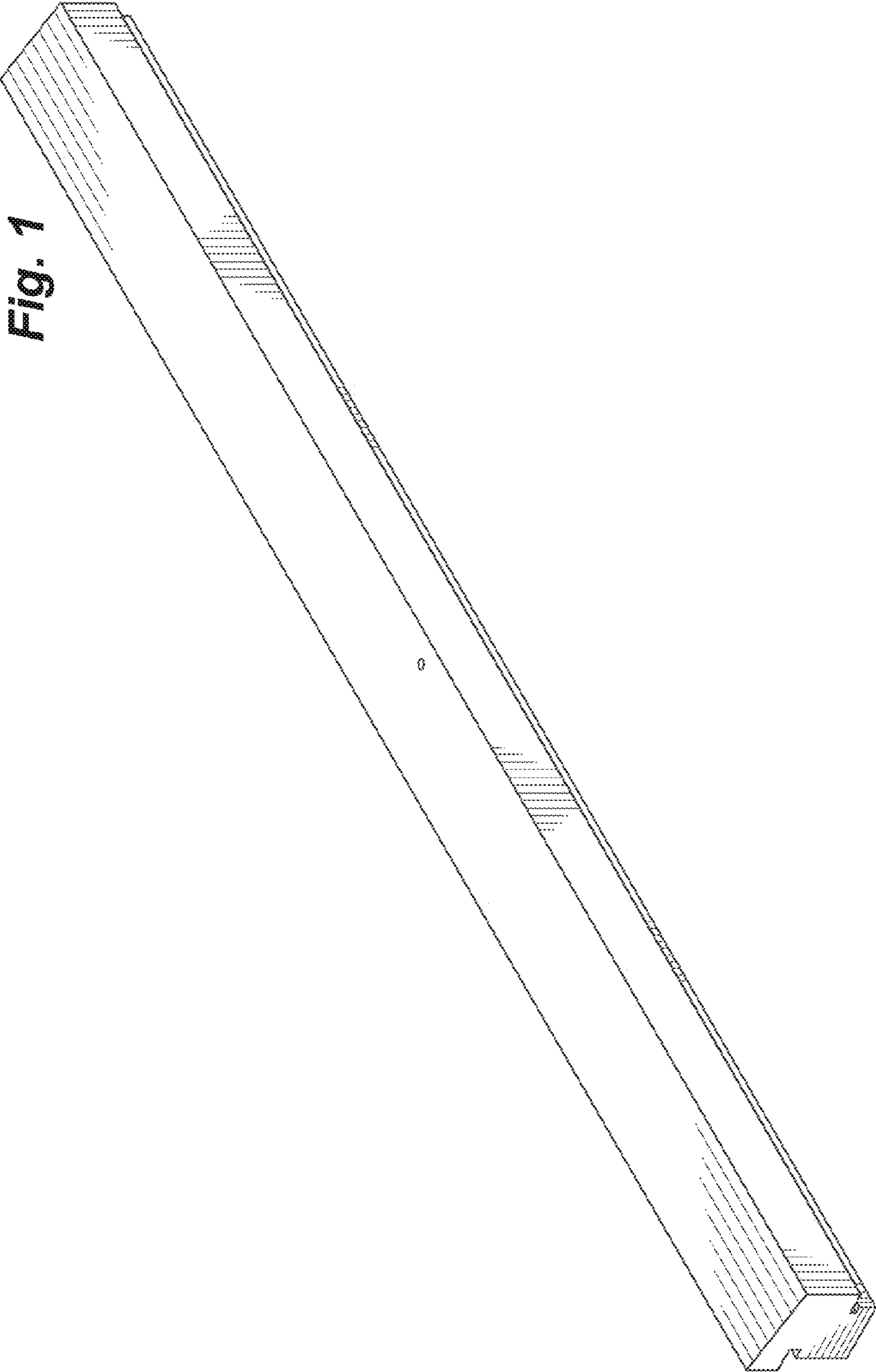

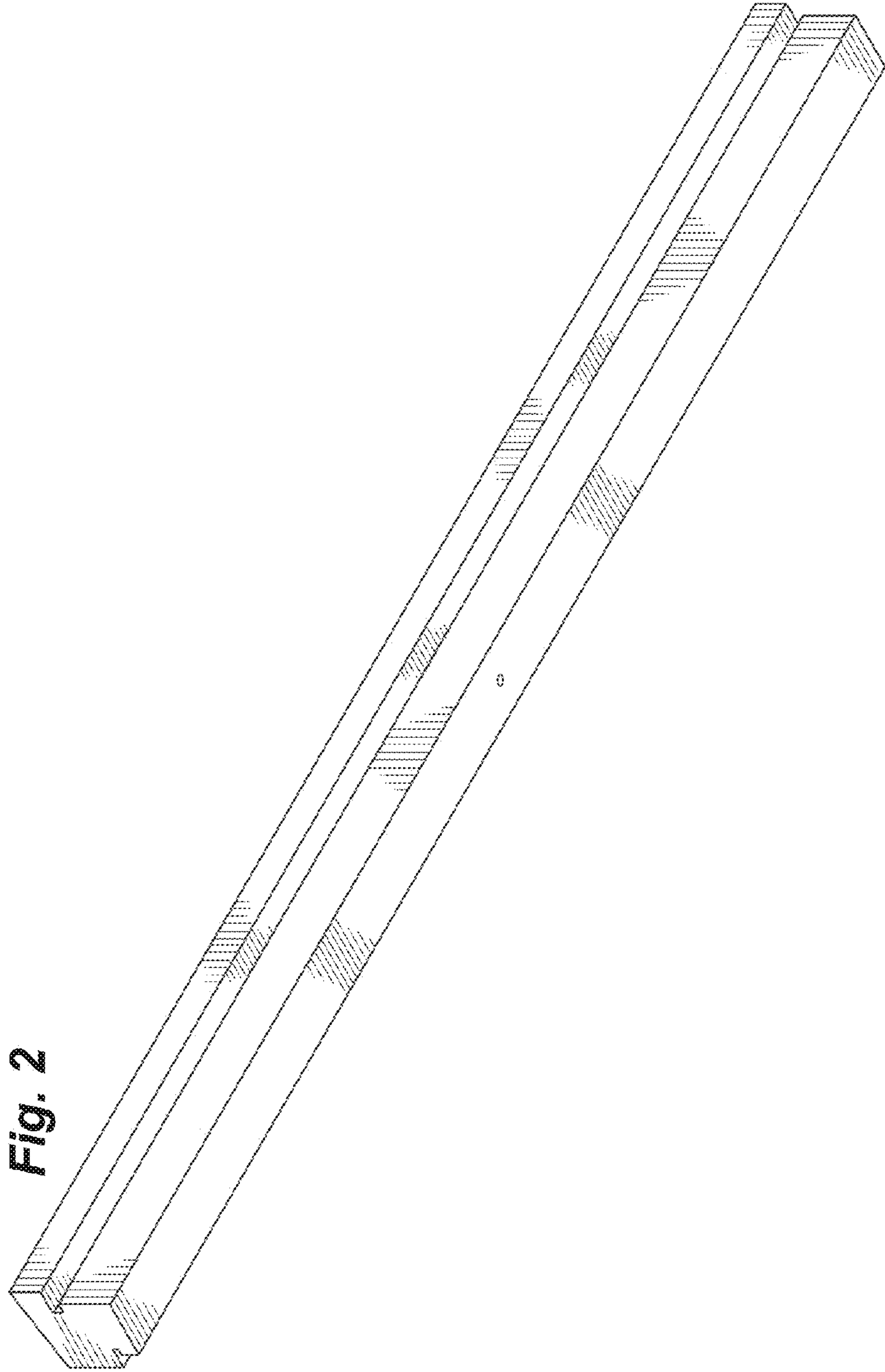

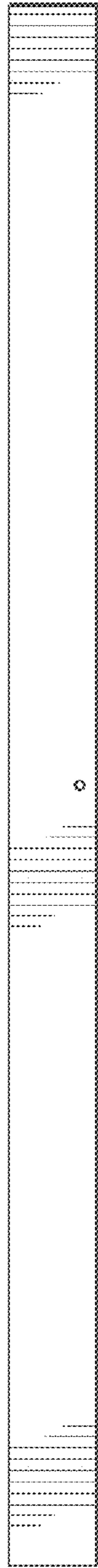

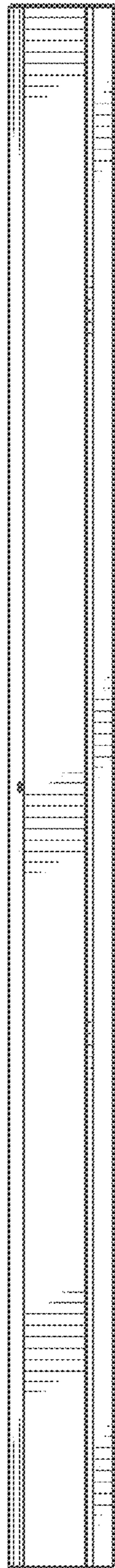

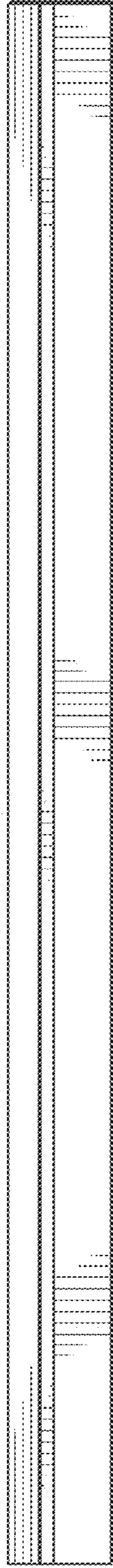

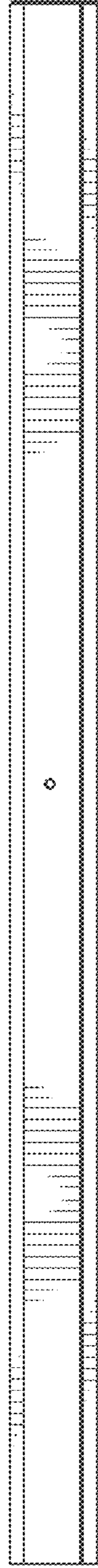

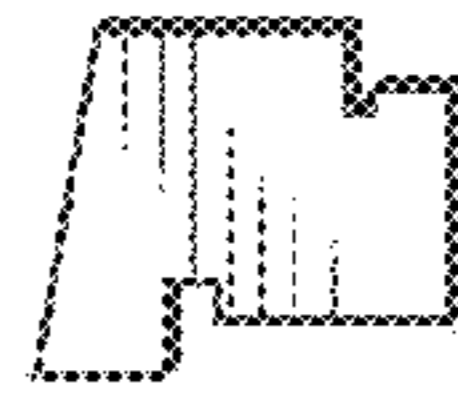
