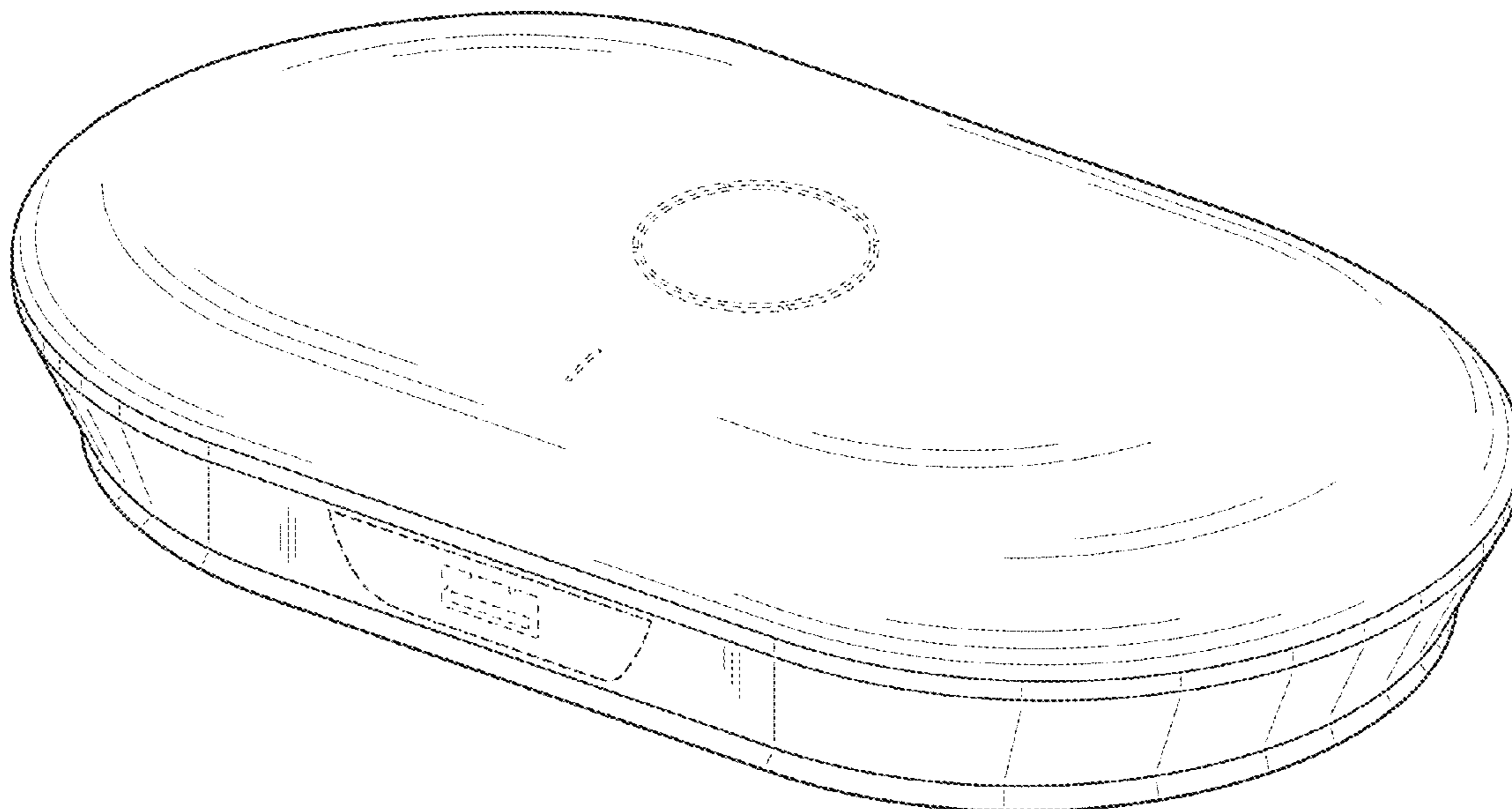
The ornamental design for a transmitter box, as shown and described.

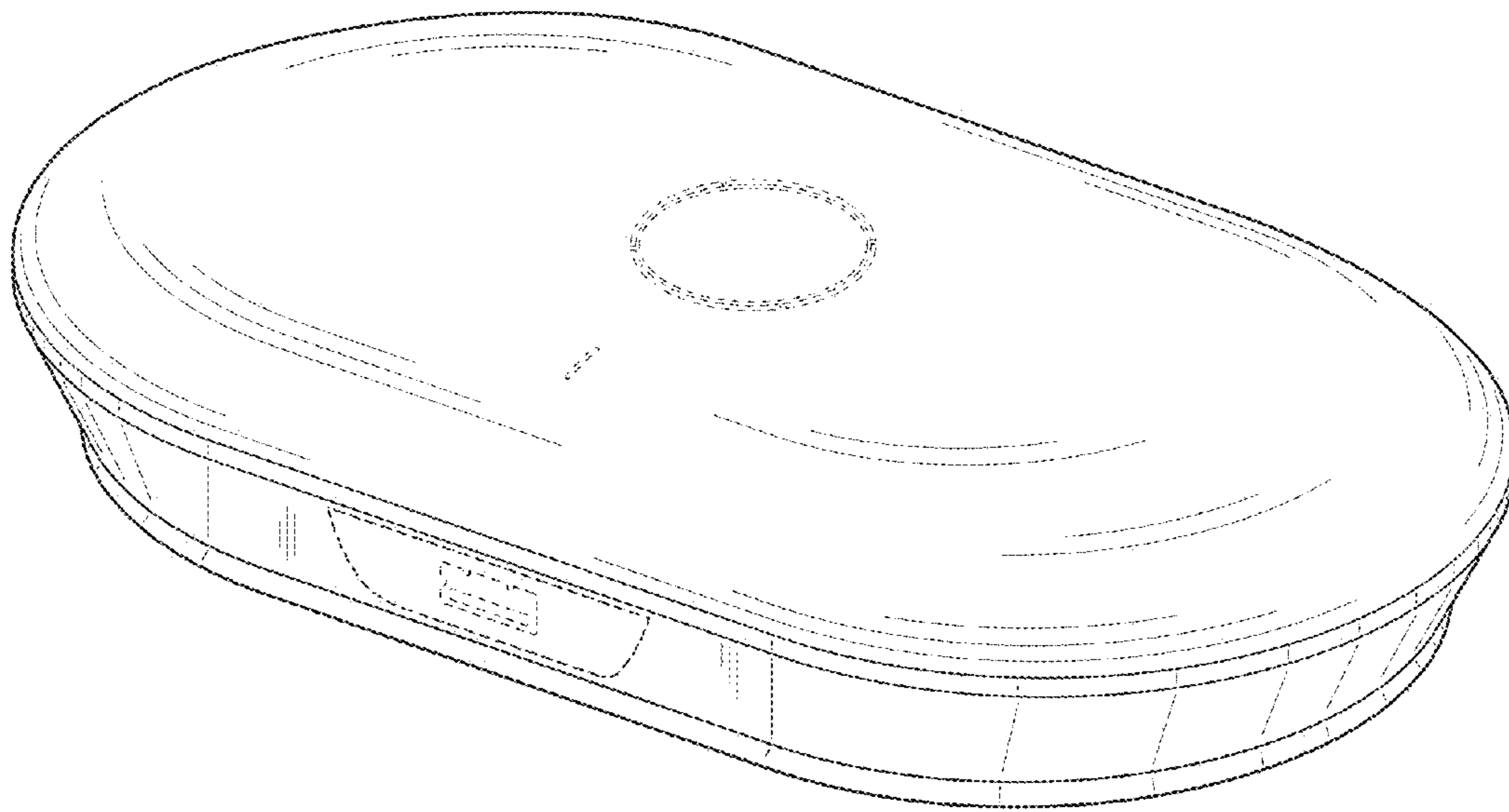

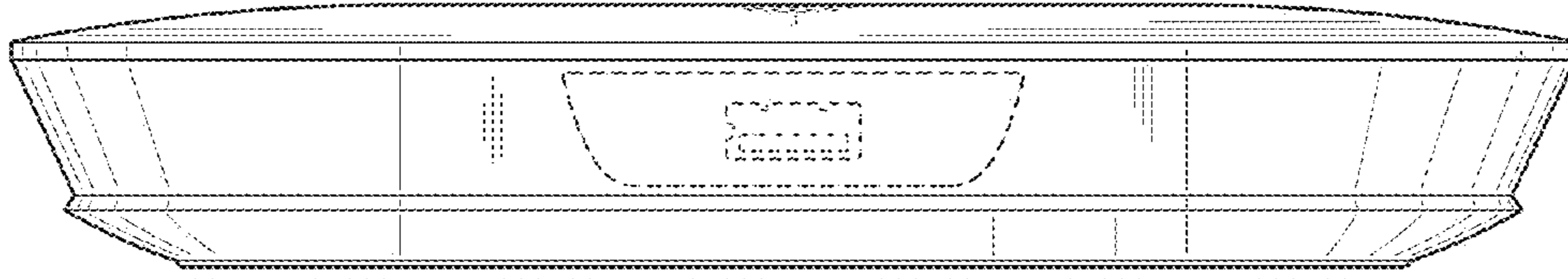

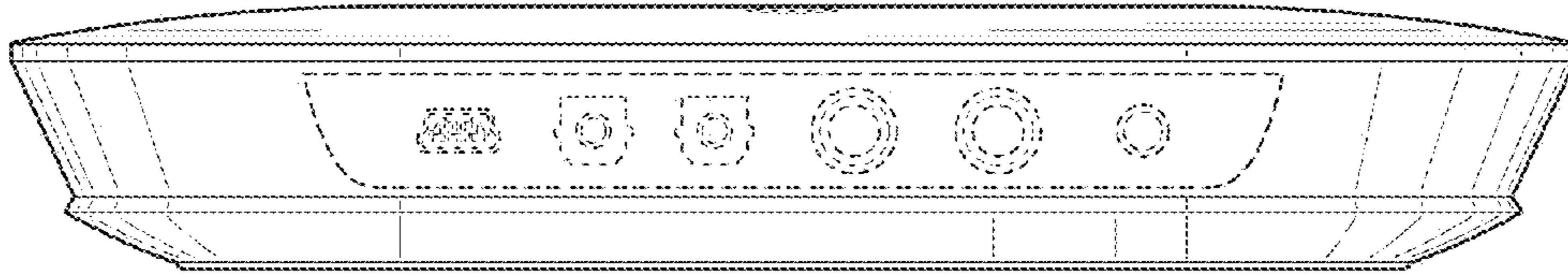

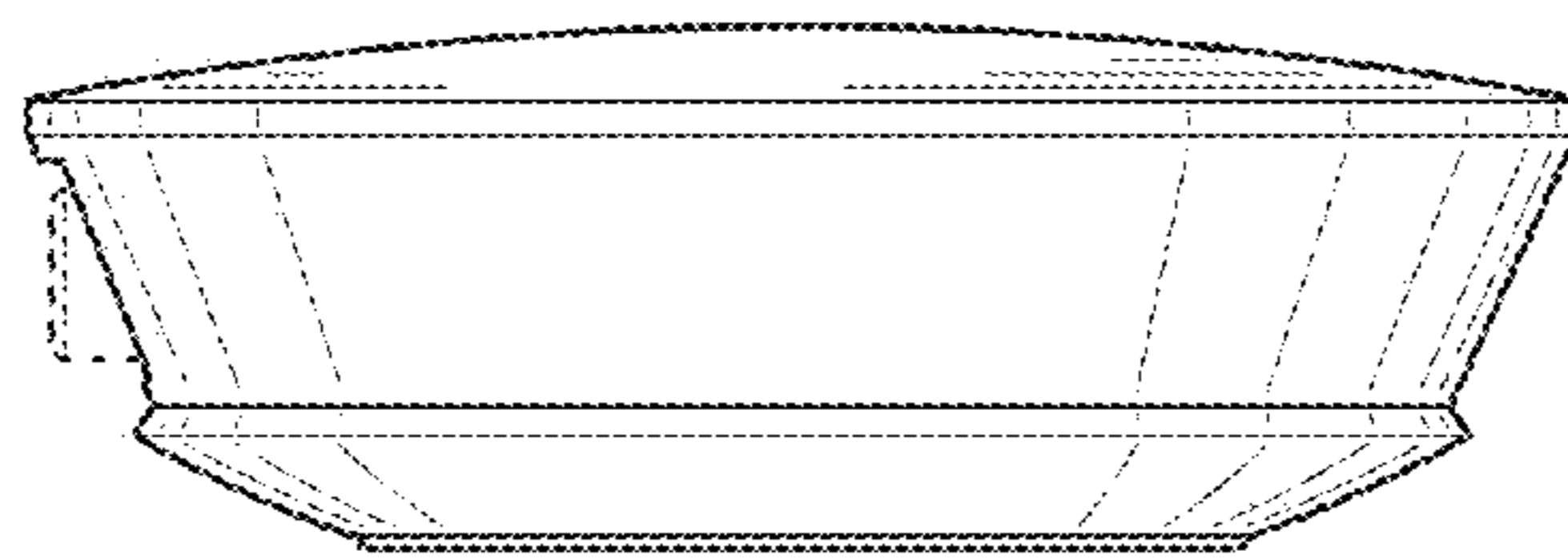

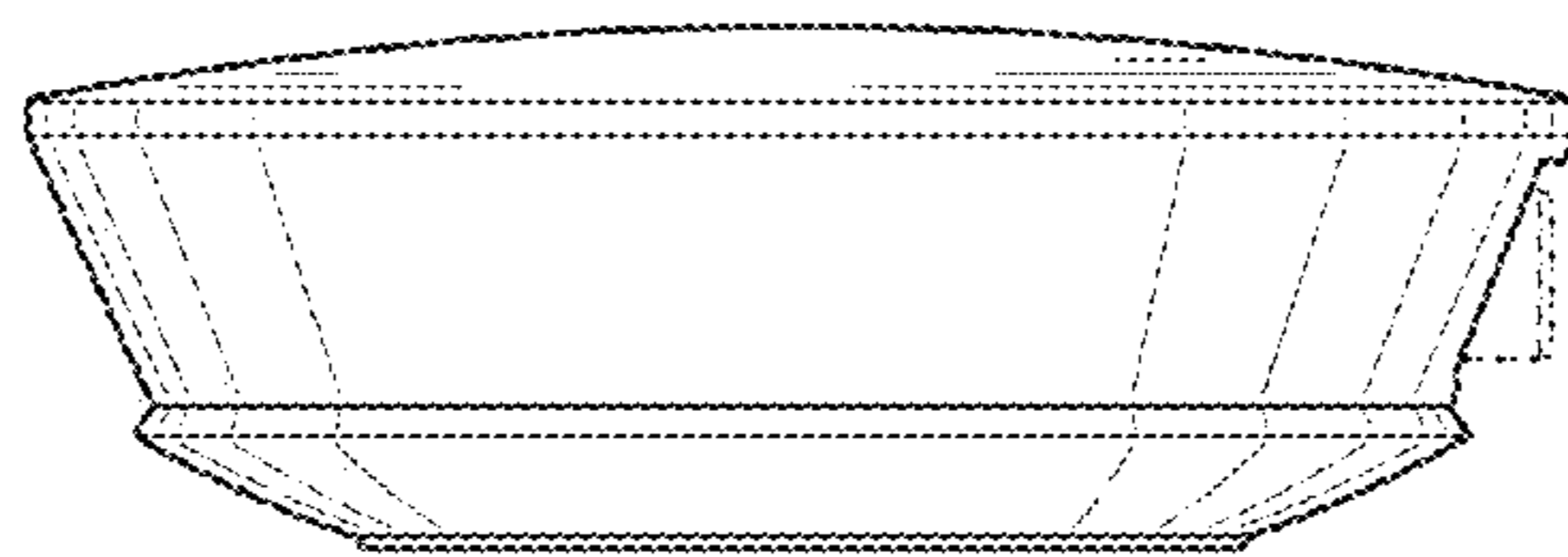

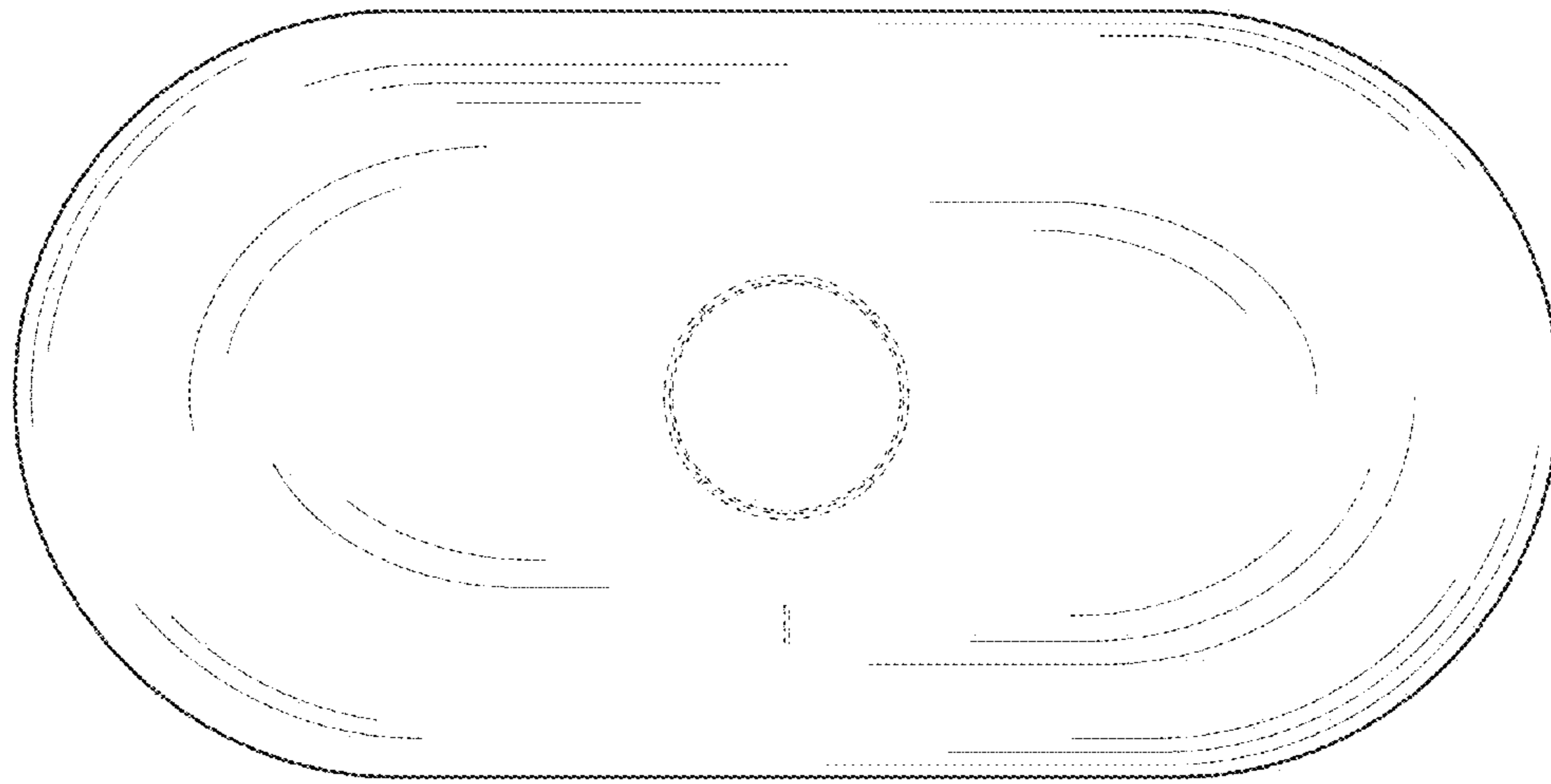

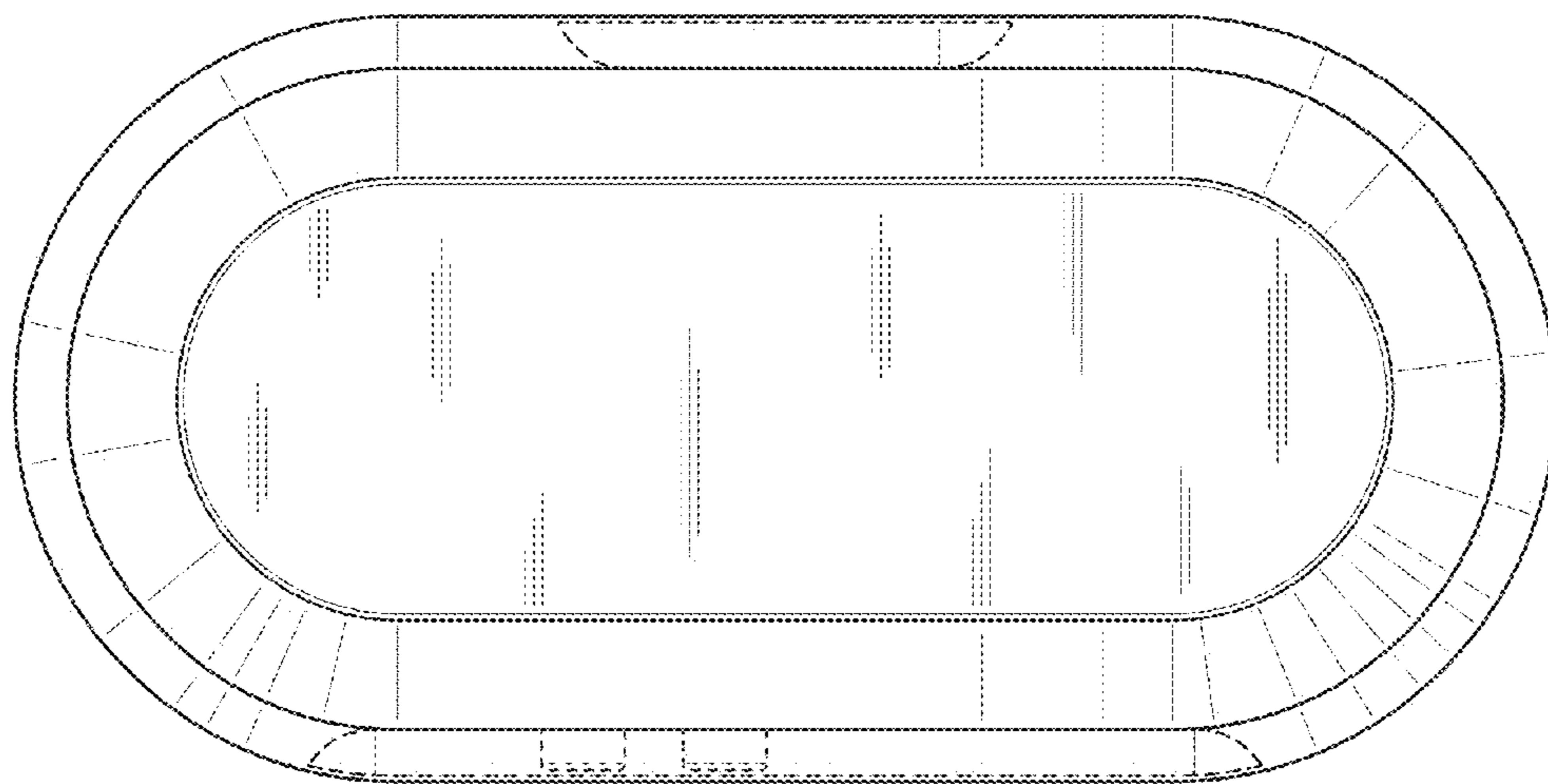
