The ornamental design for a digital notebook, as shown and described.

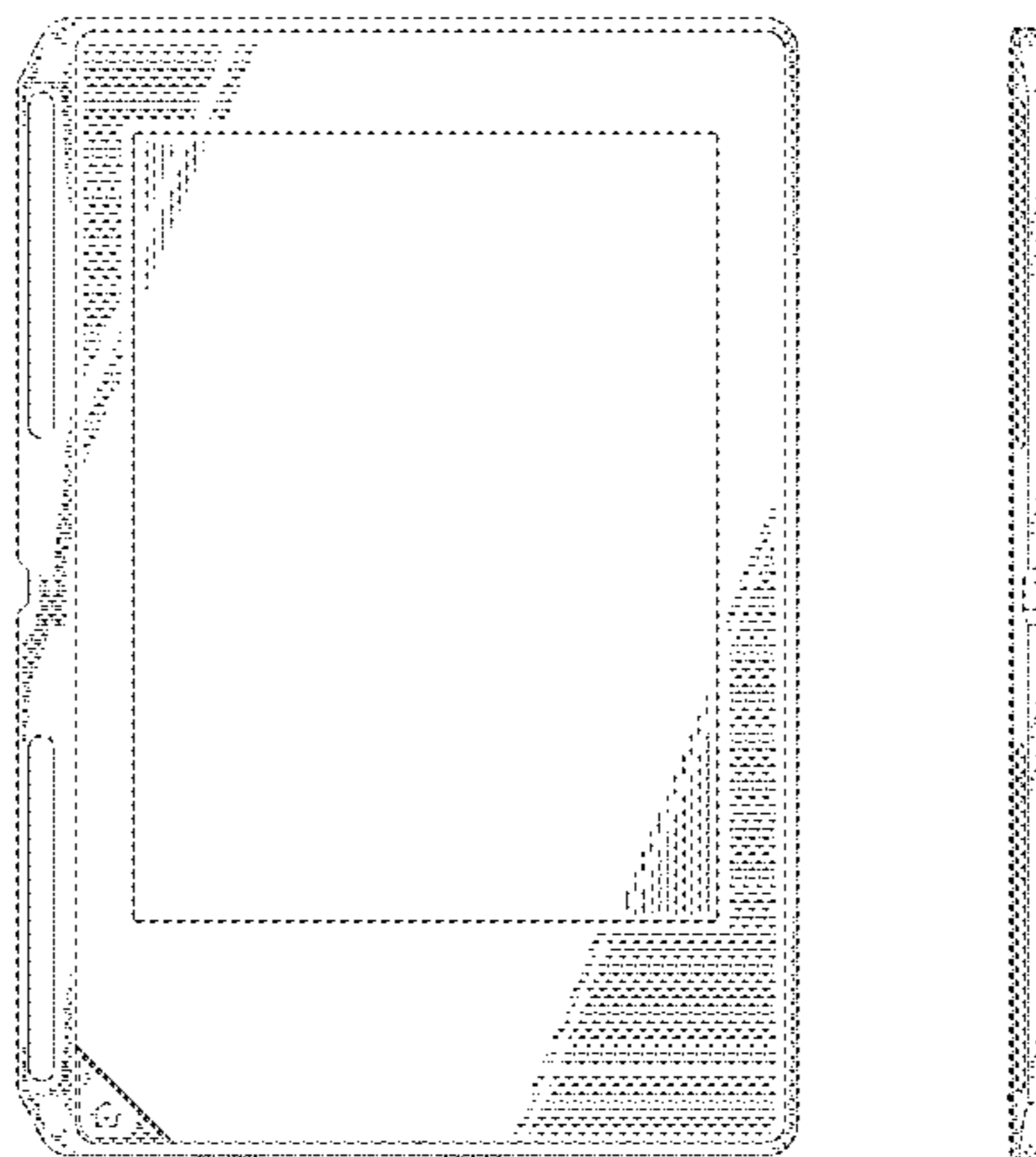
**DESCRIPTION**

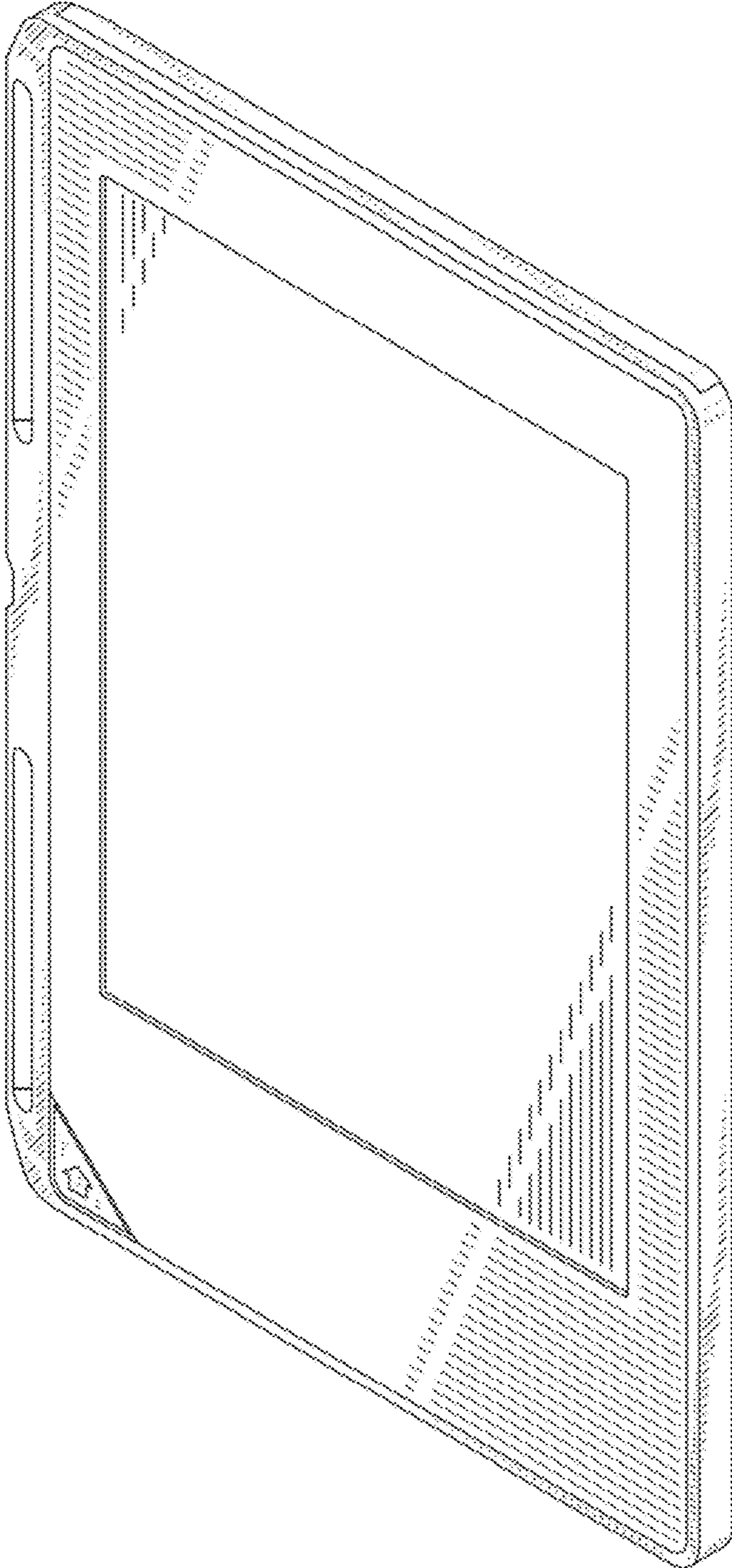

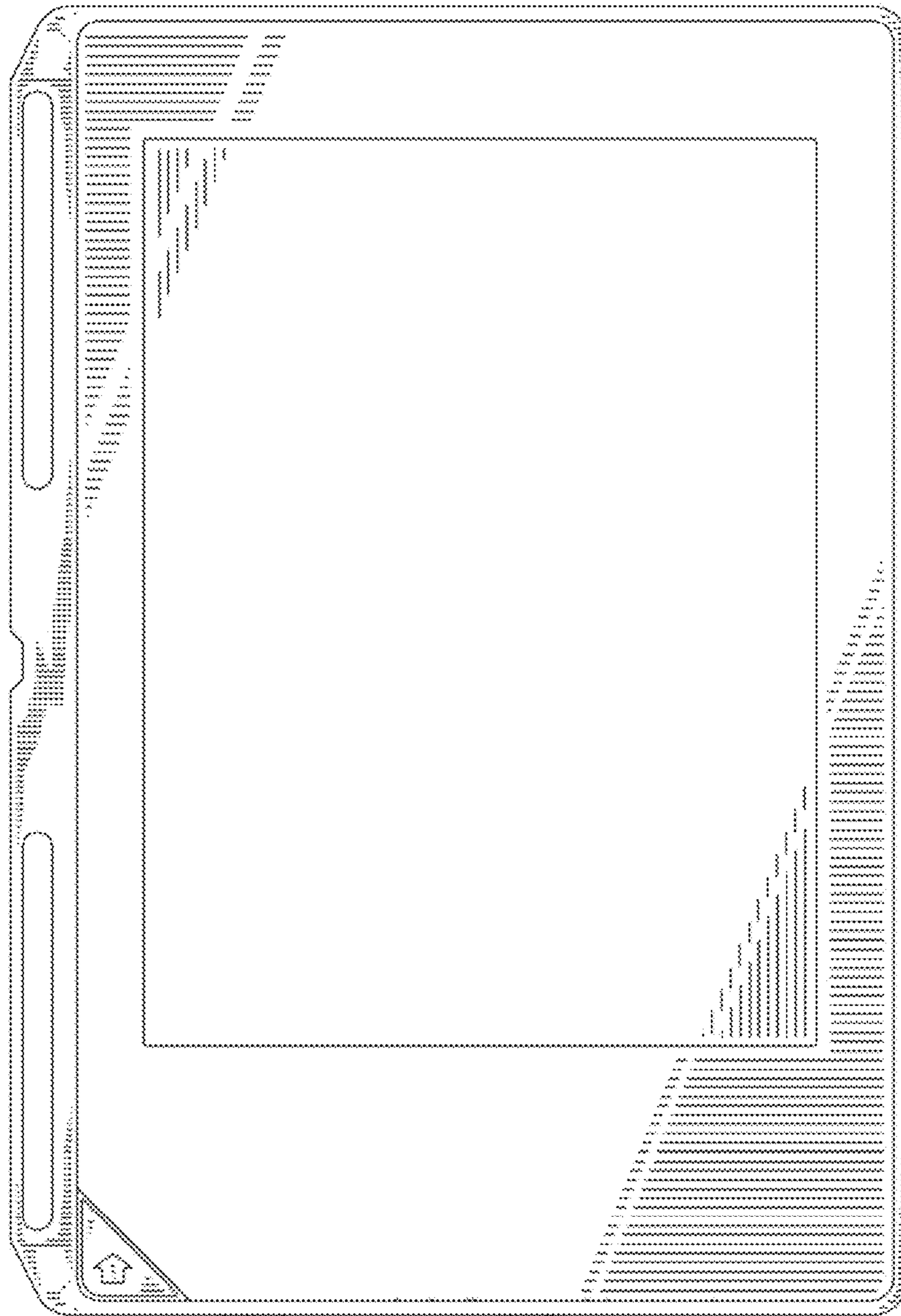

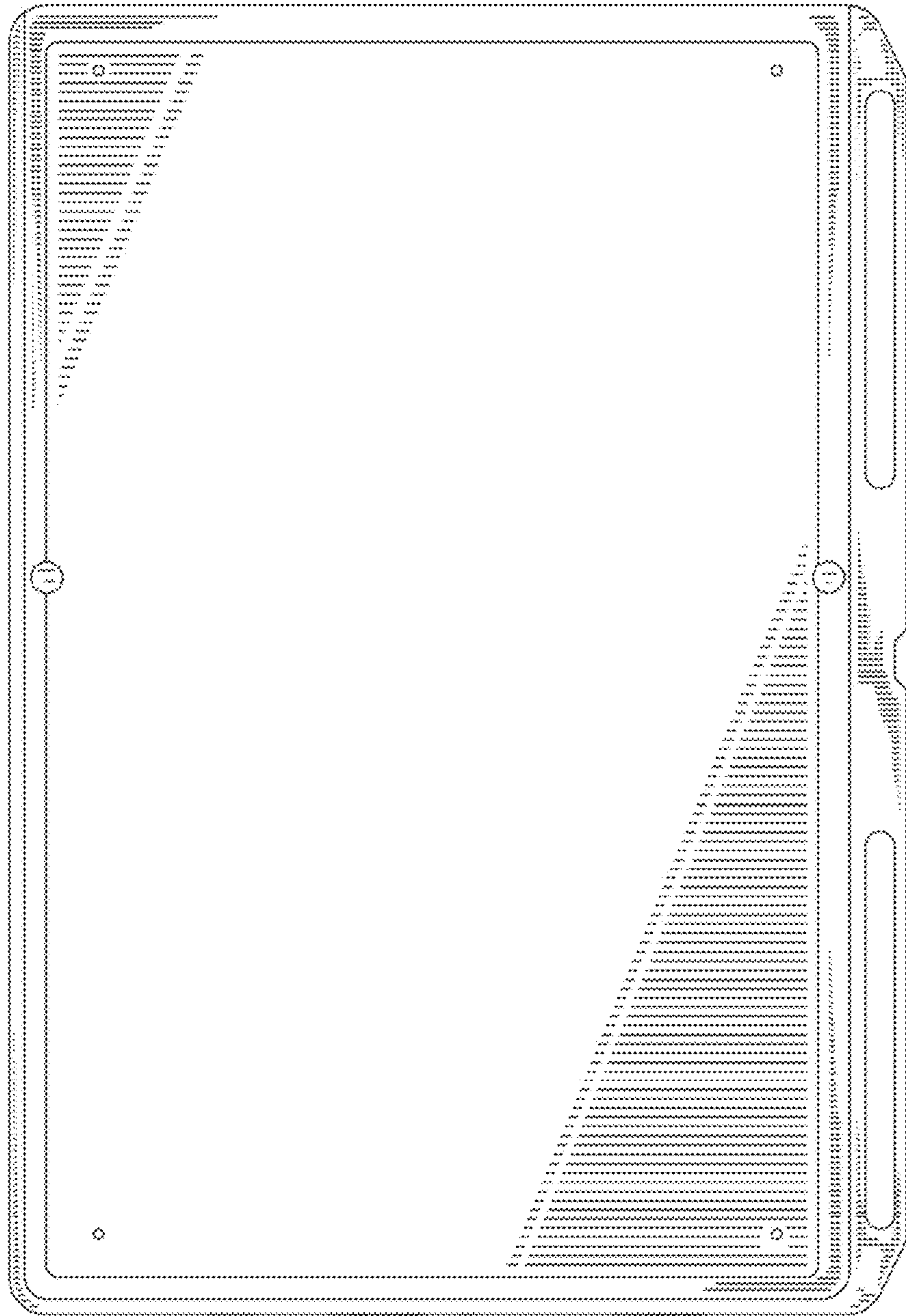

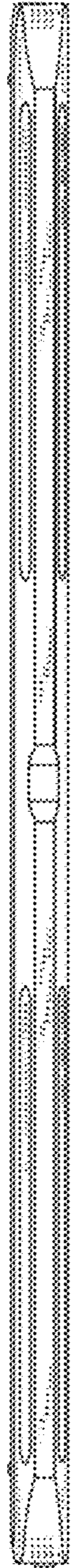

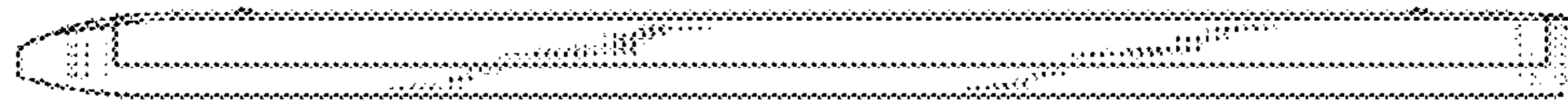
