FIG. 3 is a front view of a third image thereof;

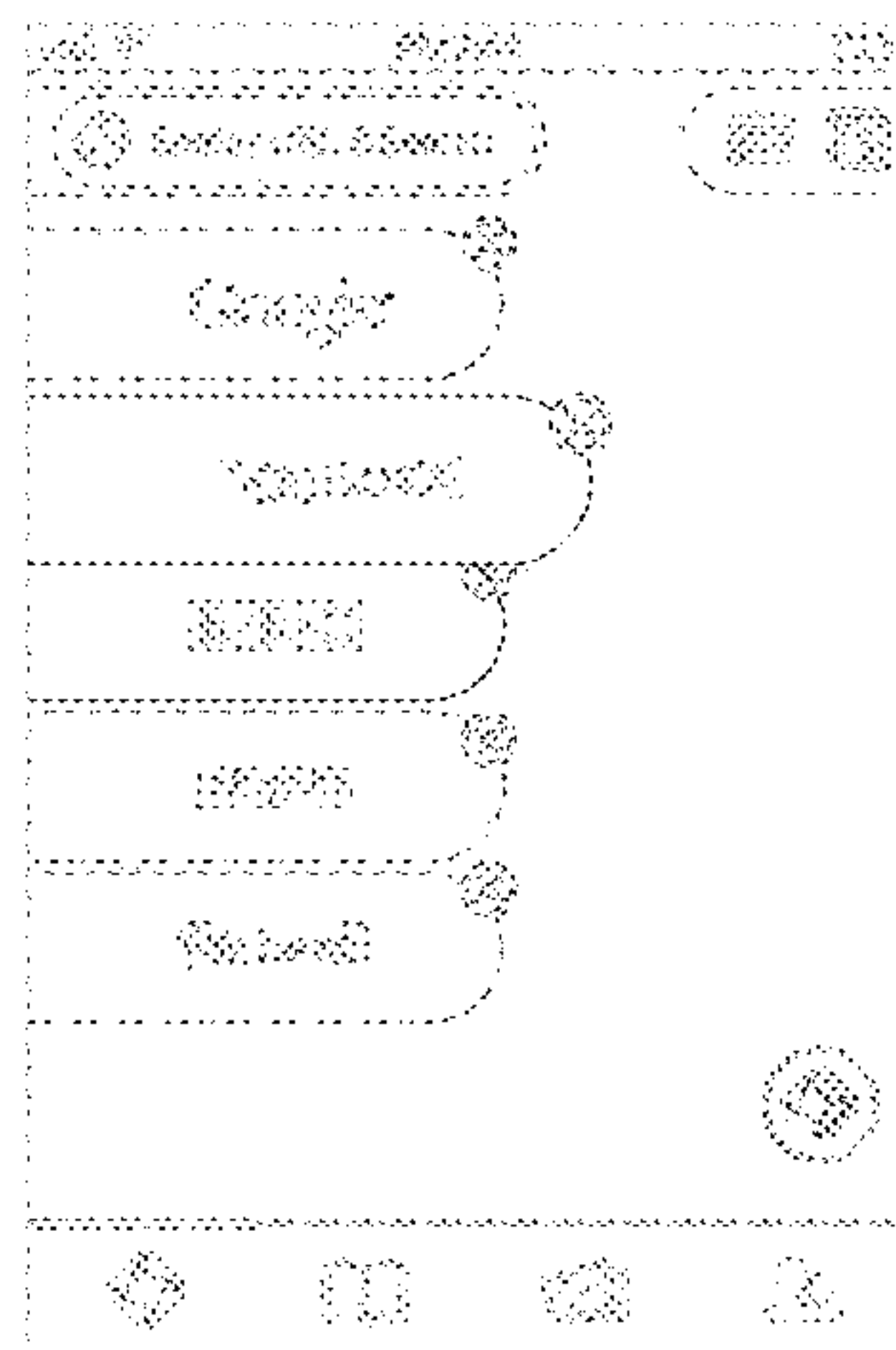
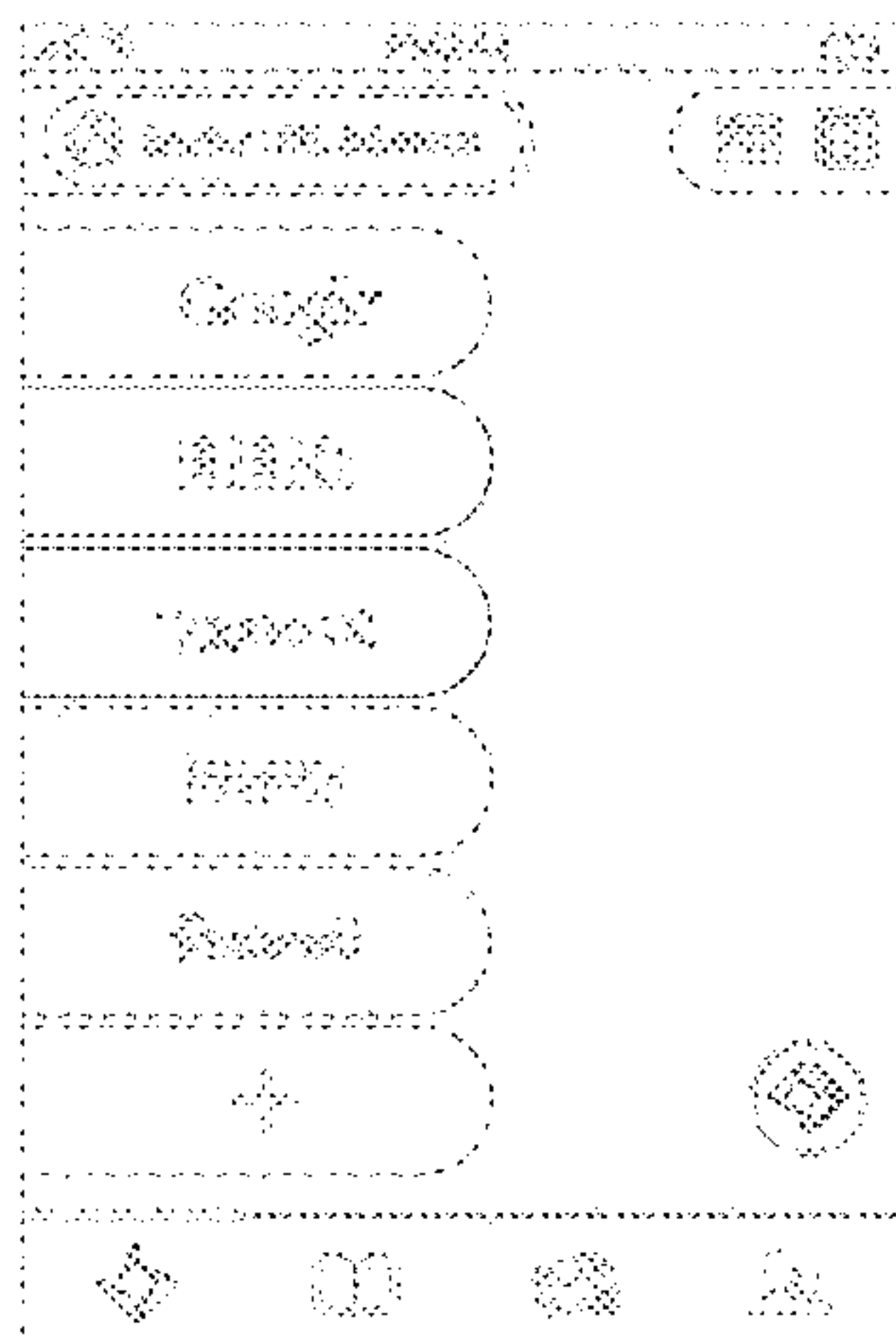
FIG. 4 is a front view of a fourth image thereof;

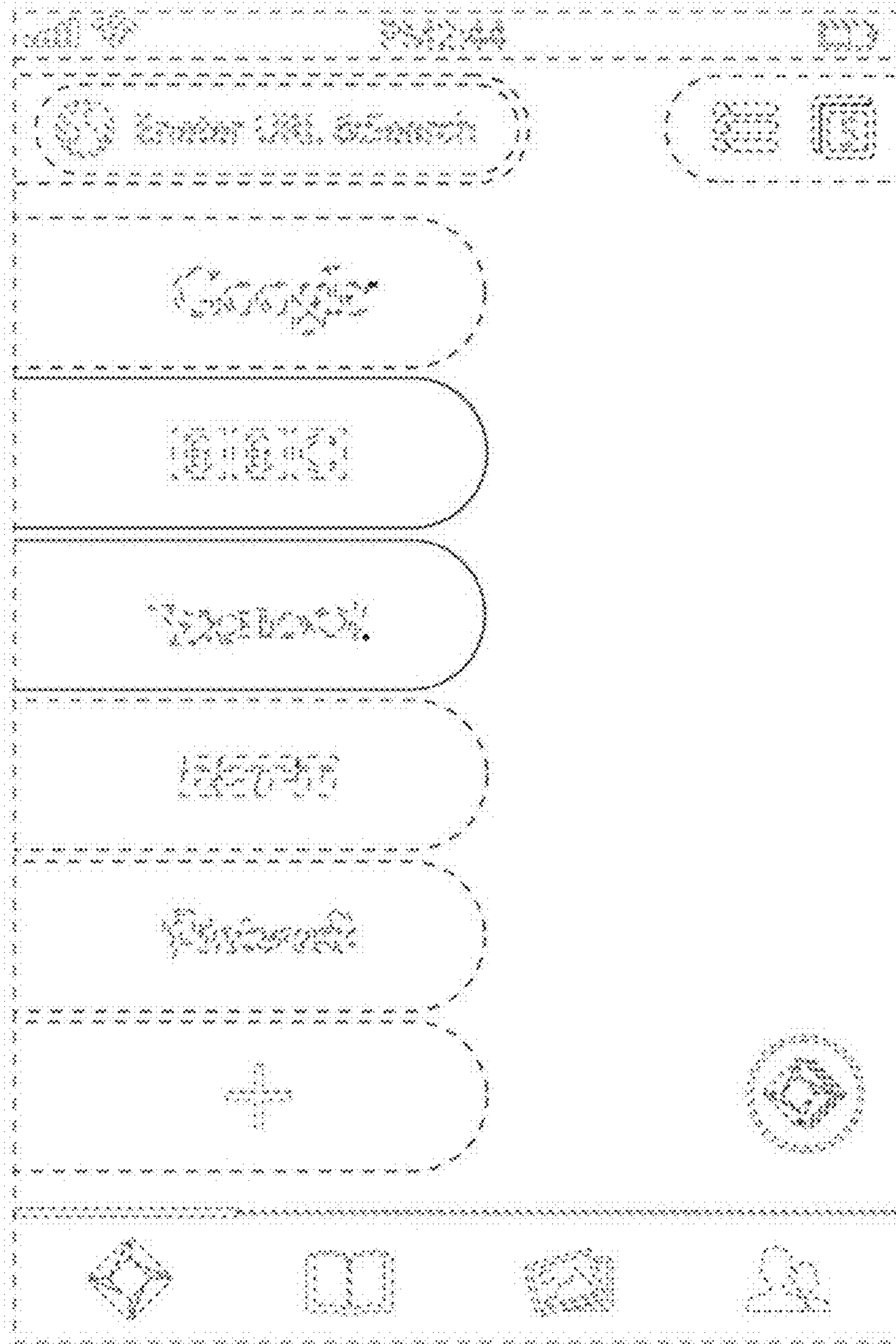

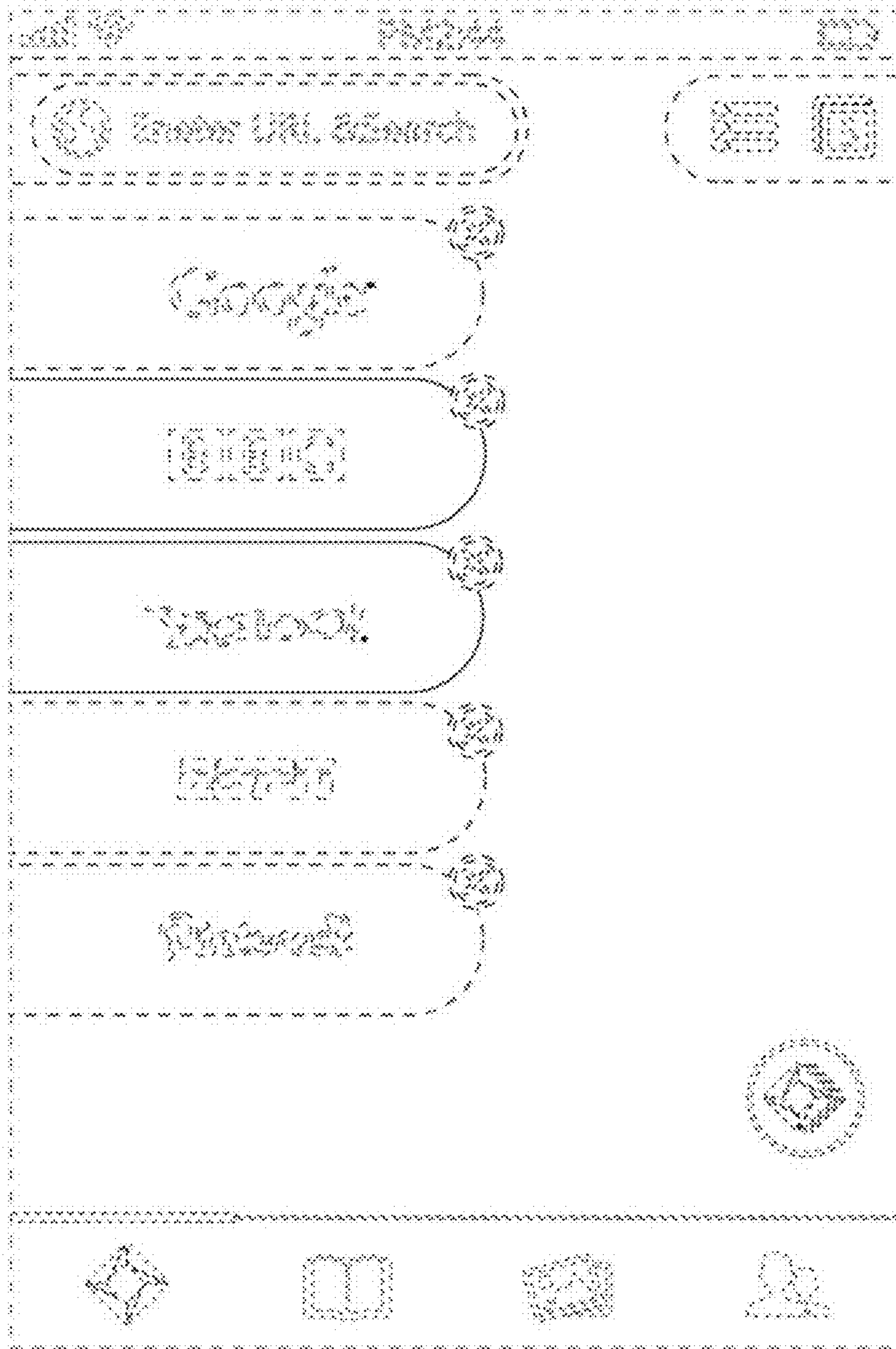

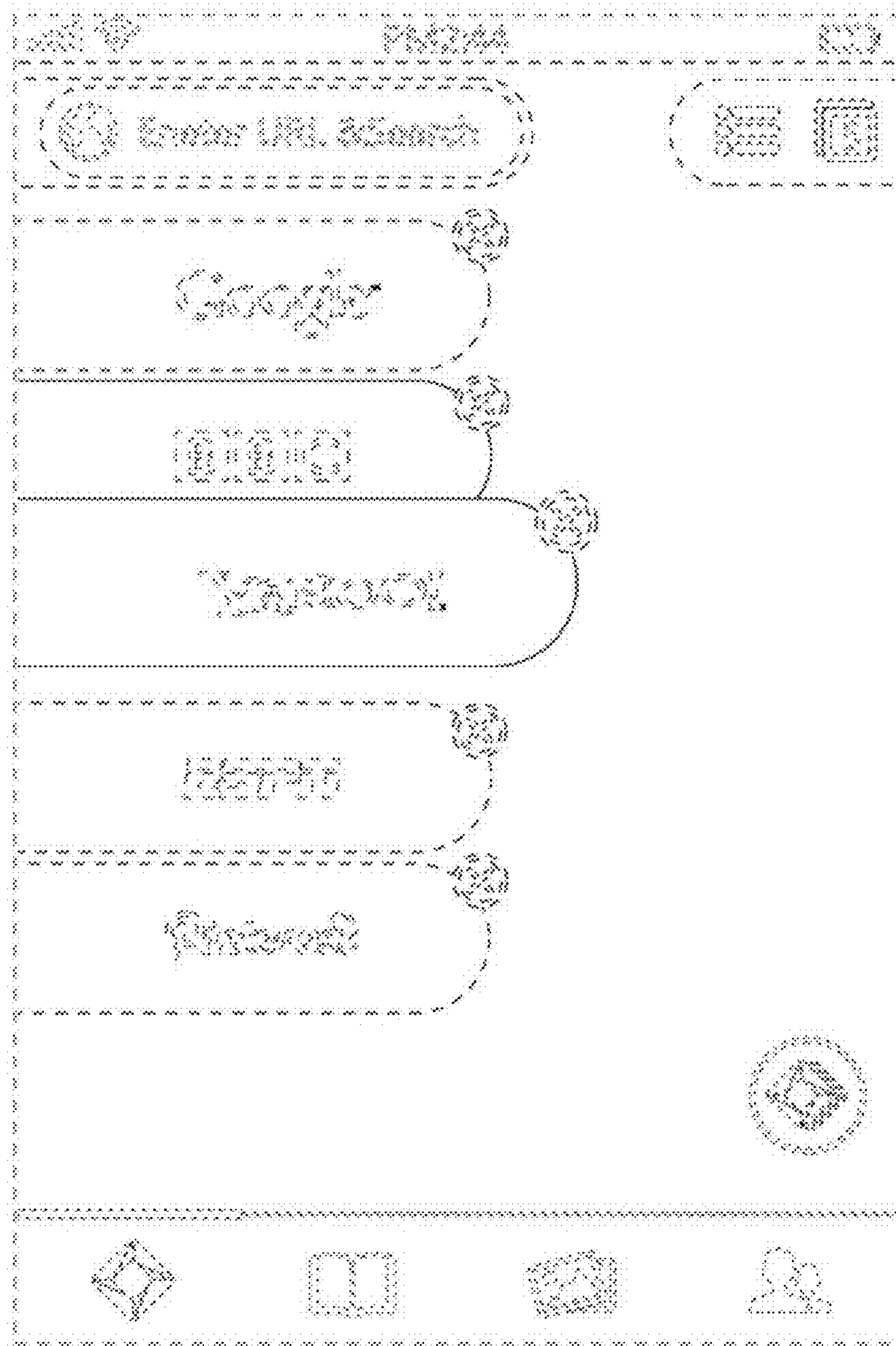

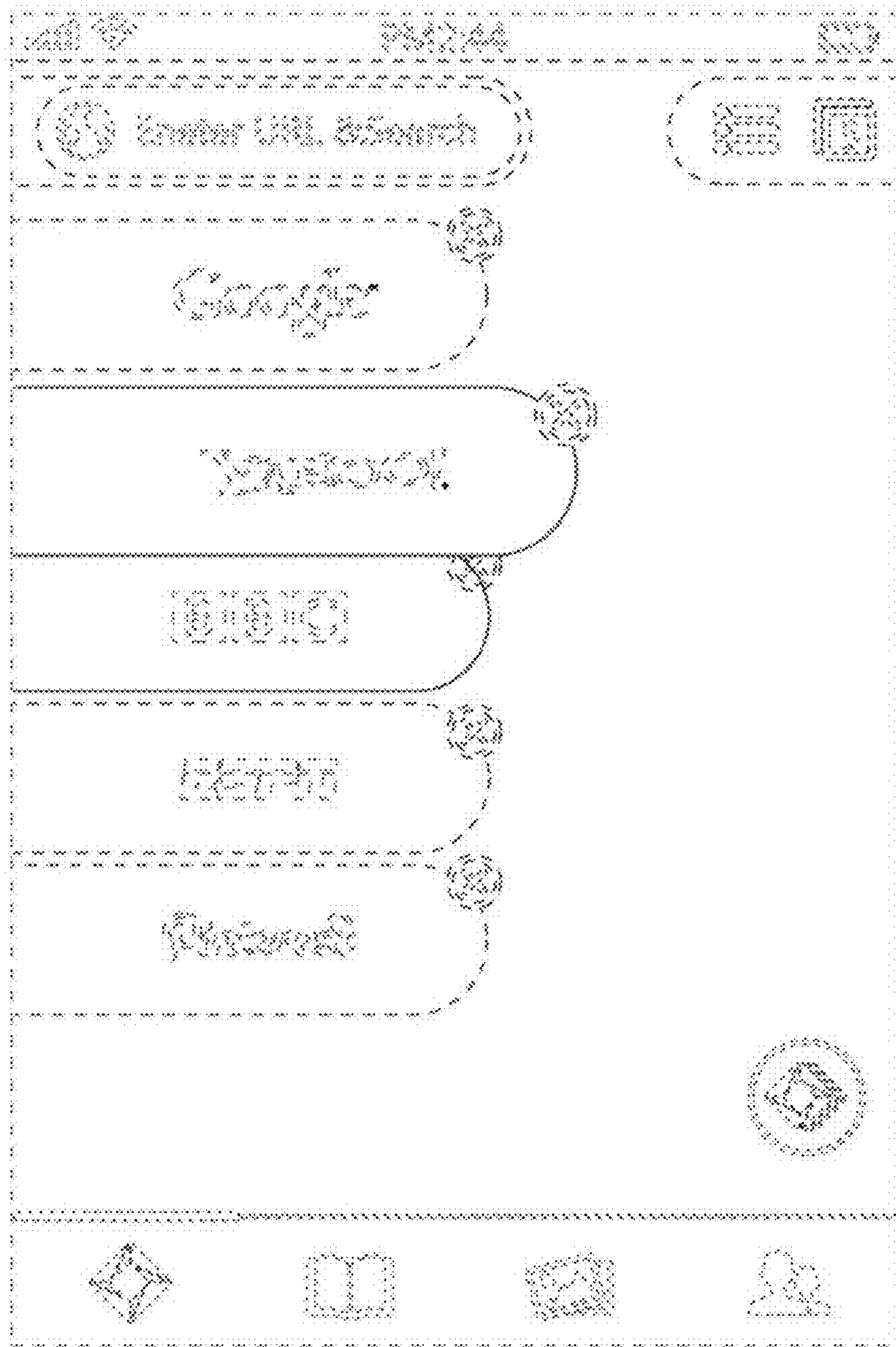

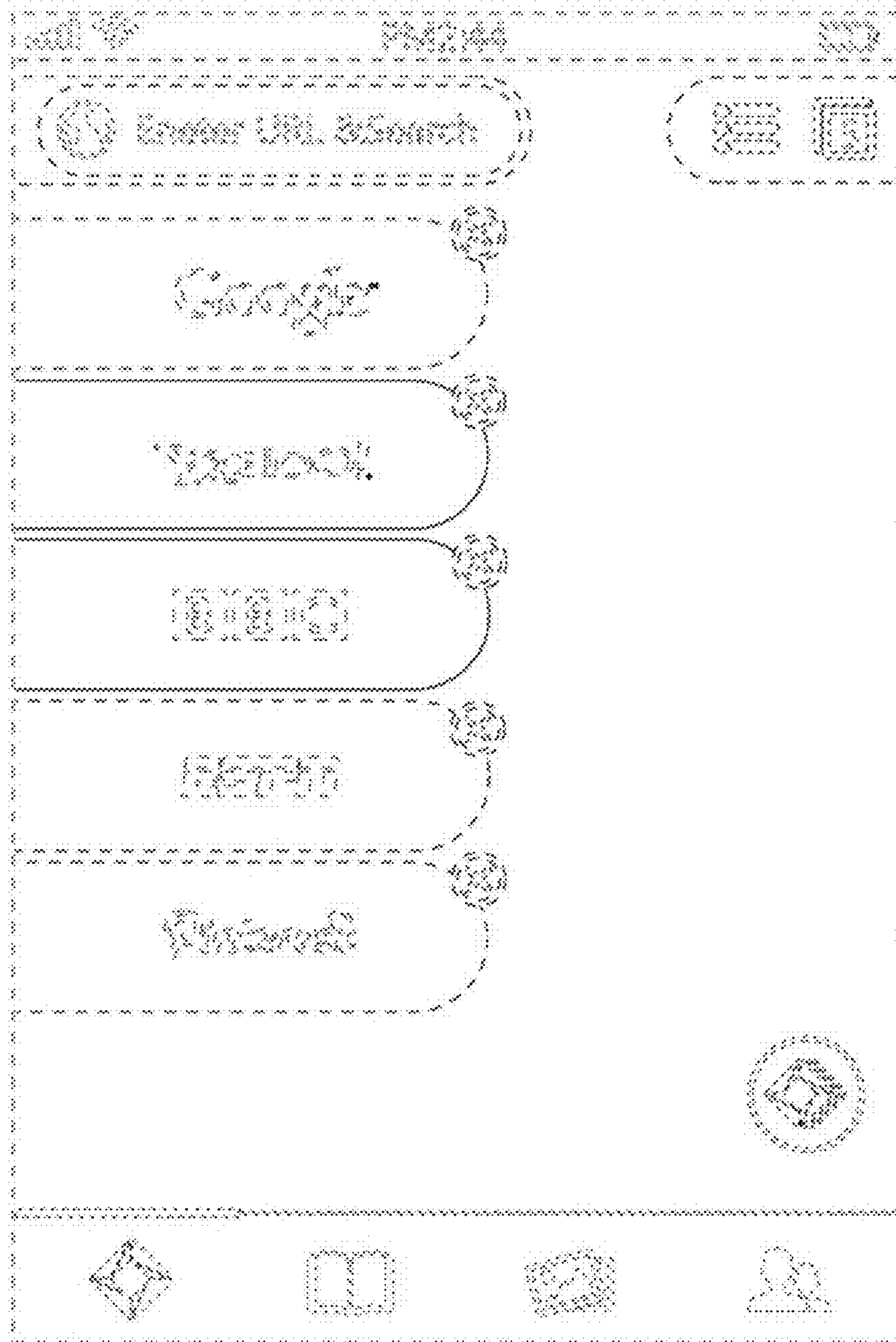

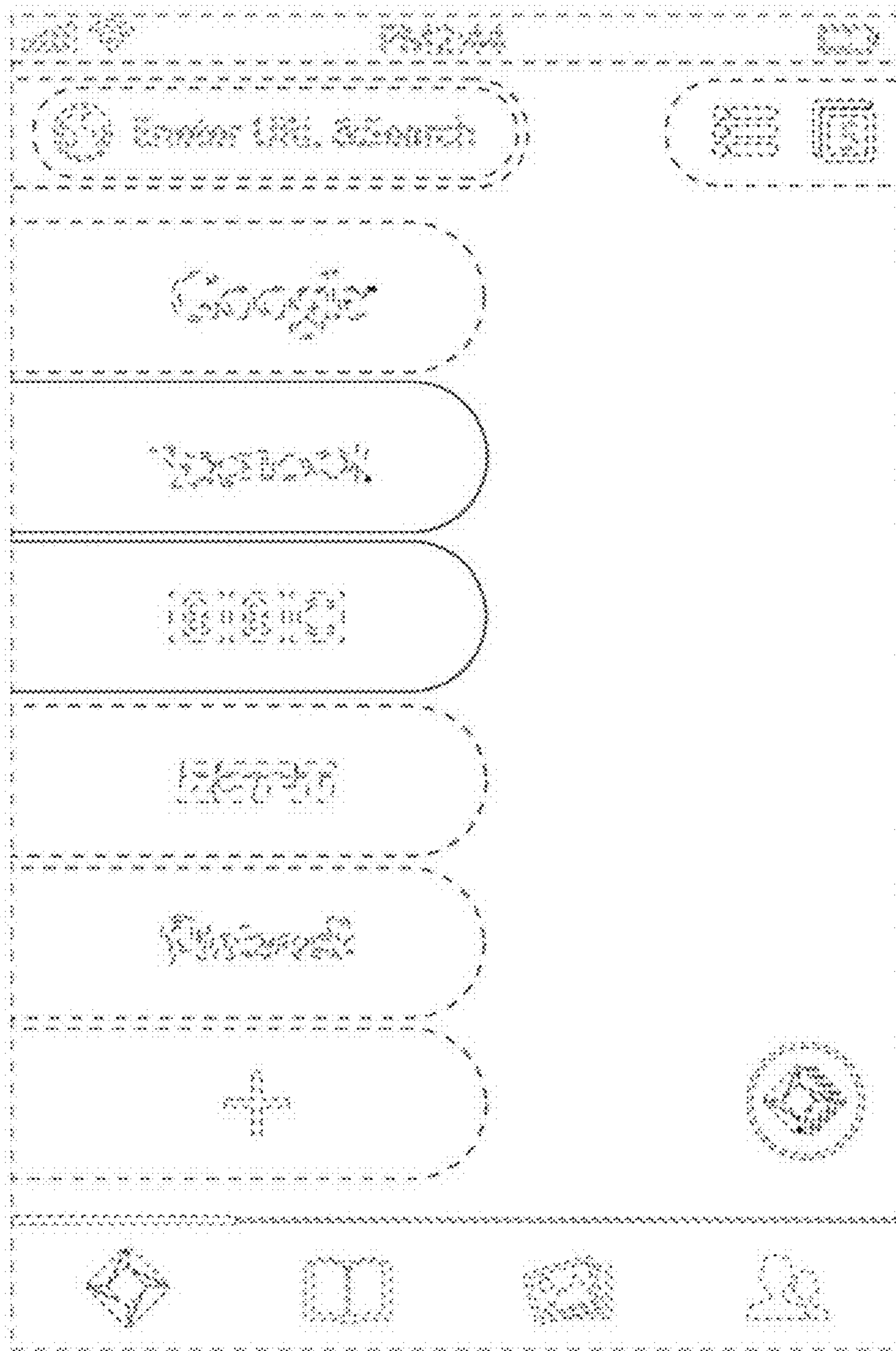
