(57) **CLAIM**
We claim, the ornamental design for a refrigerator handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator handle, showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is a another side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view thereof, showing a refrigerator handle in use condition; and,
FIG. 9 is an enlarged cross-sectional view thereof, as taken along the lines 9-9 in FIG. 2.
The broken lines in FIG. 8 of the drawings show environment only and form no part of the claimed design.

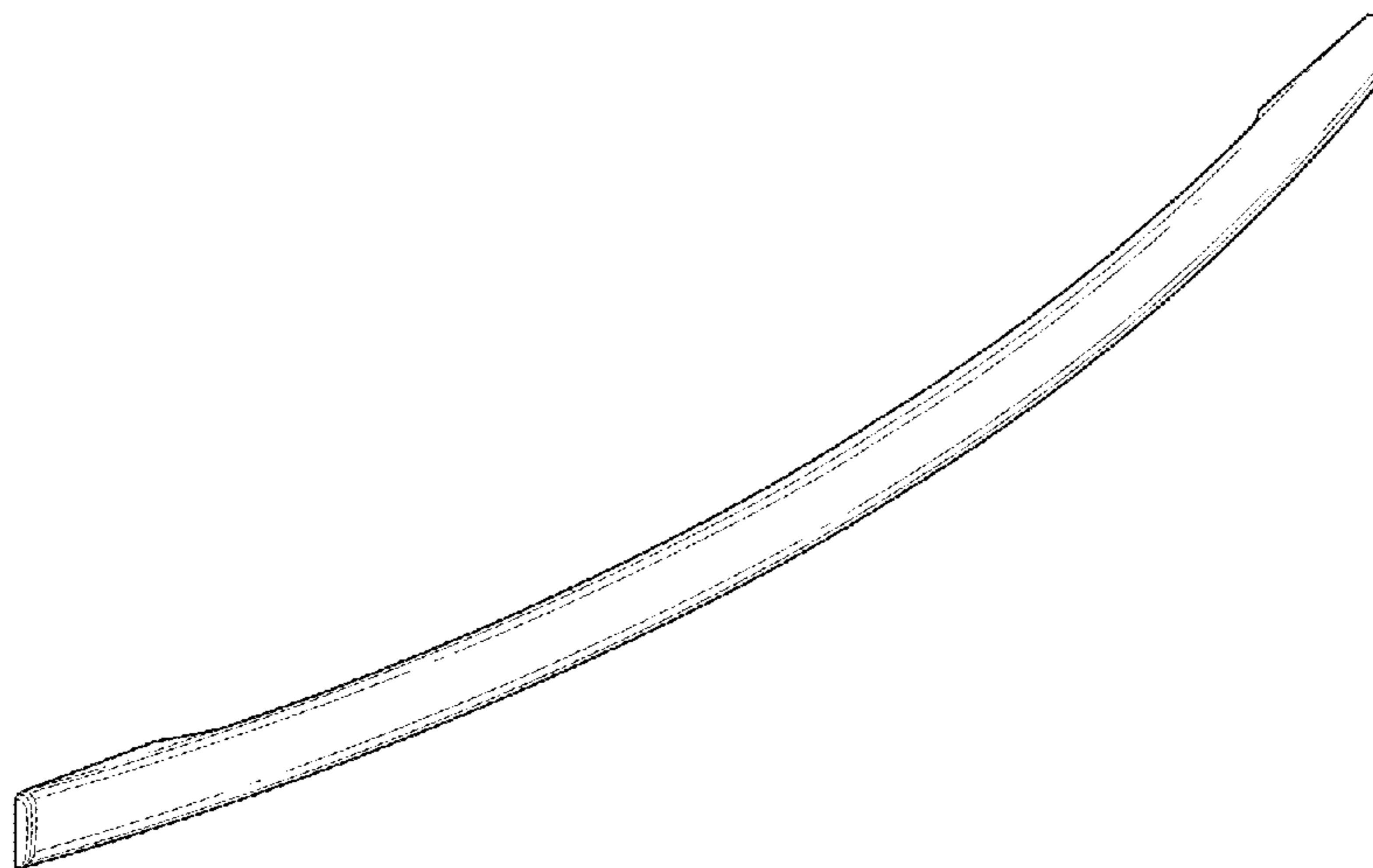

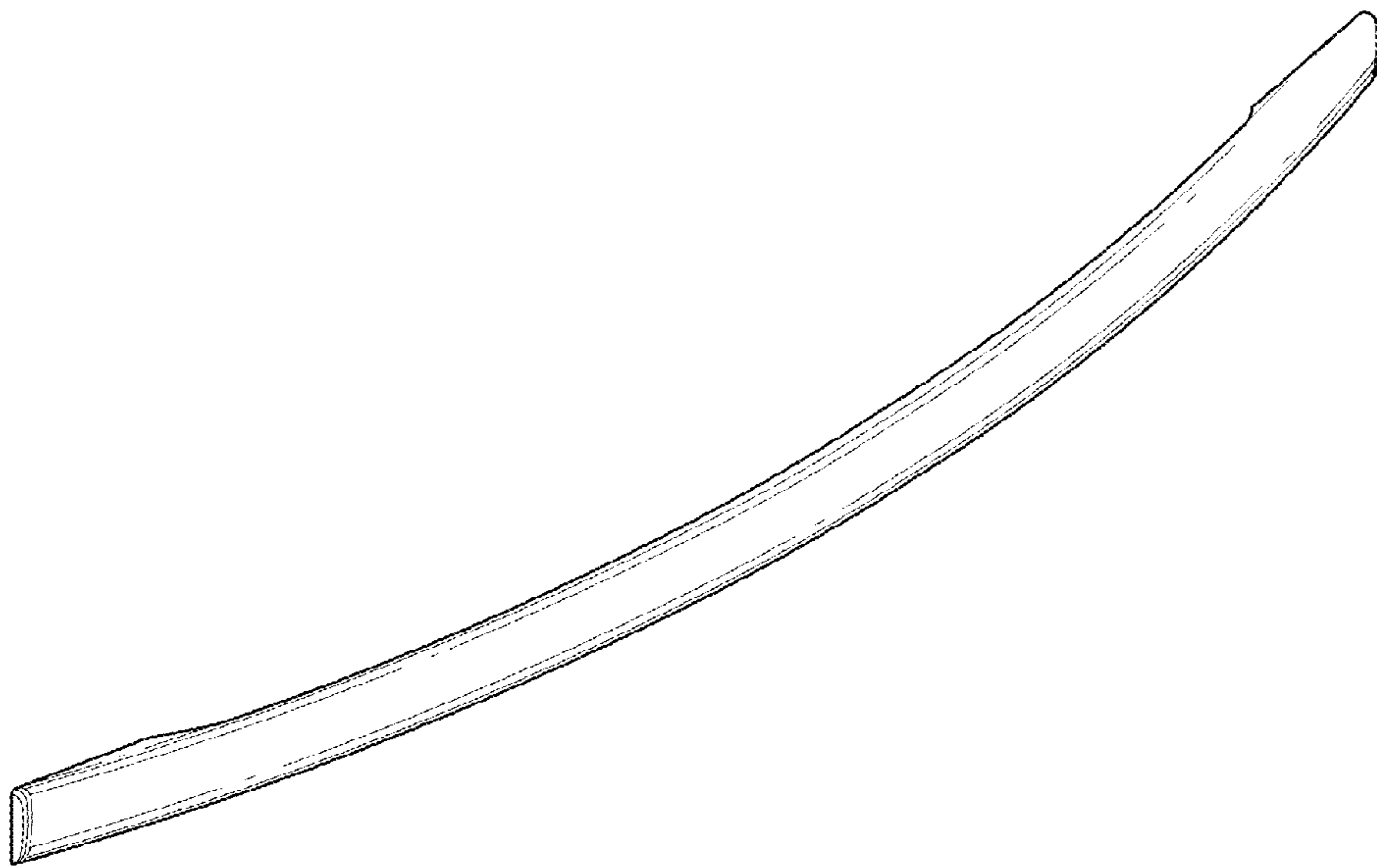

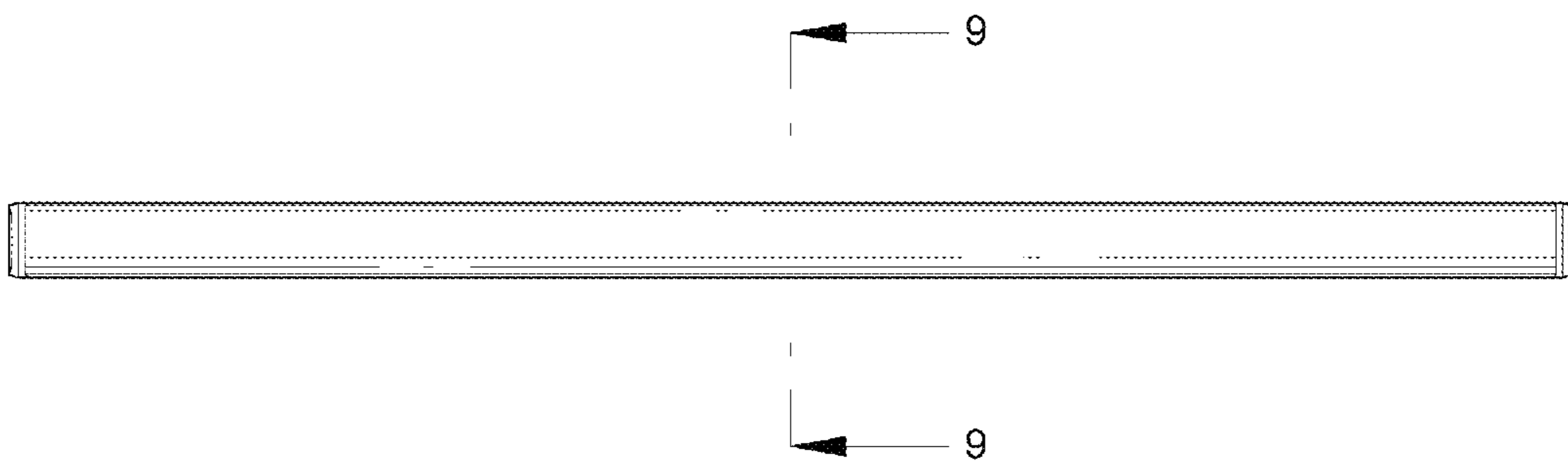

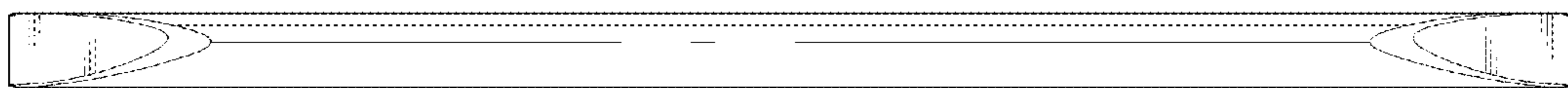

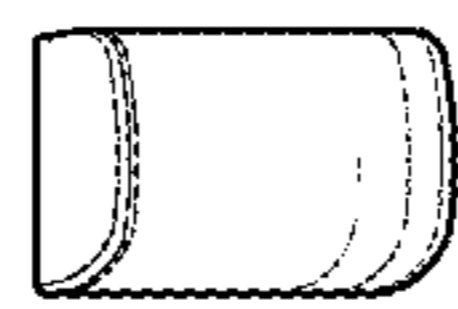

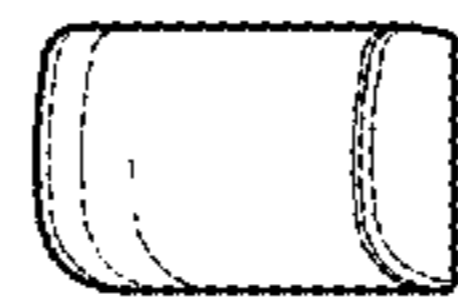

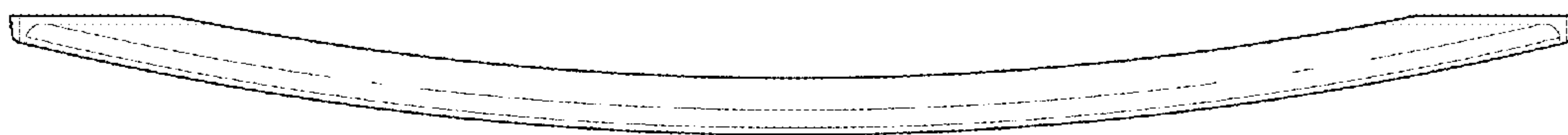

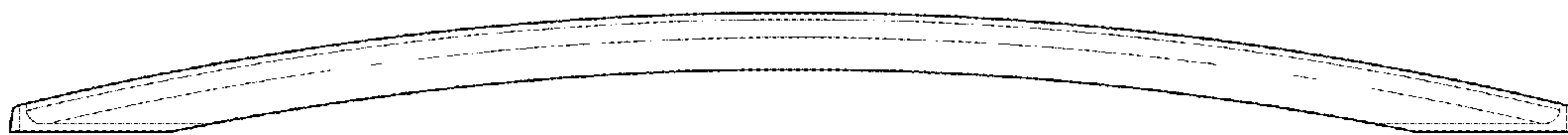

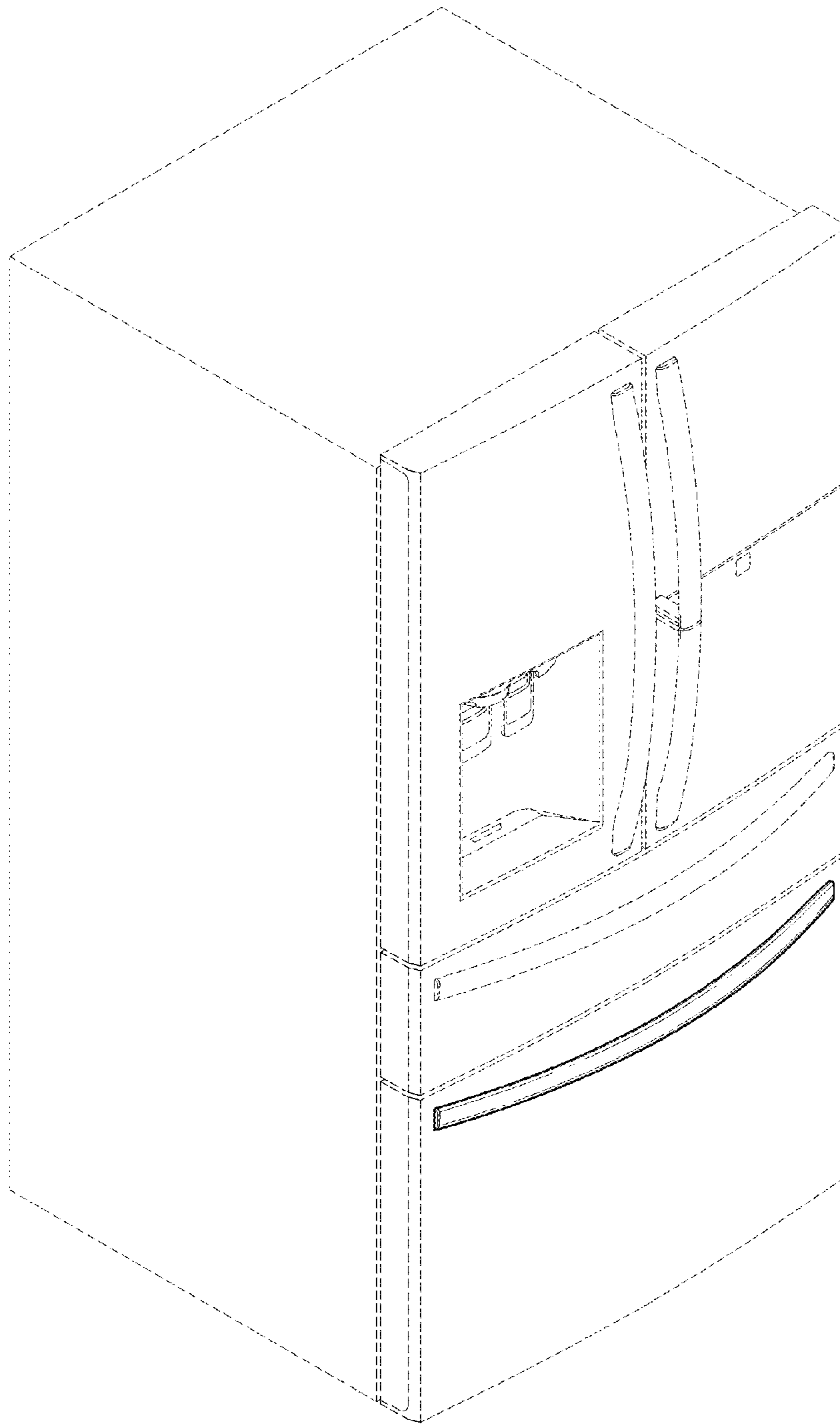
