**DESCRIPTION**

FIG. 1 is a top and bottom view of a basketball training device showing my new design;

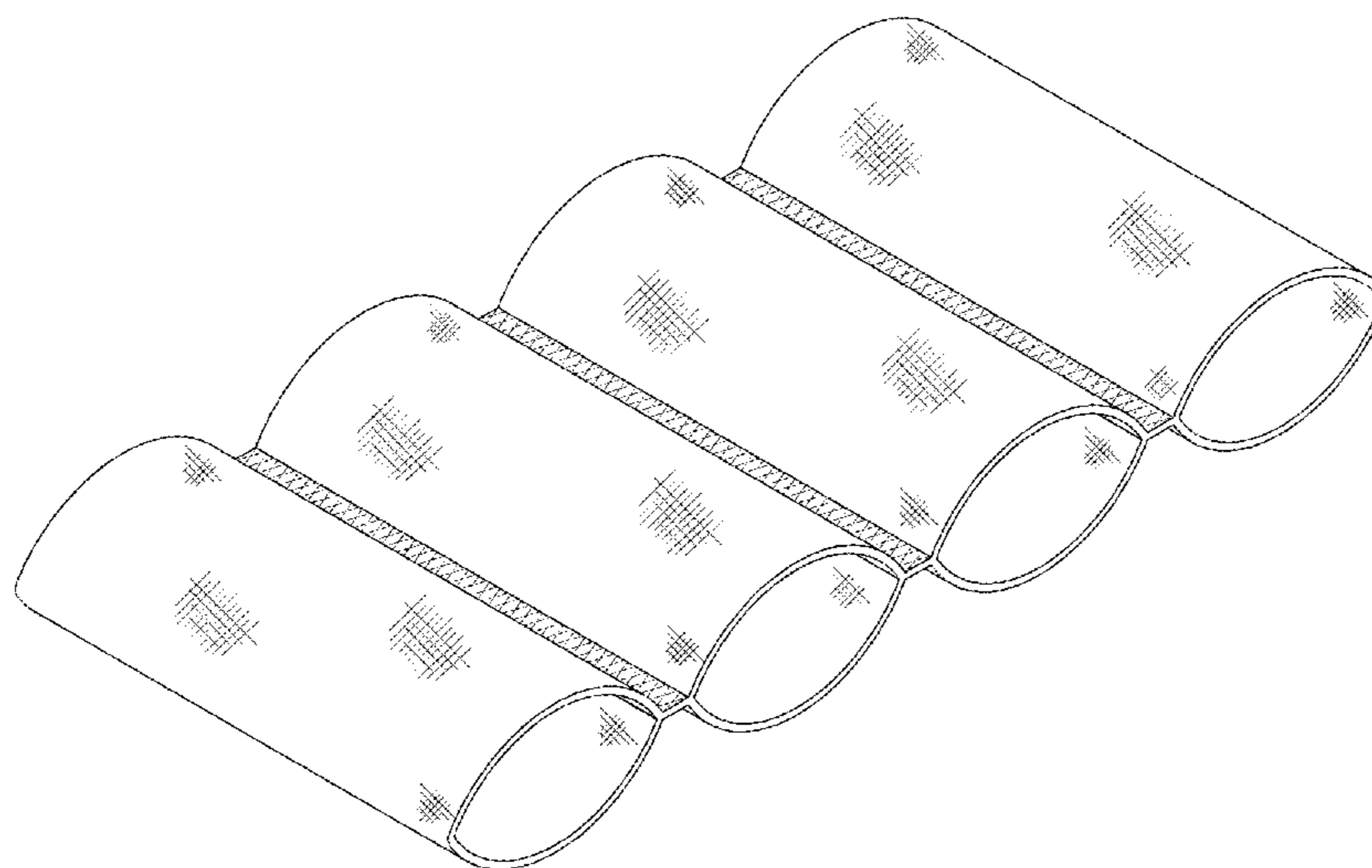

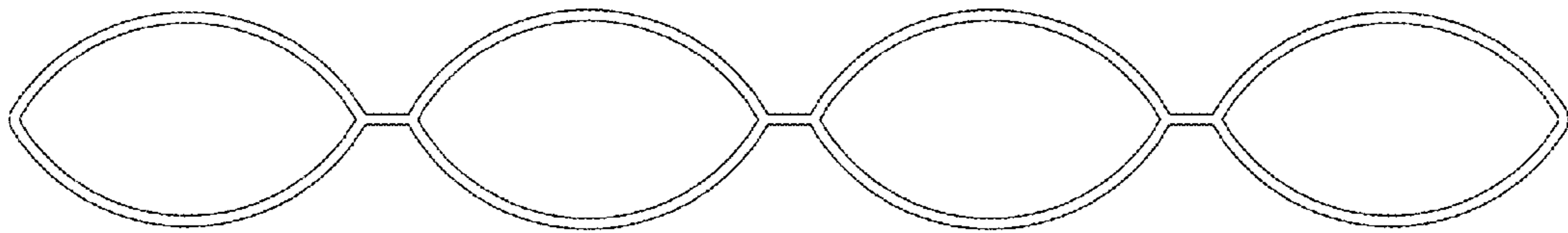

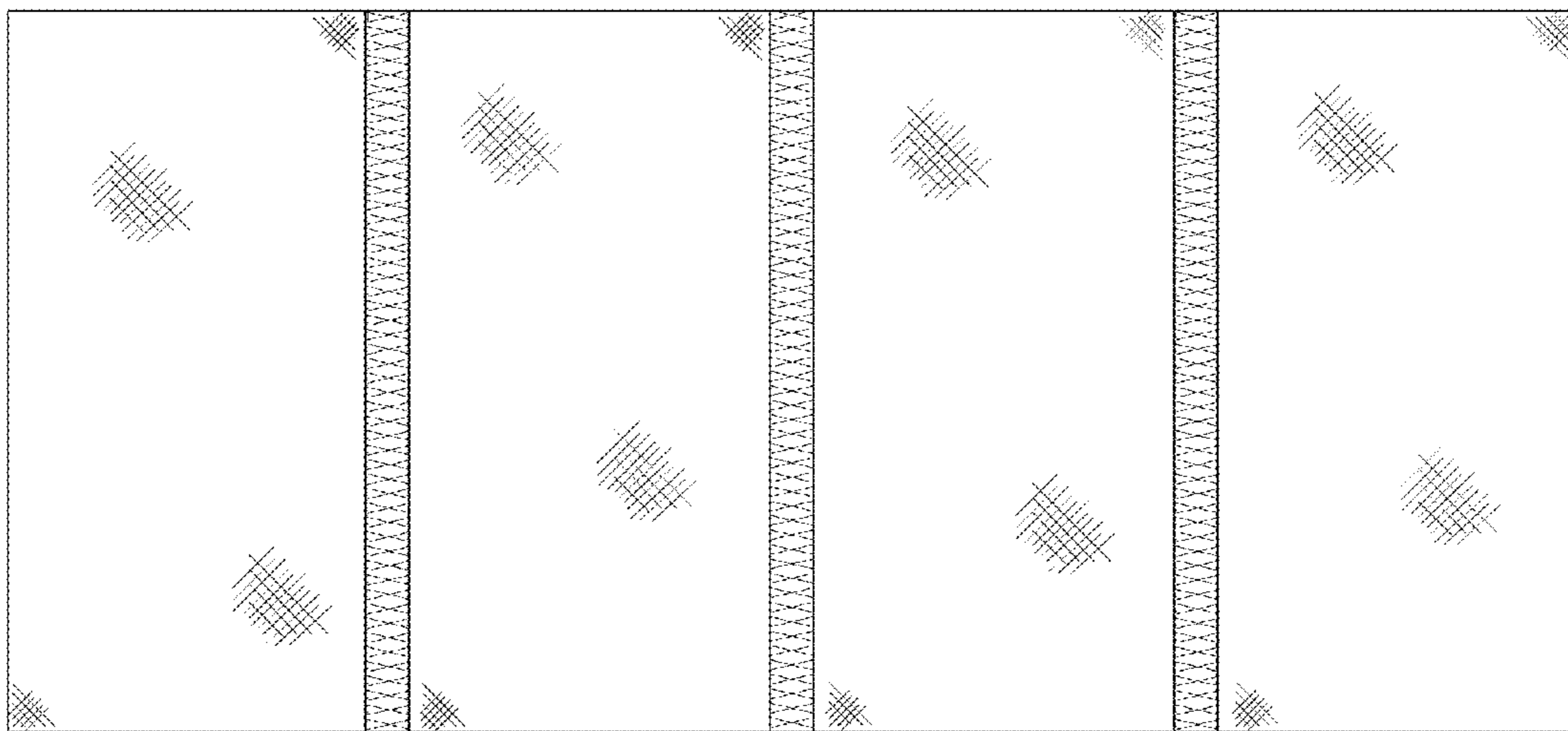

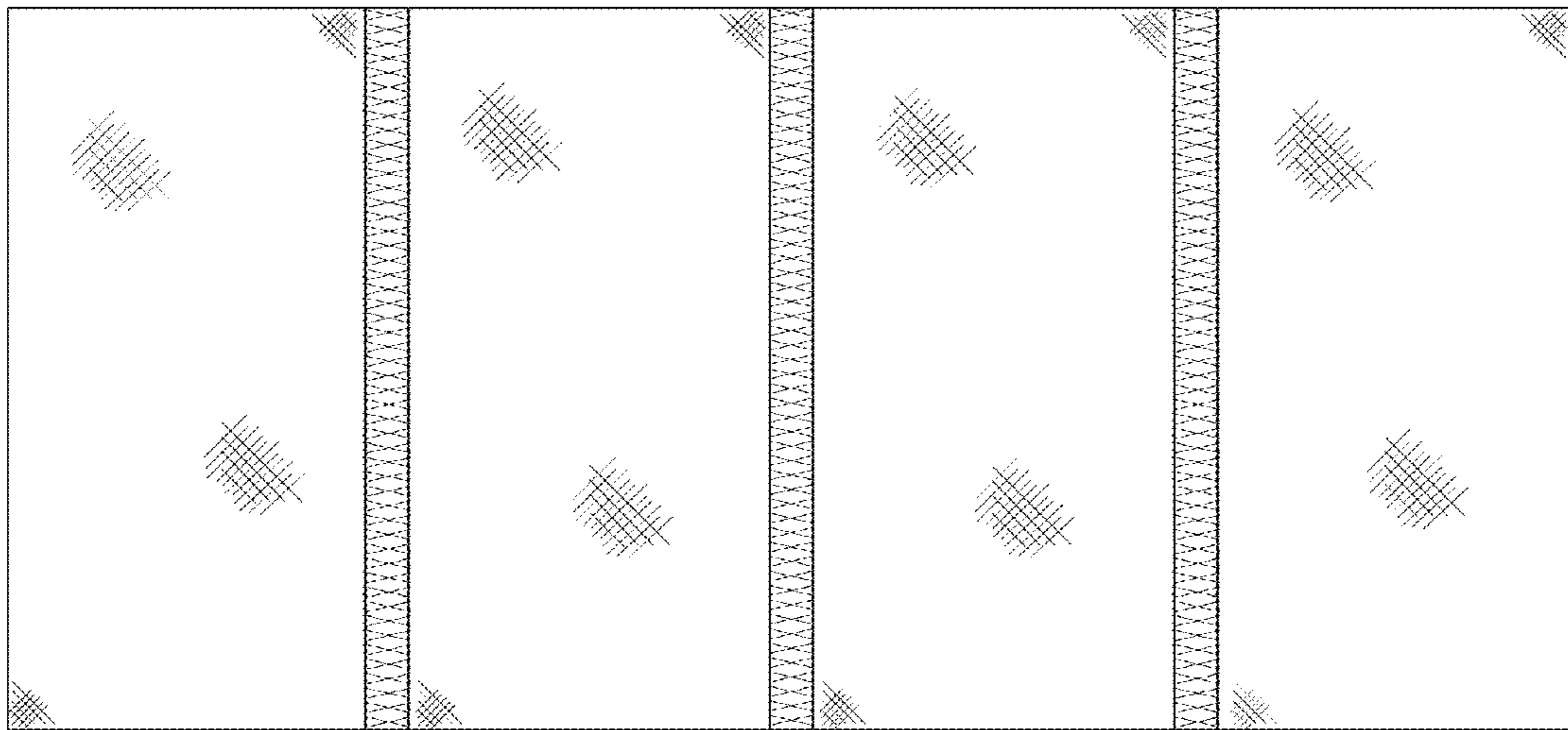

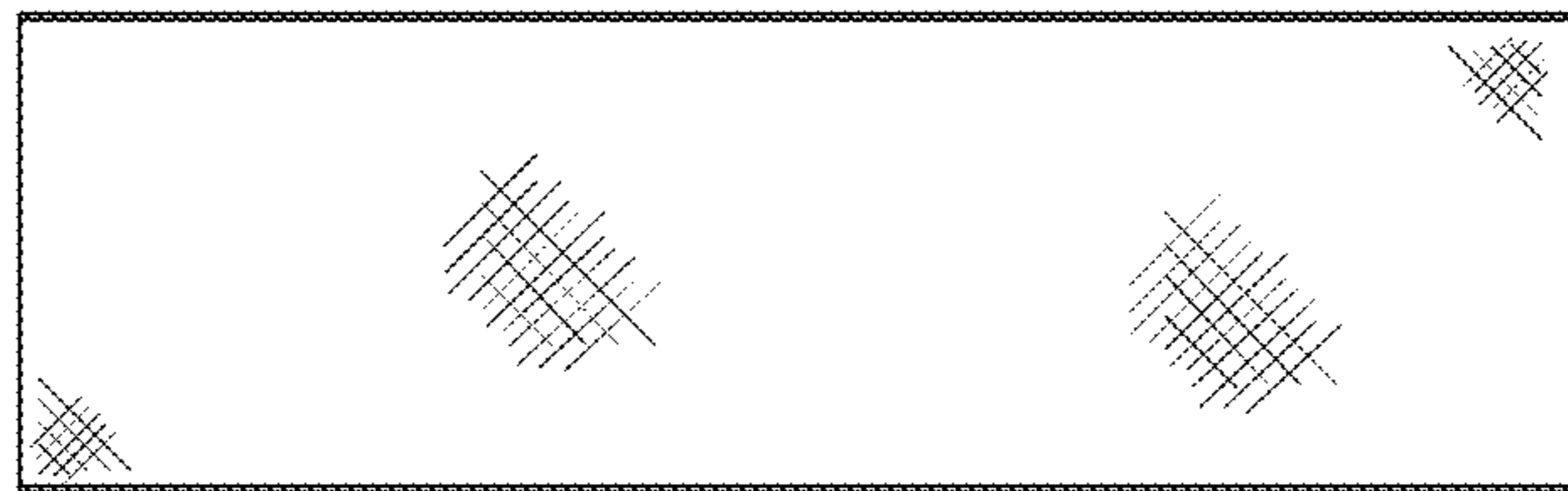

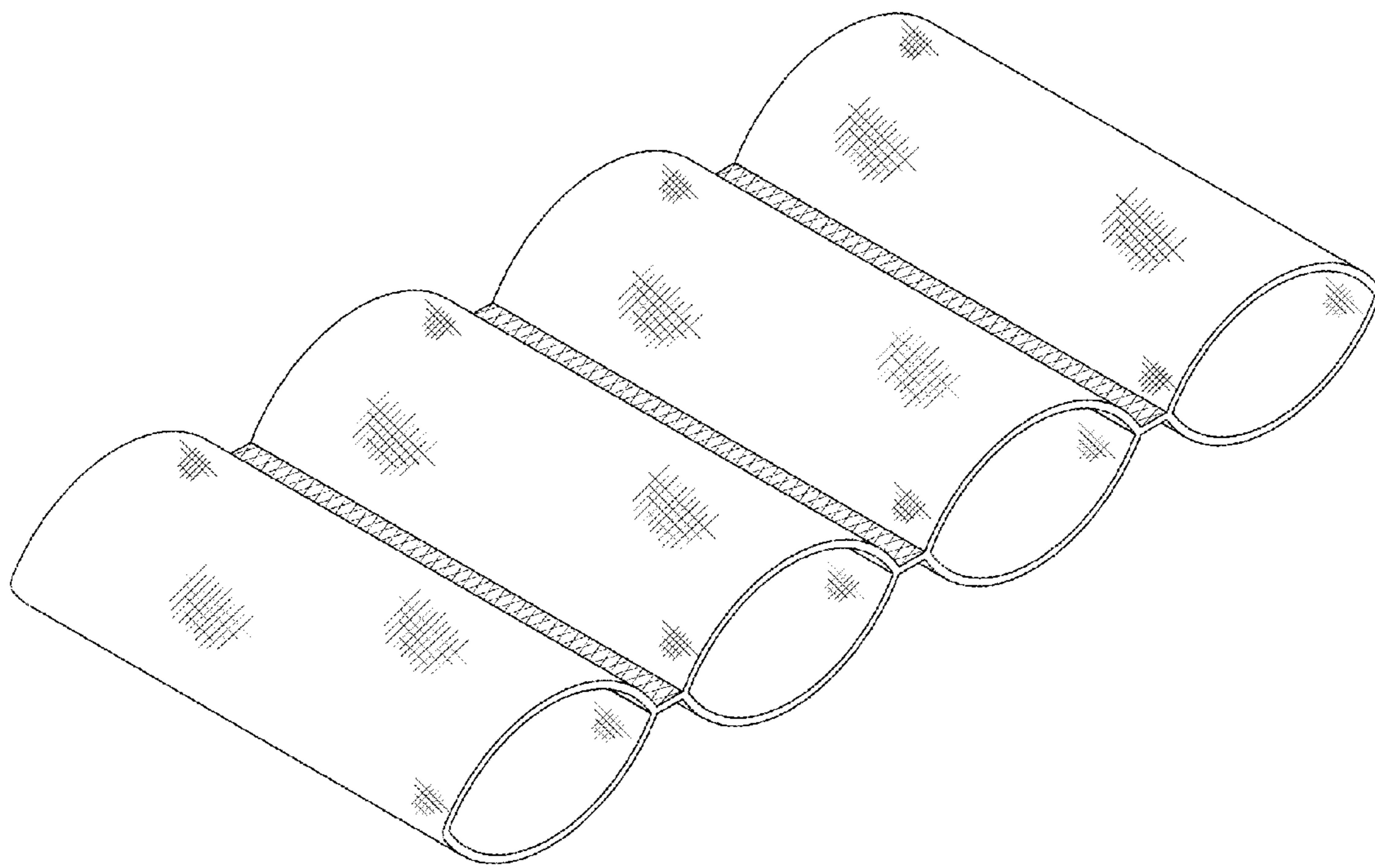

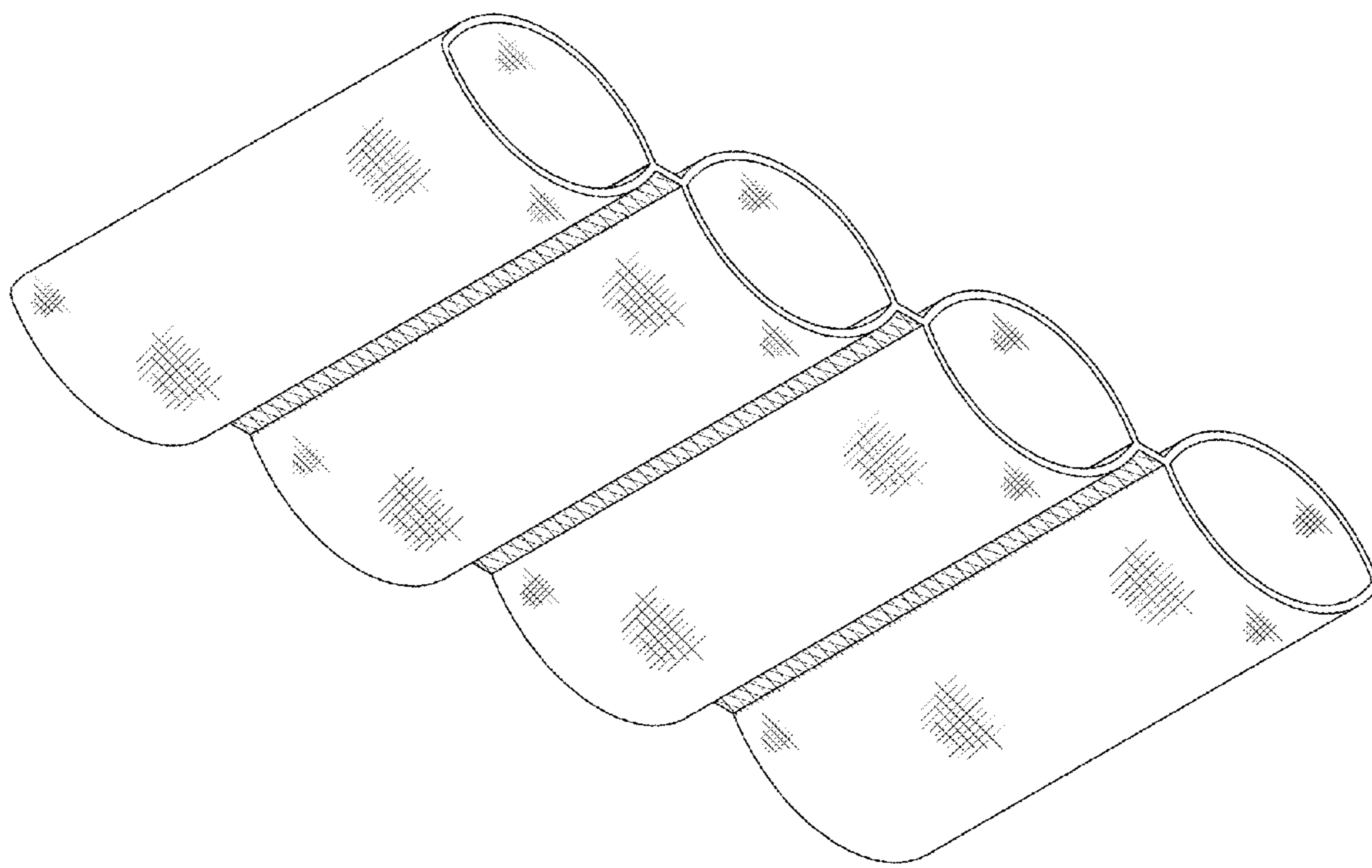
