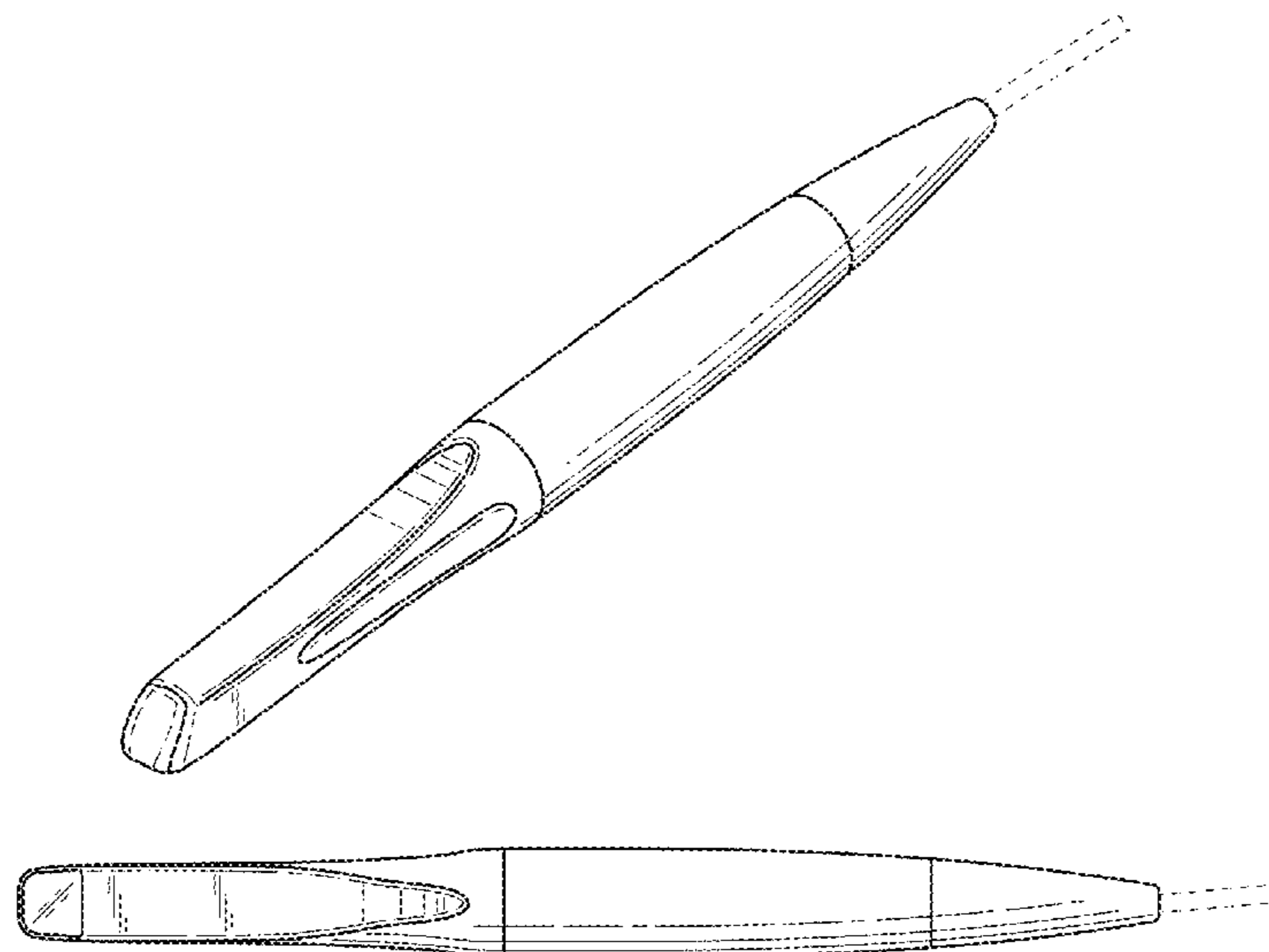
(57) **CLAIM**

The ornamental design for an intra-oral scanning wand, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the new design for an intra-oral
scanning wand containing an optical sensor for electronically
obtaining intra-oral digital images;
FIG. 2 is a right side view thereof, the left side view being a
mirror image of the right side view shown;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a front view thereof; and,
FIG. 6 is a rear view thereof.
Broken lines are used to show an electrical connection that
forms no part of the claimed design.

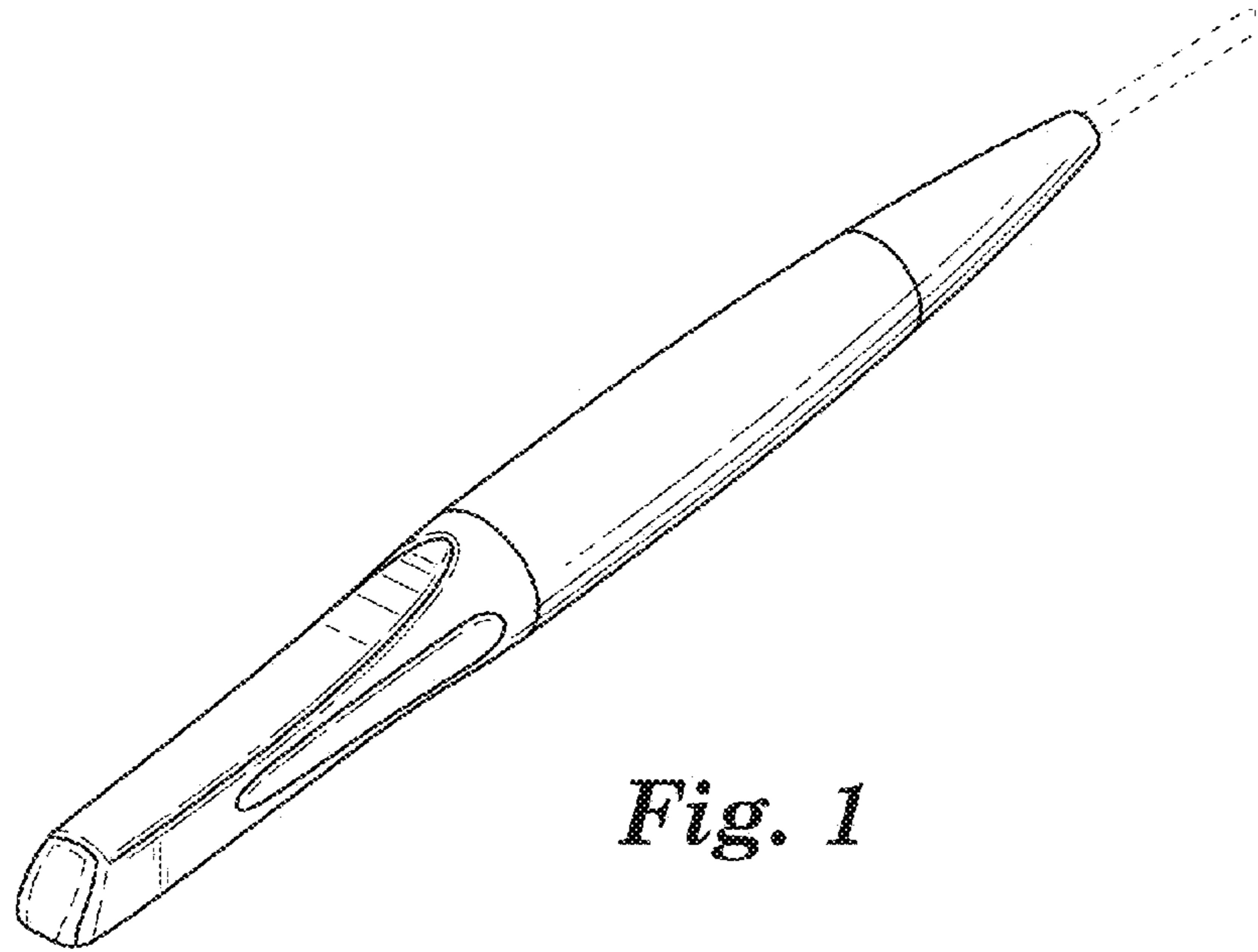

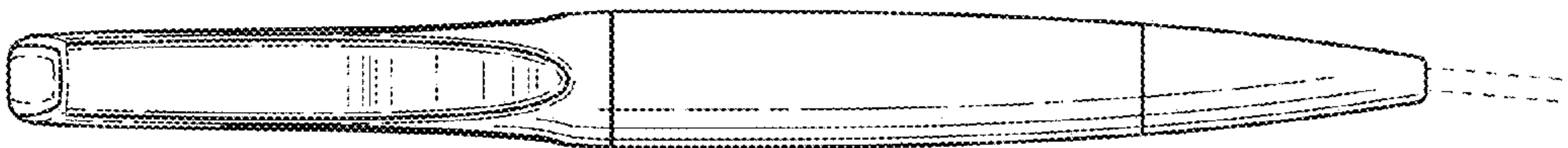

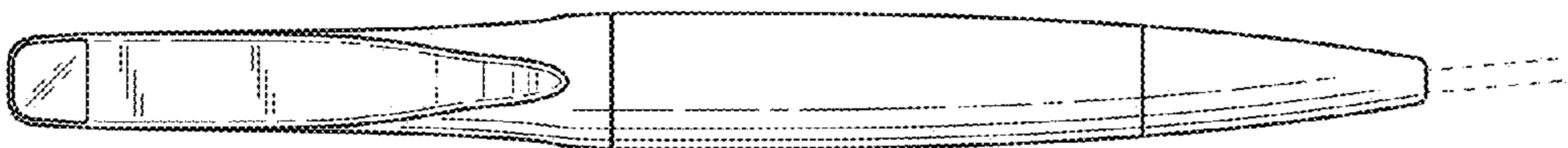

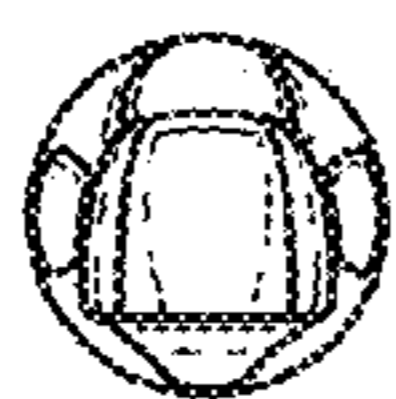
