FIG. 4 is a rear view of the design of FIG. 1;

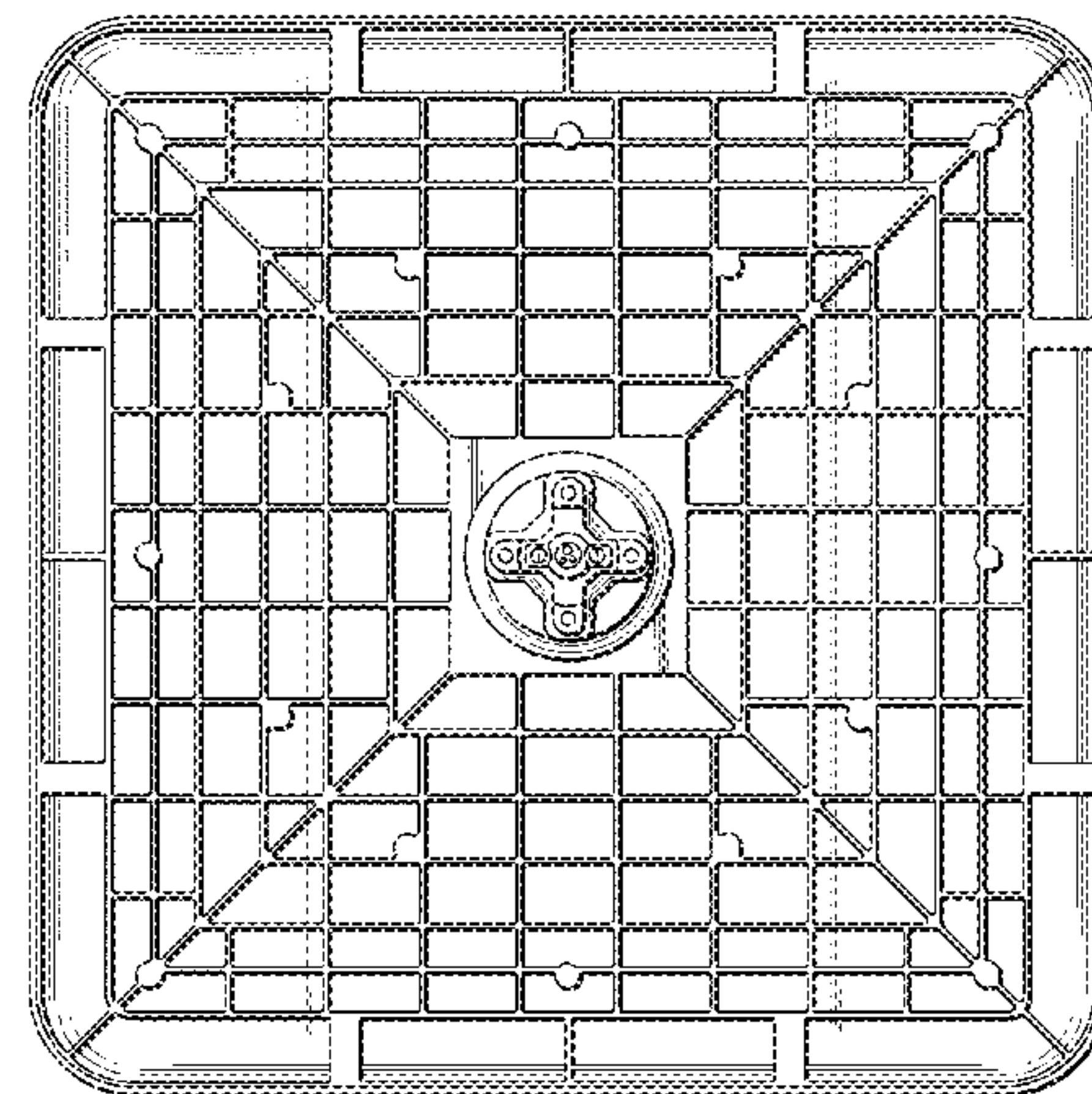
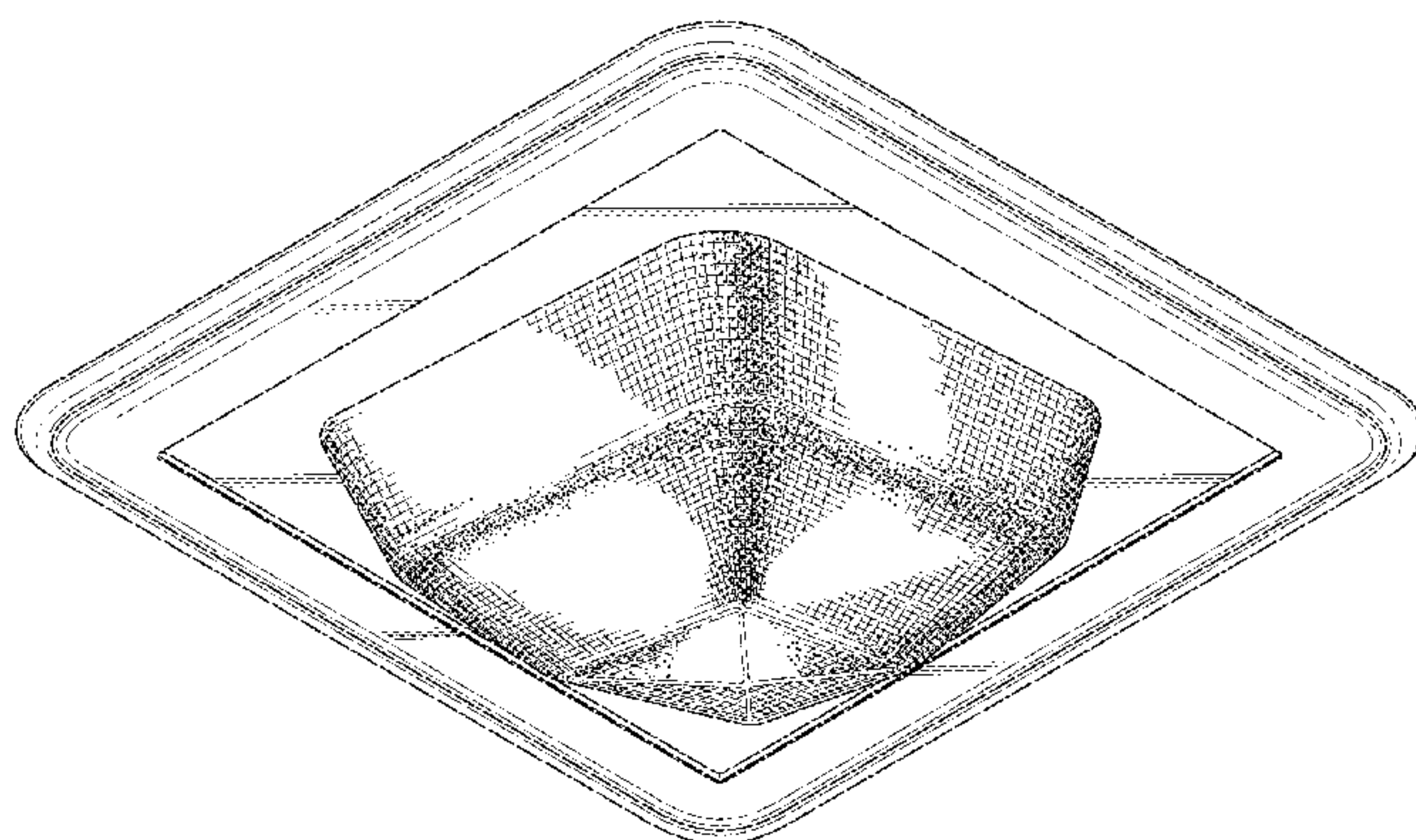
FIG. 5 is a left-side view of the design of FIG. 1;

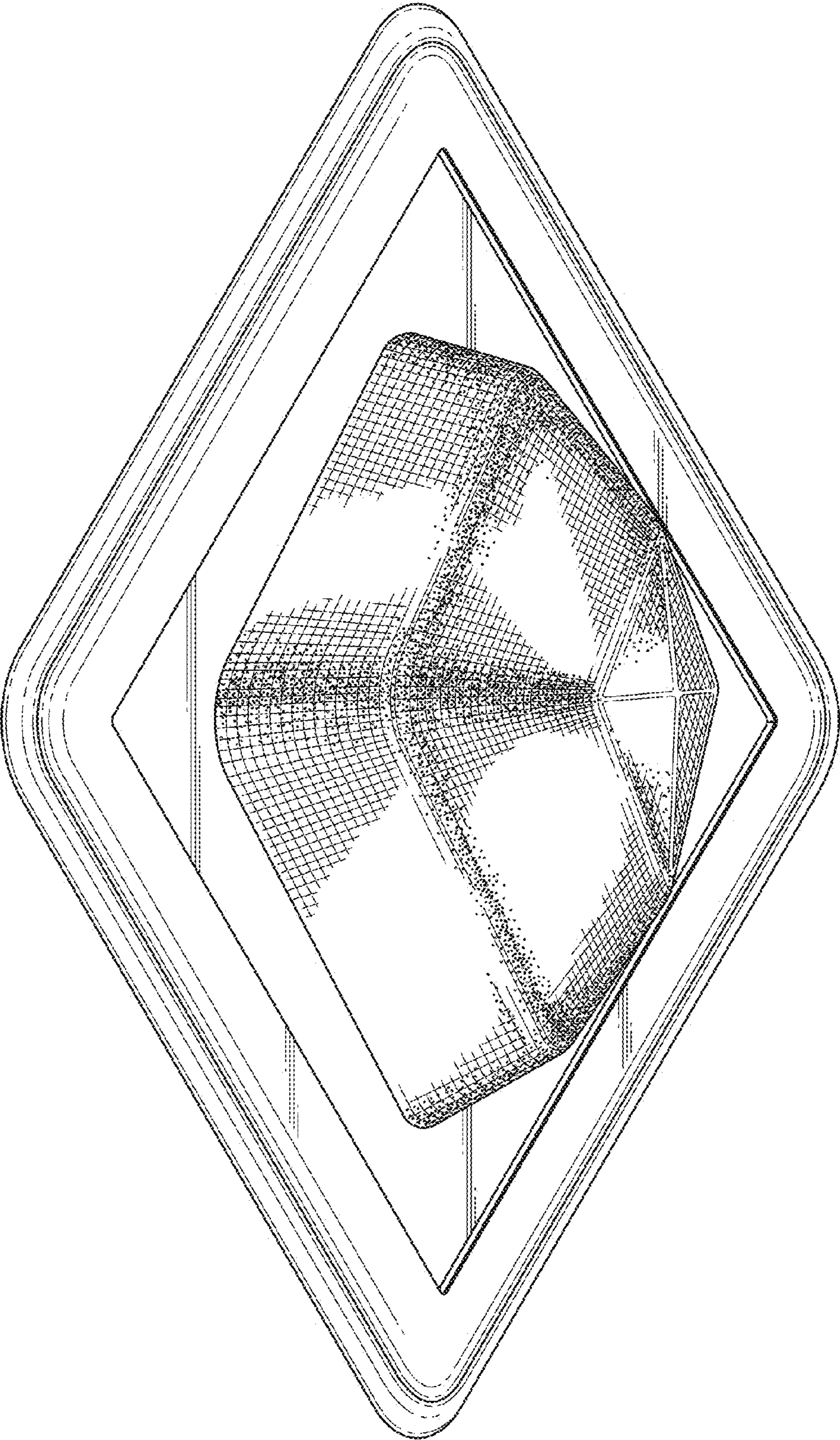

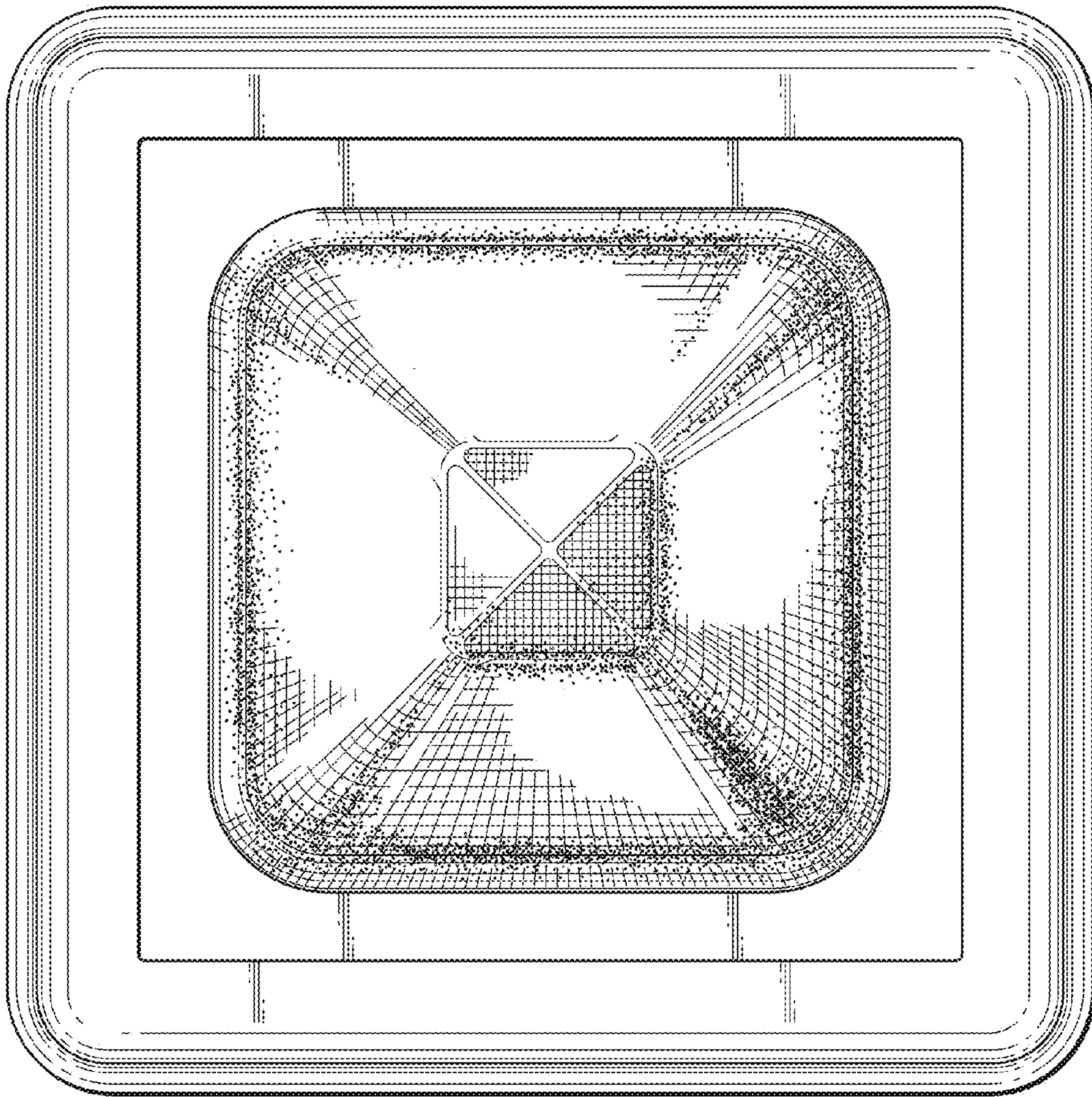

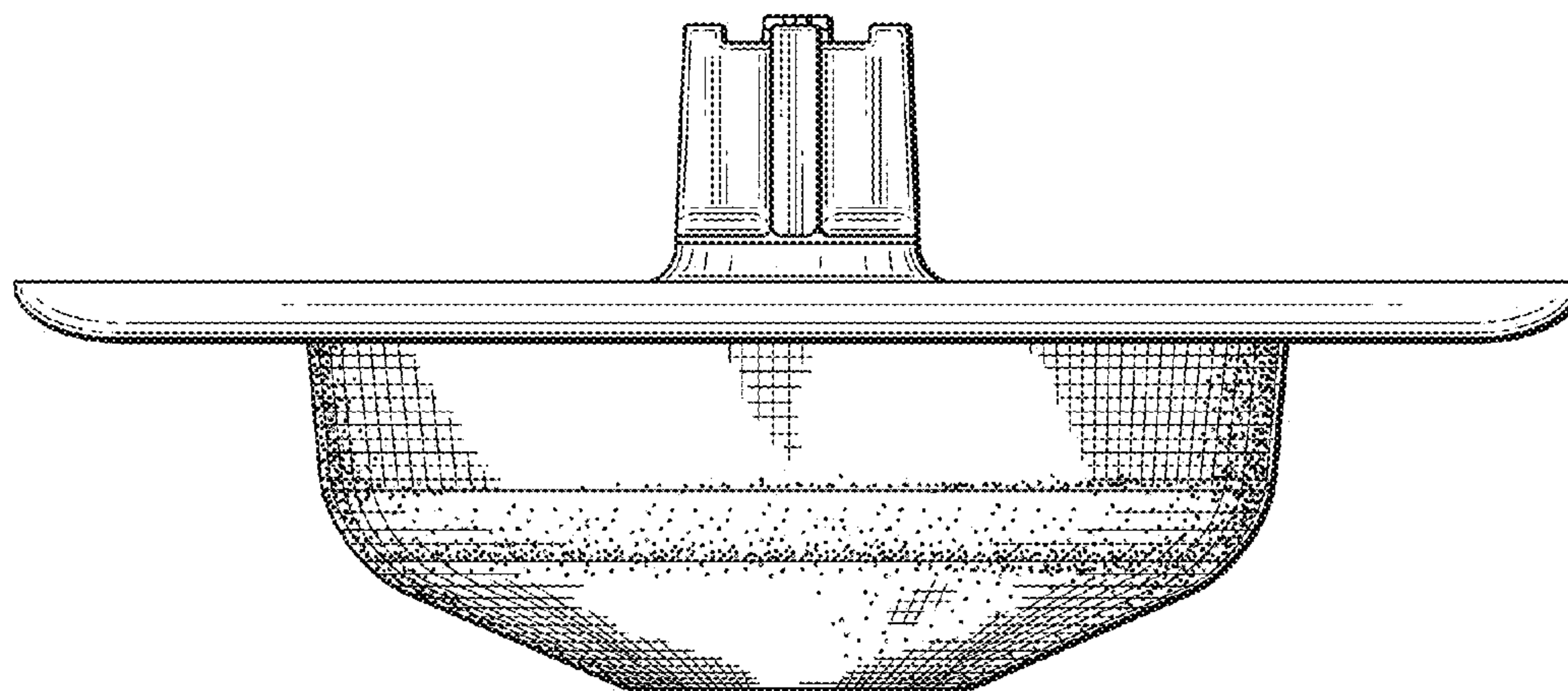

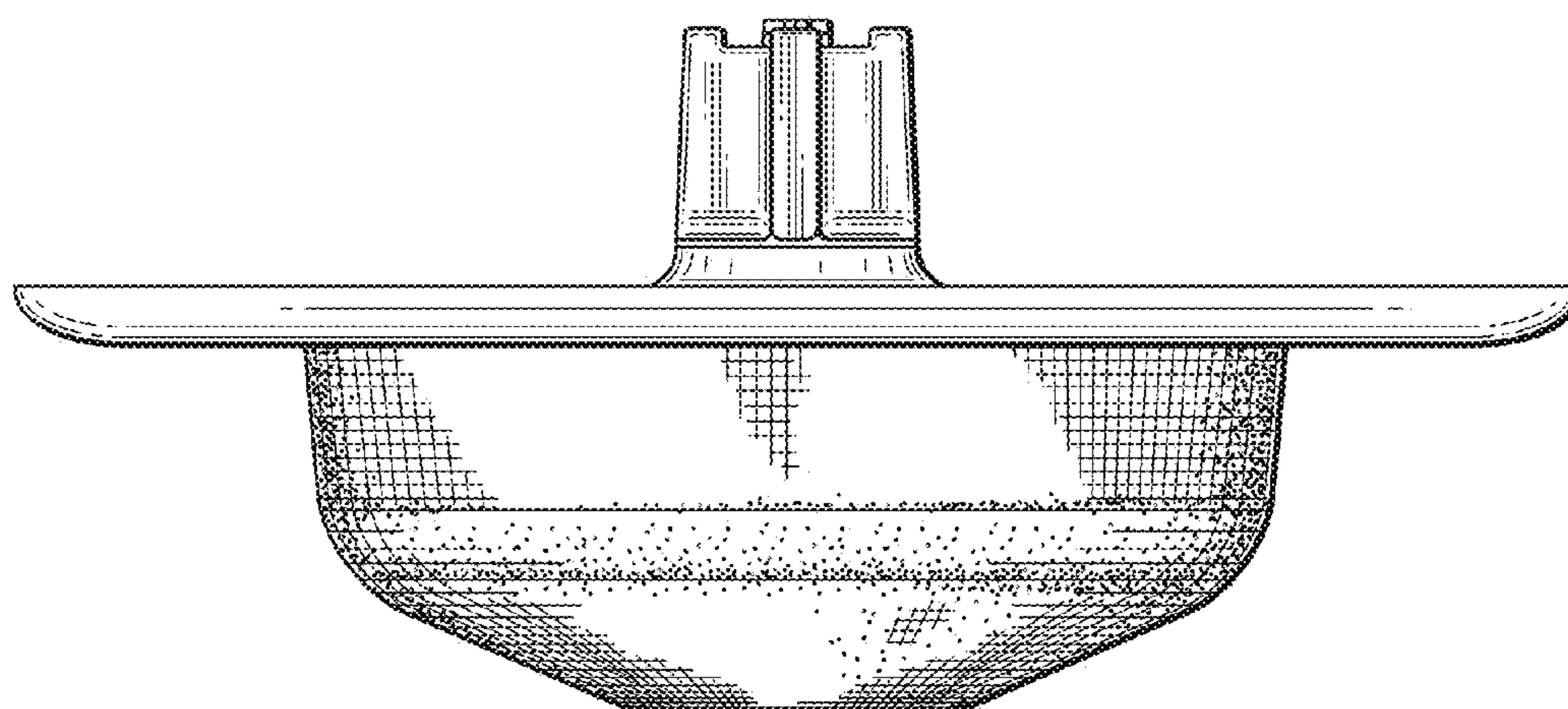

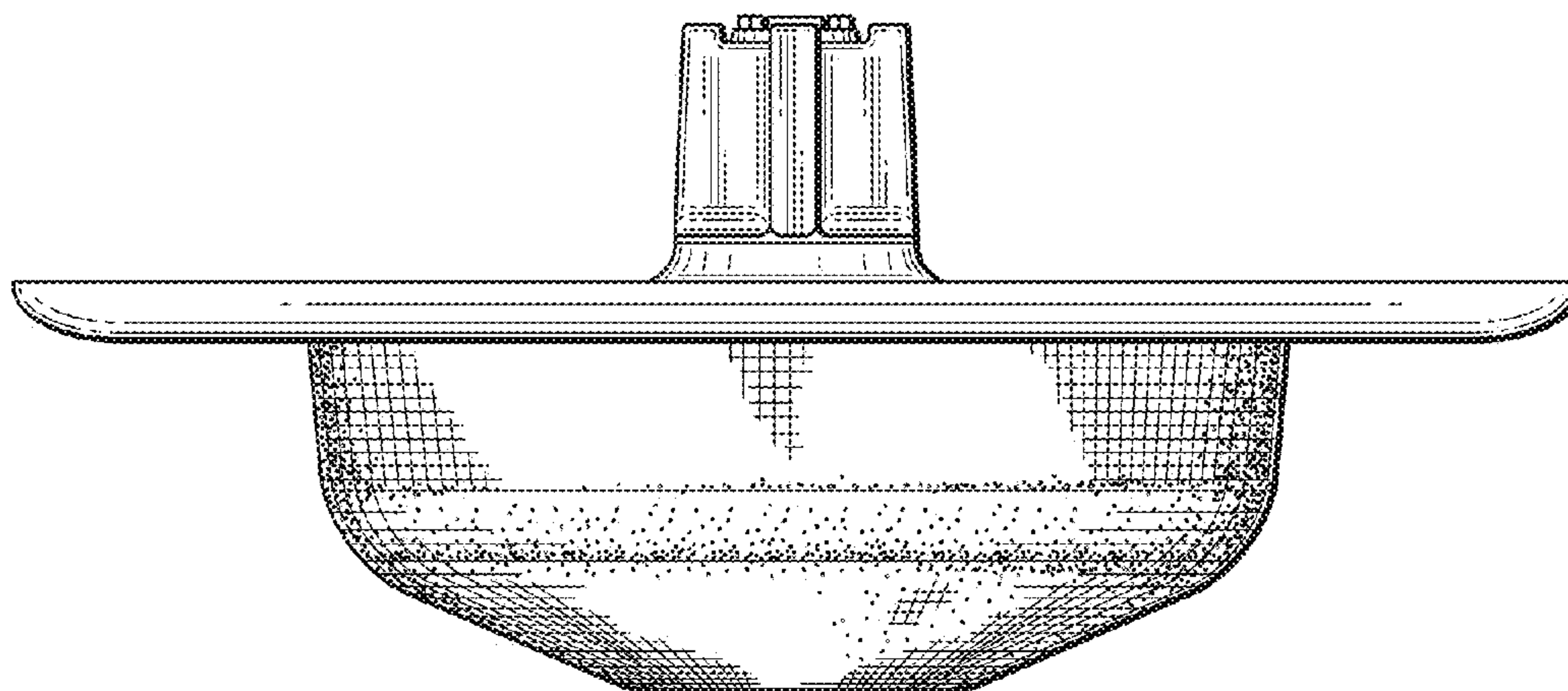

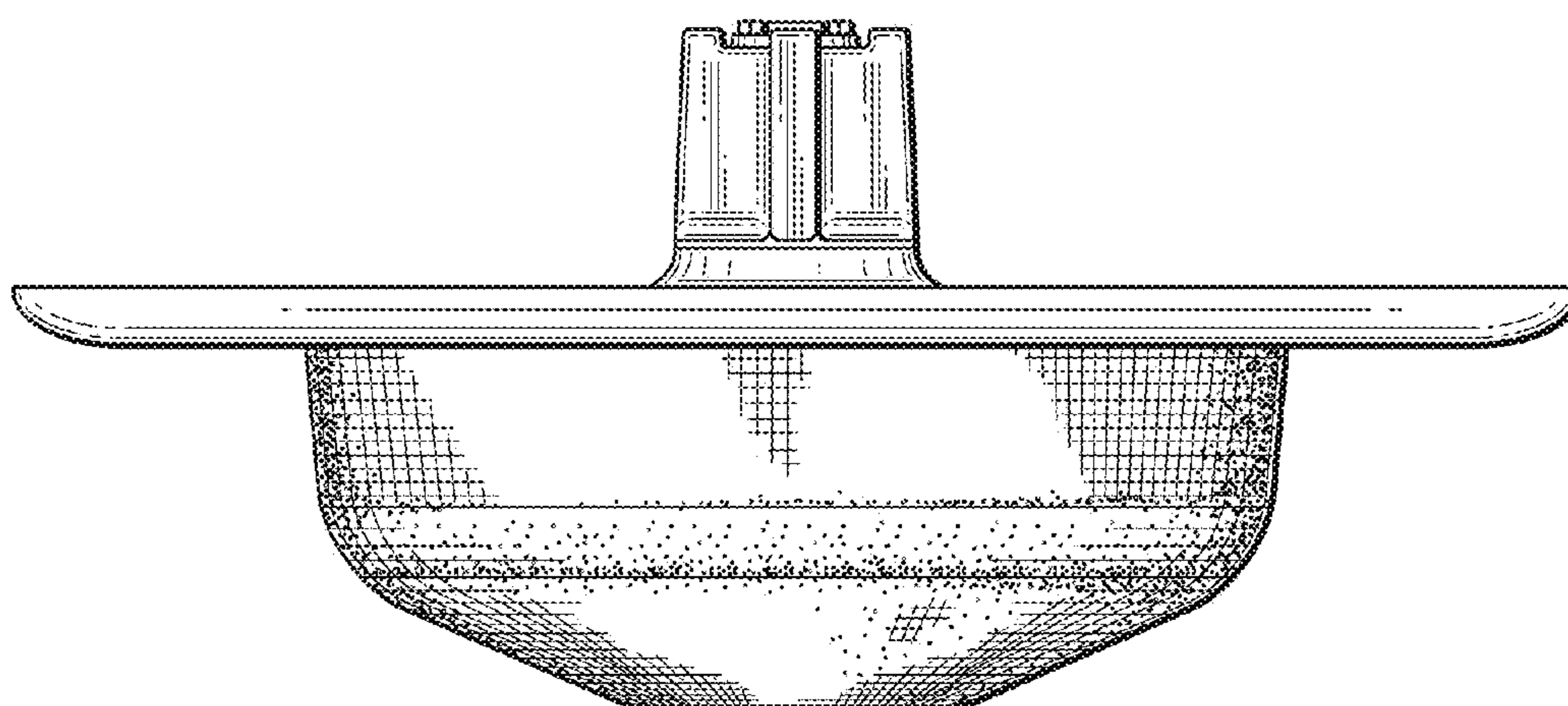

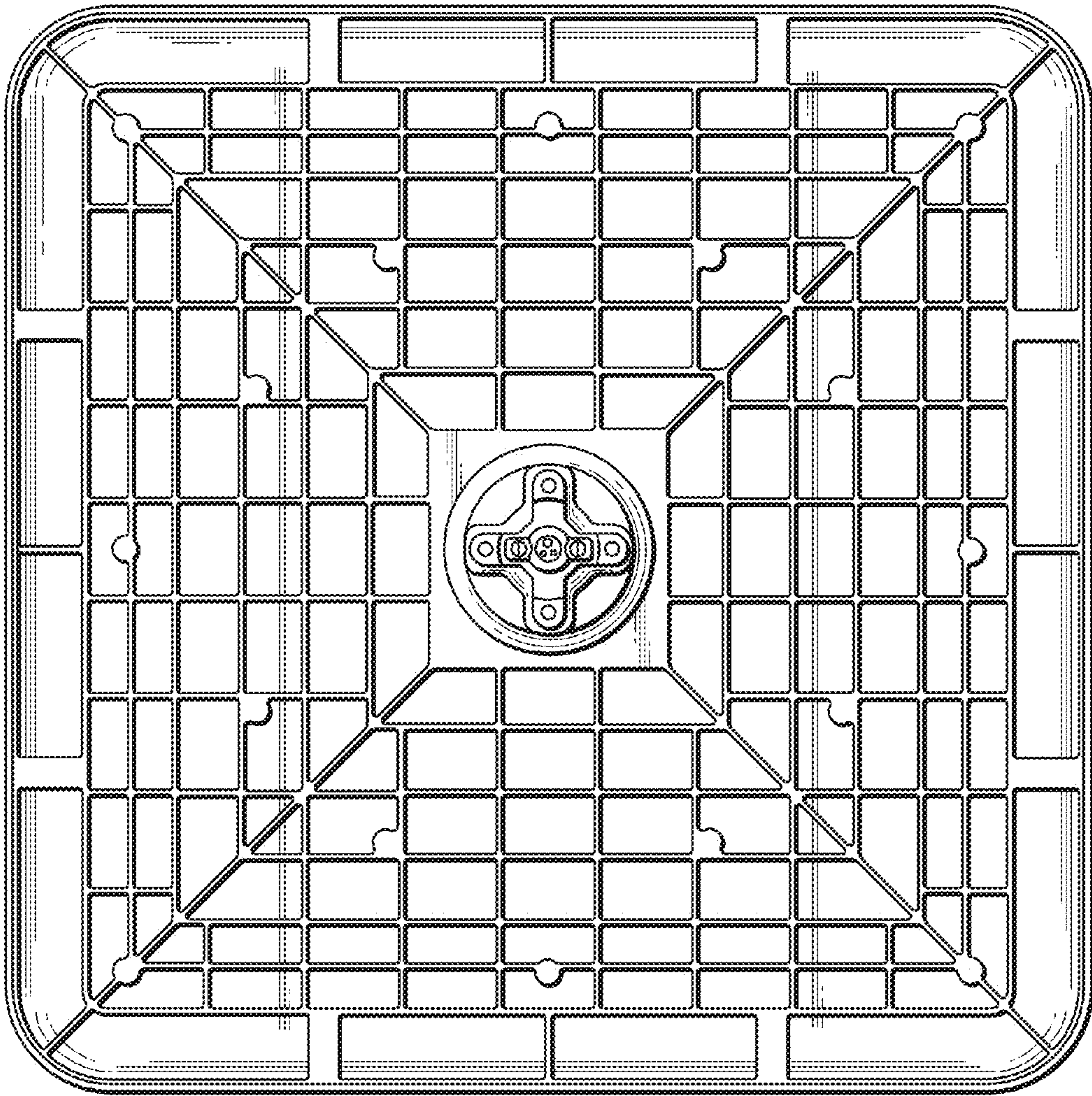
