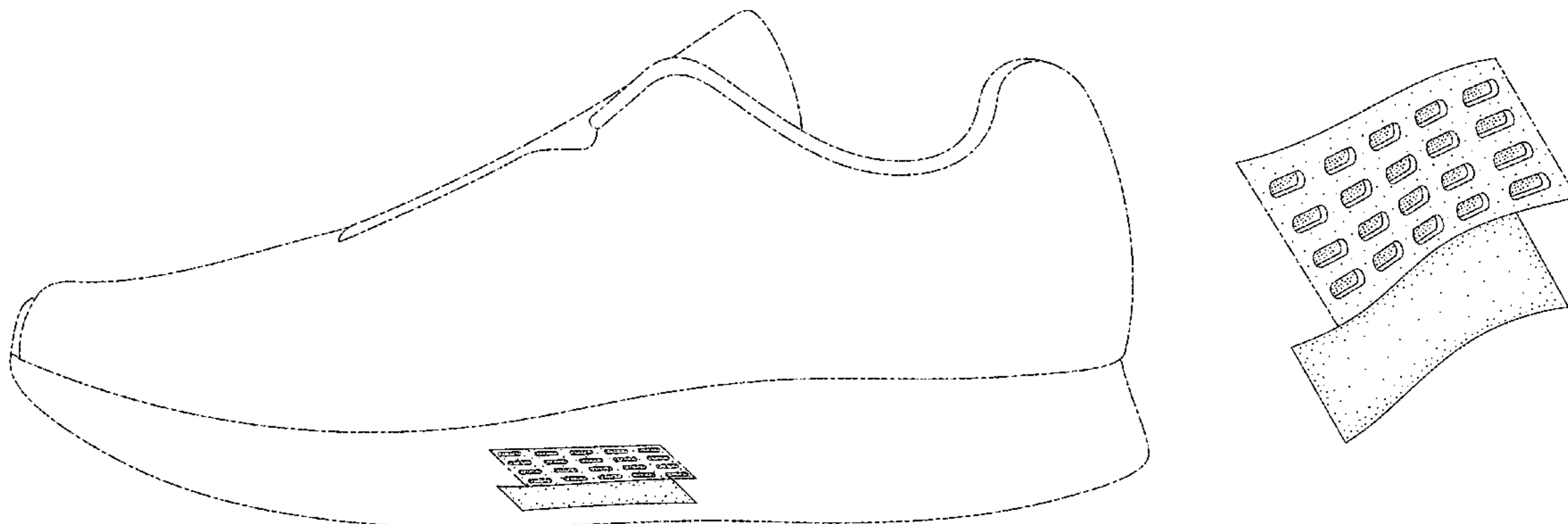
(57) **CLAIM**
The ornamental design for a shoe midsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe midsole showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof; and,
FIG. 4 is a second front perspective view thereof, enlarged and shown with unclaimed subject matter omitted.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions adjacent to the shaded area form no part of the claimed design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

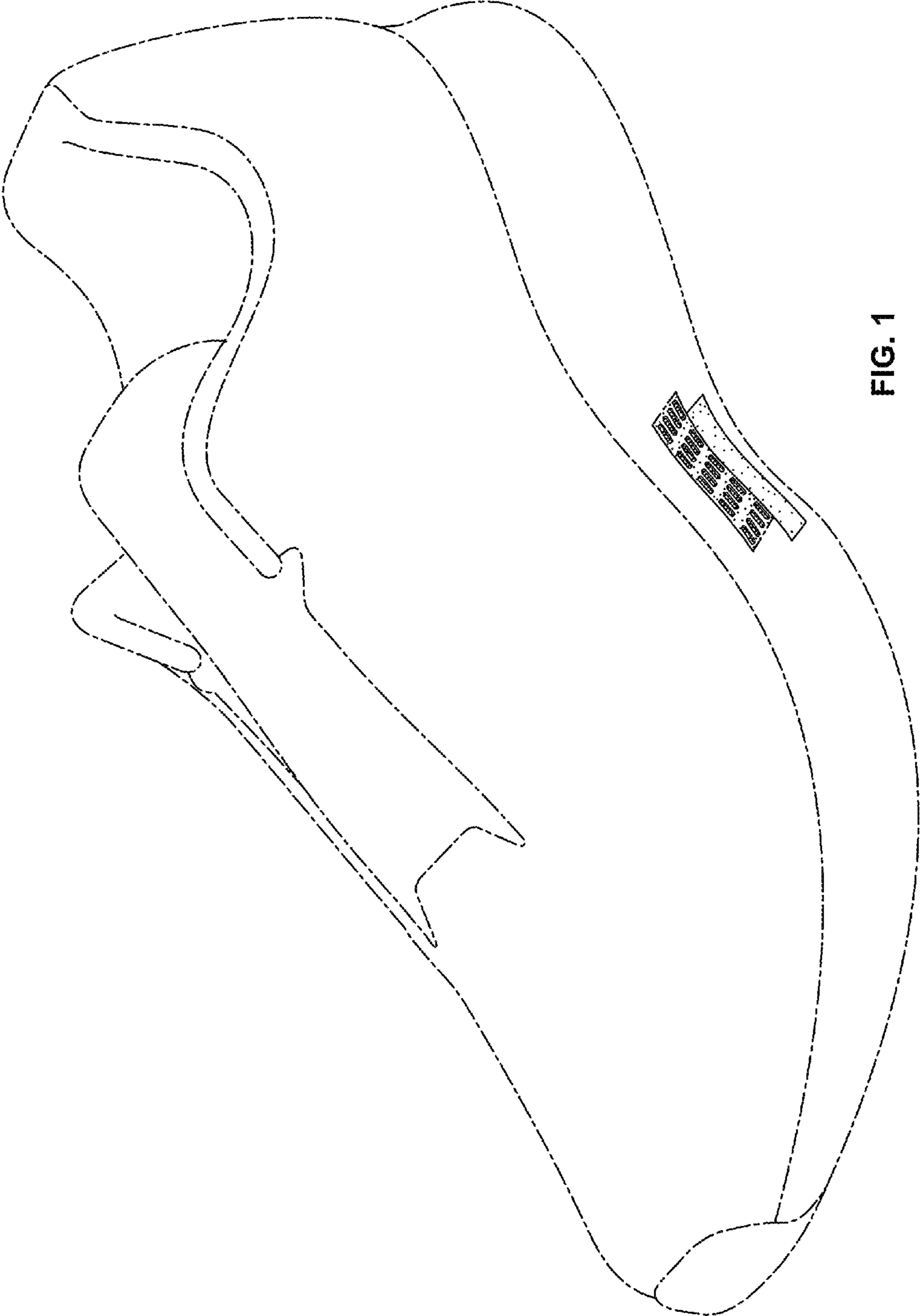

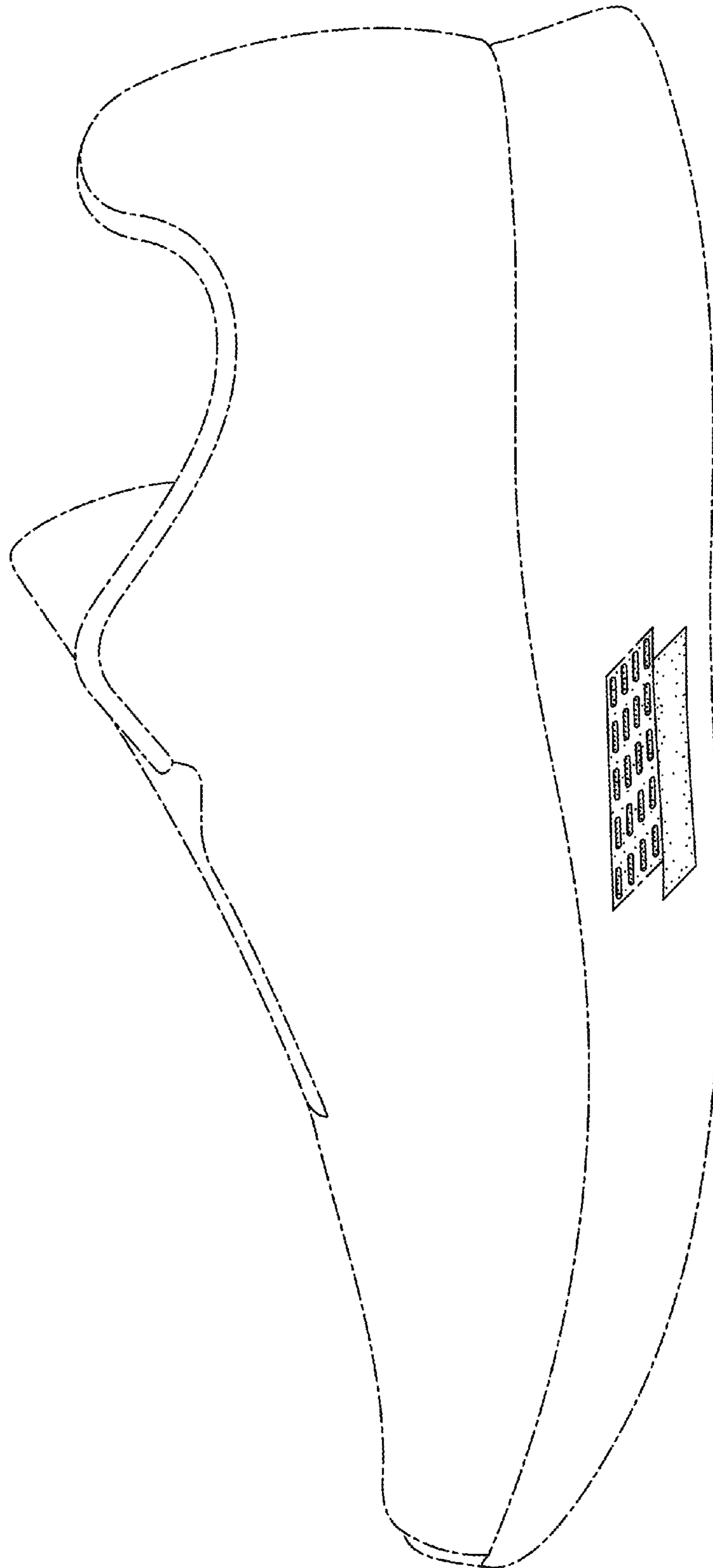

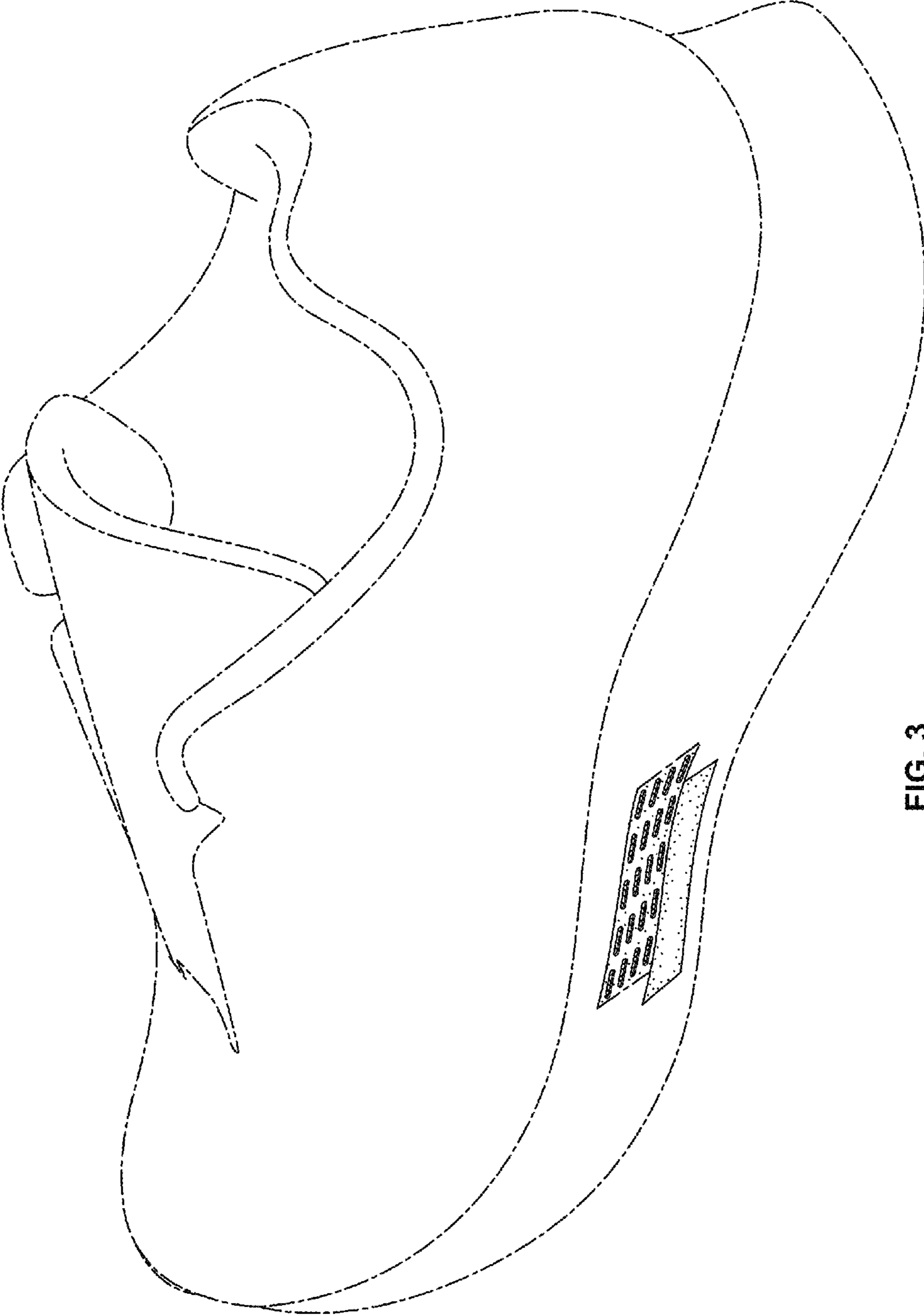

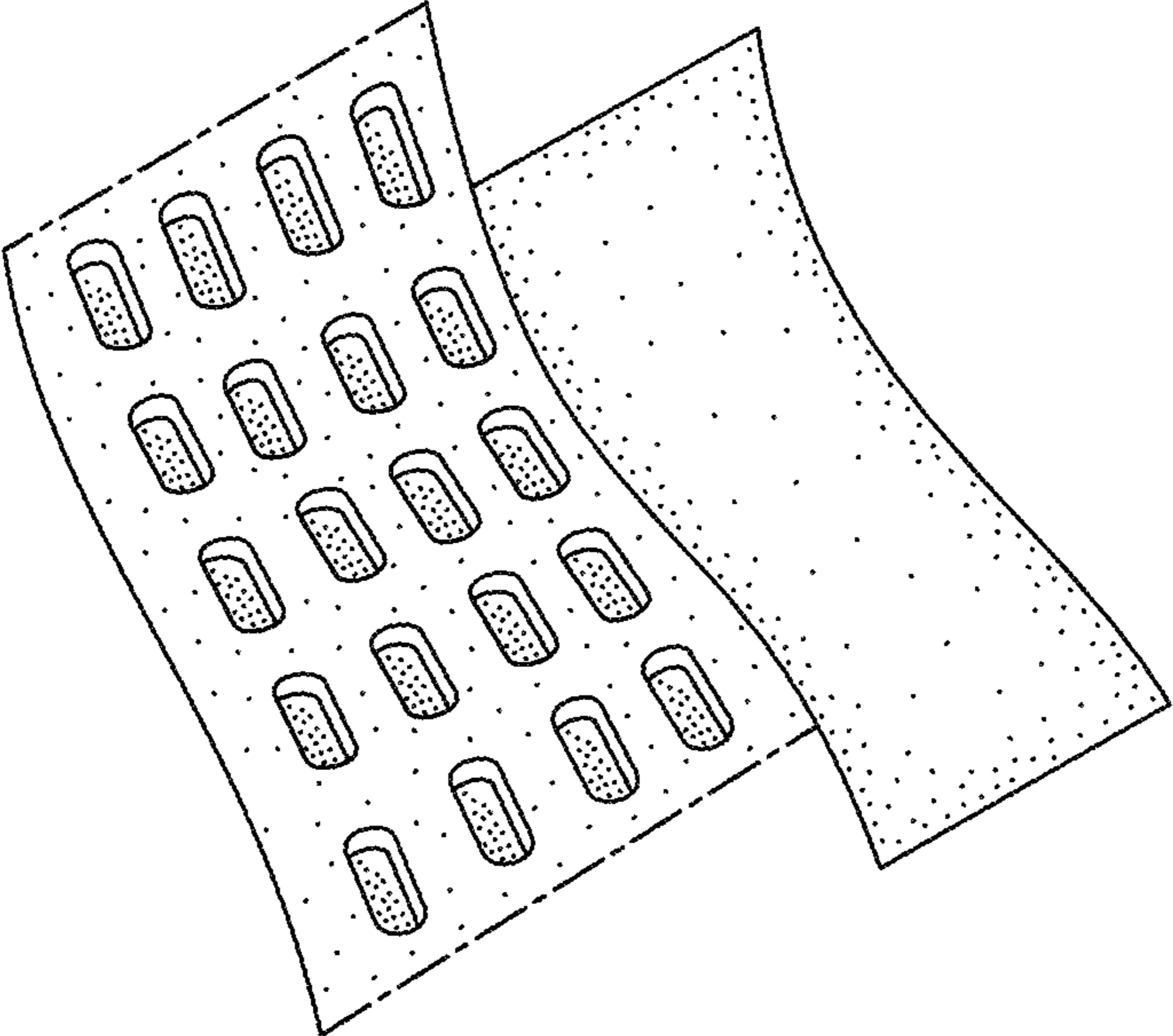
