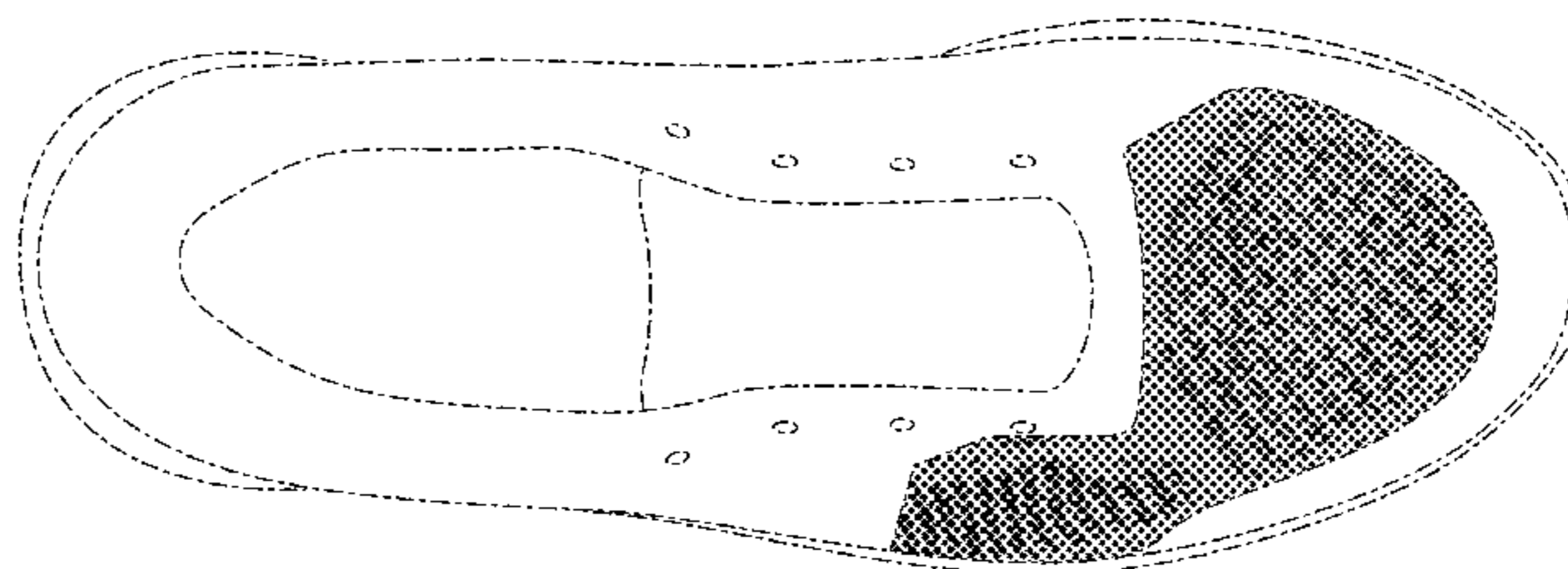
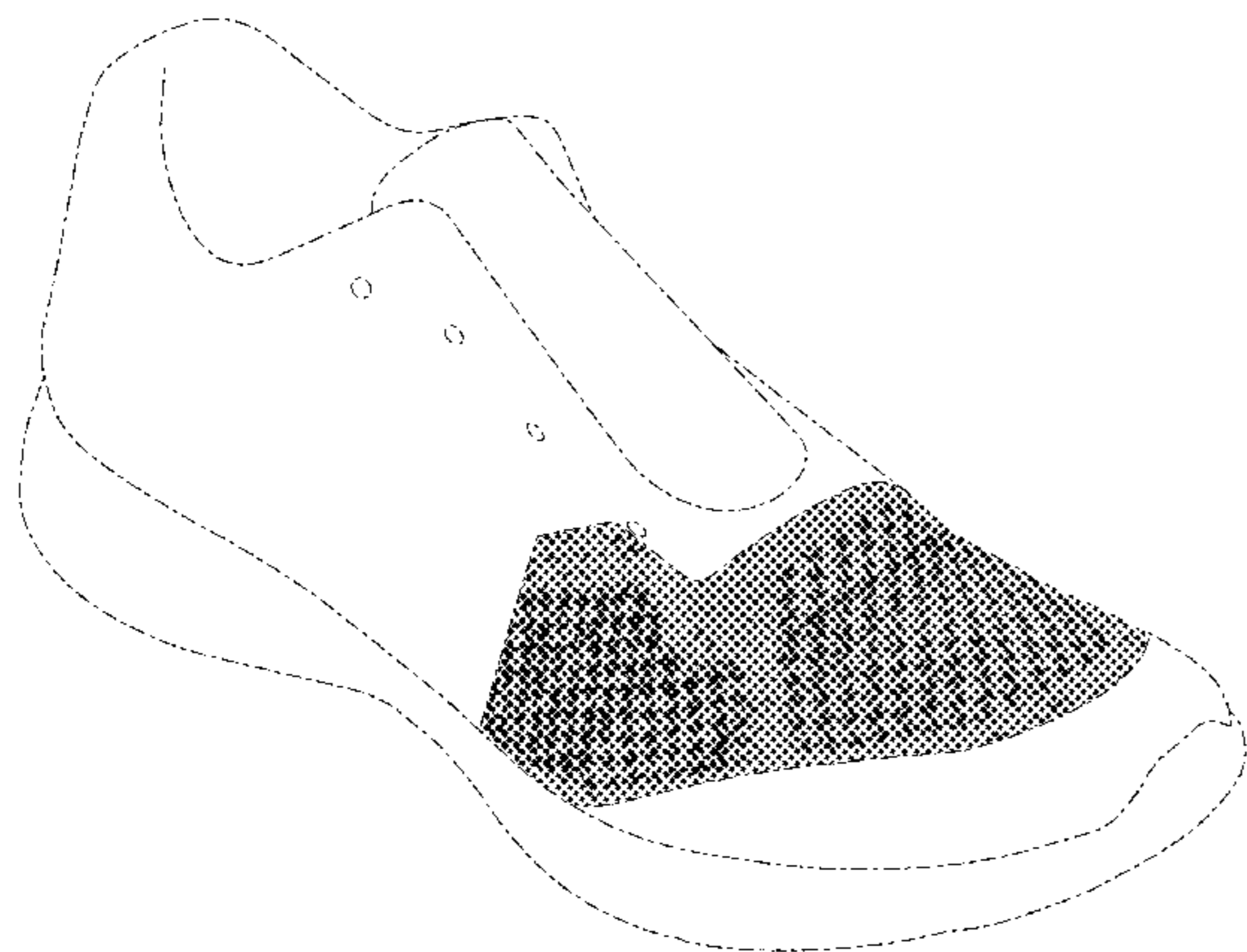
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
 FIG. 2 is a lateral side view thereof; and
 FIG. 3 is a medial perspective view thereof; and,
 FIG. 4 is a top view thereof.

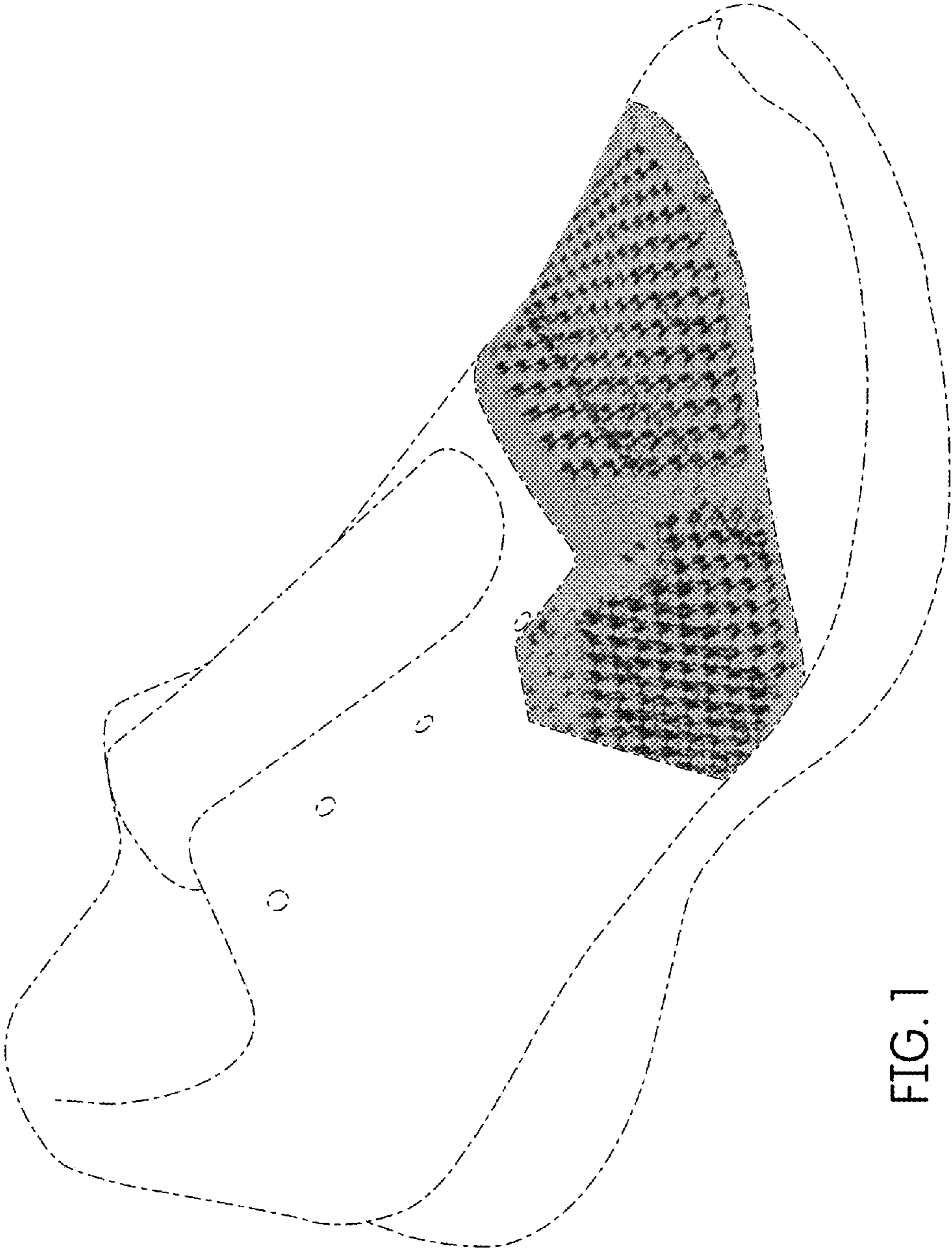

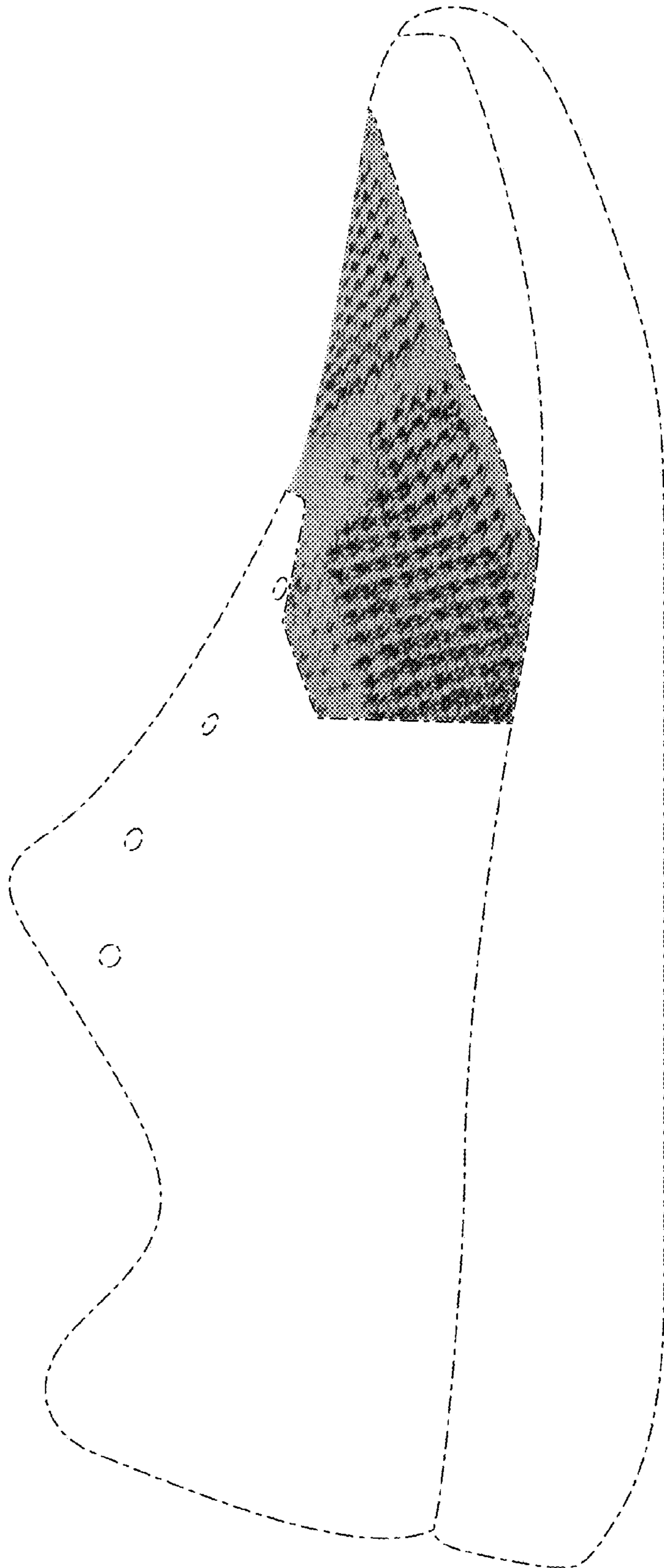

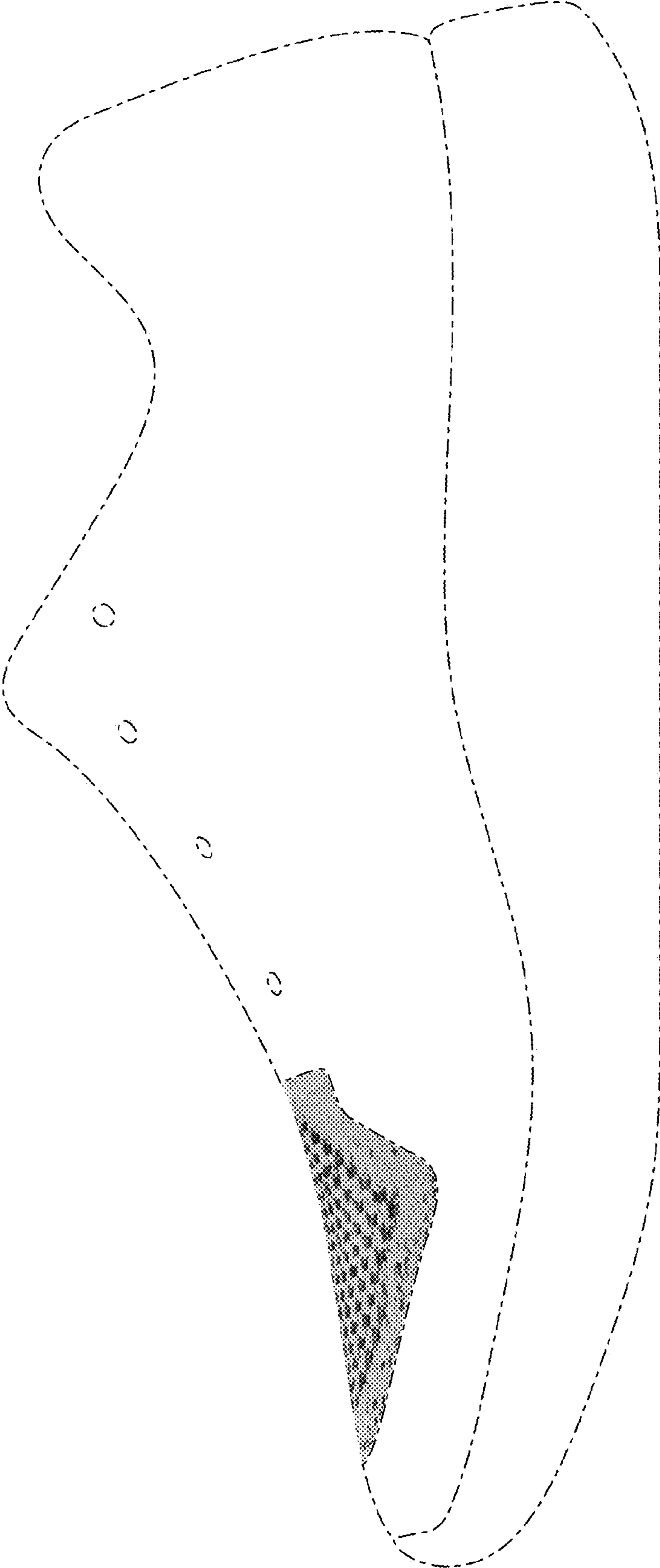

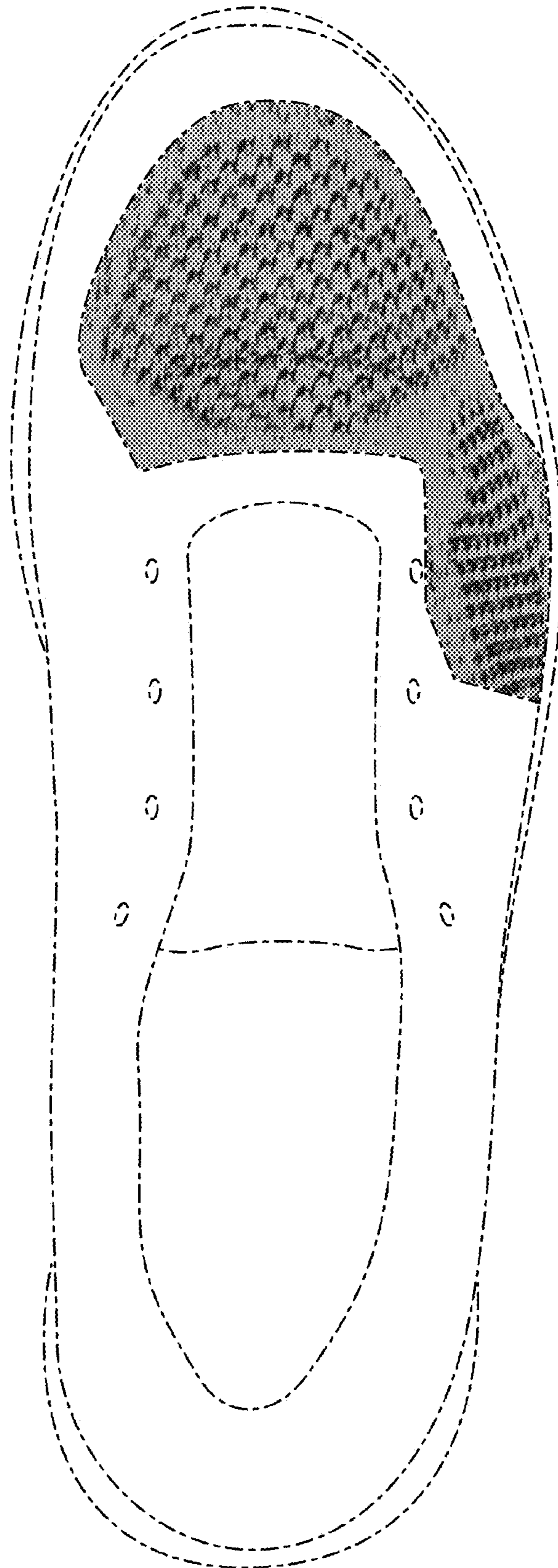
