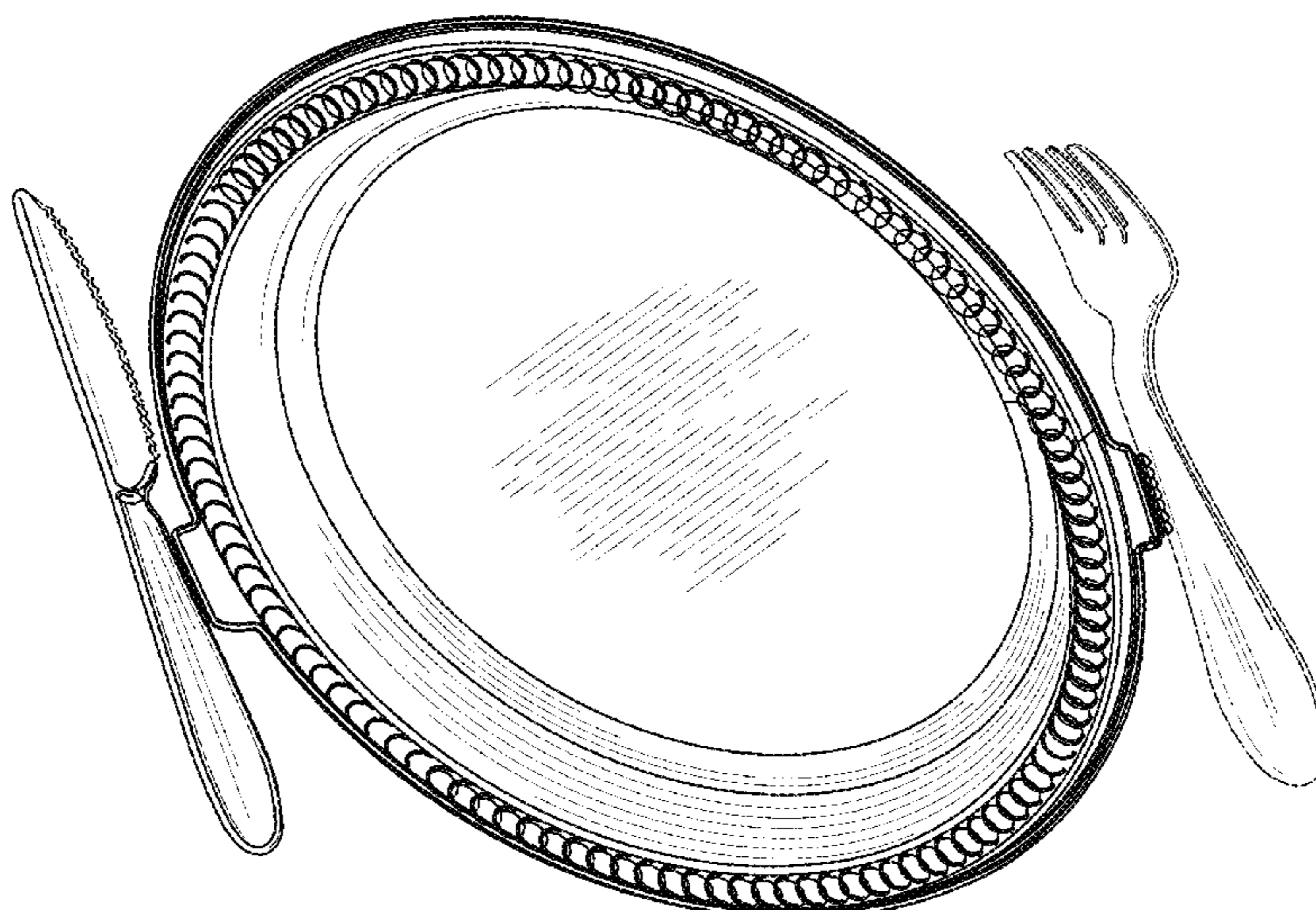
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a combination plate and utensils, showing our new design;

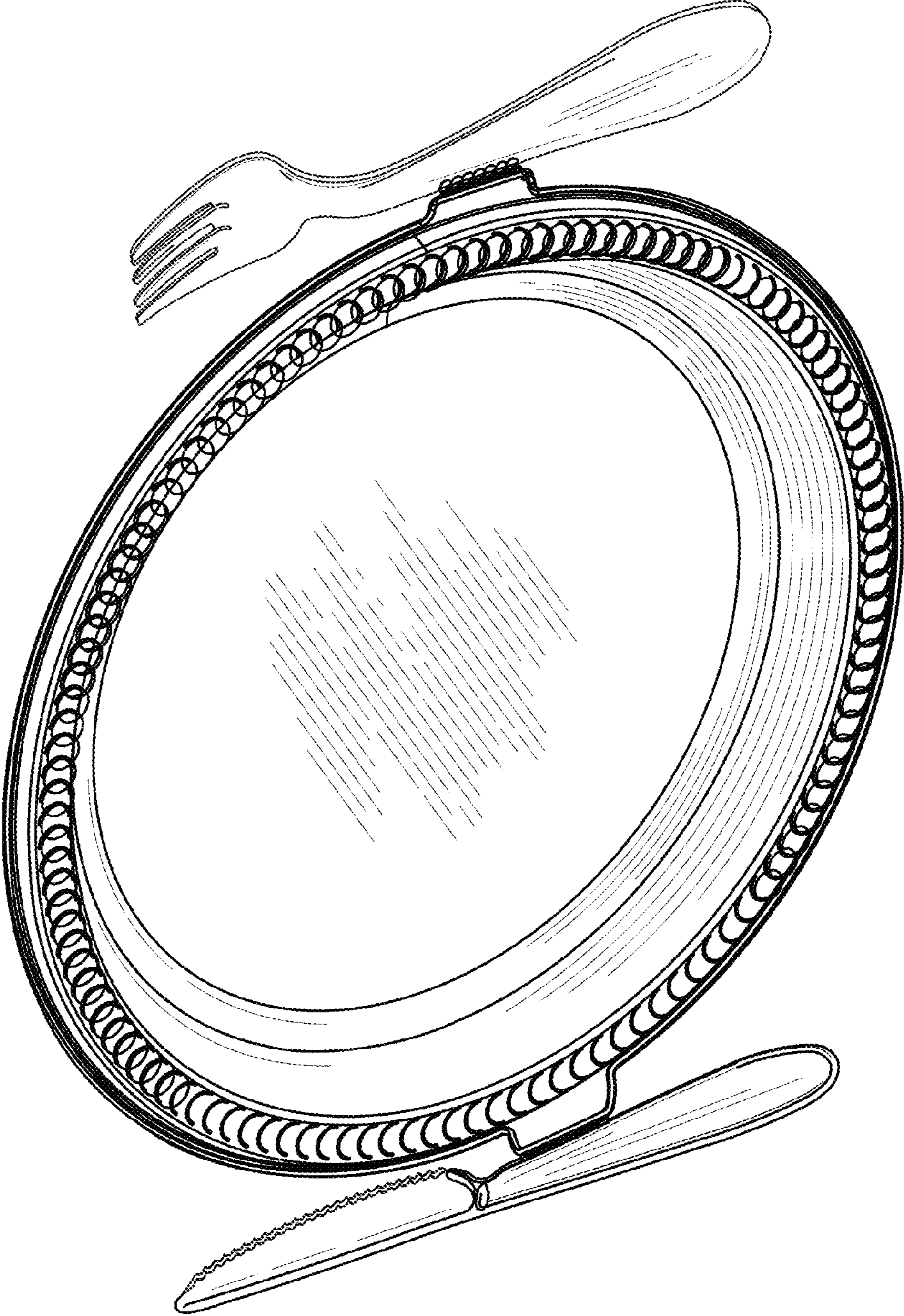

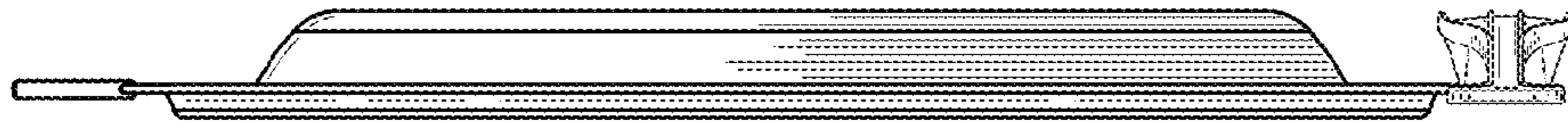

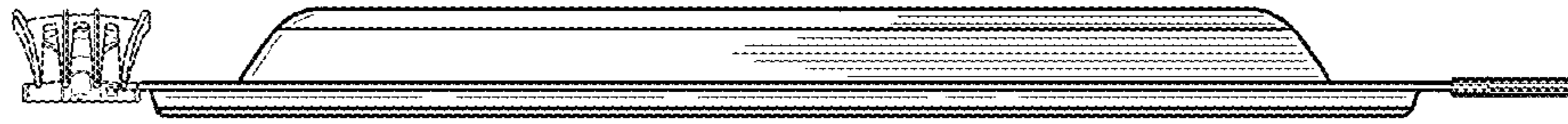

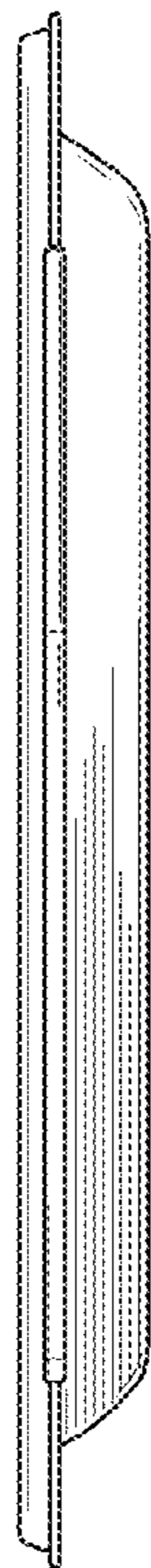

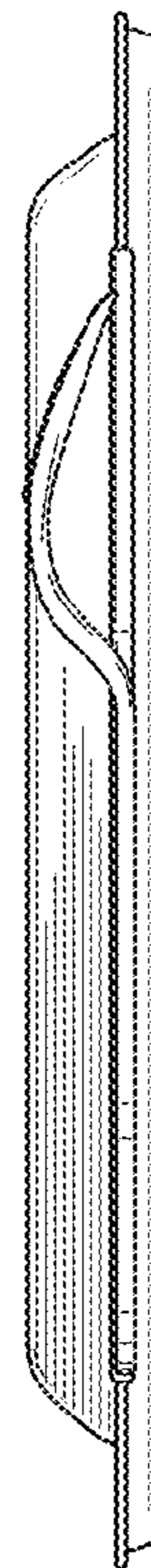

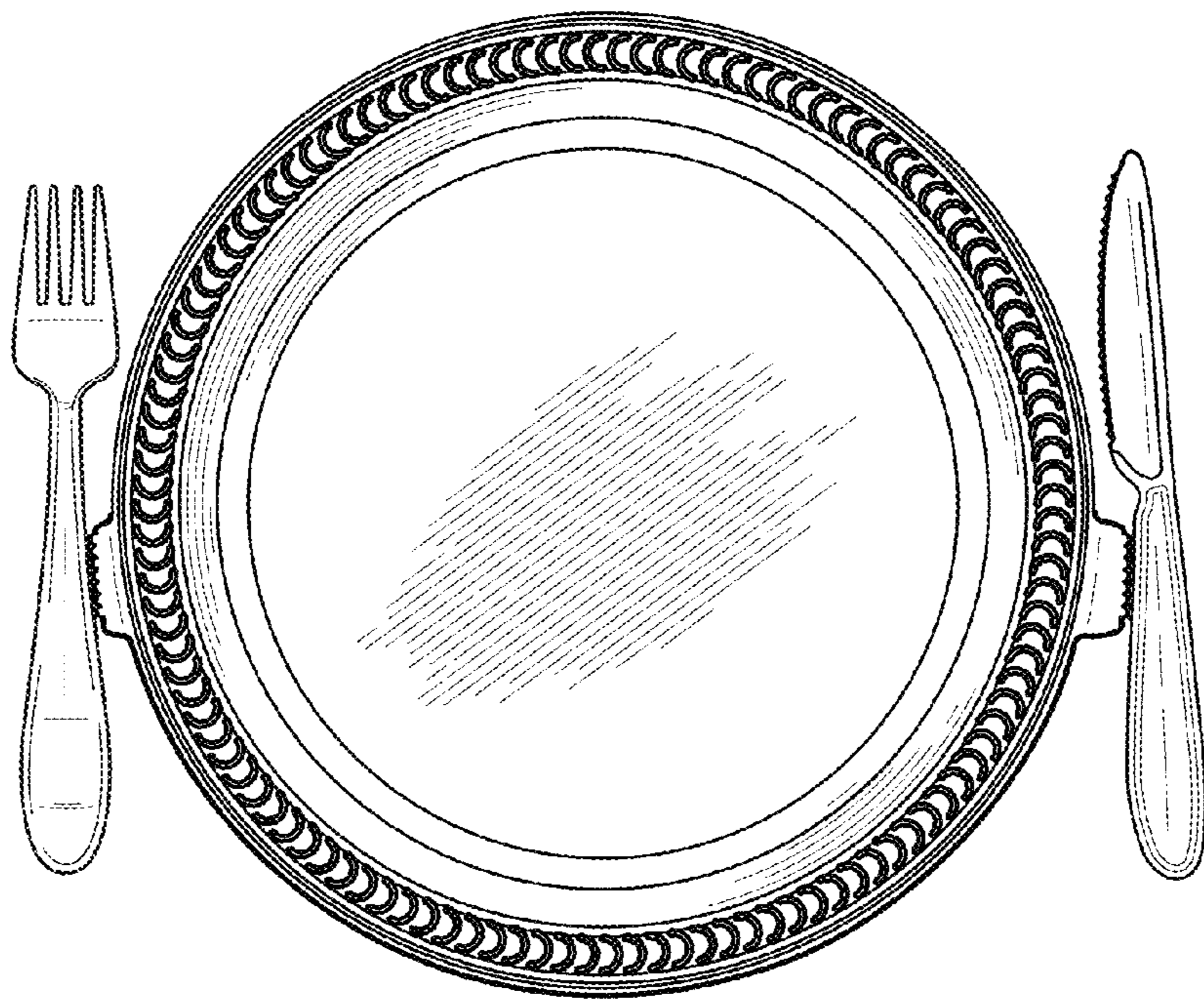

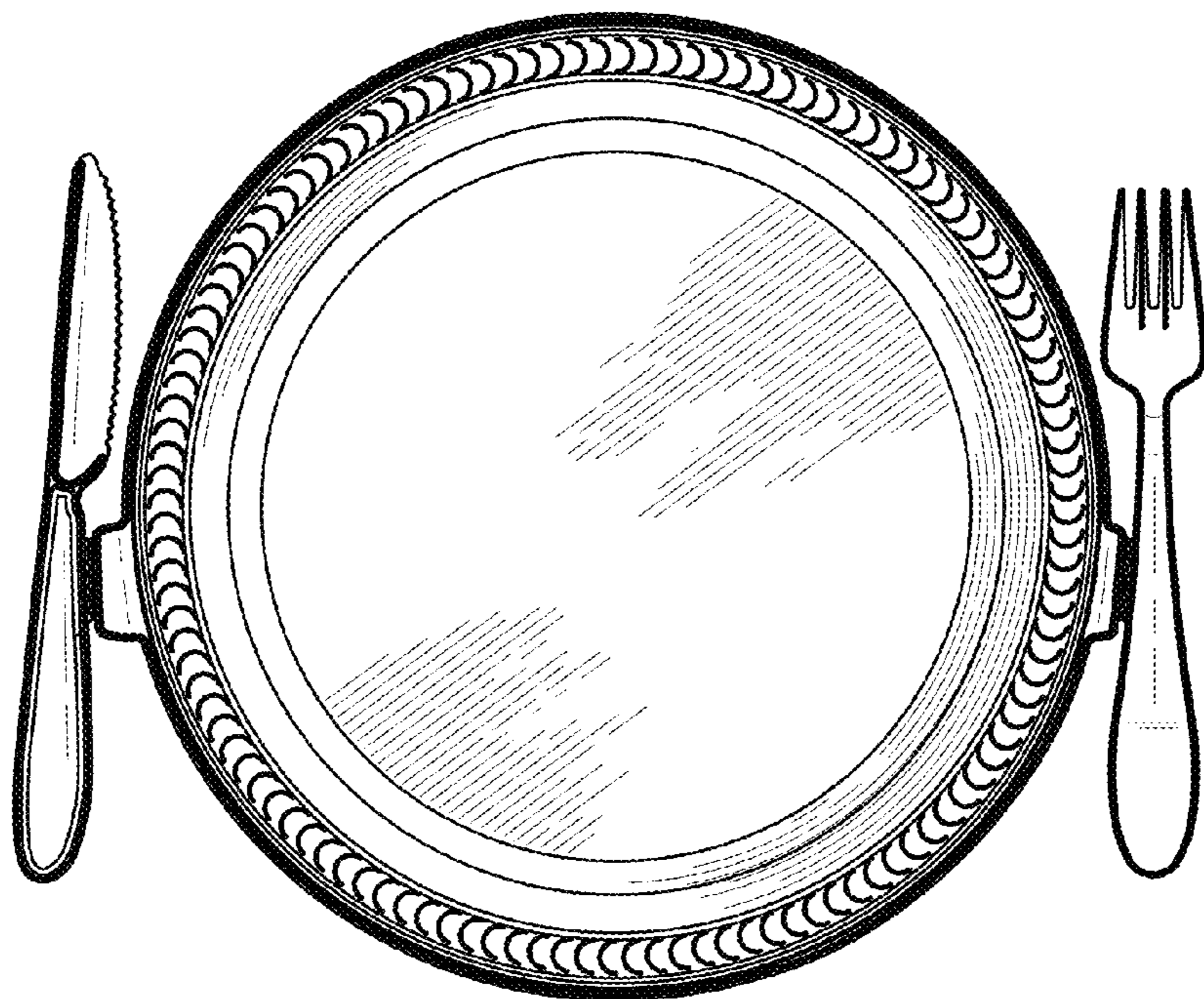
