(57) **CLAIM**

The ornamental design for a television with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, perspective view of a television with graphical user interface showing our new design; FIG. 2 is a front view thereof; and, FIG. 3 is a front view thereof, shown separately from portions of the television excluded from the claim. The portions of the television and the graphical user interface shown in broken line form no part of the claimed design.

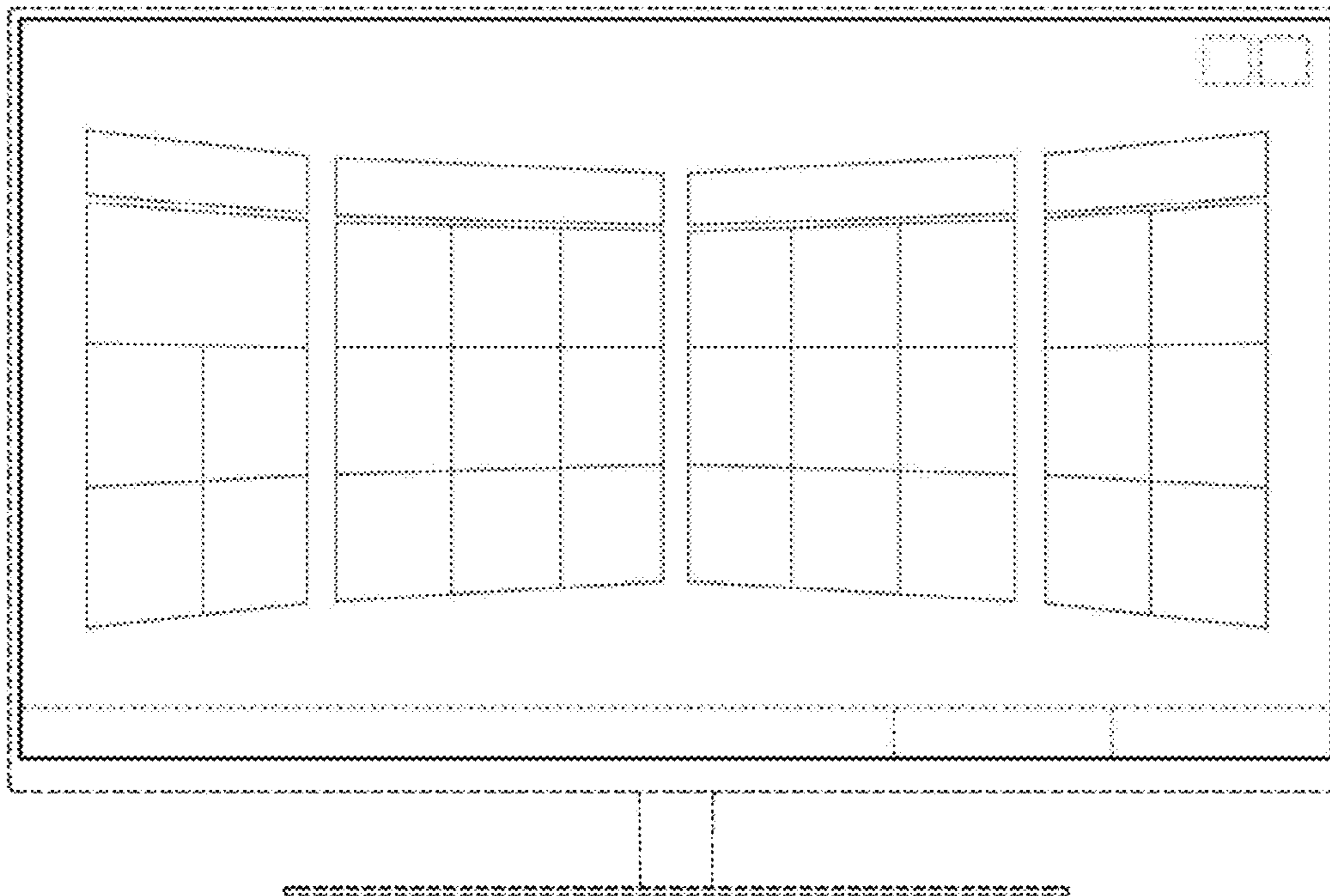

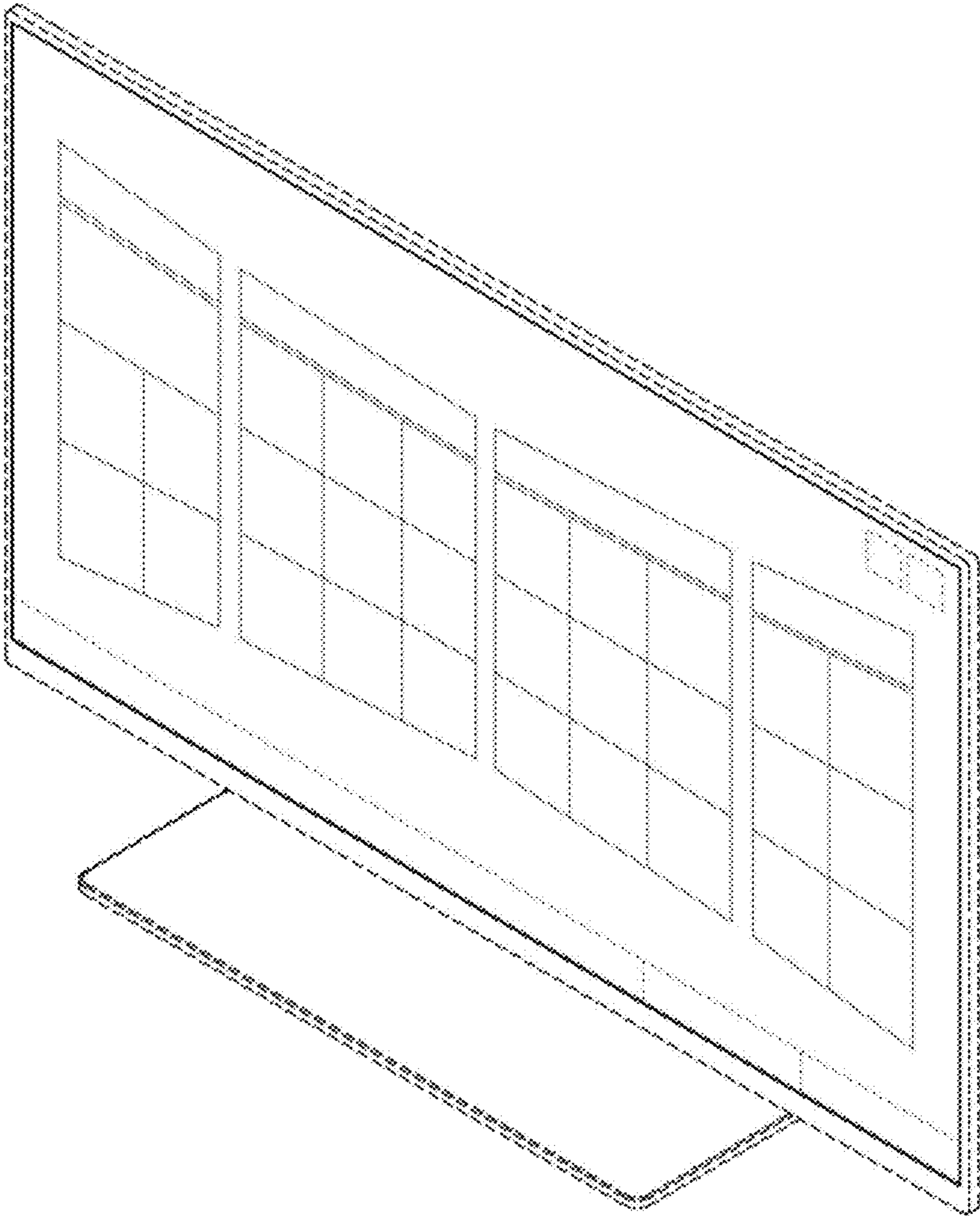

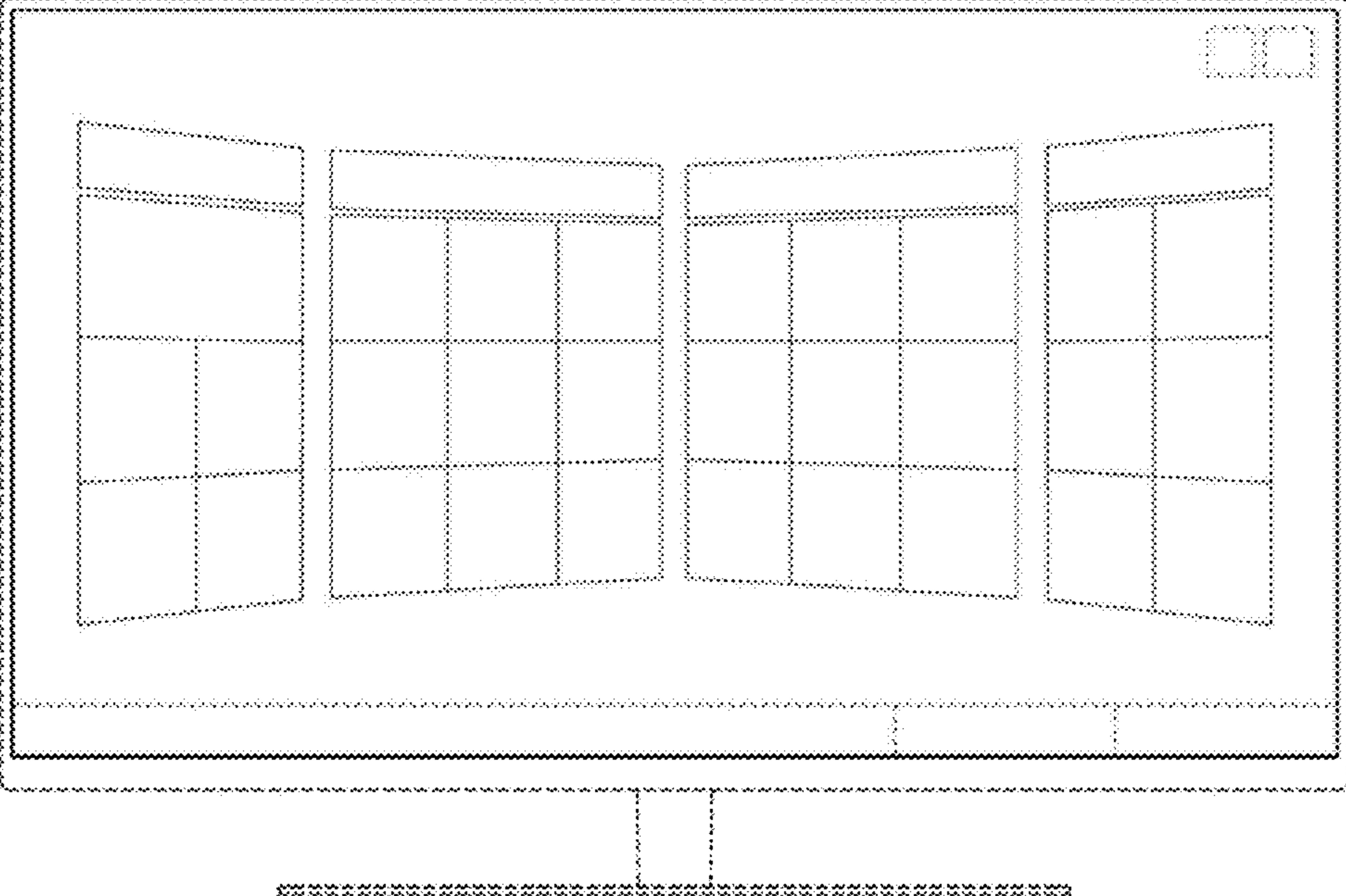
