(57) **CLAIM**

I claim the ornamental design for a rear cylinder for automobiles, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a rear cylinder for automobiles showing our new design;
FIG. 2 is a front-side elevational view thereof;
FIG. 3 is a rear-side elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top-side elevational view thereof;
FIG. 7 is a bottom-side elevational view thereof; and,
FIG. 8 is a rear perspective view thereof.

The broken lines are included for the purpose of illustrating portions of the rear cylinder for automobiles that form no part of the claimed design.

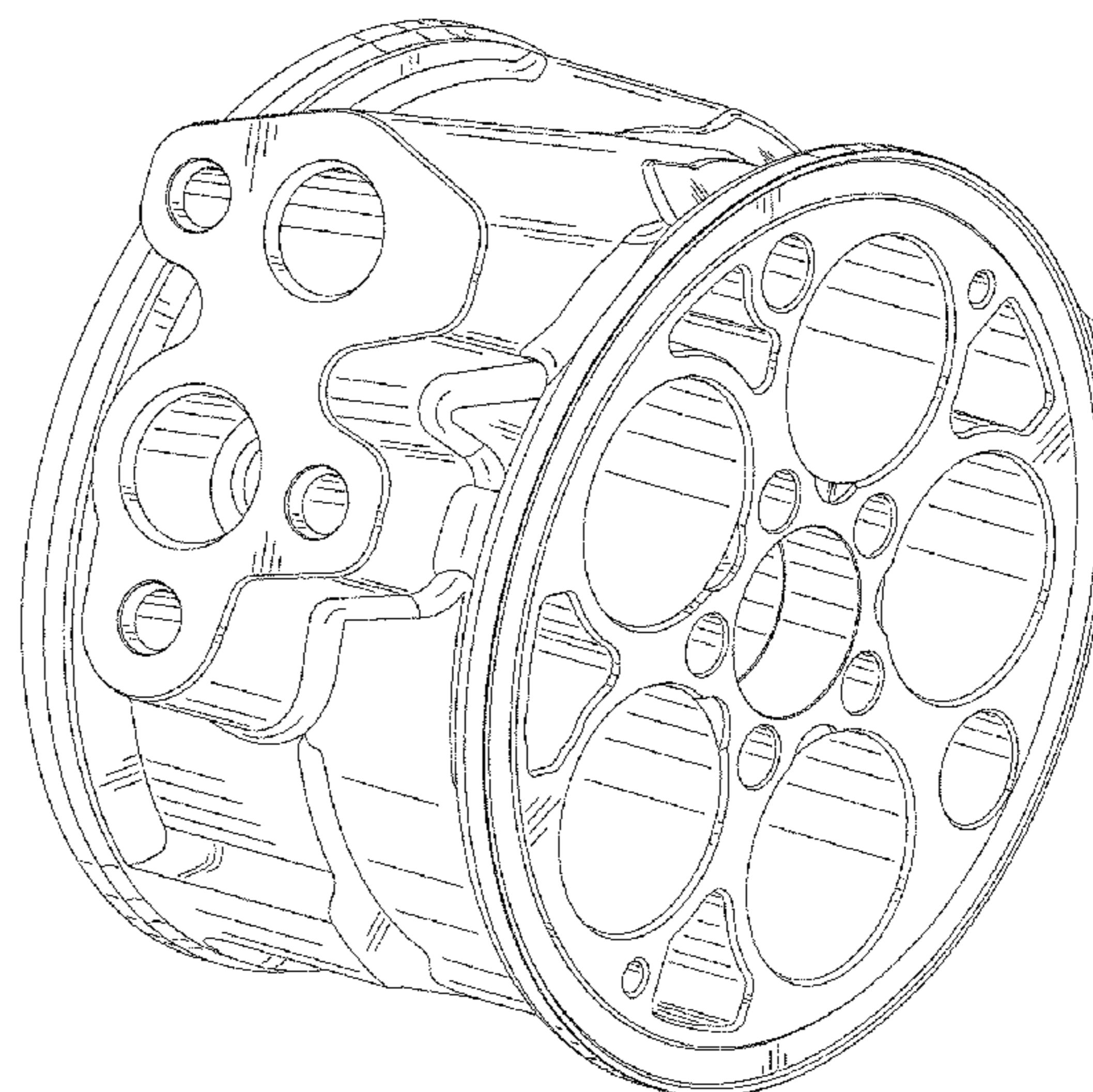
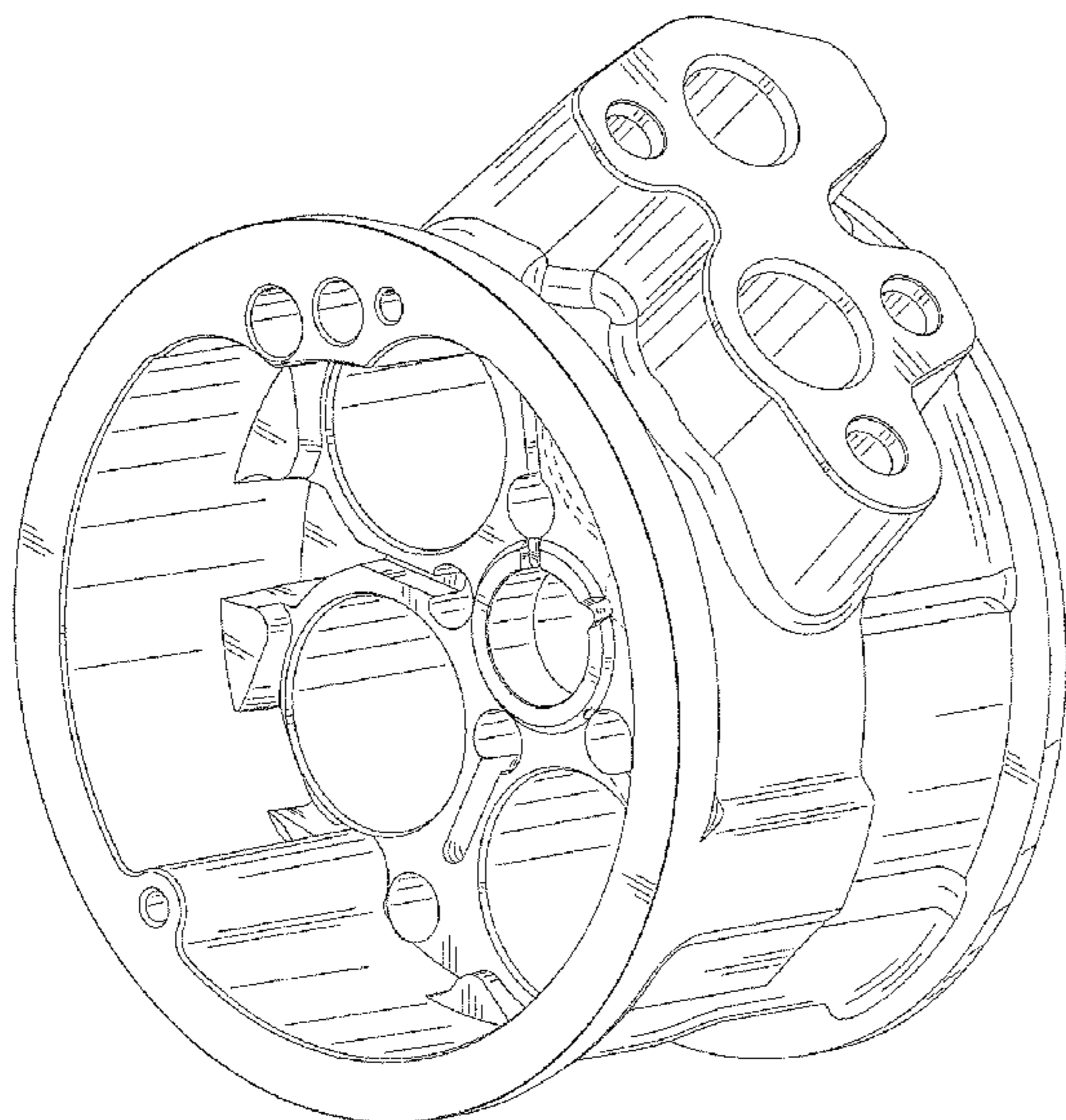

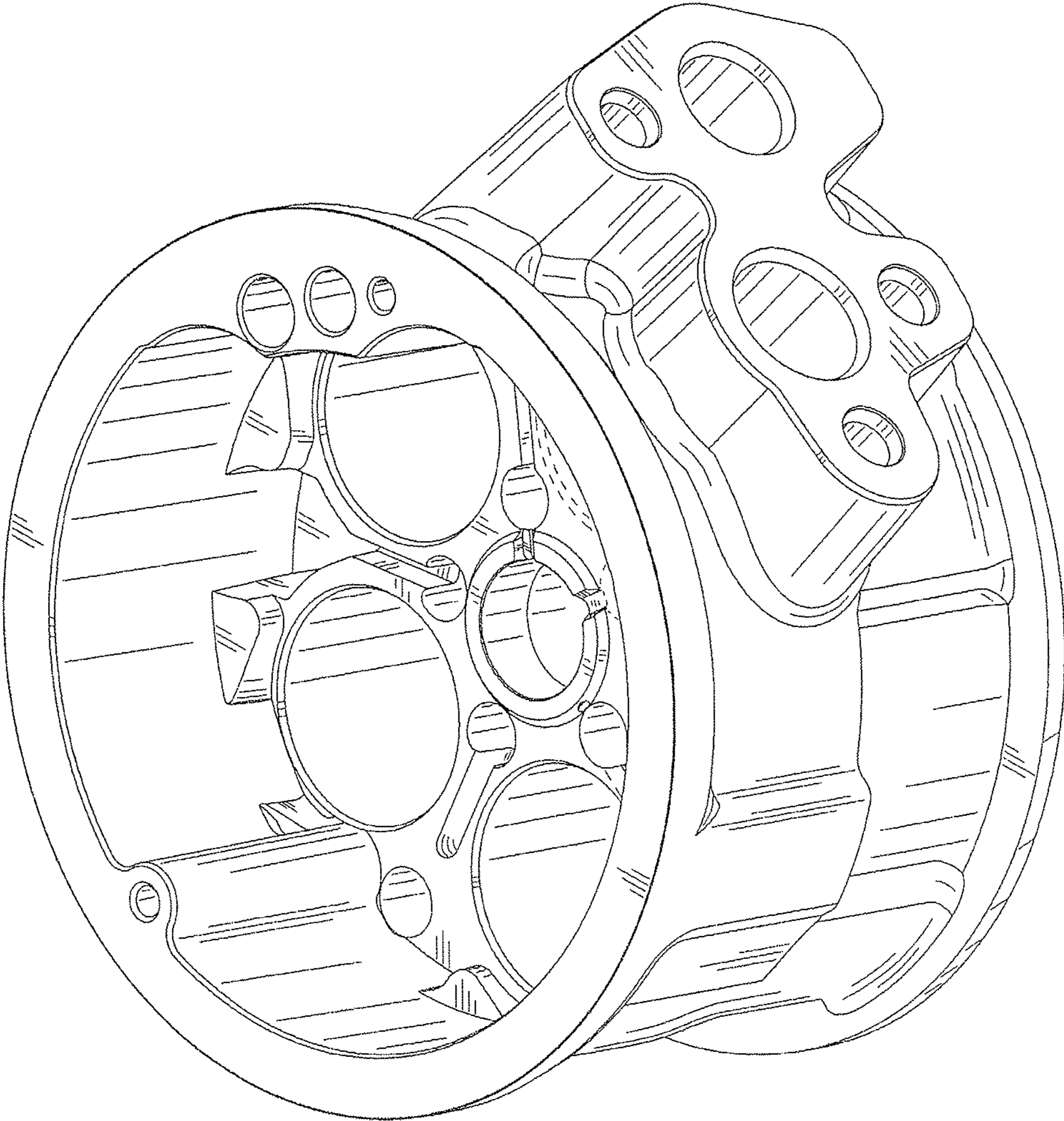

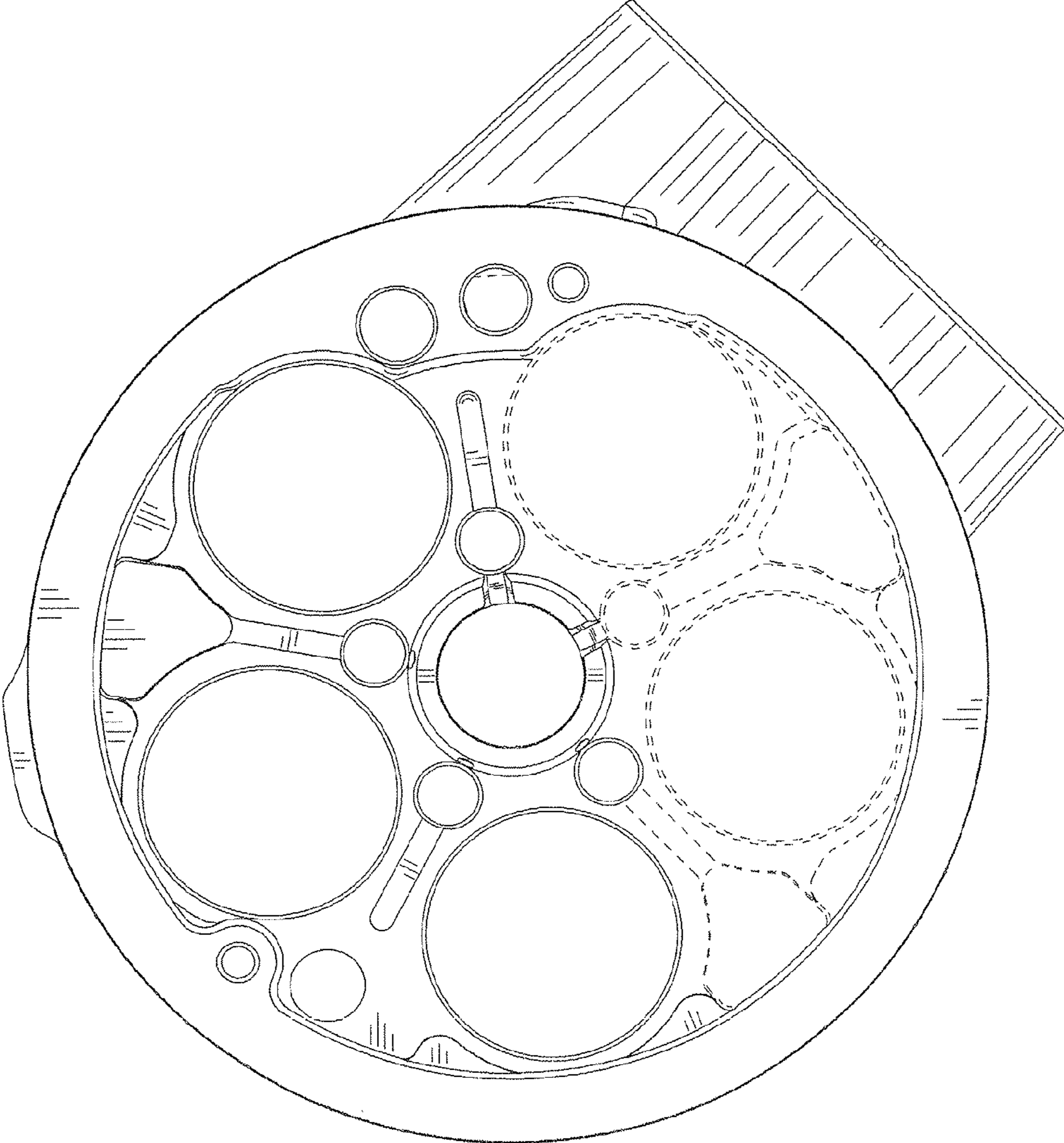

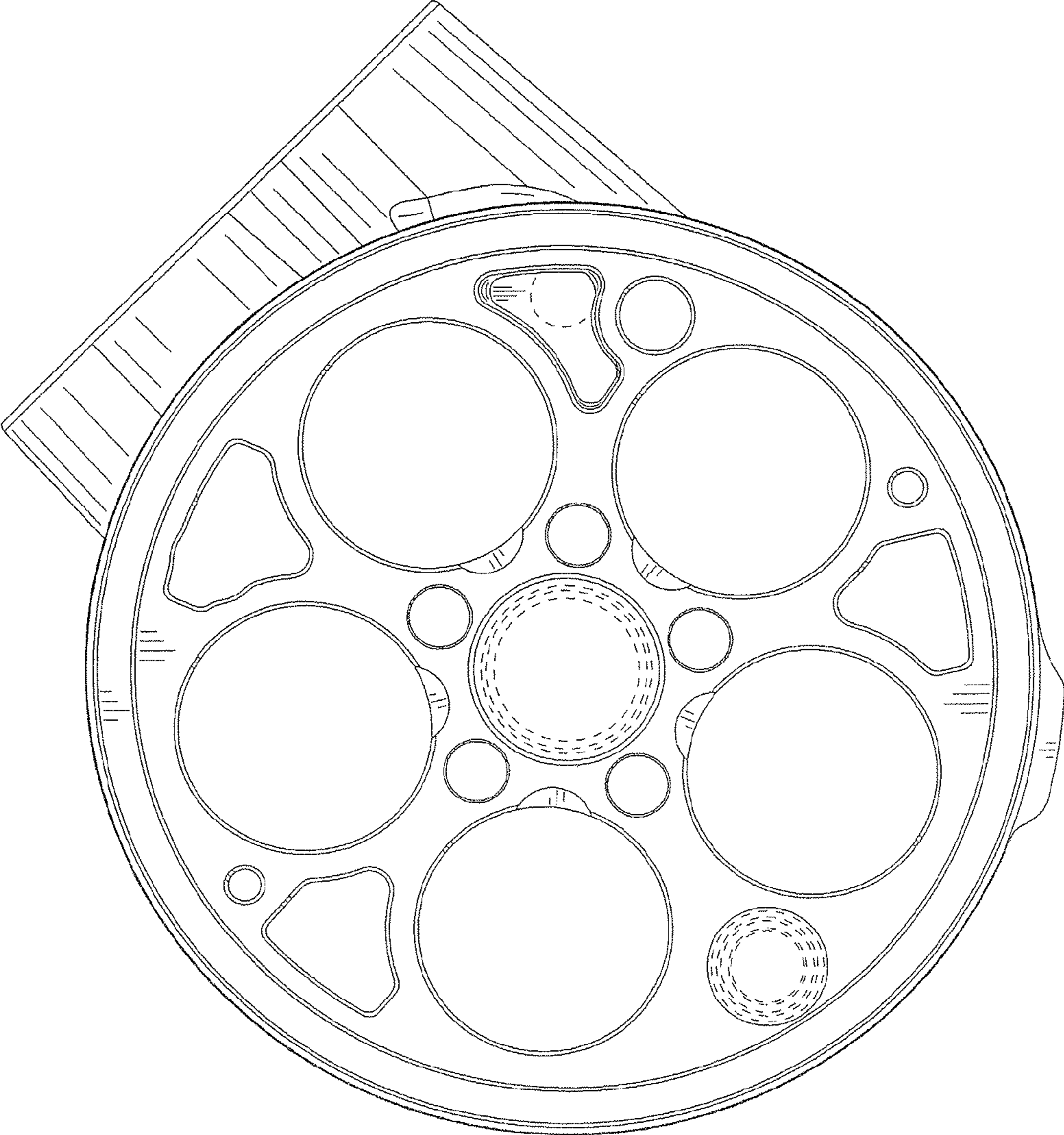

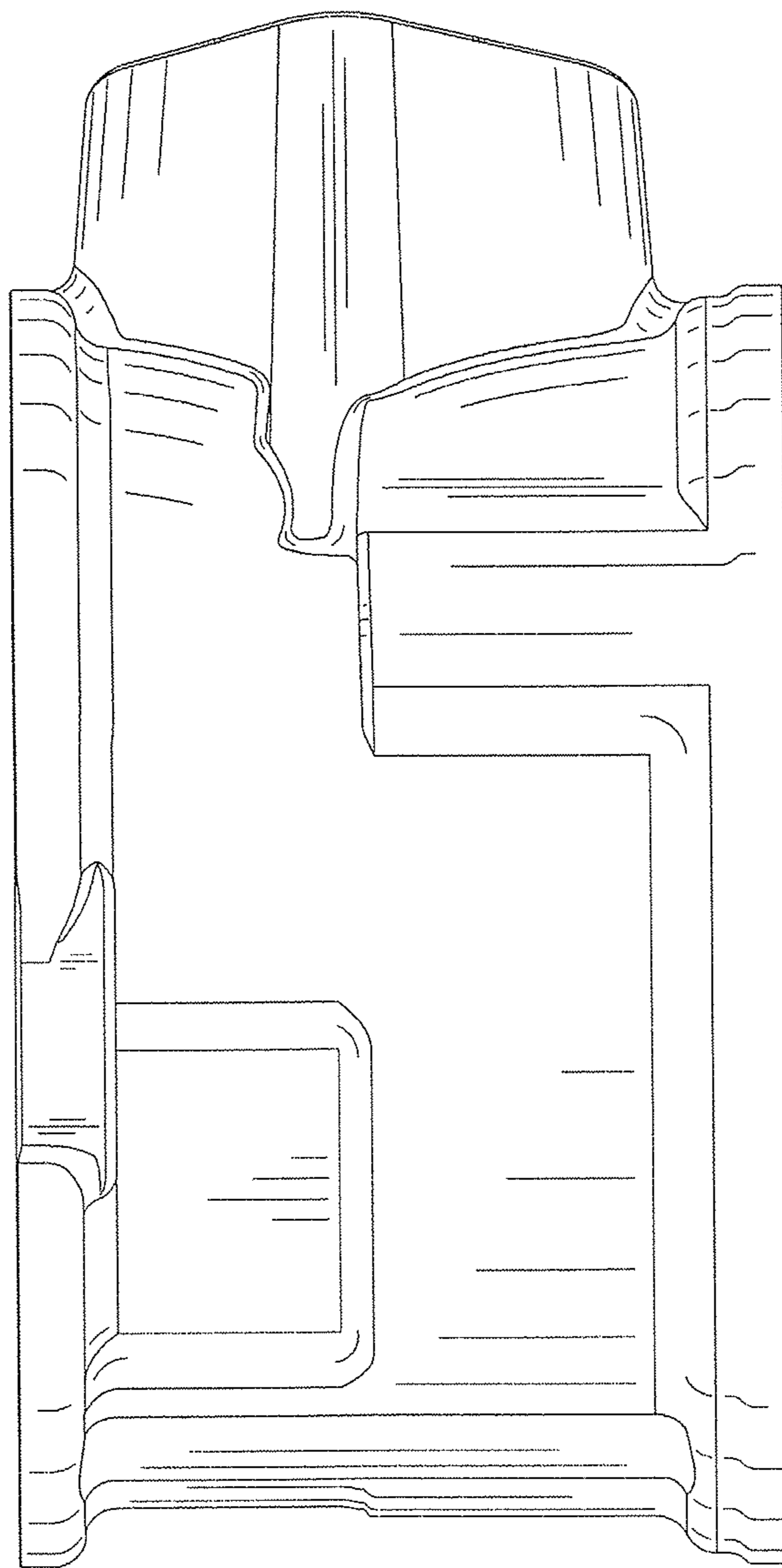

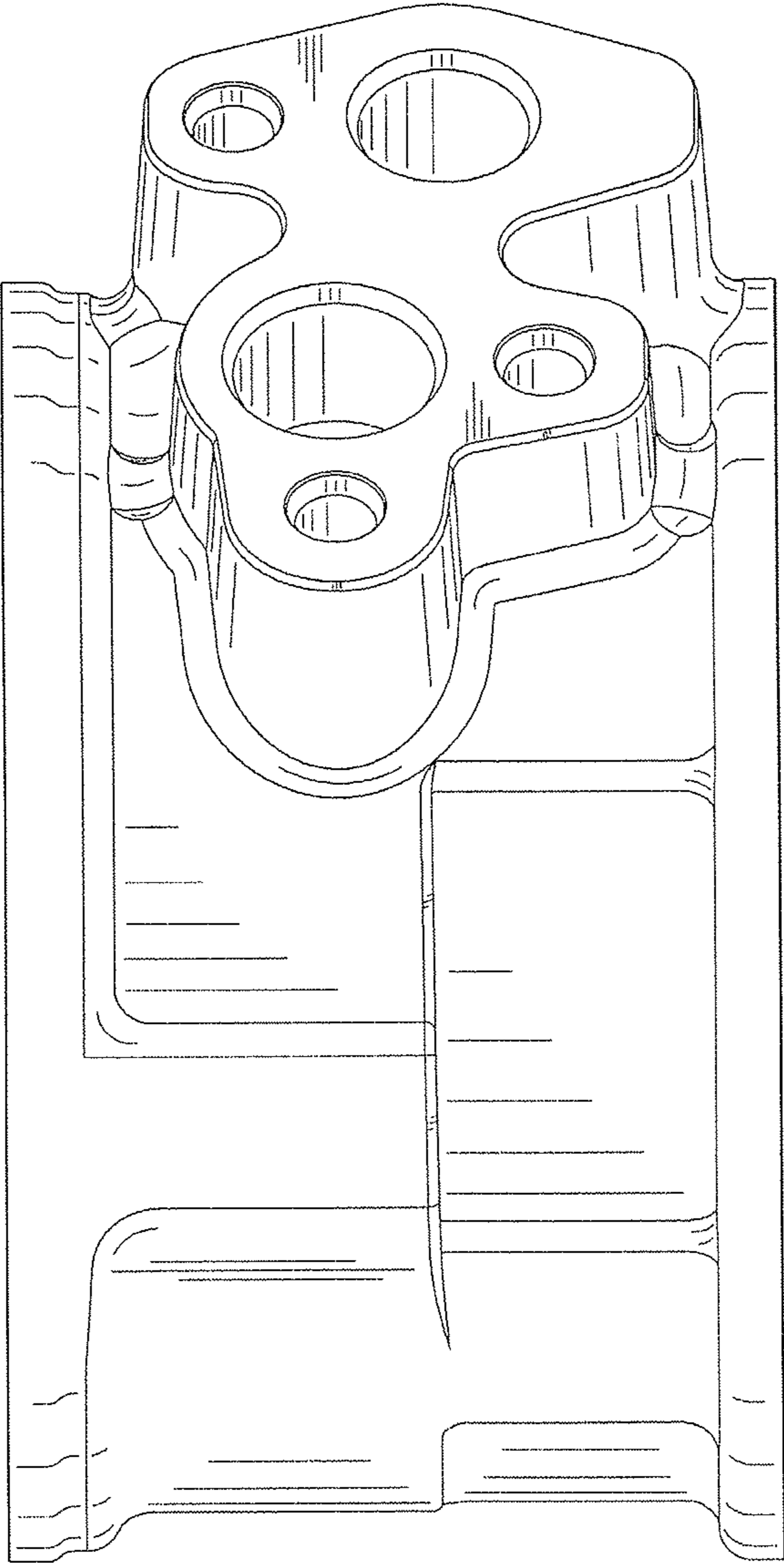

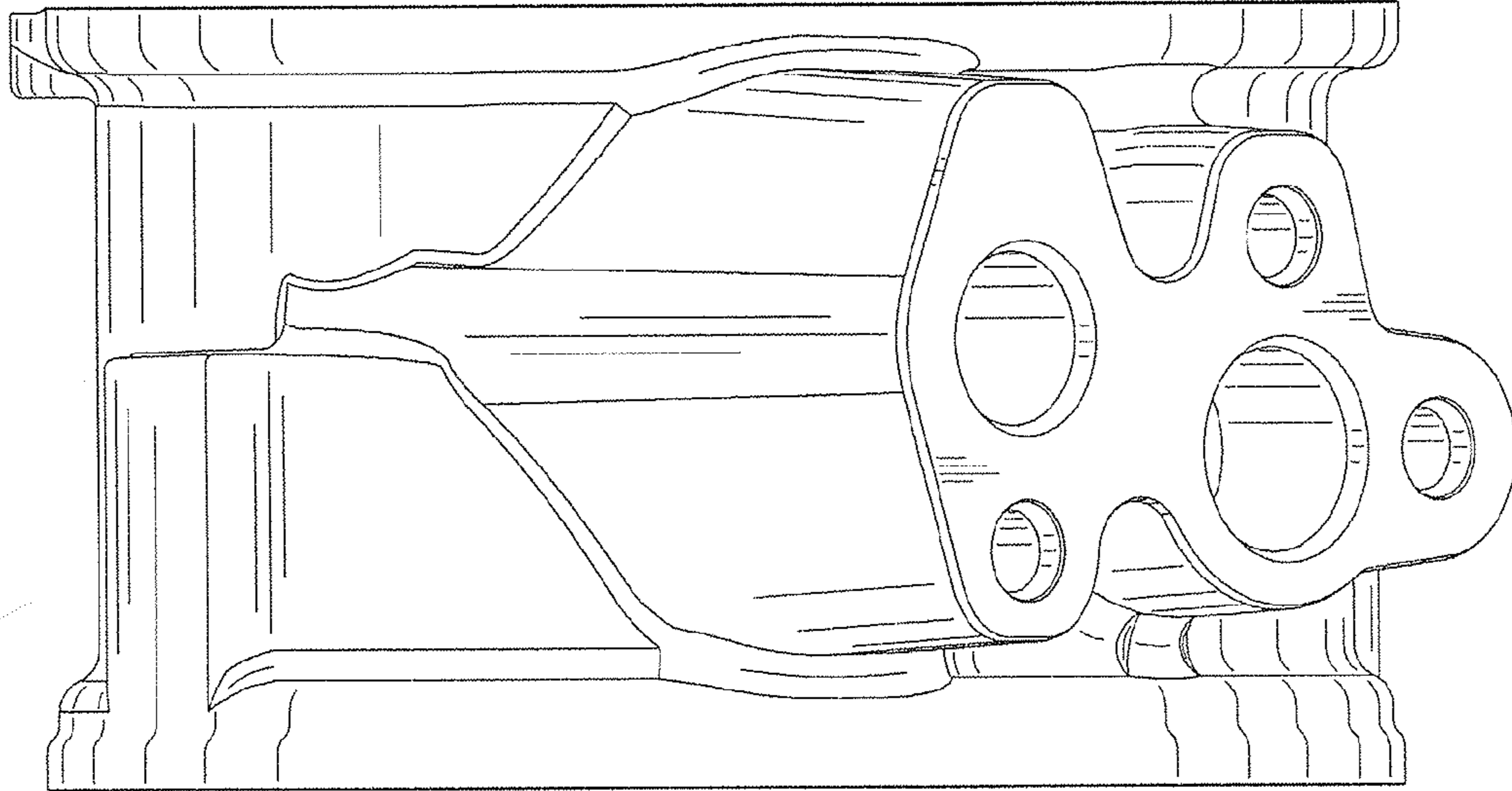

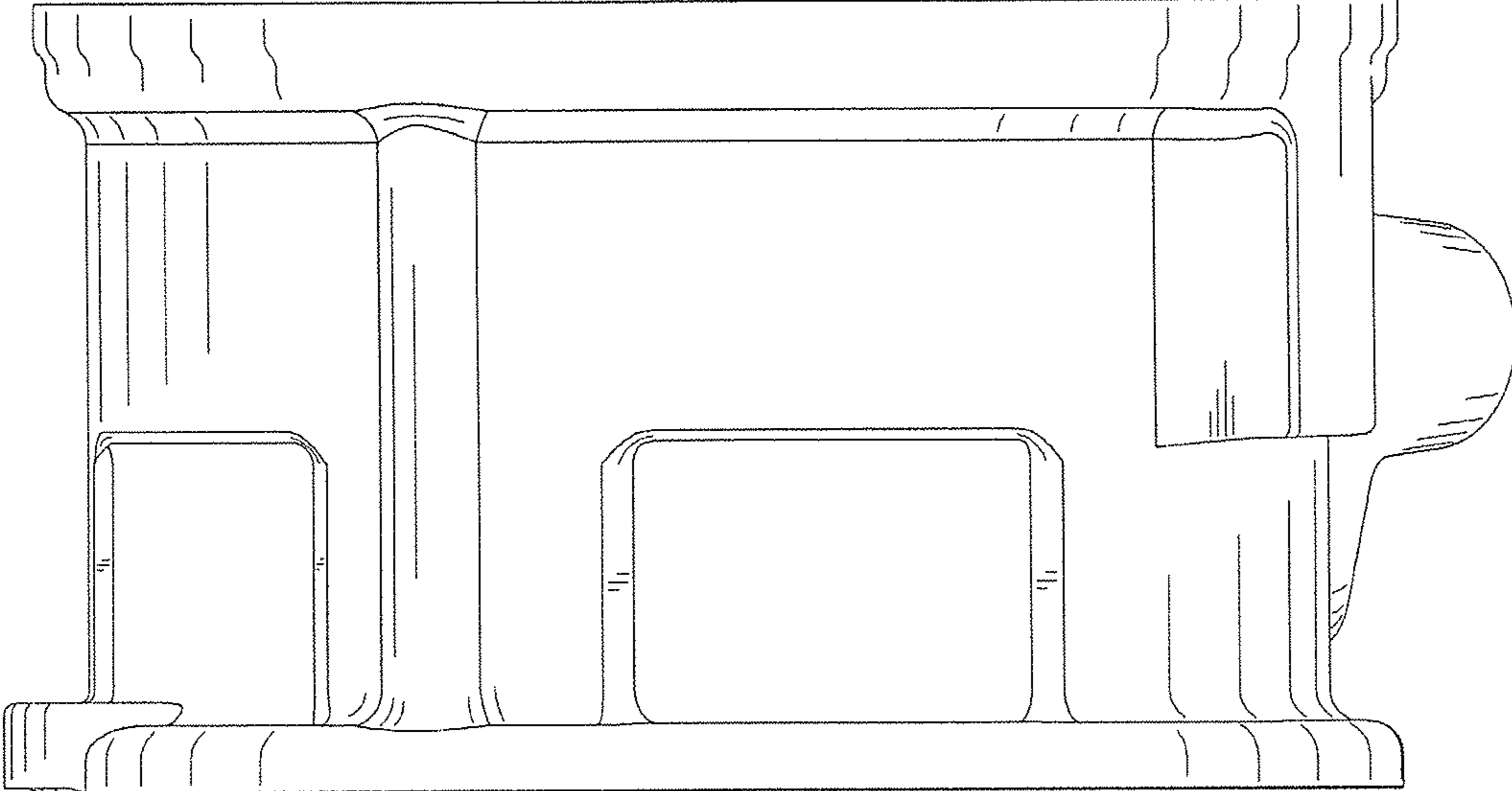
