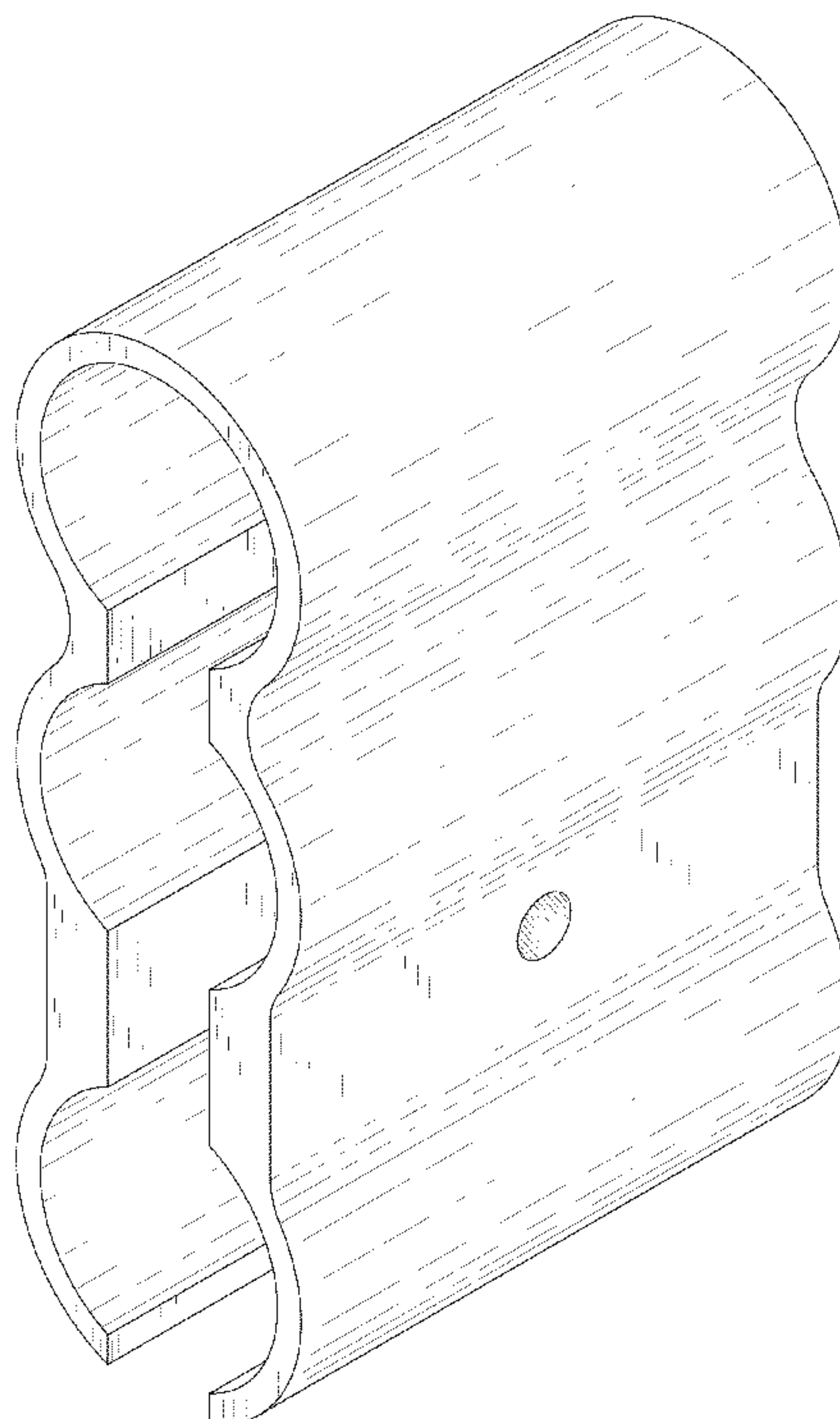
(57) **CLAIM**

The ornamental design for a gun sight accessory mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a gun sight accessory mount; FIG. 2 is a front side view thereof, the rear side being a mirror image; FIG. 3 is a right view thereof; FIG. 4 is a left view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a front view thereof, showing a fastener secured to the gun sight accessory mount. The broken line showing fastener is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

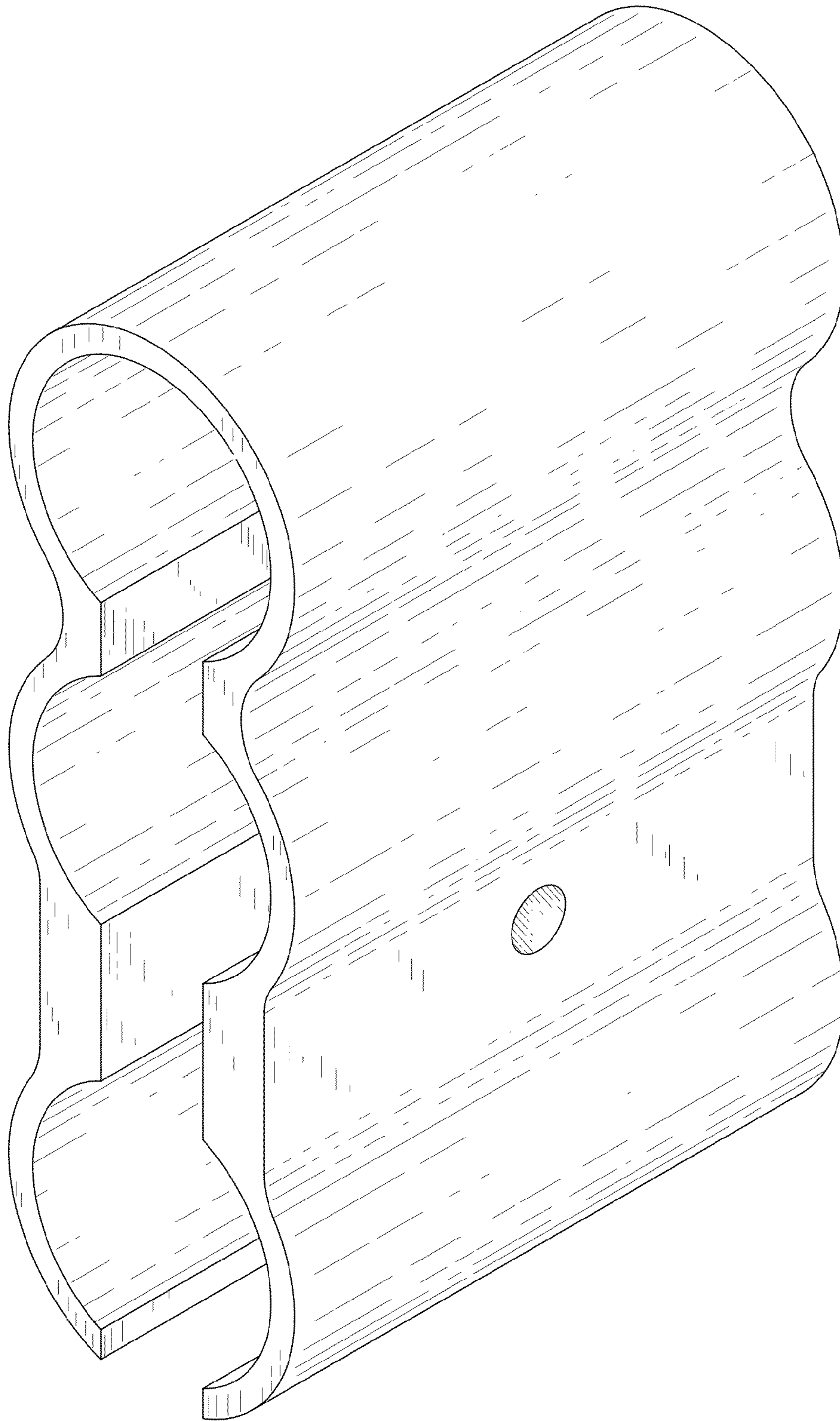

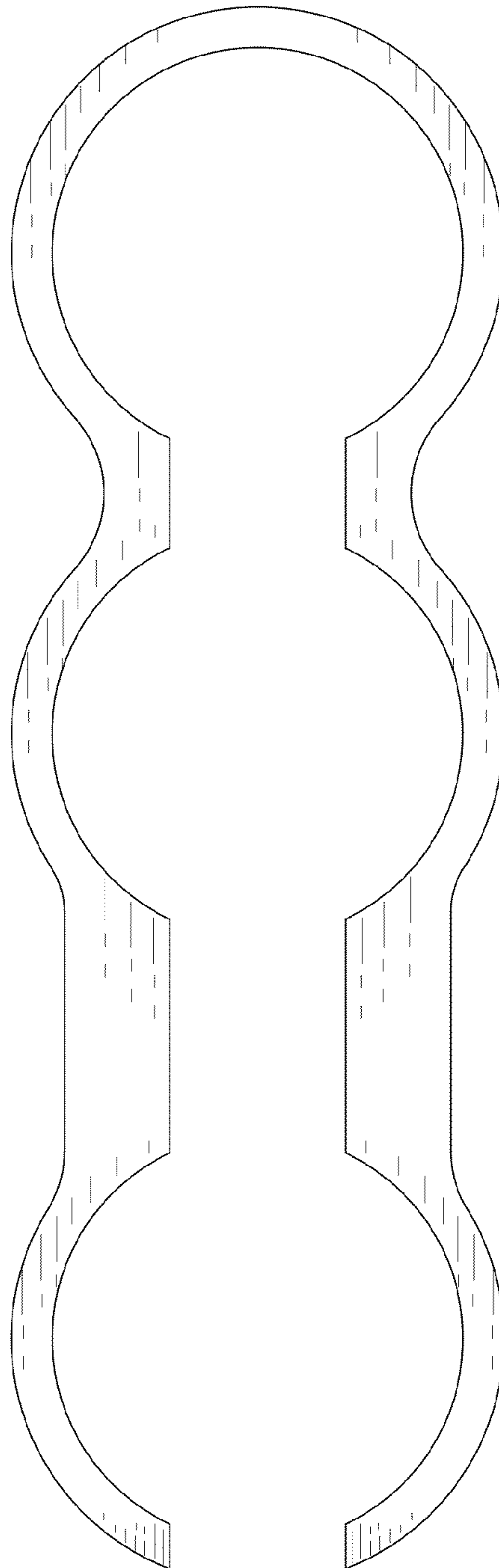

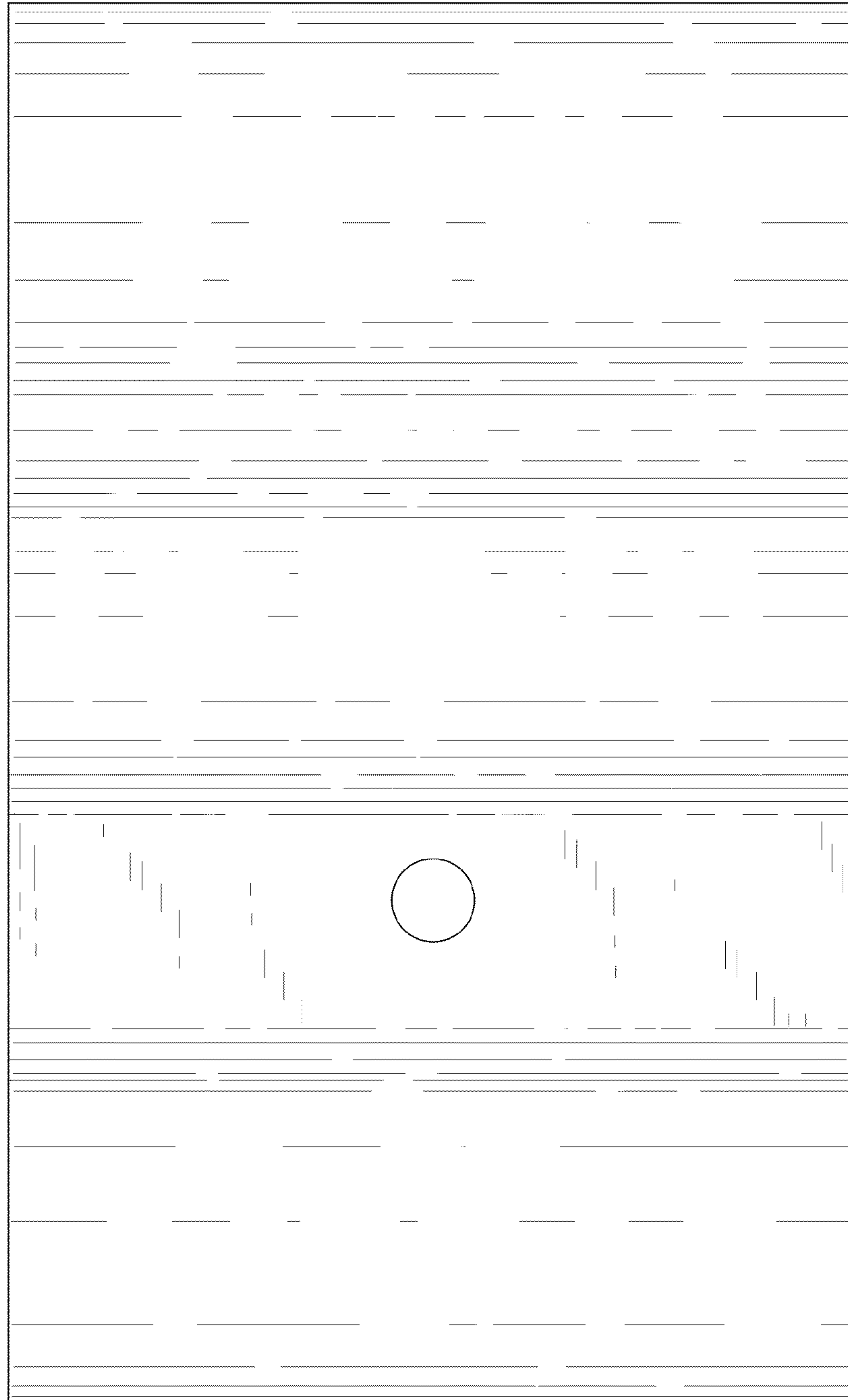

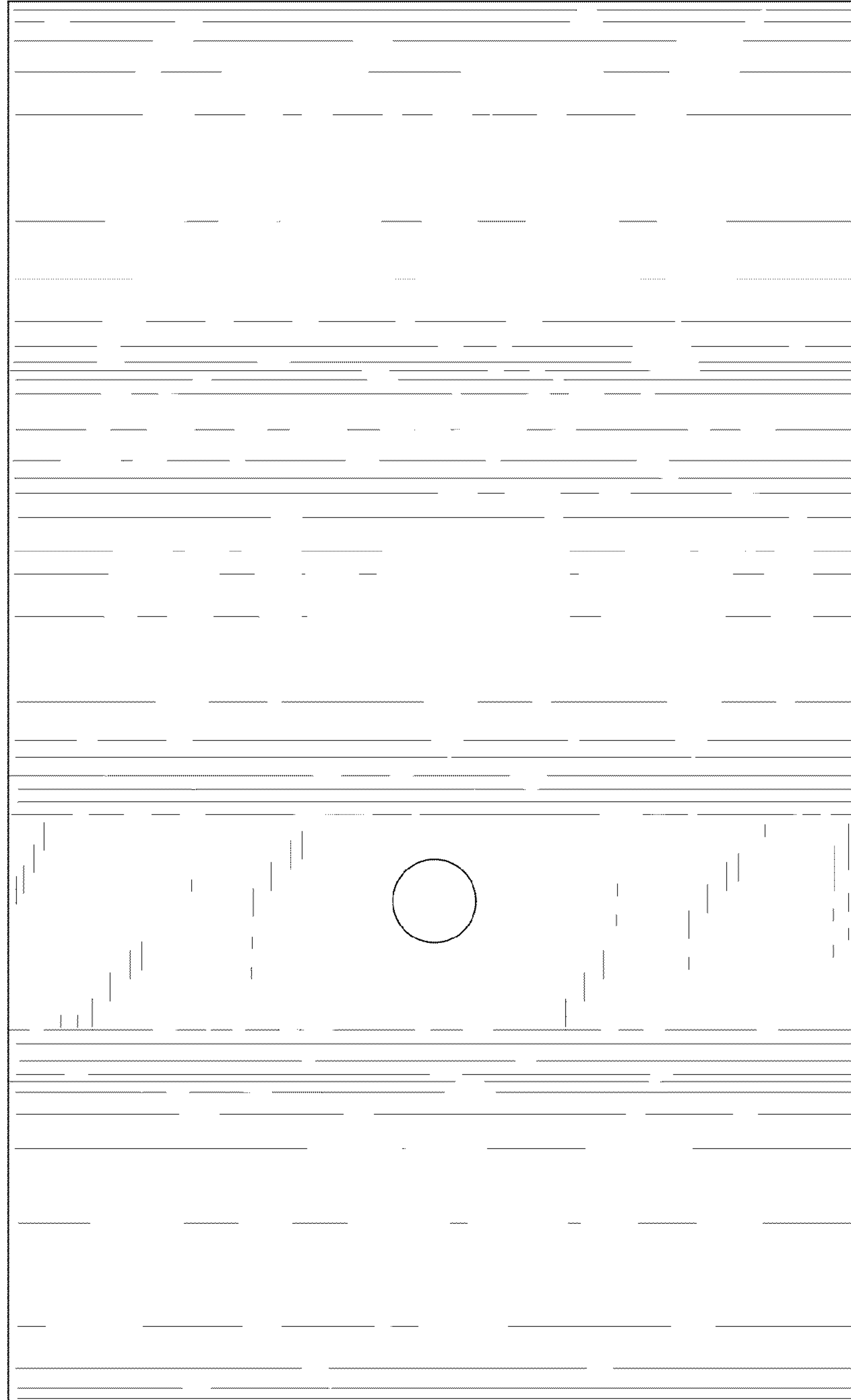

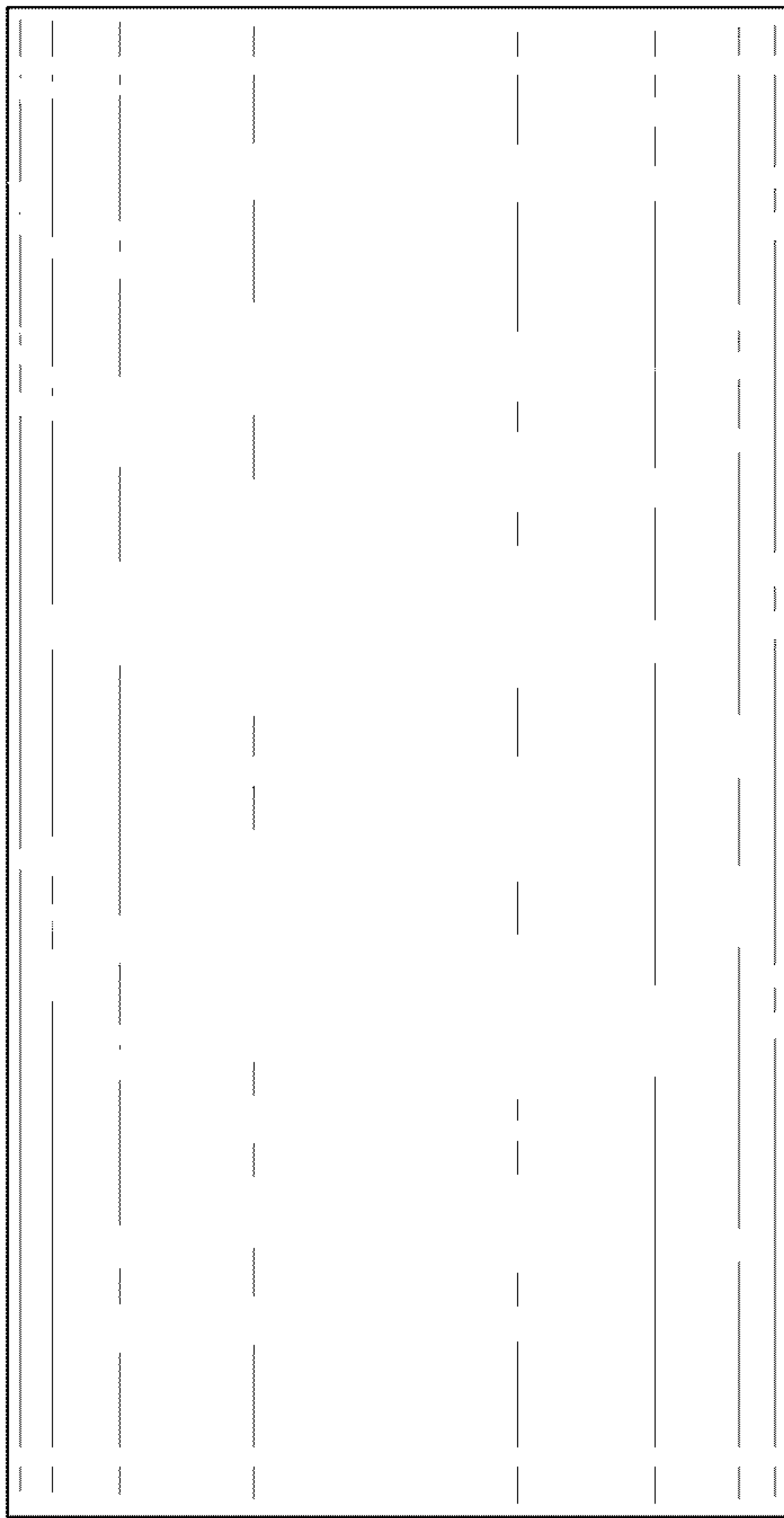

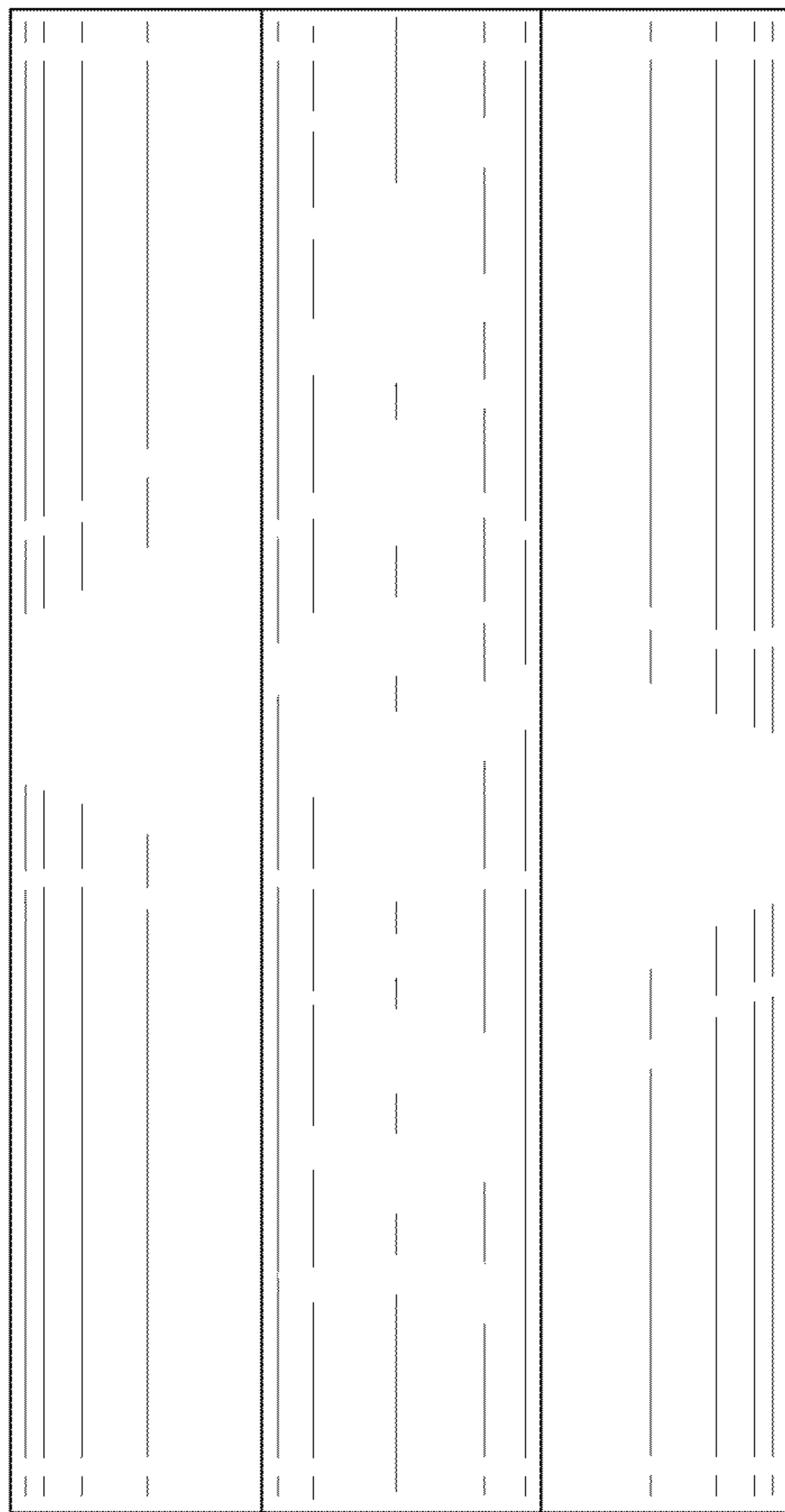

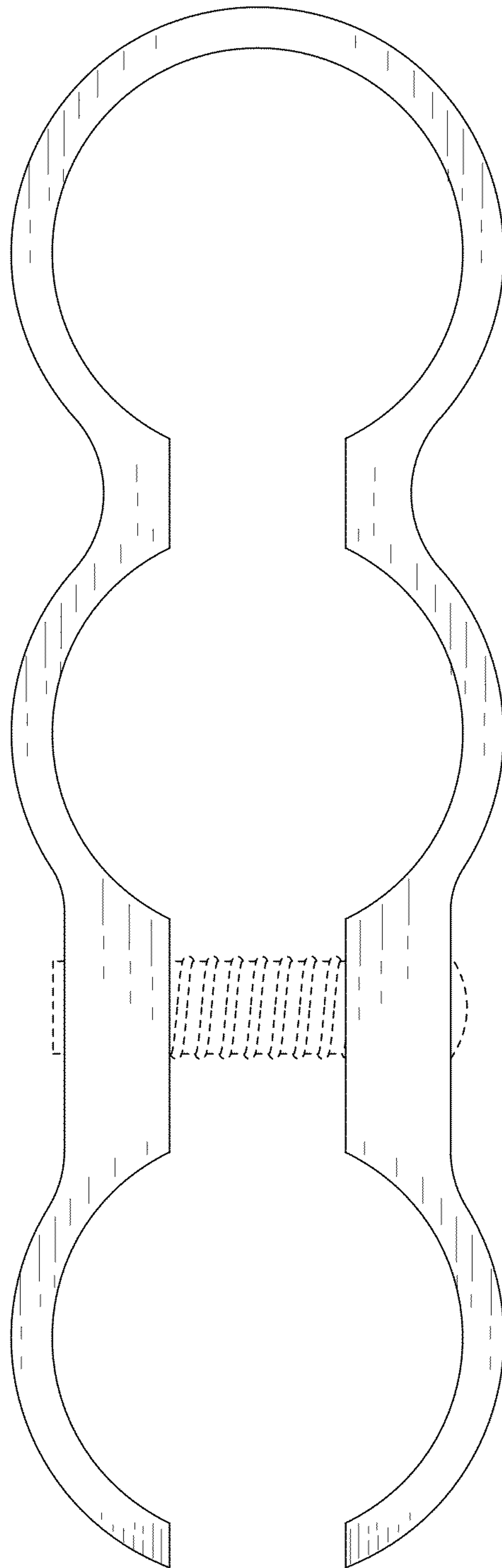
