The ornamental design for an interchangeable structural module, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design for an interchangeable structural module from the front, top, and right side;

FIG. 2 is a perspective view showing the design from the front, top and left side;

FIG. 3 is a perspective view showing the design from the rear, top and left side;

FIG. 4 is an alternate perspective view of the design showing the design from the top, rear and left side;

FIG. 7 is a rear elevational view thereof;

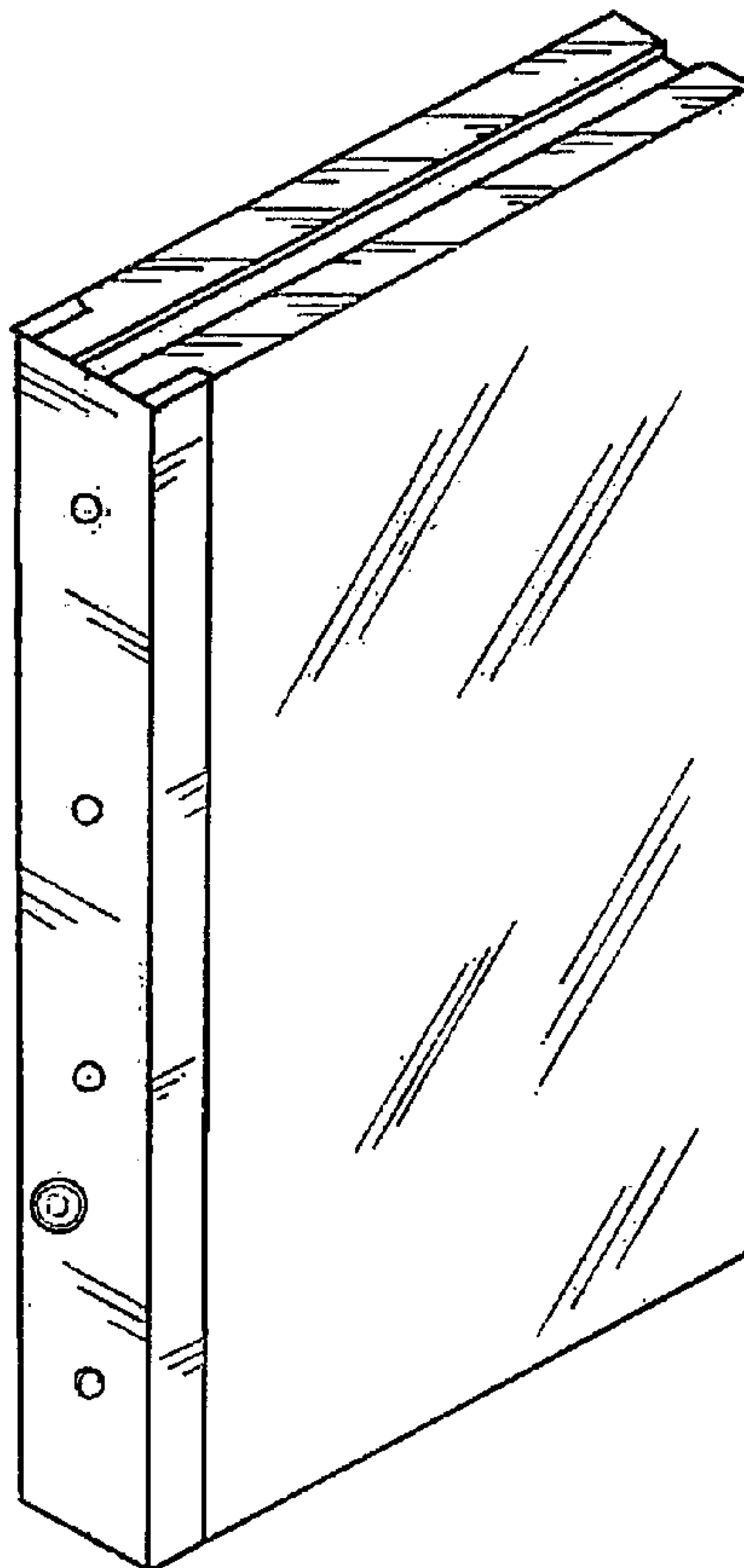
FIG. 8 is a right-side elevational view thereof;

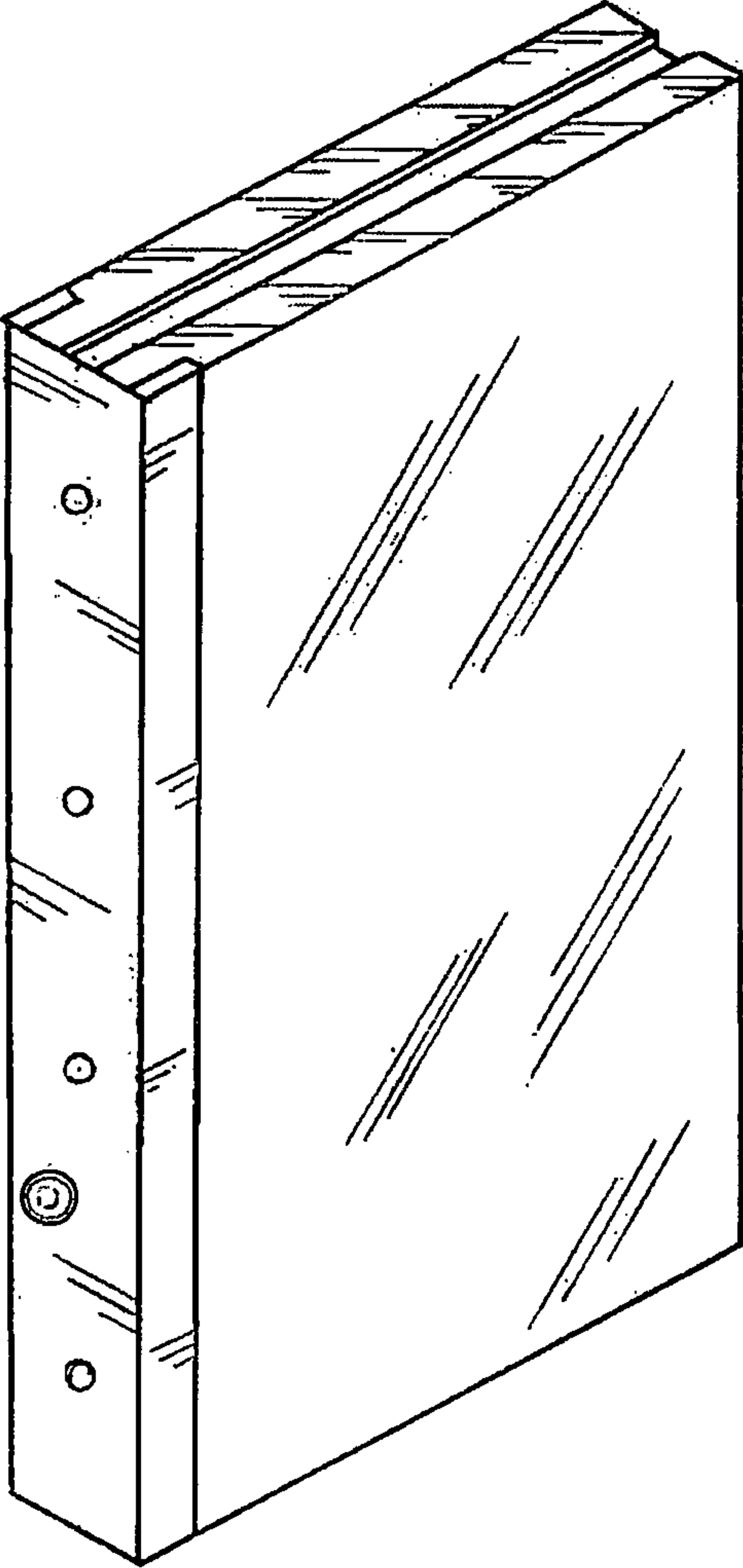

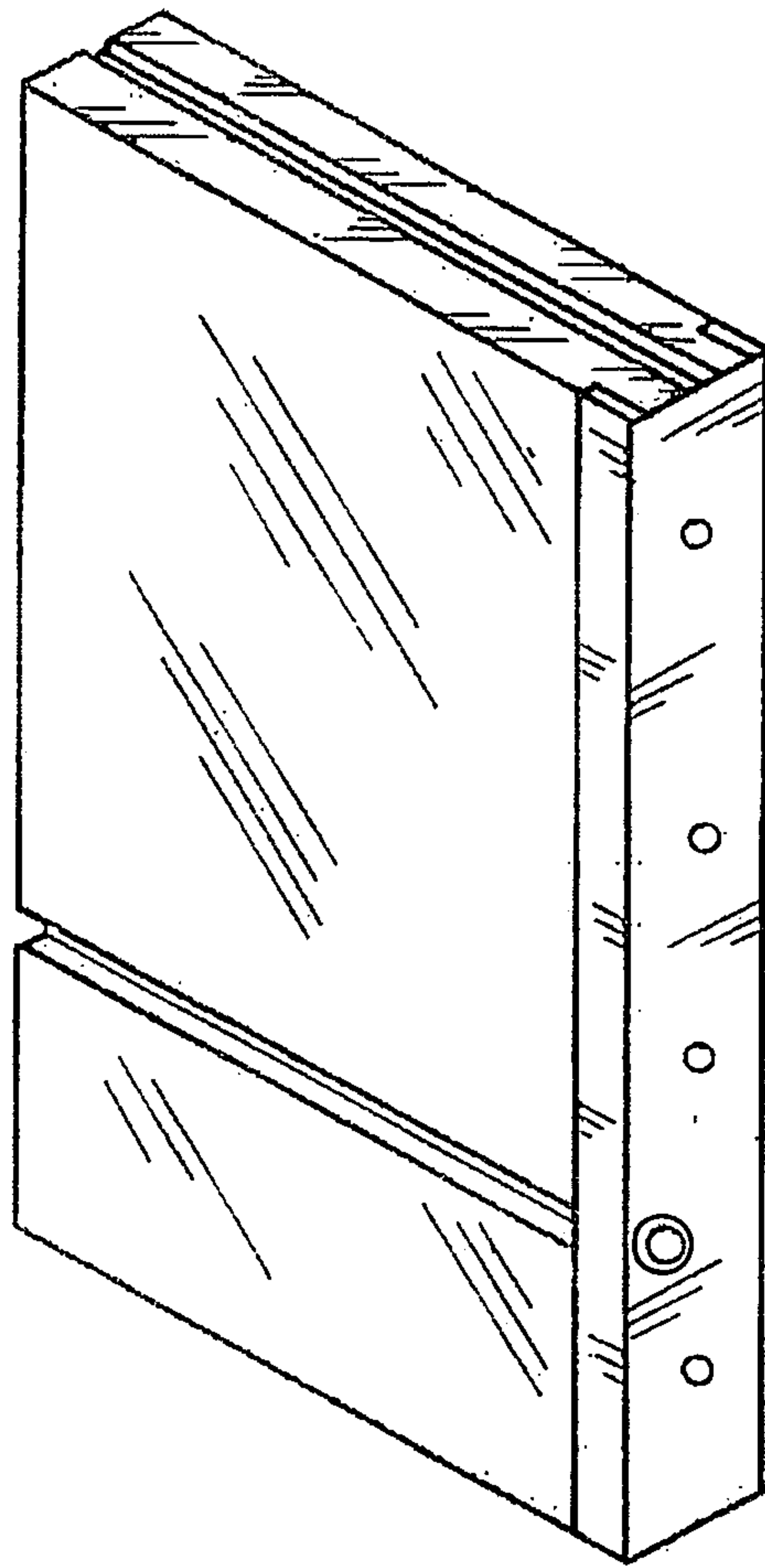

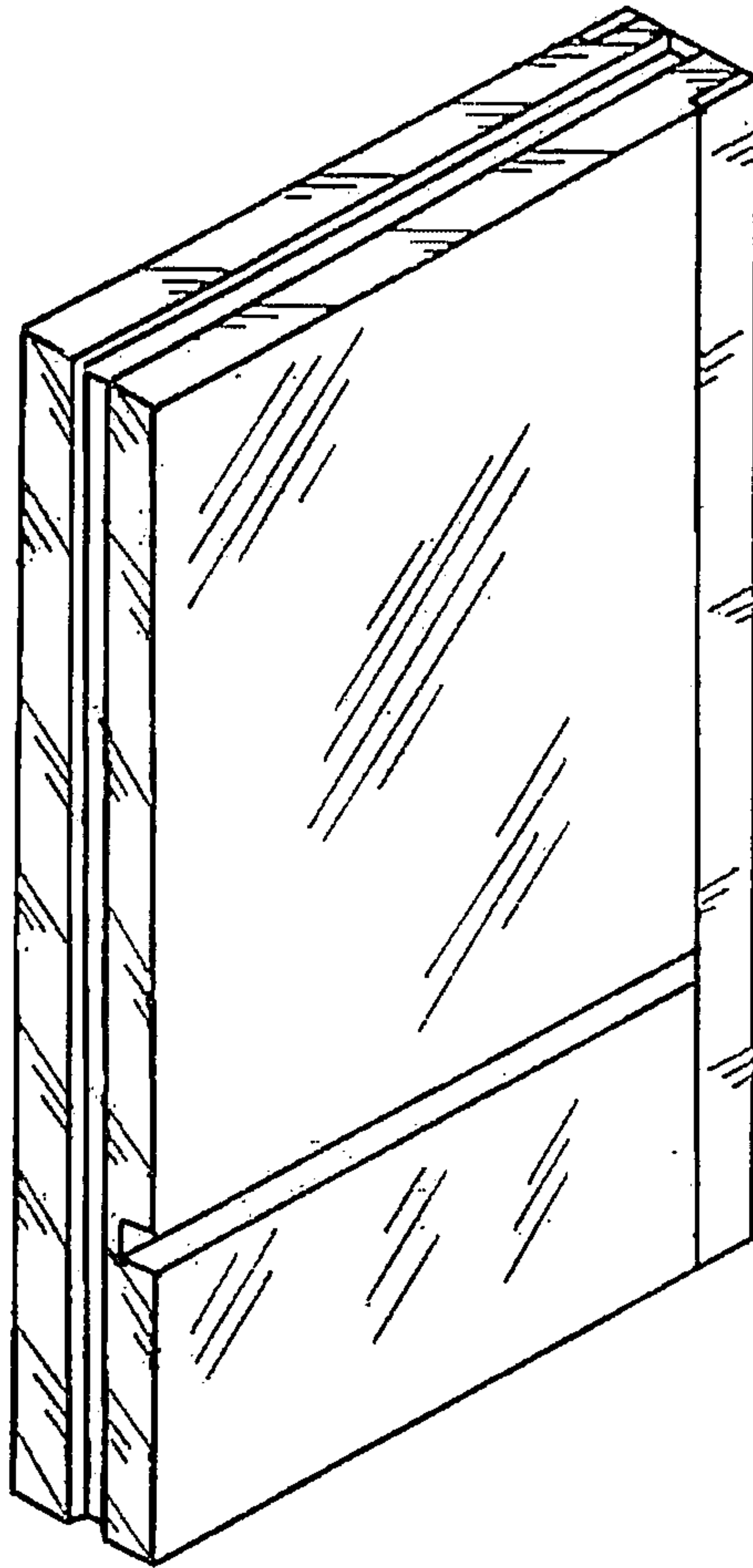

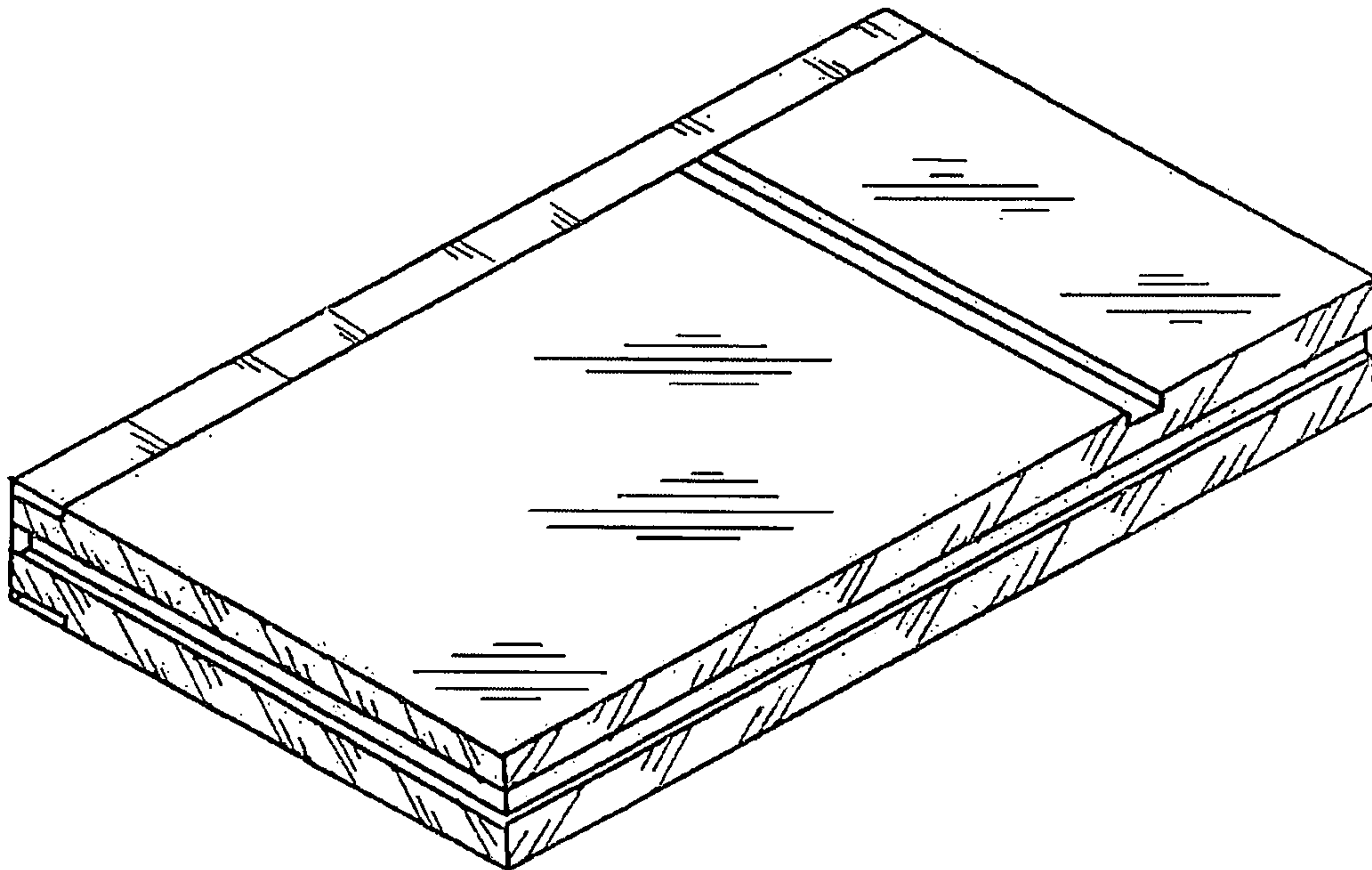

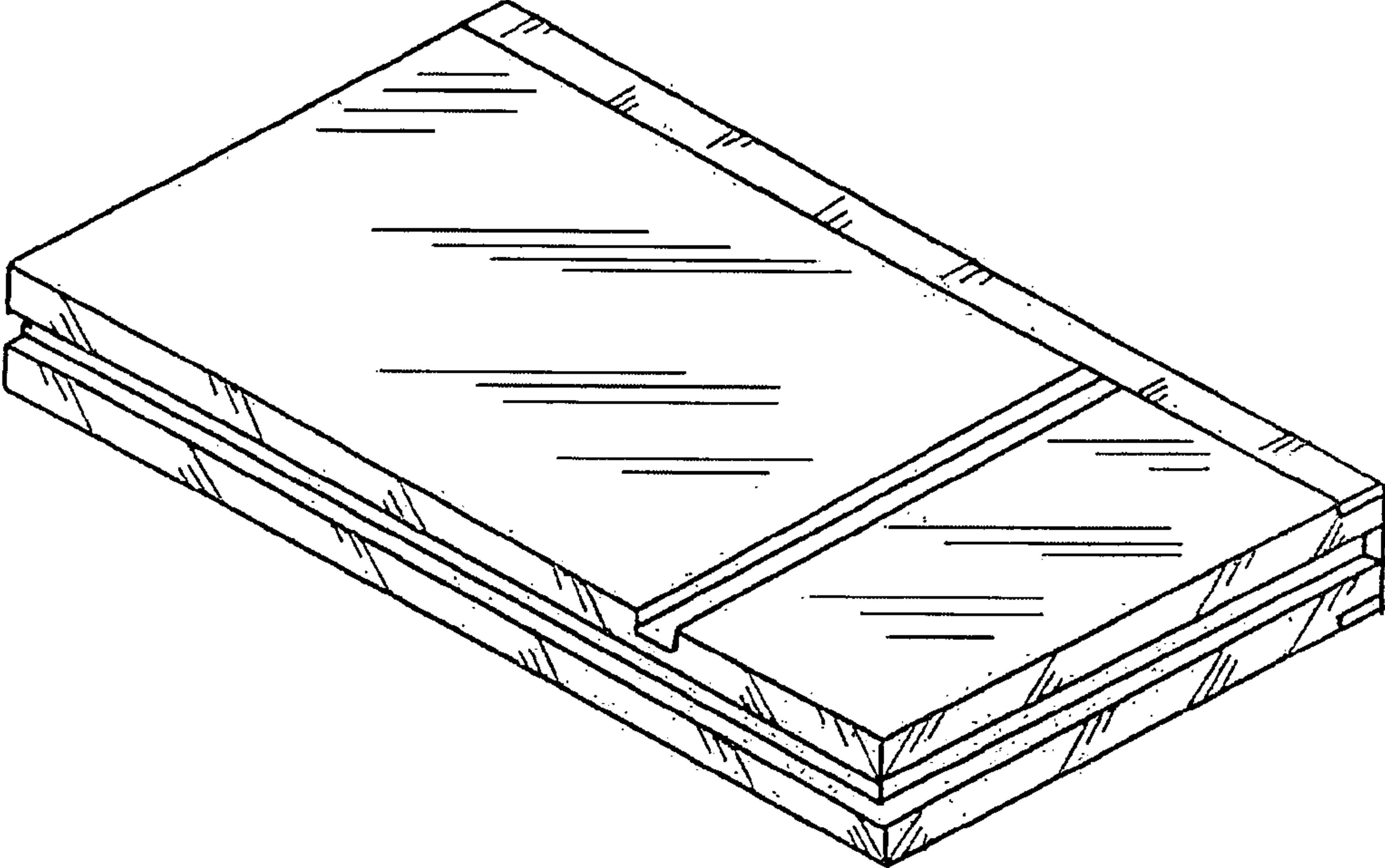

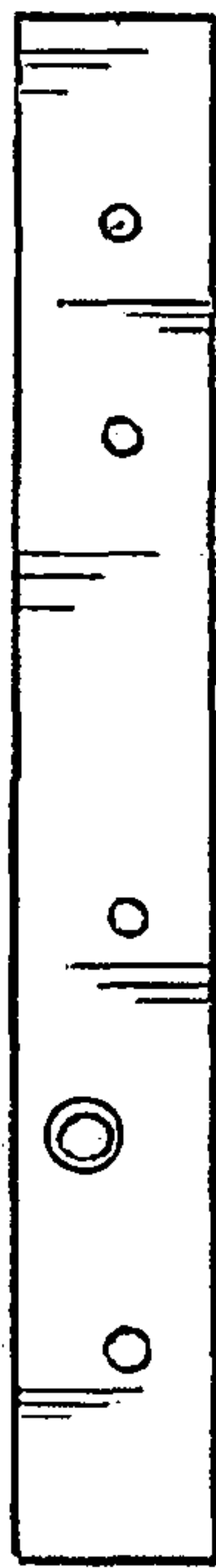

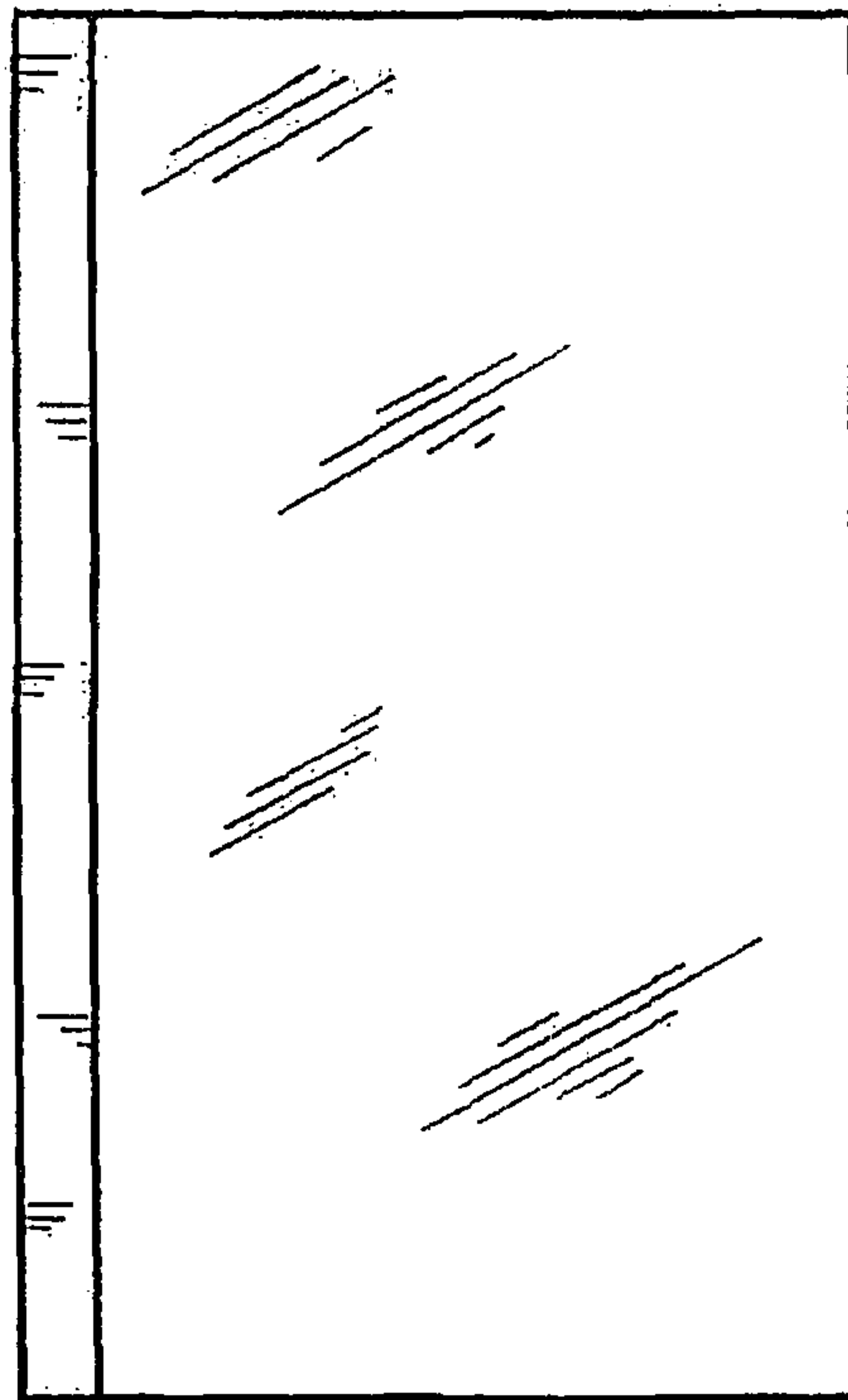

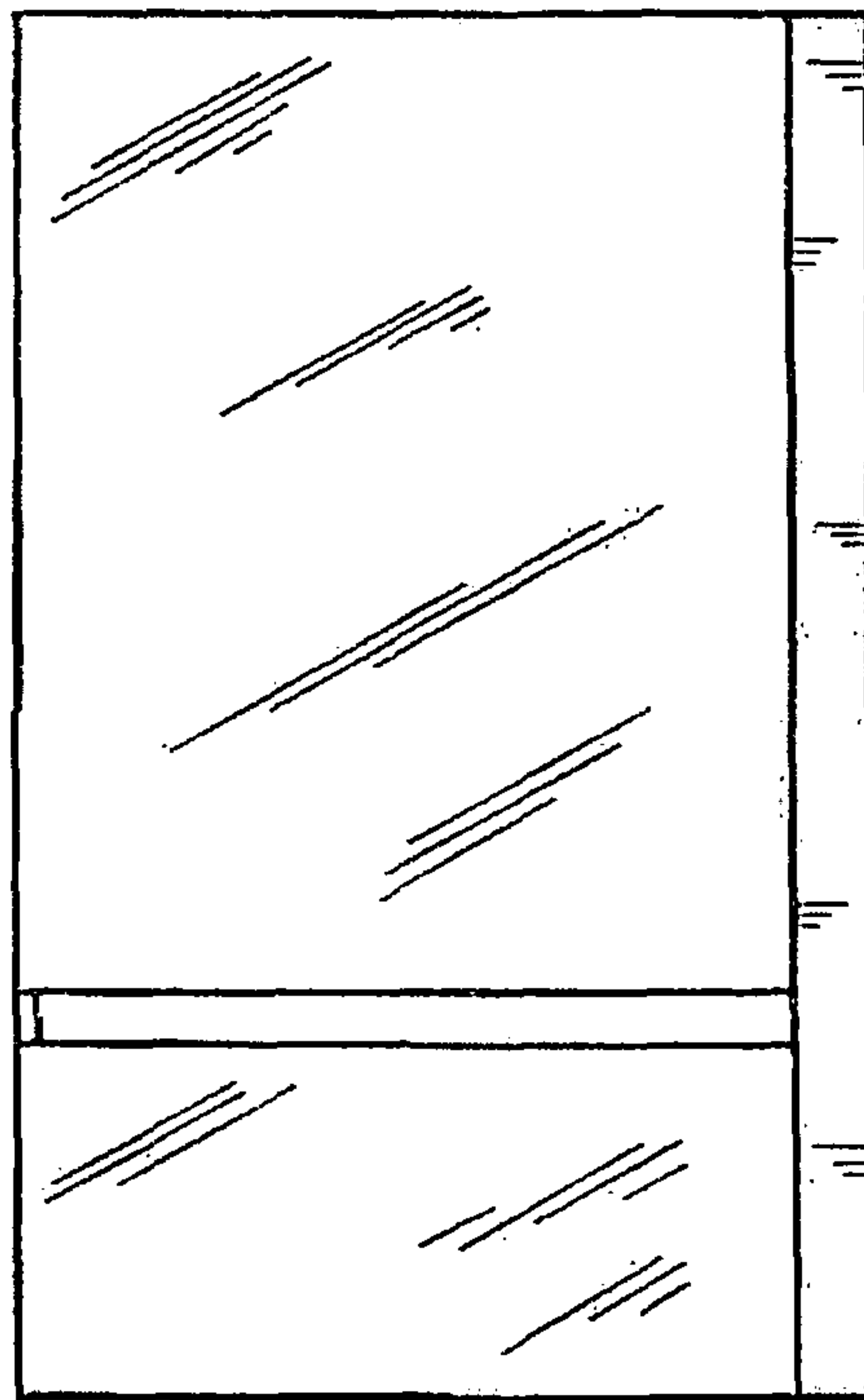

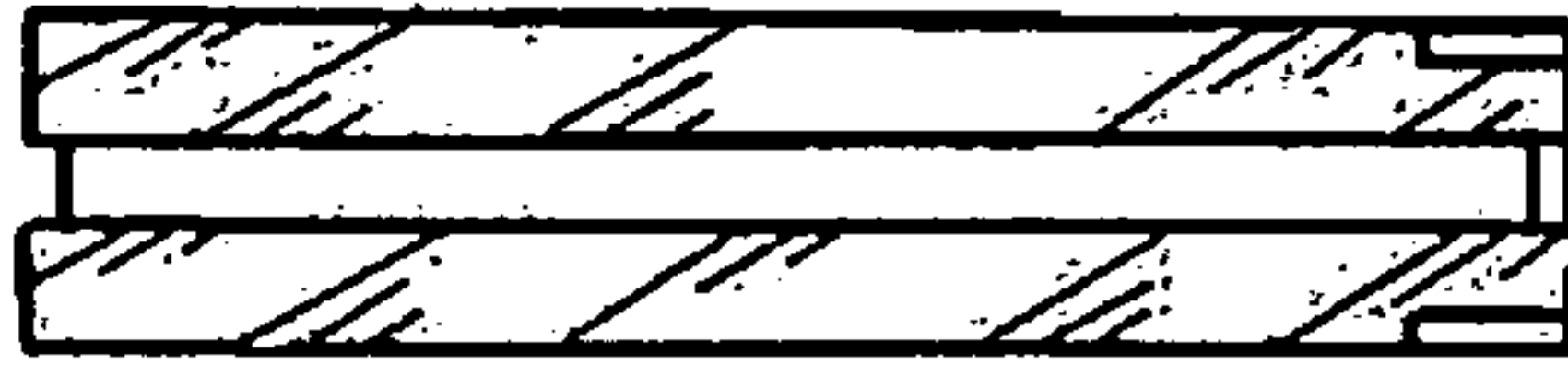
