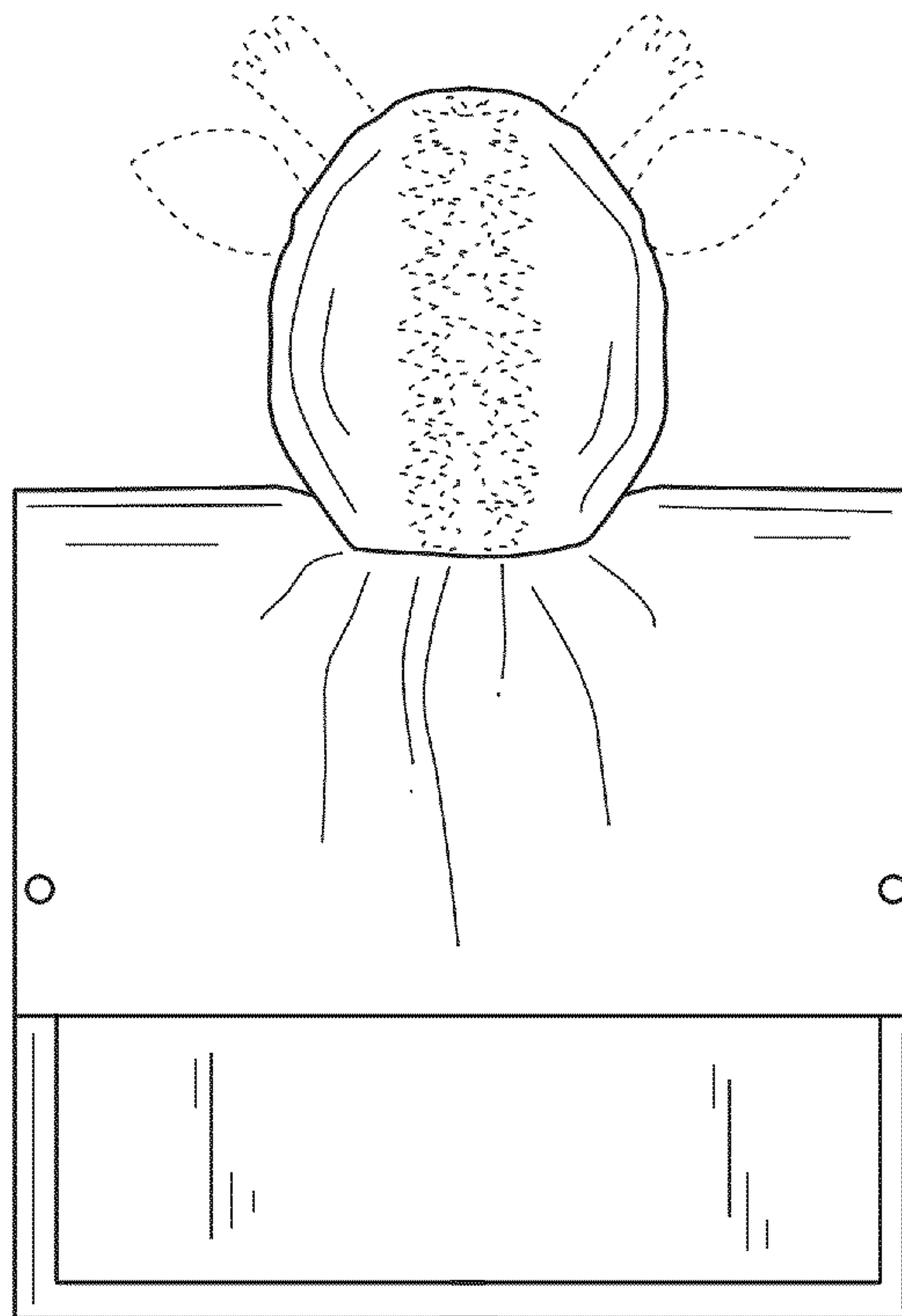
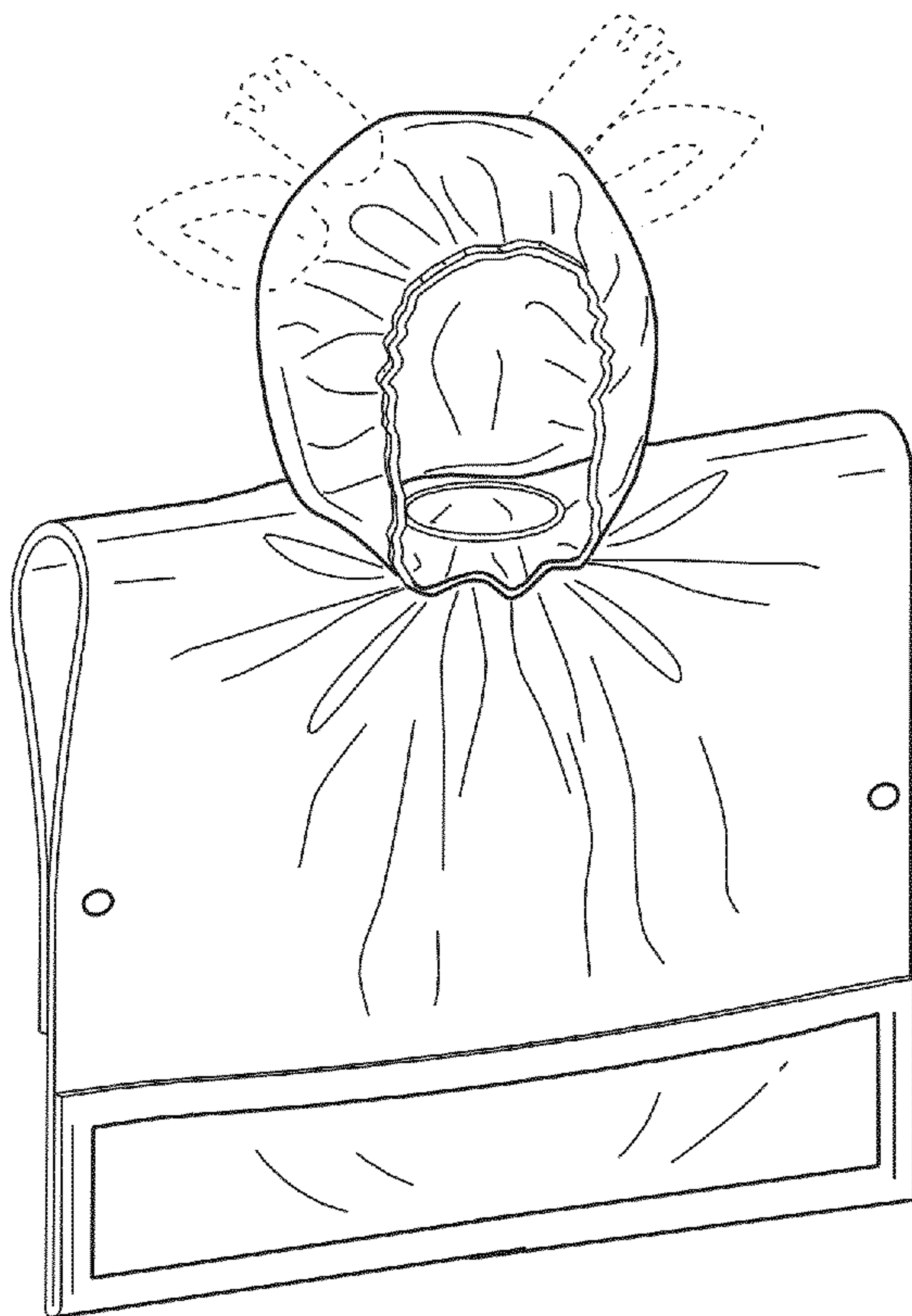
(57) **CLAIM**

The ornamental design for a hair protector bib, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective front view of a hair protector bib; FIG. 2 is a front elevation view of the hair protector bib; FIG. 3 is a rear elevation view of the hair protector bib; FIG. 4 is a left side elevation view of the hair protector bib; the right side elevation view being a mirror image thereof; FIG. 5 is a top plan view of the hair protector bib; and, FIG. 6 is a bottom plan view of the hair protector bib. The hair, ears, and horns are shown in broken lines for illustrative purposes only and form no part of the claimed design.

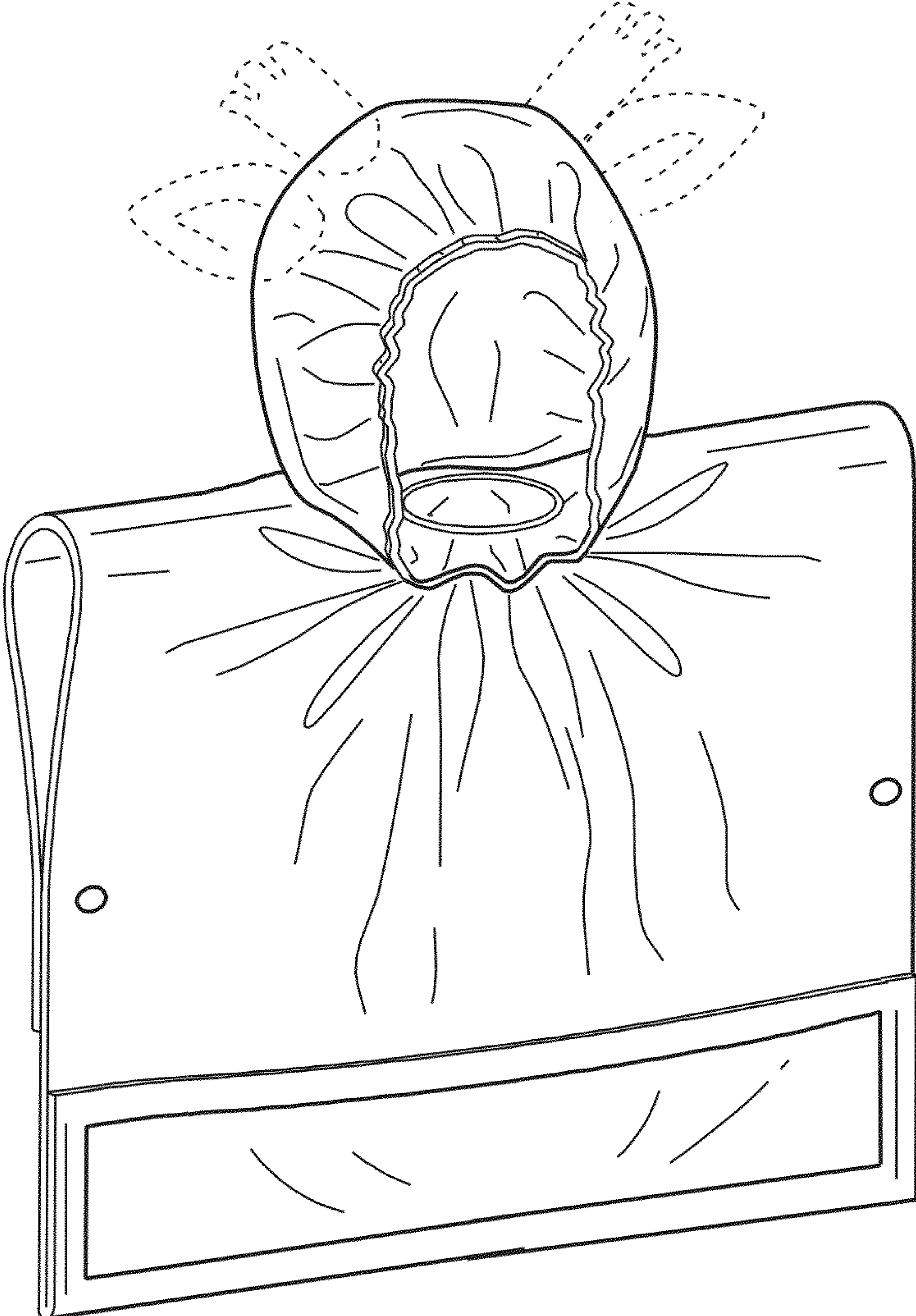

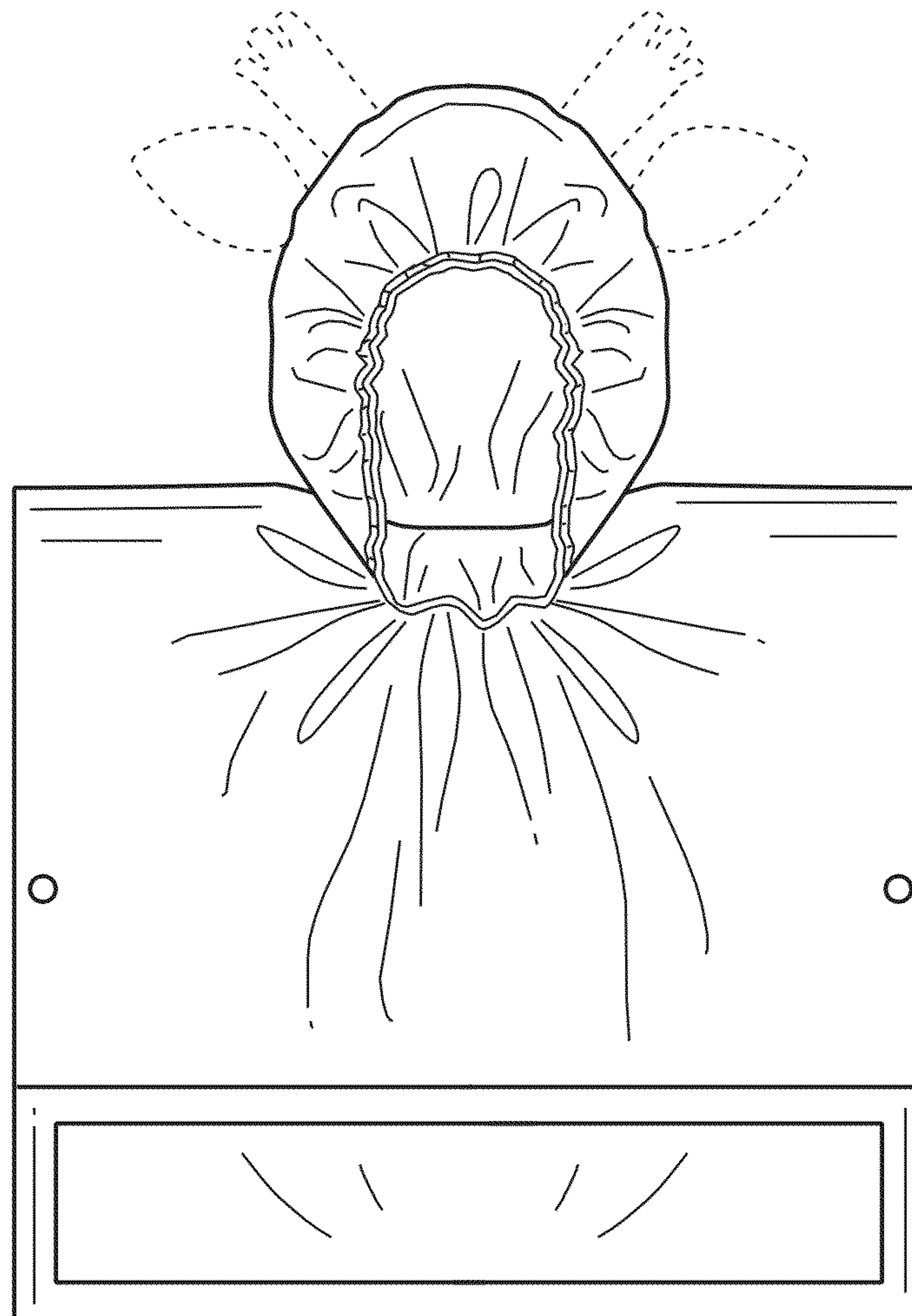

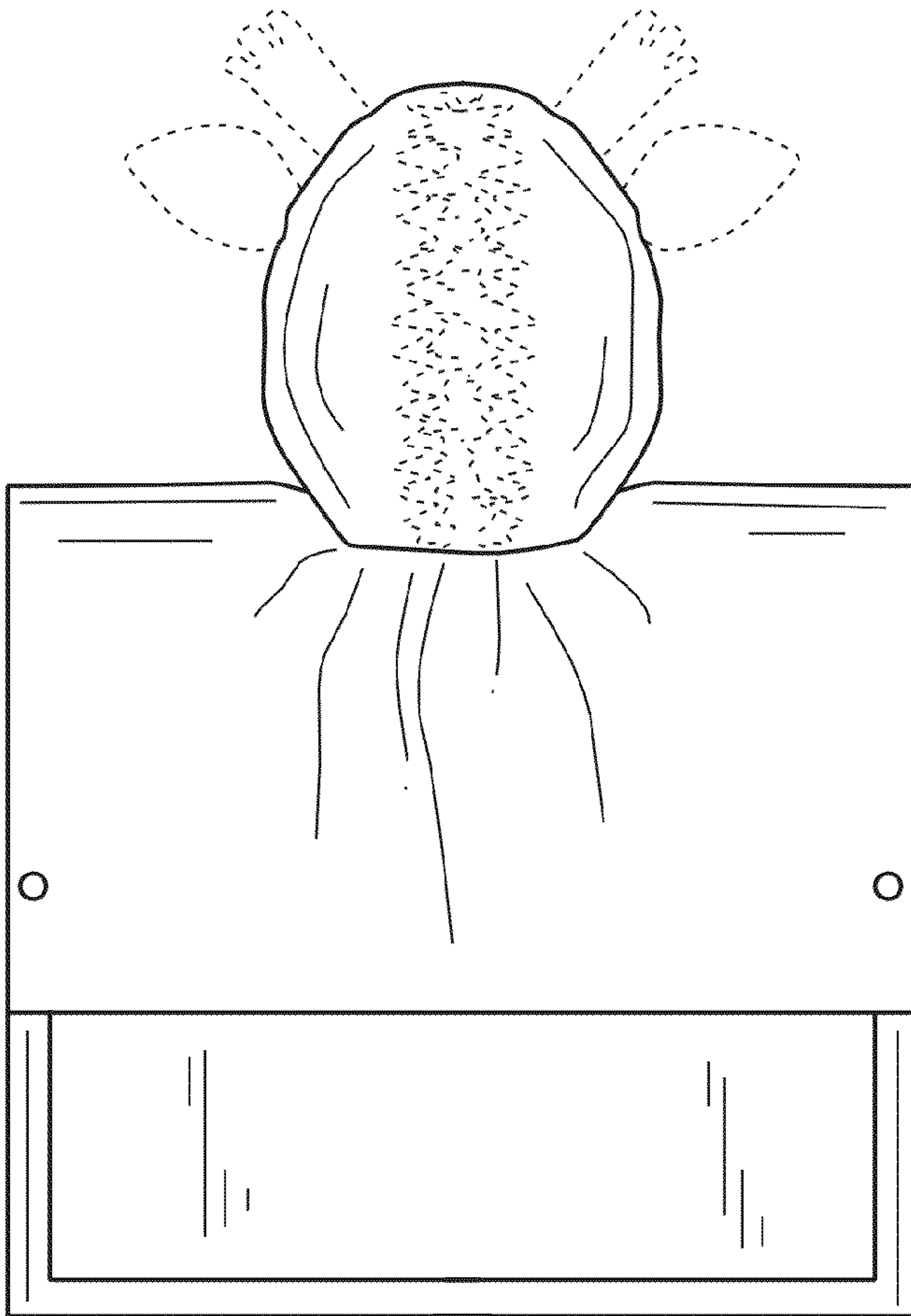

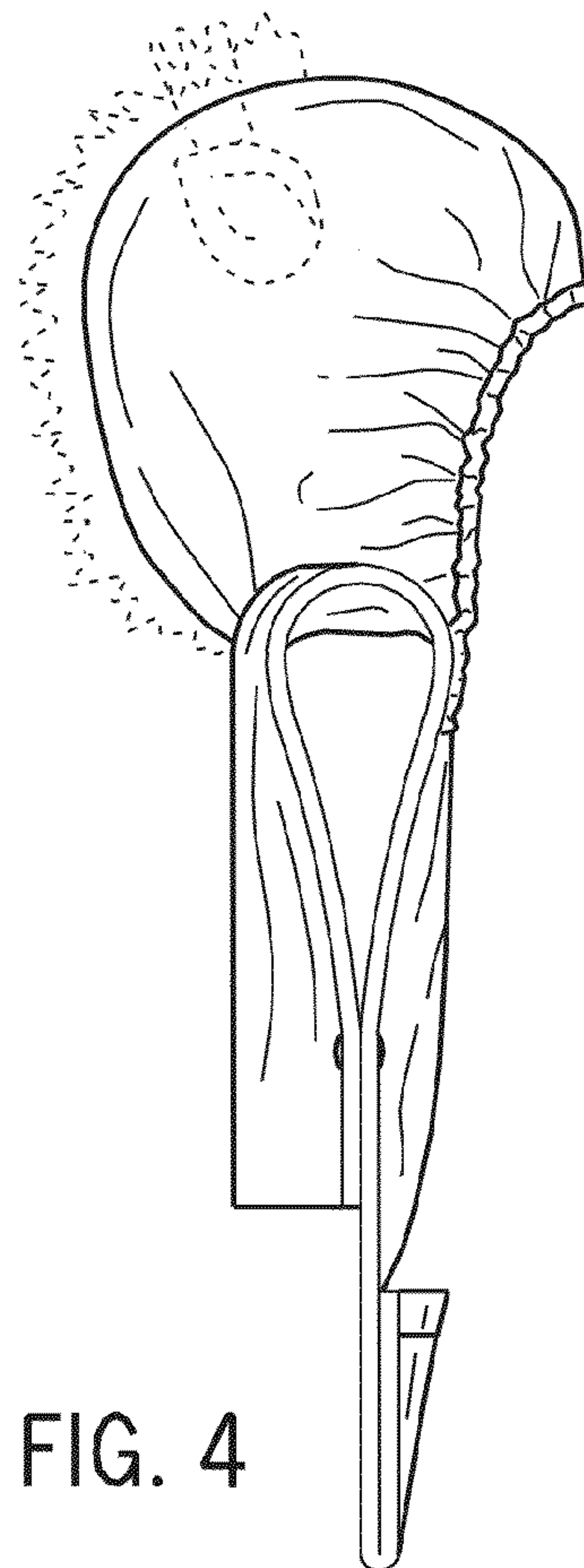

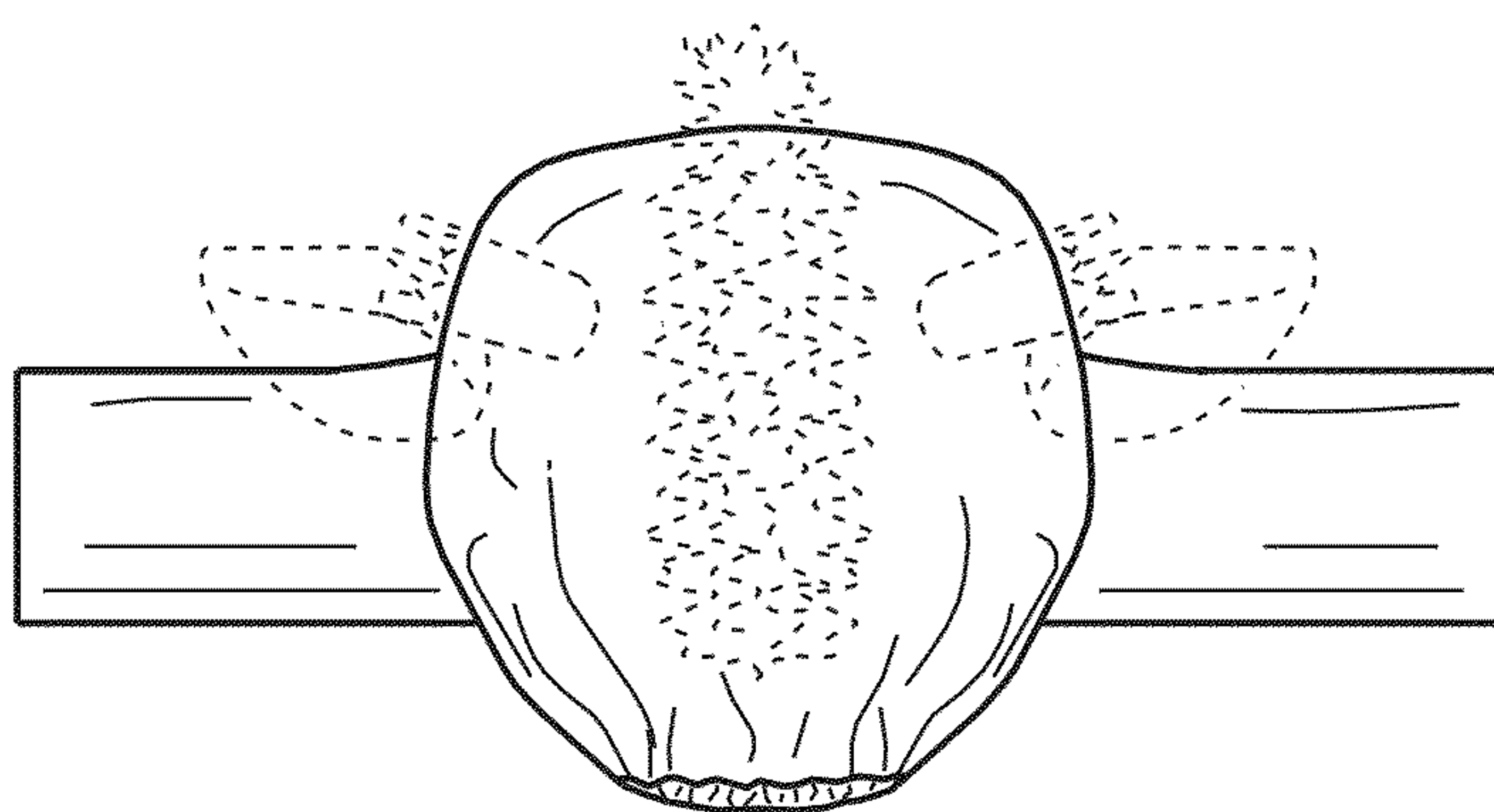

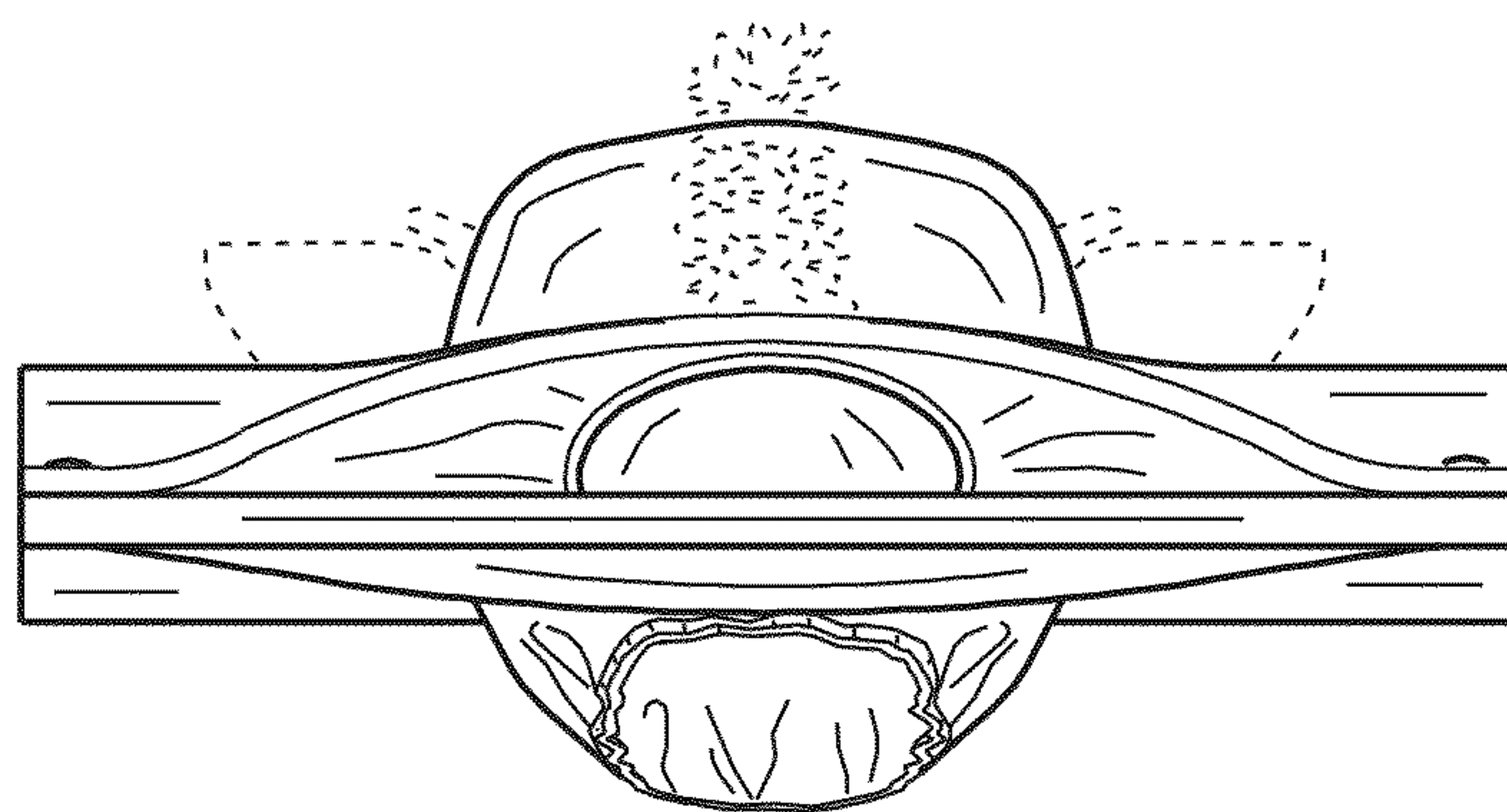
