FIG. 1 is a front perspective view.

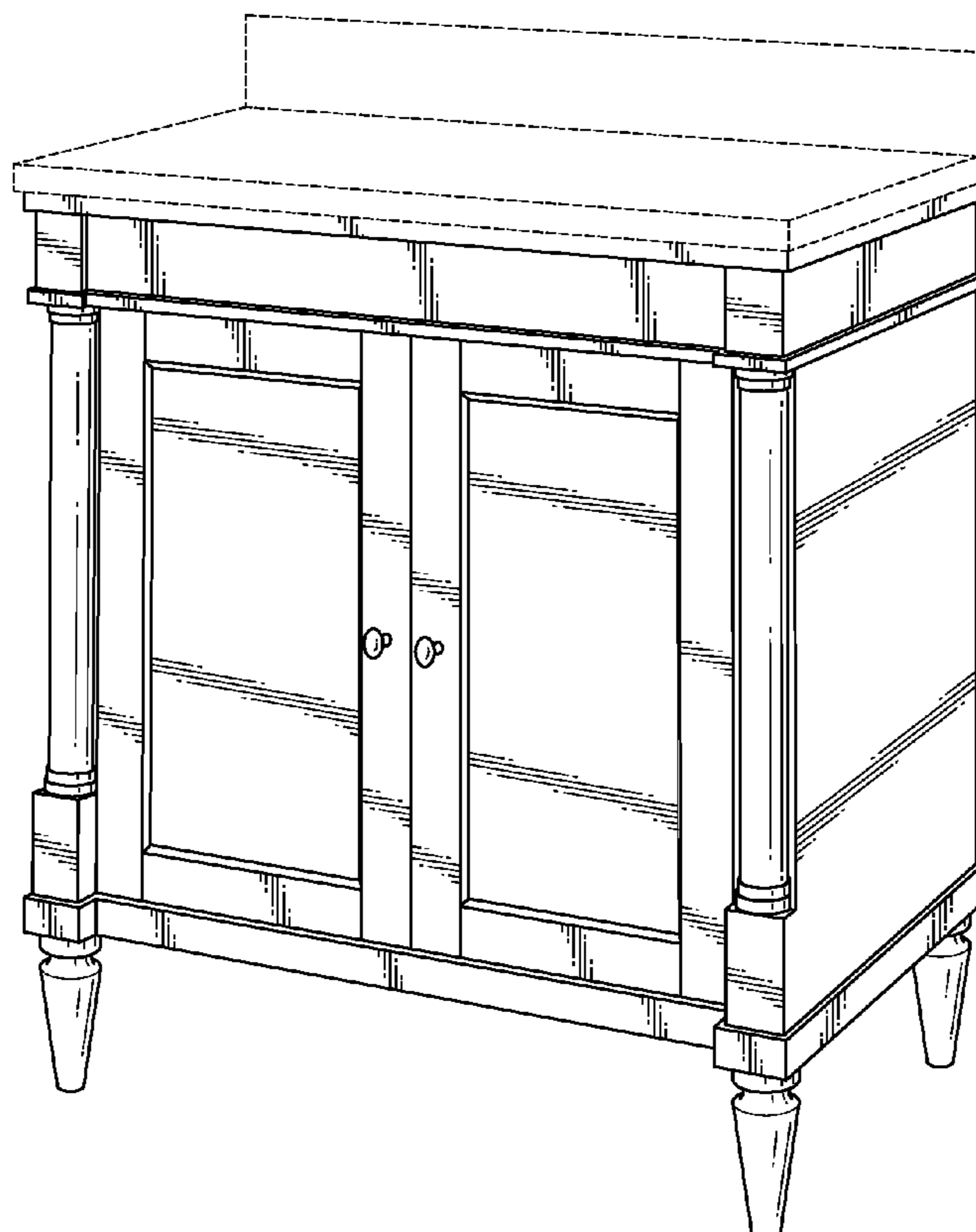
FIG. 2 is a front view.

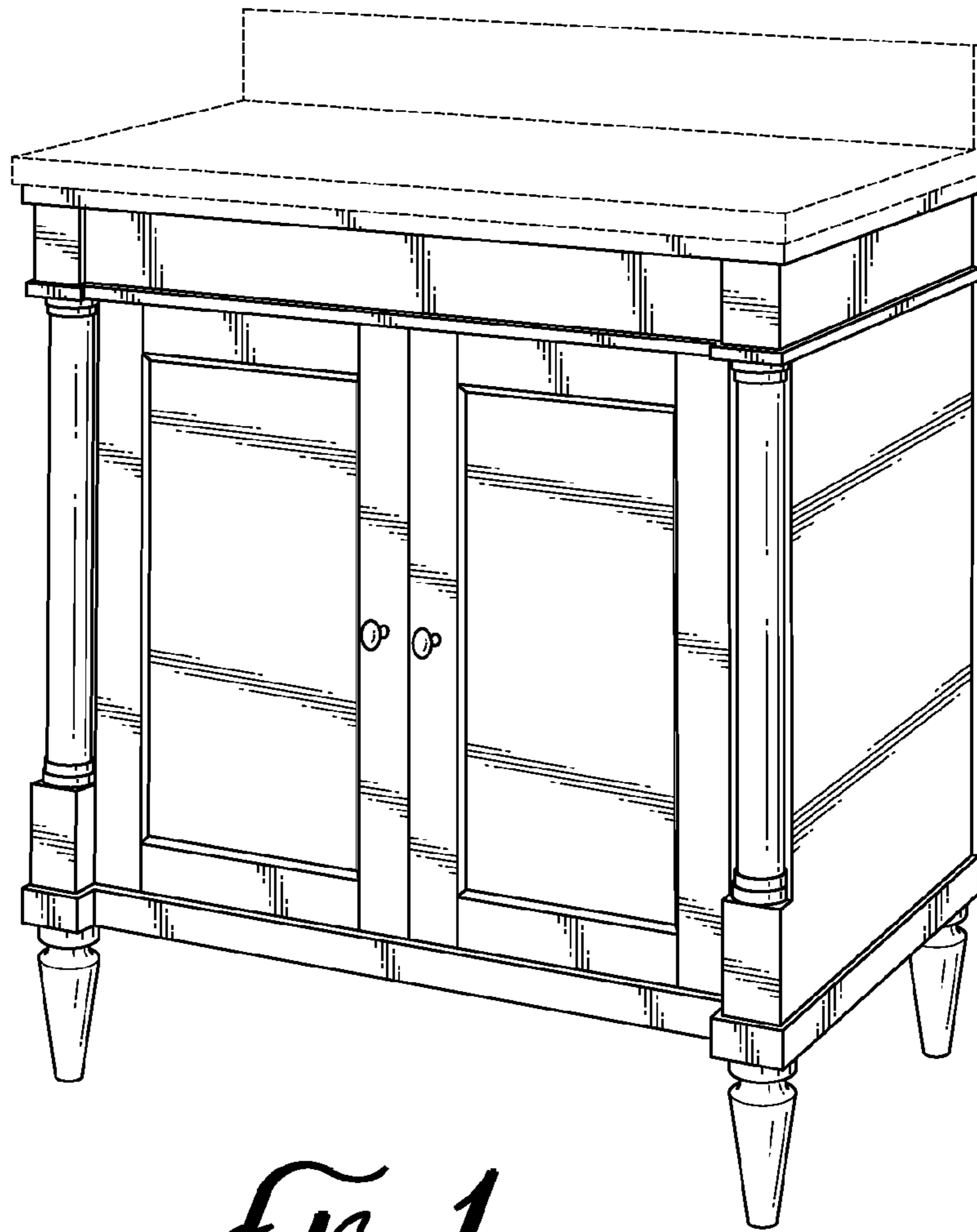

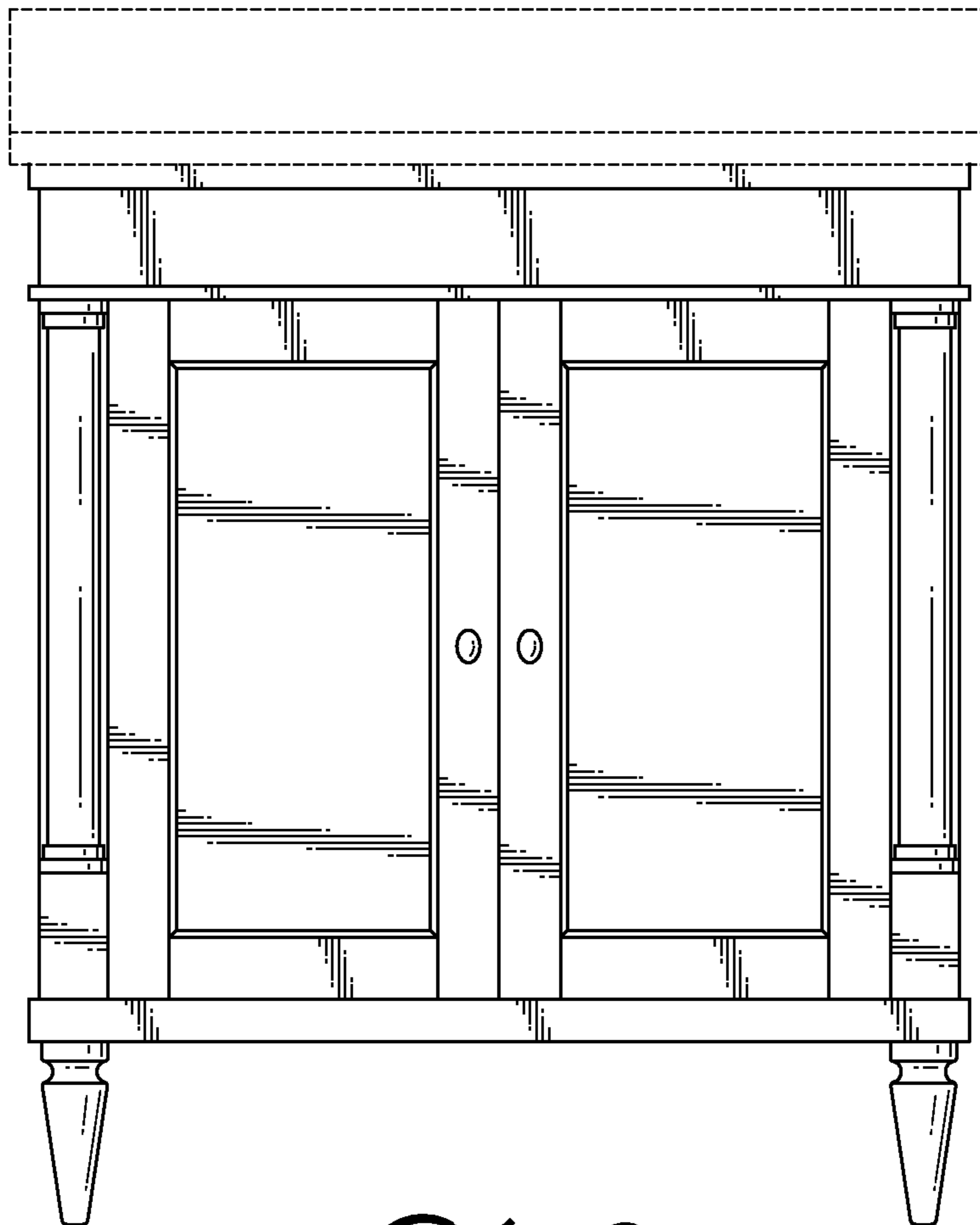

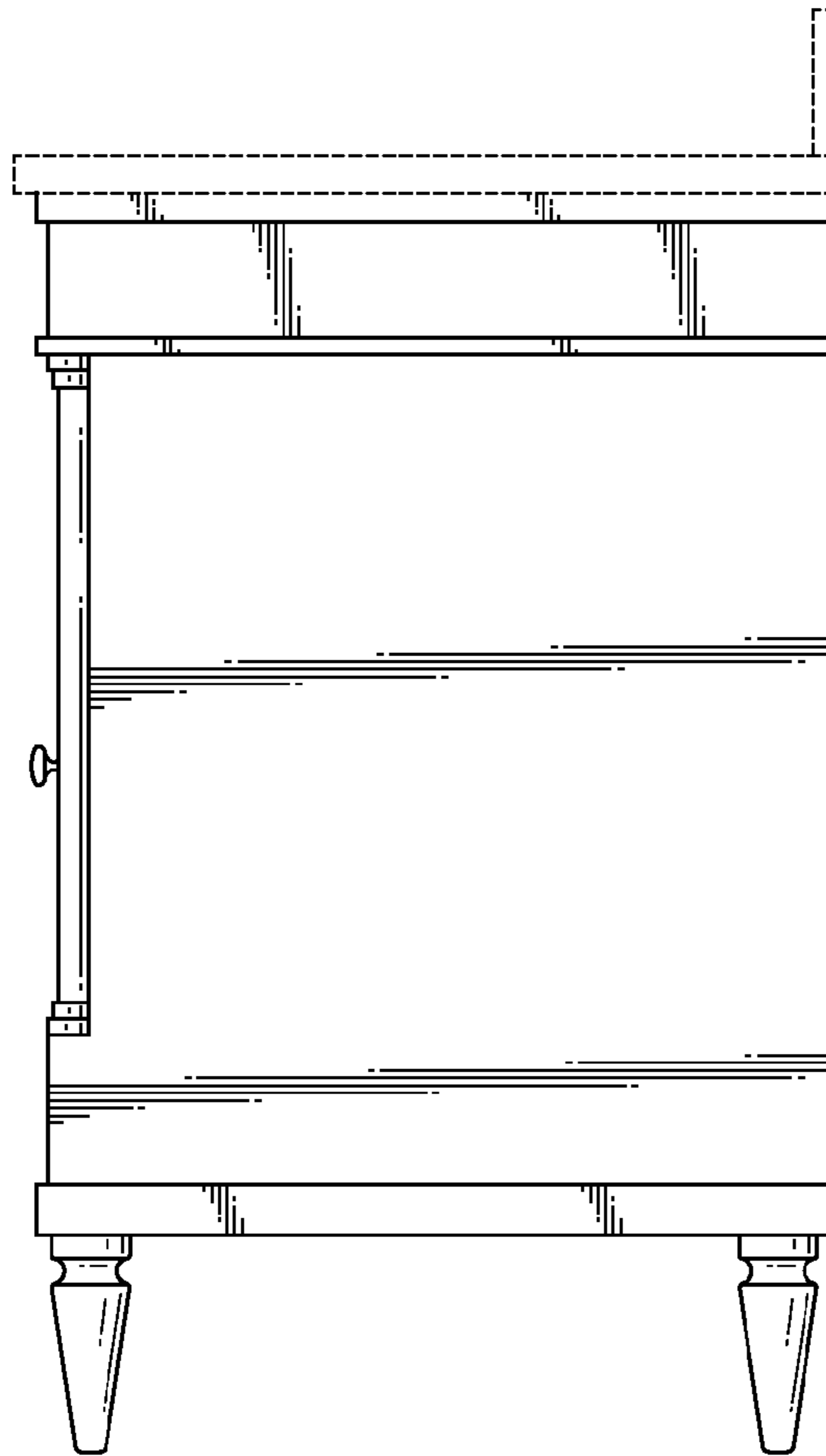
